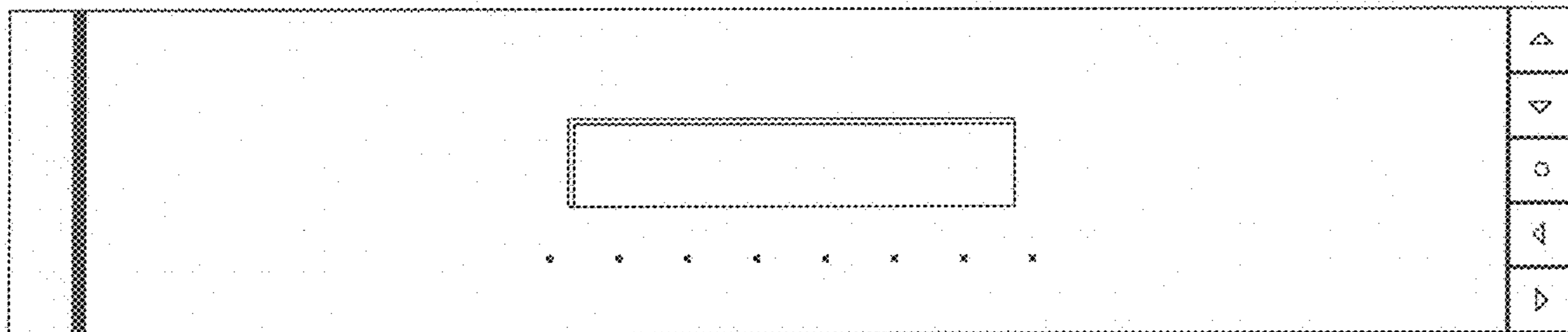
FIG. 1 is a front view of an audio controller in accordance with the invention;

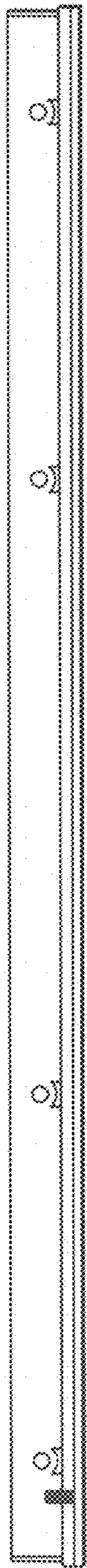

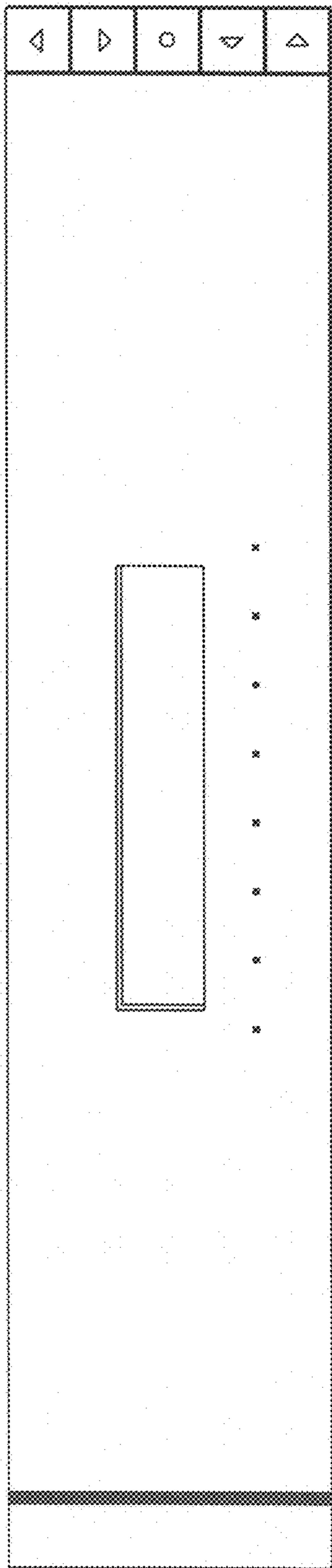

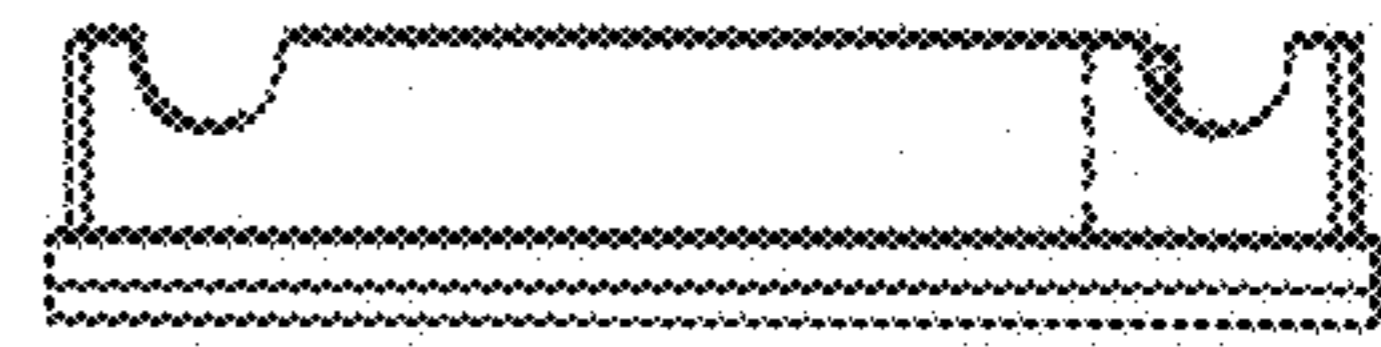
