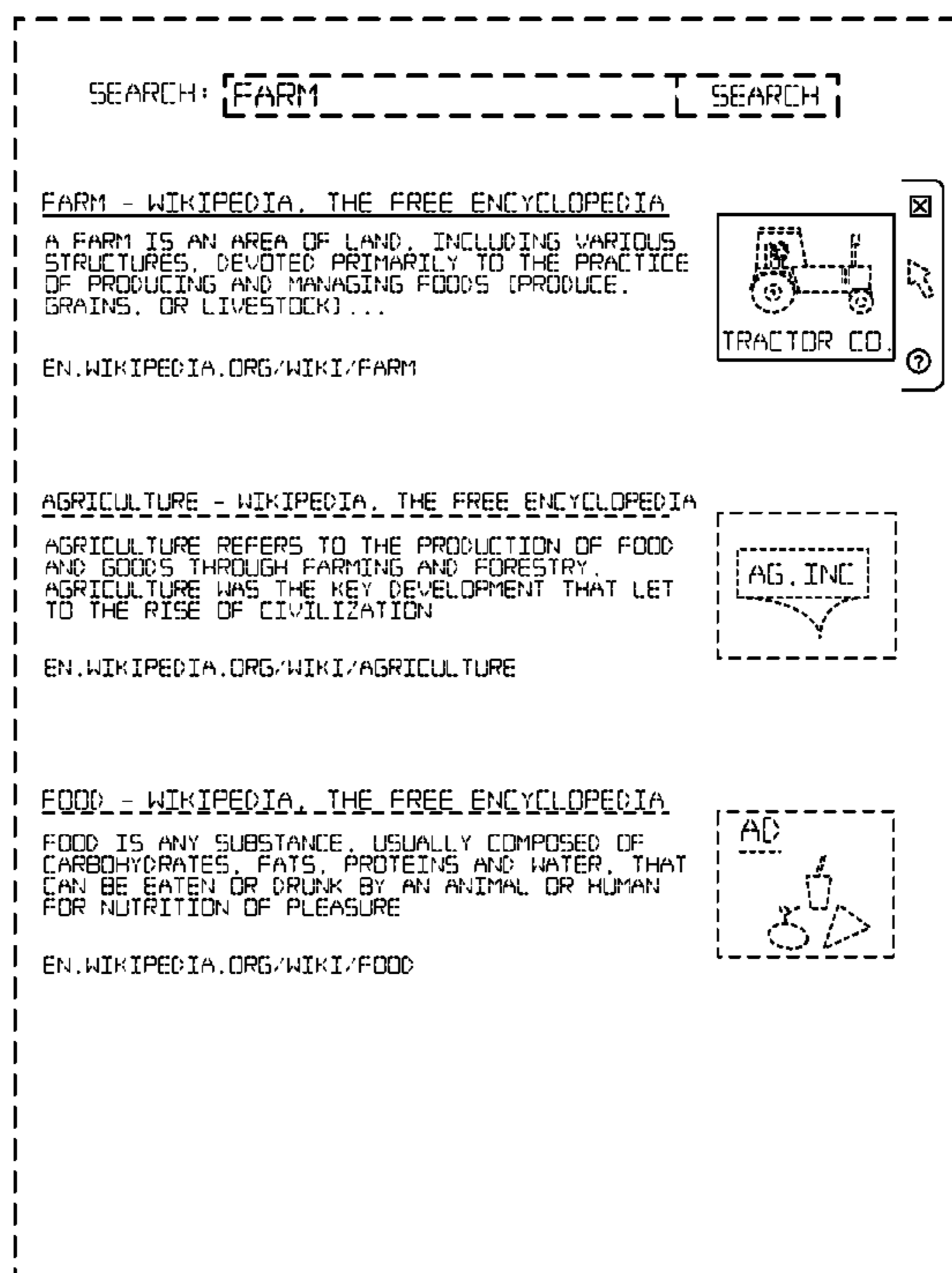
The ornamental design for a portion of a display screen with  
computer user interface, as shown and described.

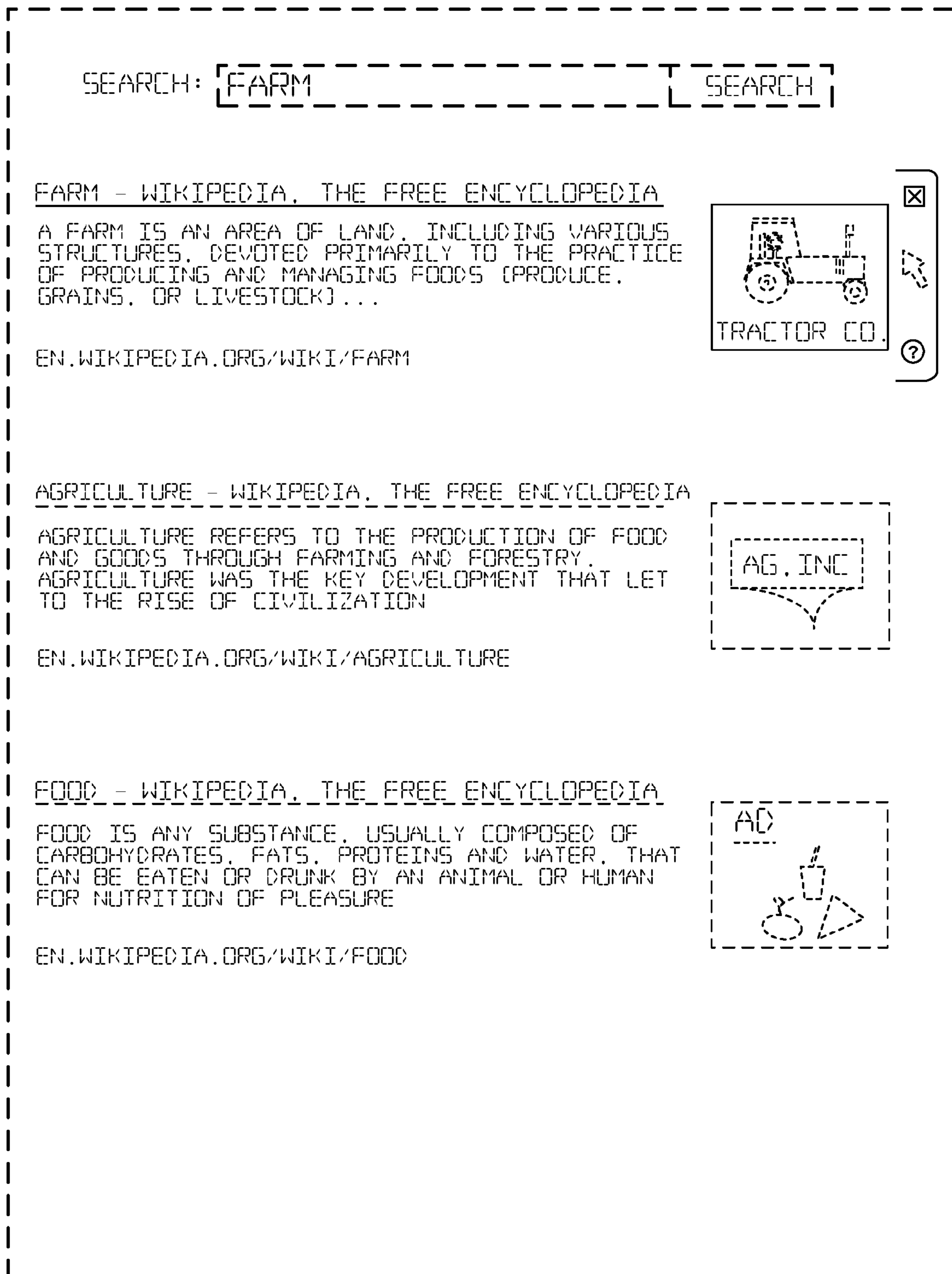
**DESCRIPTION**
