FIG. 3 a back view thereof;

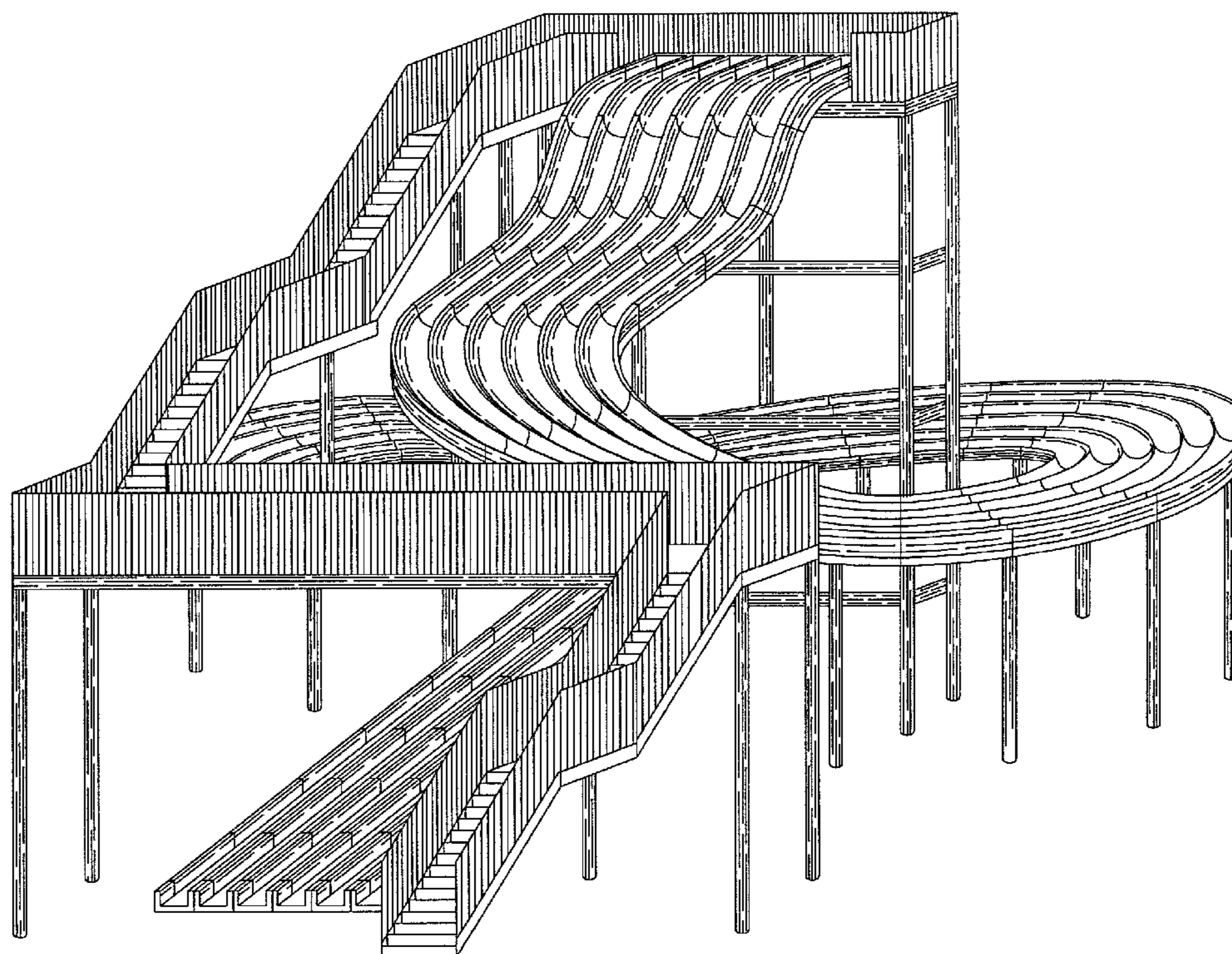
FIG. 4 a top plan view thereof;

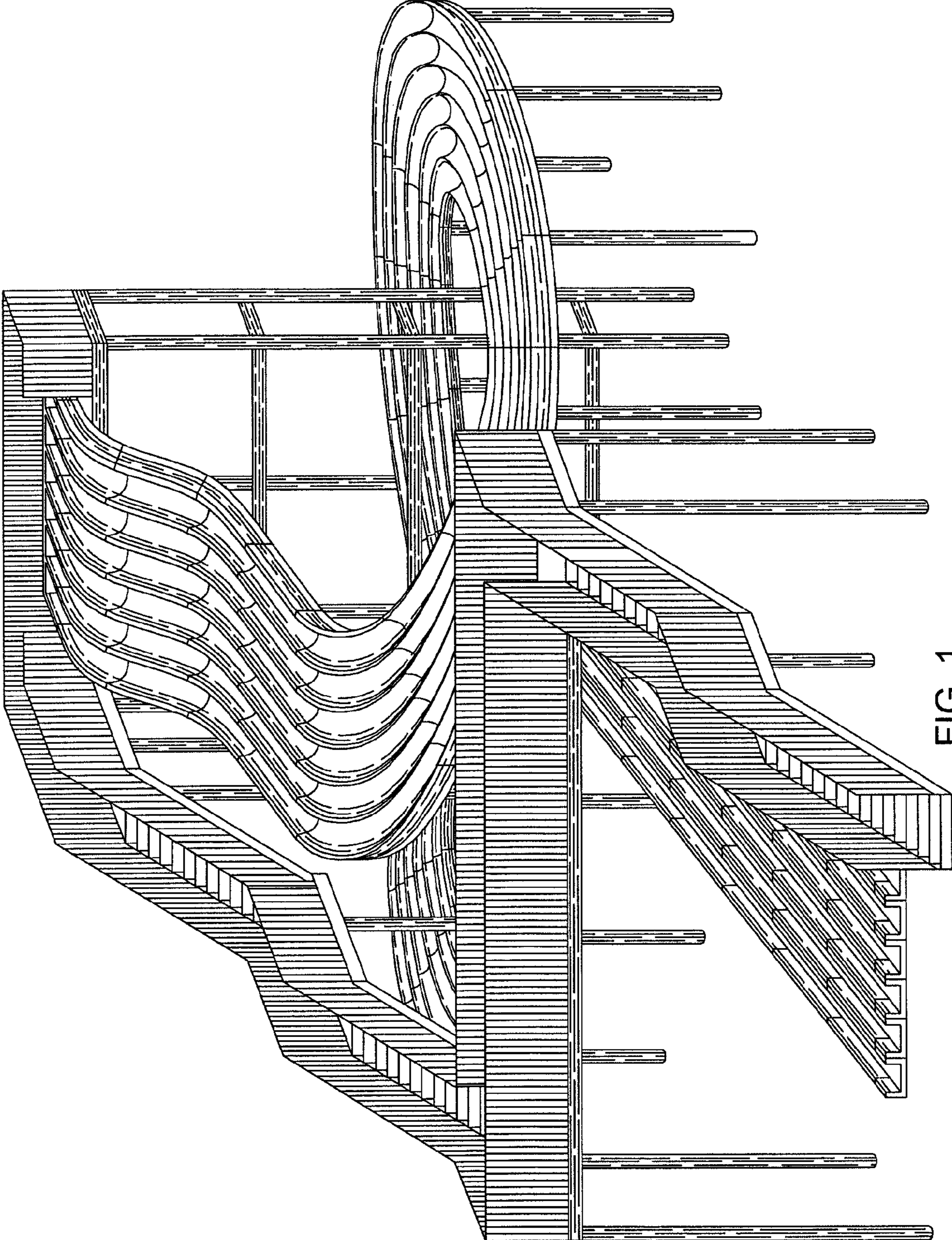

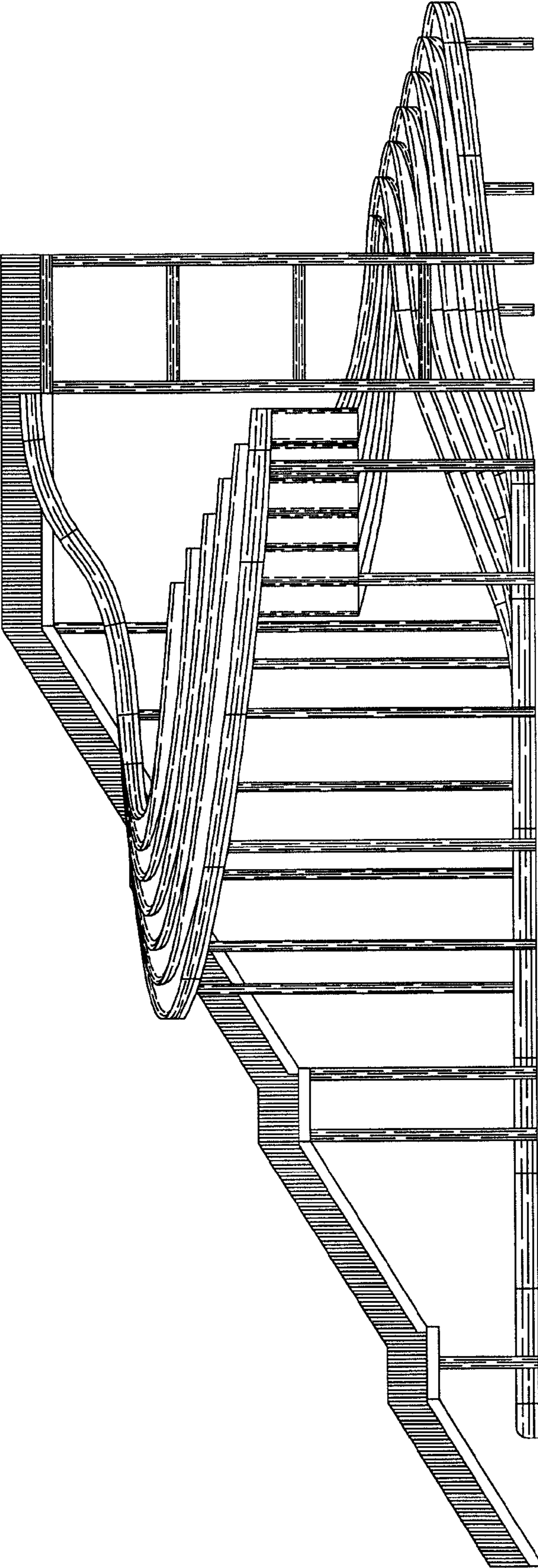

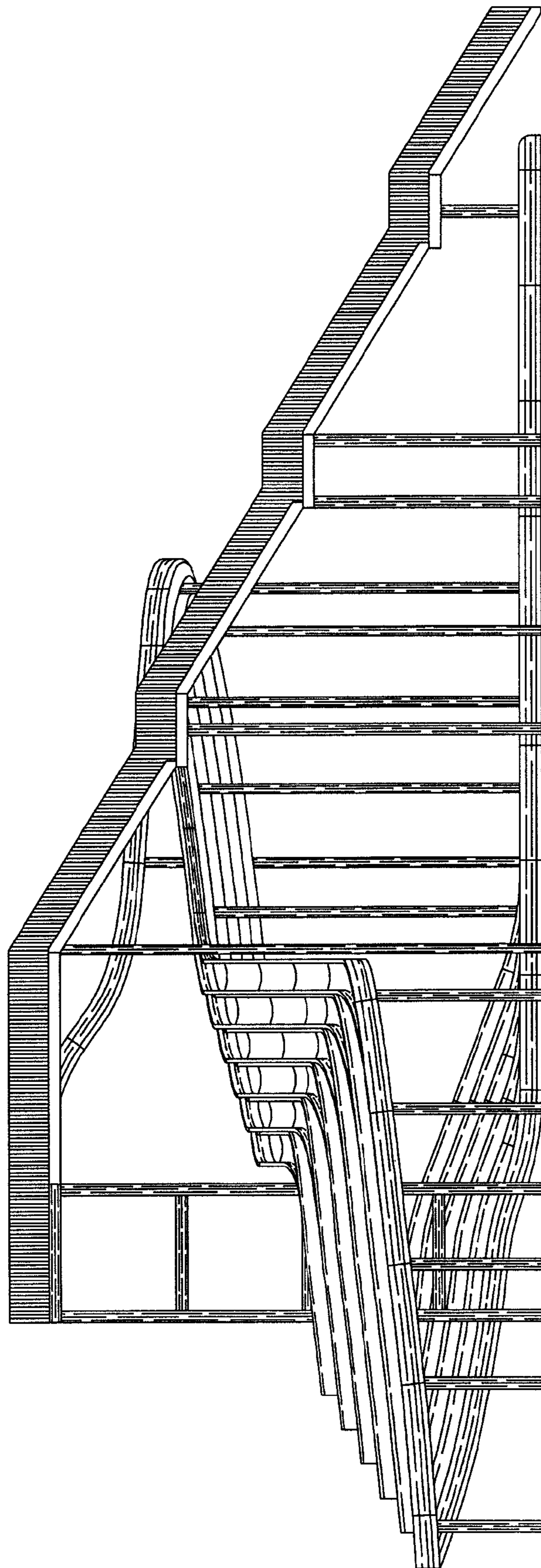

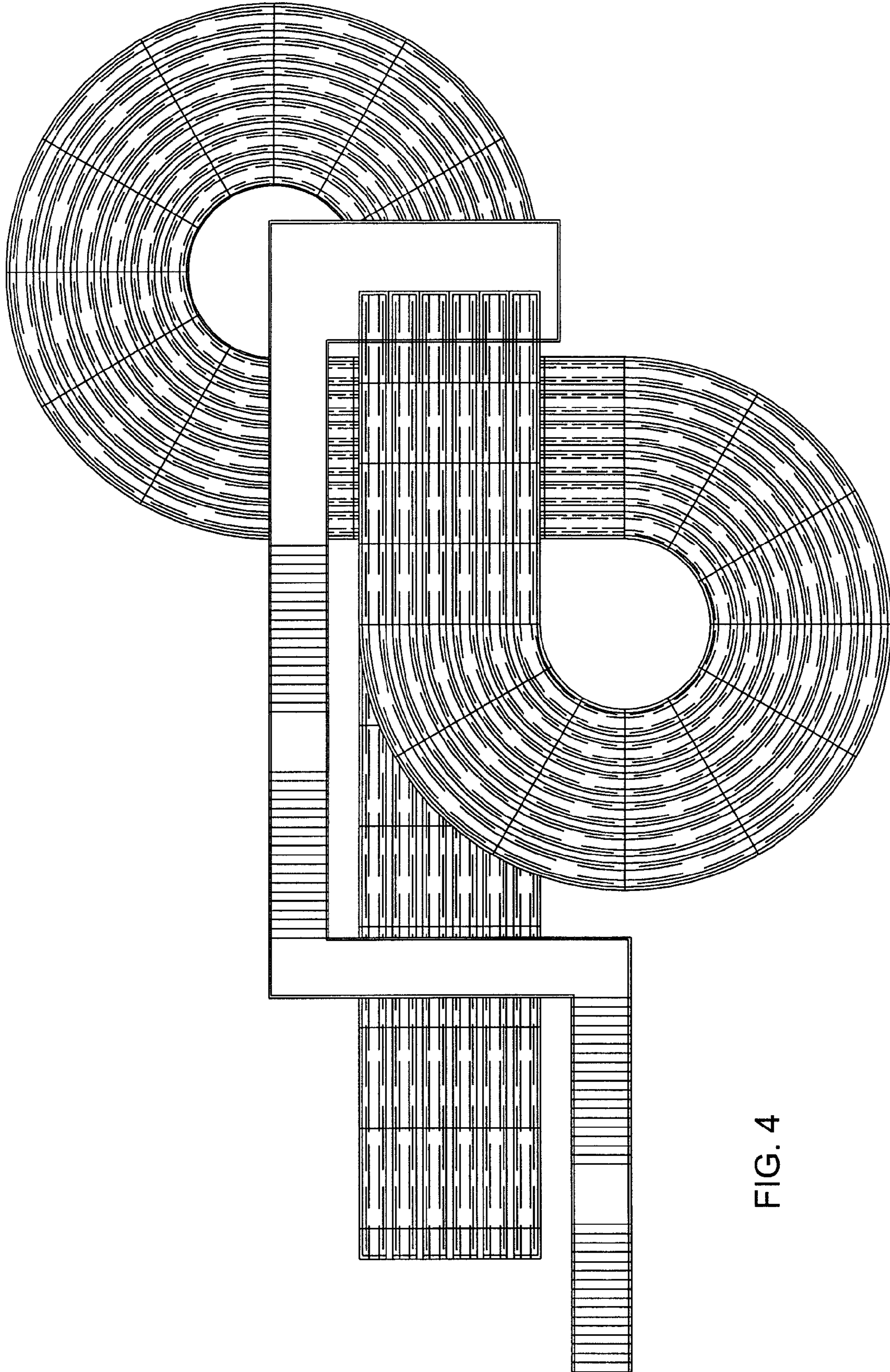

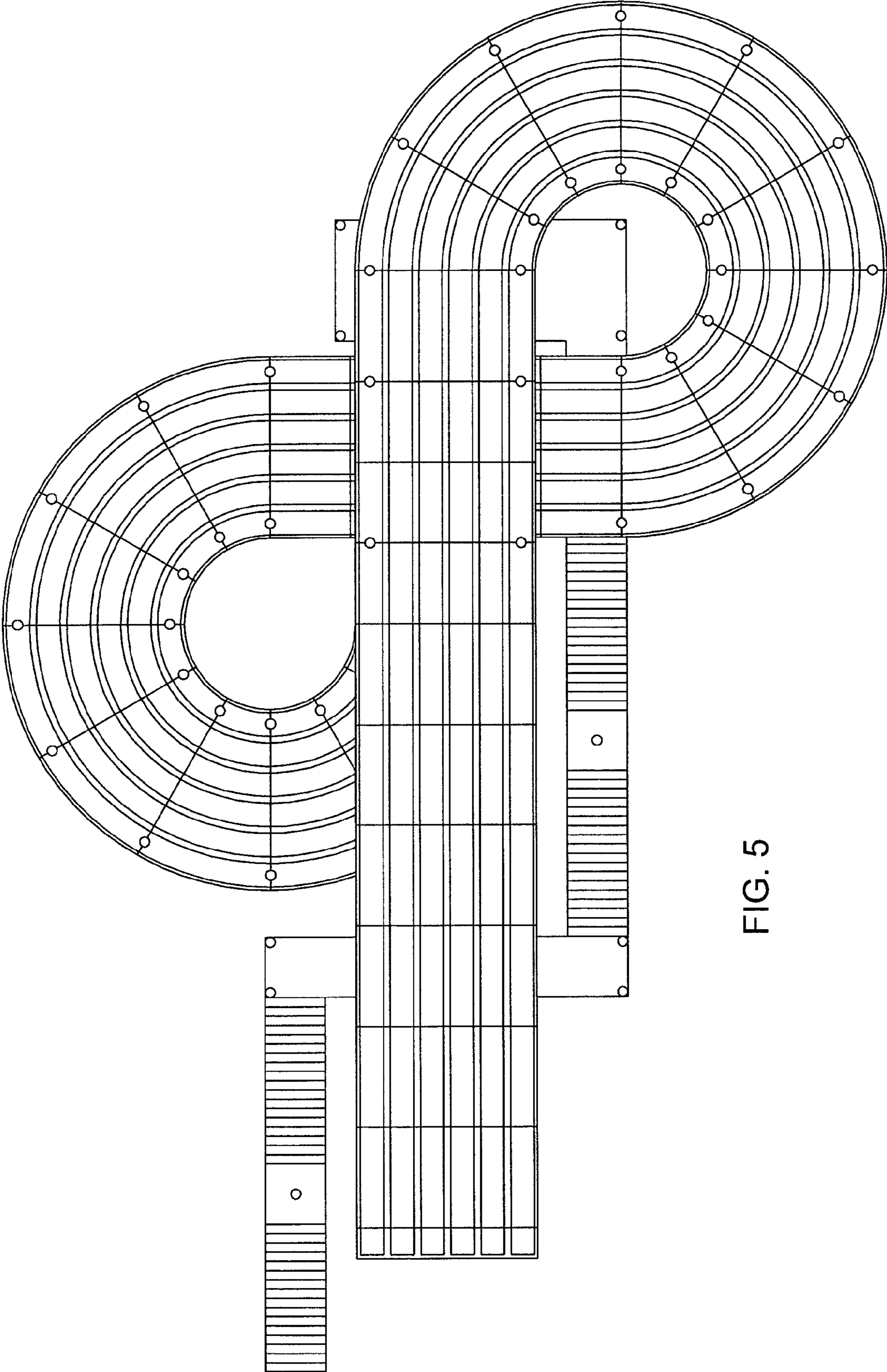

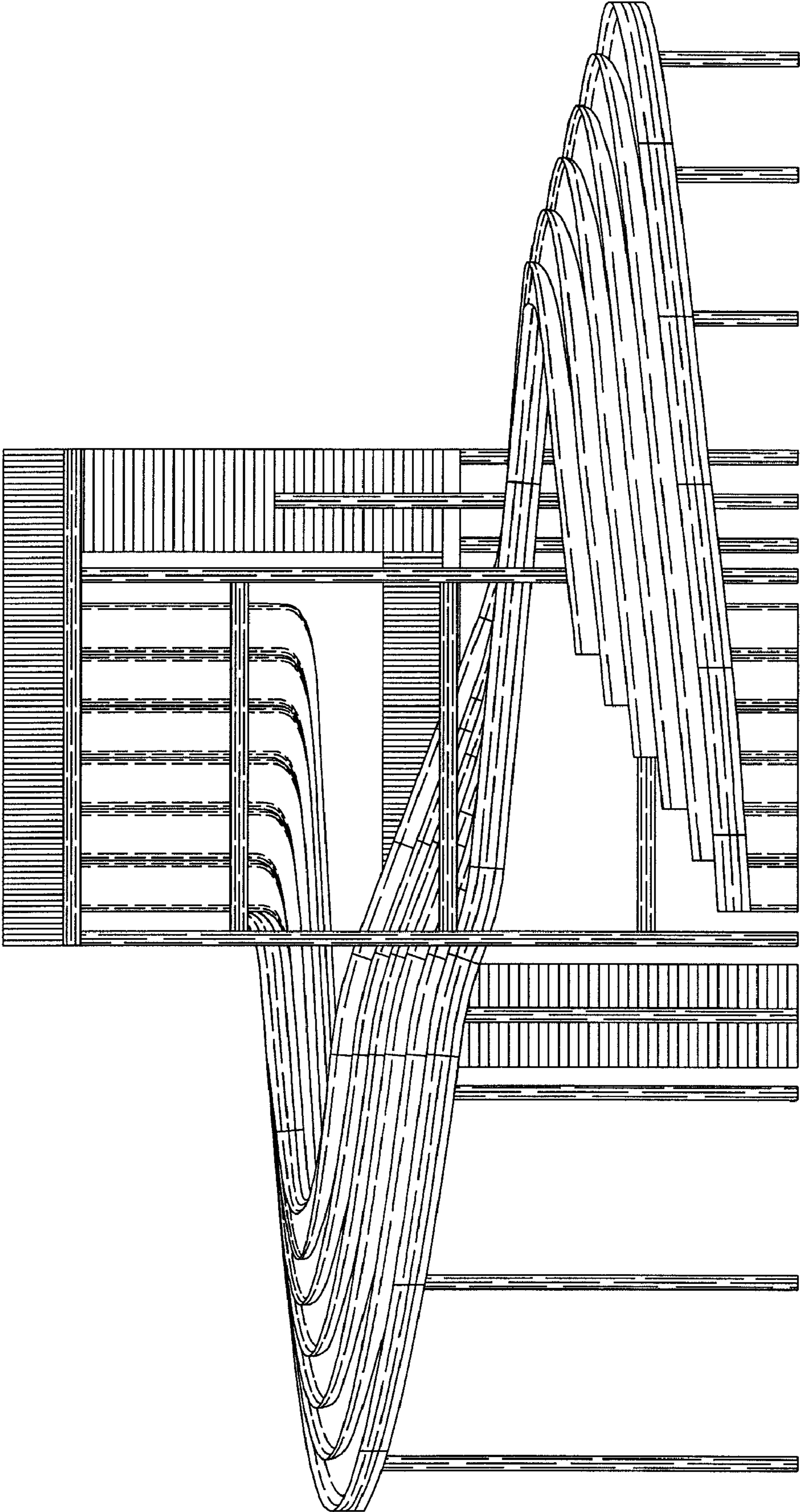

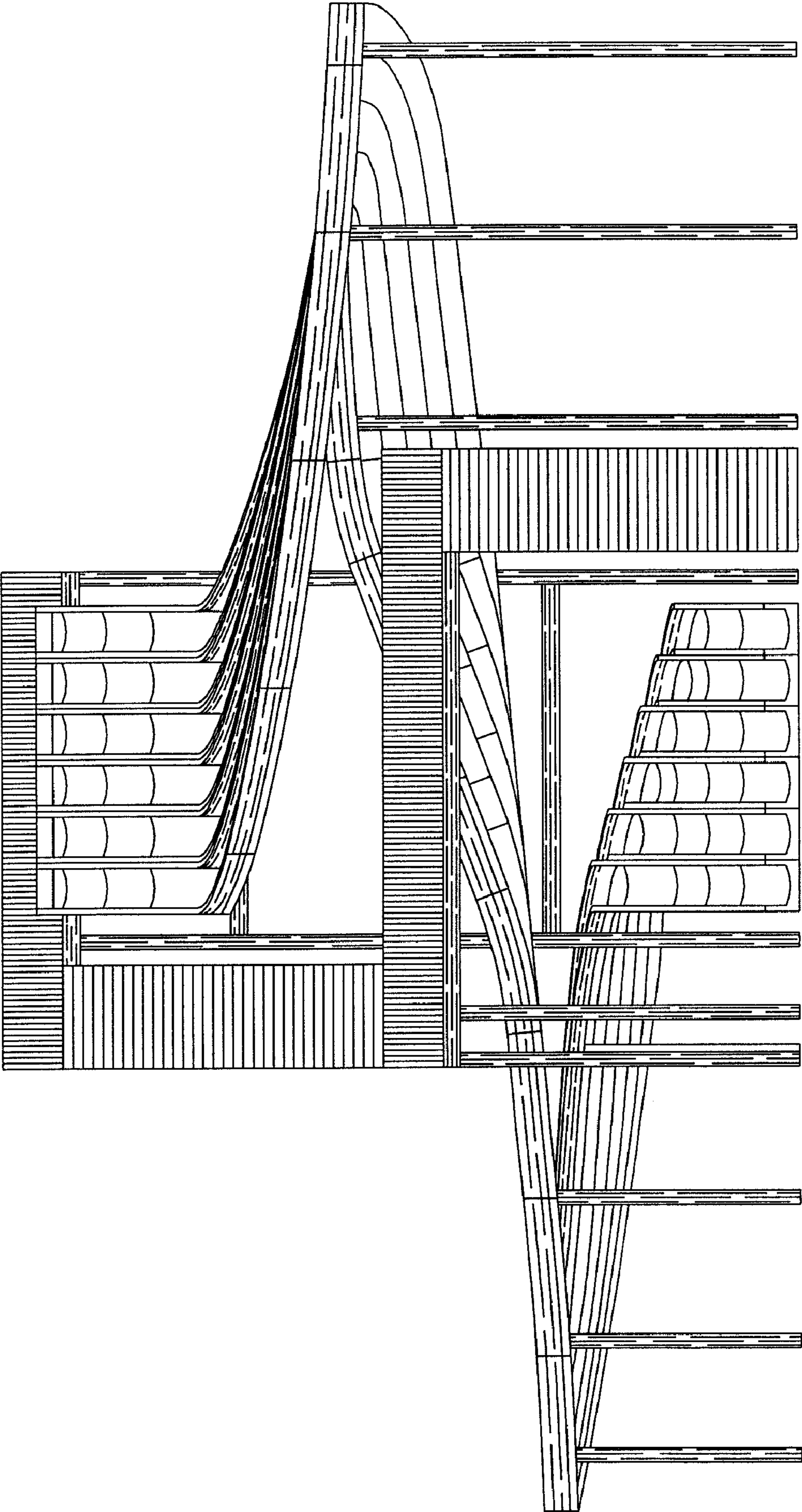
