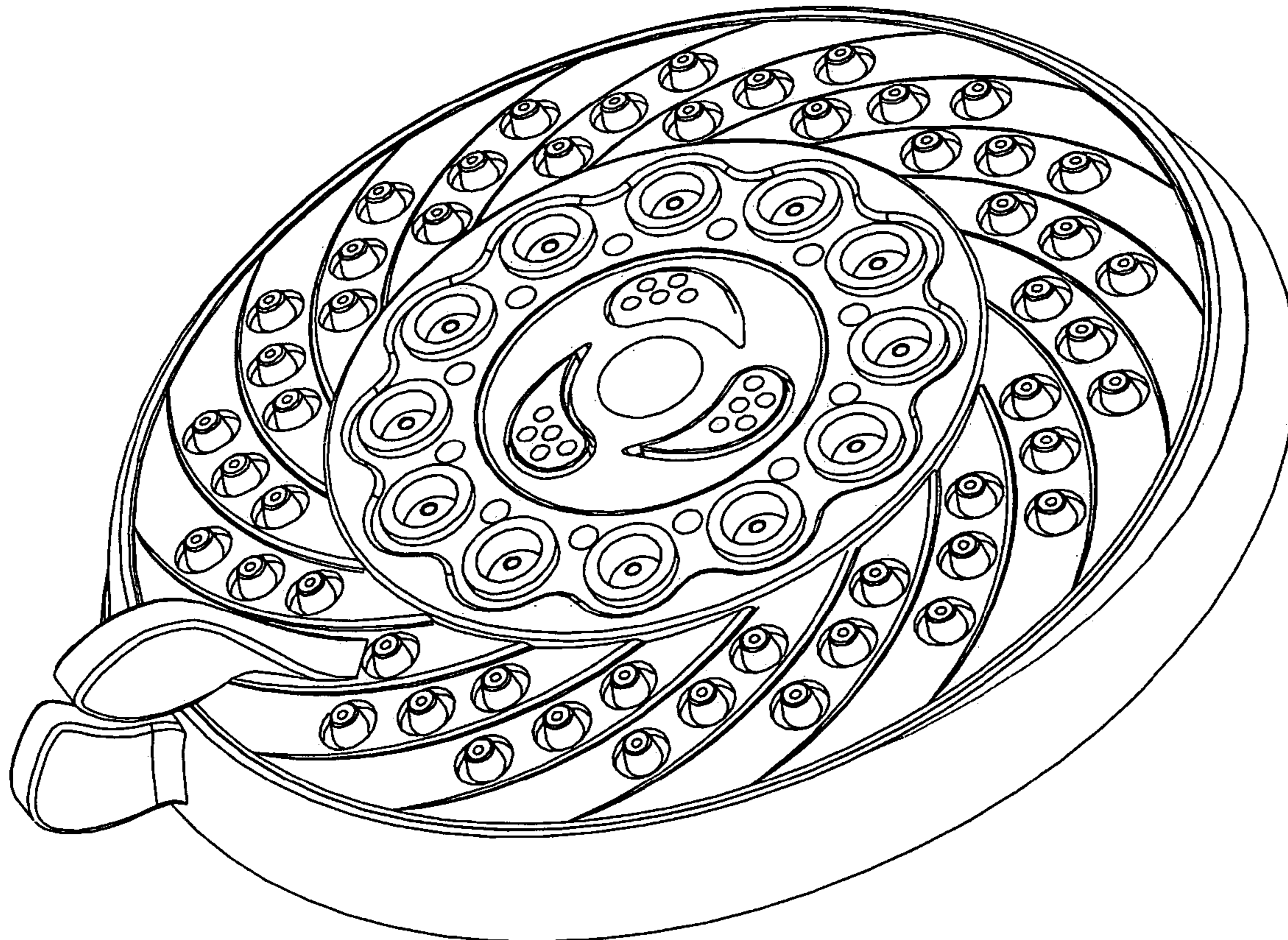
FIG. 1 is the front elevational view of a shower head;

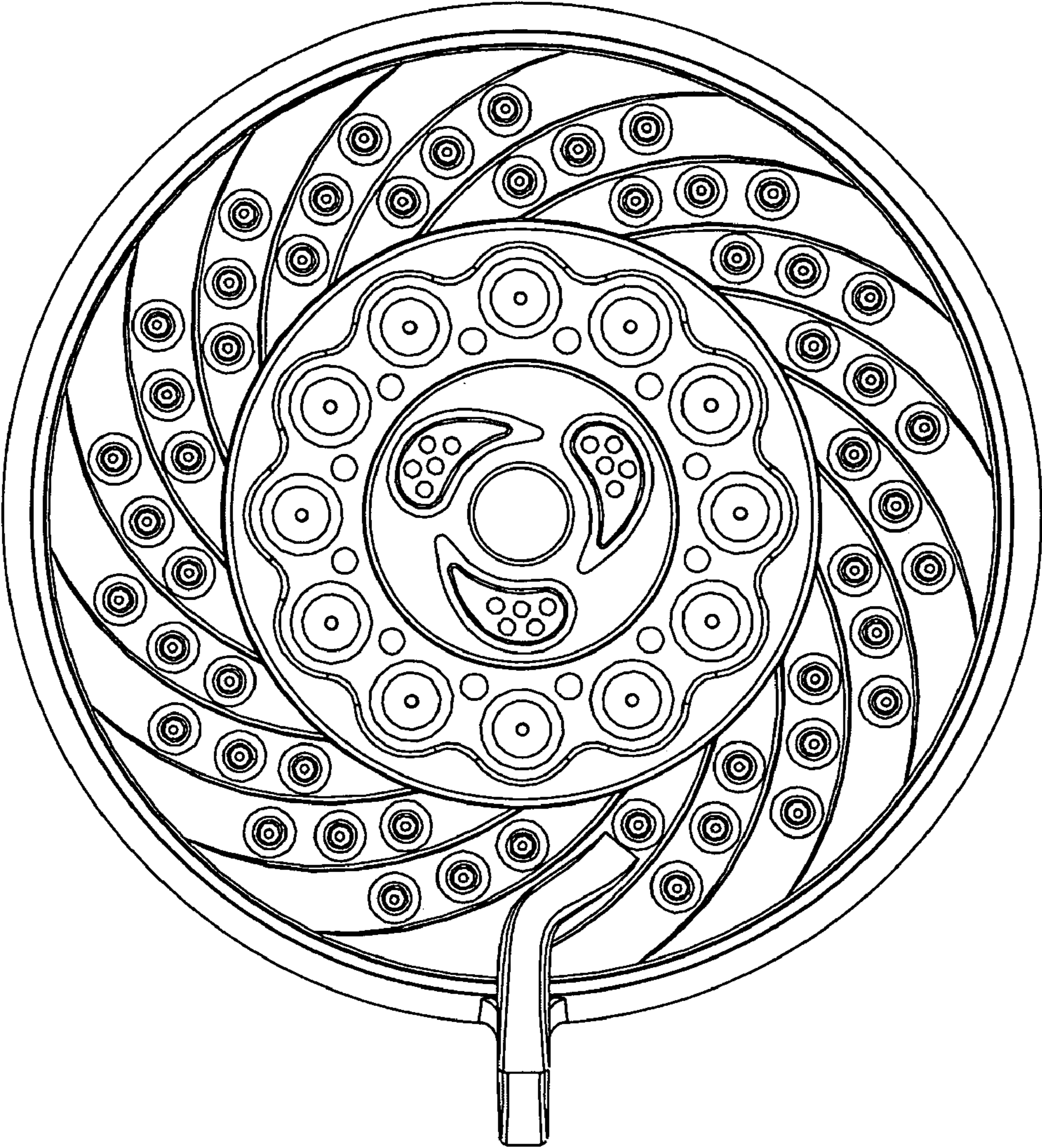

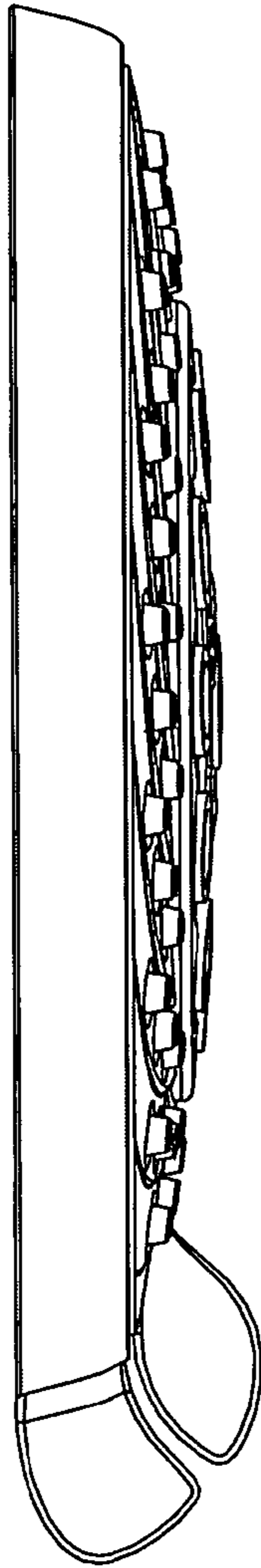

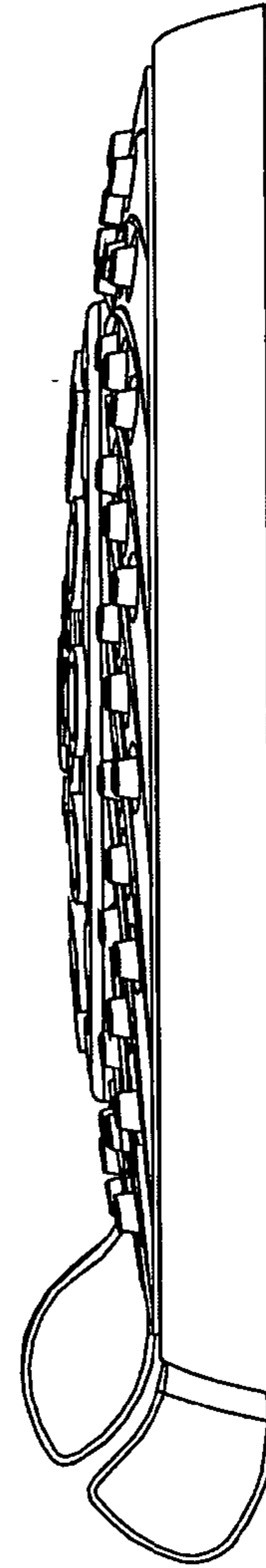

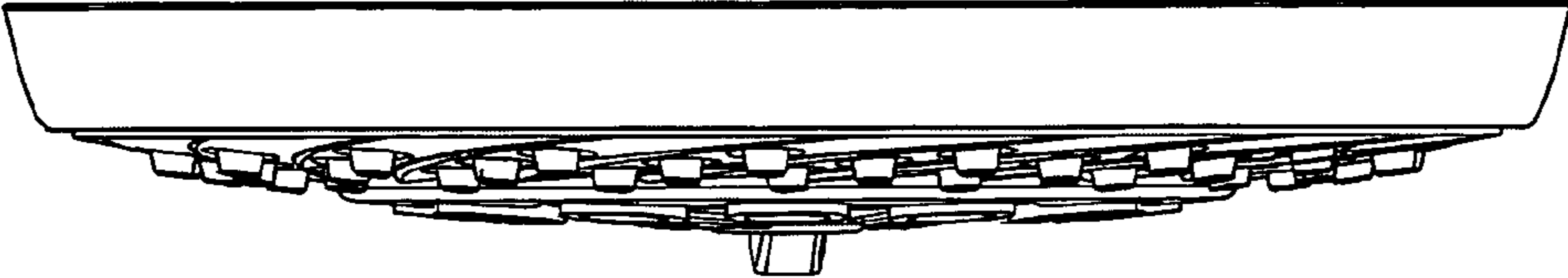

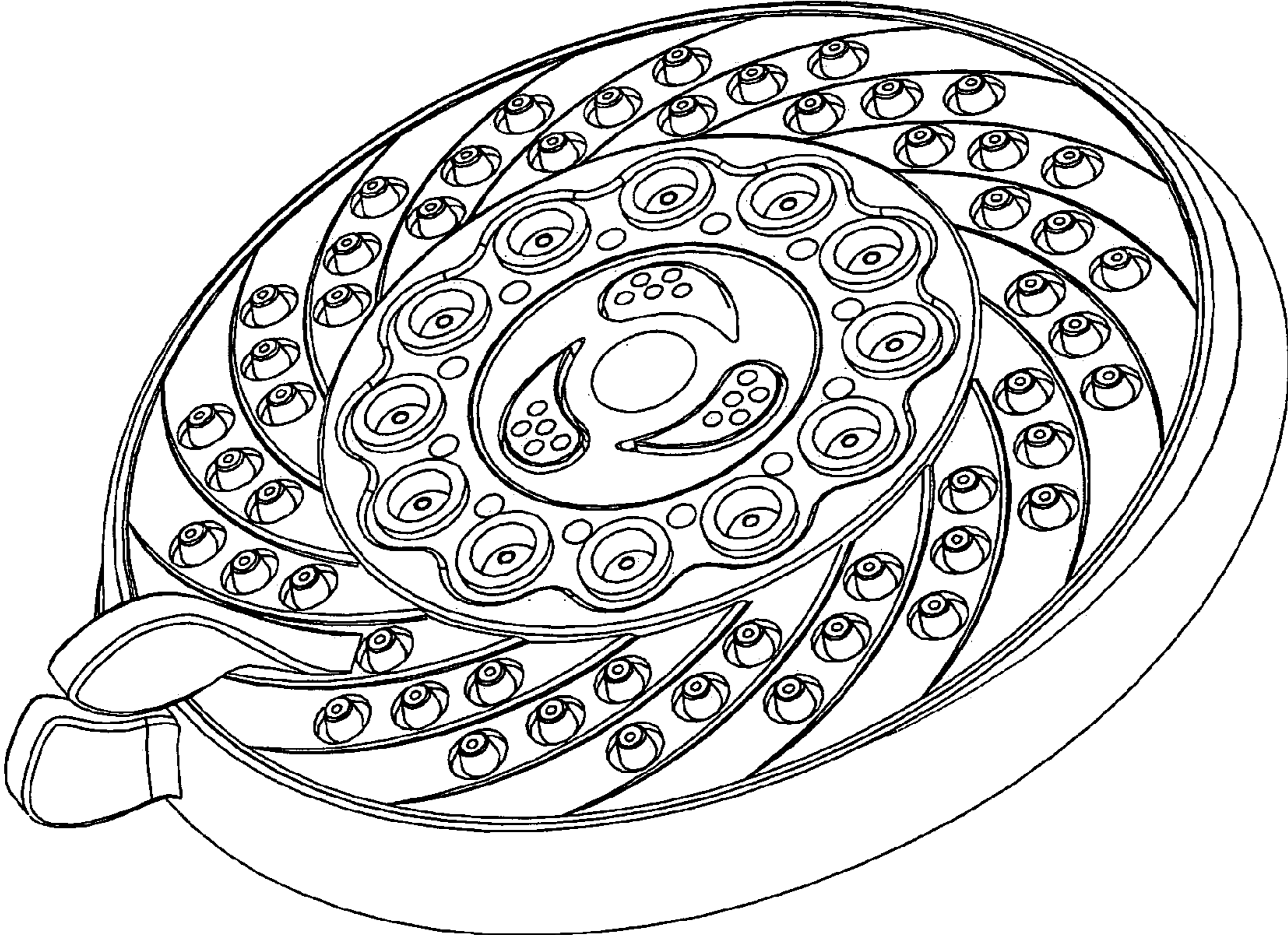

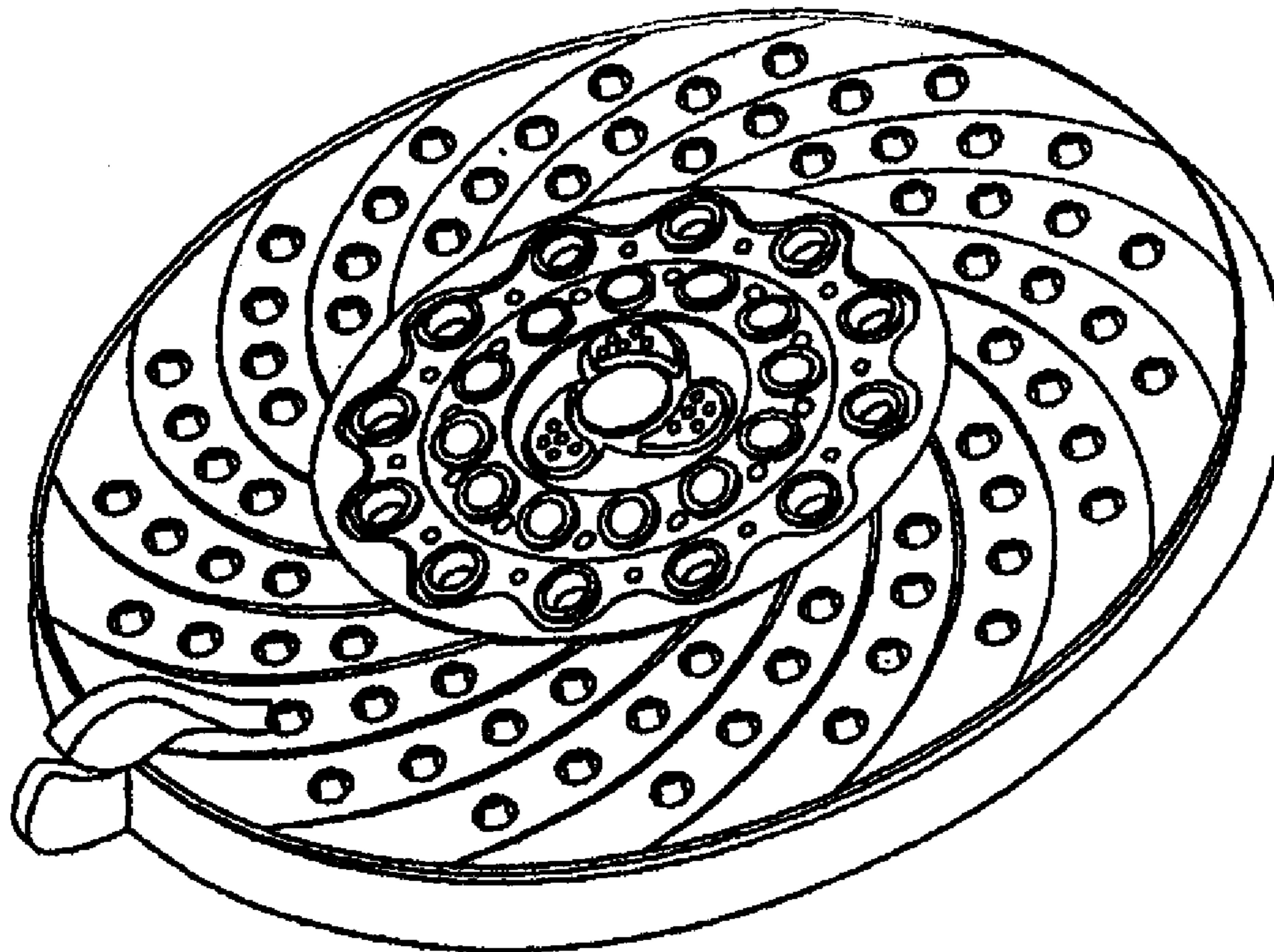
FIG. 1 is the front elevational view of a shower head;

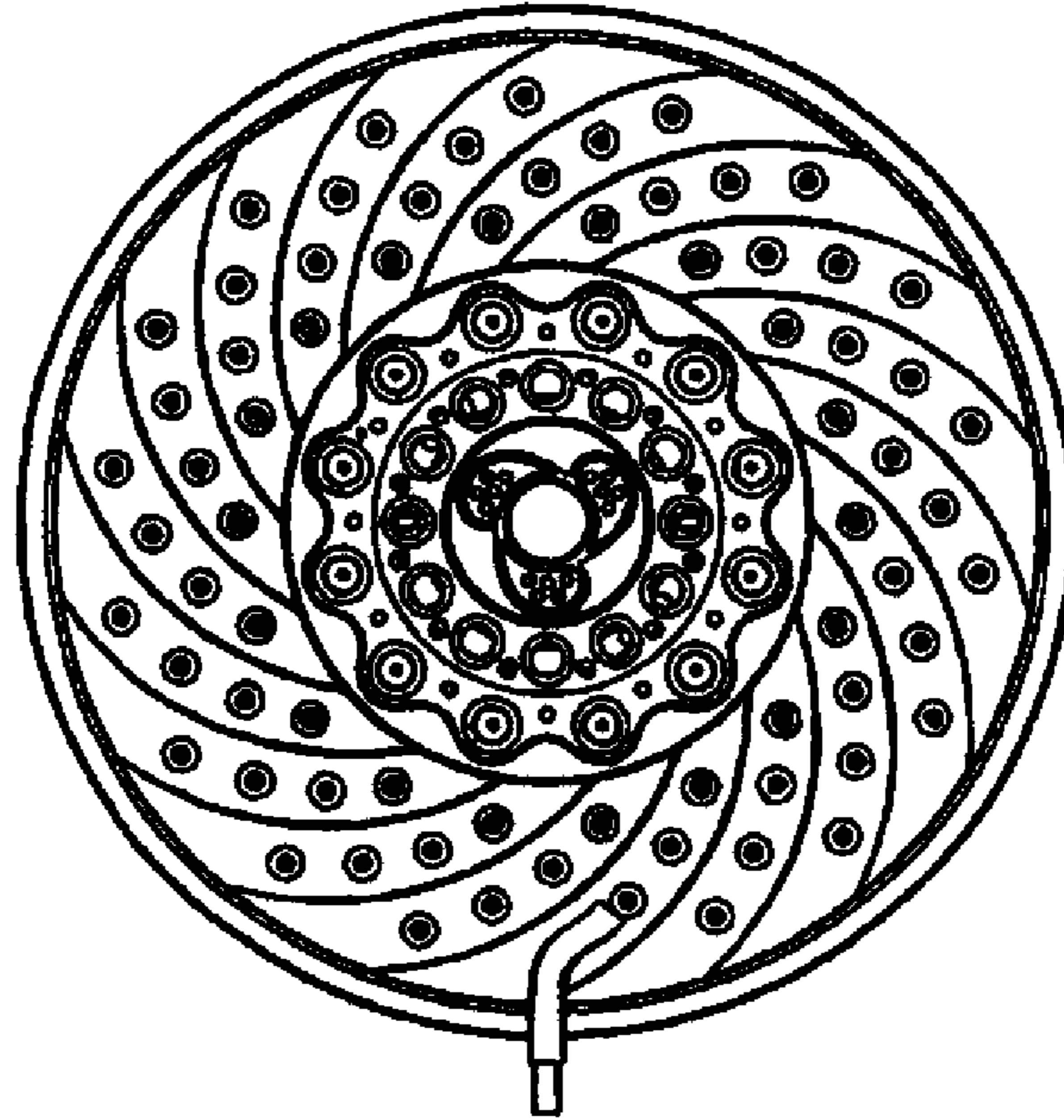

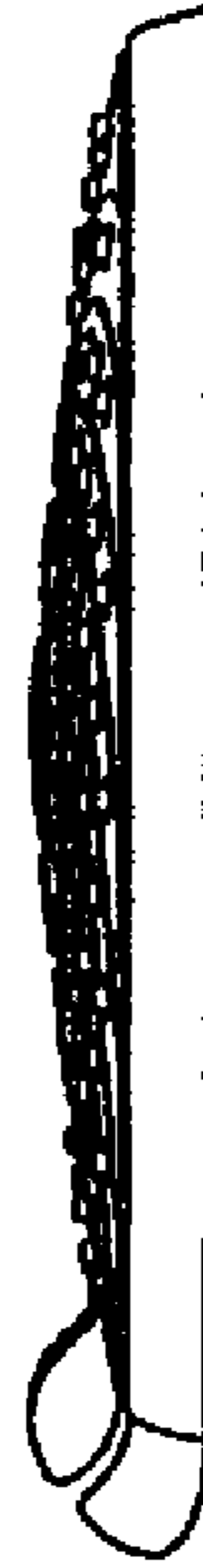

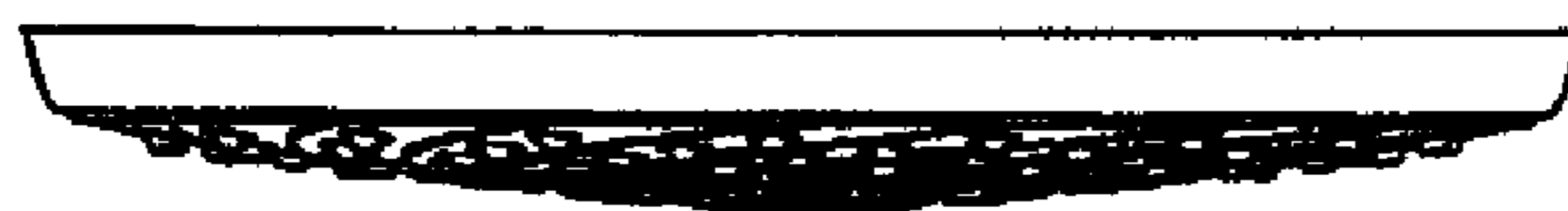

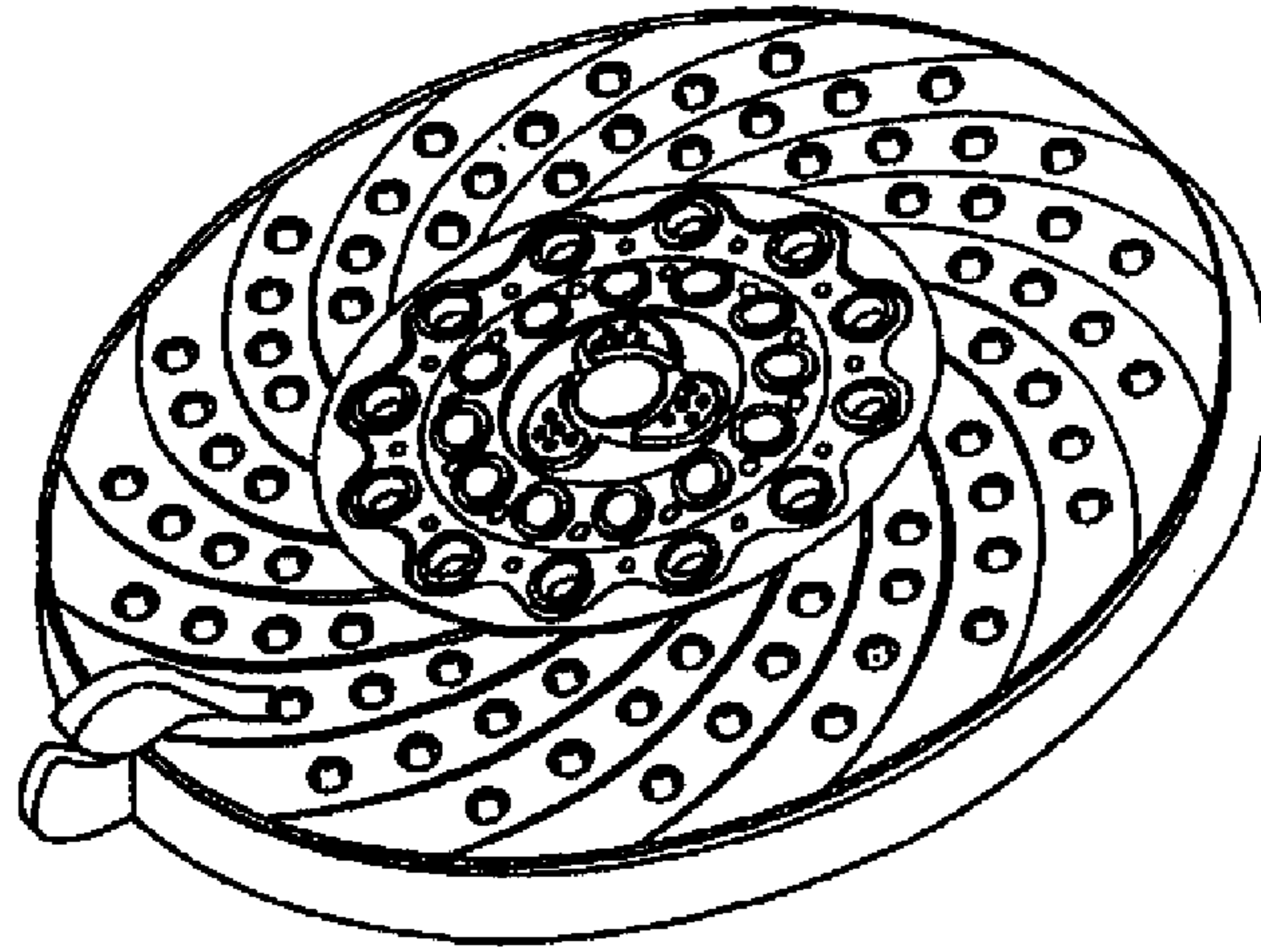
