(57) **CLAIM**

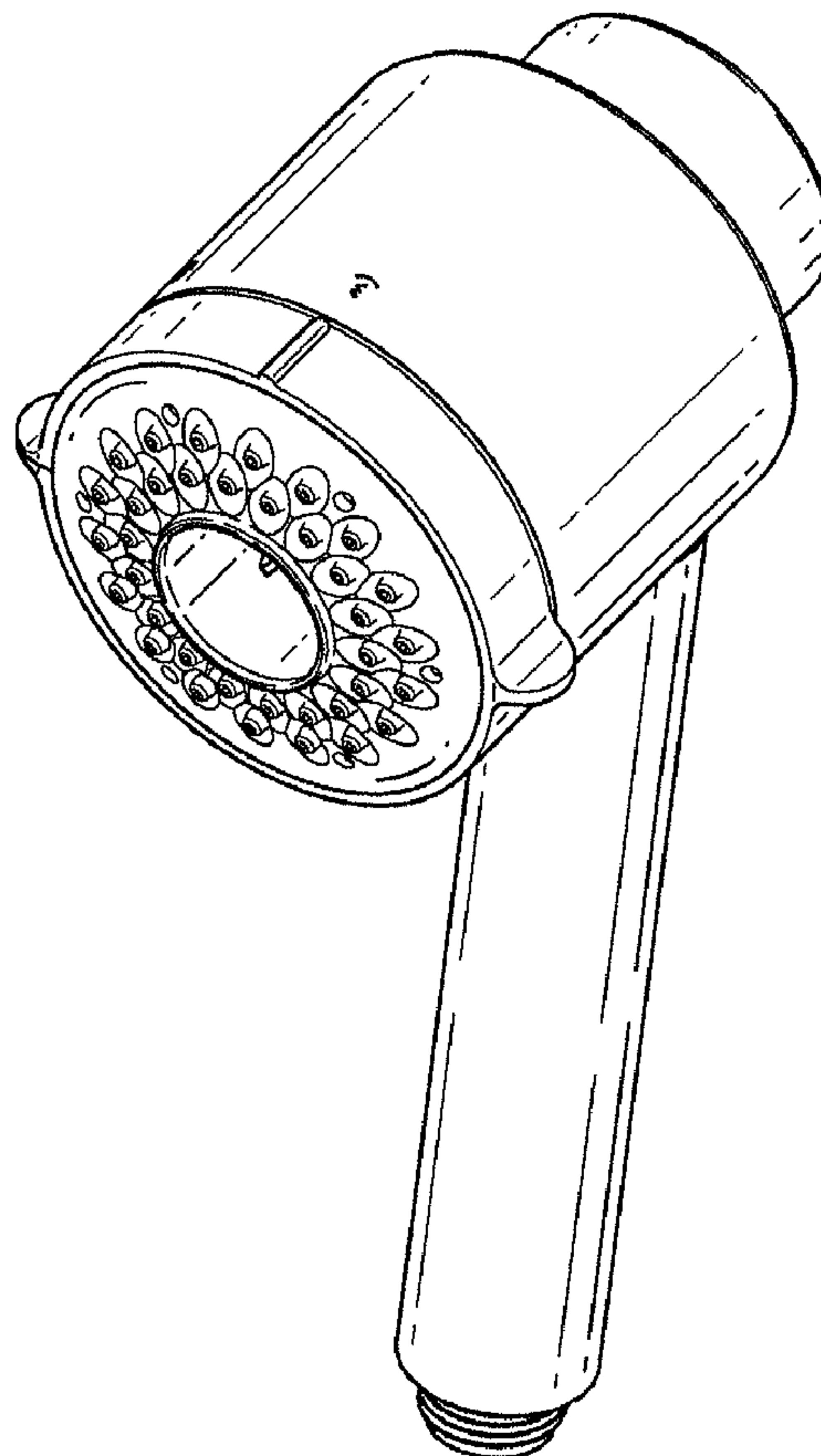
The ornamental design for a showerhead, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a showerhead;
FIG. 2 is a front view of the showerhead of FIG. 1;
FIG. 3 is a right side view of the showerhead of FIG. 1;
FIG. 4 is a left side view of the showerhead of FIG. 1;
FIG. 5 is a top view of the showerhead of FIG. 1;

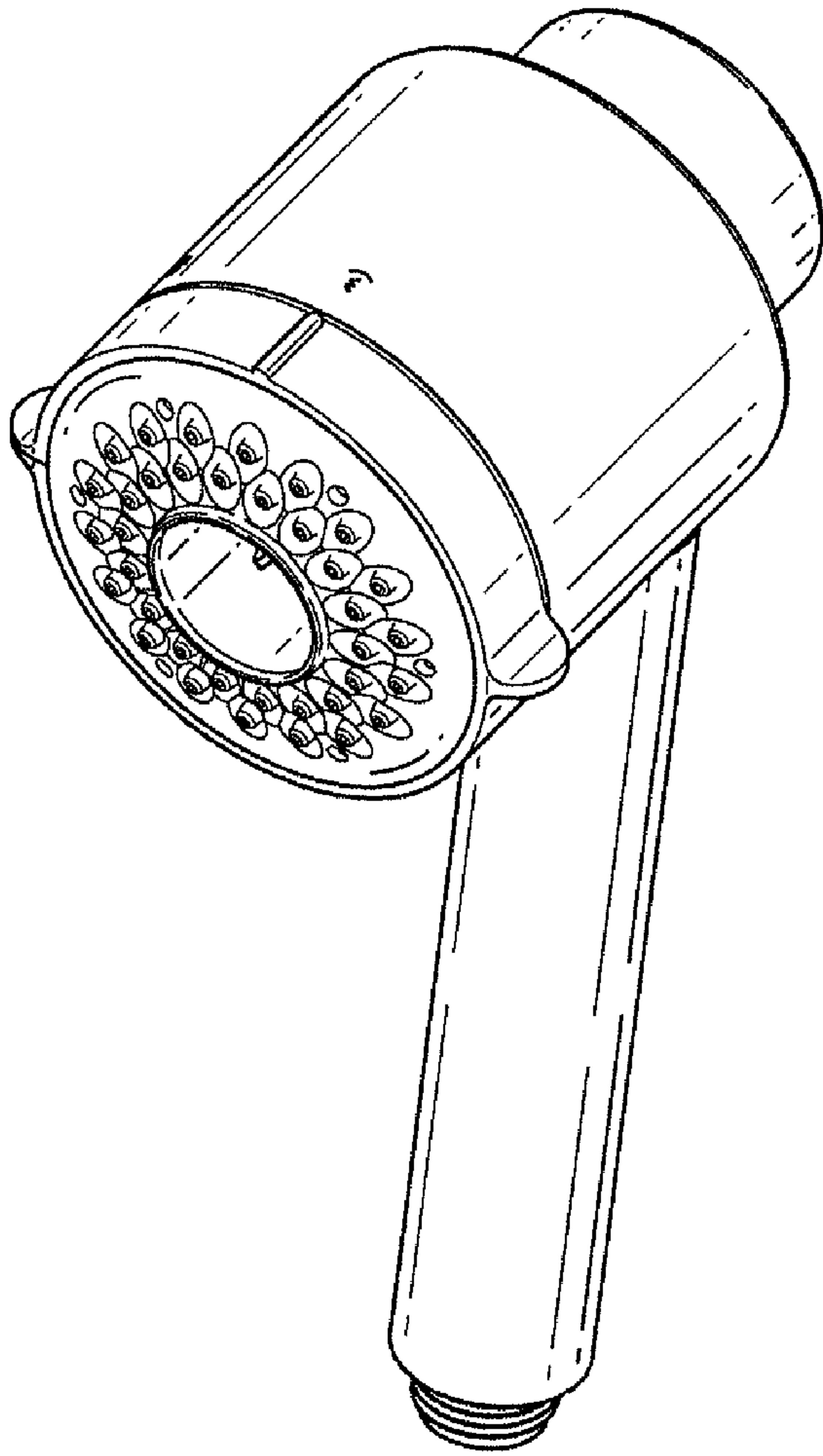

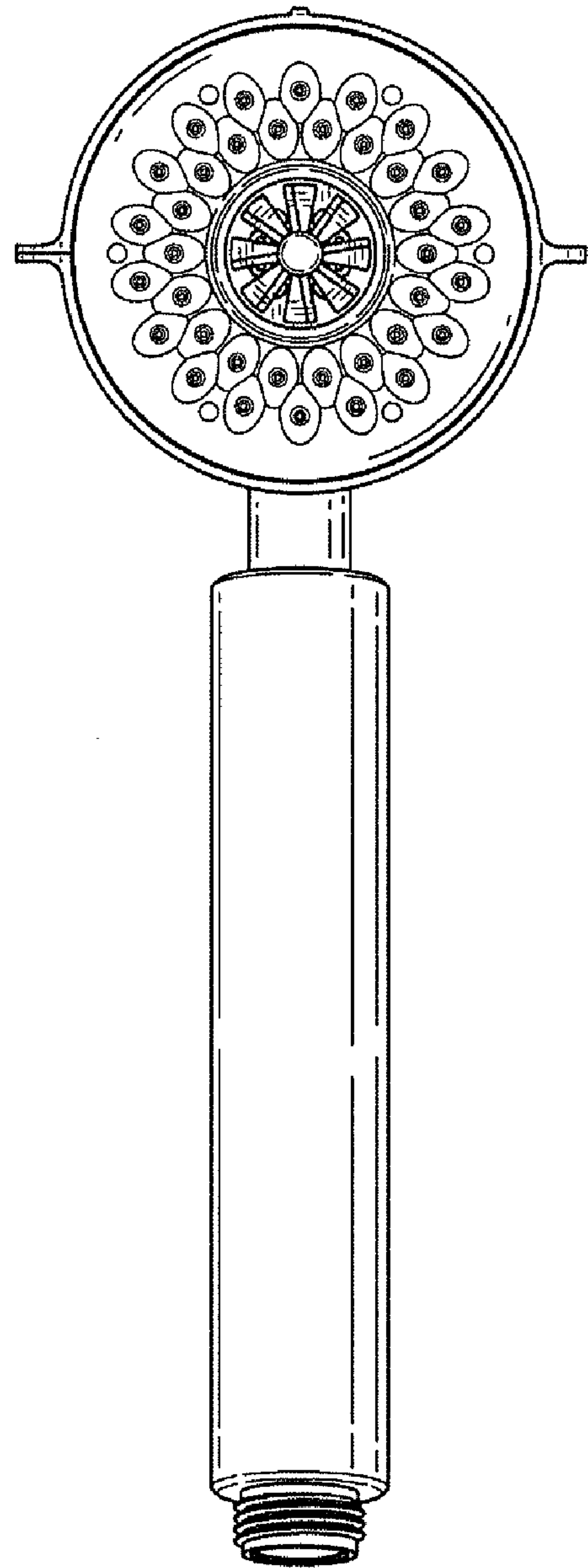

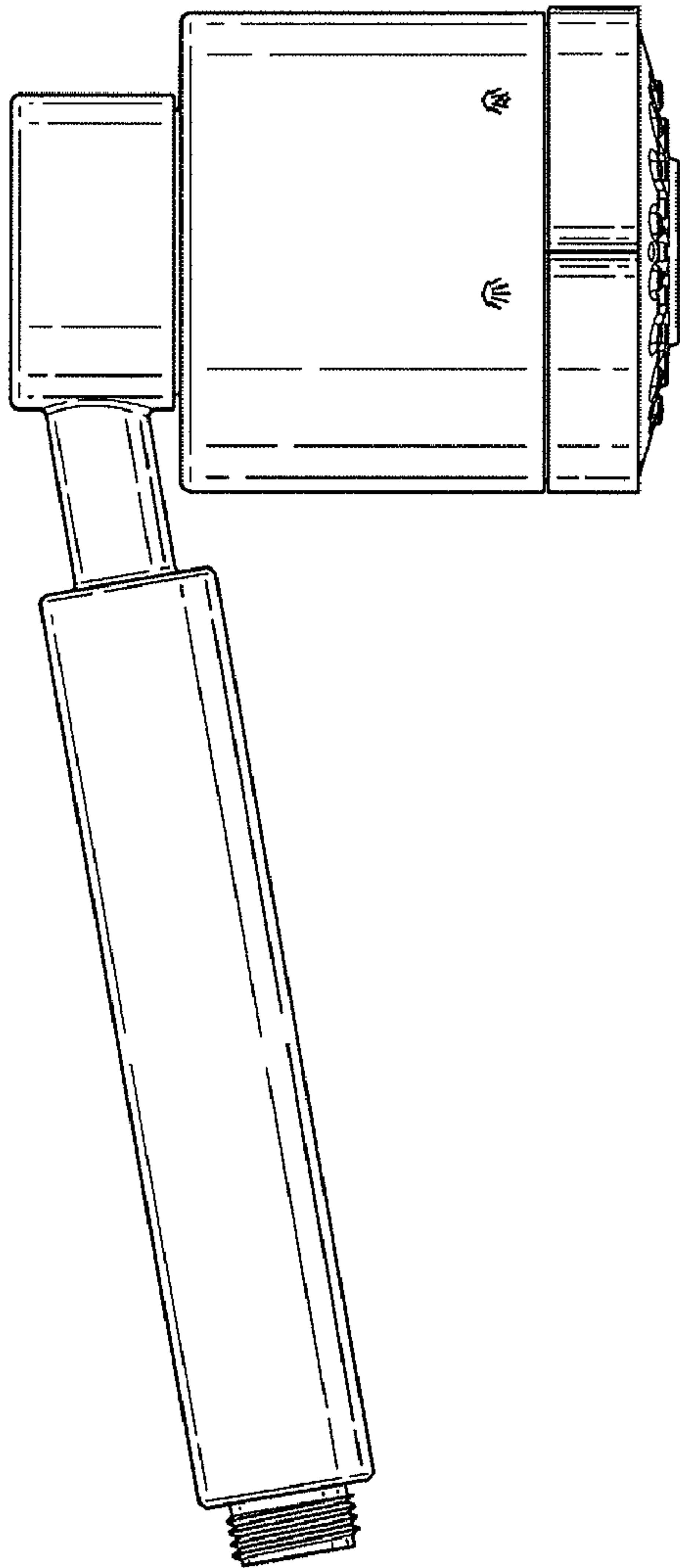

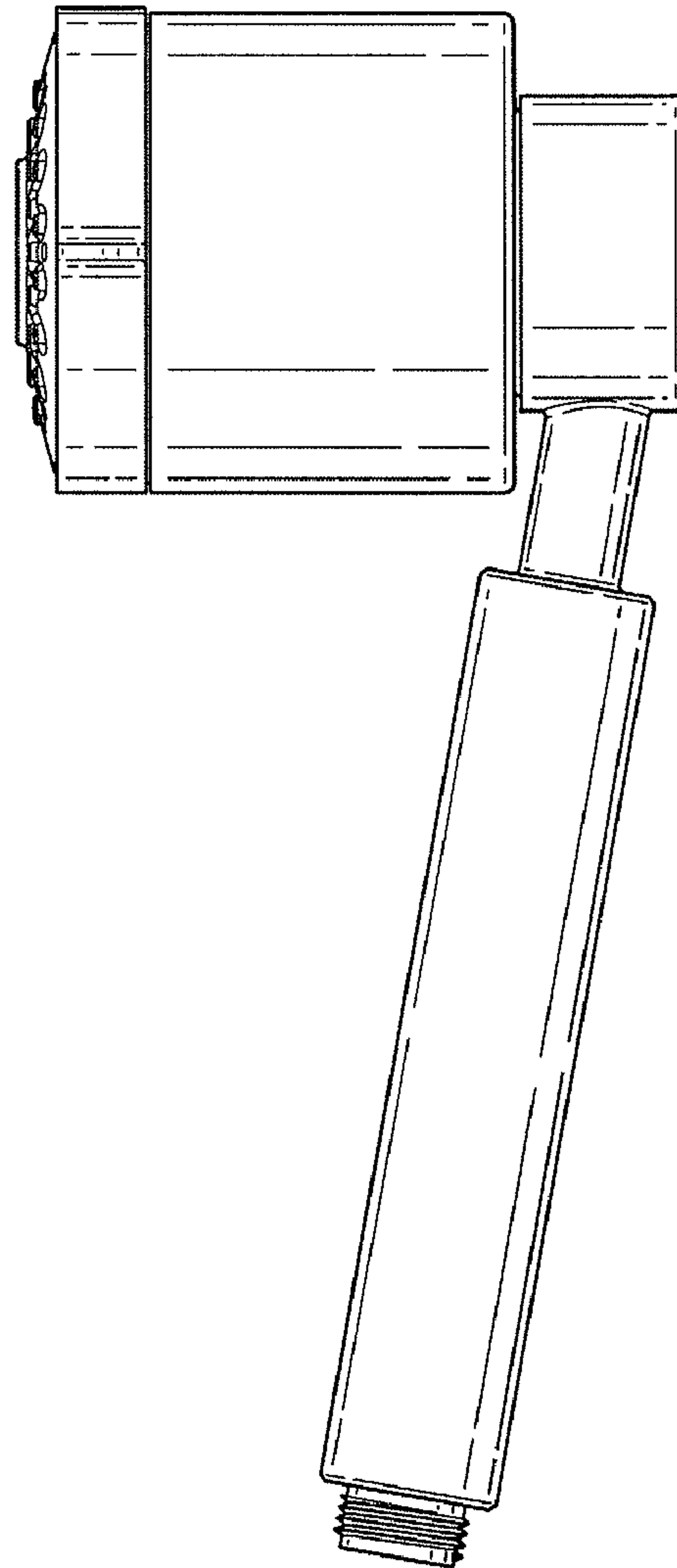

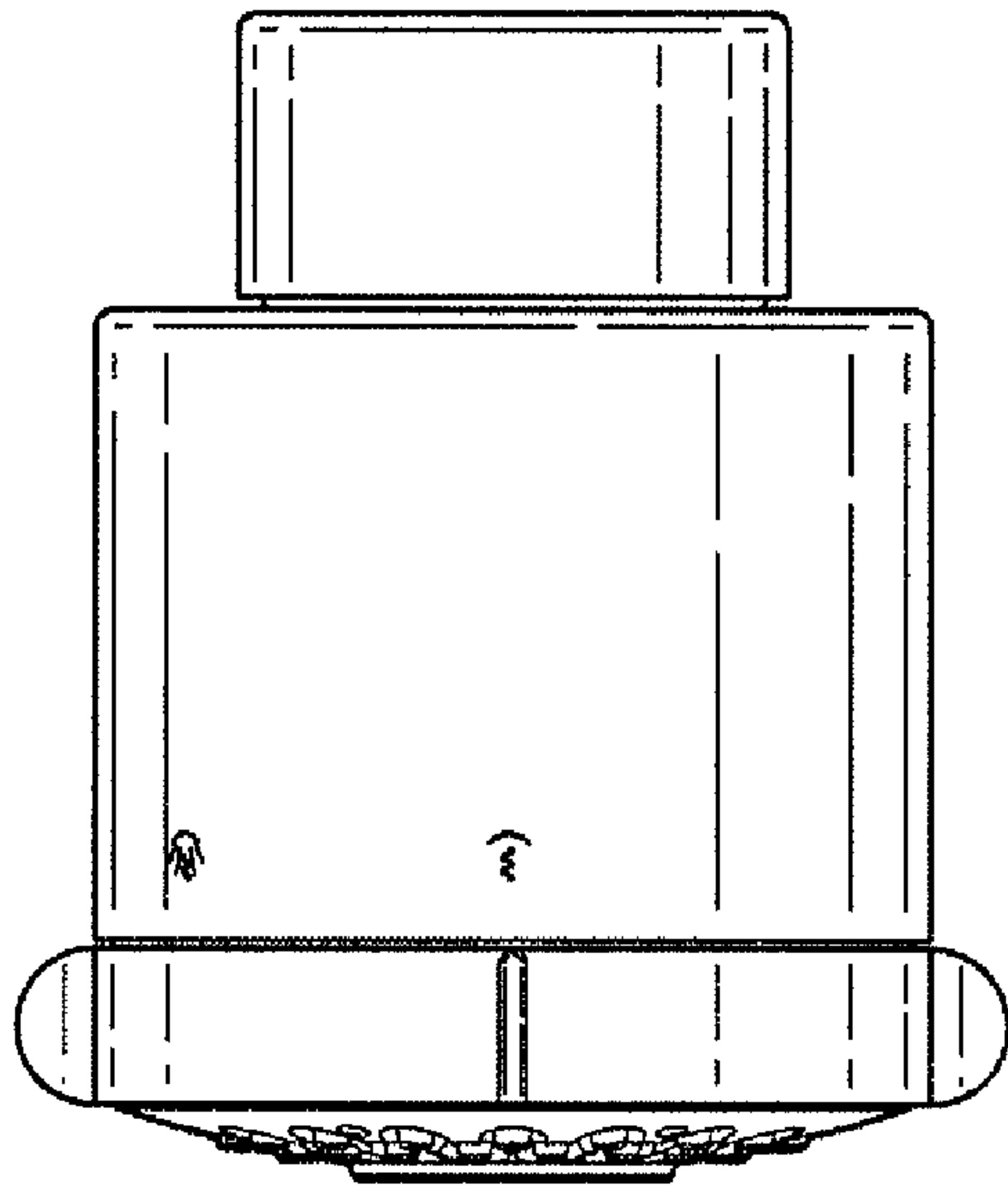

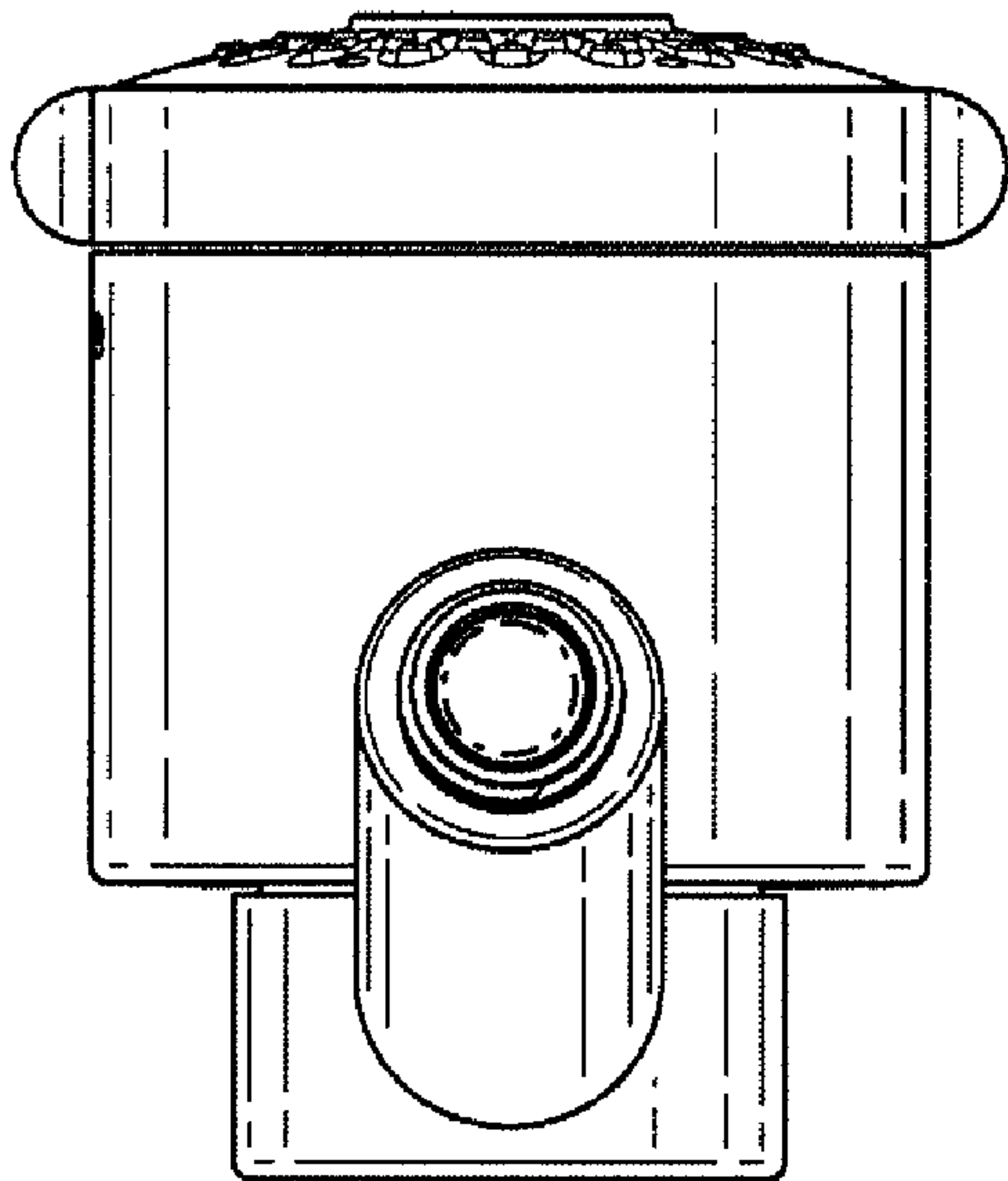

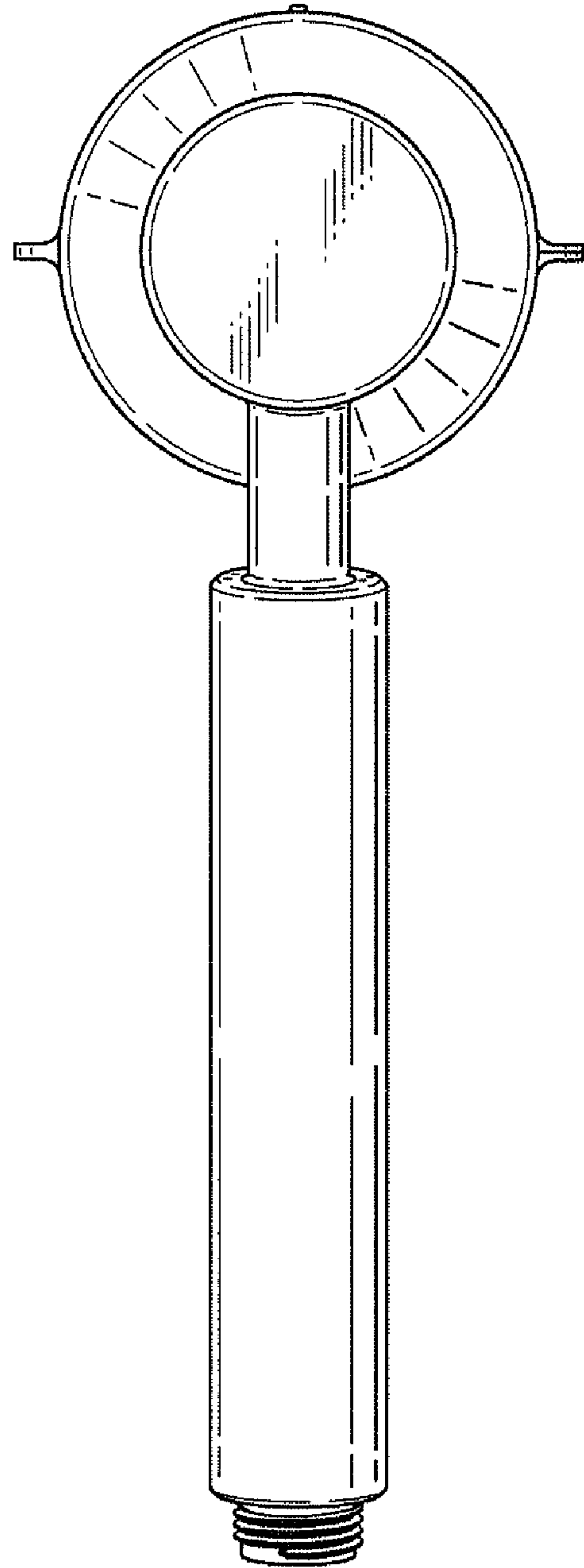
