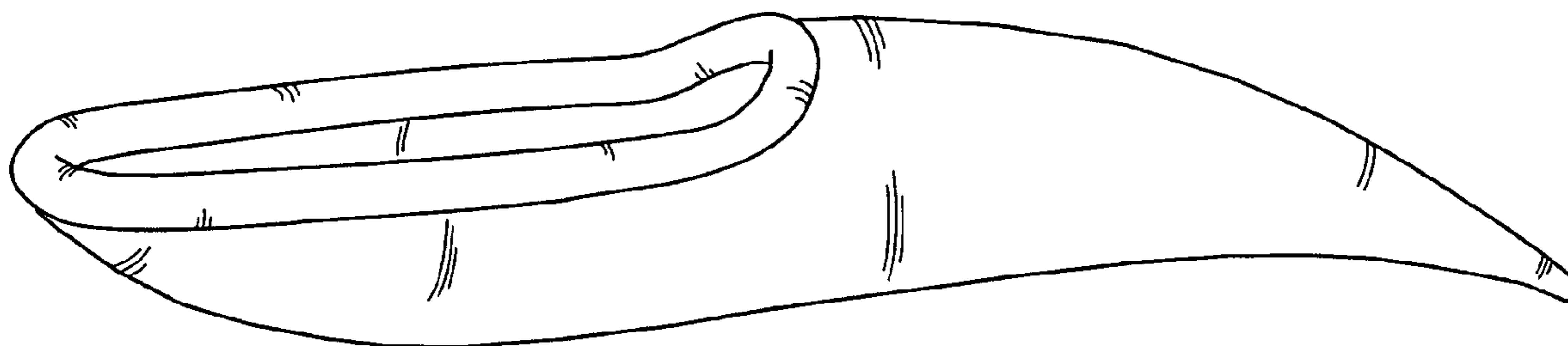
(57) **CLAIM**

DESCRIPTION

FIG. 1 is an isometric view of a portable urinal for women, as shown and described;
FIG. 2 is a front view thereof;
FIG. 3 is a rear view thereof;
FIG. 4 is a right side view with a left side view being the mirror image thereof;
FIG. 5 is a top view thereof, shown at a smaller scale; and,

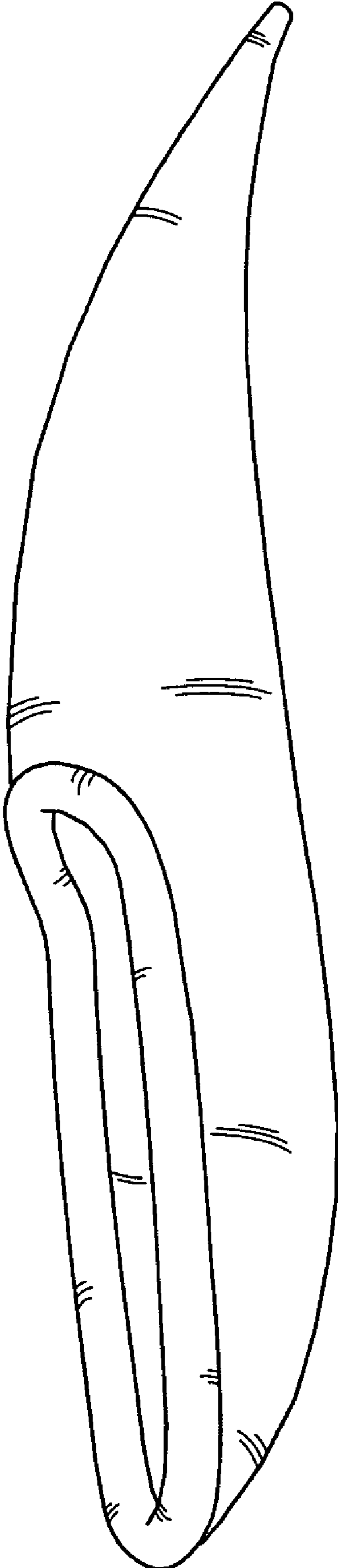

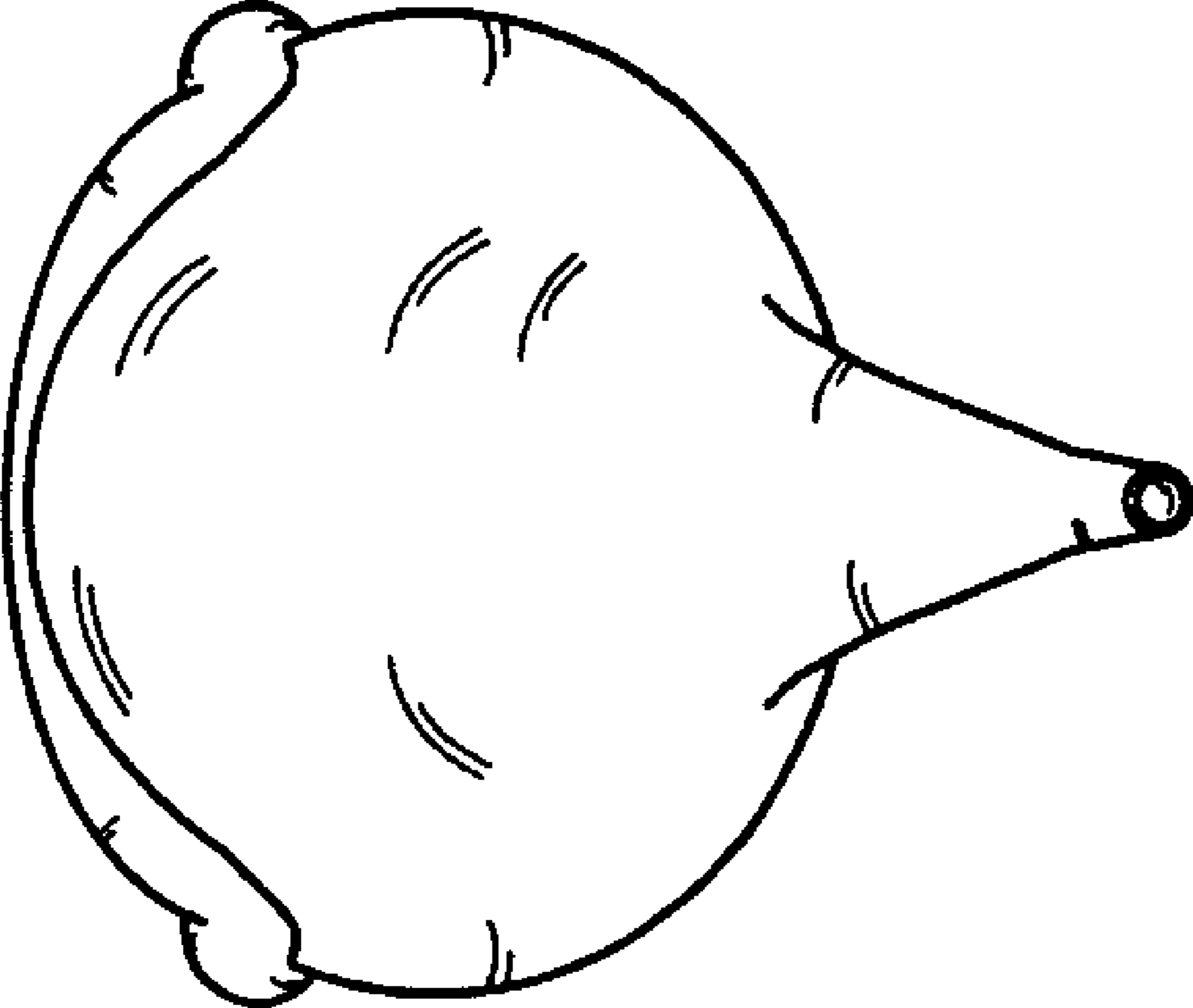

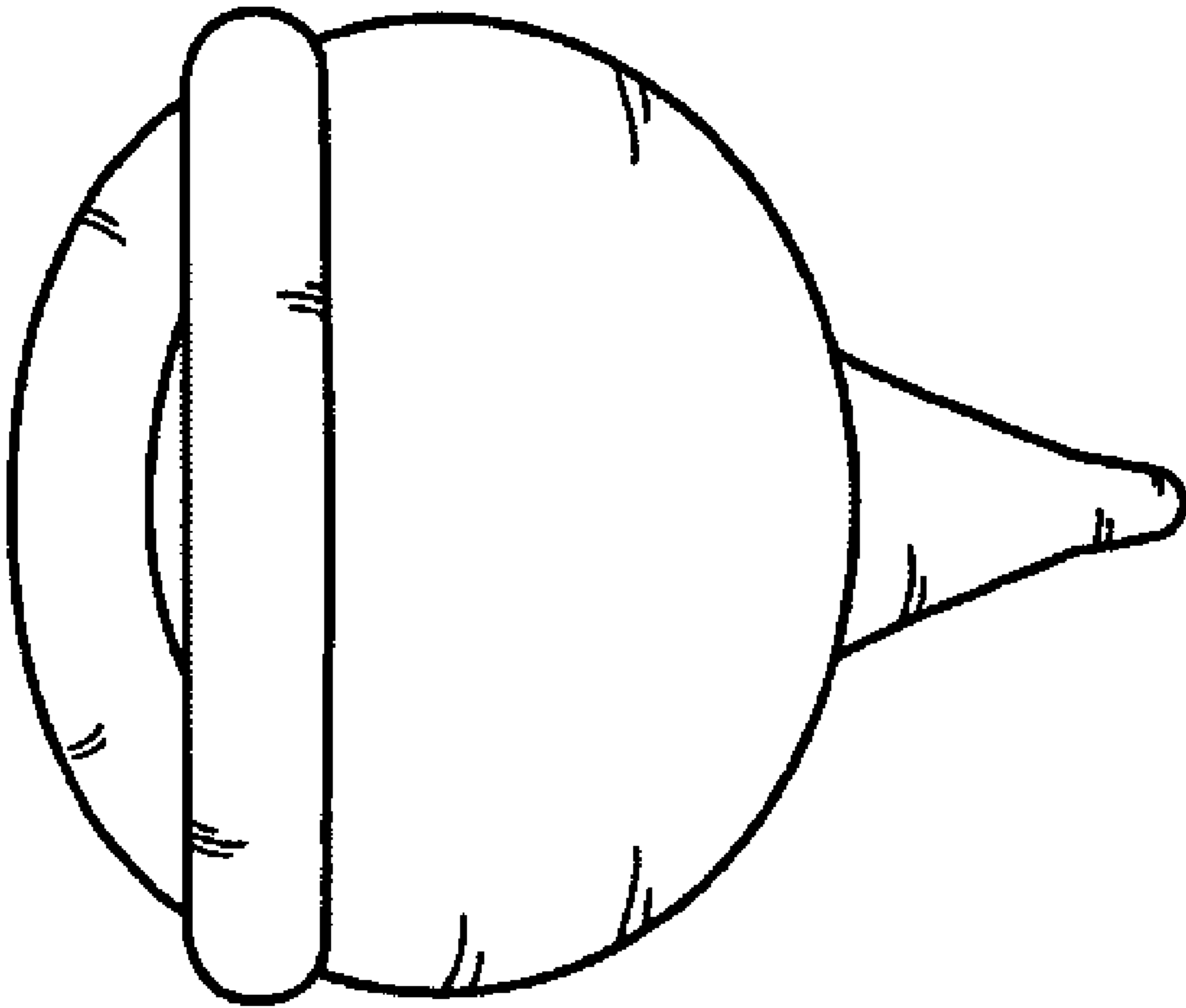

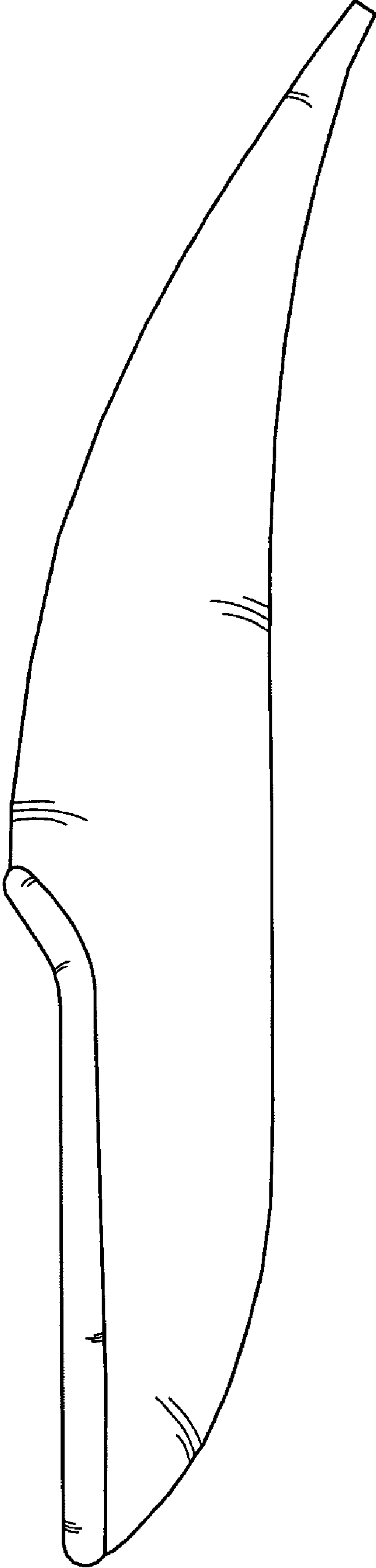

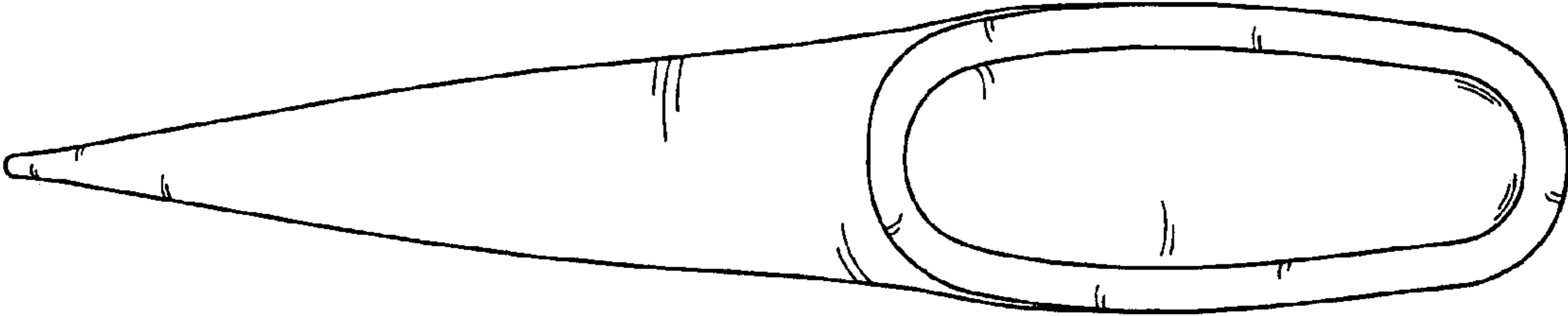

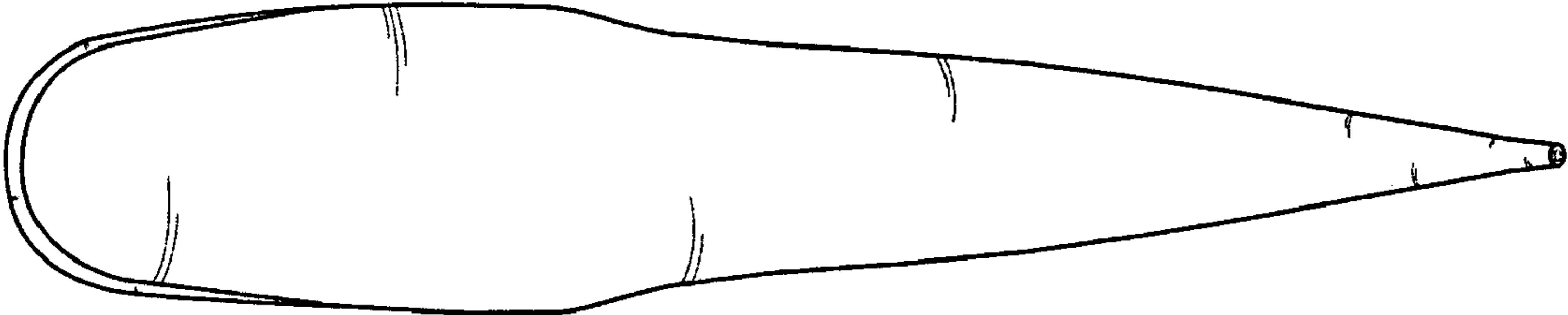
