FIG. 5 is a top plan view of a massage device showing our design;

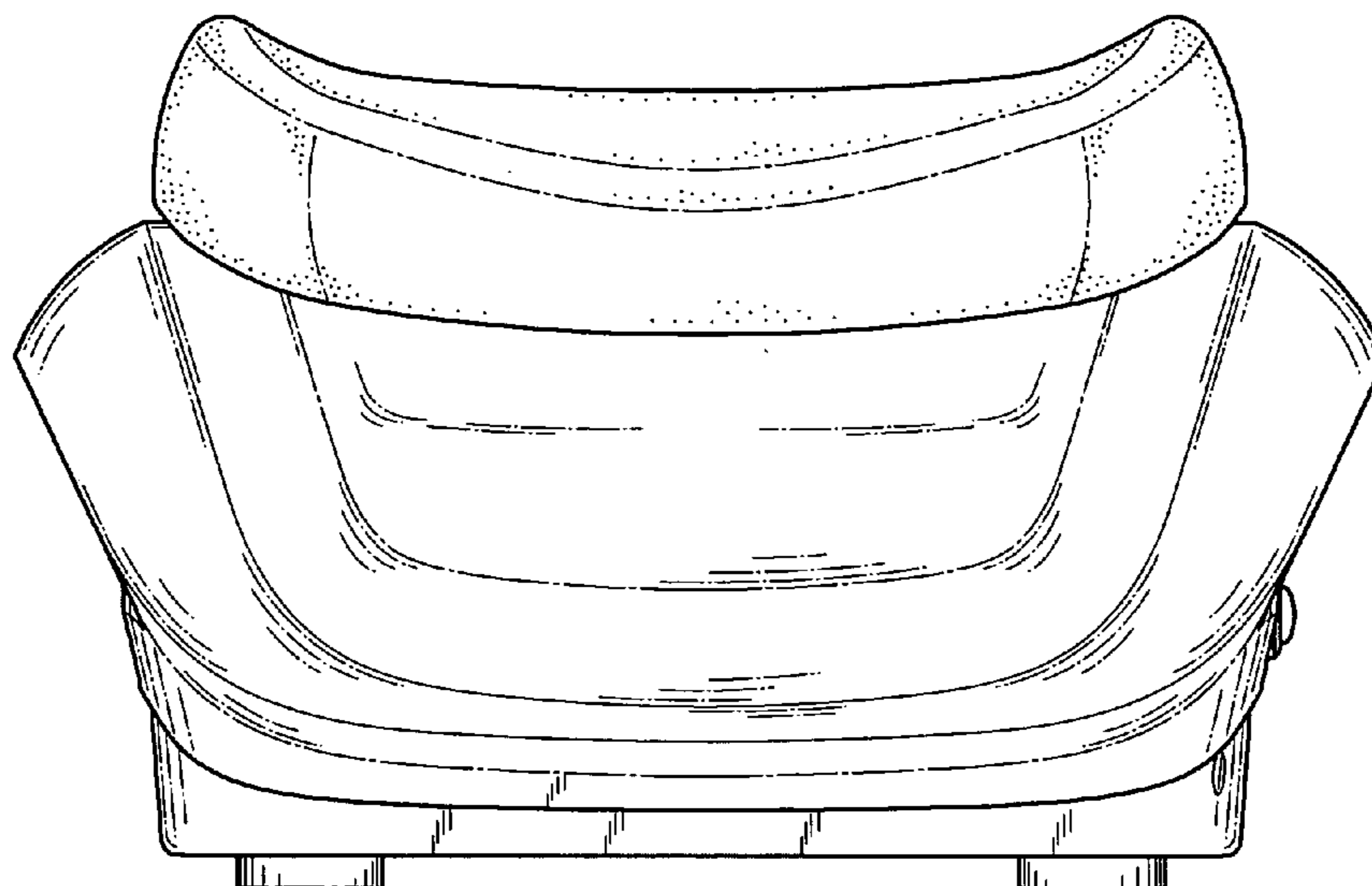
FIG. 6 is a bottom plan view of a massage device showing our design;

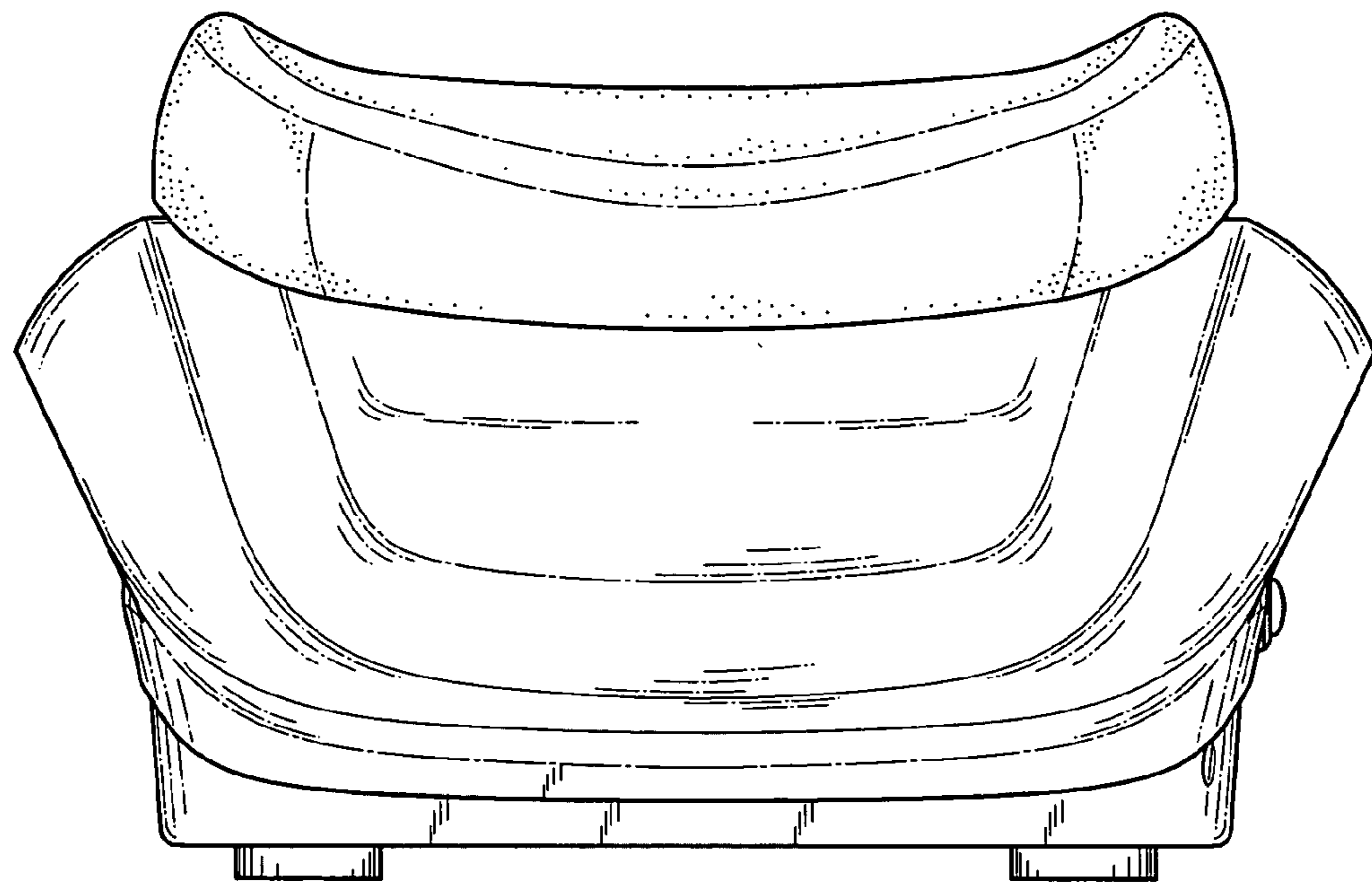

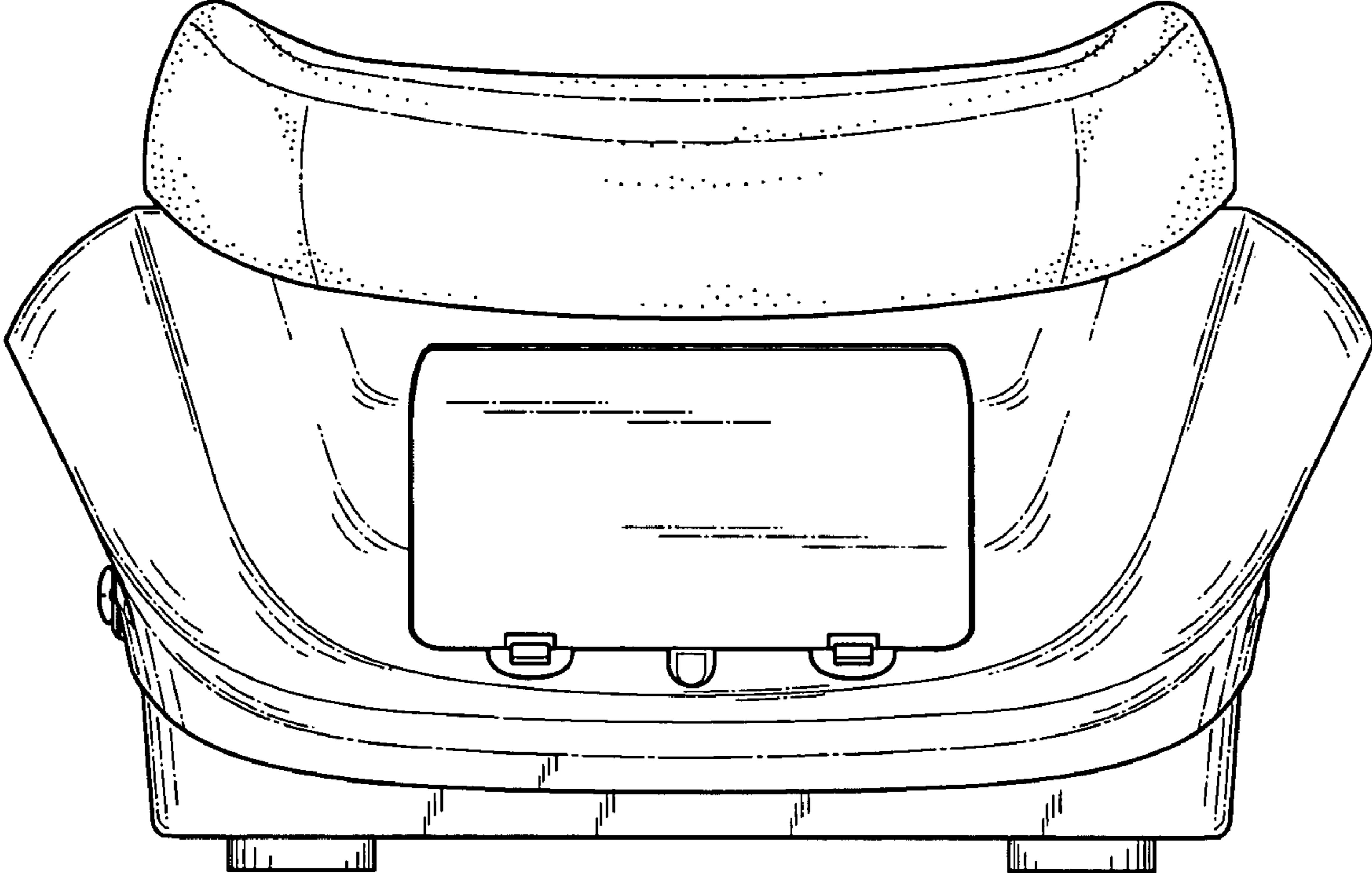

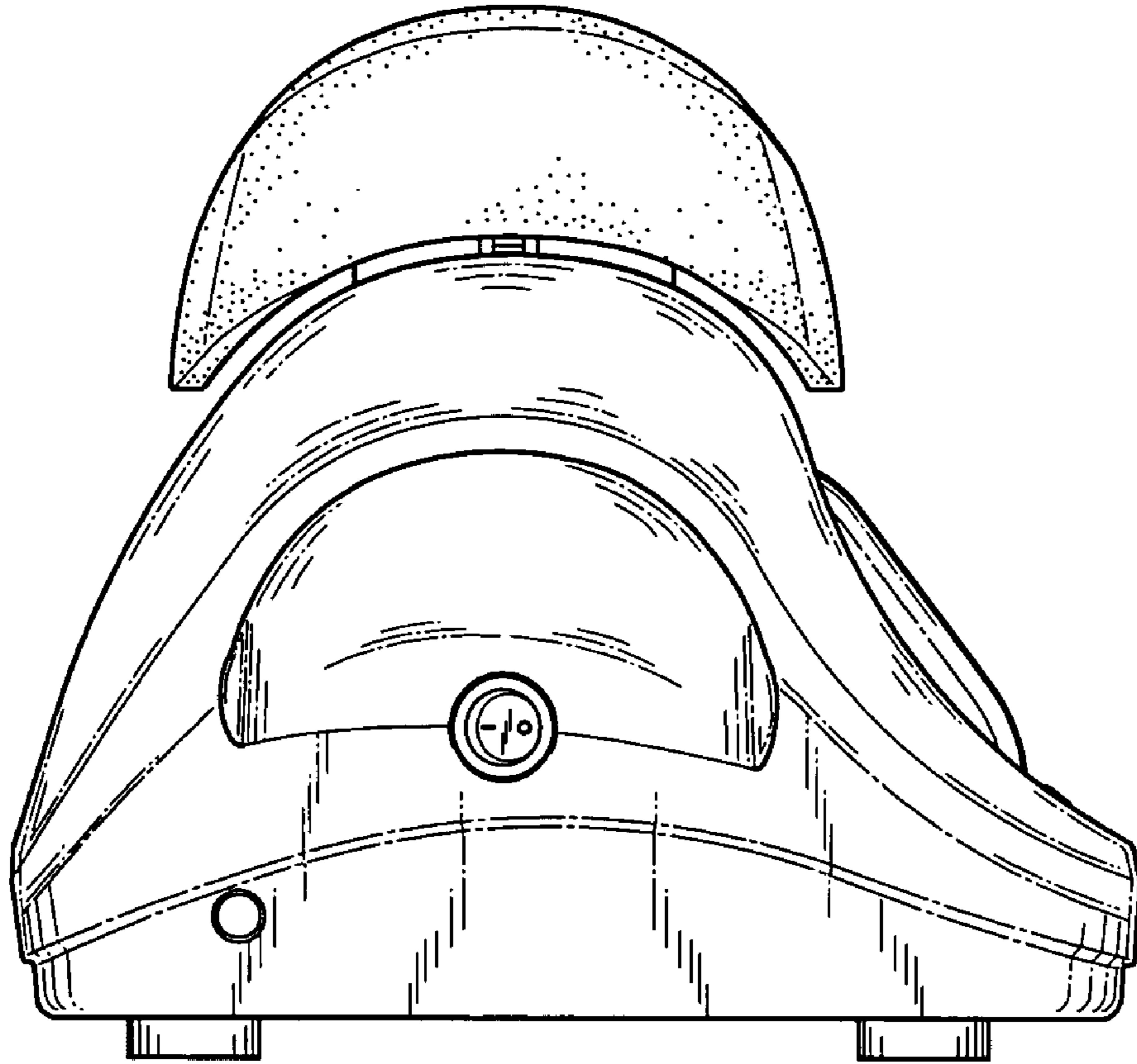

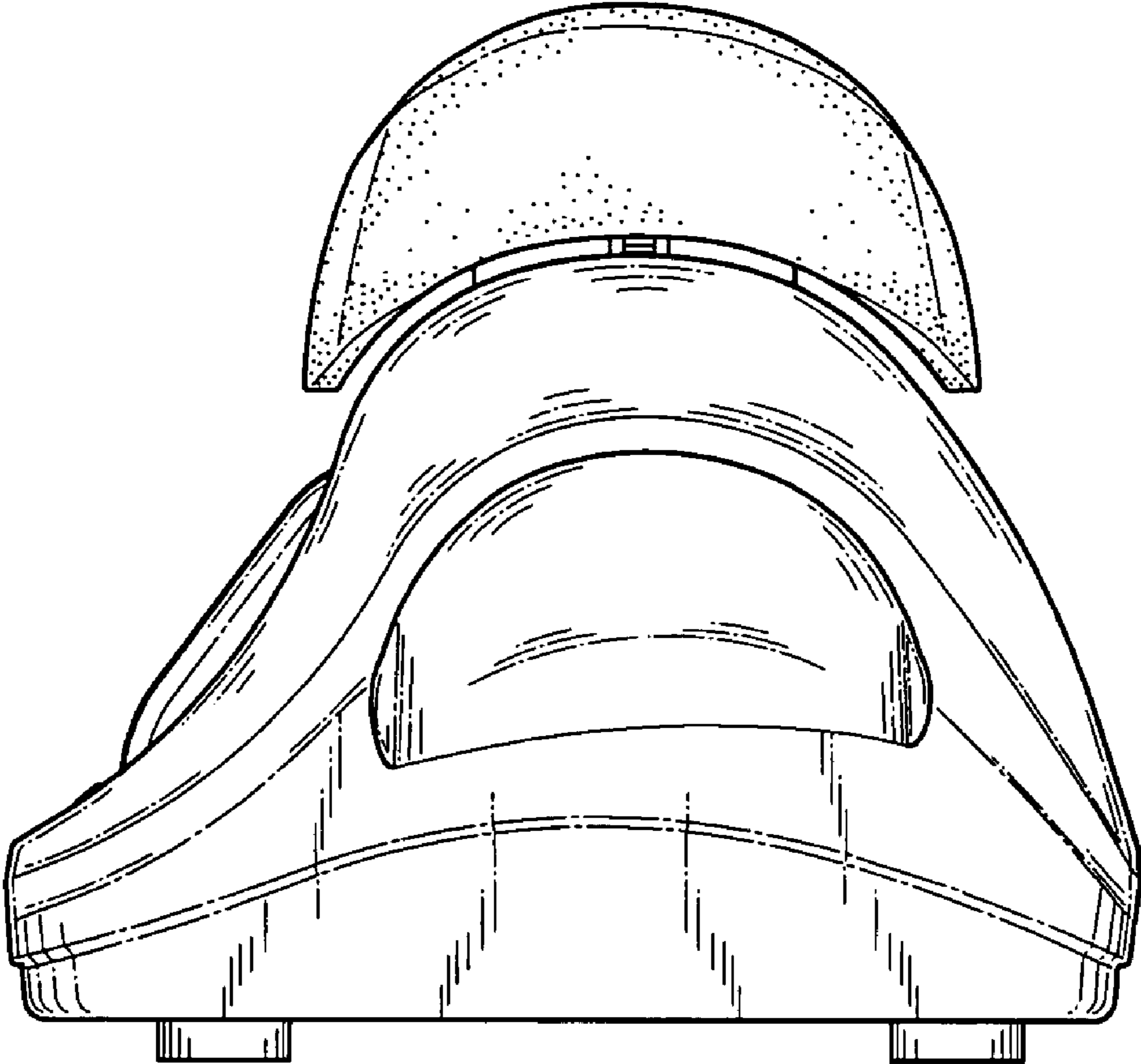

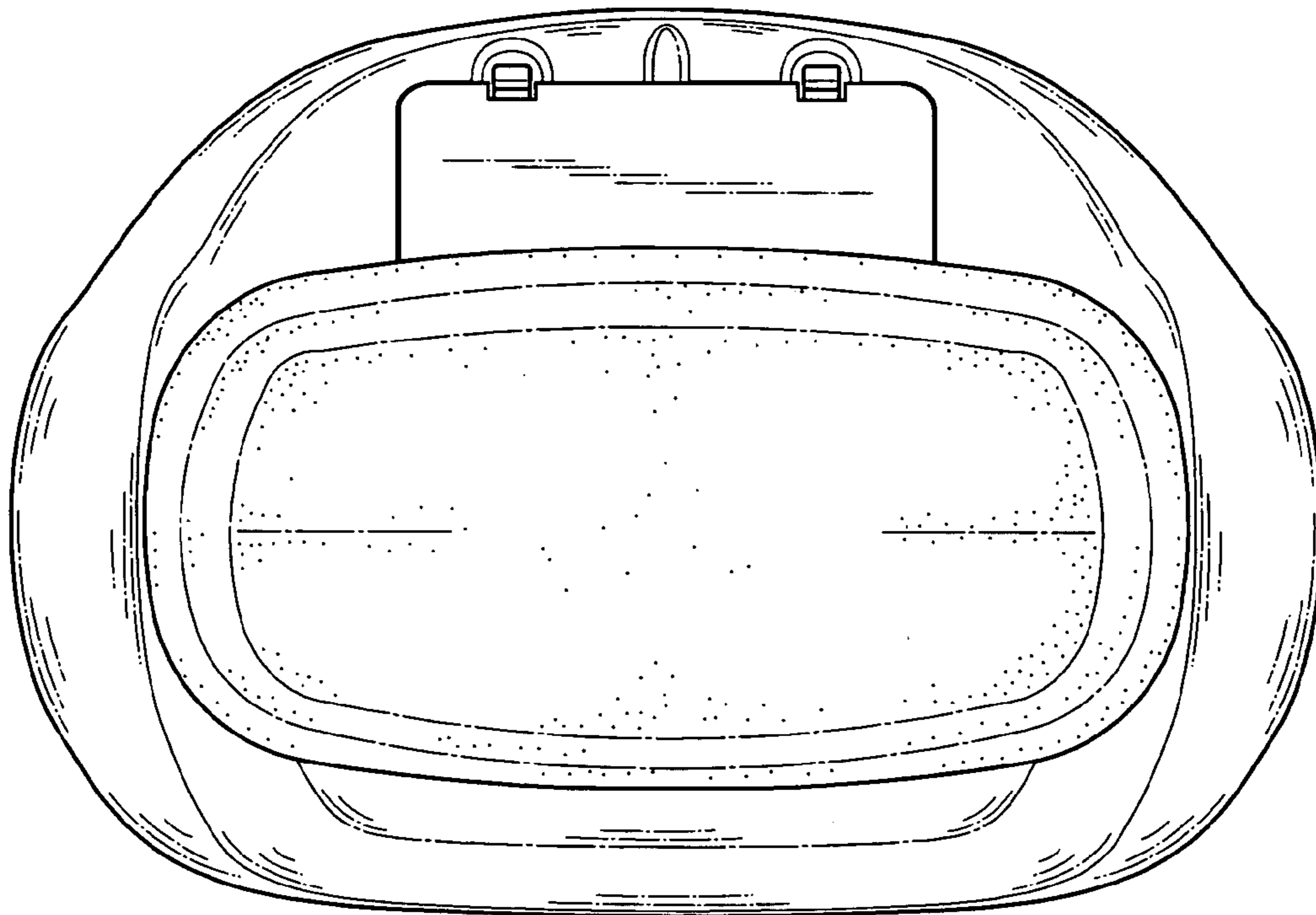

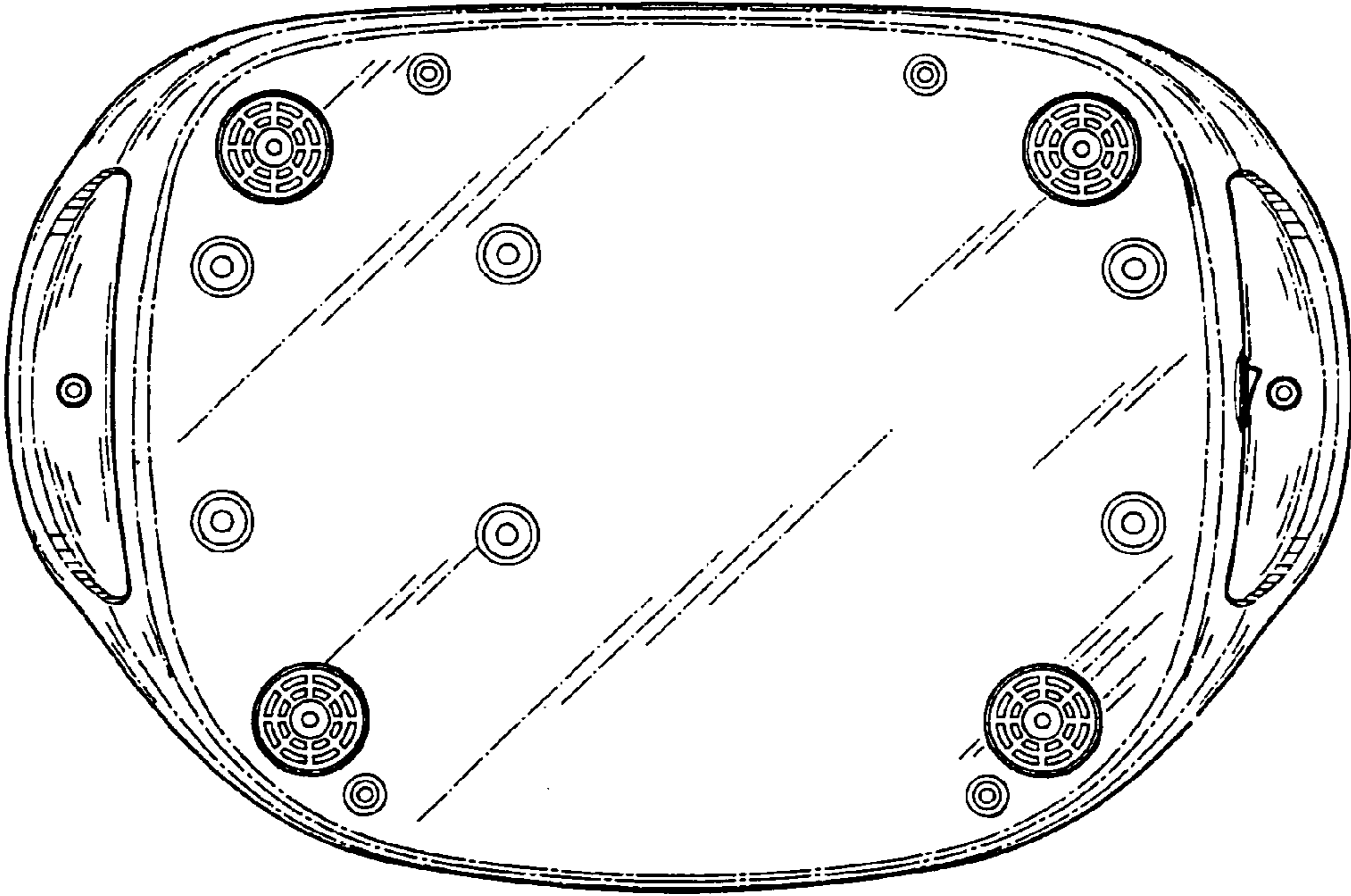

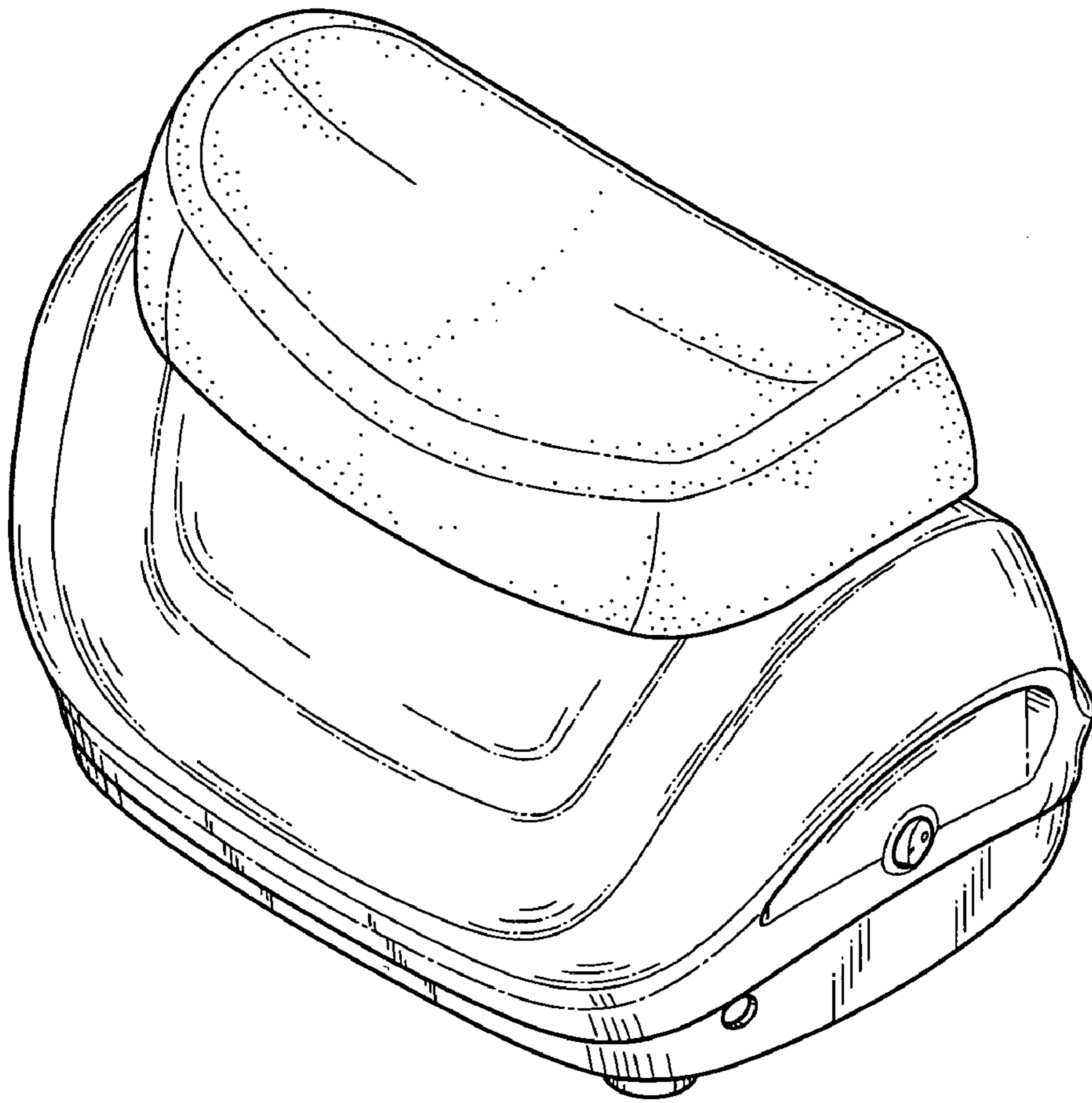

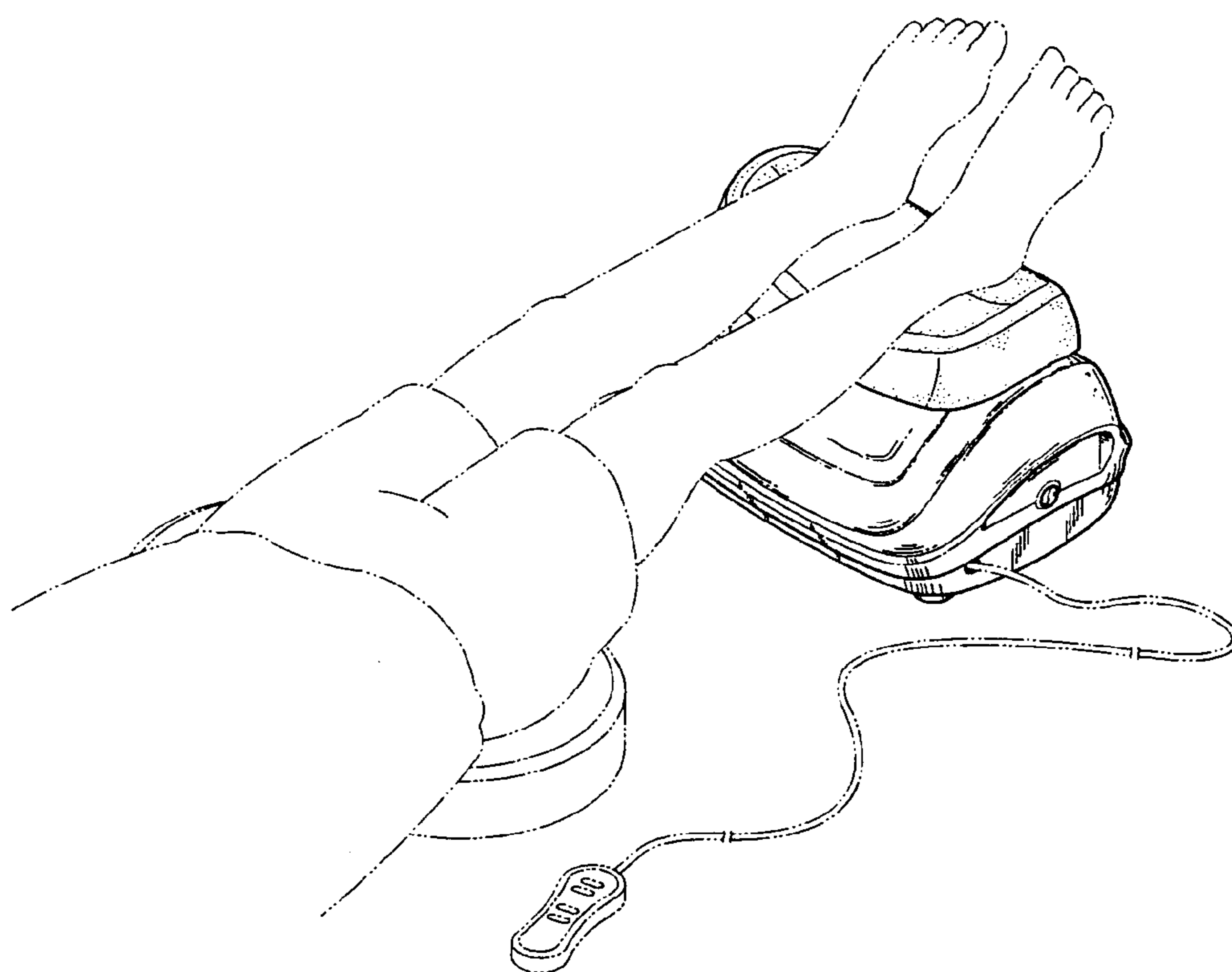
