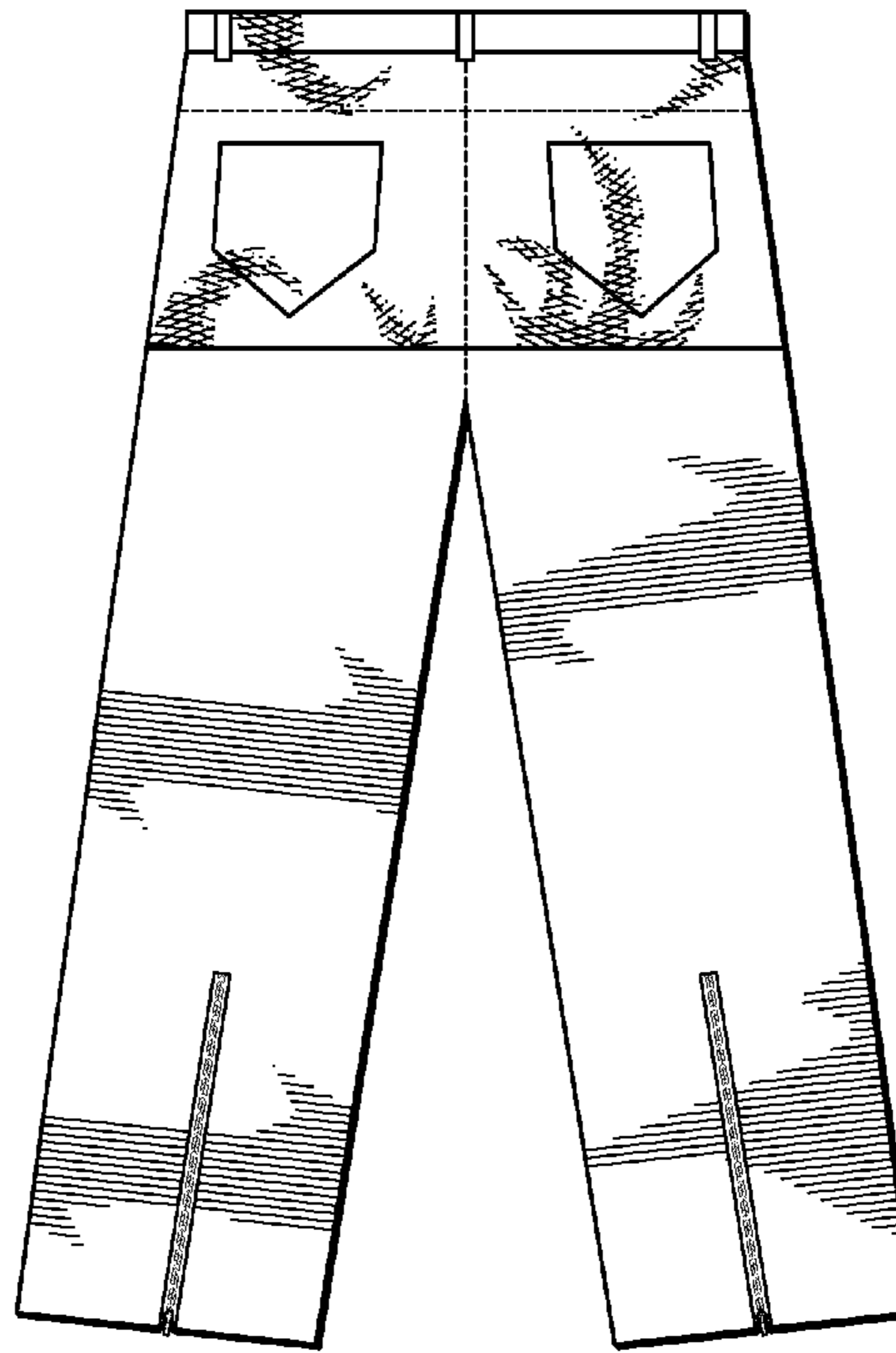
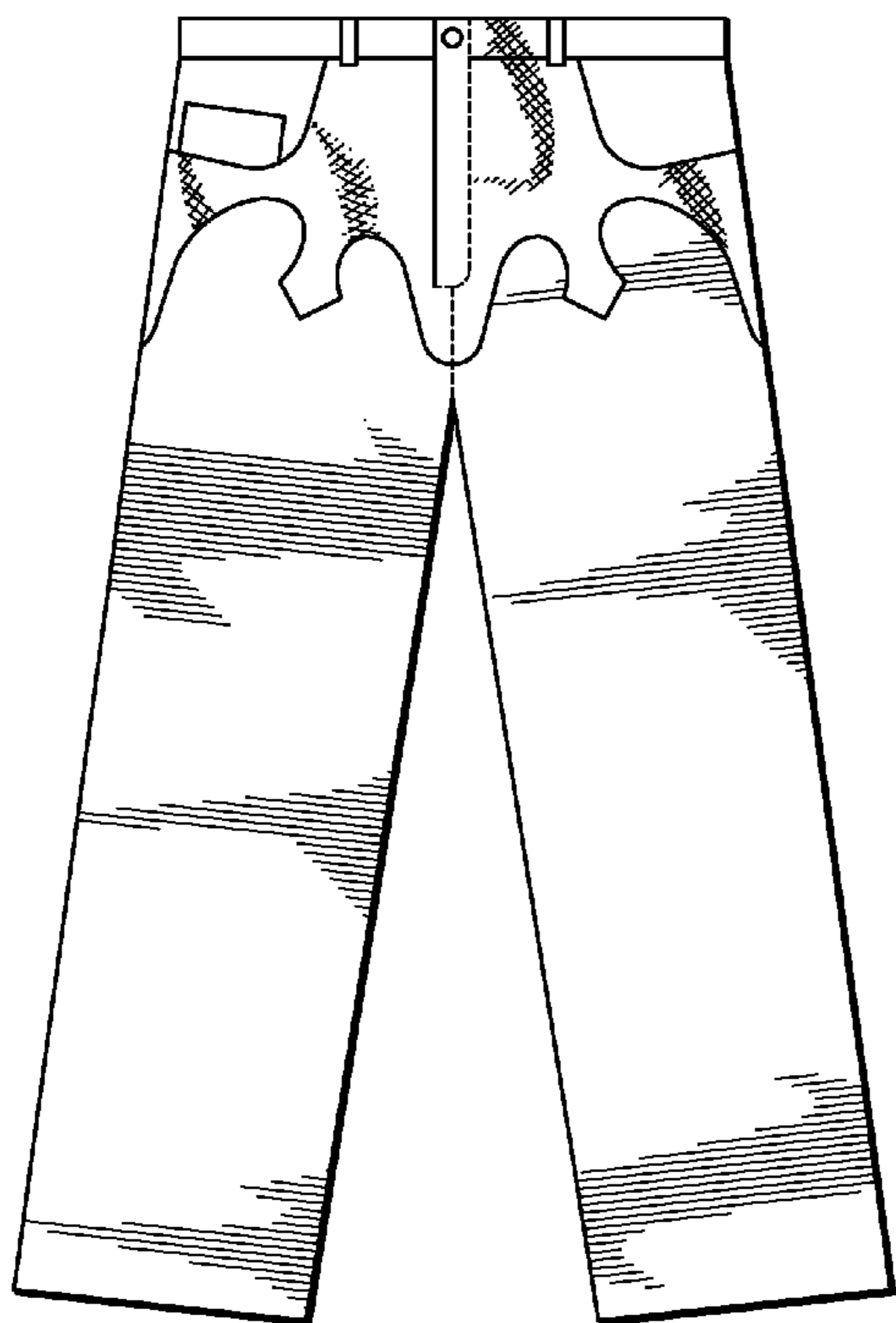
The ornamental design for a pant, as shown and described.

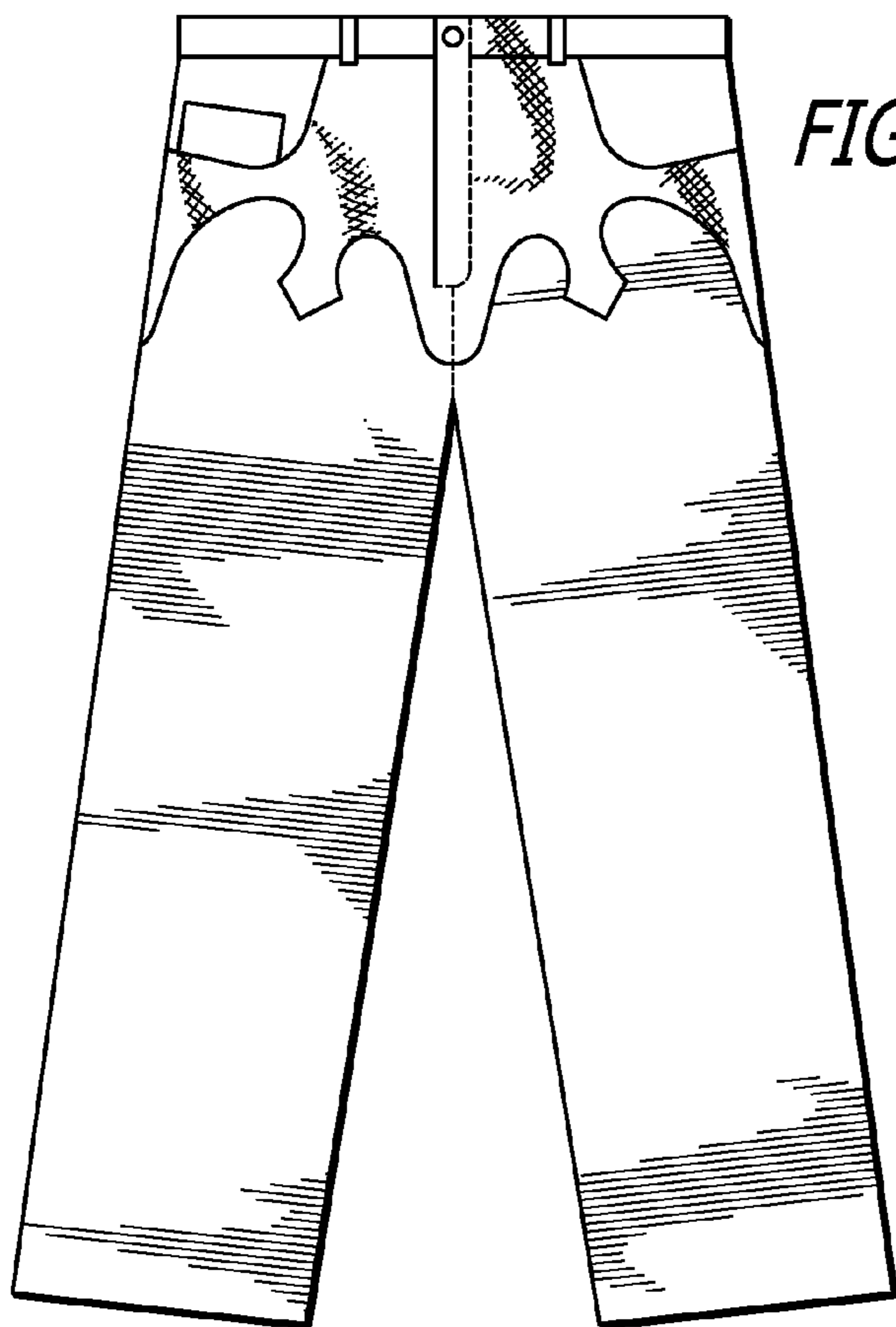

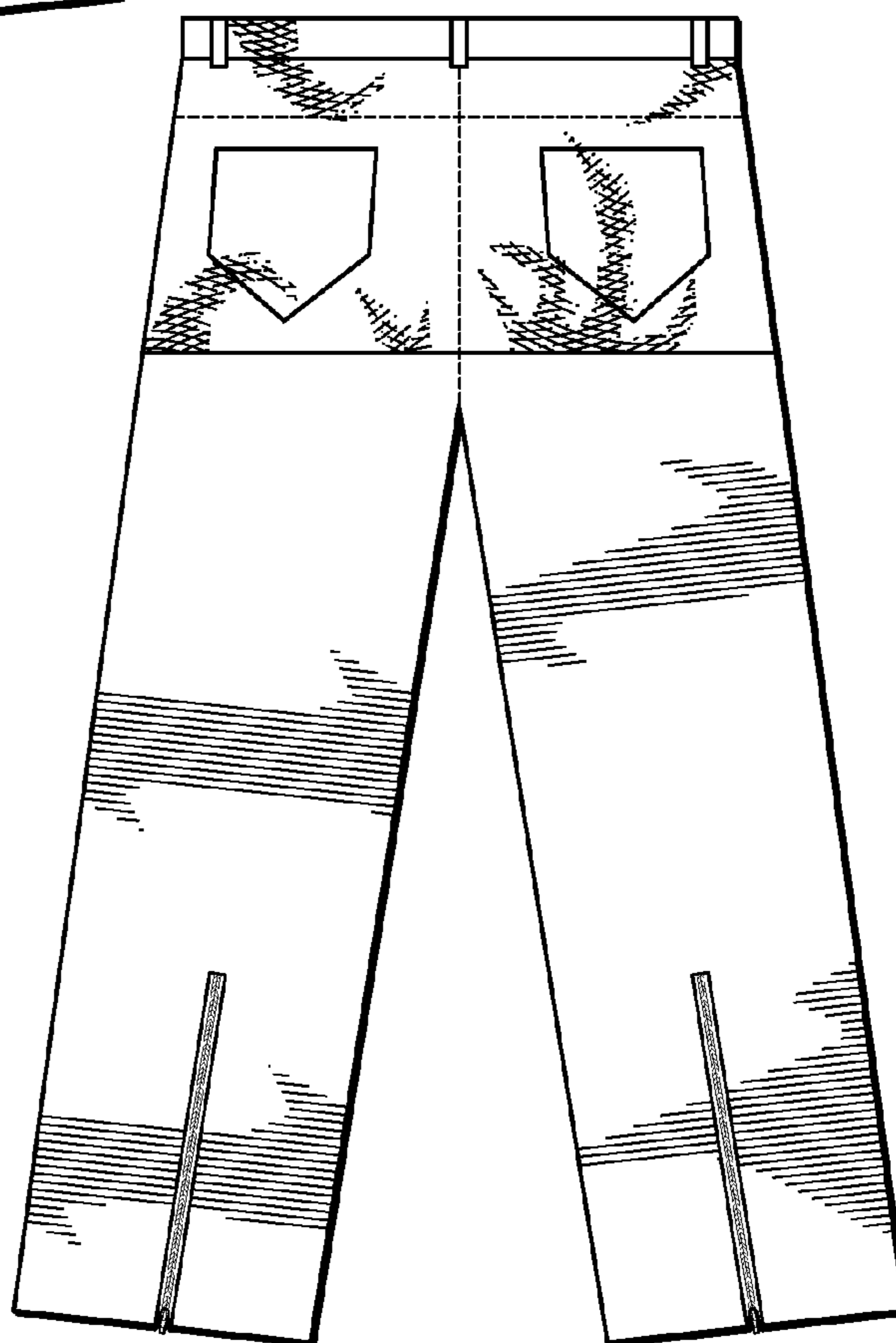
