**DESCRIPTION**

FIG. 1 is a perspective view of a playpen with bassinet showing our new design;

FIG. 2 is a front elevation view of the playpen with bassinet shown in FIG. 1;

FIG. 3 is a rear elevation view of the playpen with bassinet shown in FIG. 1;

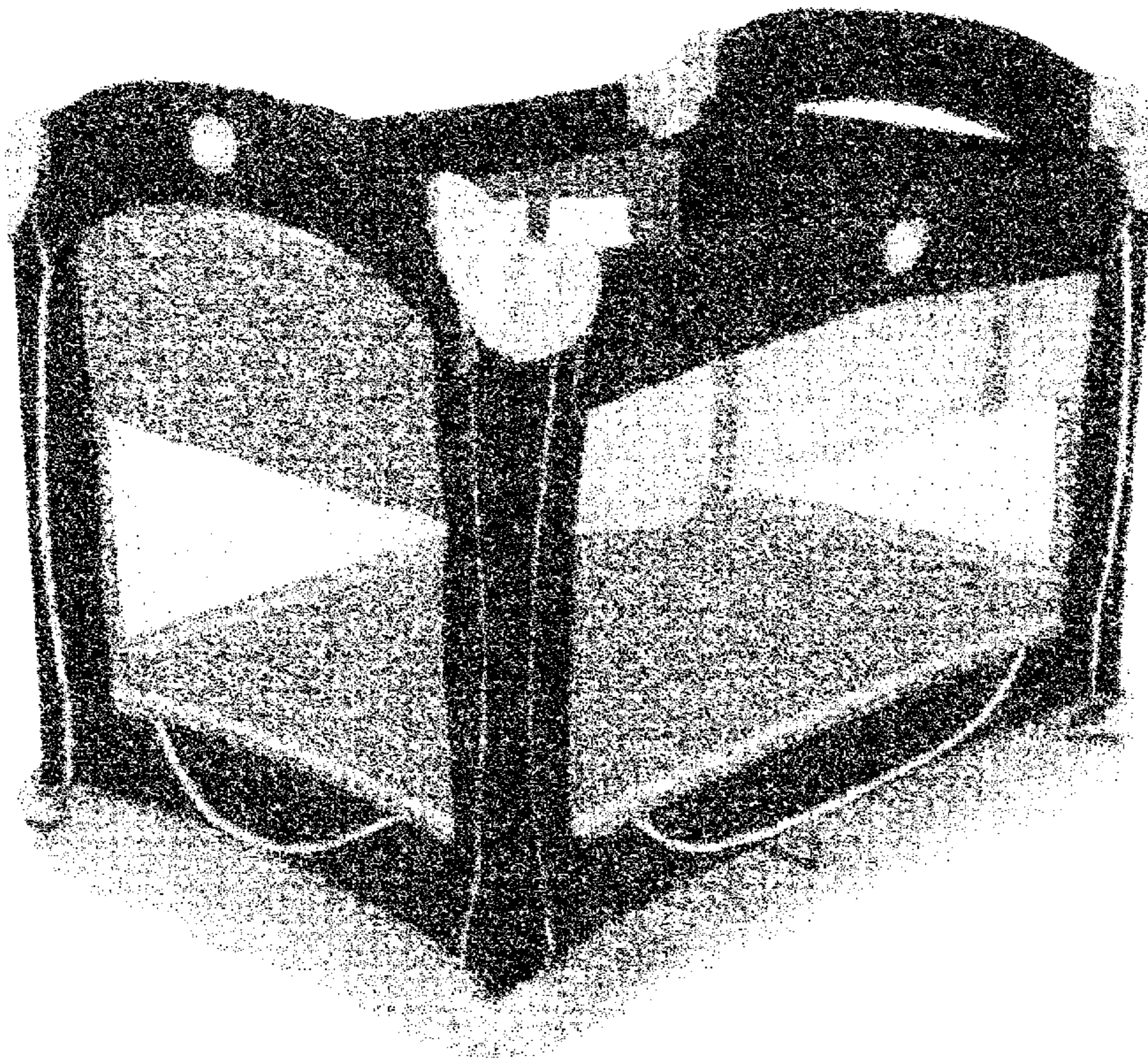
FIG. 4 is a left-side elevation view of the playpen with bassinet shown in FIG. 1;

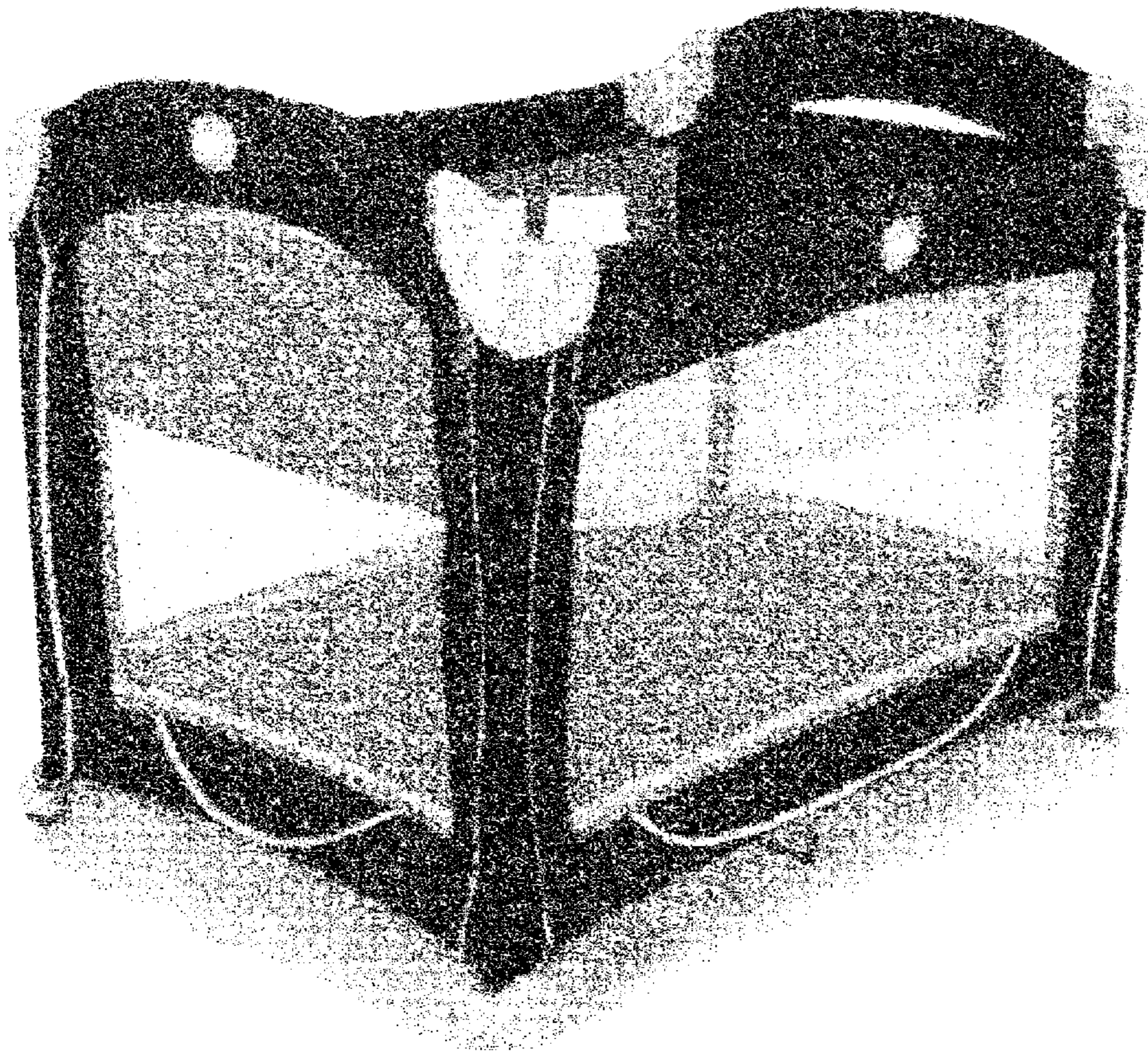

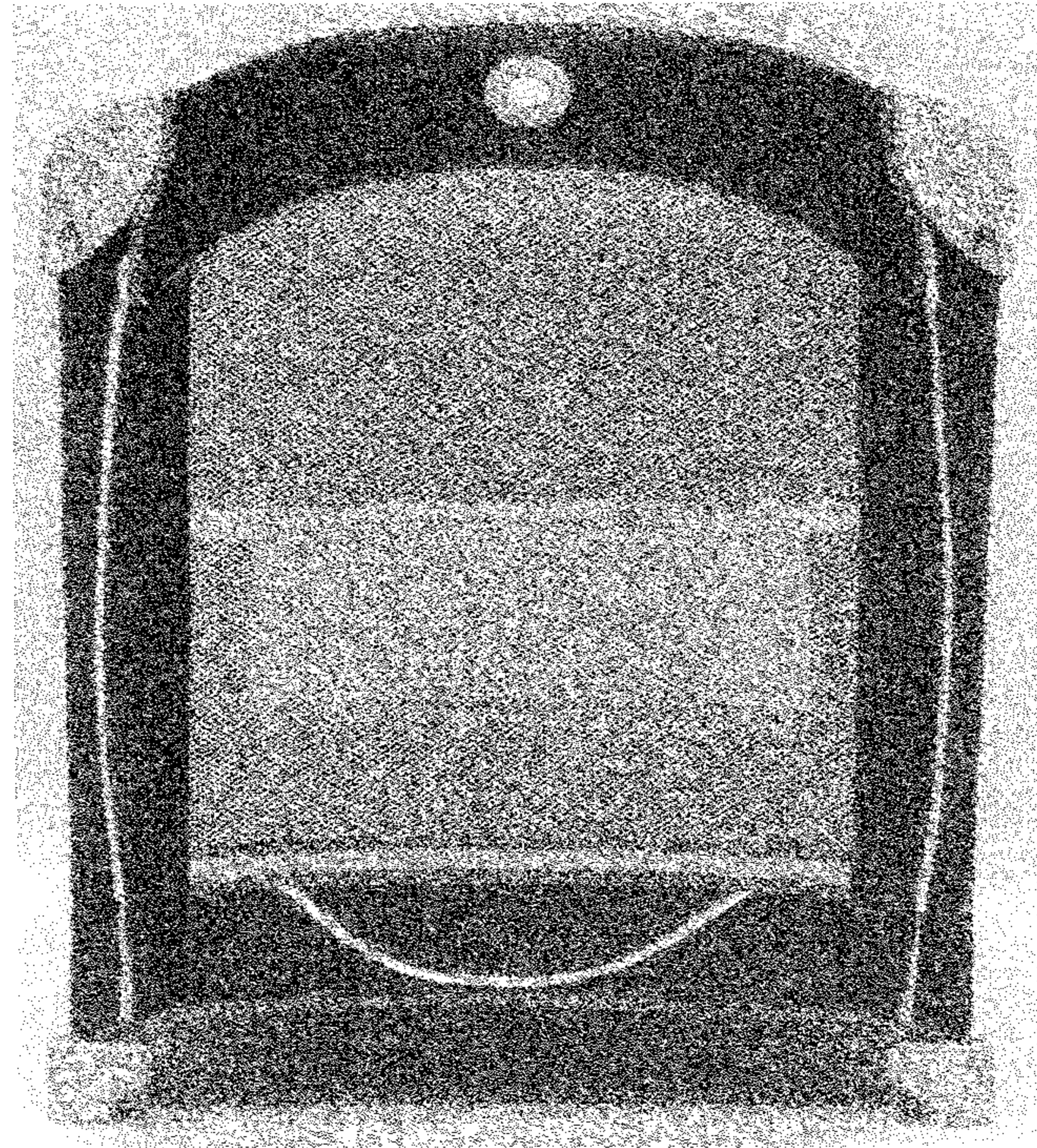

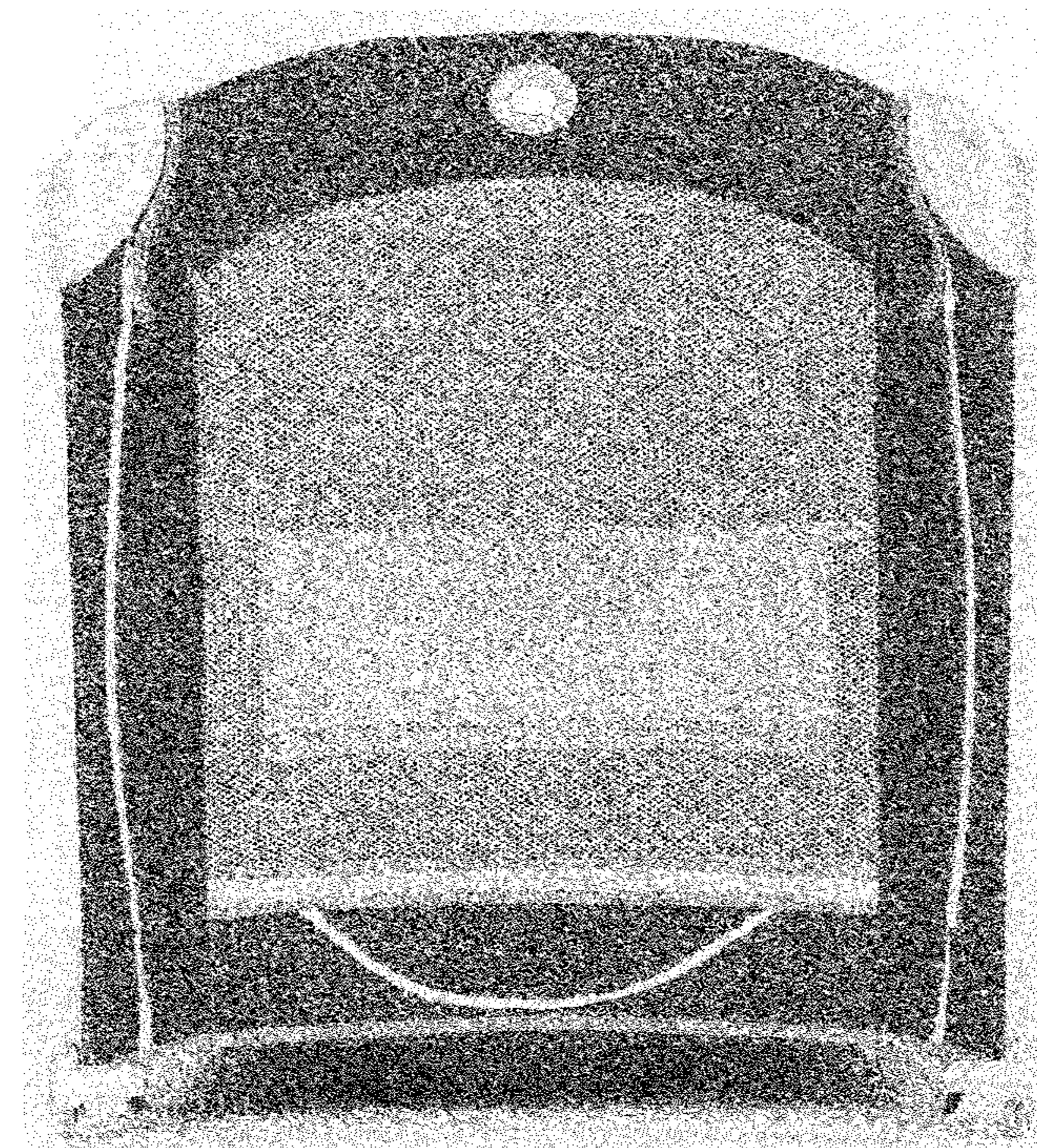

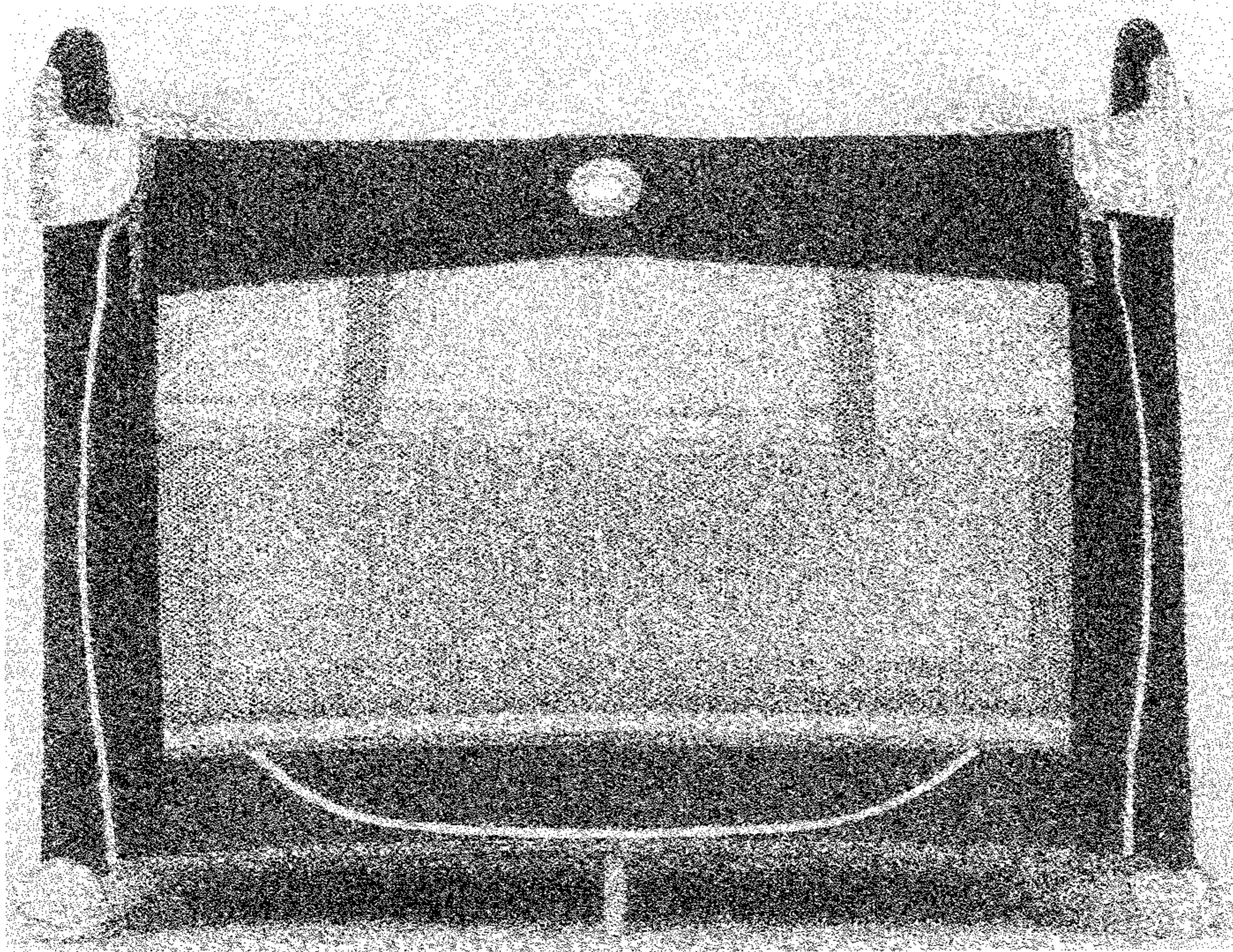

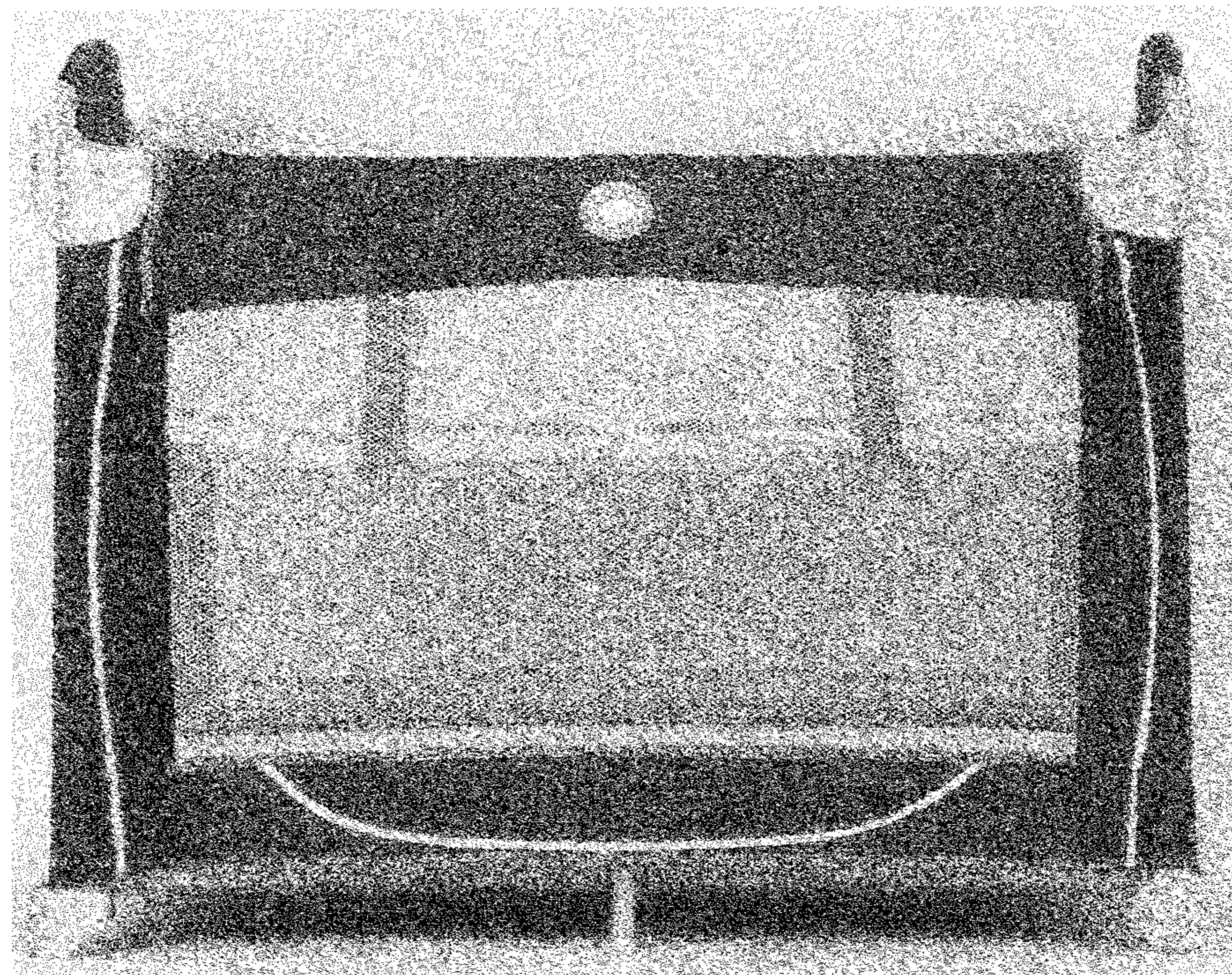

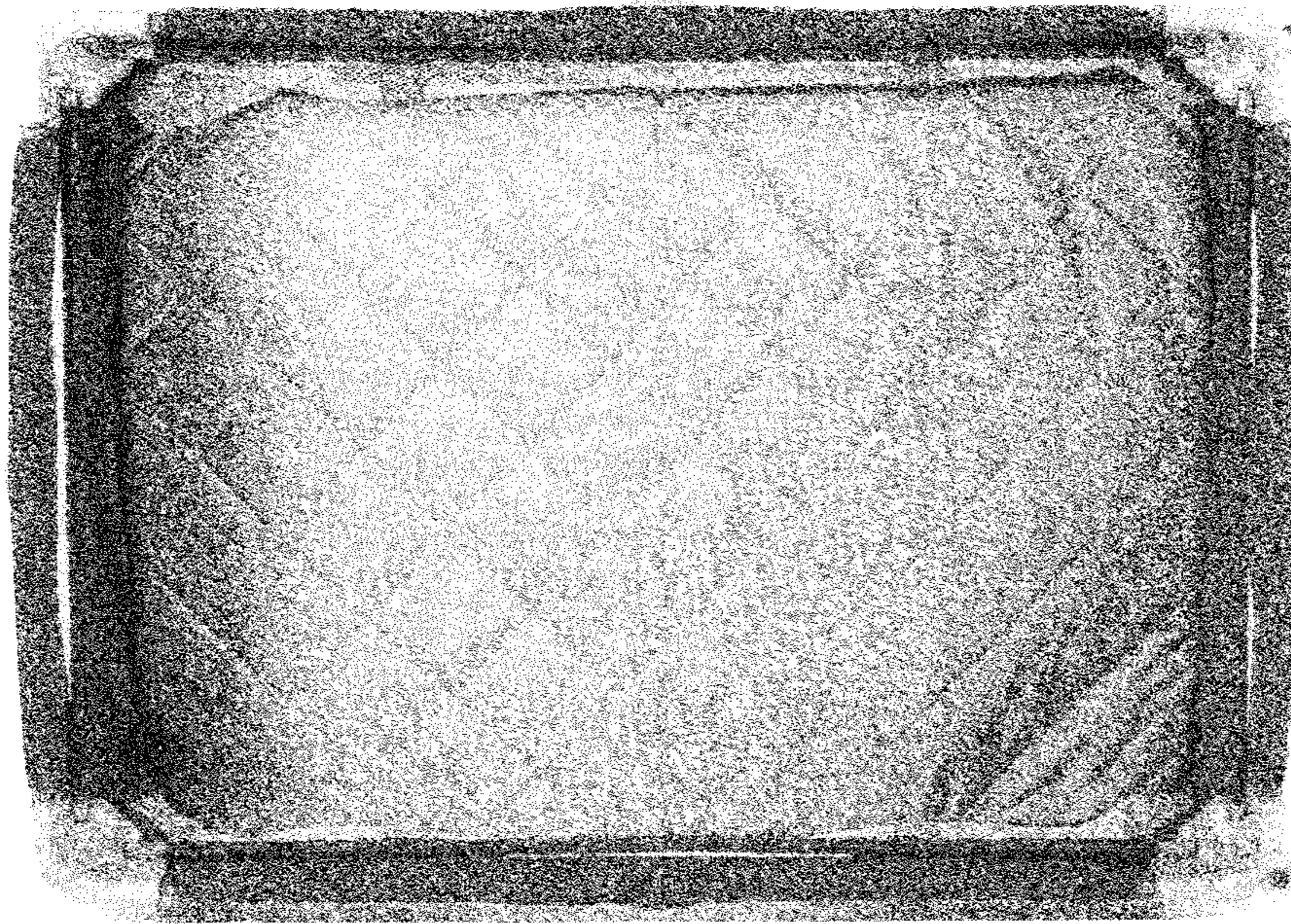

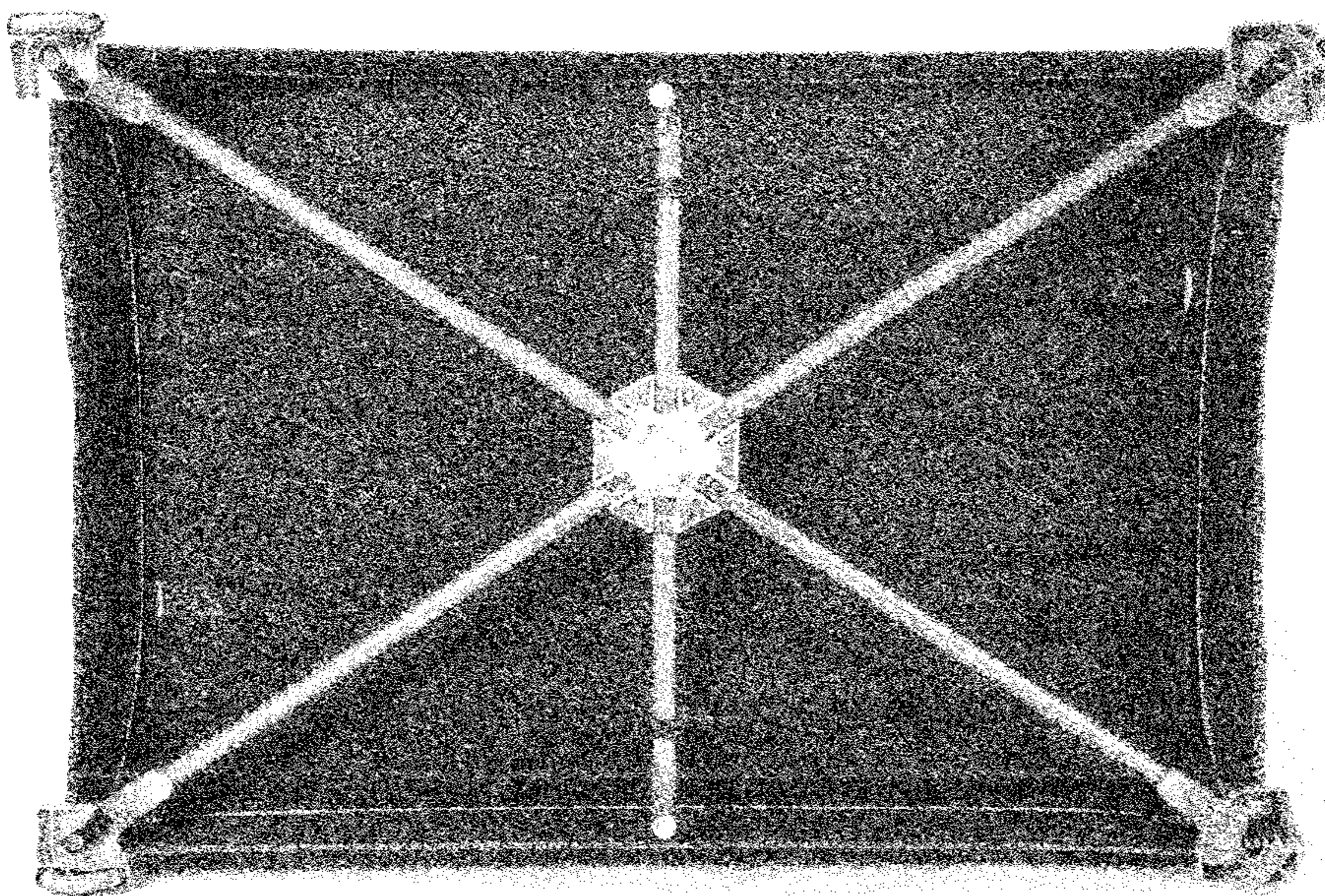
