and described;

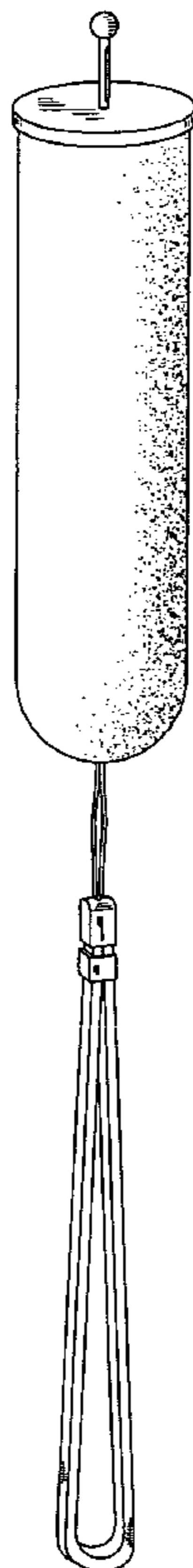
FIG. 2 is a front view with a rear view being the mirror image

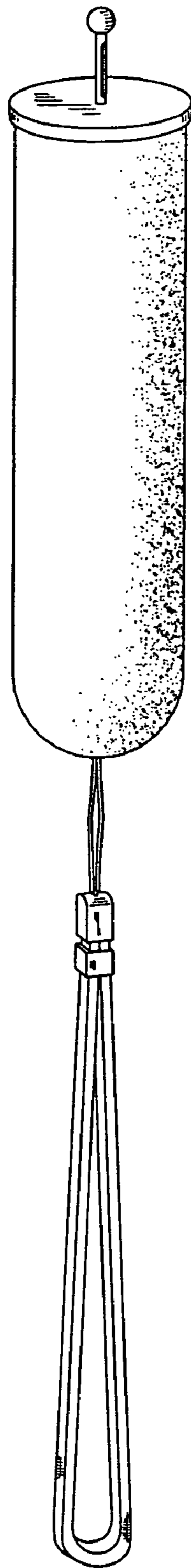

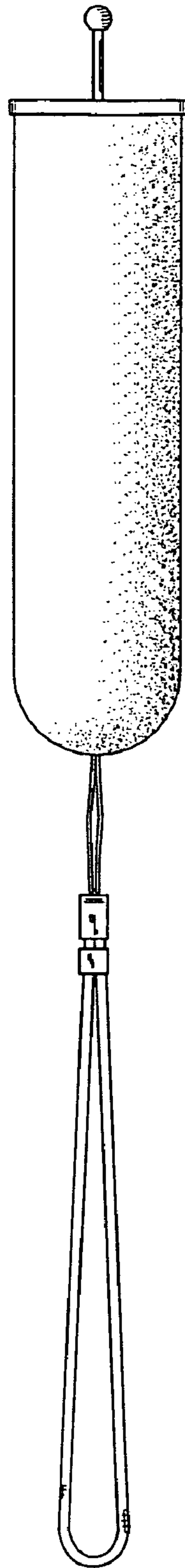

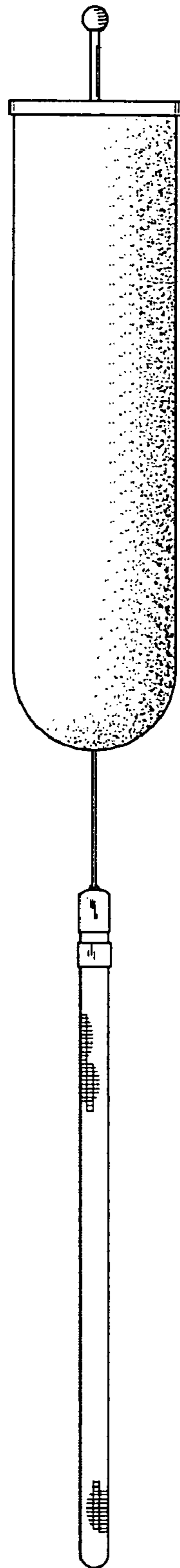

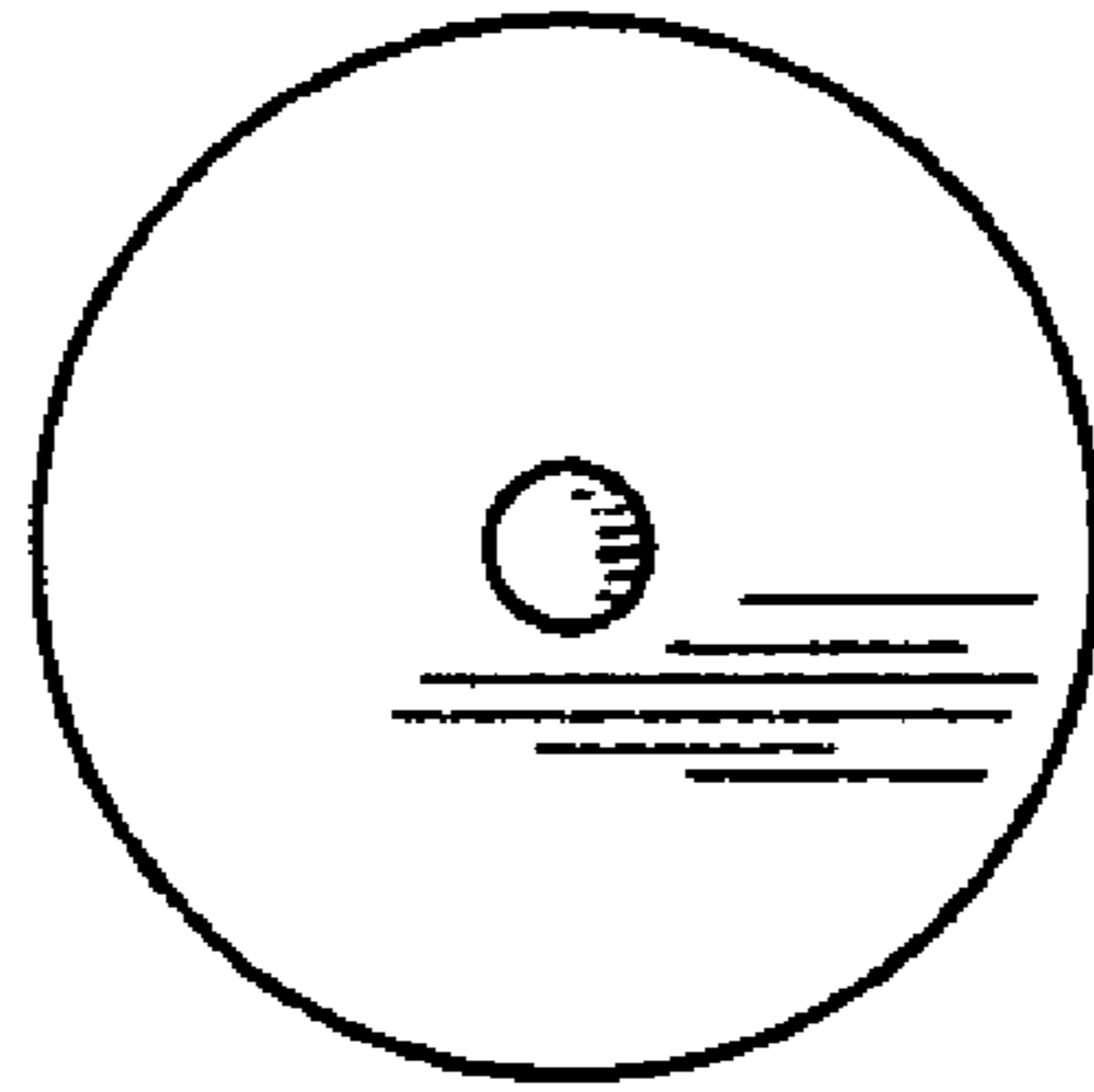

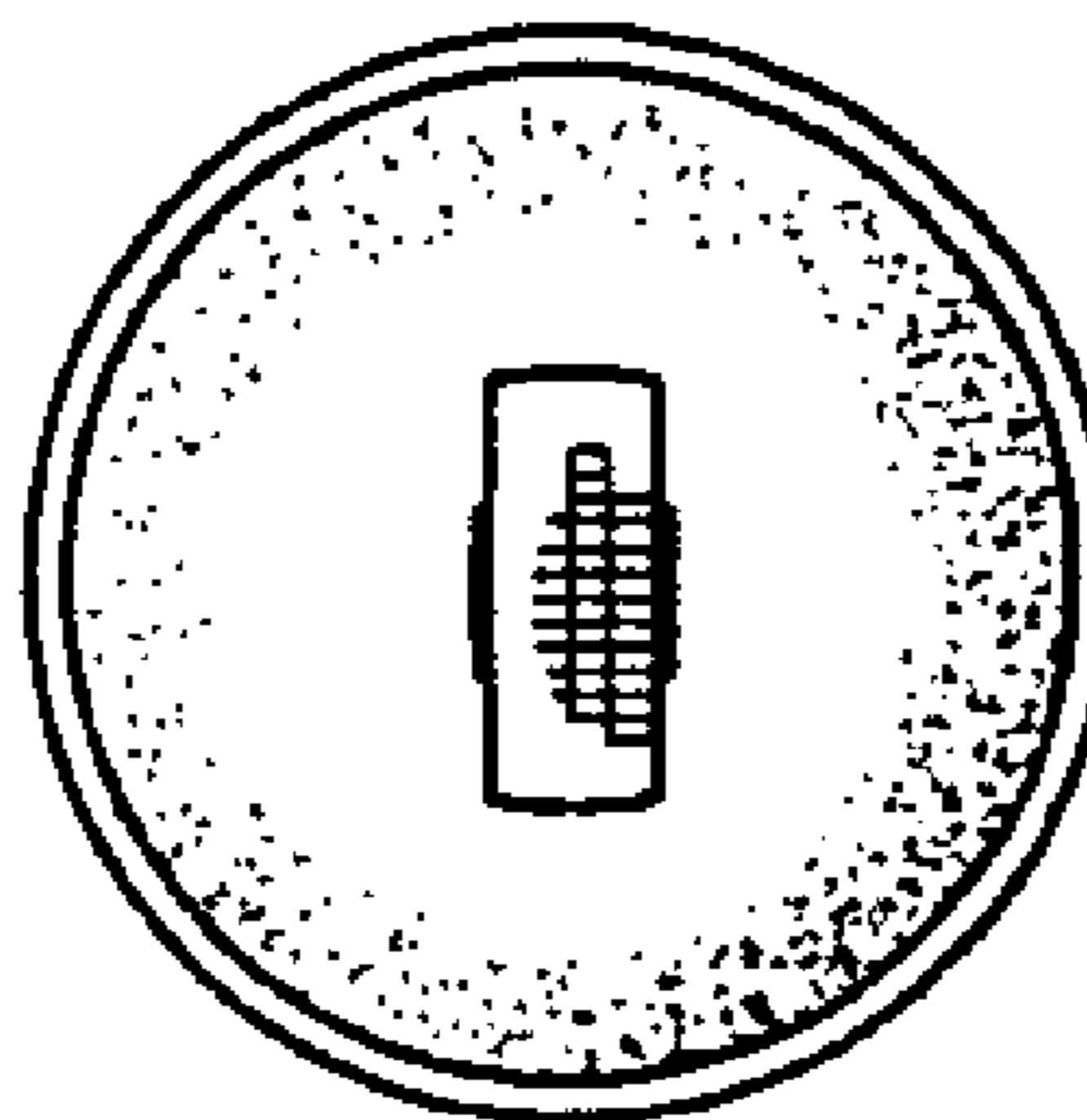
