DESCRIPTION

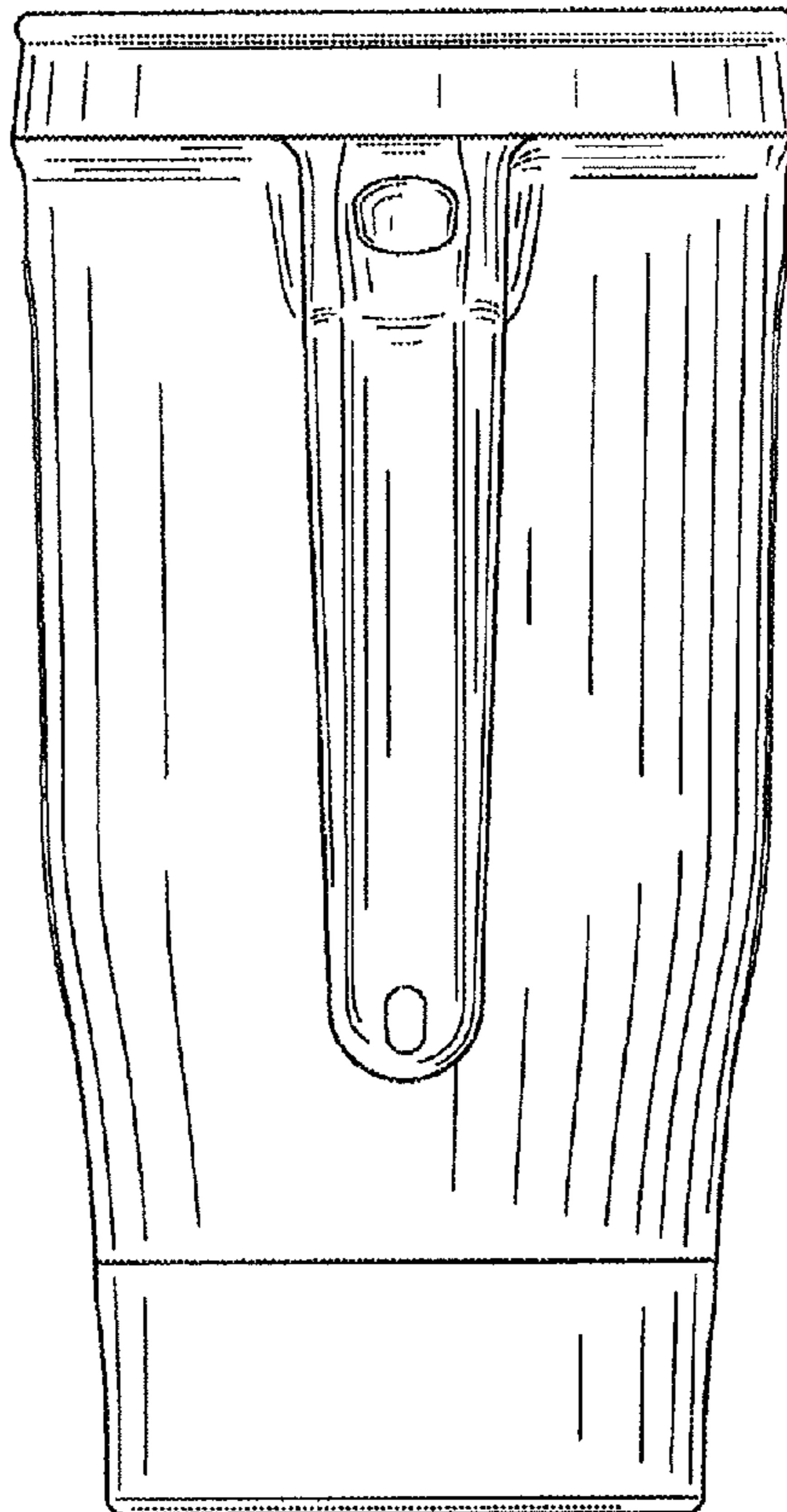
FIG. 1 is a perspective view of the beverage container according to the present design;

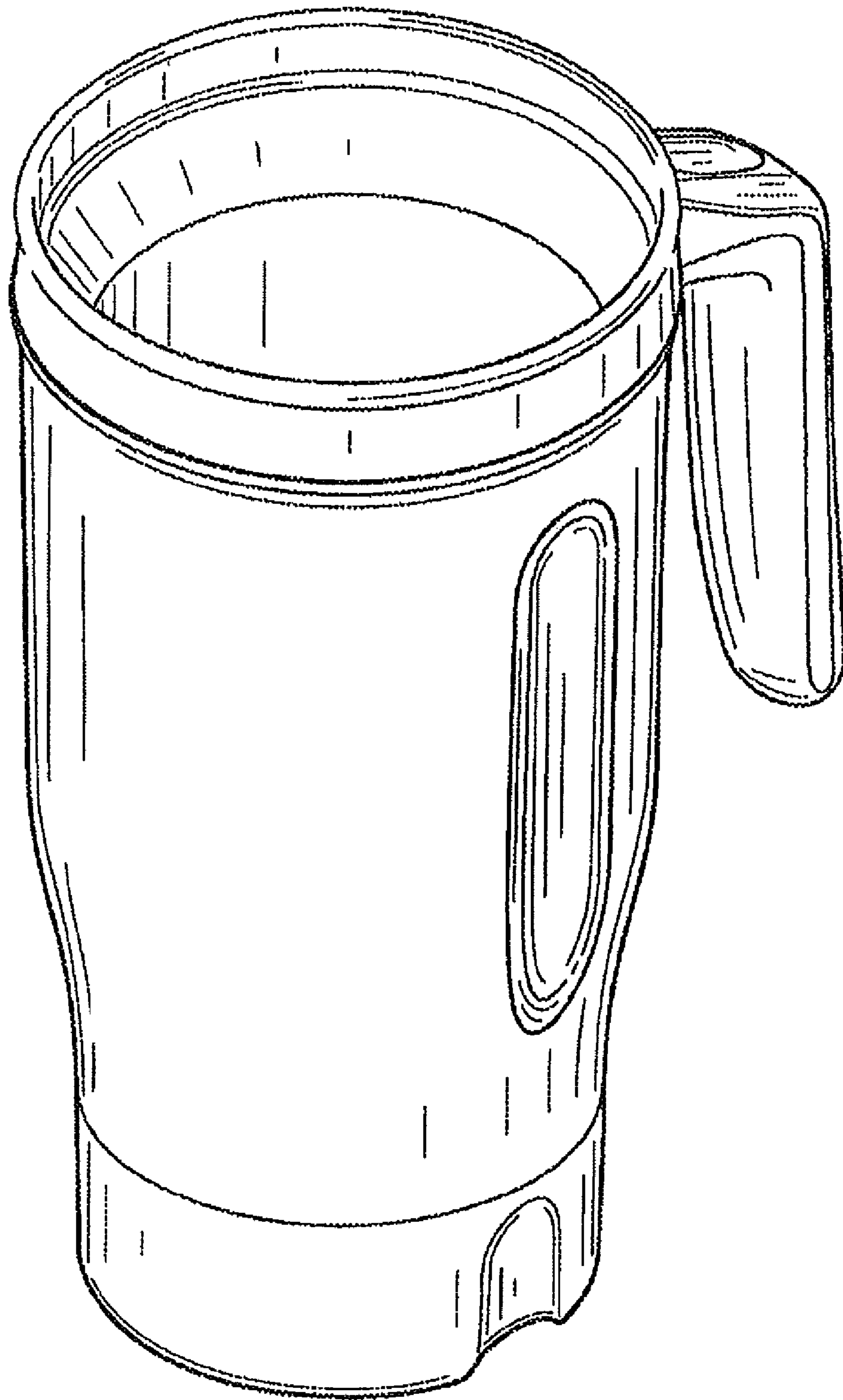

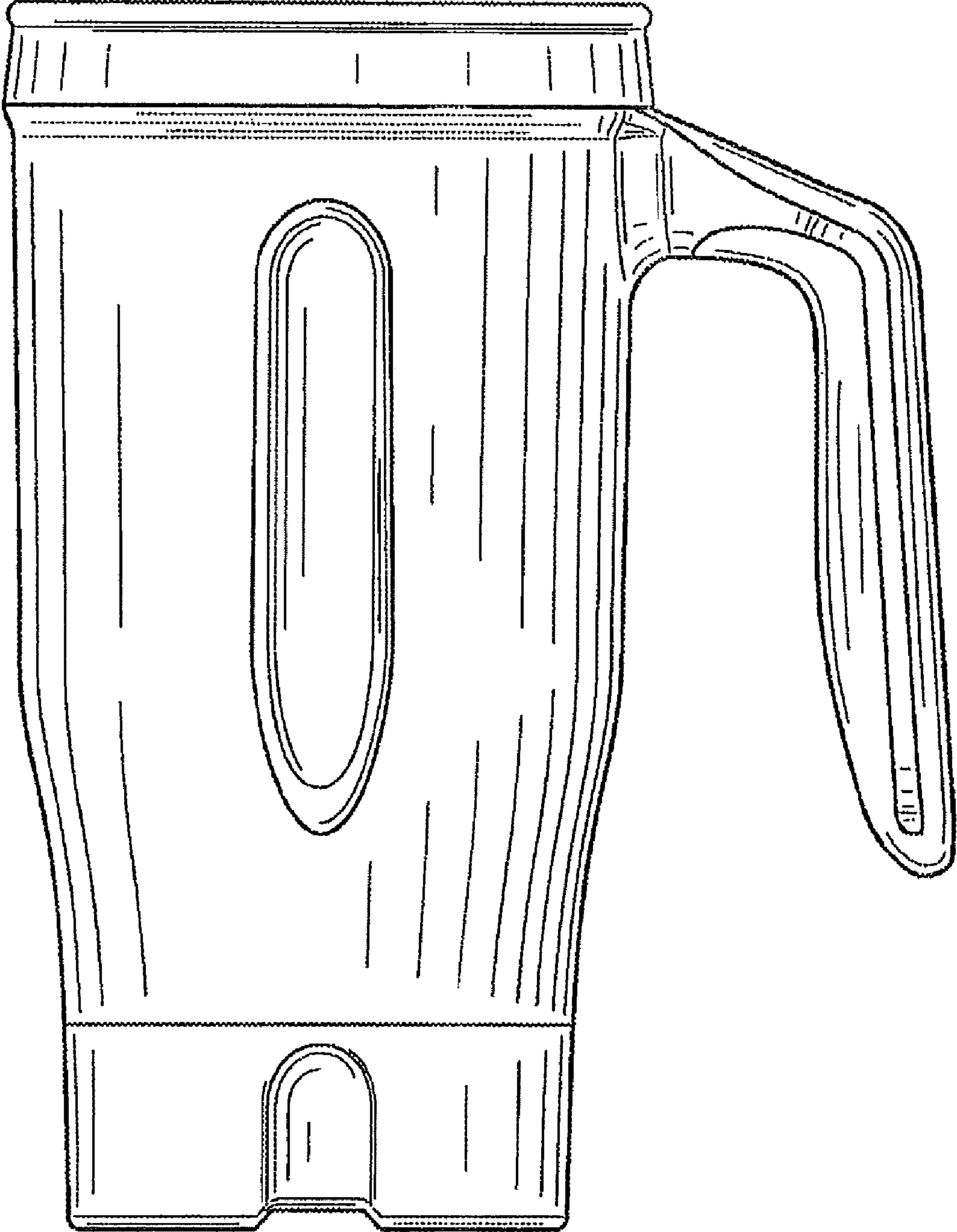

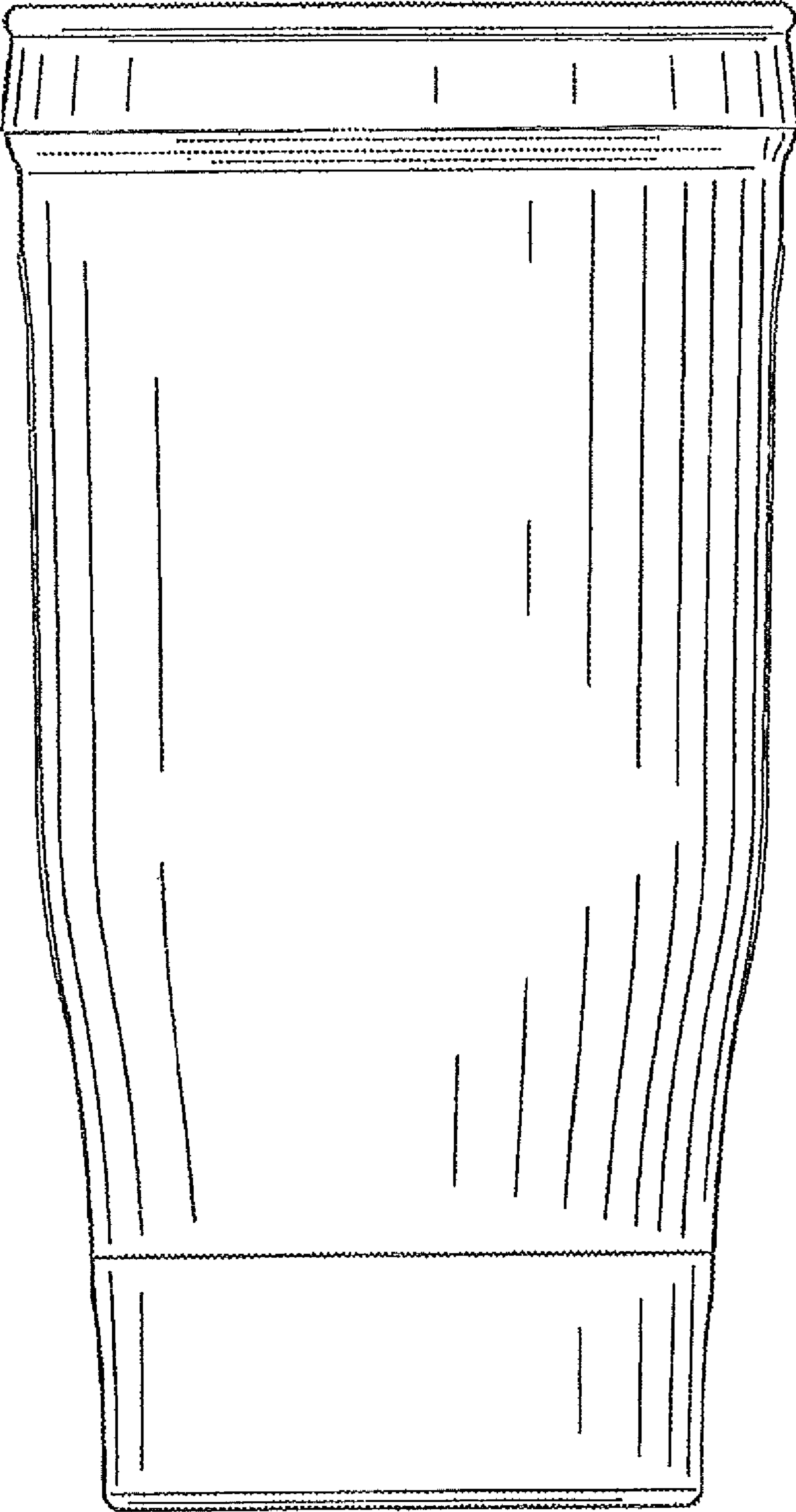

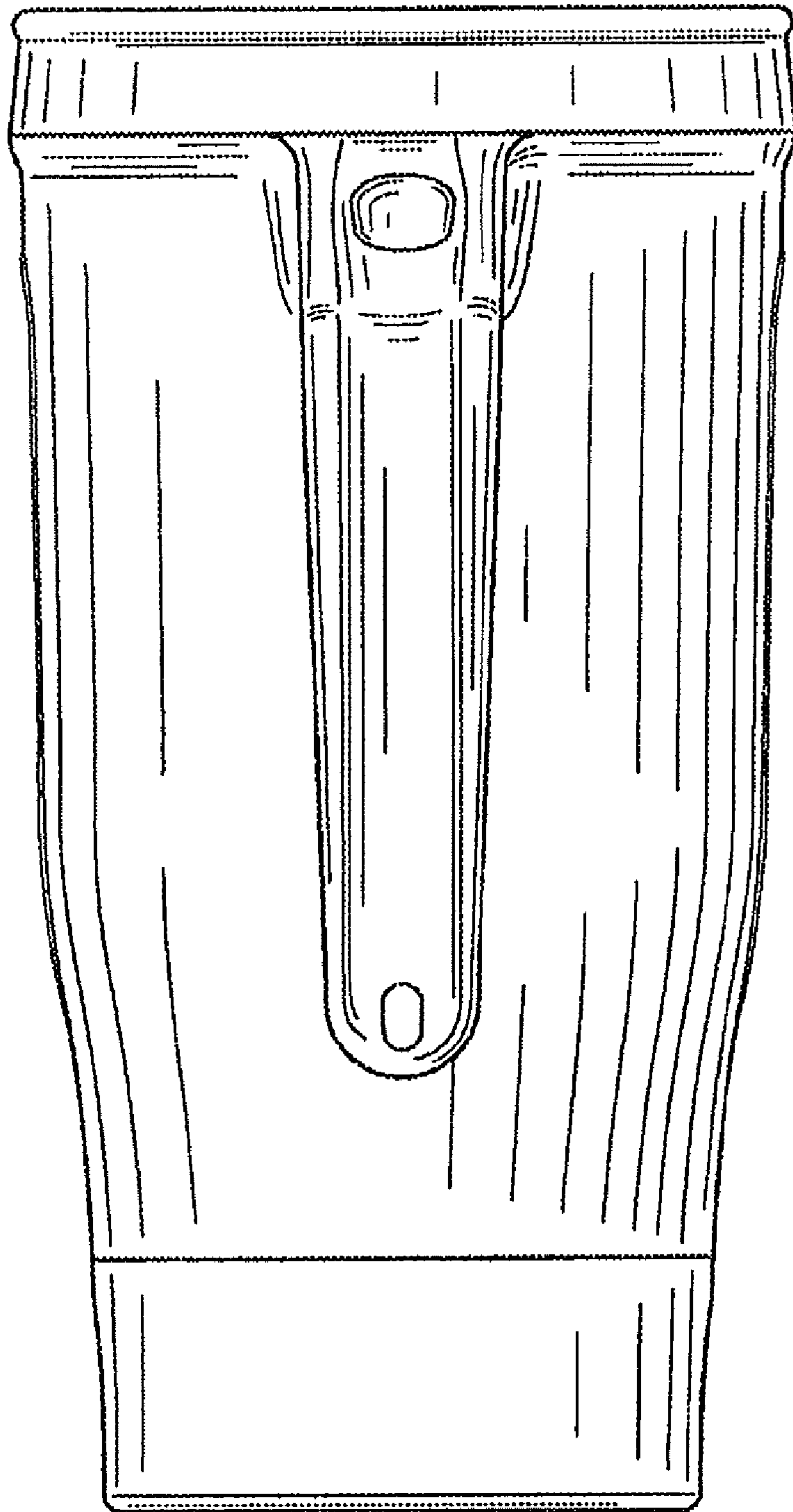
