DESCRIPTION

FIG. 1 is a right elevation of a salsa bowl showing our new design, the side opposite being a mirror image;

FIG. 2 is a front elevation view thereof;

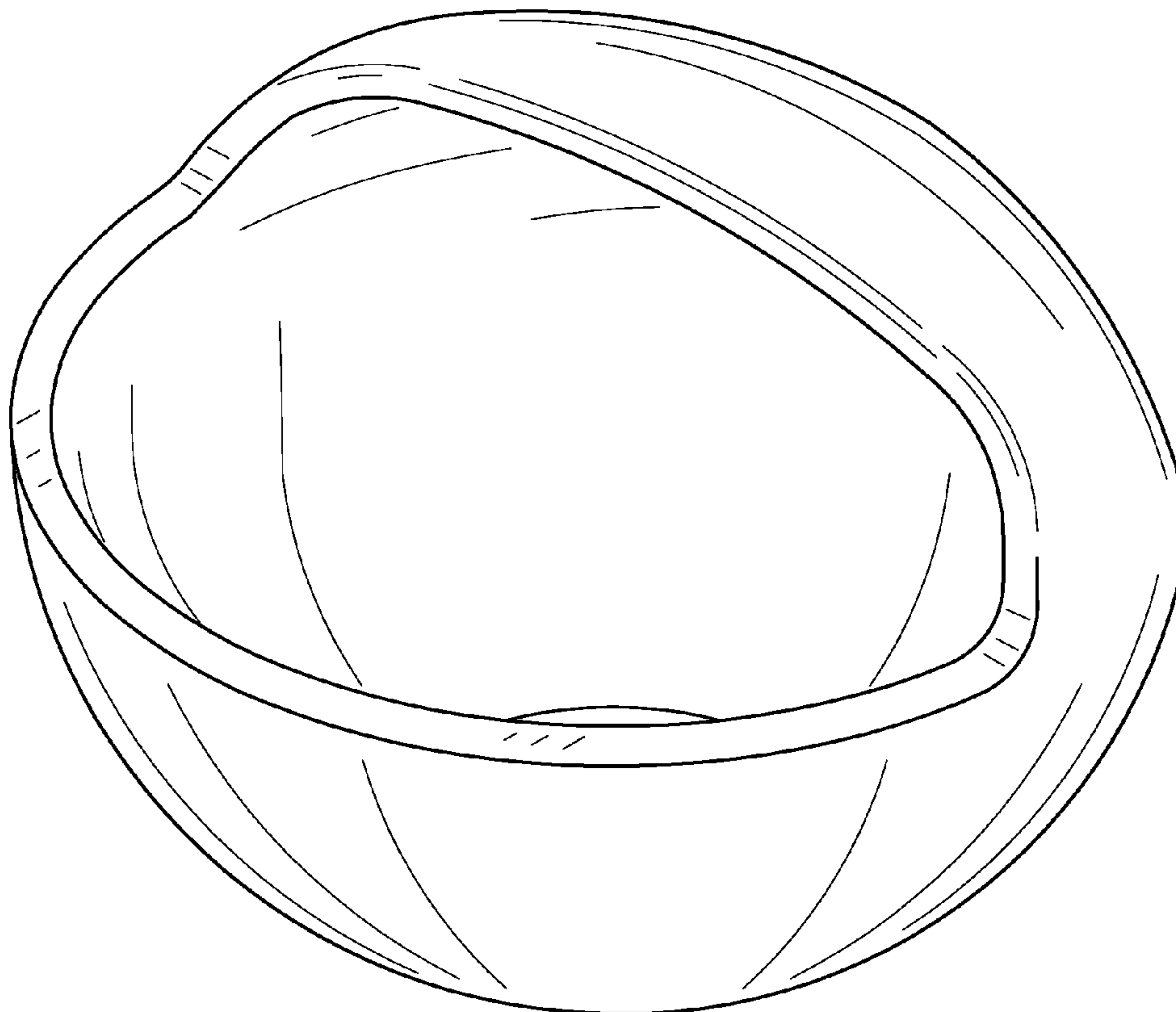
FIG. 3 is a rear elevation view thereof;

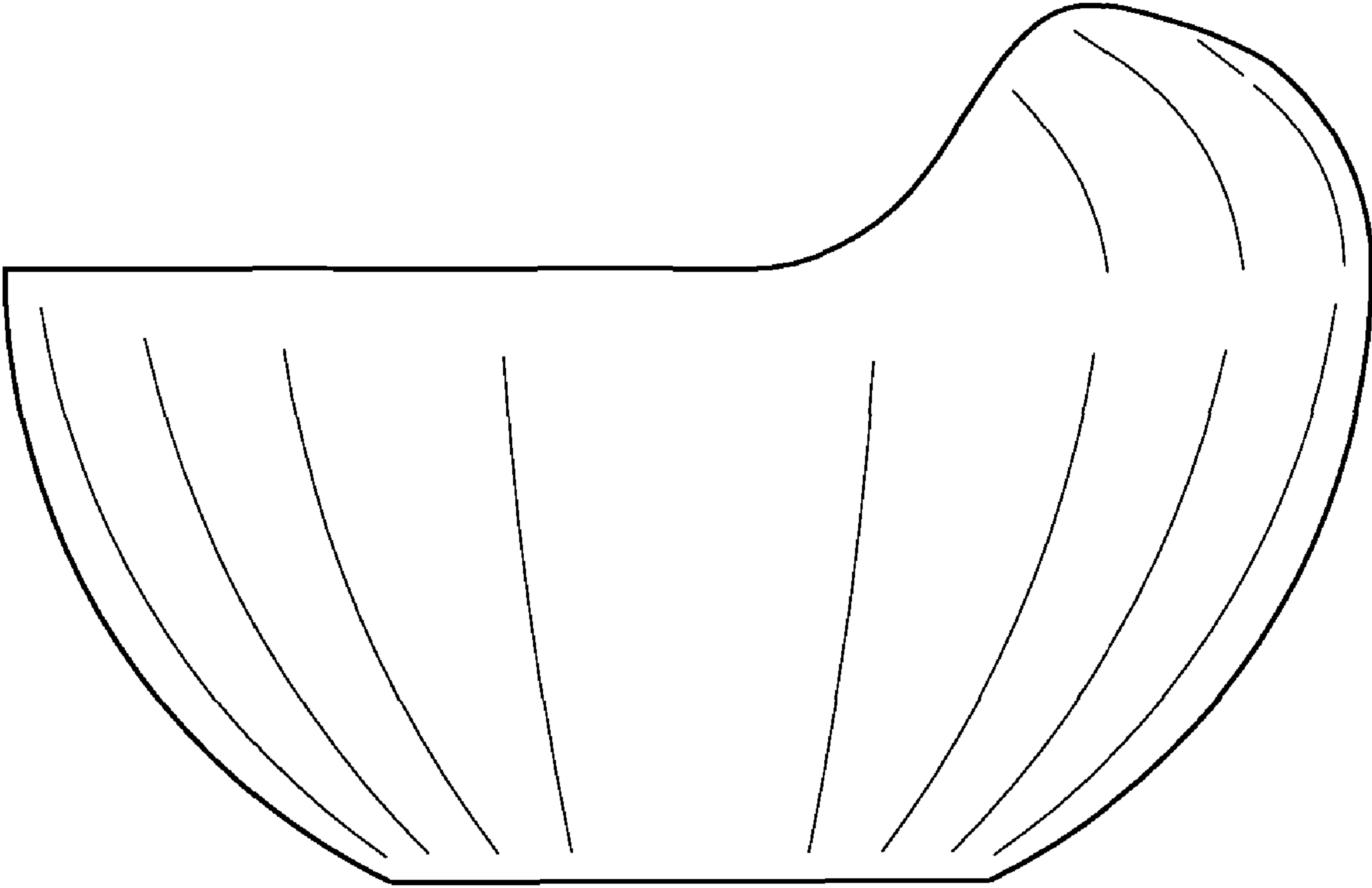

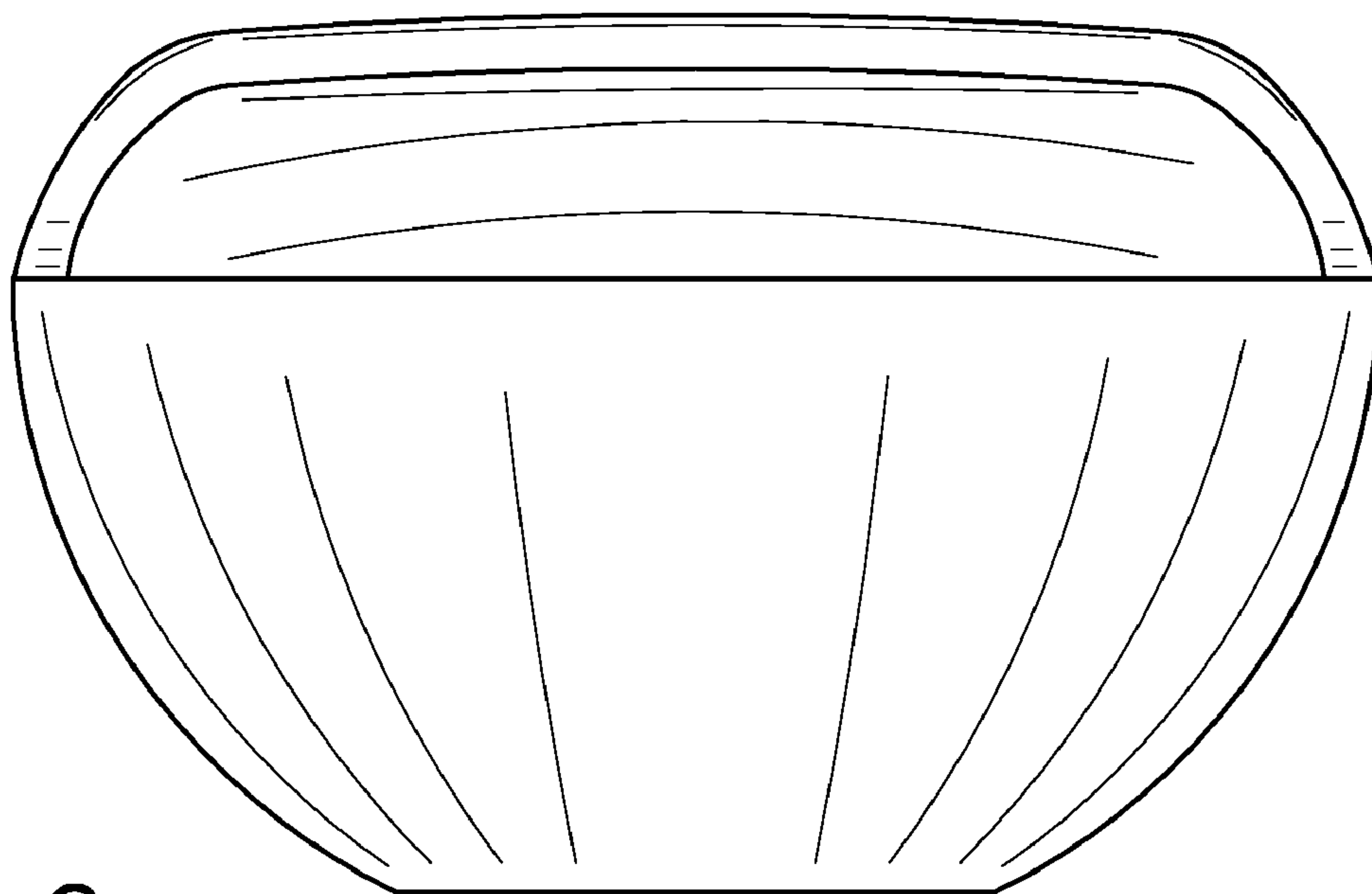

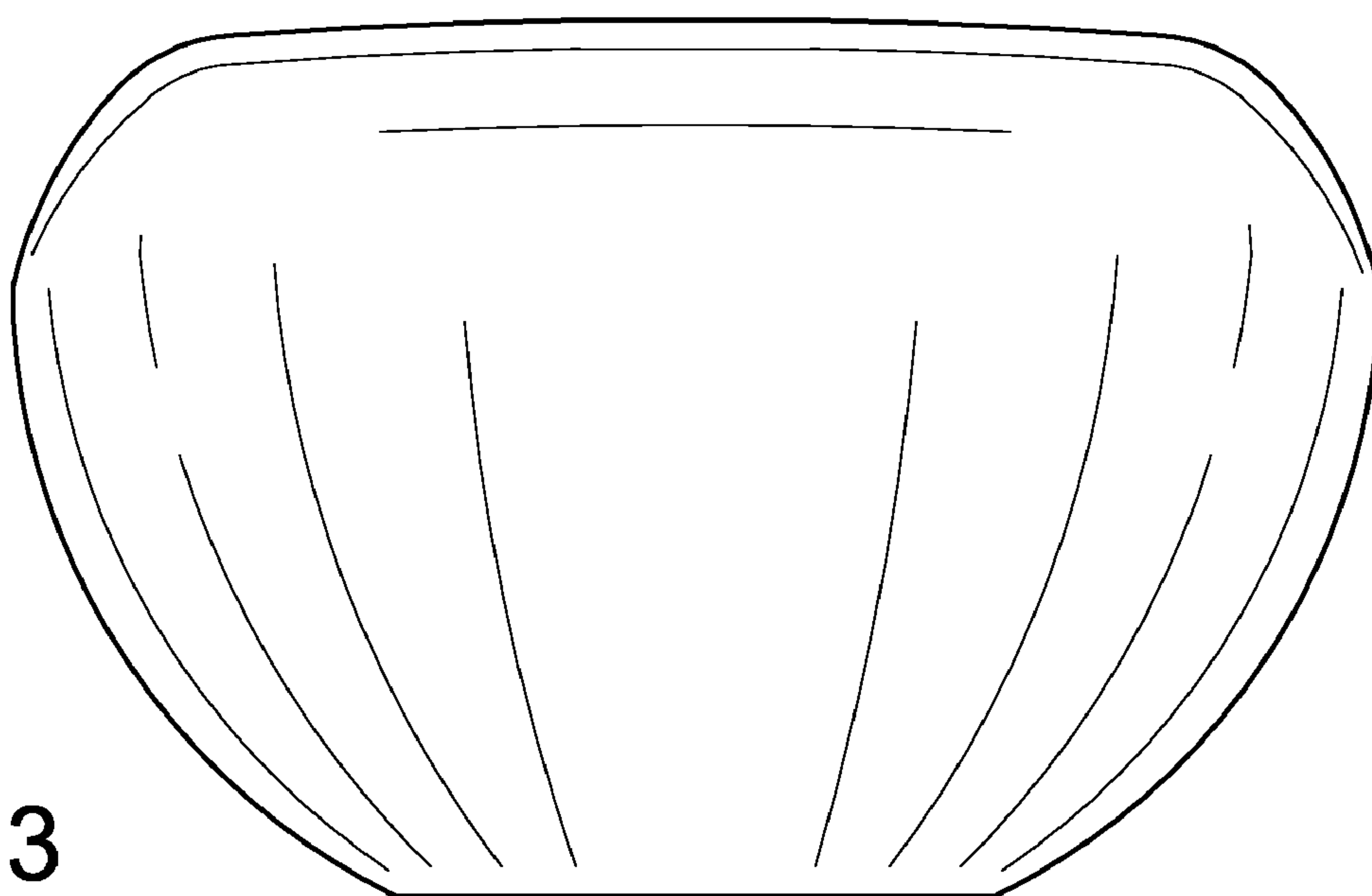

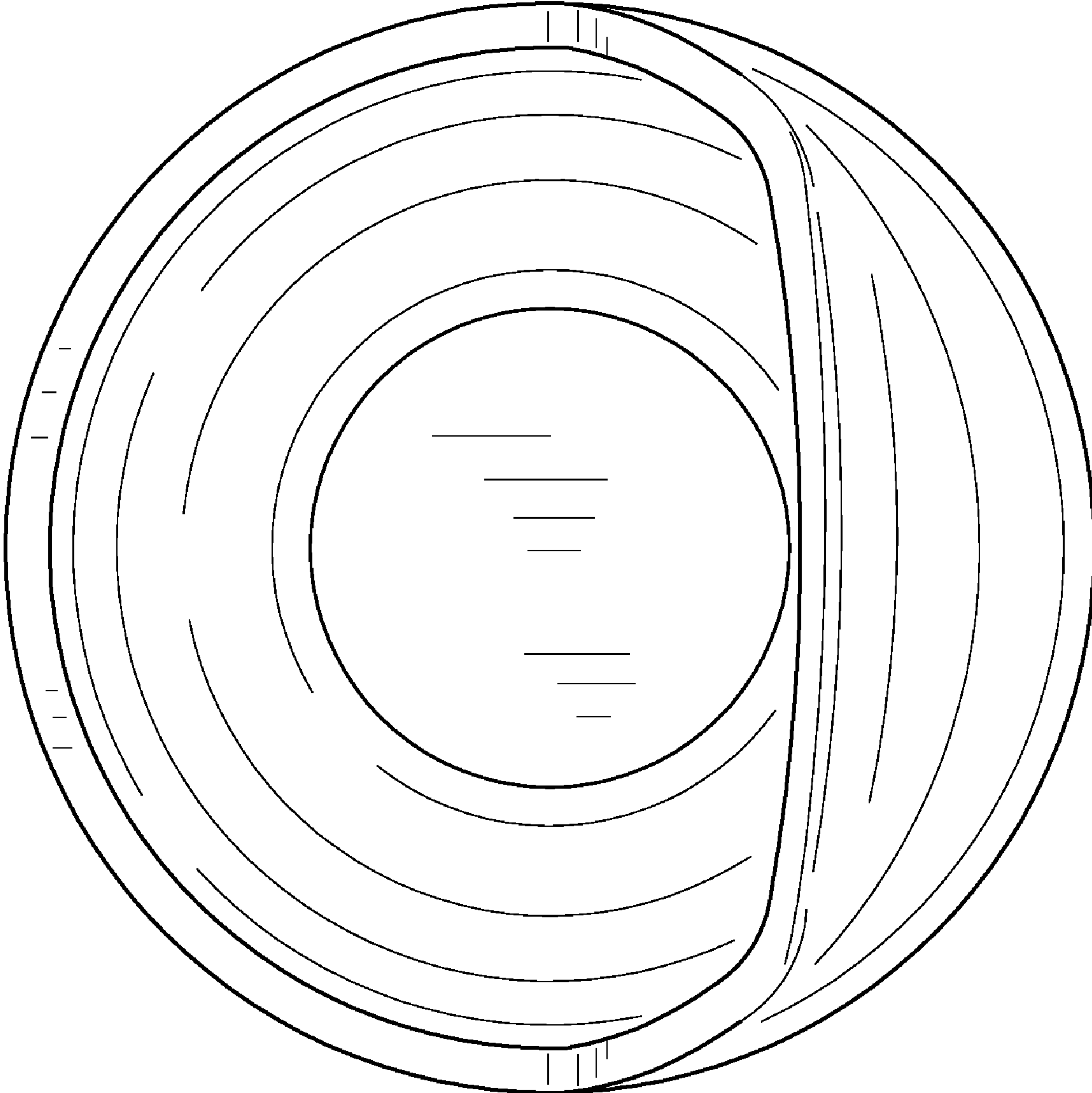

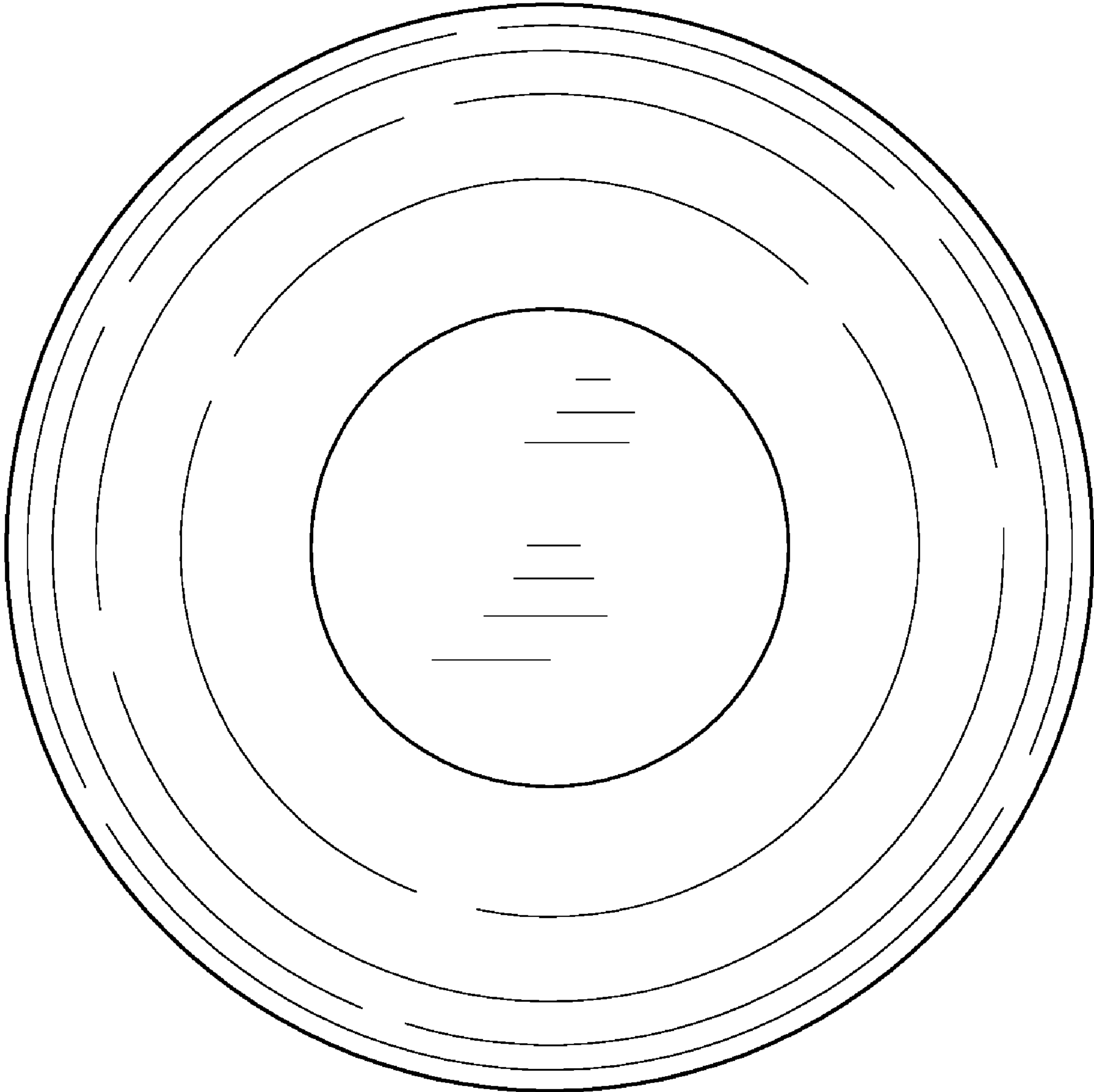

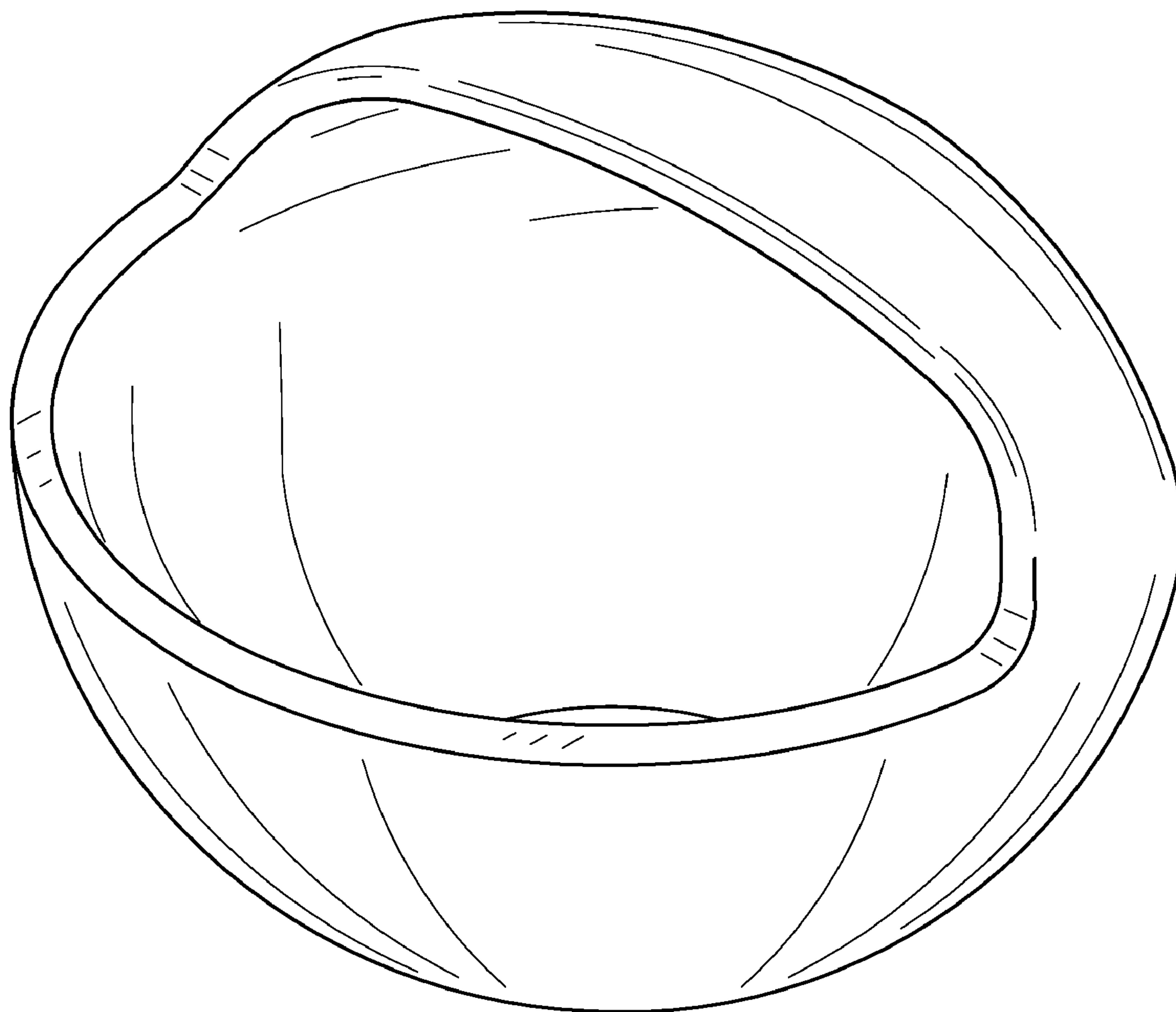
