DESCRIPTION

FIG. 25 is a left side elevational view thereof.

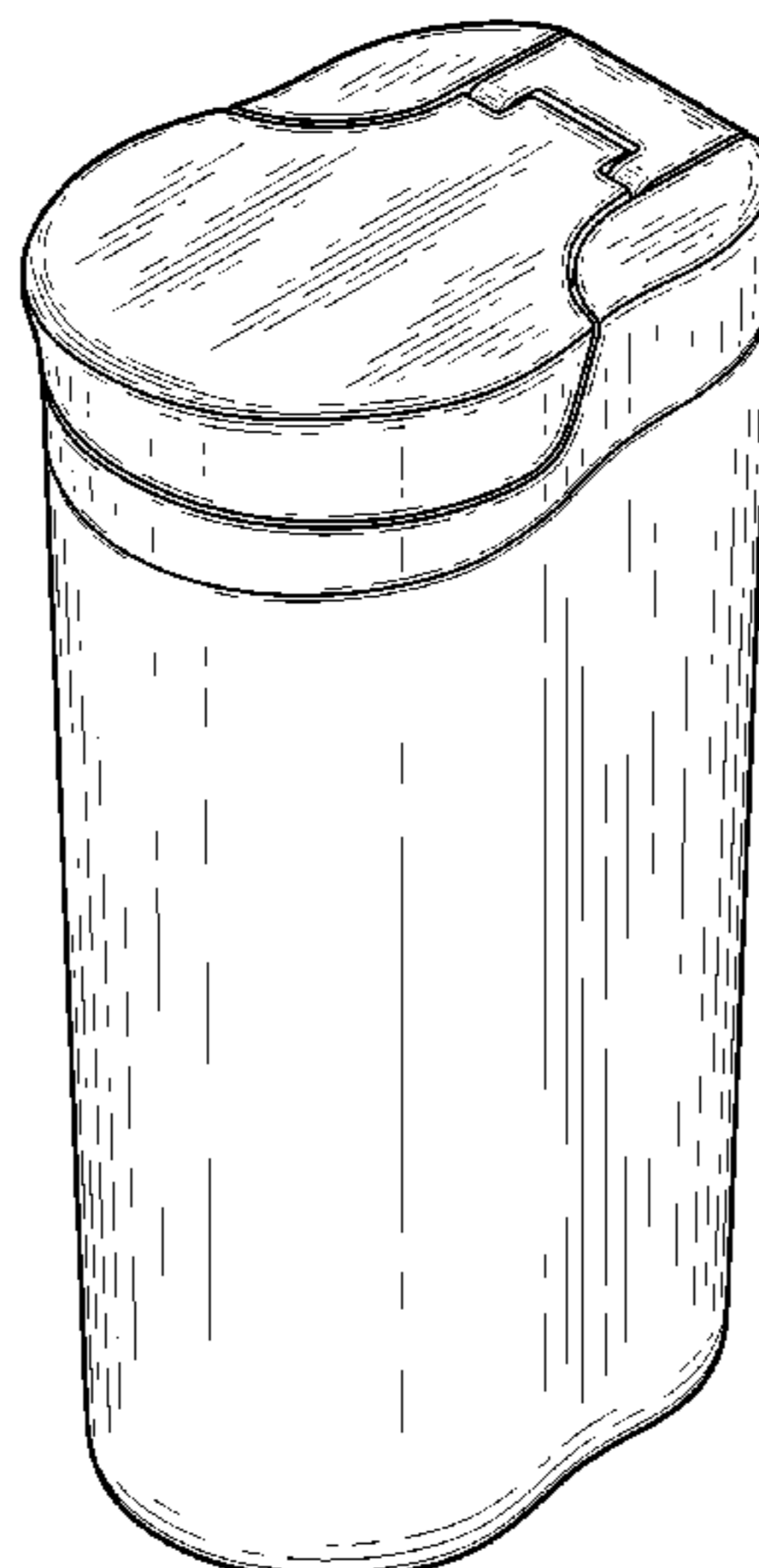
FIG. 26 is a right side elevational view thereof.

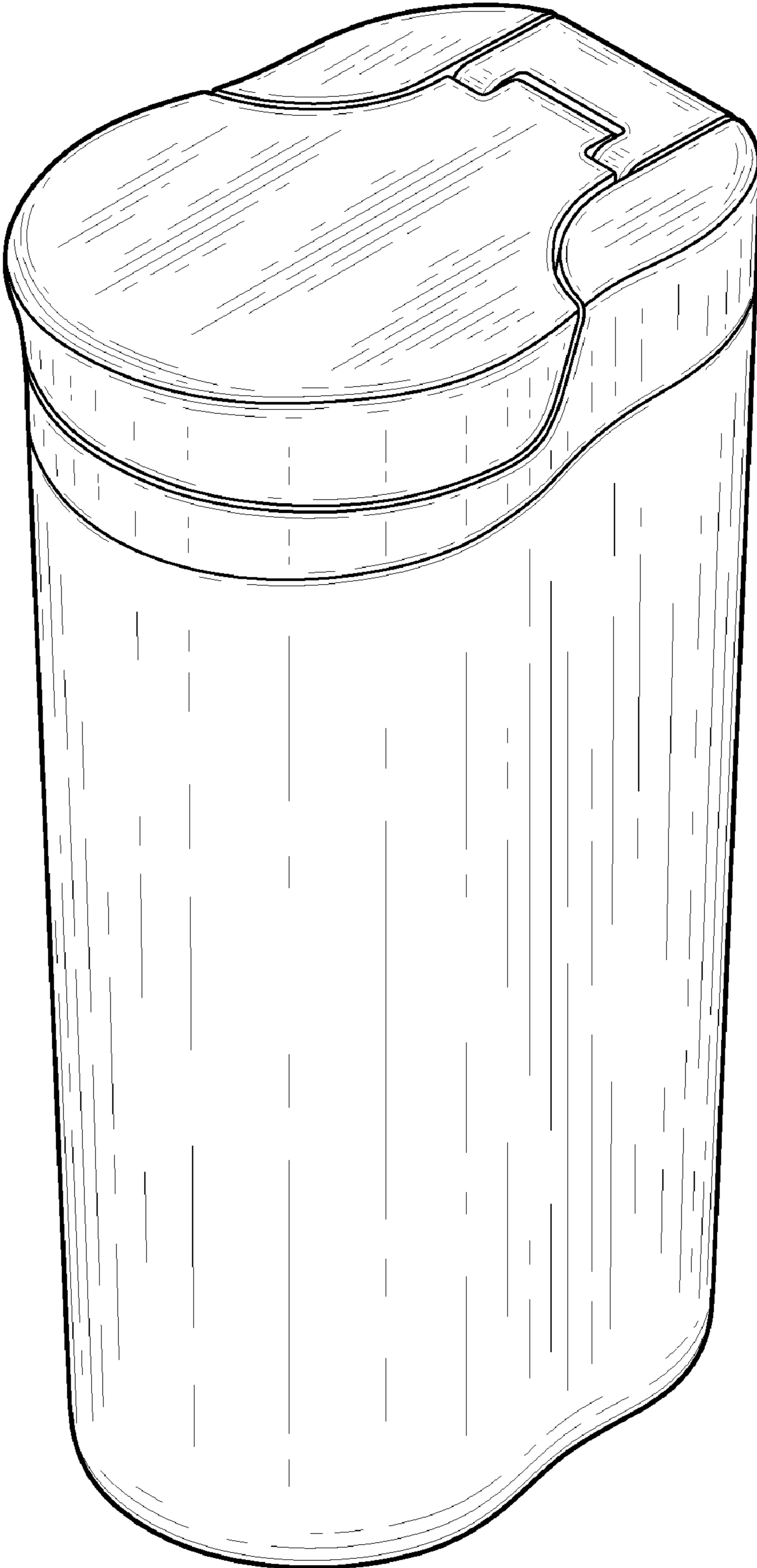

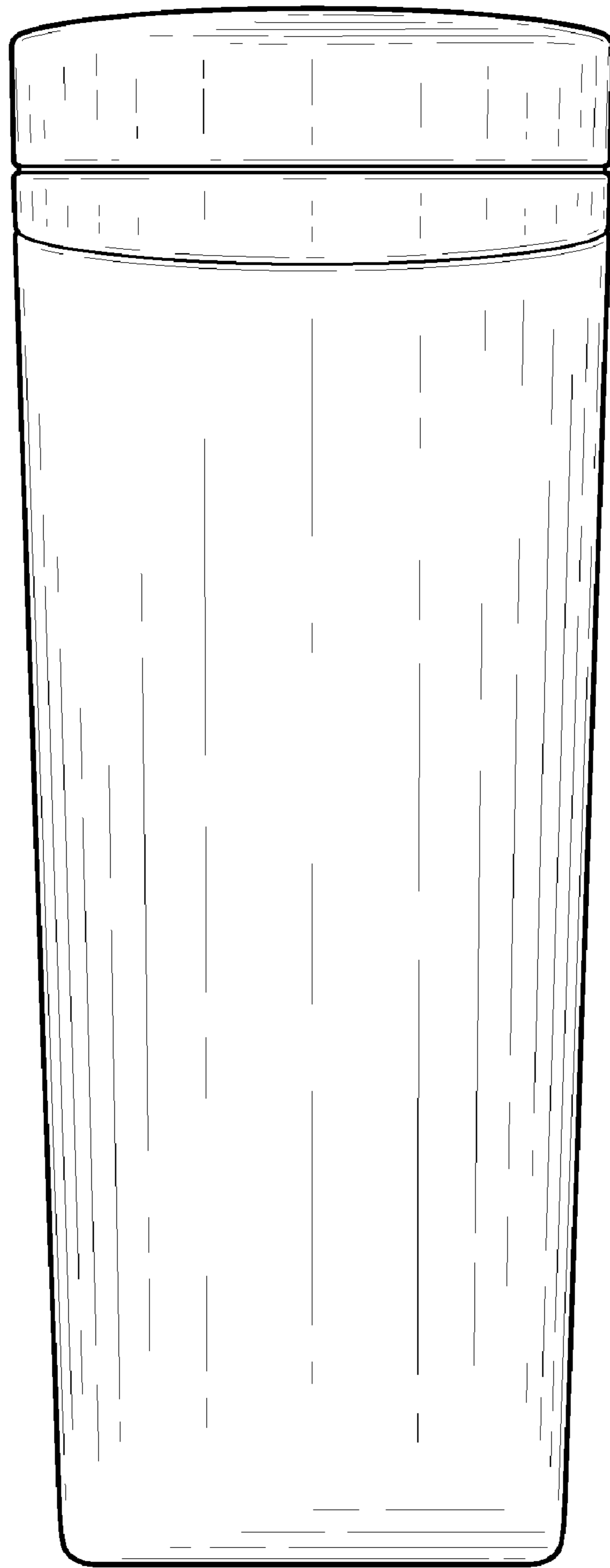

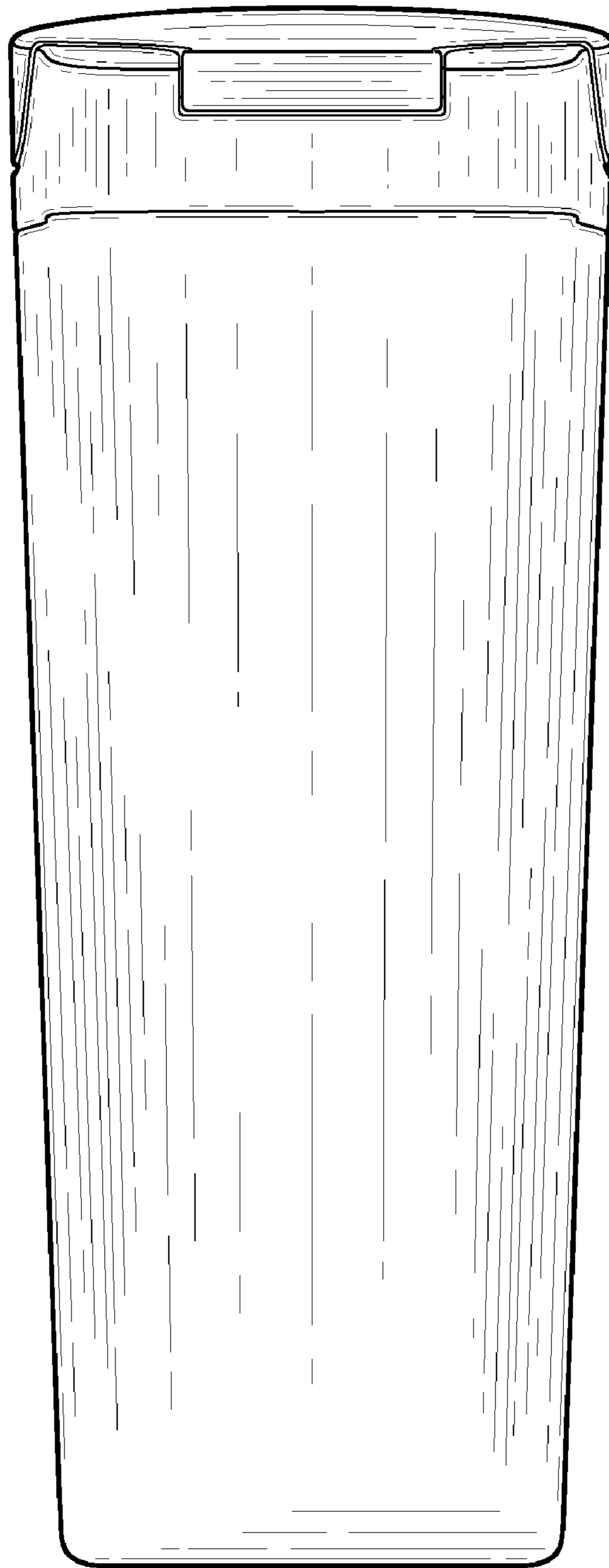

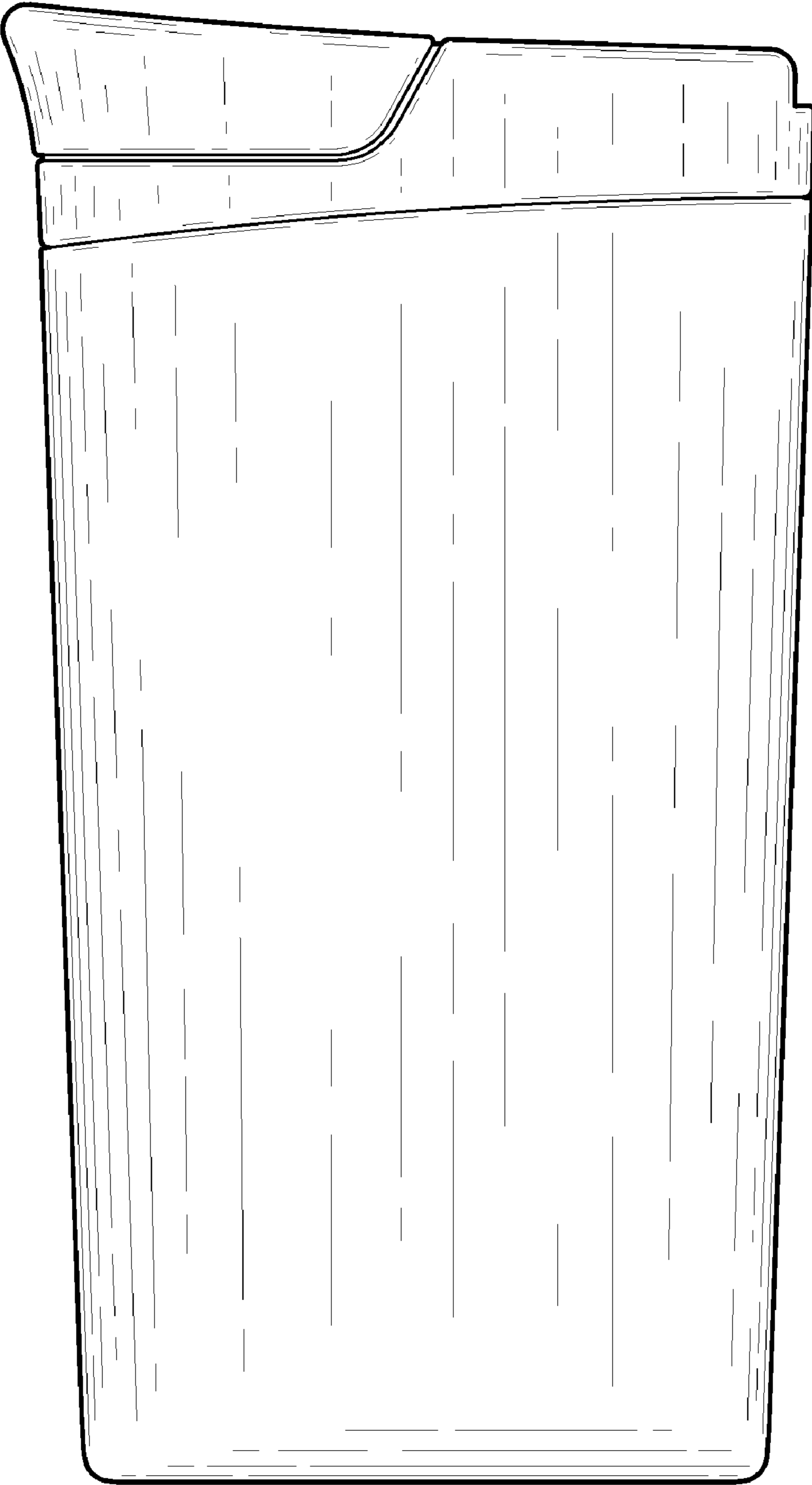

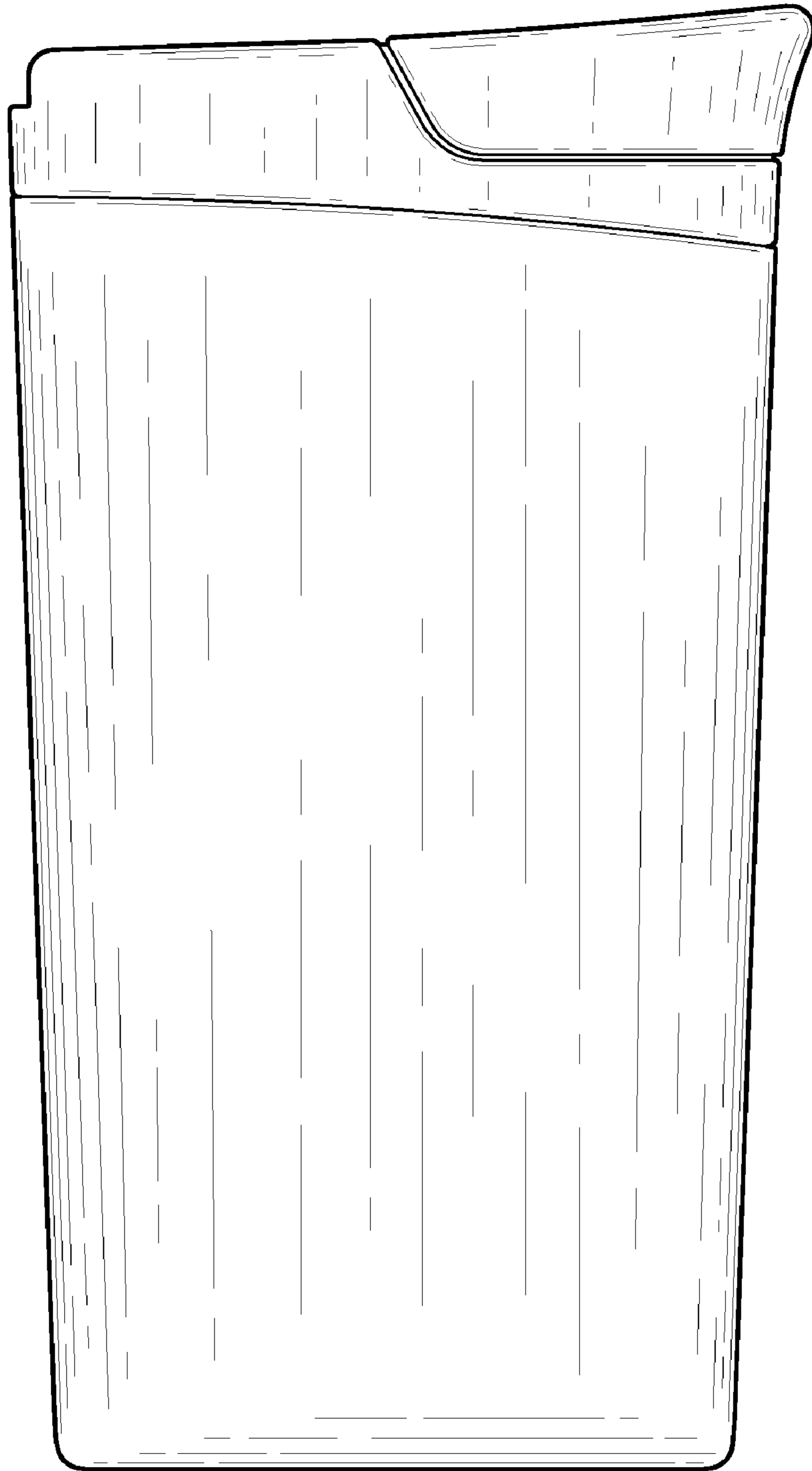

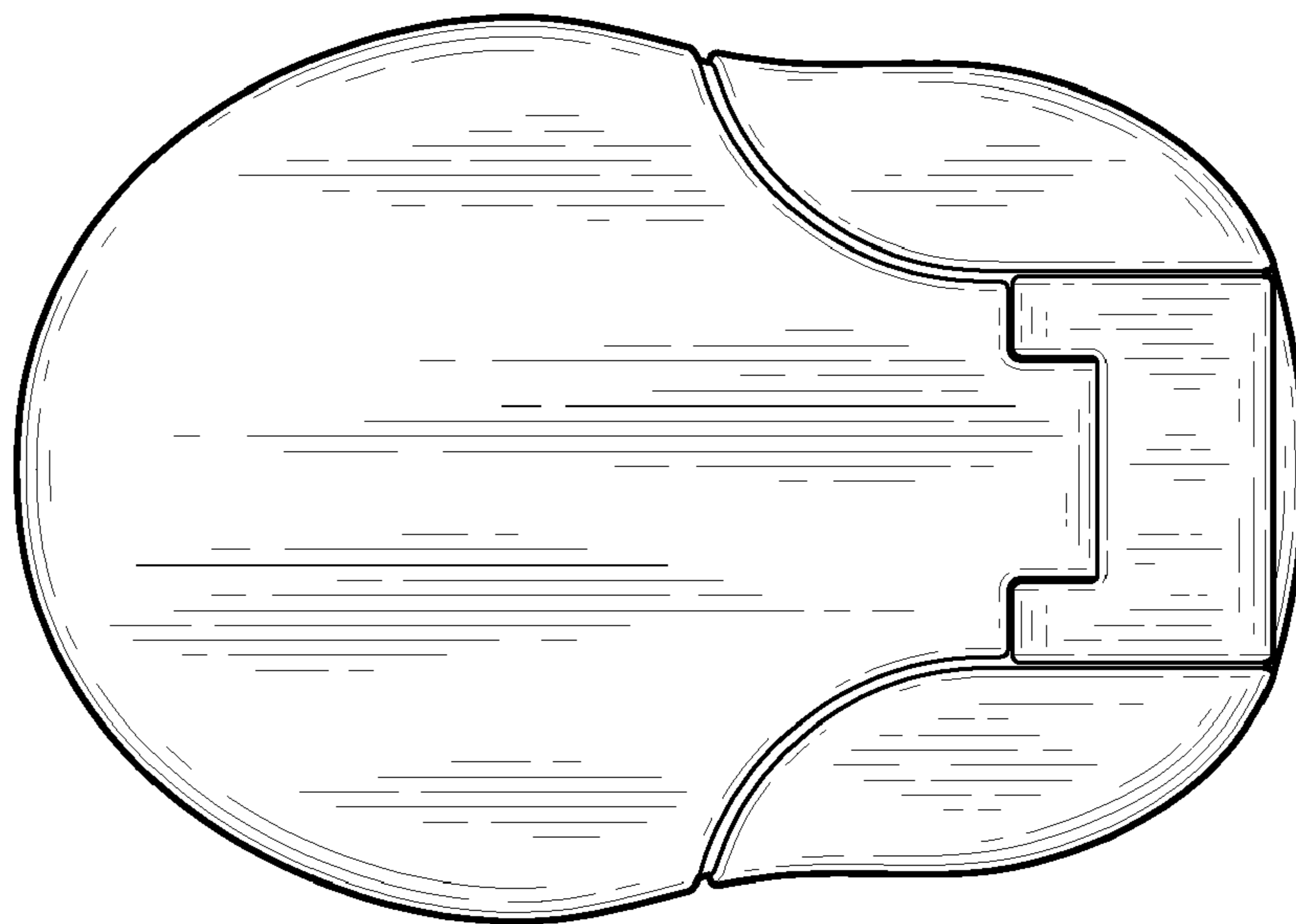

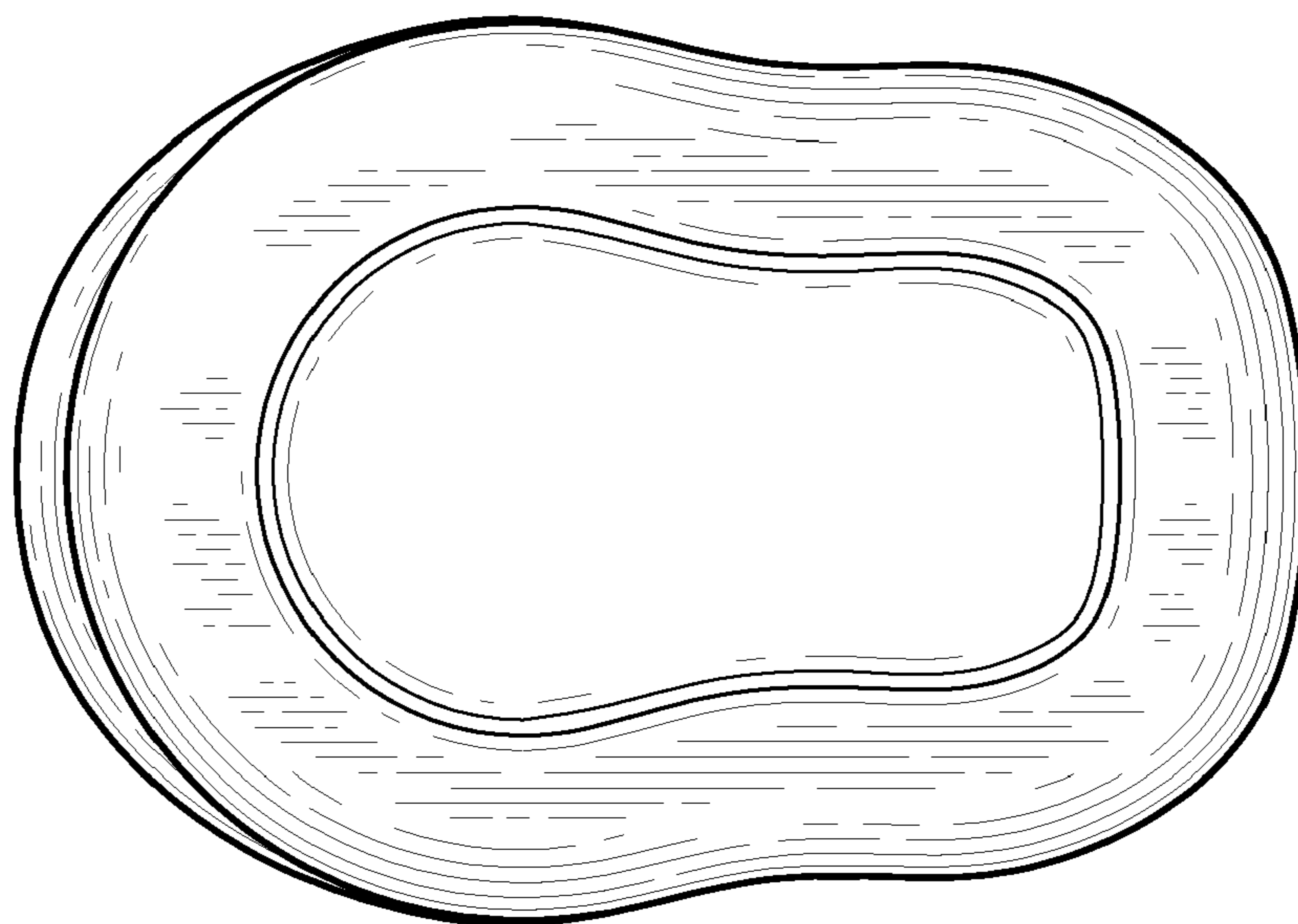

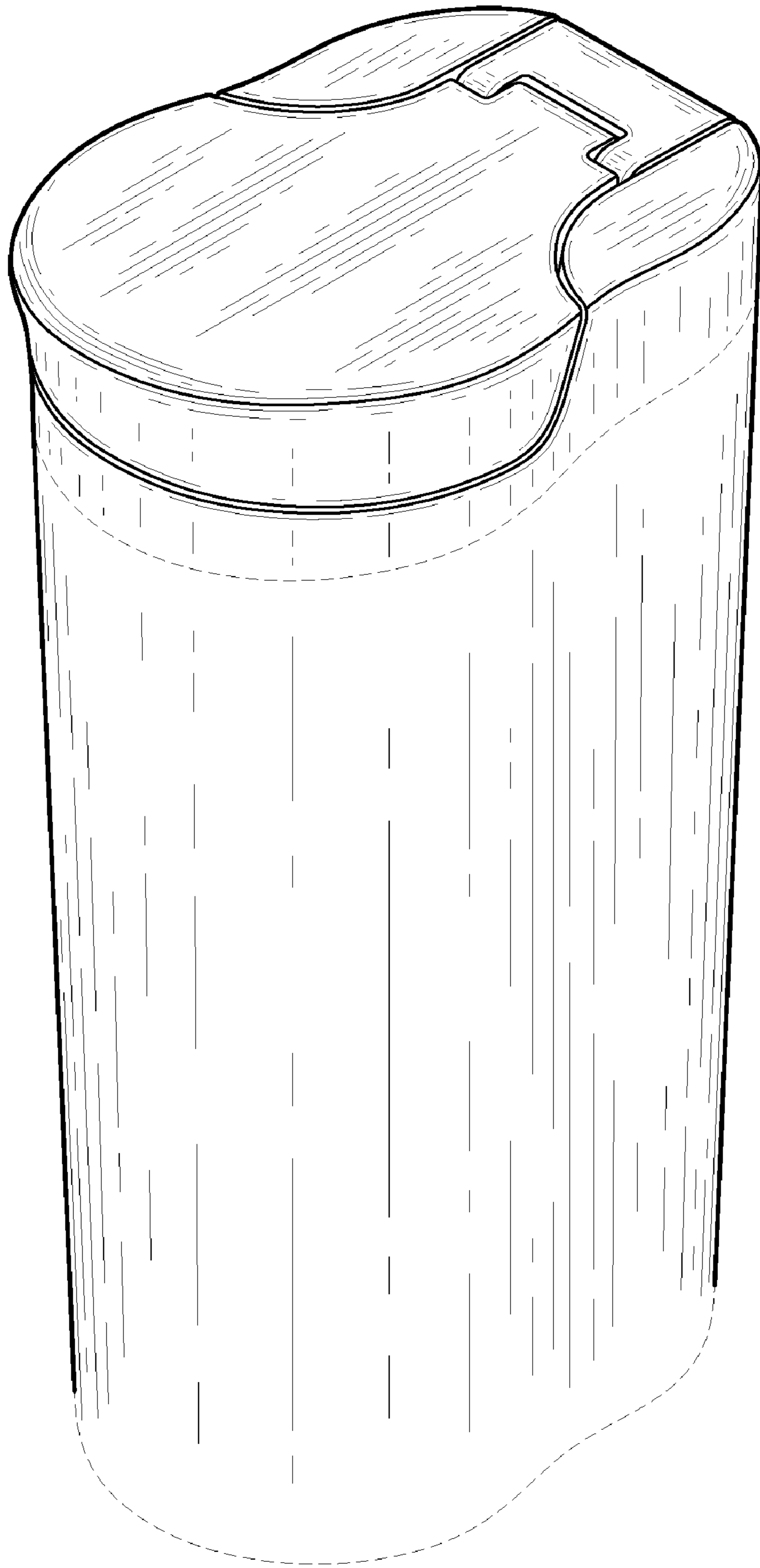

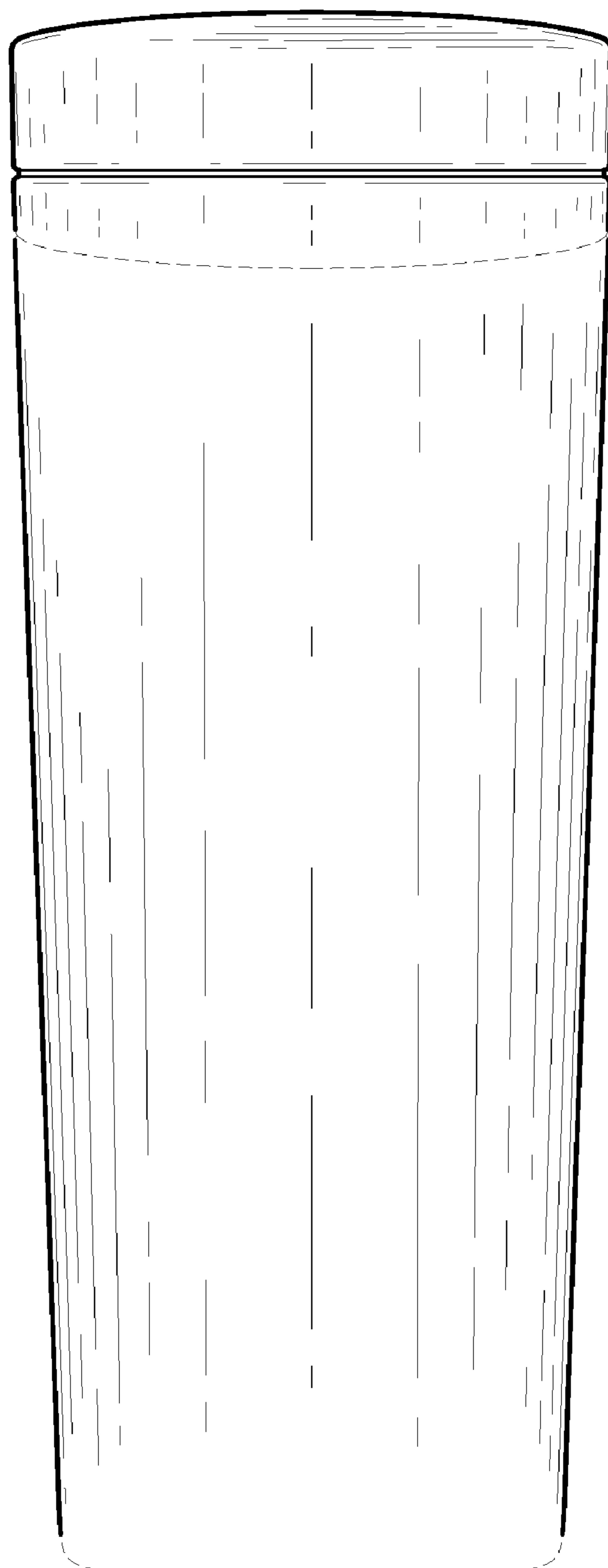

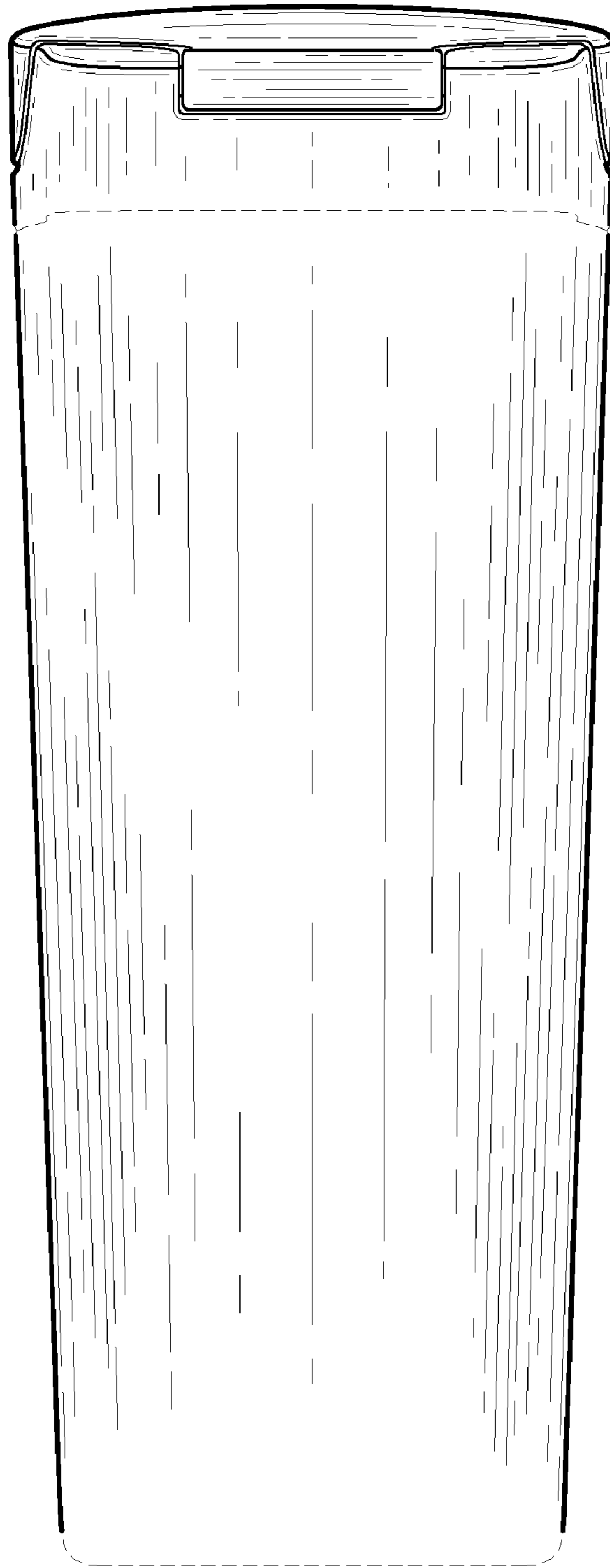

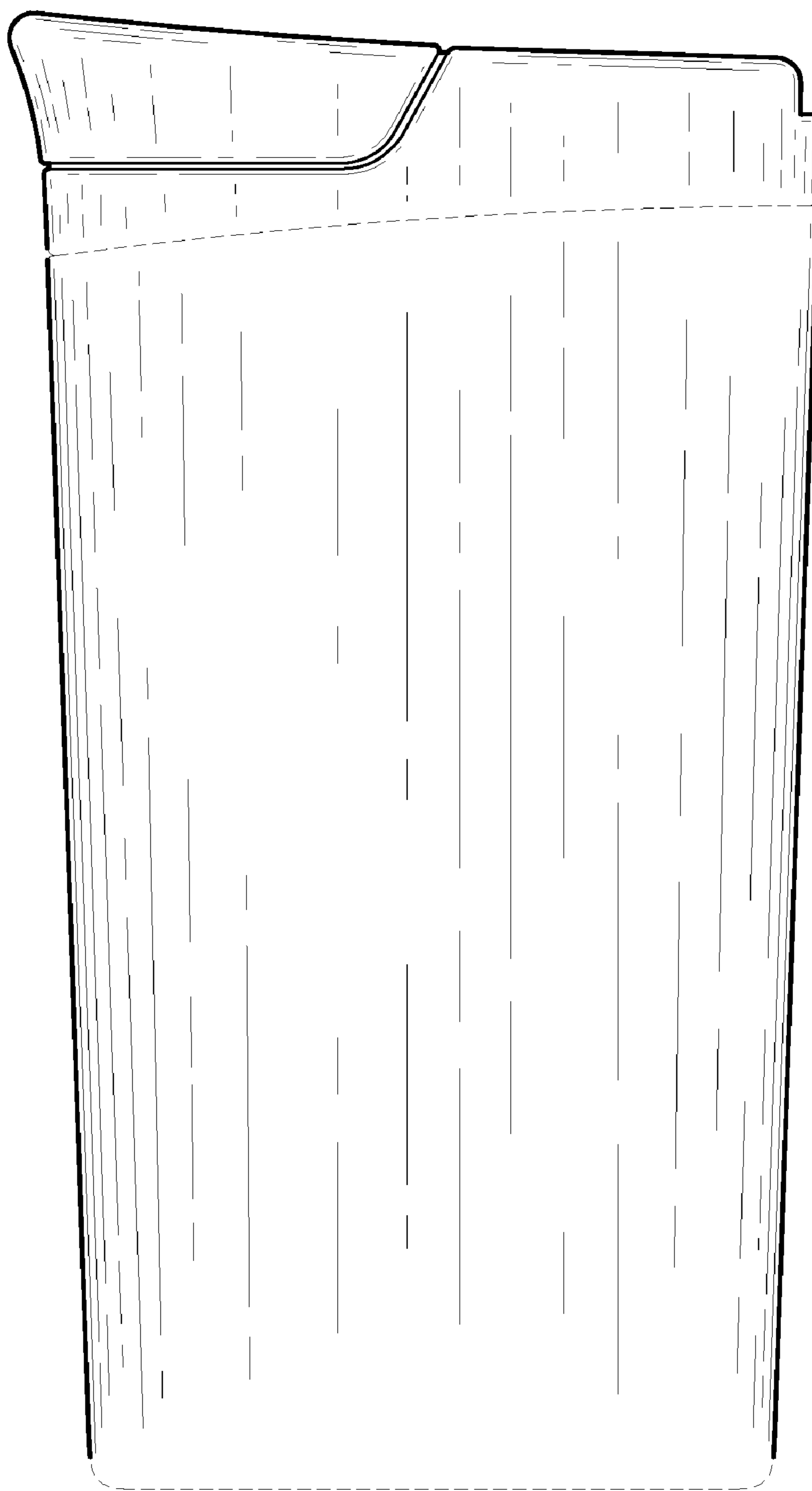

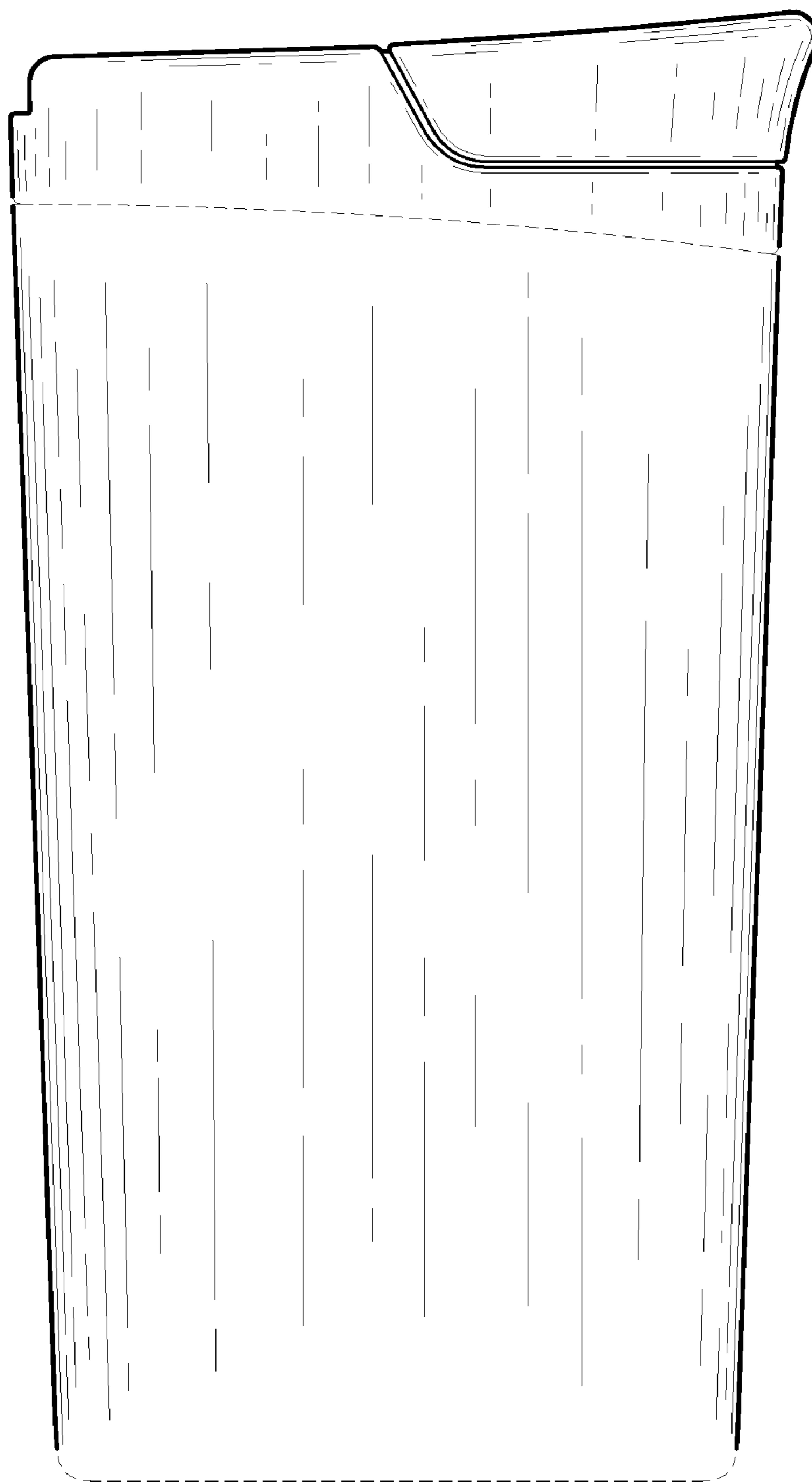

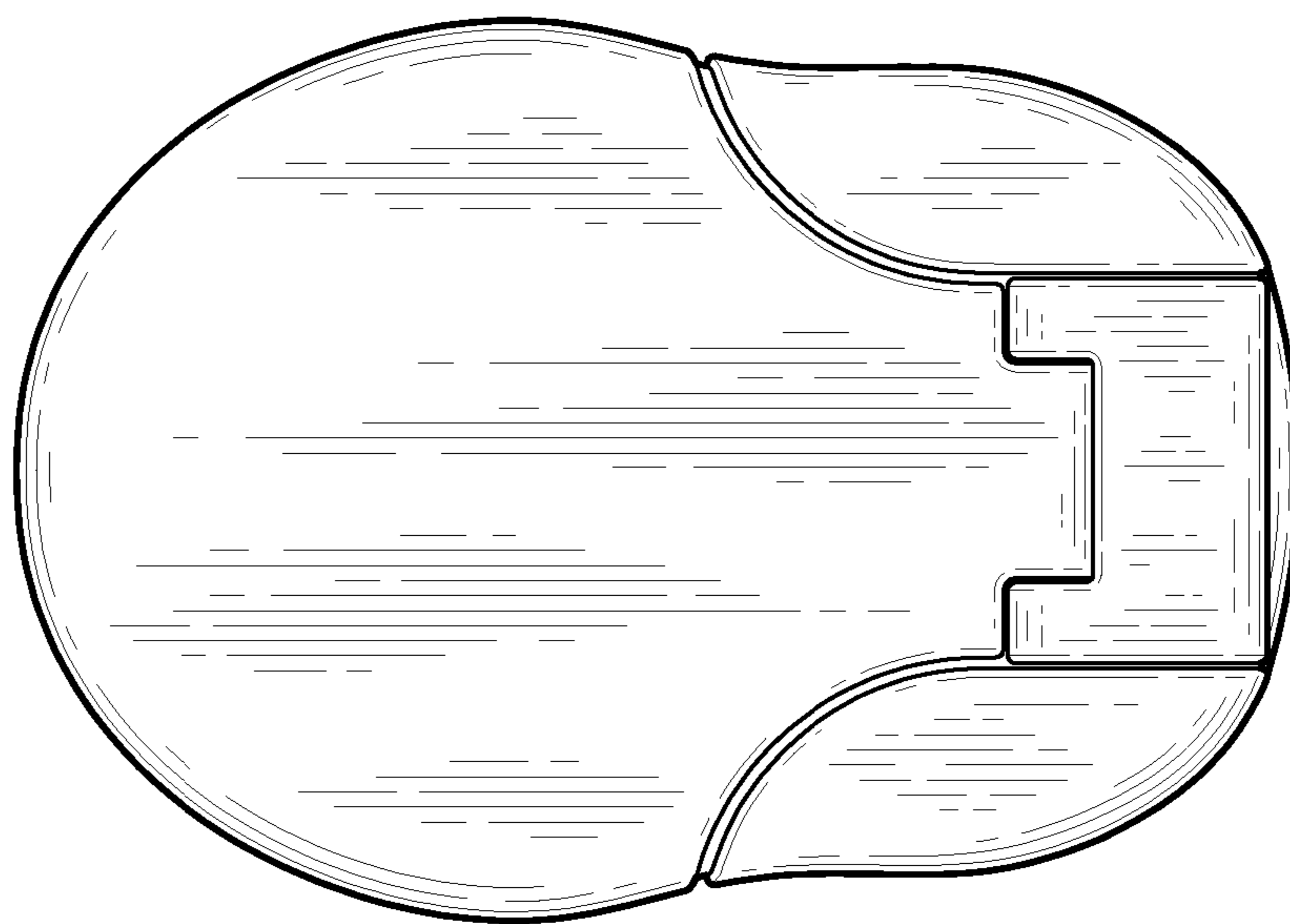

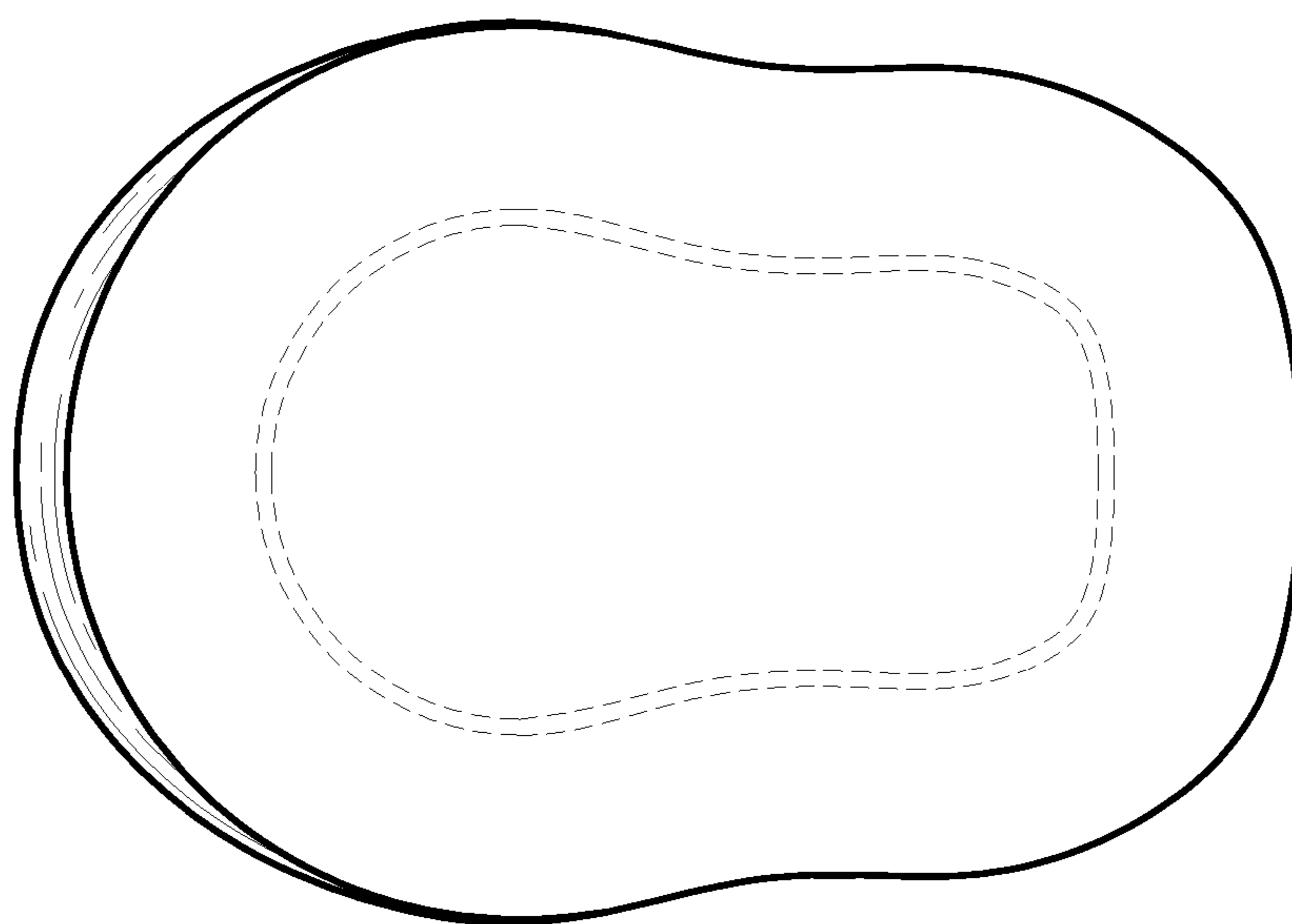

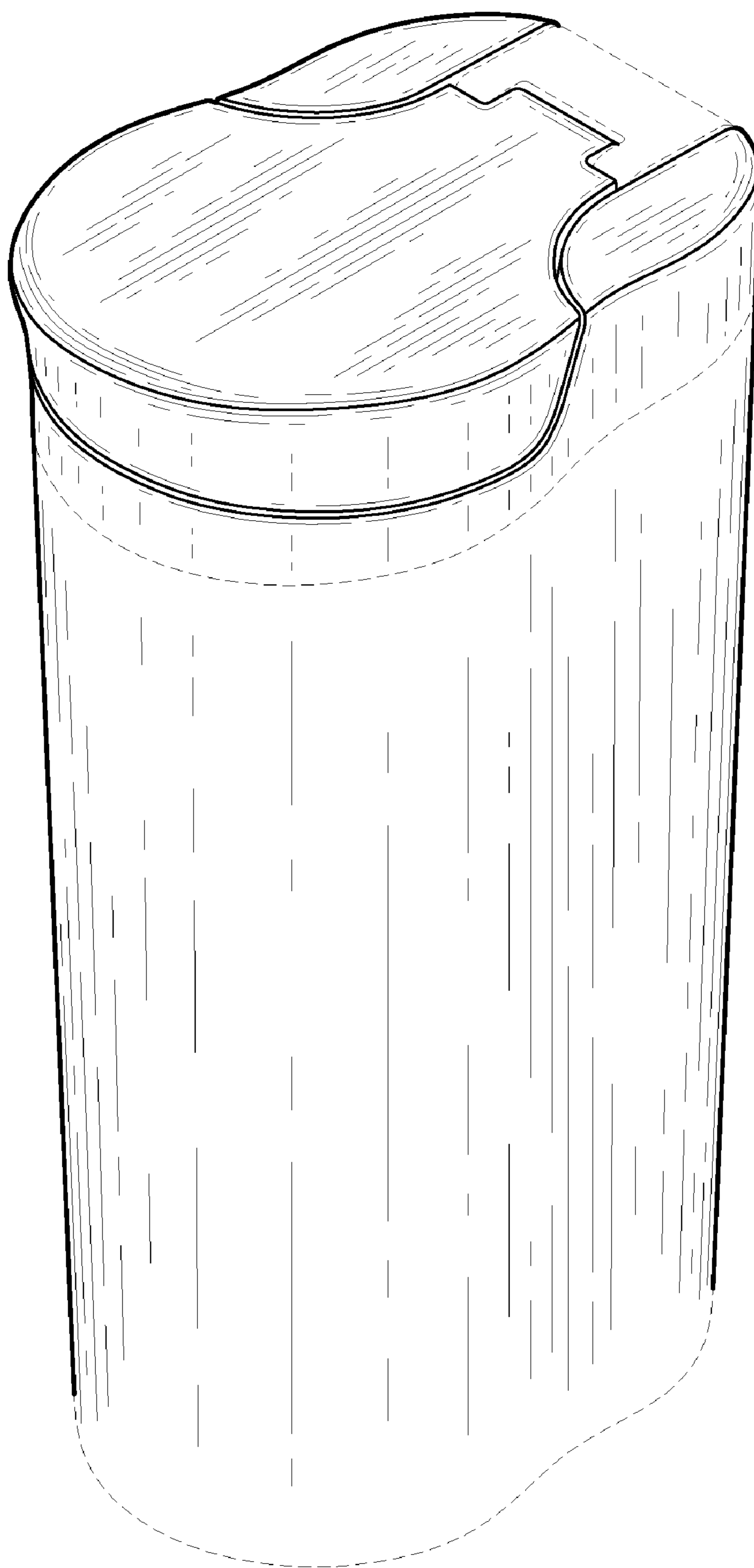

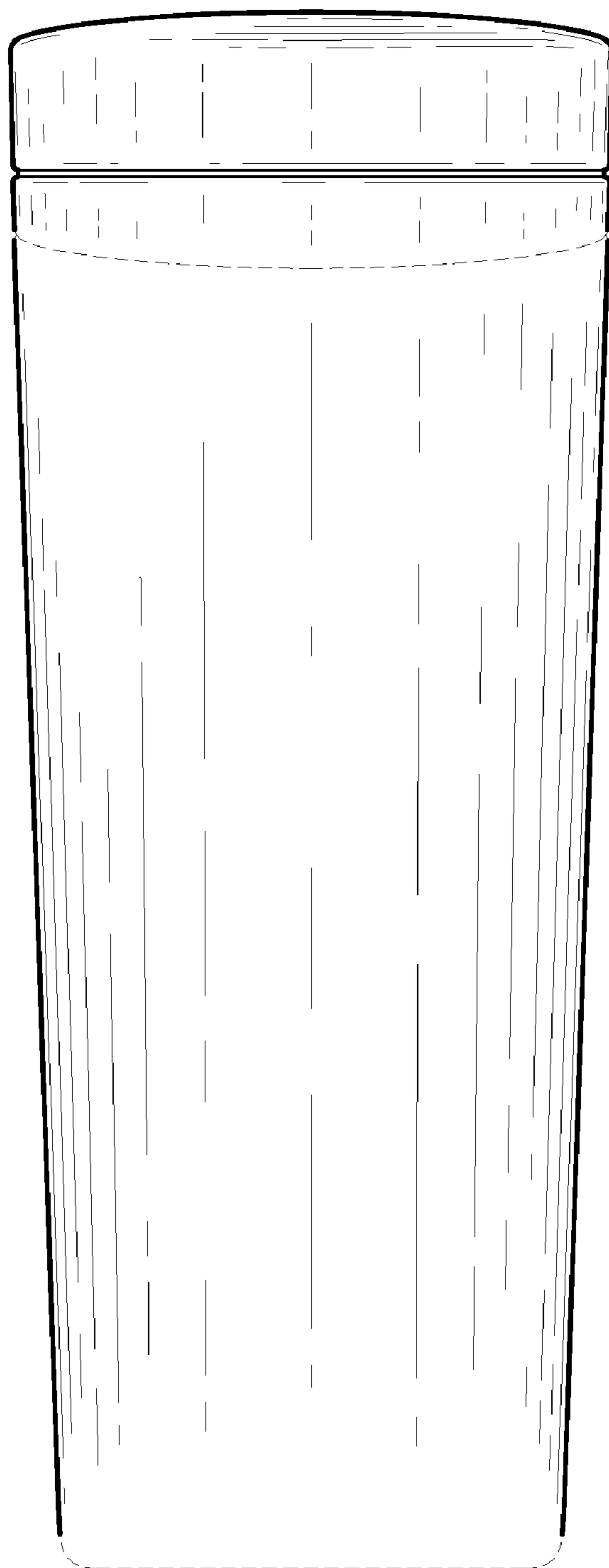

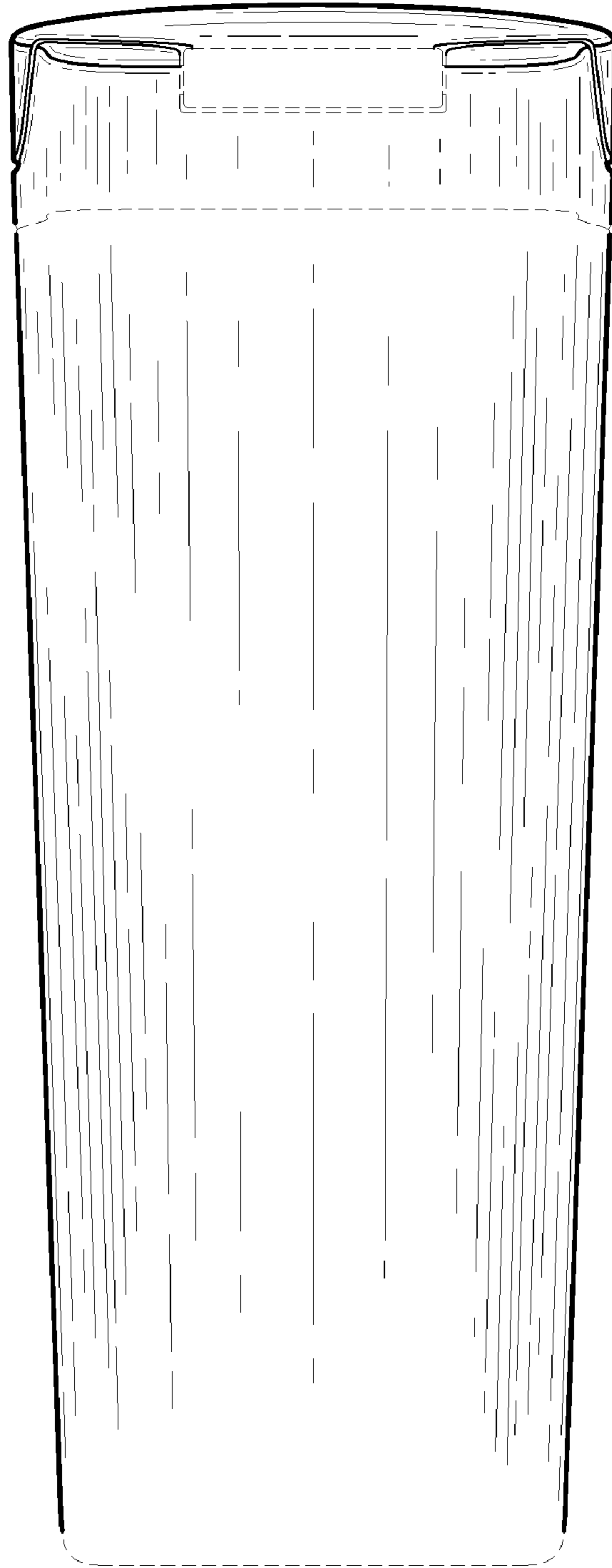

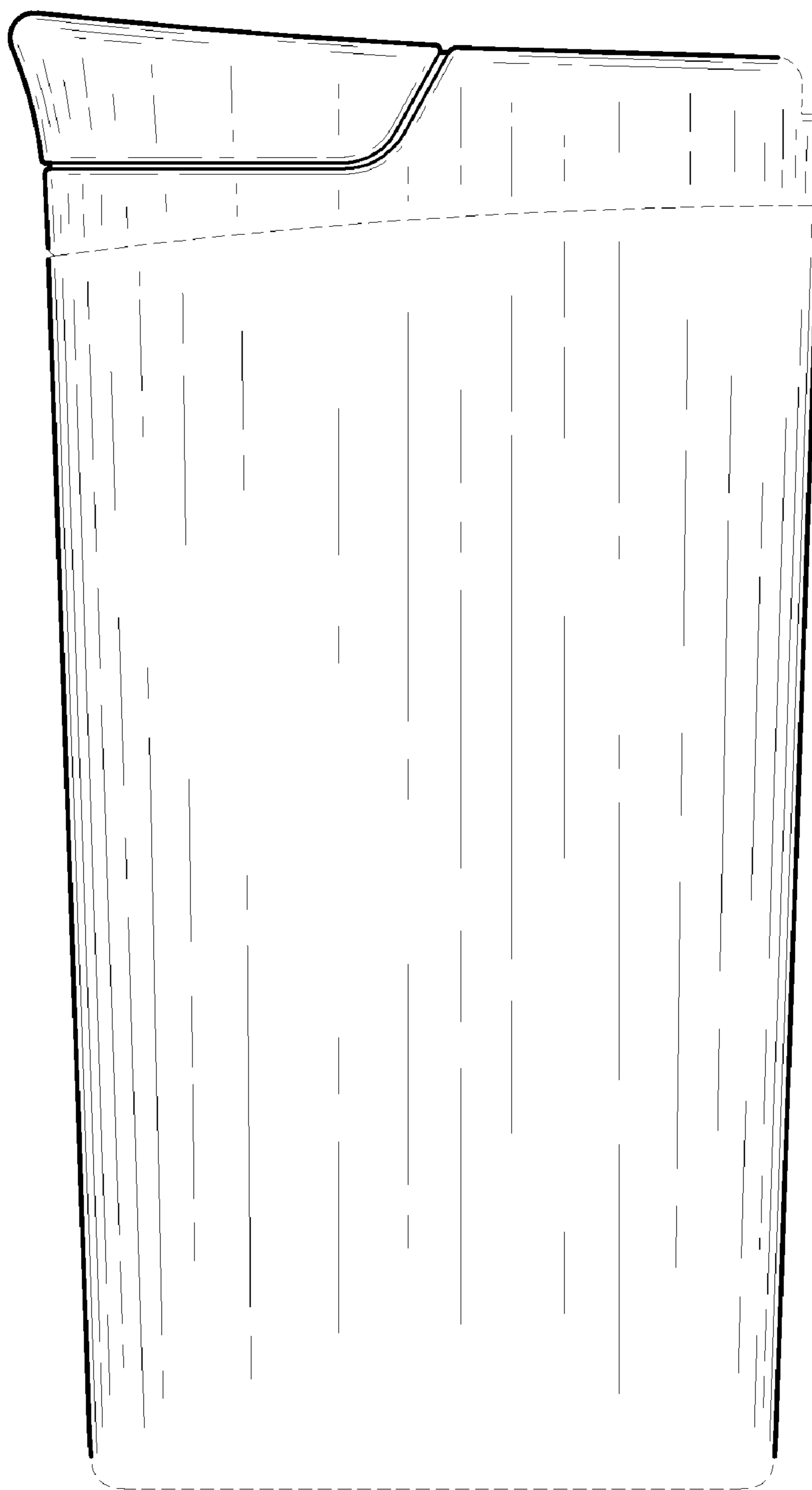

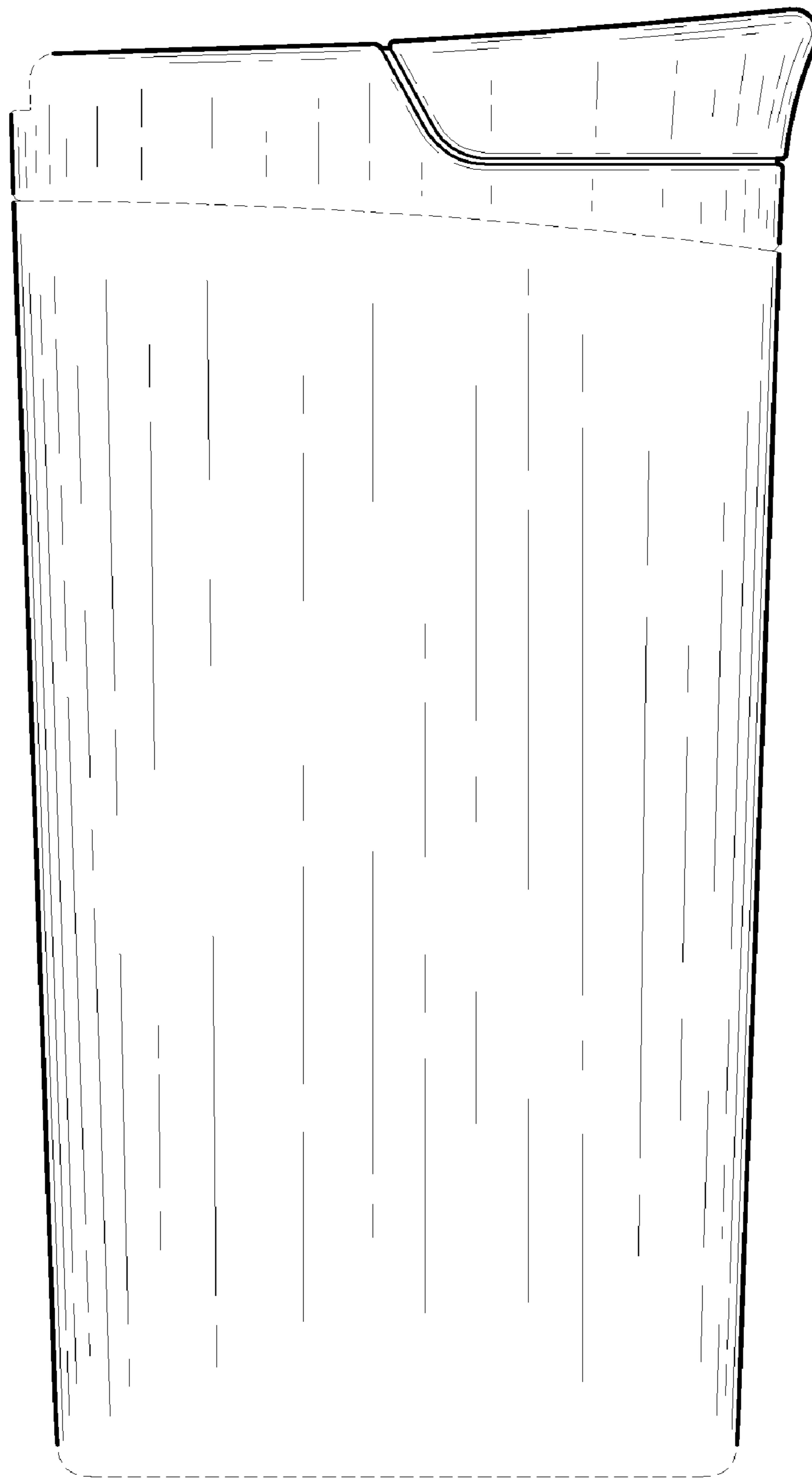

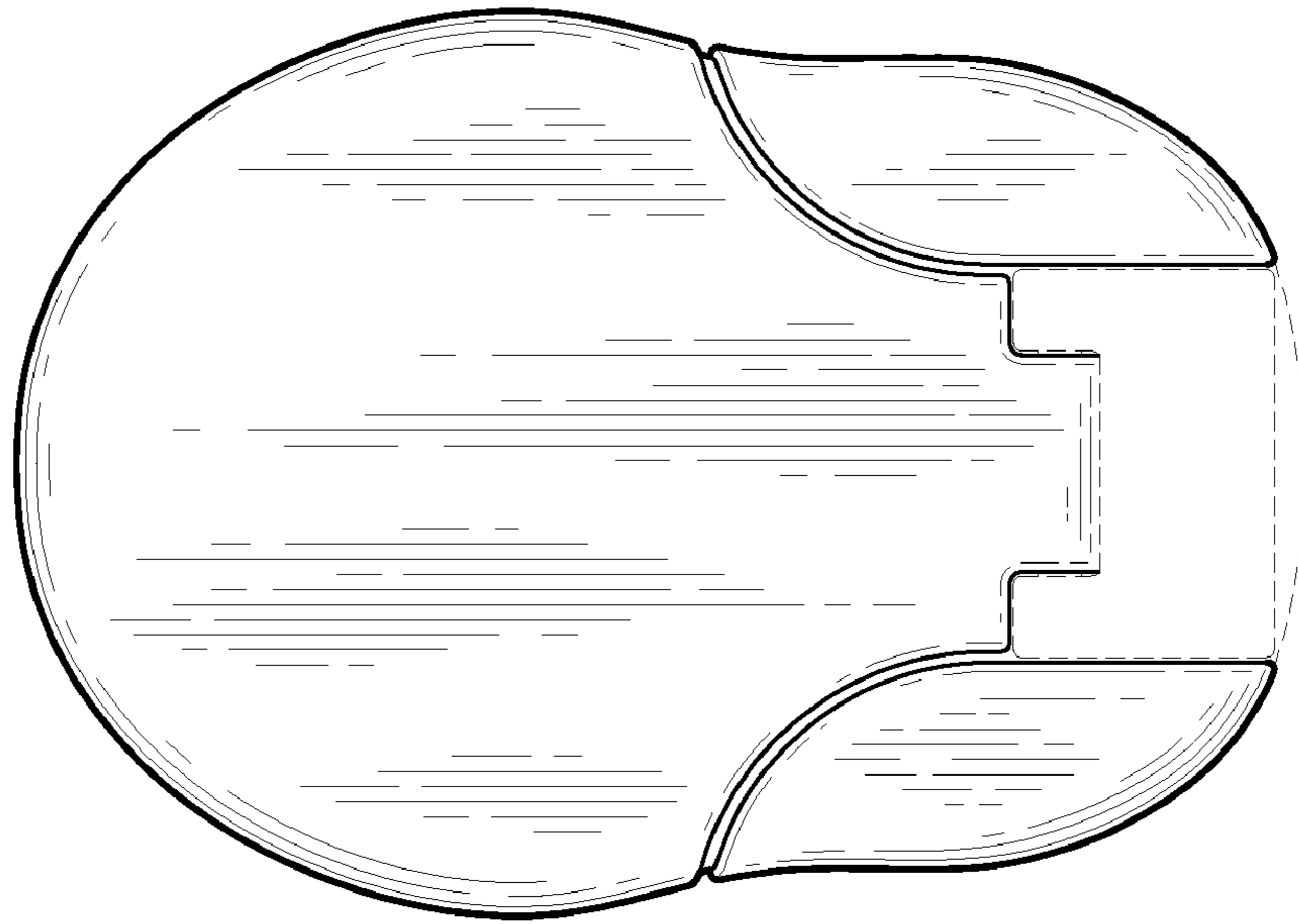

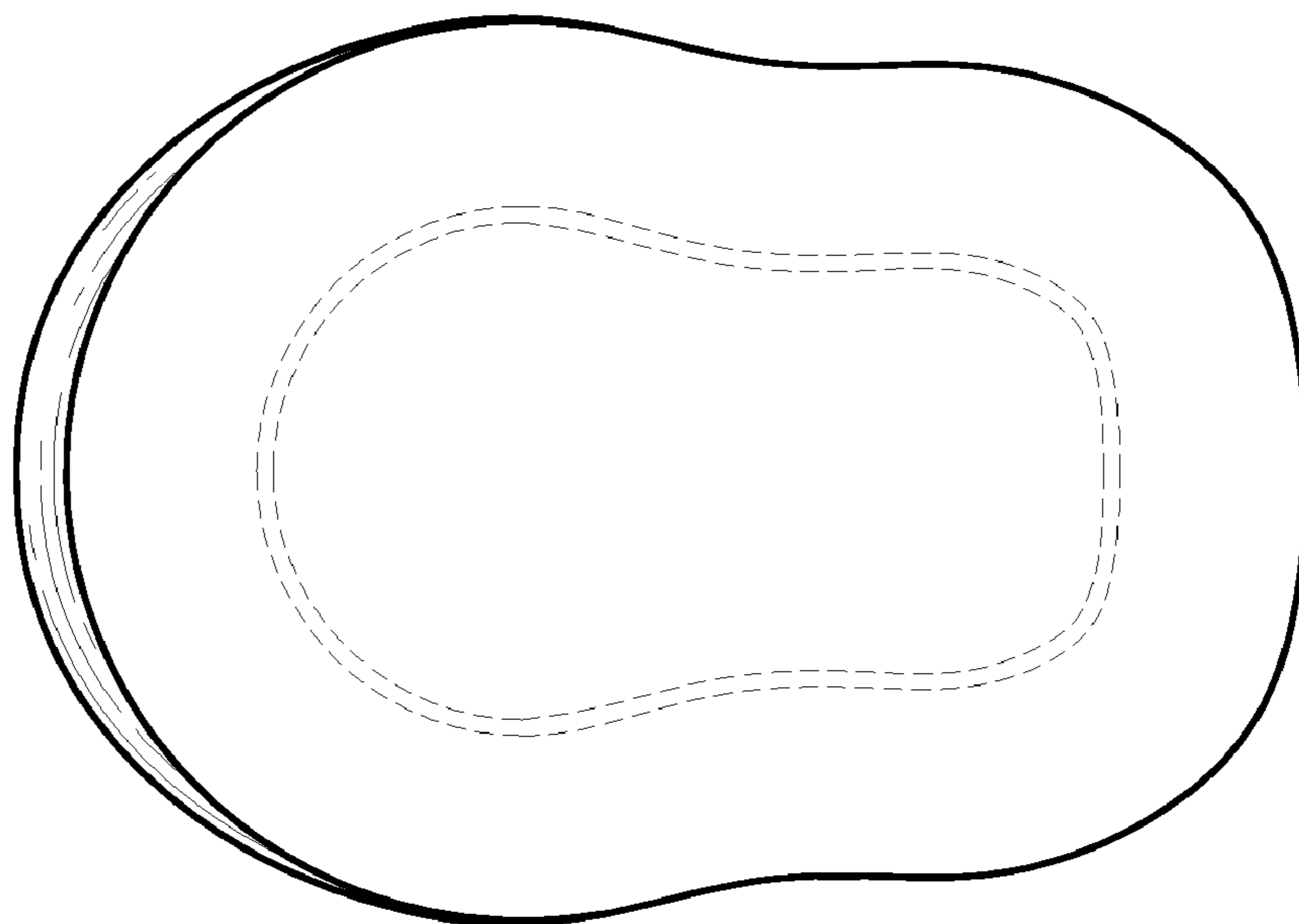

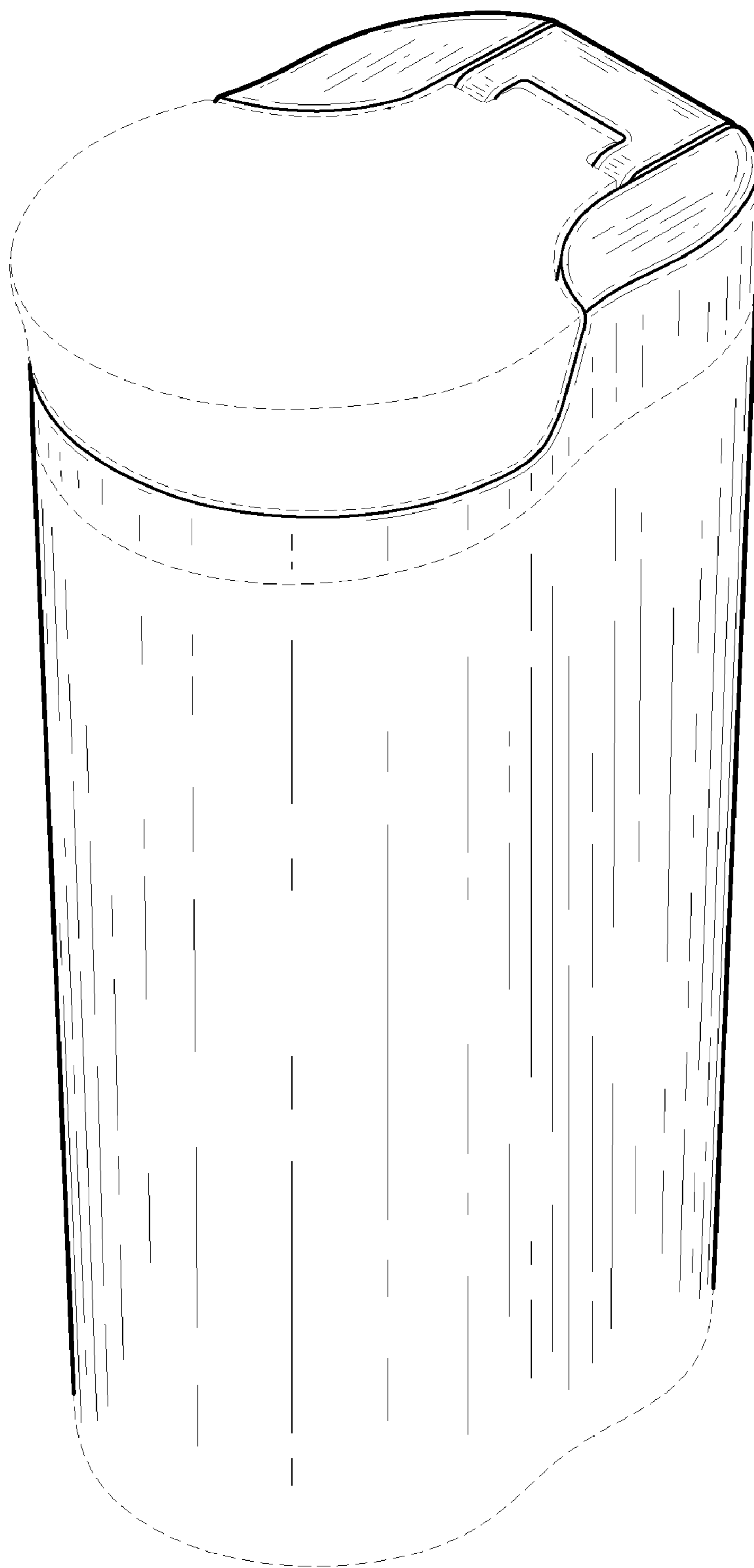

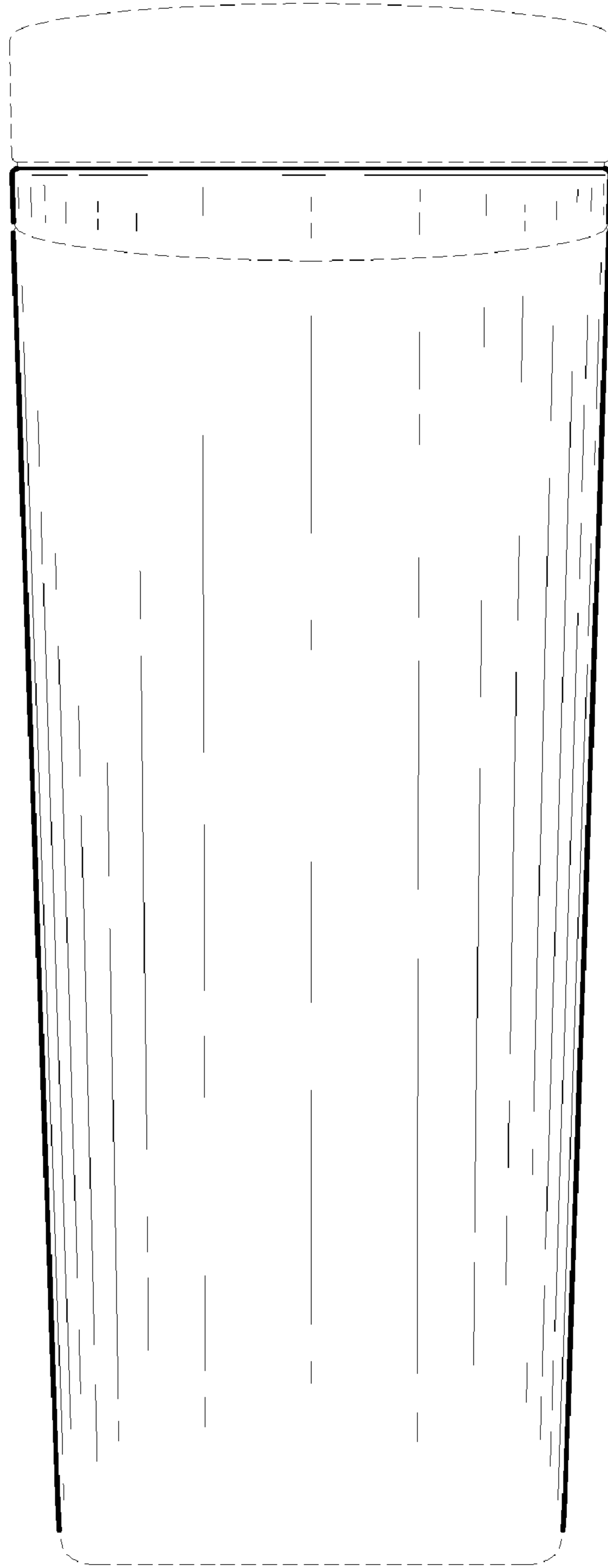

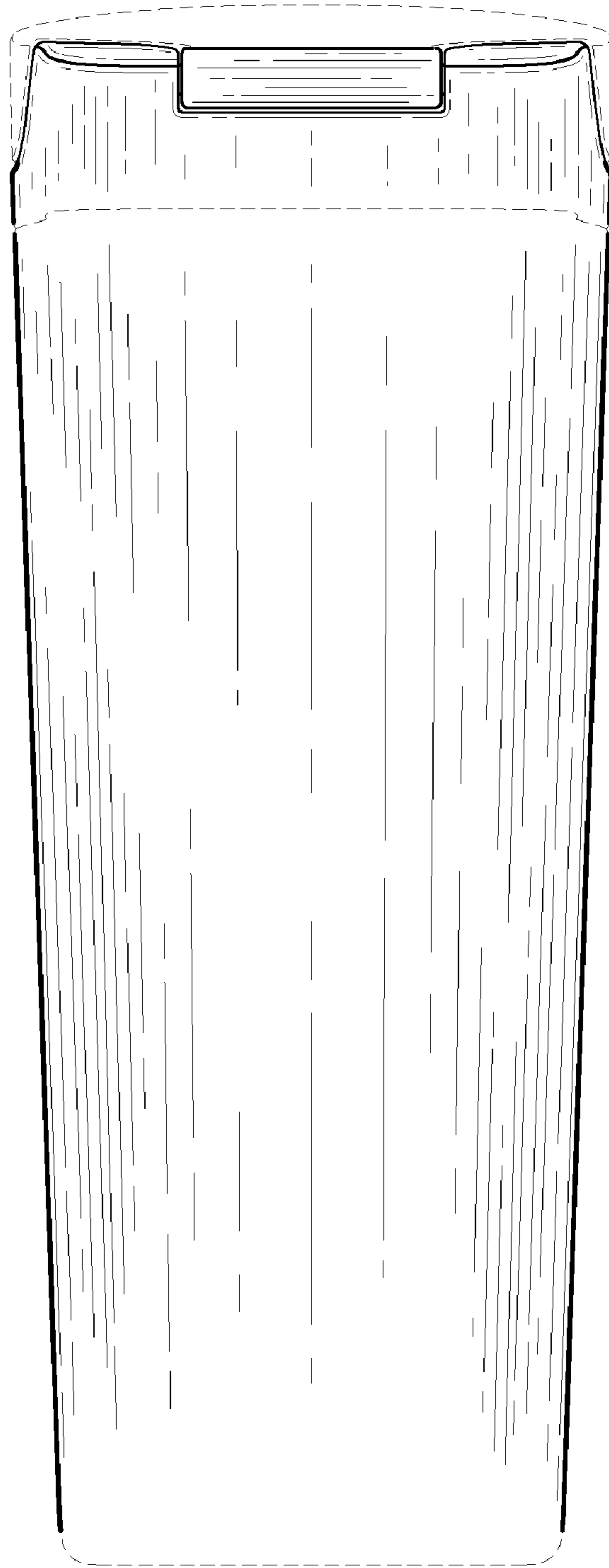

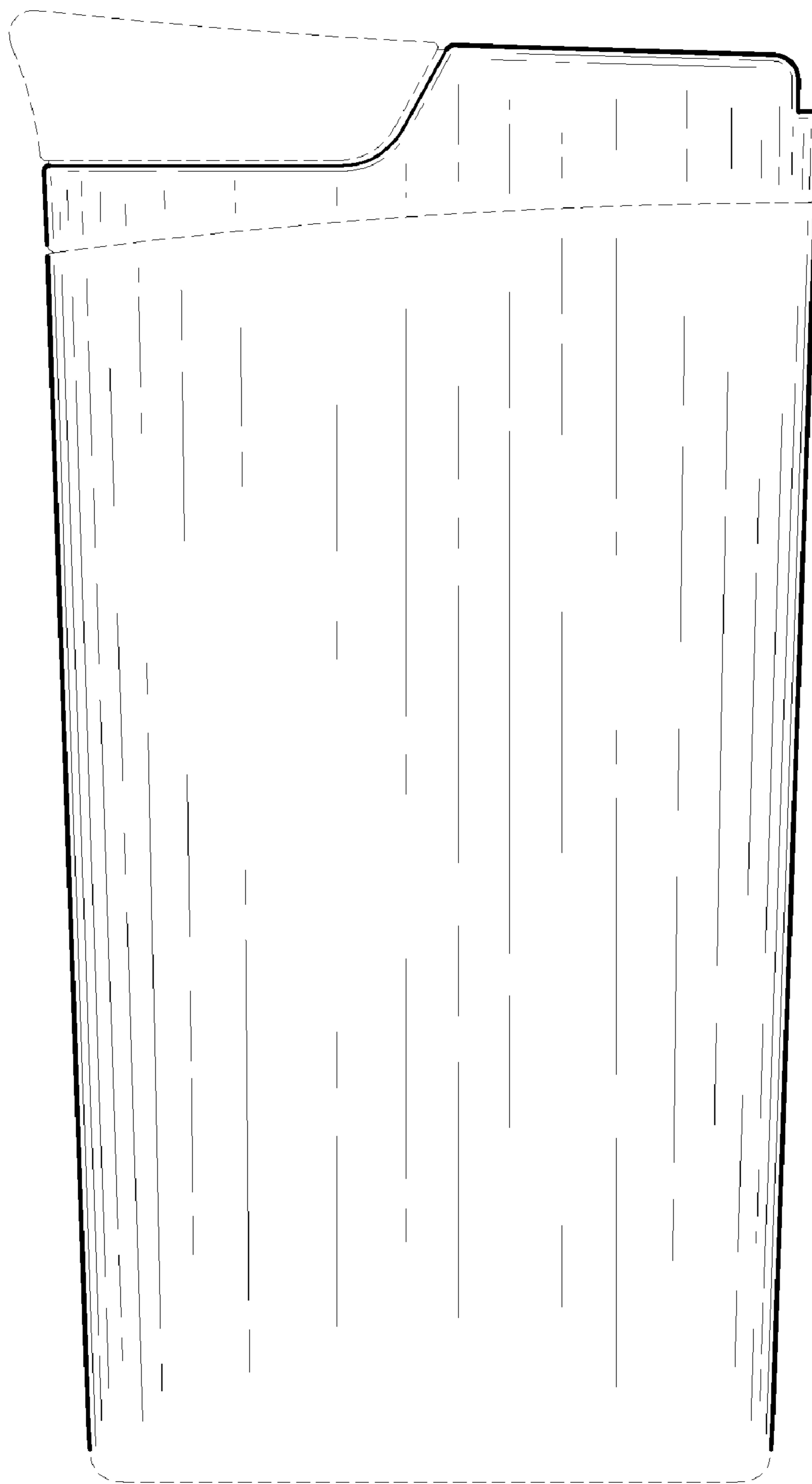

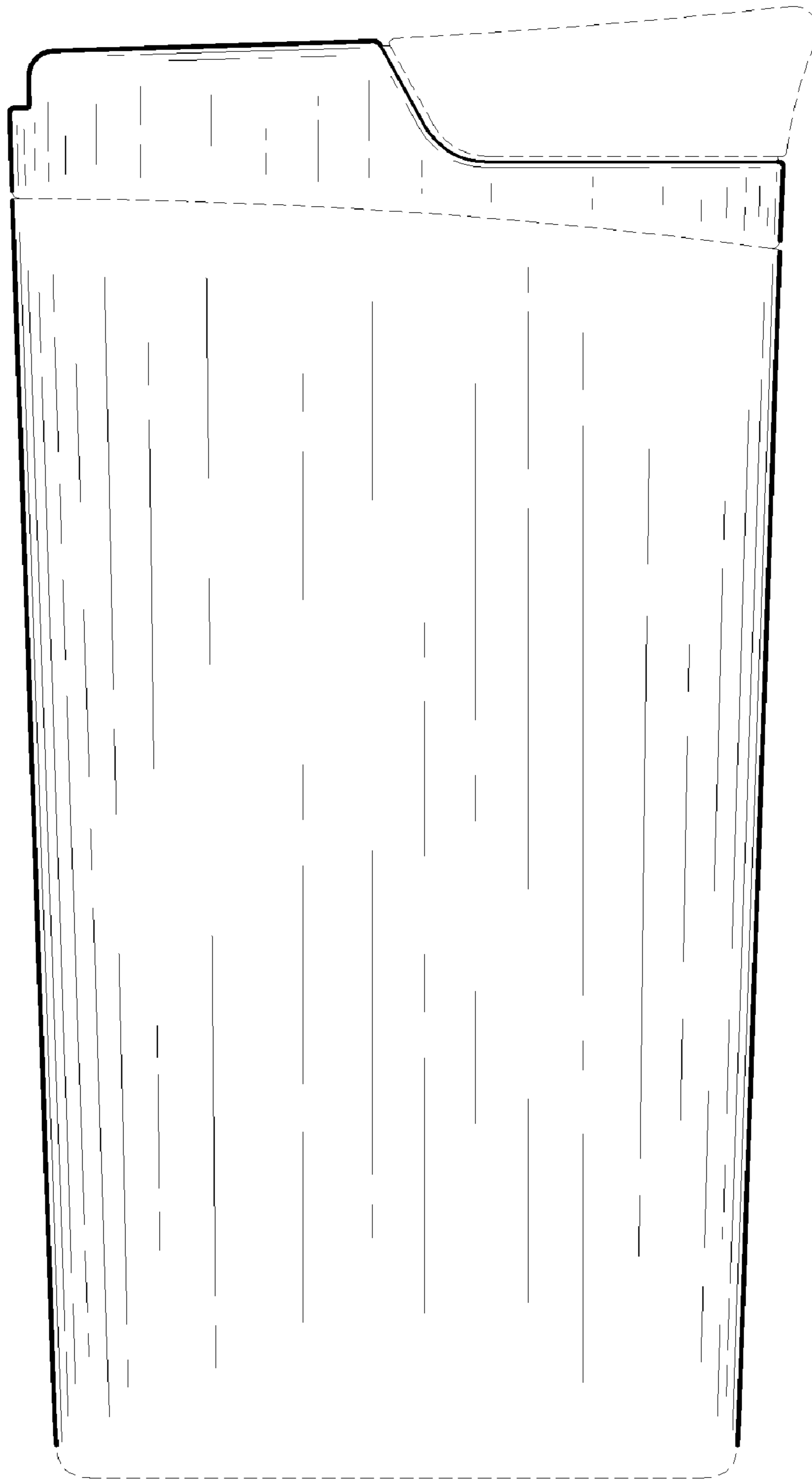

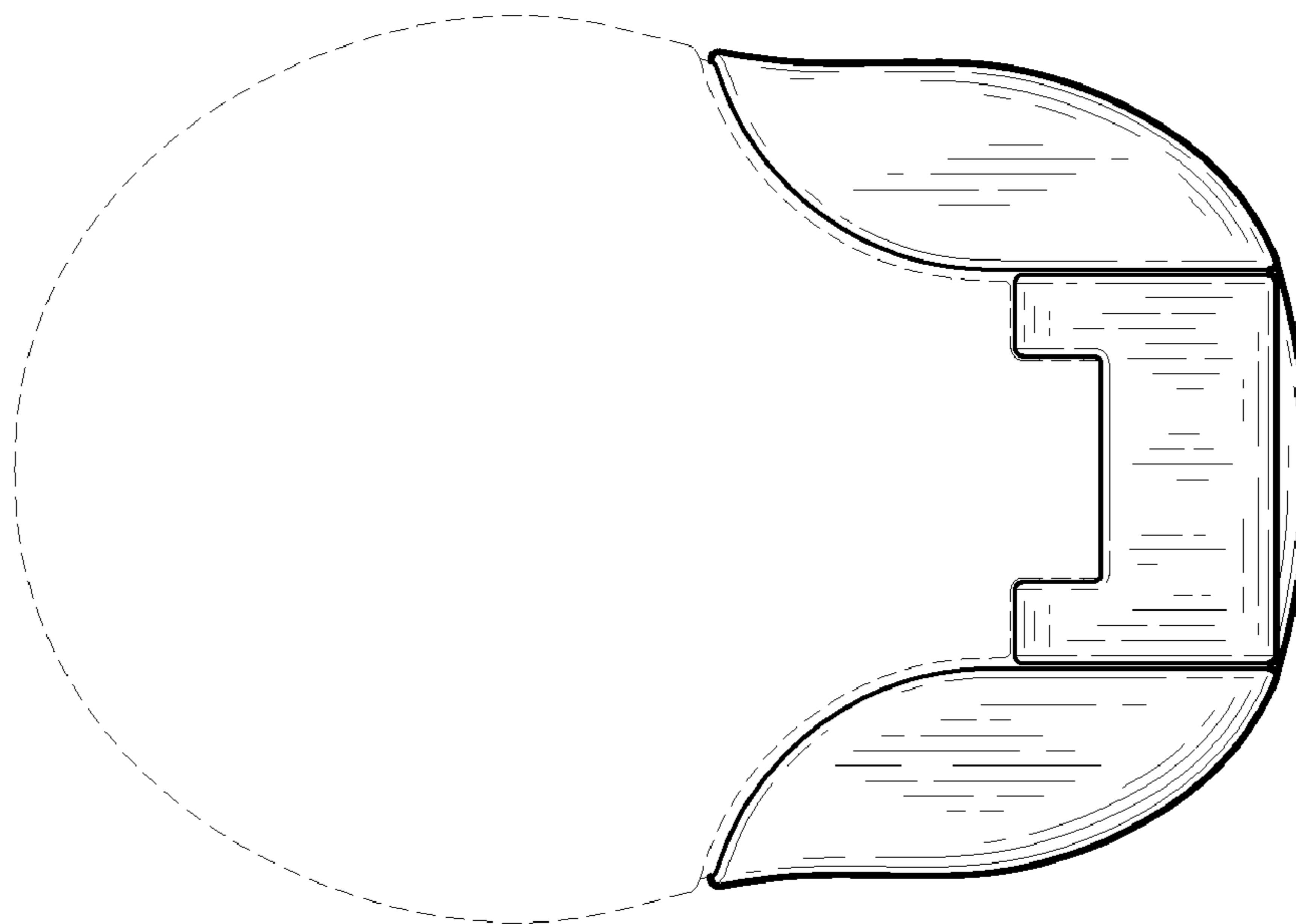

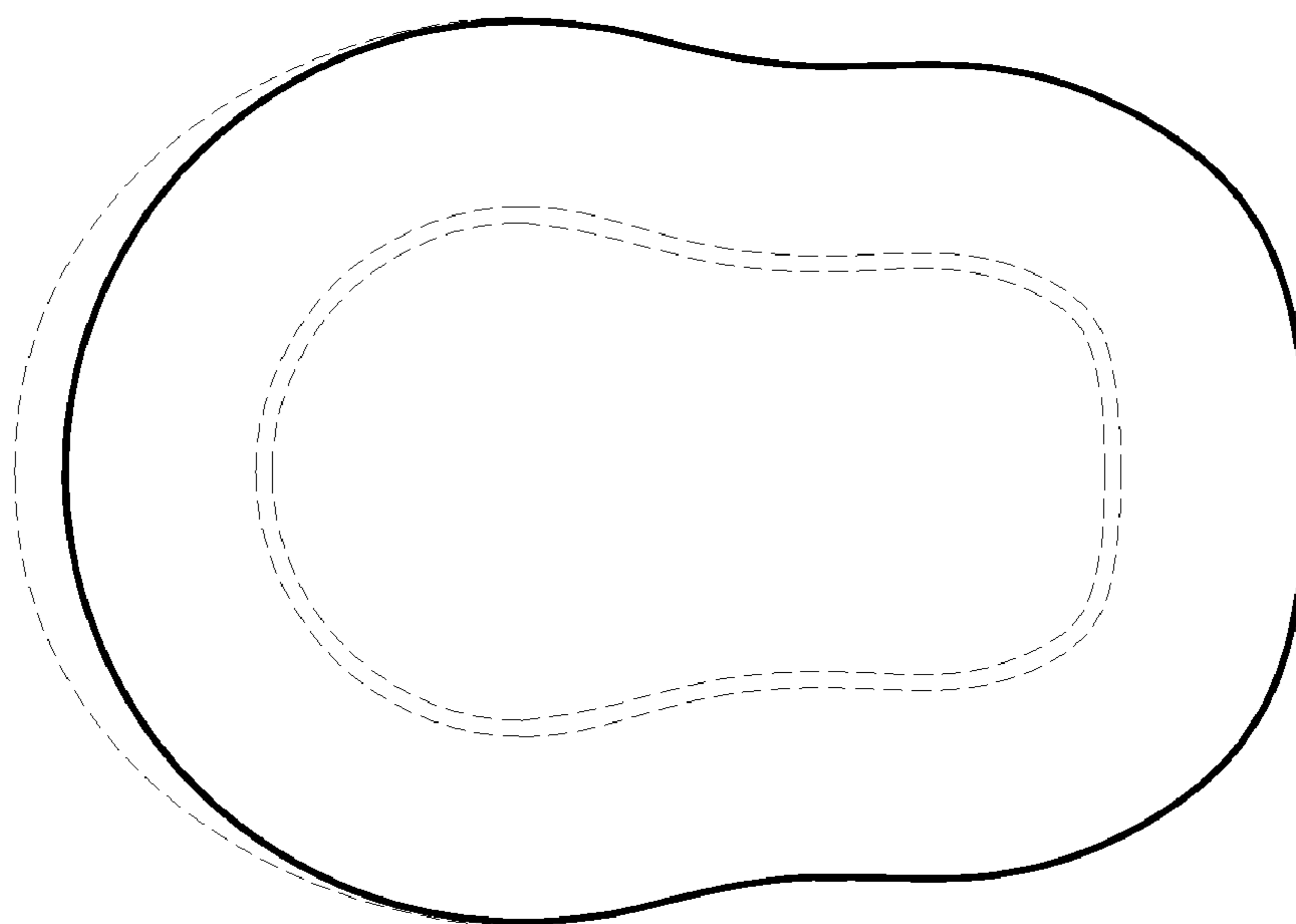
