FIG. 2 is a perspective view of the lunch box of this invention with the cover flap open.

FIG. 3 is a front elevational view of the lunch box shown in FIG. 1

FIG. 4 is a rear elevational view of the lunch box shown in FIG. 1.

FIG. 5 is a side elevational view of the lunch box shown in FIG. 1; and,

FIG. 6 is a plan view of the lunch box shown in FIG. 1.

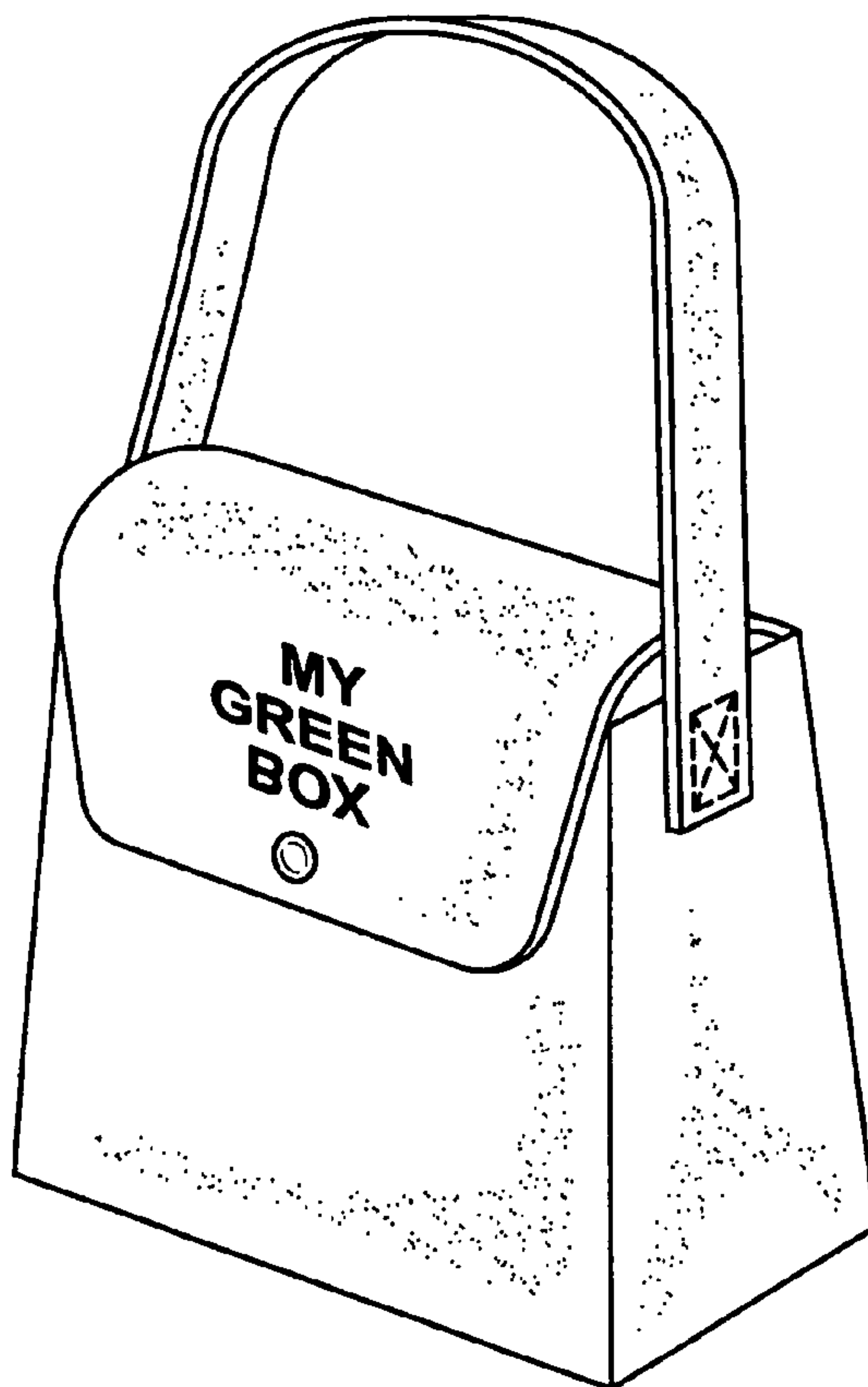
The broken lines in the drawings on the side surface of the lunch box visible in FIGS. 1, 2 & 5 represent stitching and are included as part of the claim.

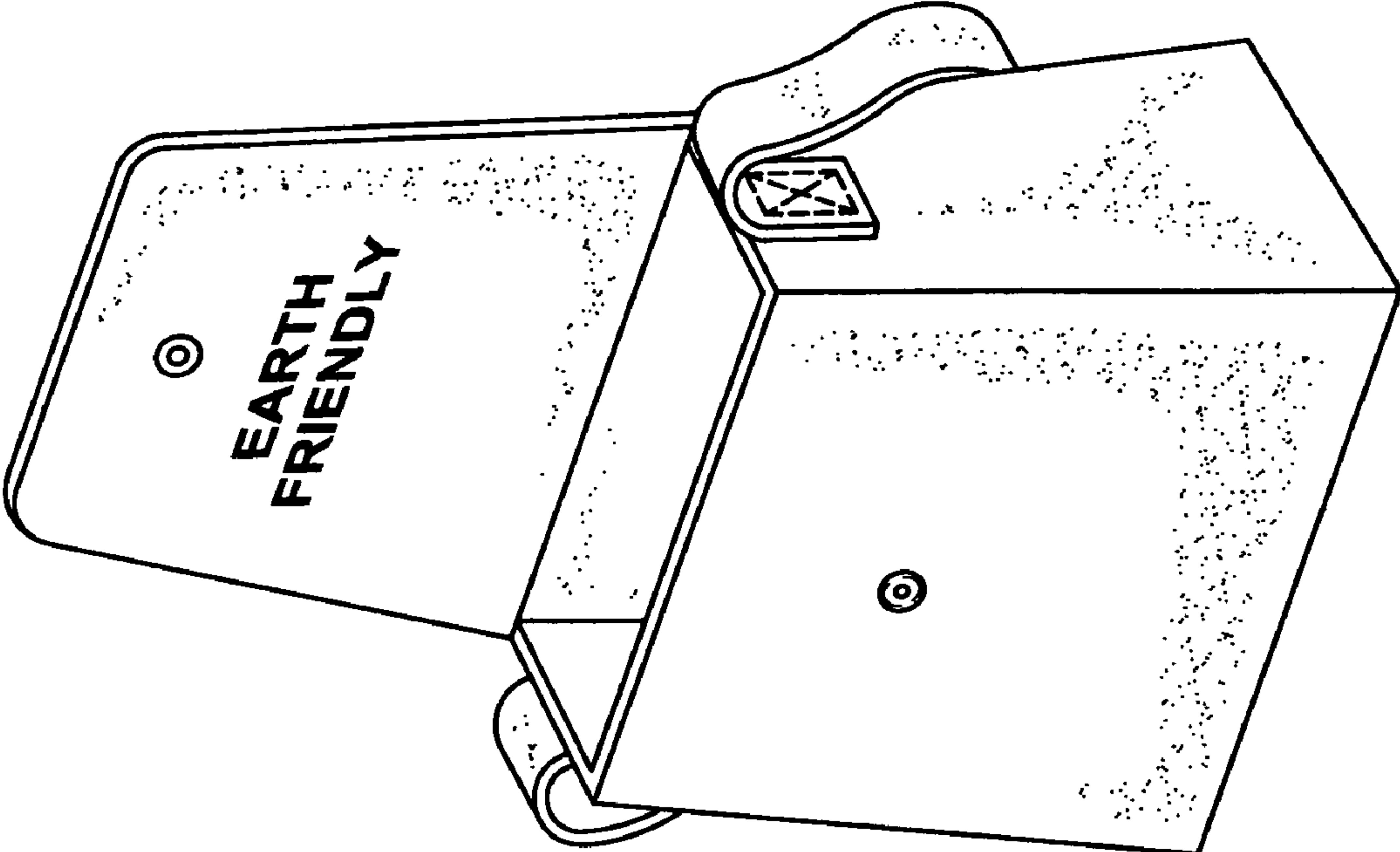

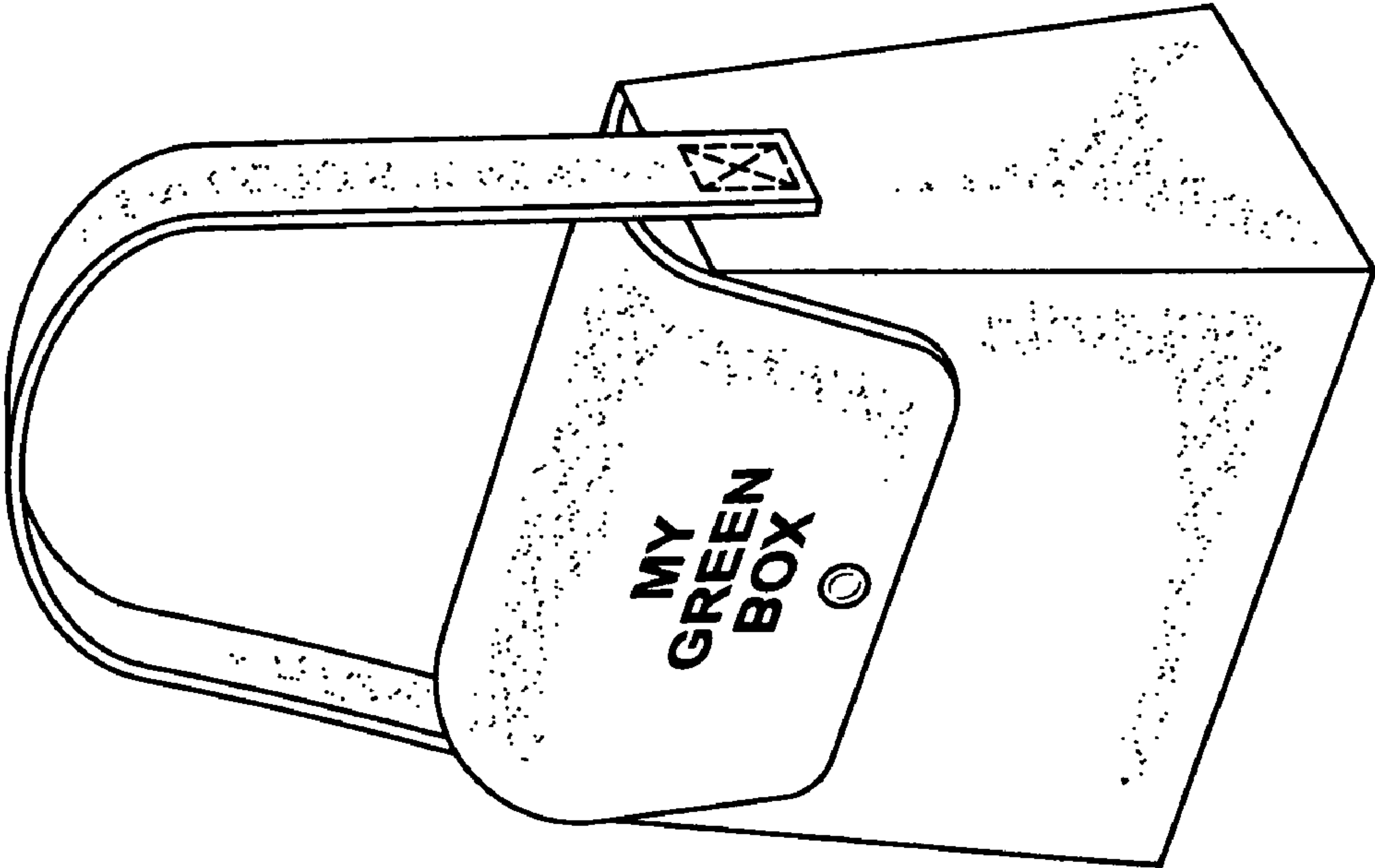

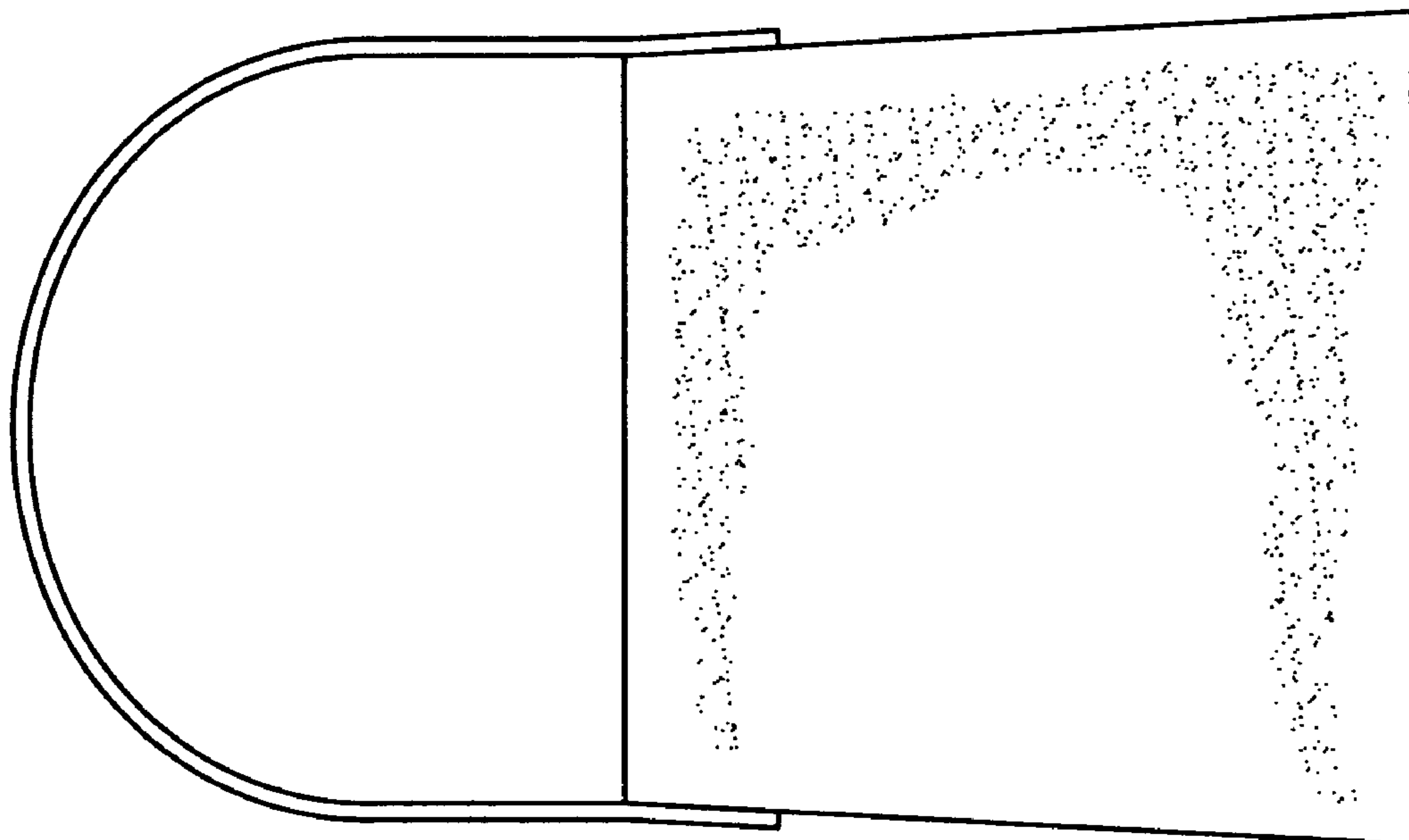

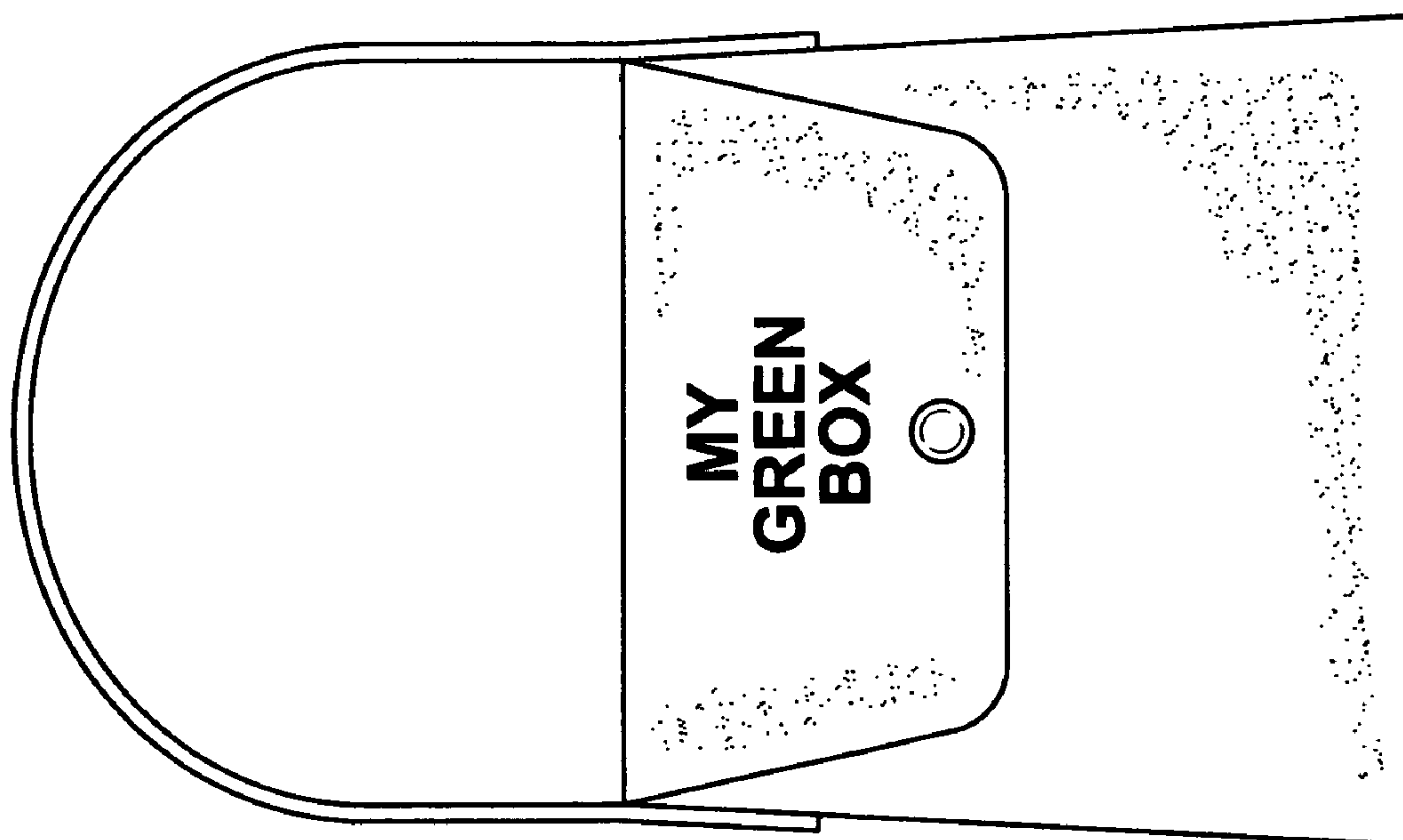

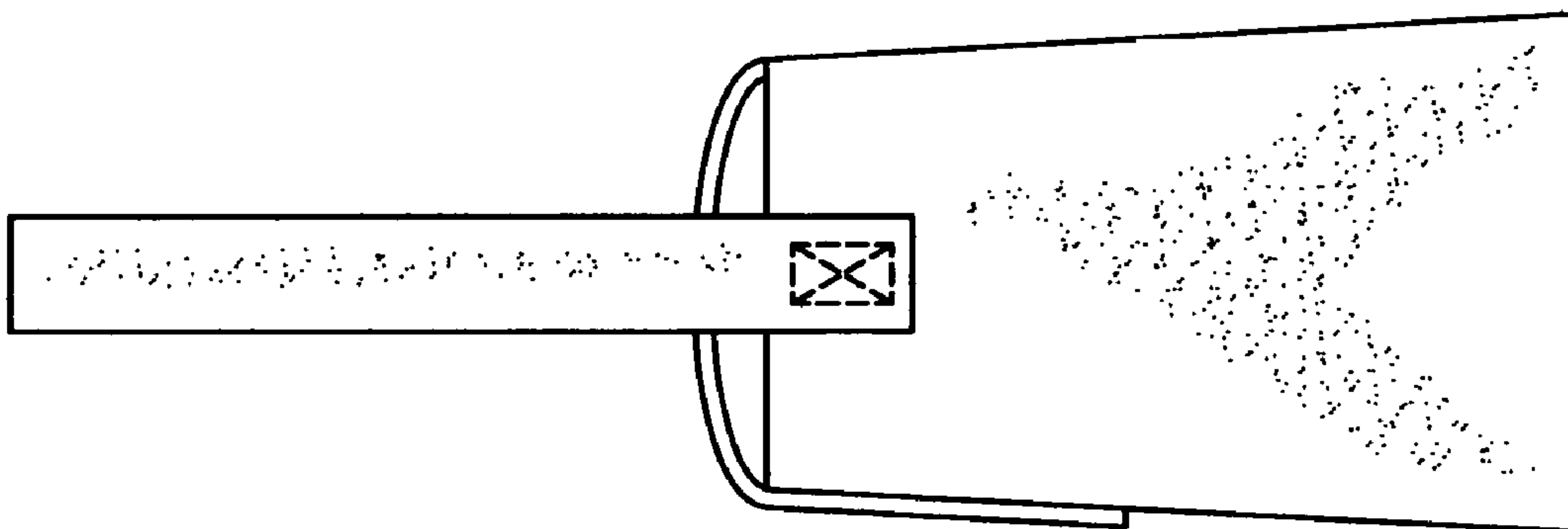

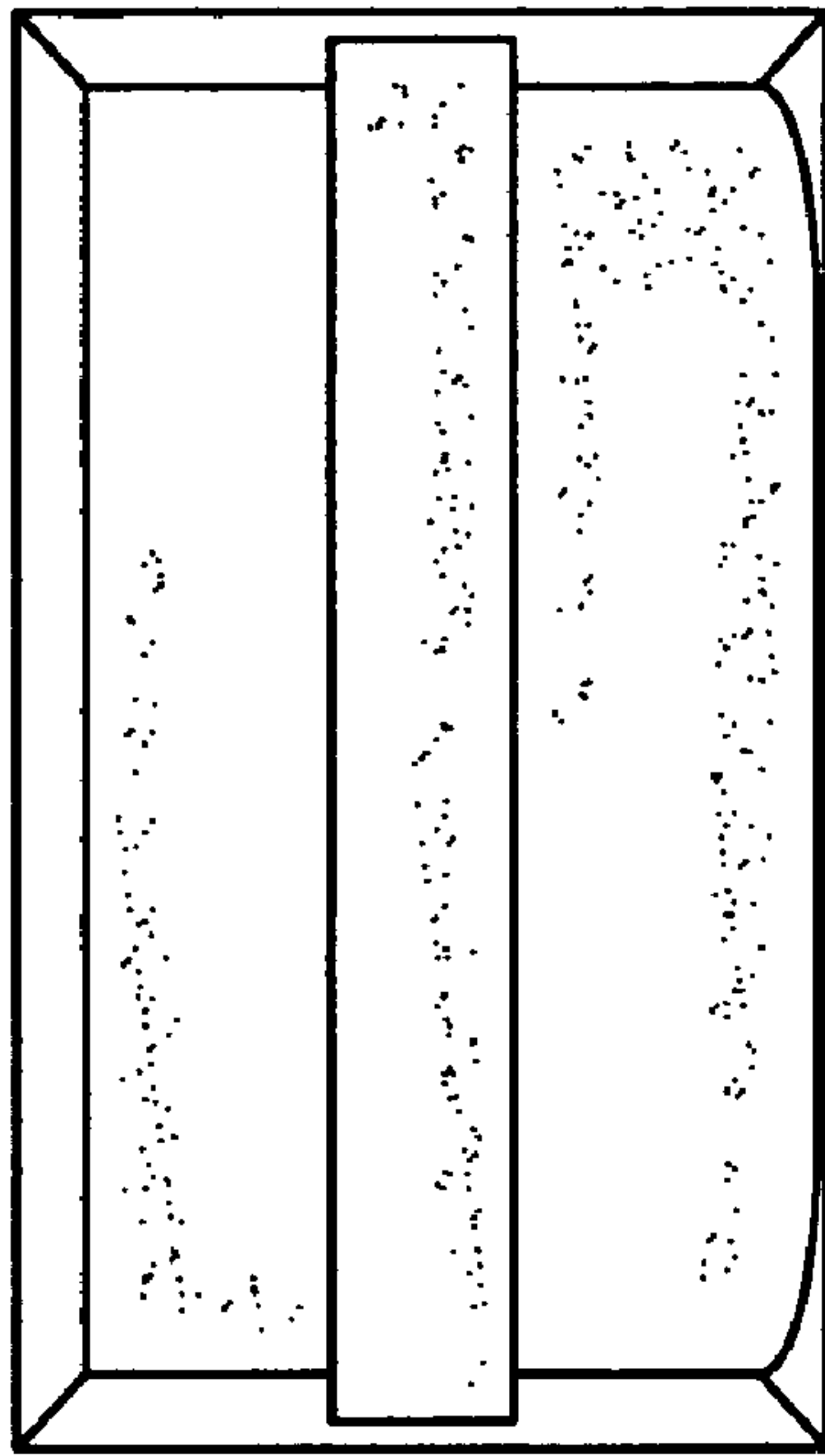
