**DESCRIPTION**

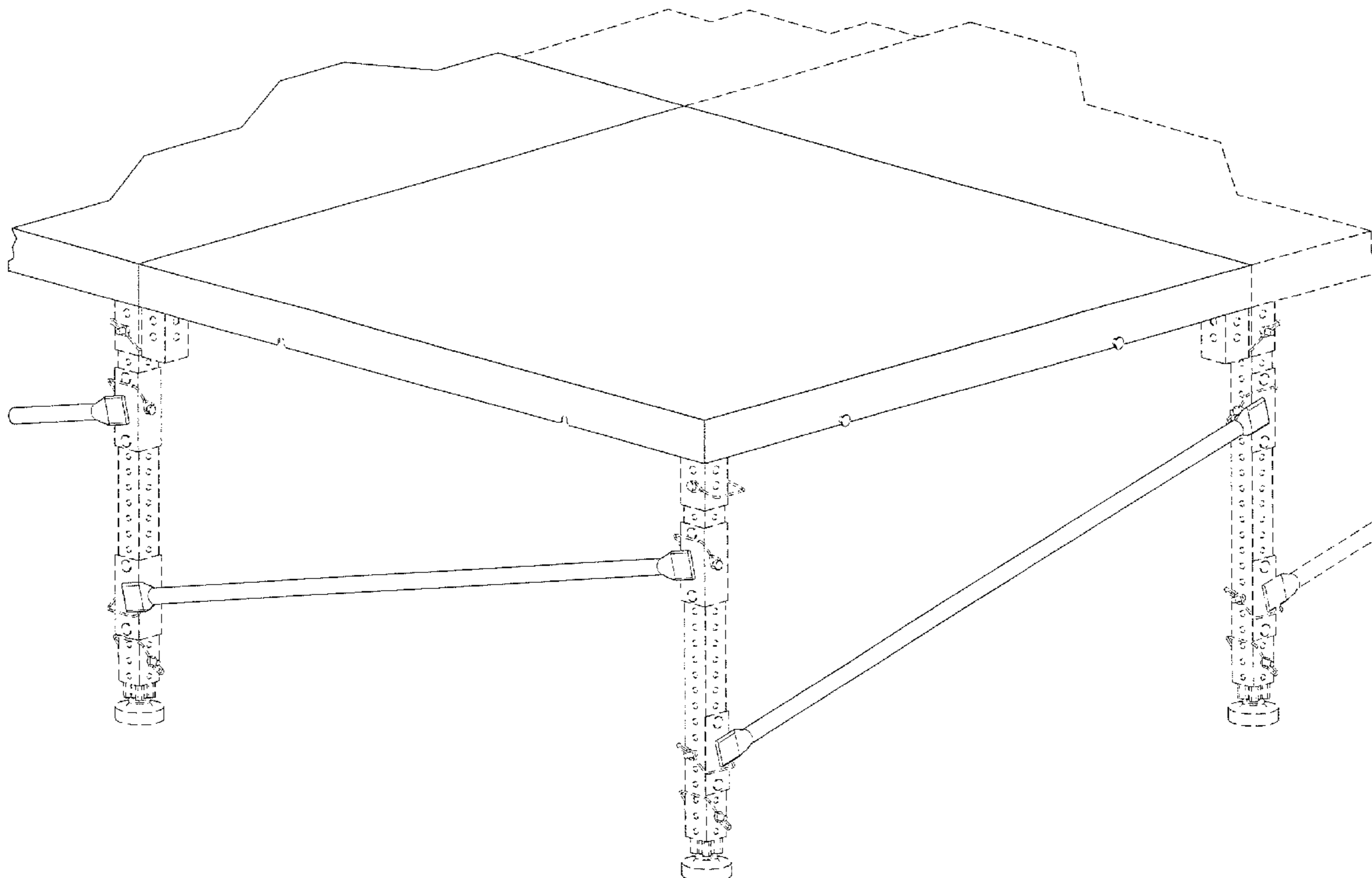
FIG. 1 is a top perspective view of a modular stage leg bracing embodying my design;

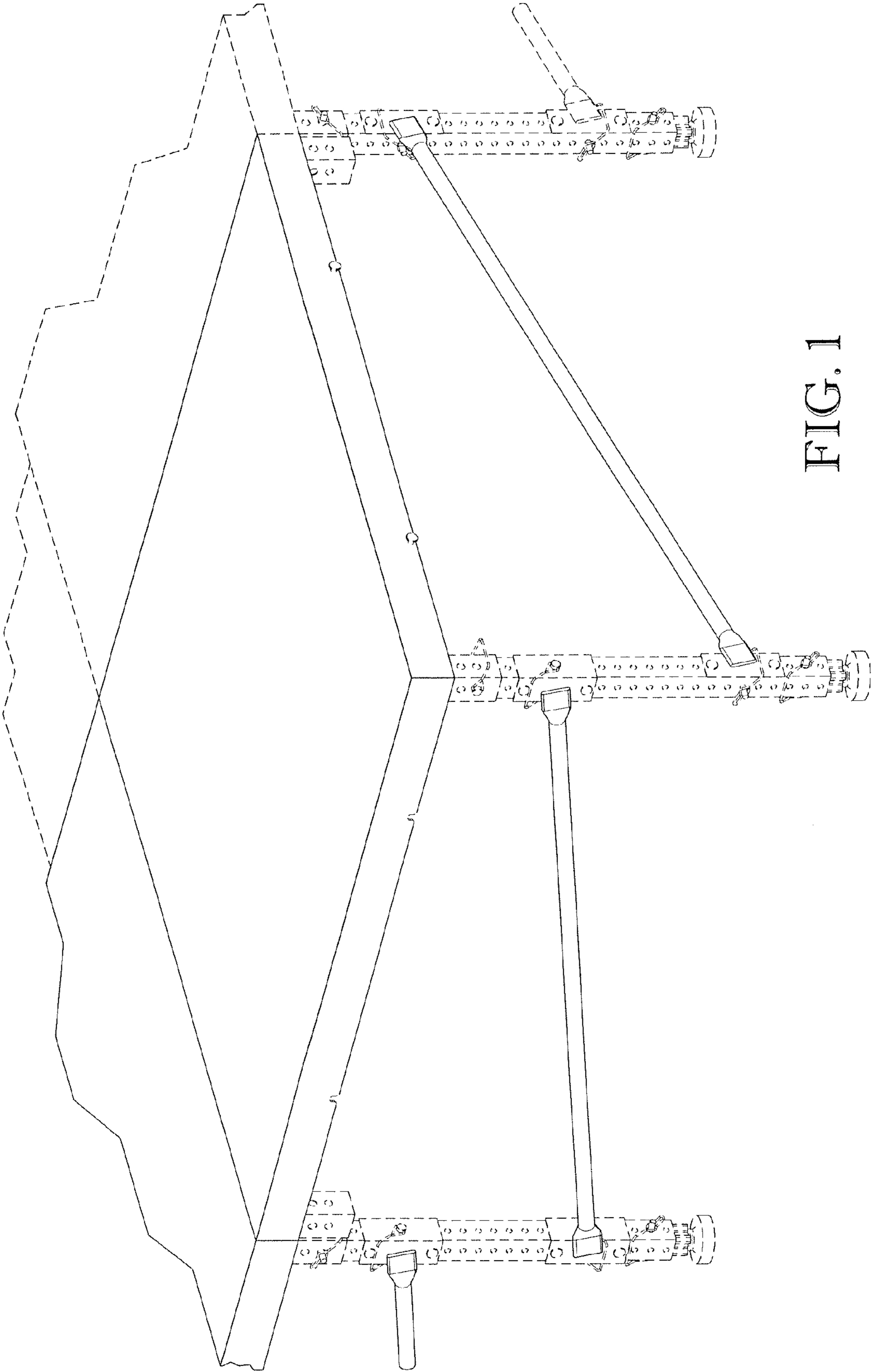

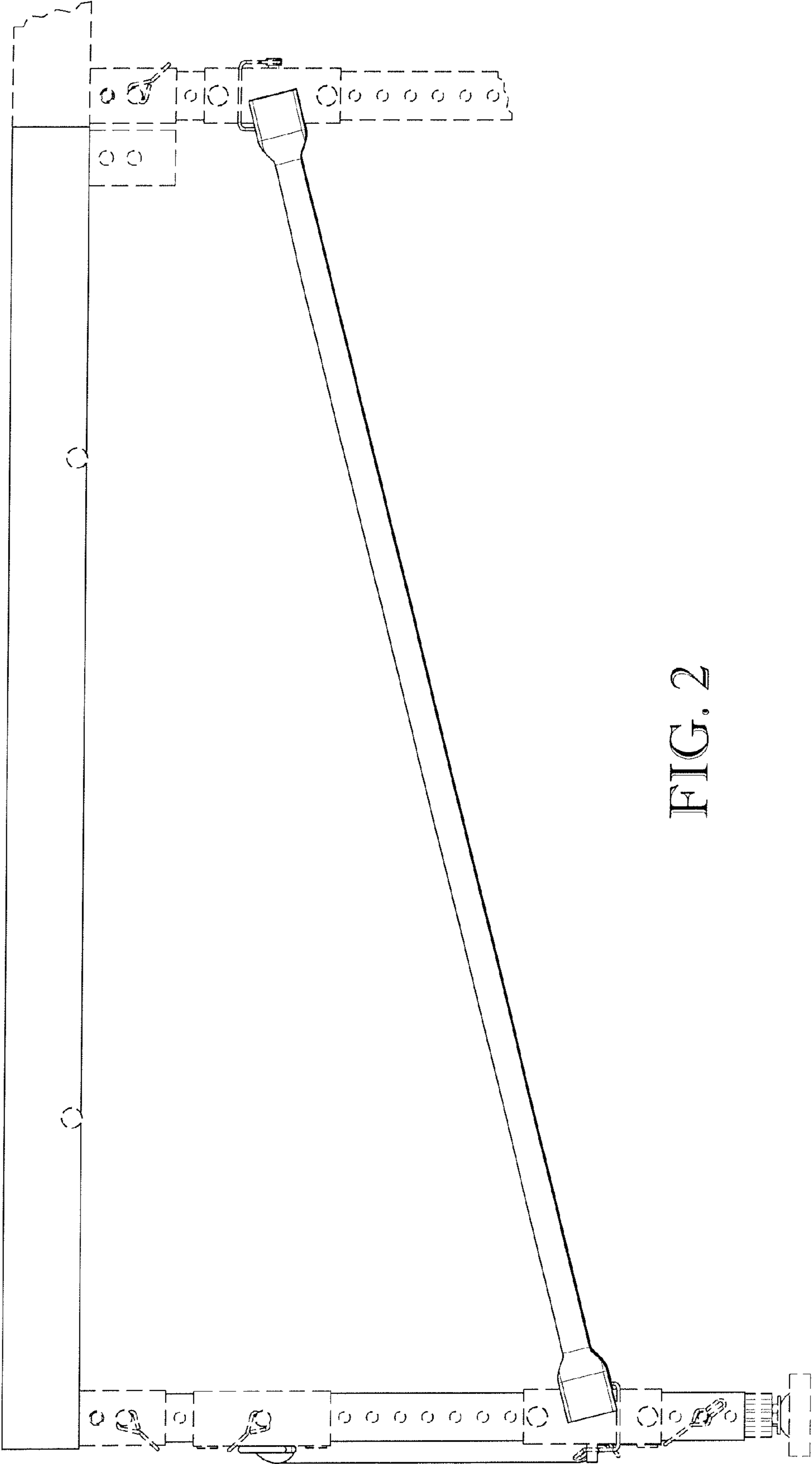

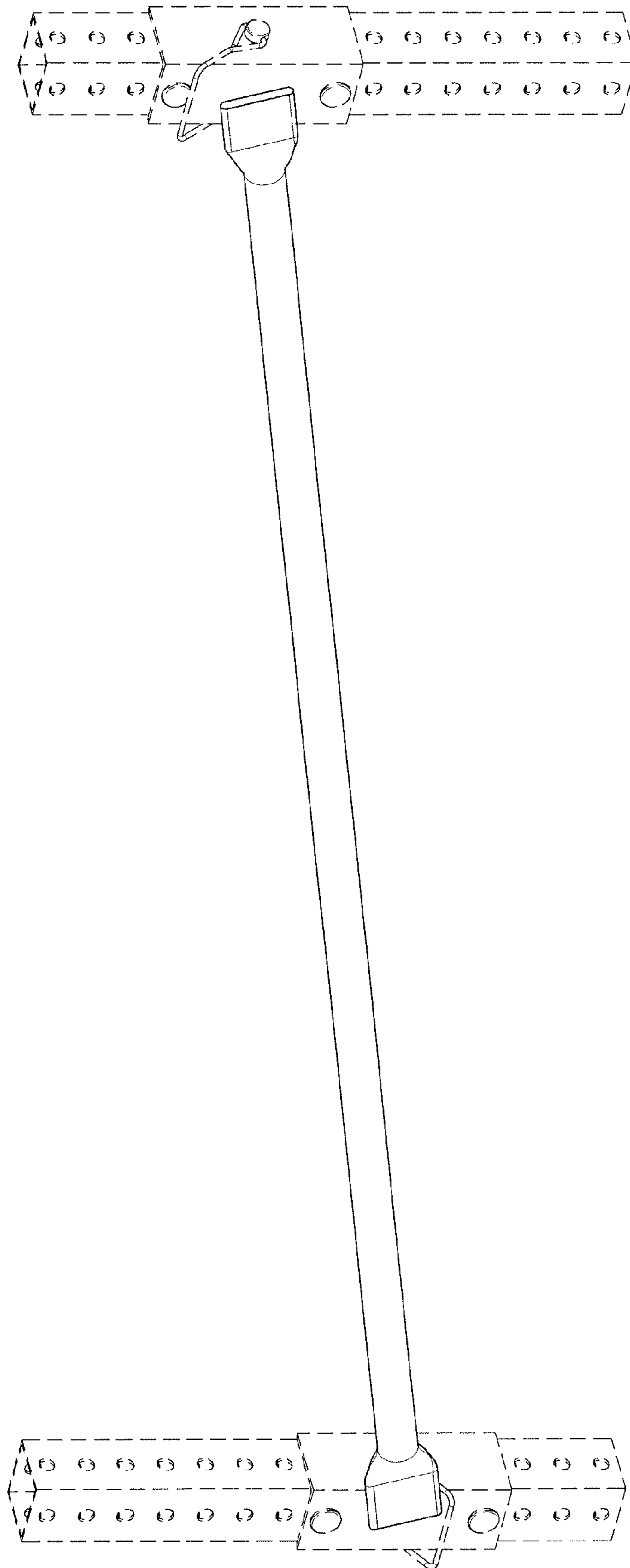
