**DESCRIPTION**

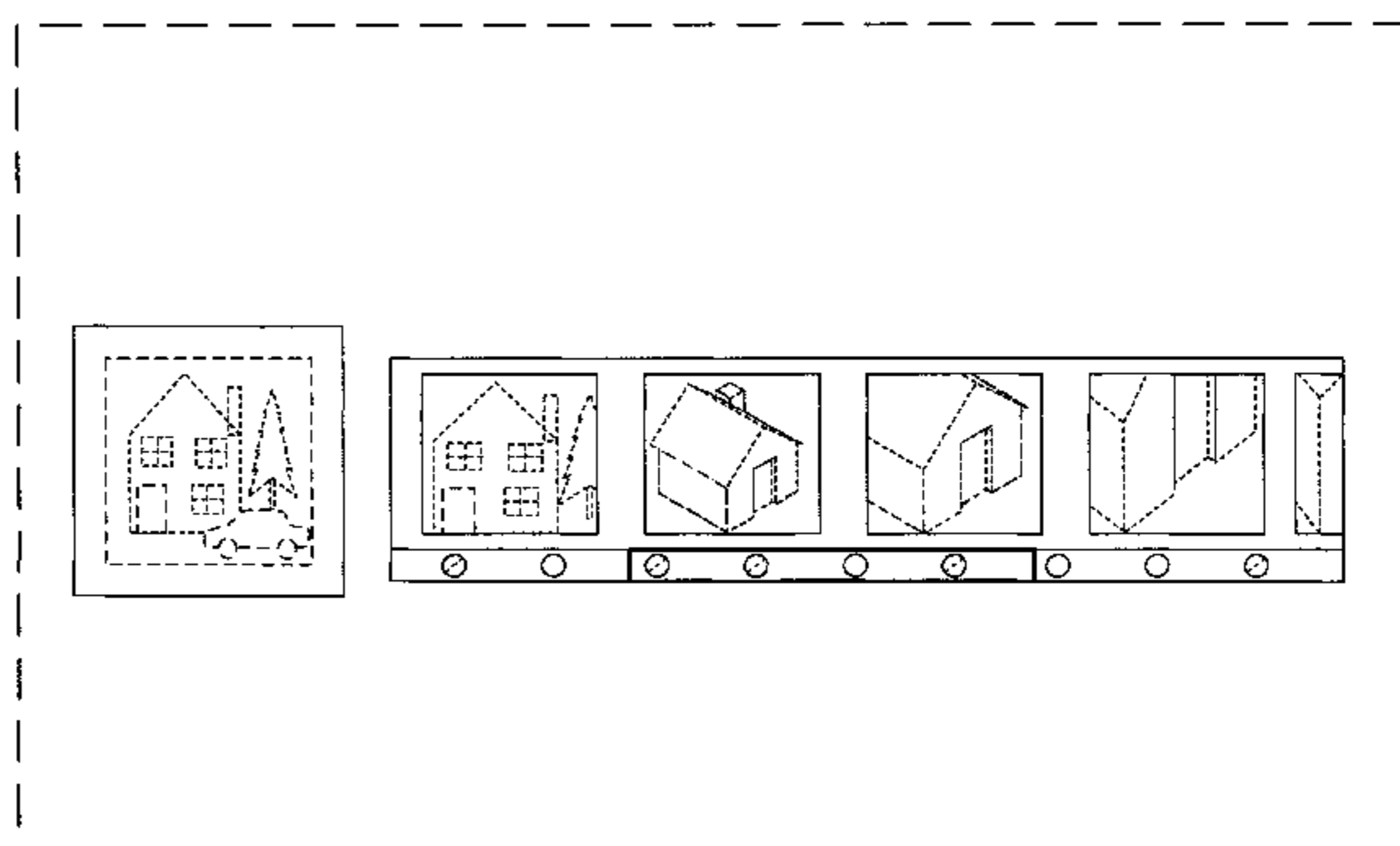
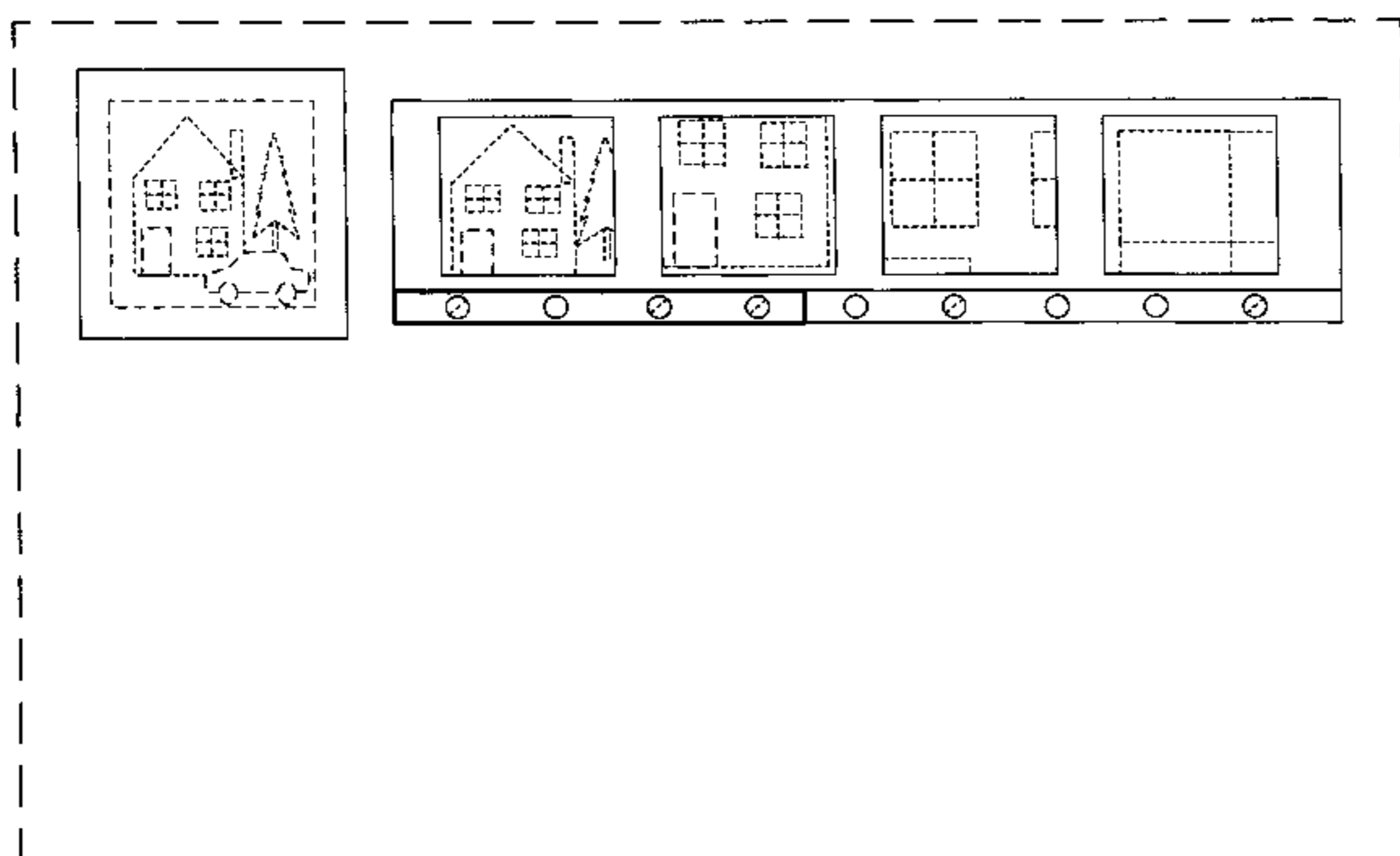
FIG. 1 is a view of a display screen with video search graphical interface showing an embodiment of our new design;

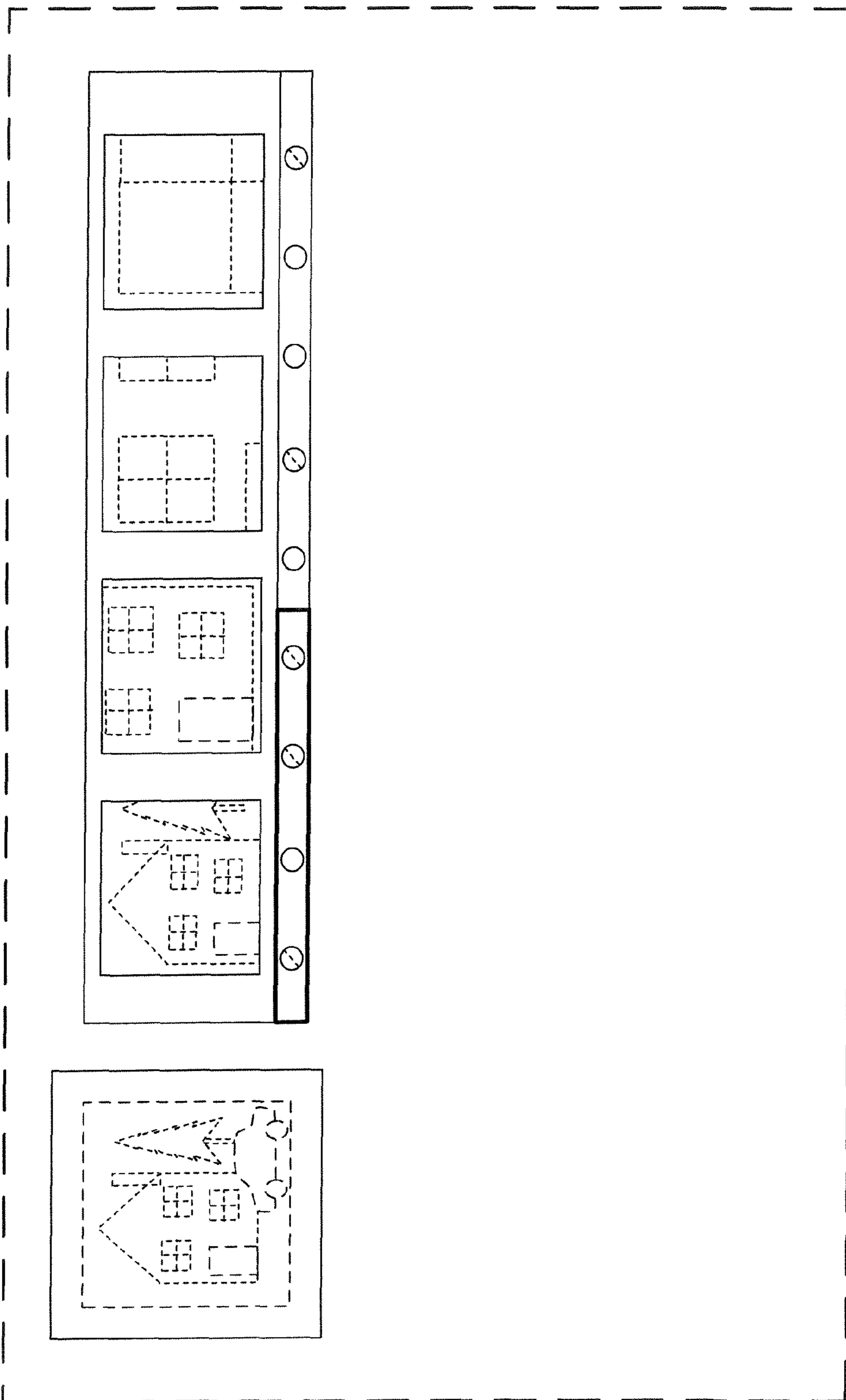

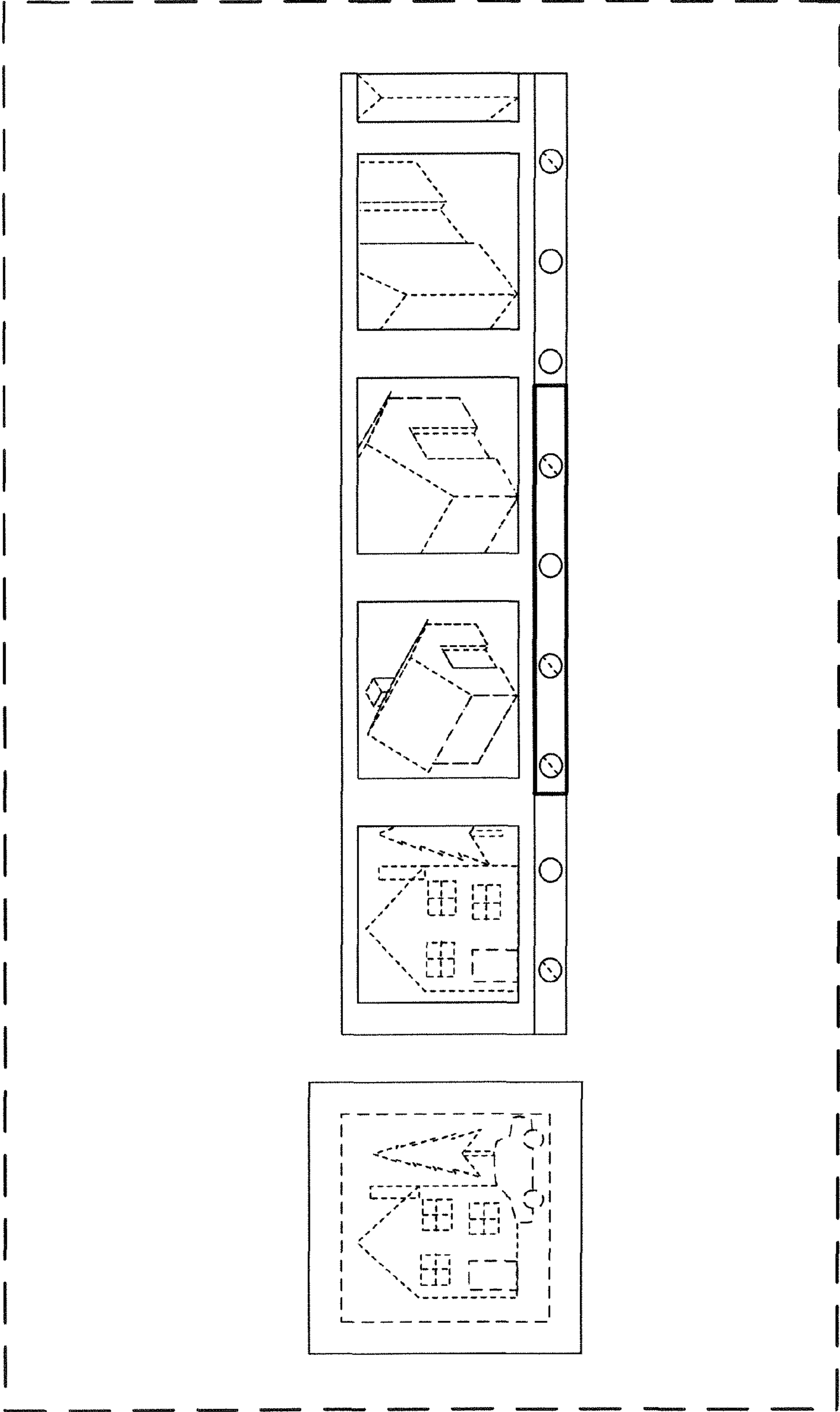

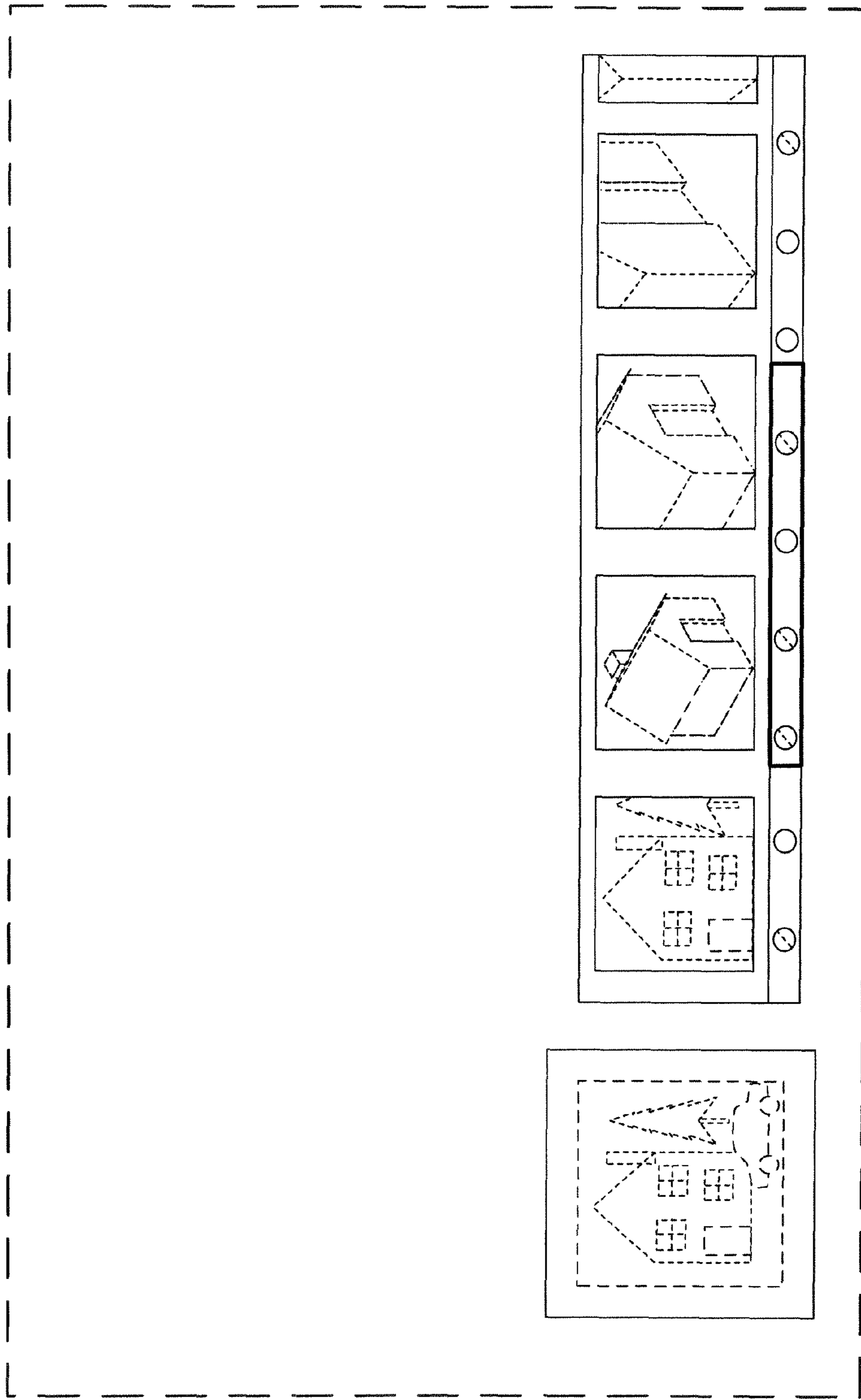
