(57) **CLAIM**

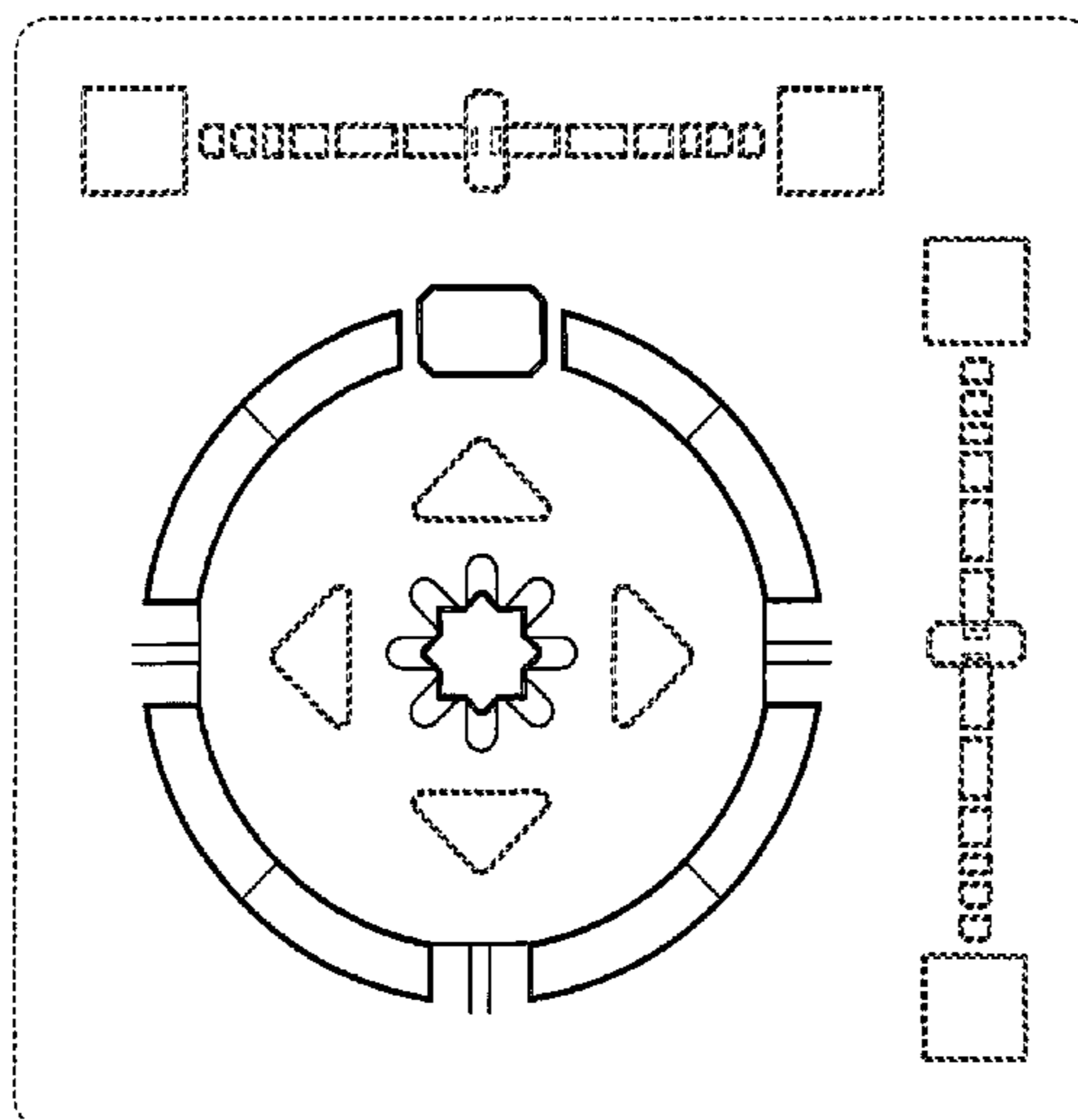
The ornamental design for a user interface for display device, as shown and described.
