FIG. 6 is a left side elevation view thereof;

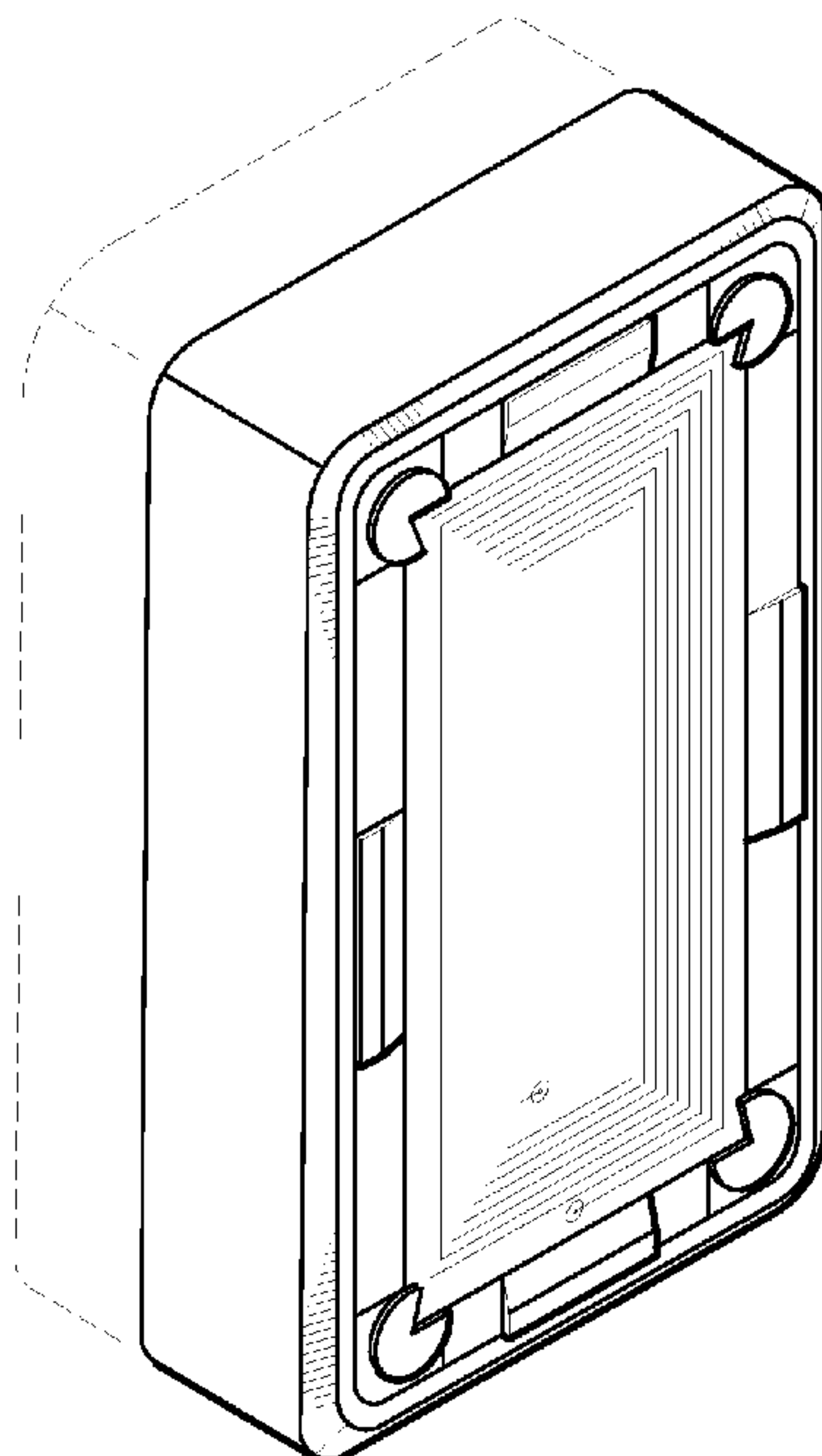
FIG. 7 is a top, front and right side perspective view thereof;

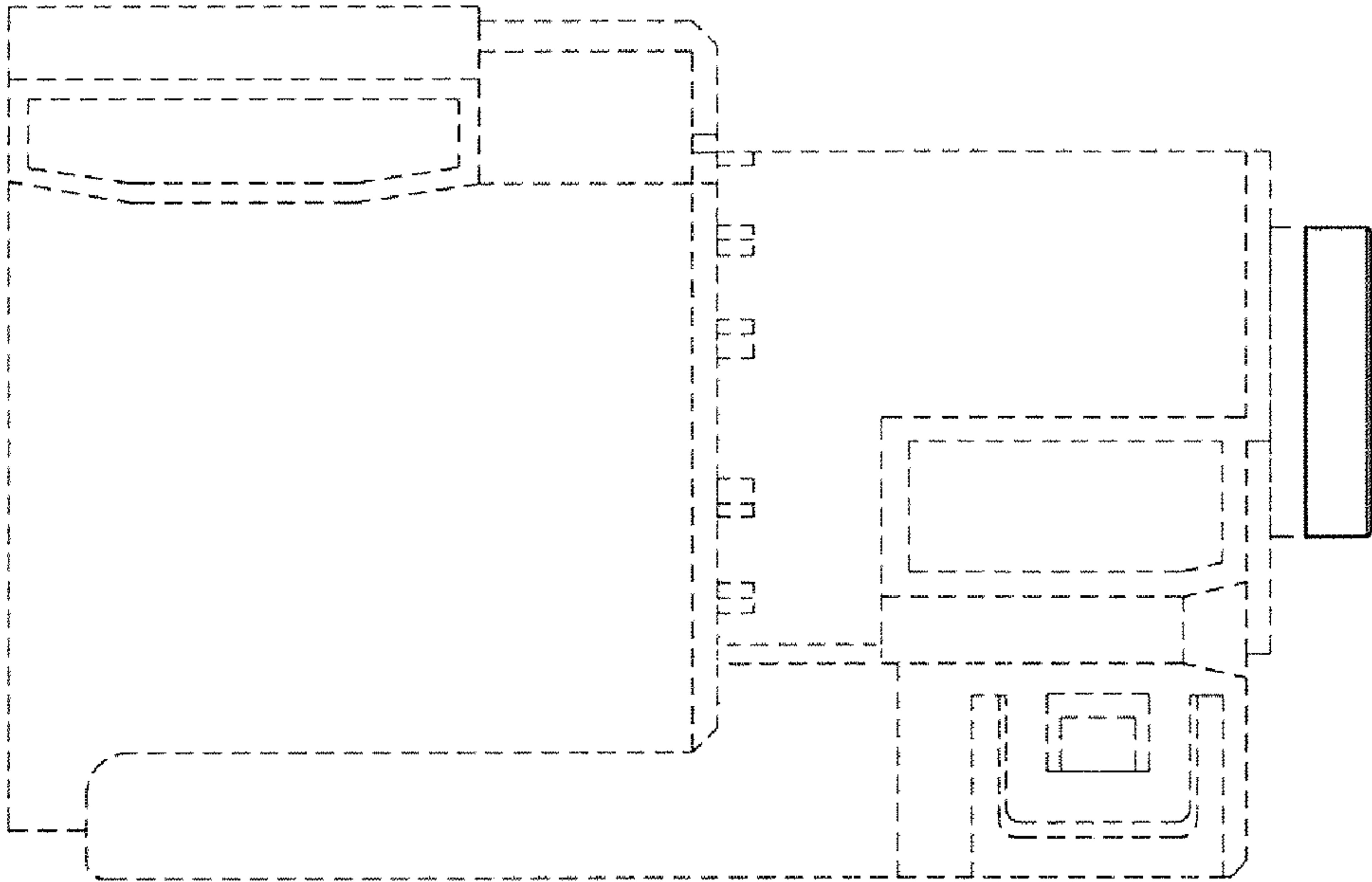

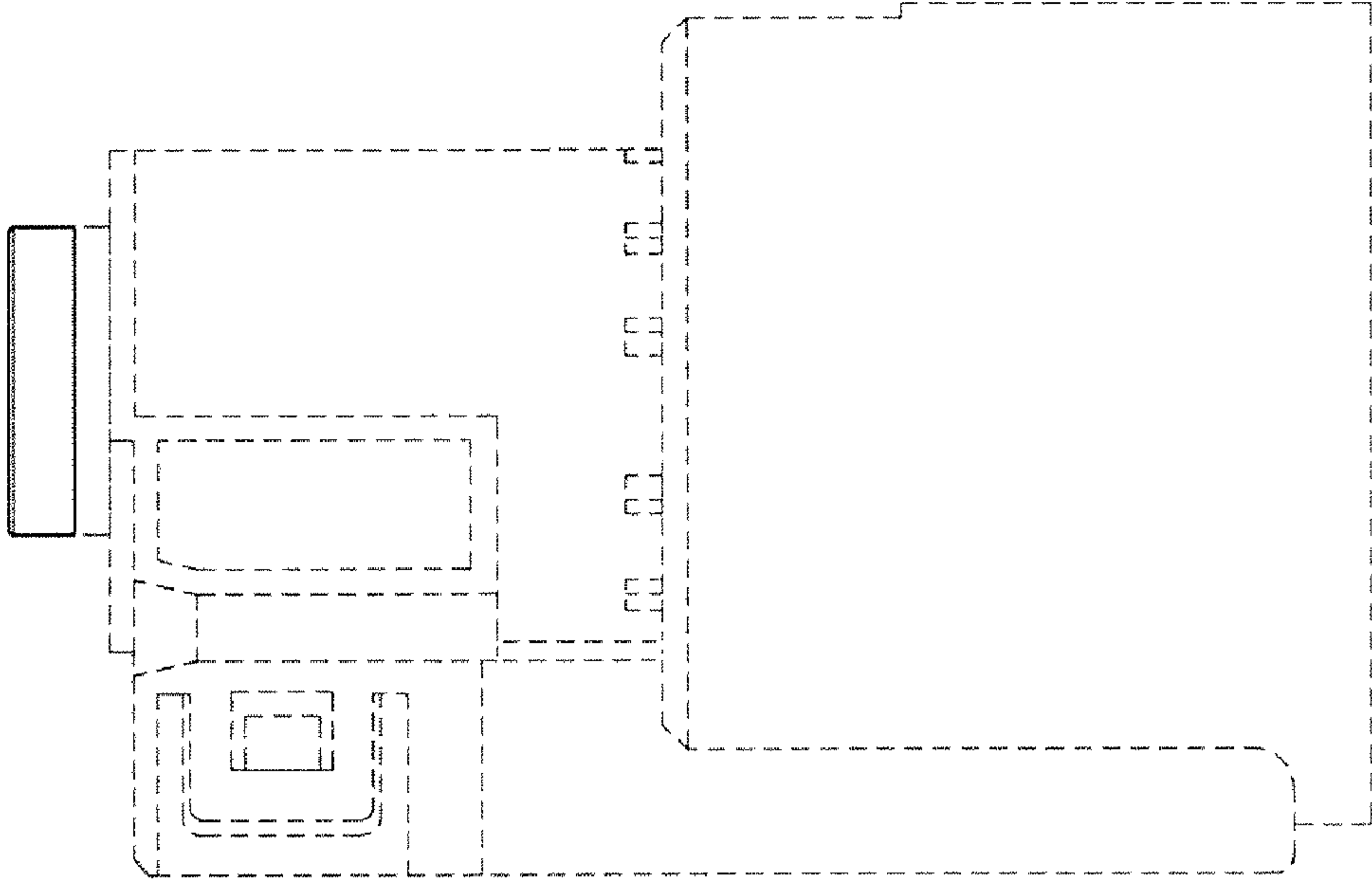

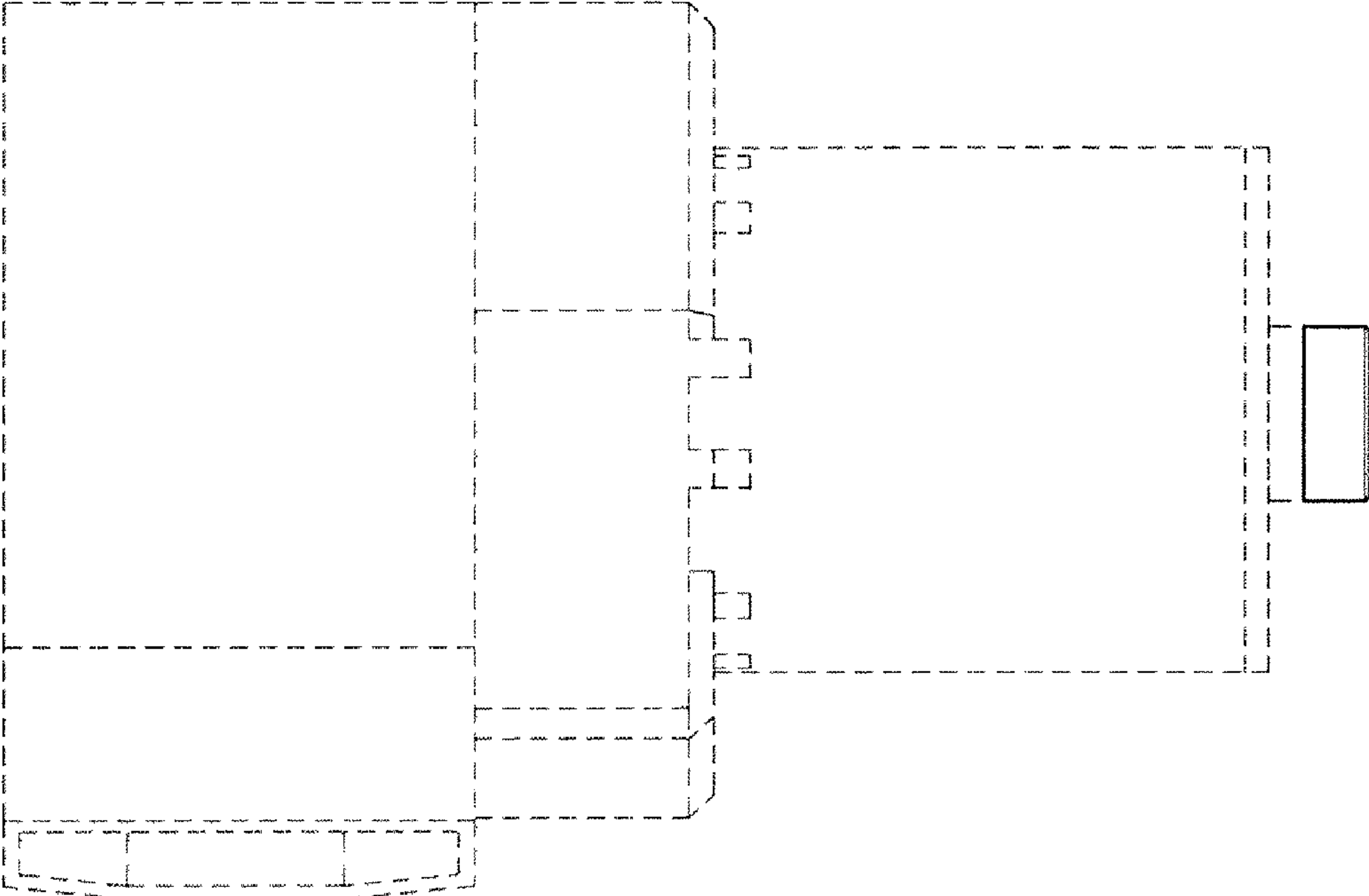

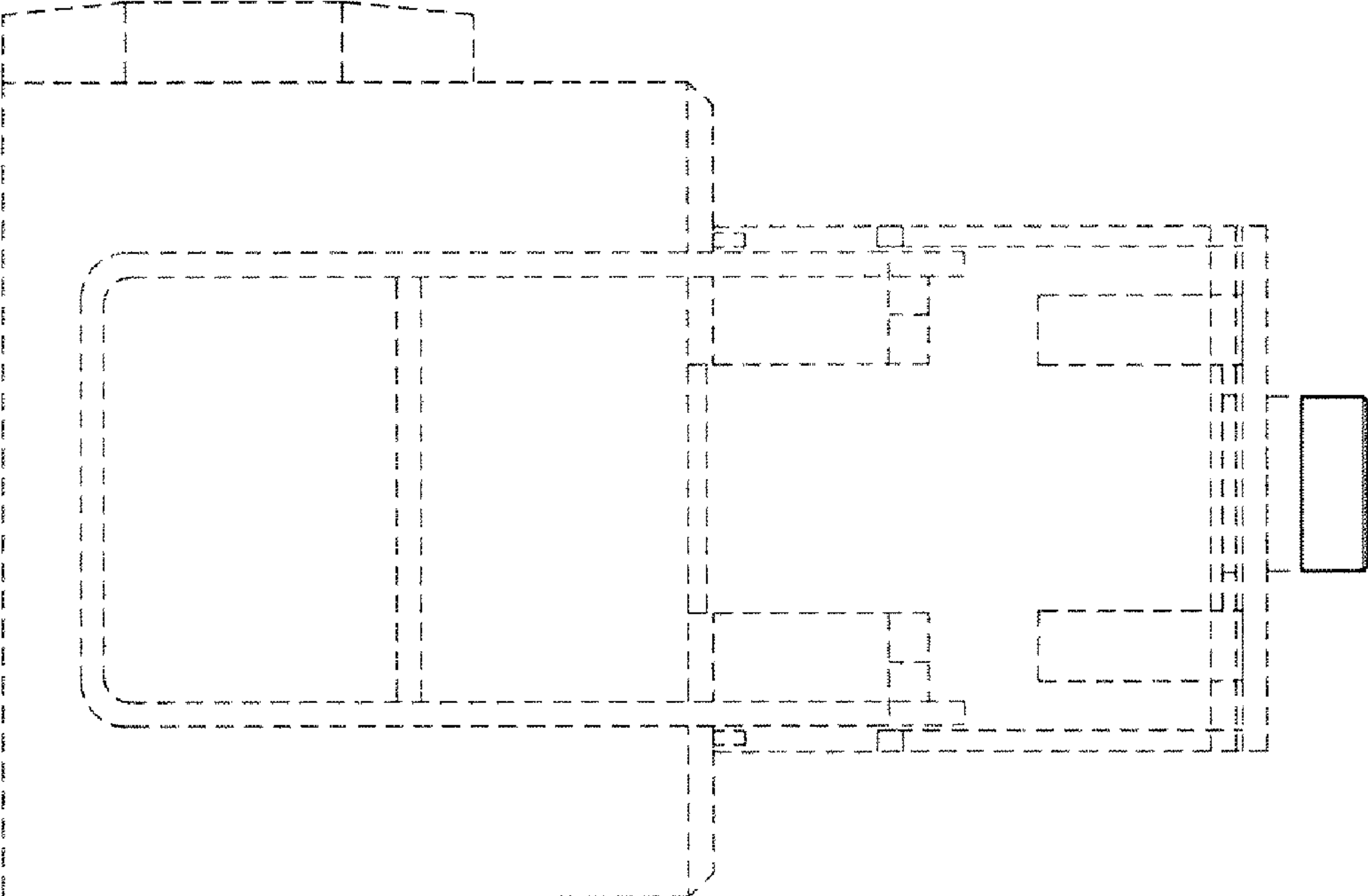
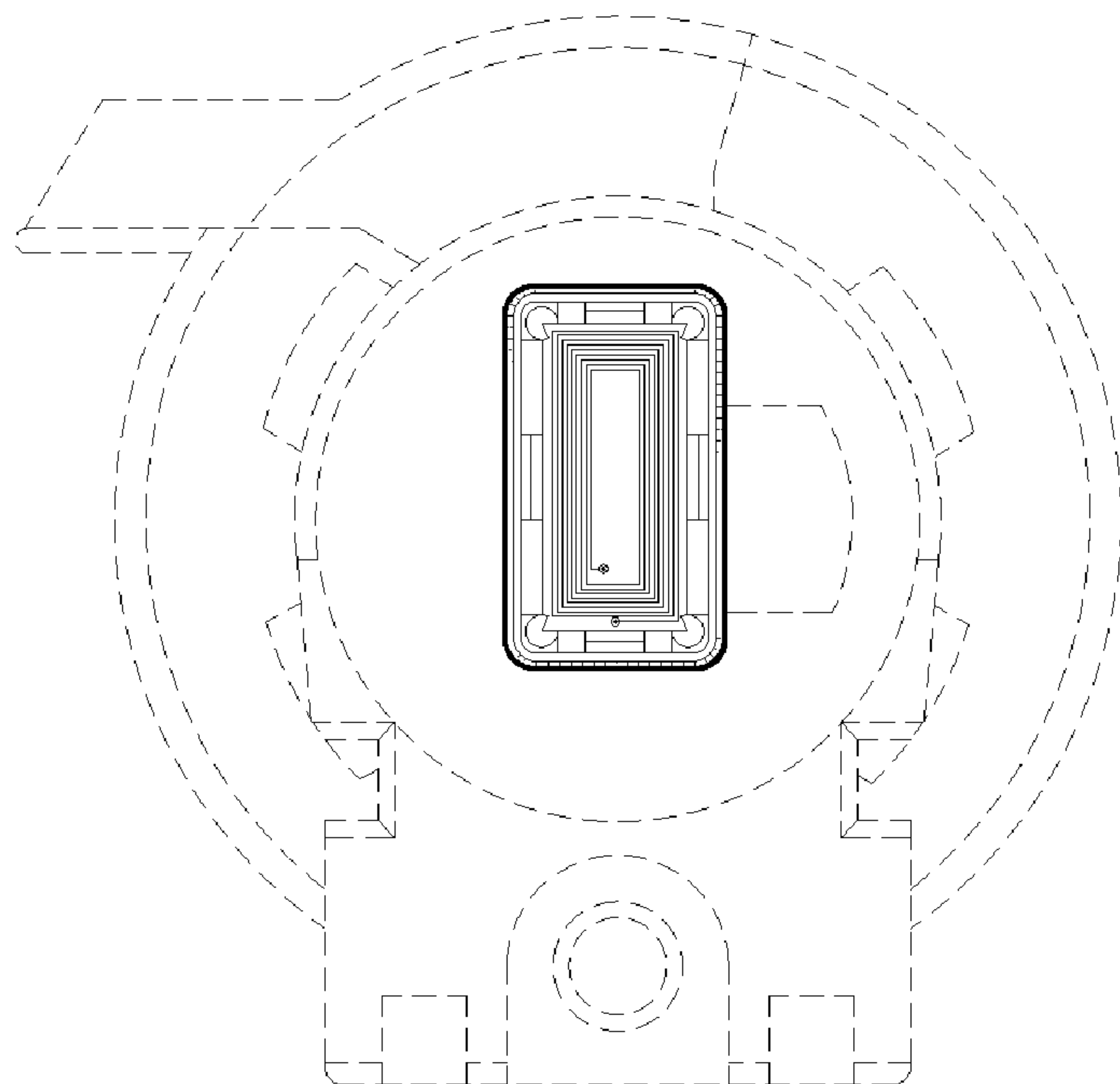
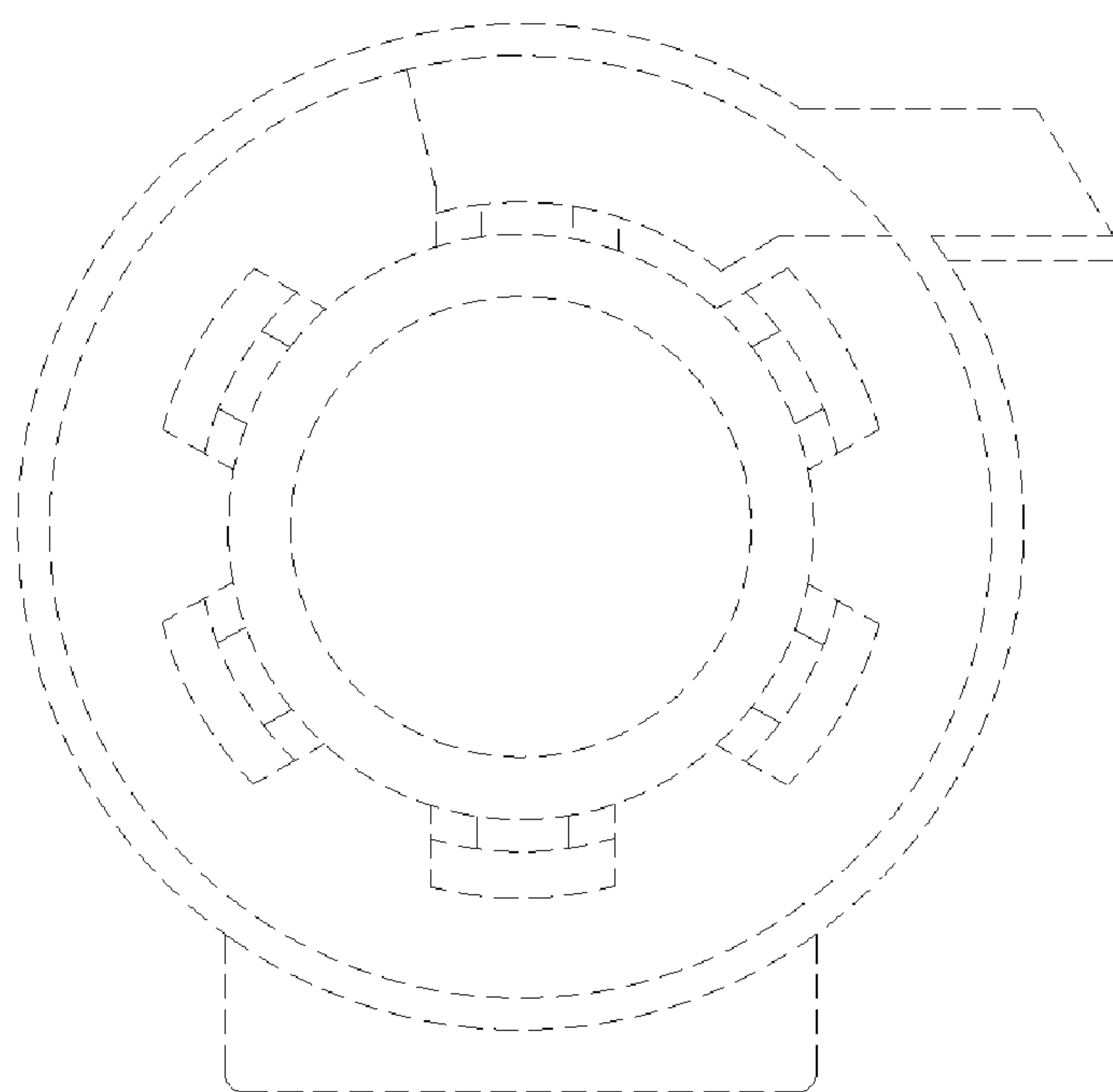

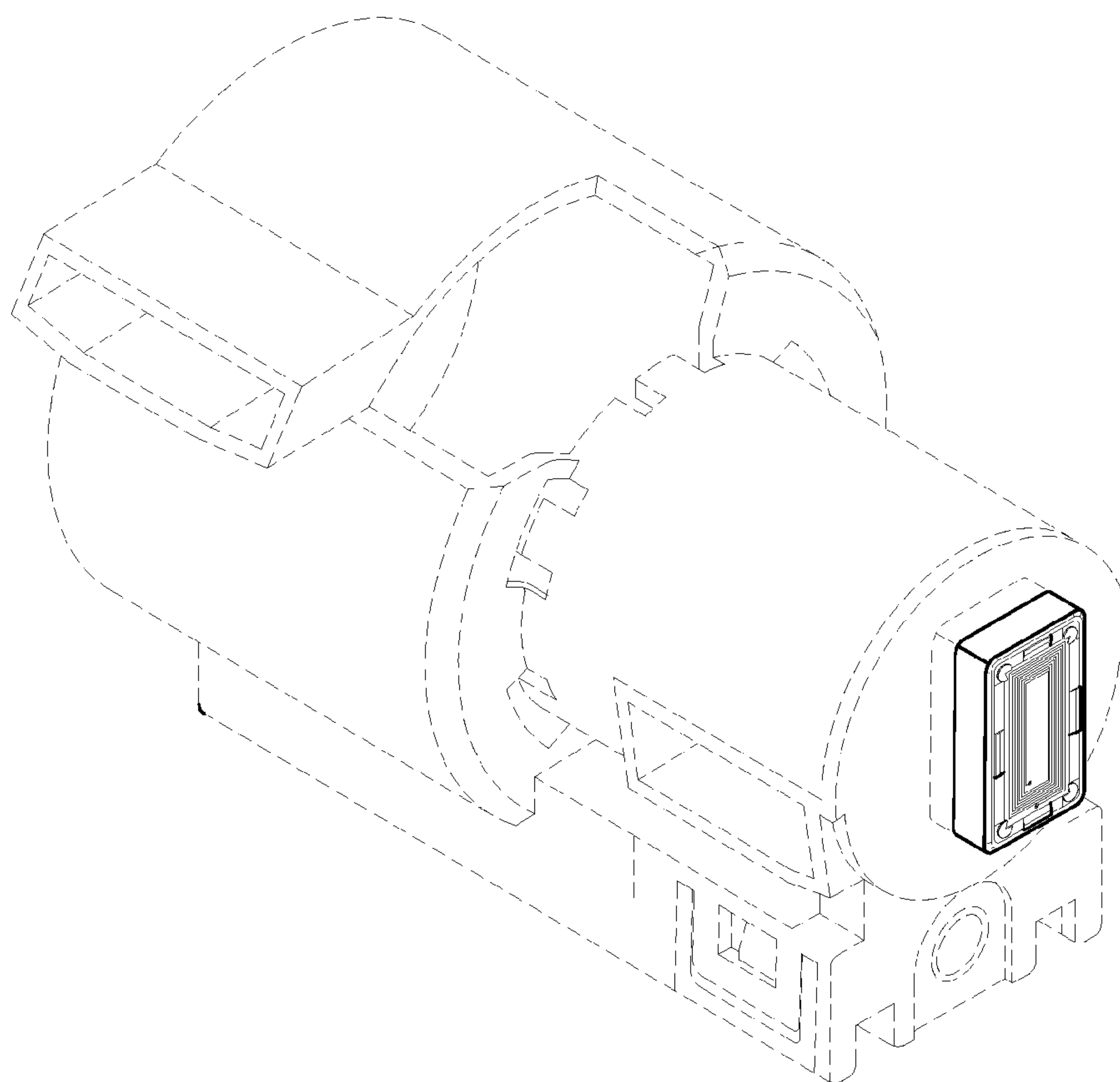

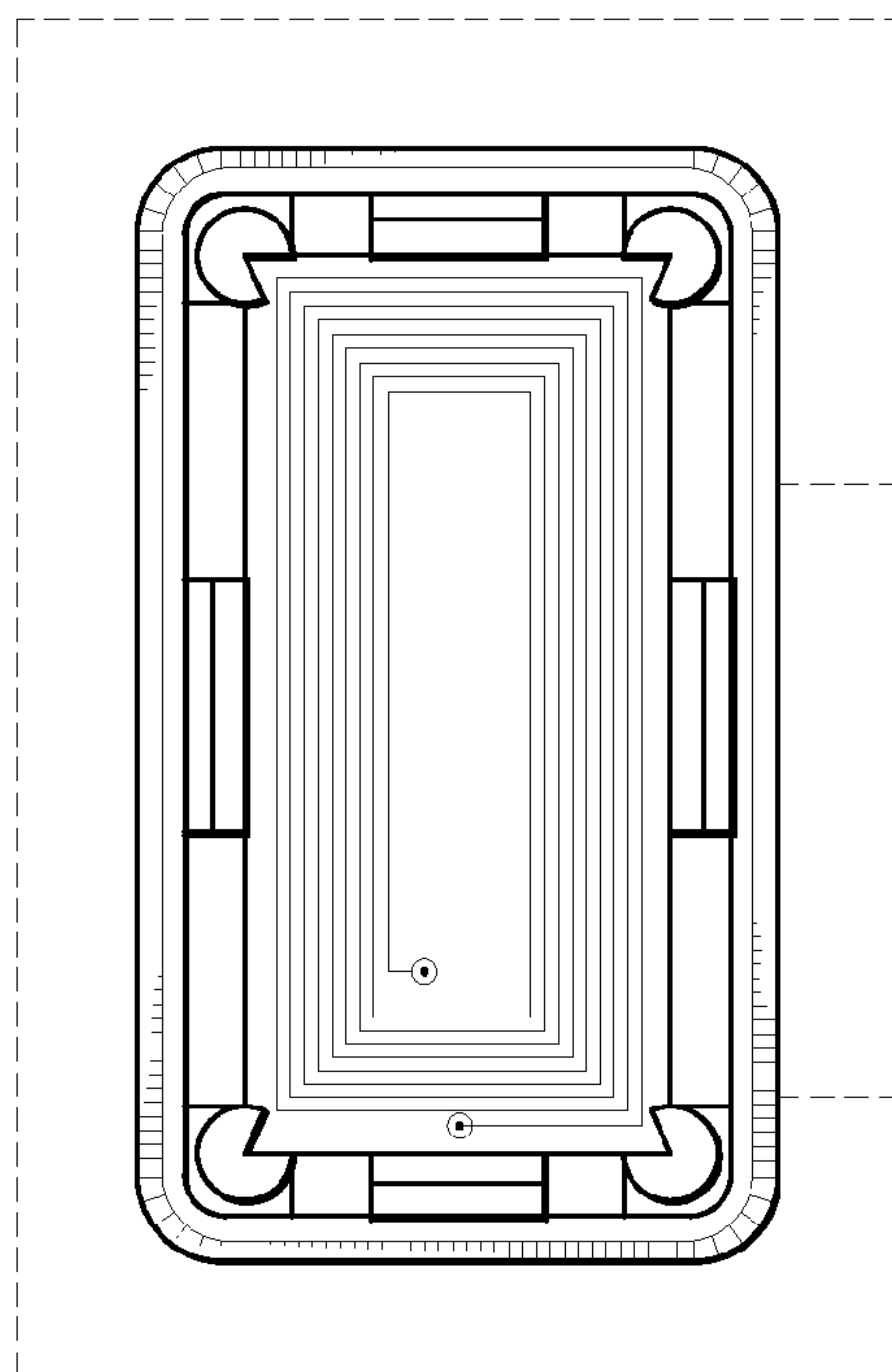

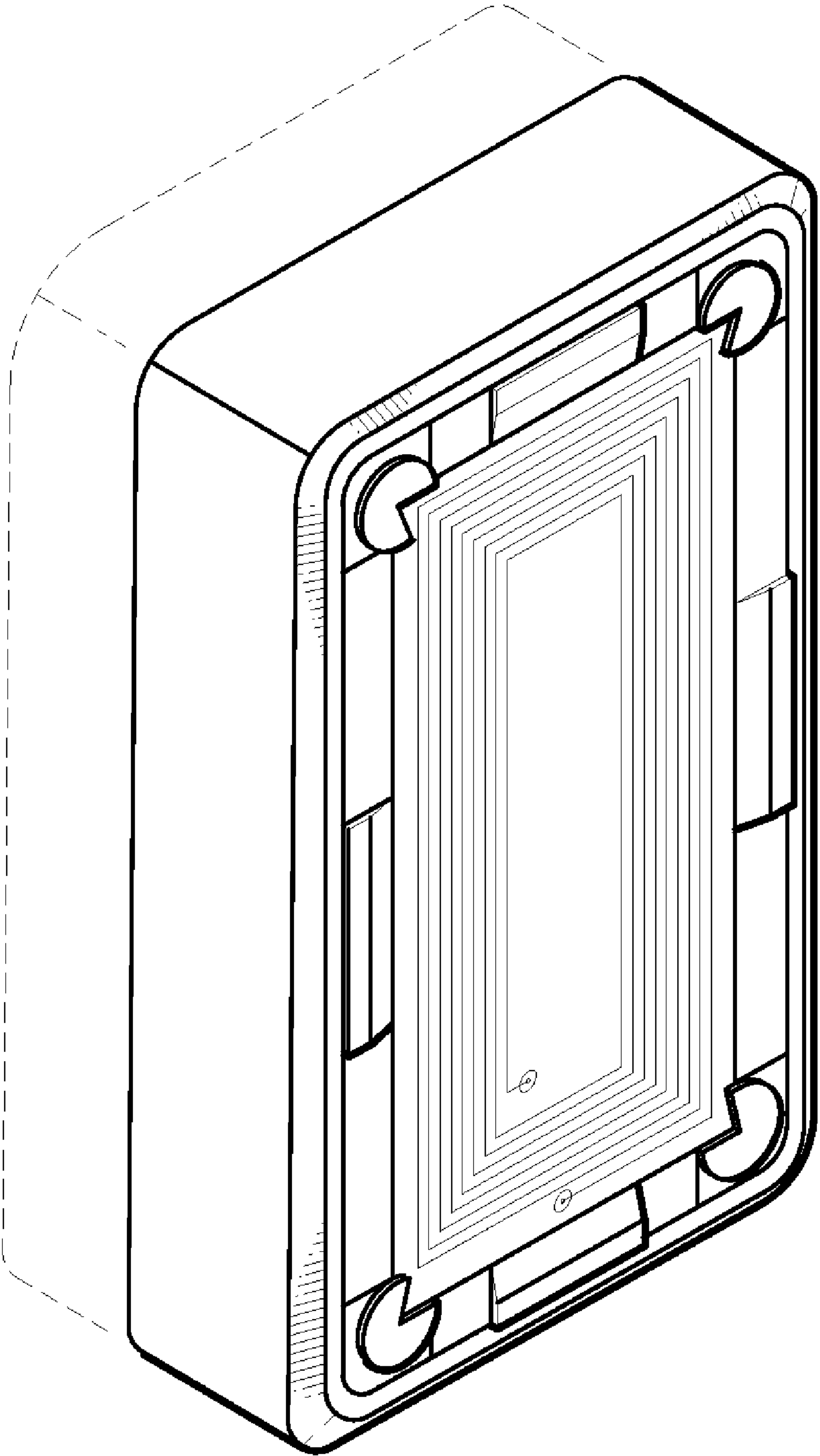
