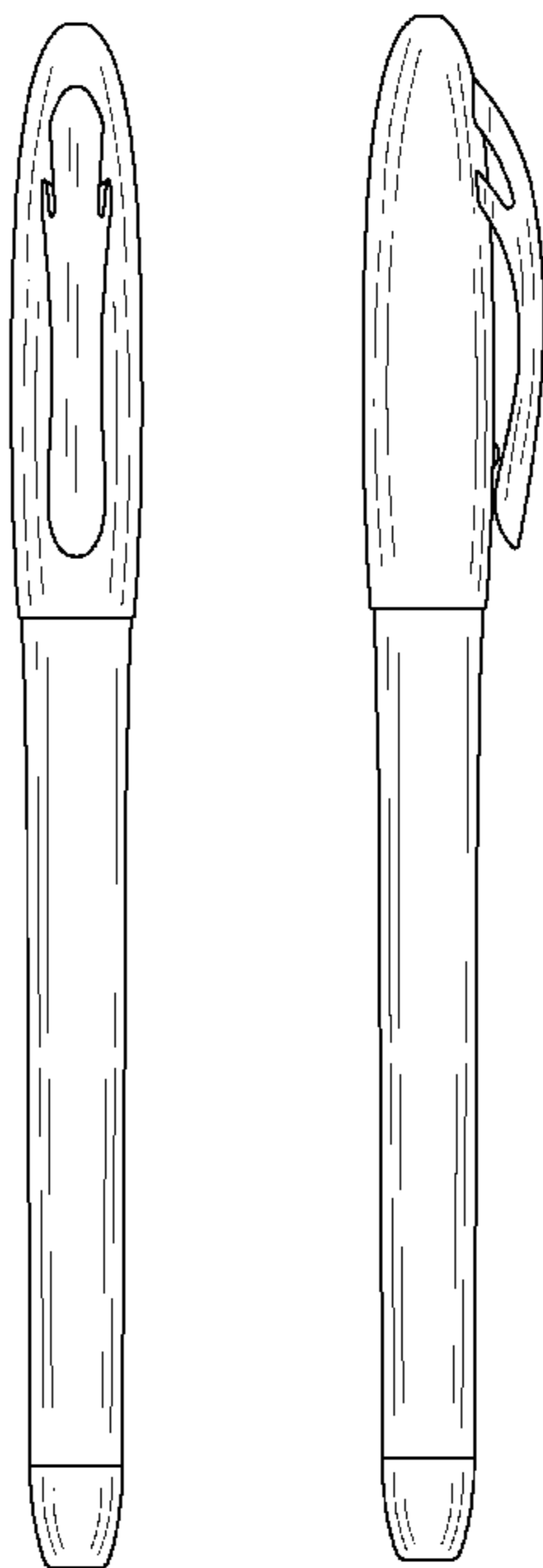
(57) **CLAIM**

DESCRIPTION

FIG. 1 is an upper right perspective view of a pen showing my new design;
FIG. 2 is a right side elevation view thereof;

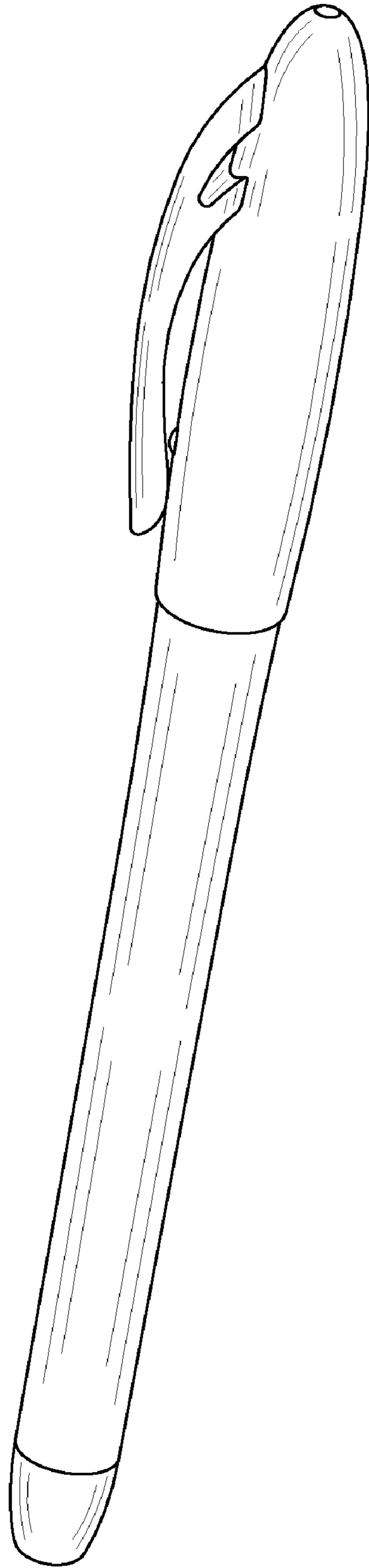

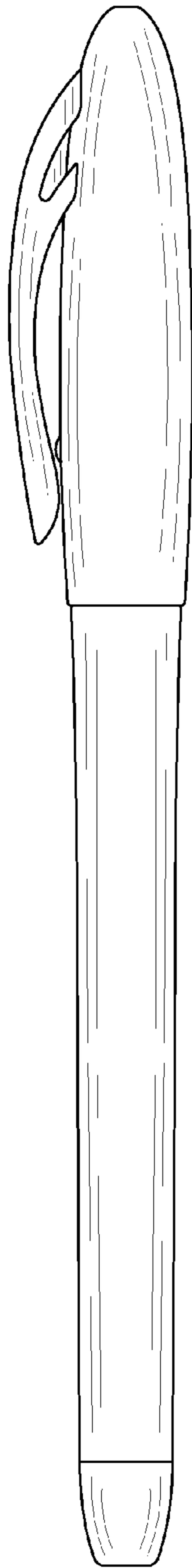

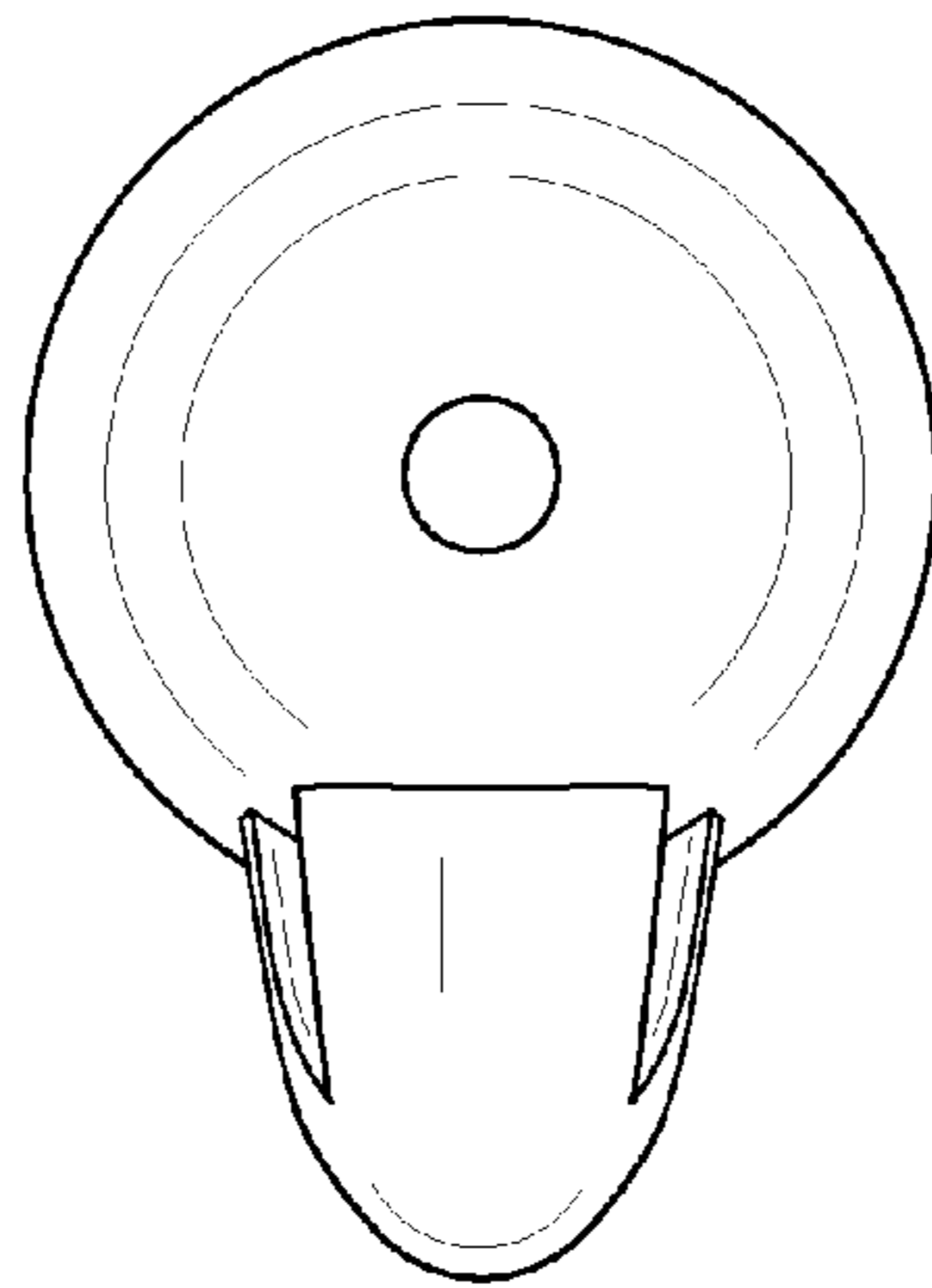

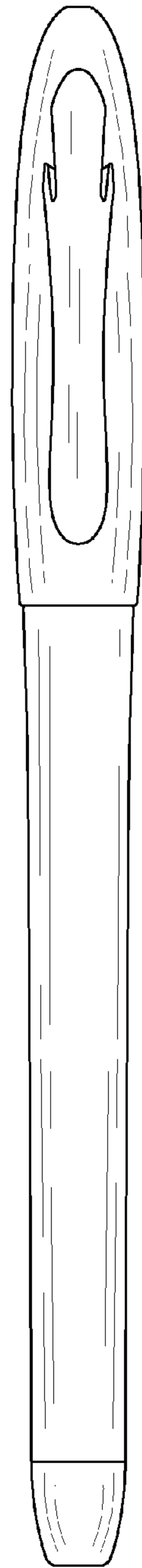

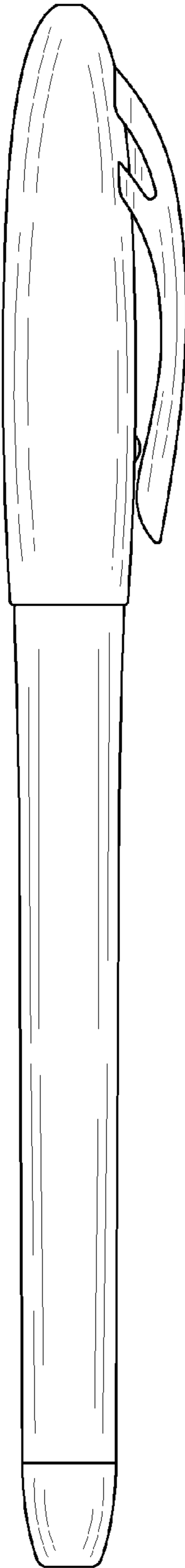

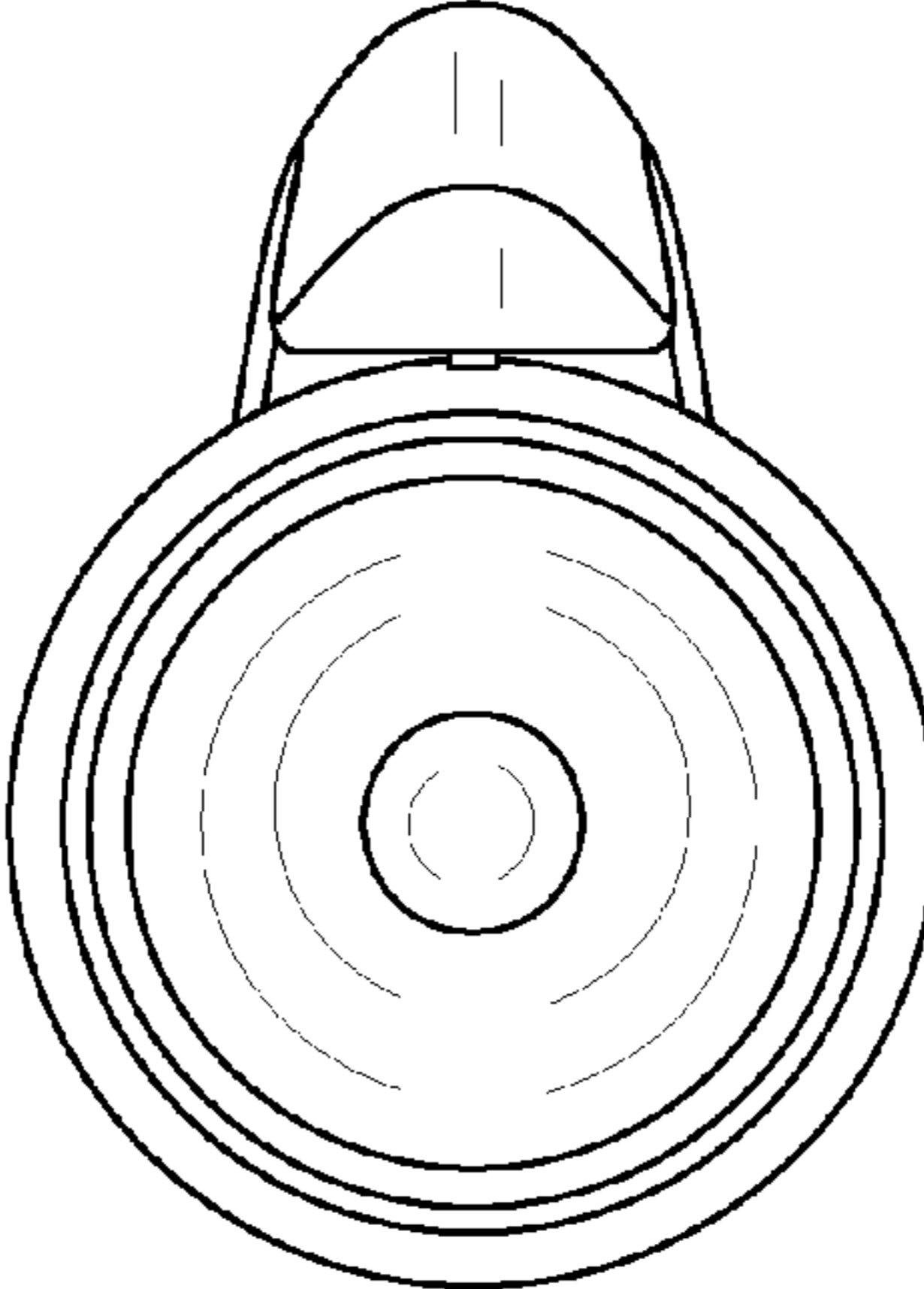

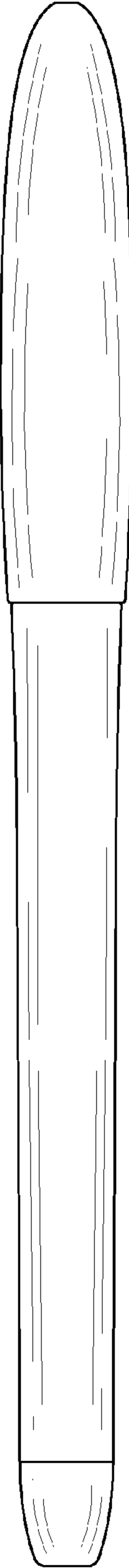
