FIG. 10 is a right side view of the embodiment of the fluid dispenser shown in FIGS. 7-9.

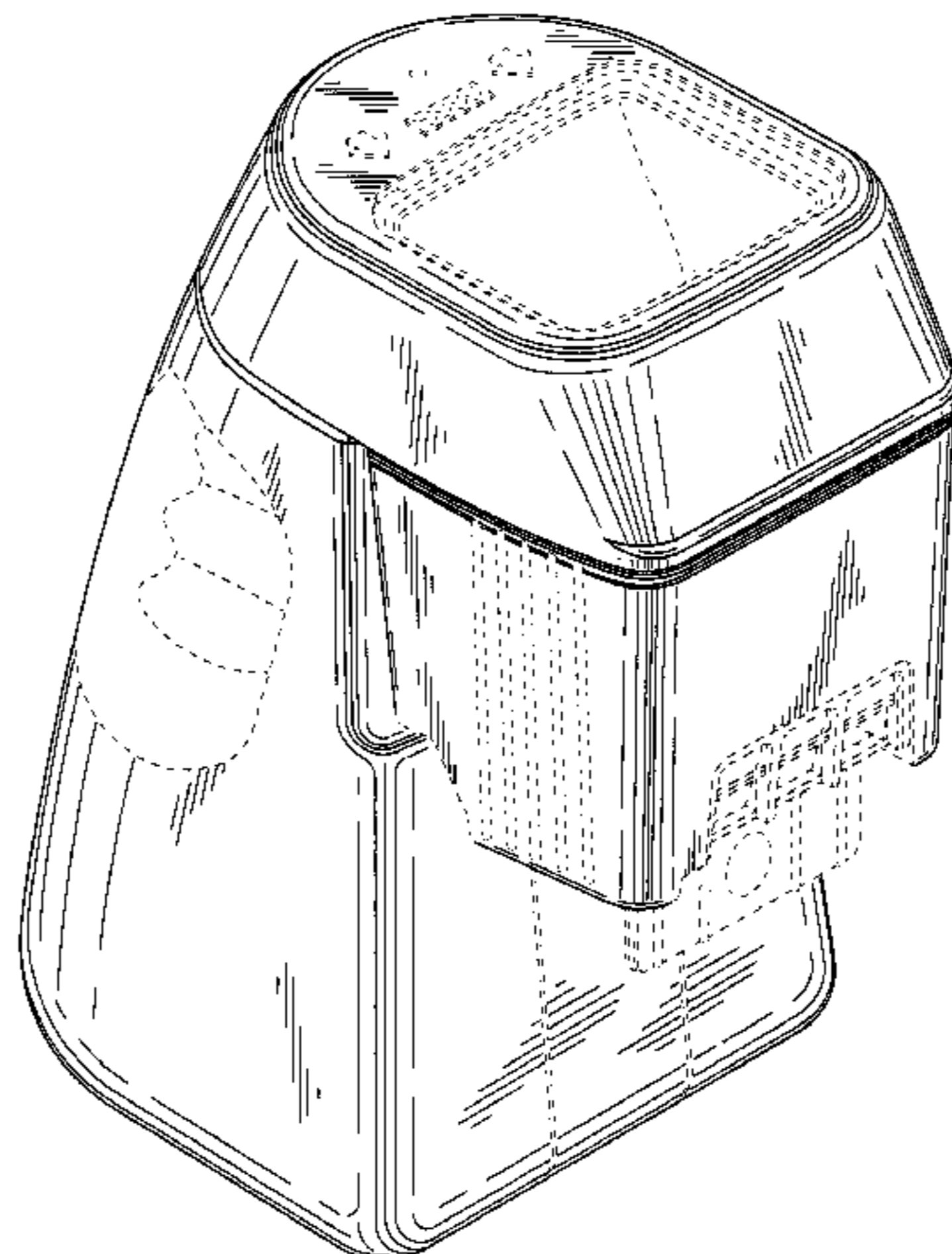
FIG. 11 is a rear view of the embodiment of the fluid dispenser shown in FIGS. 7-10; and,

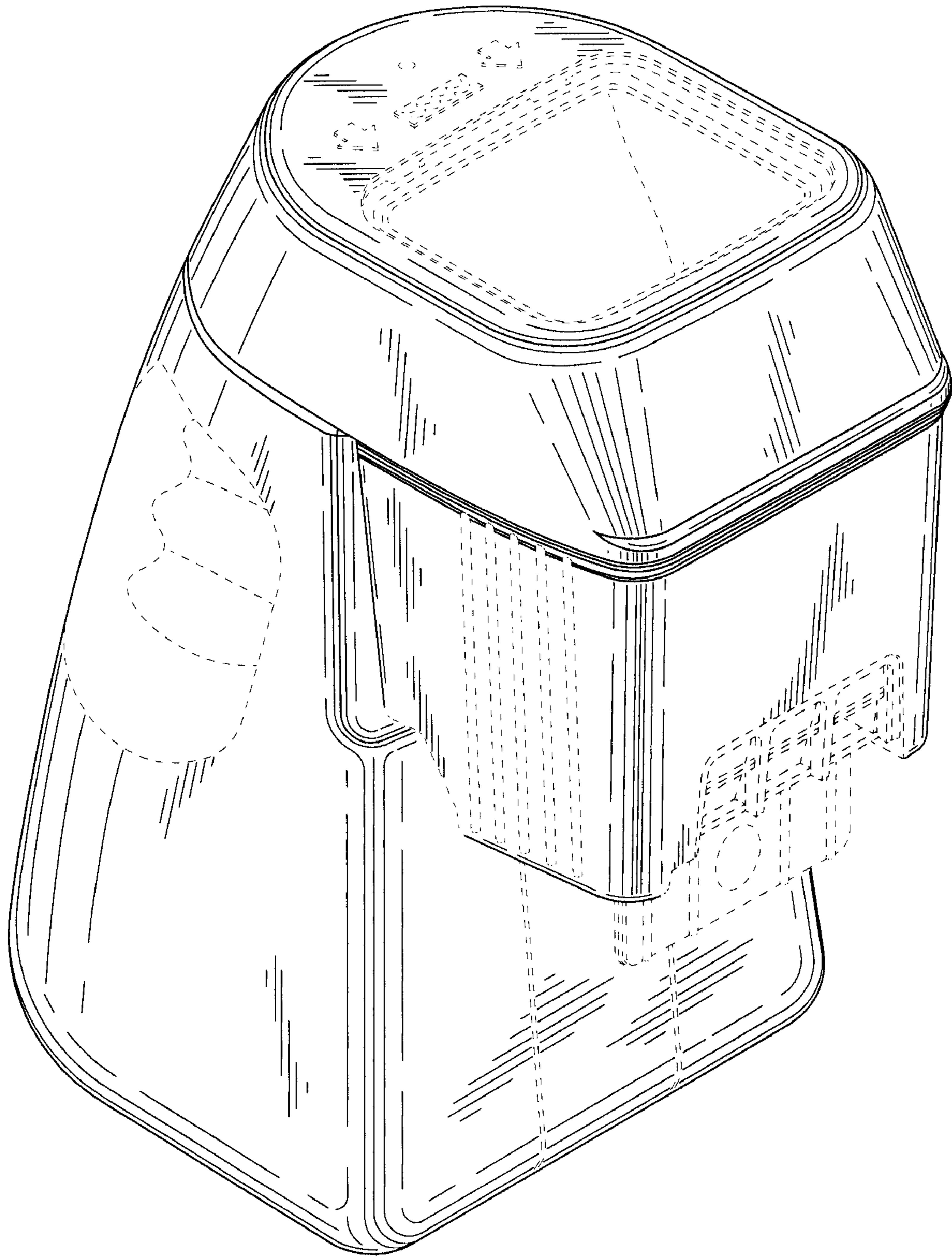

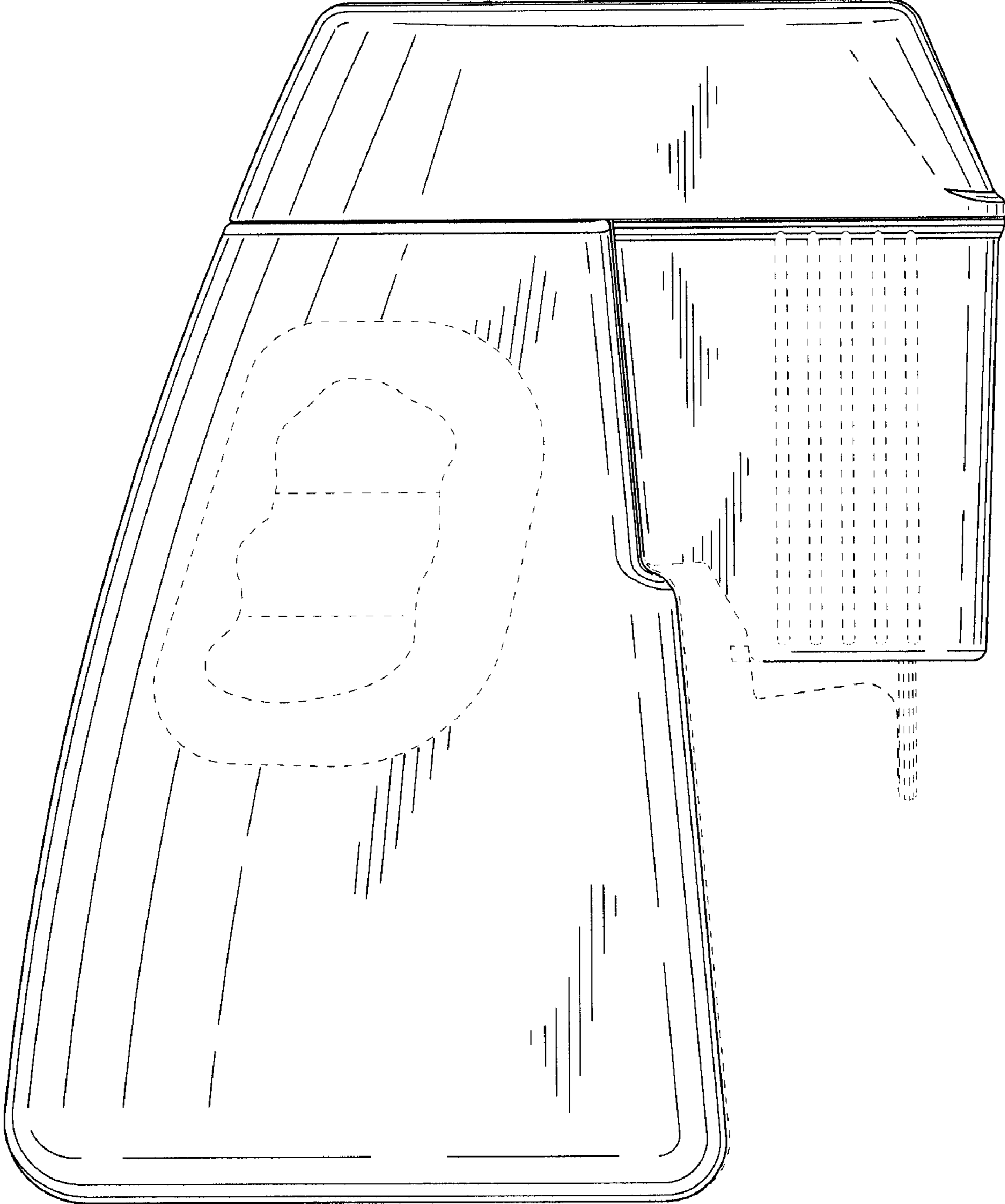

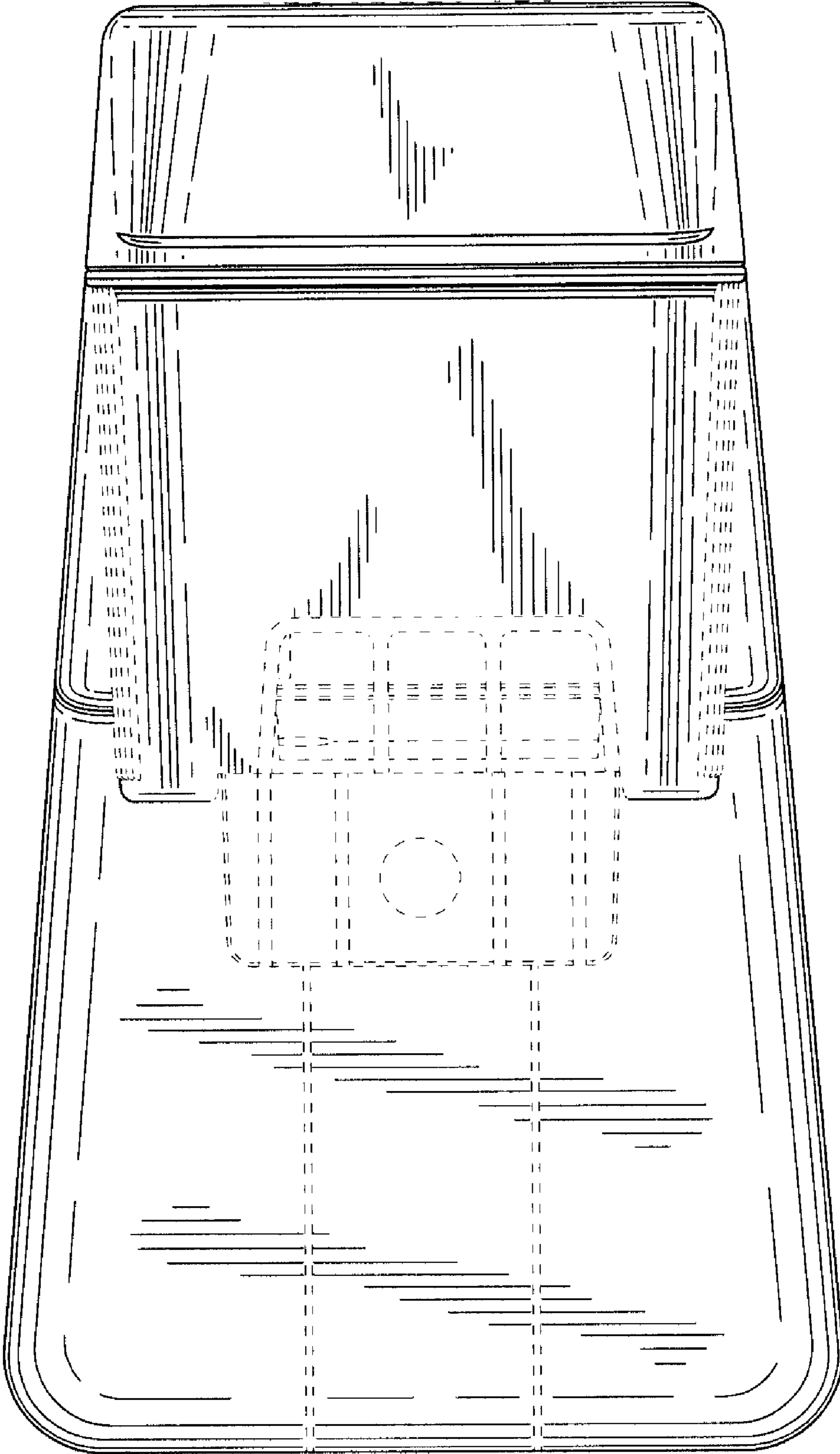

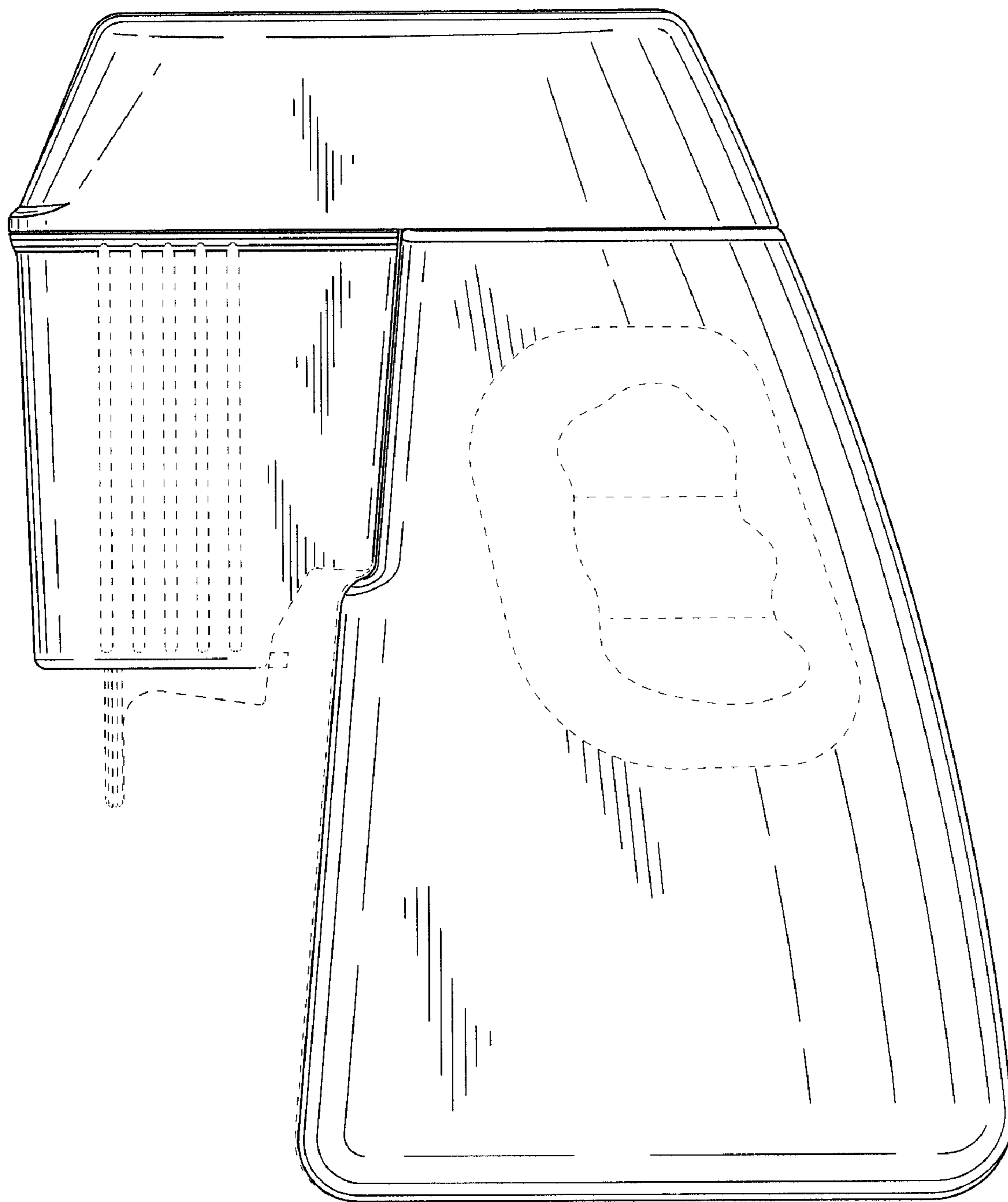

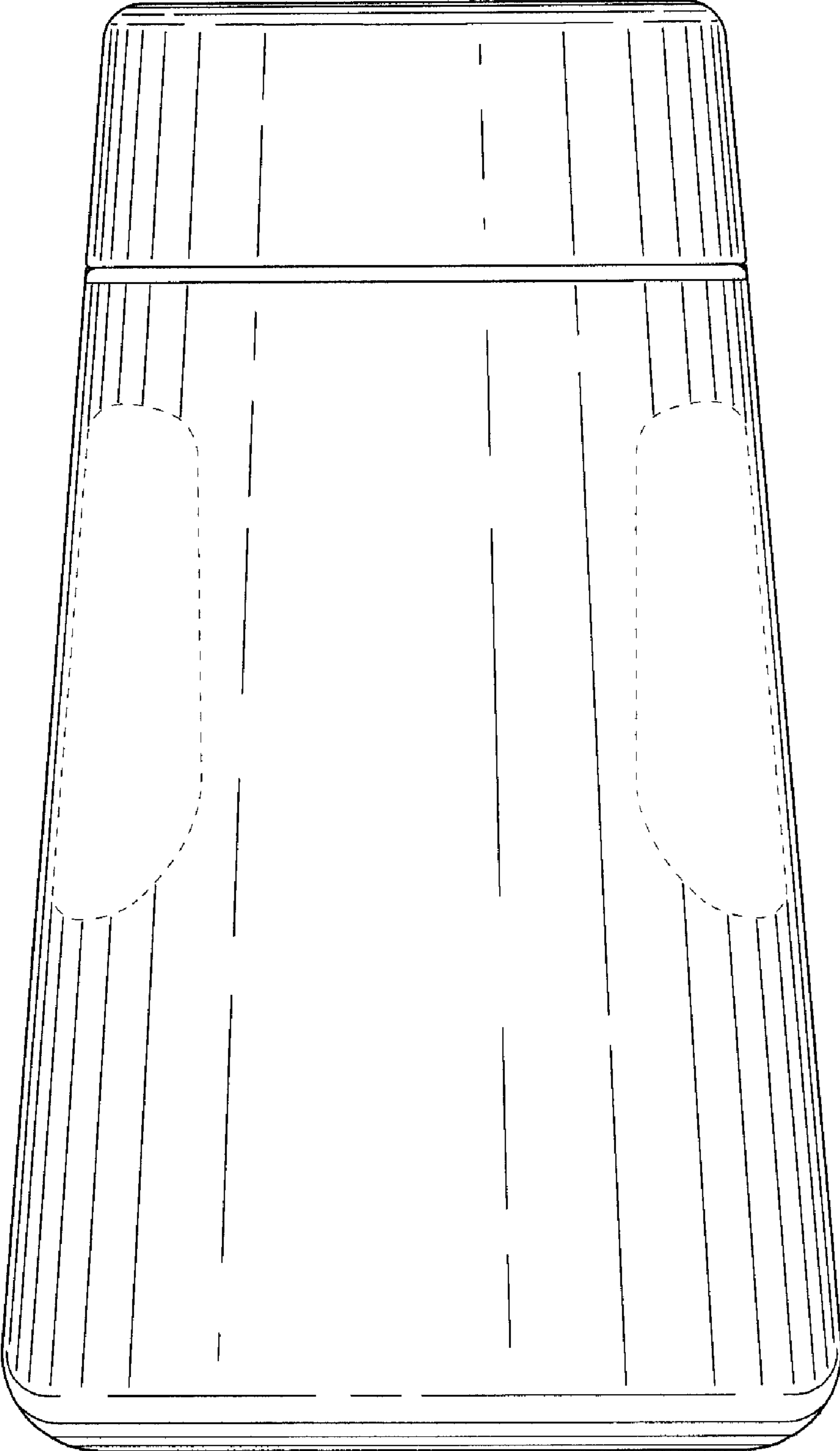

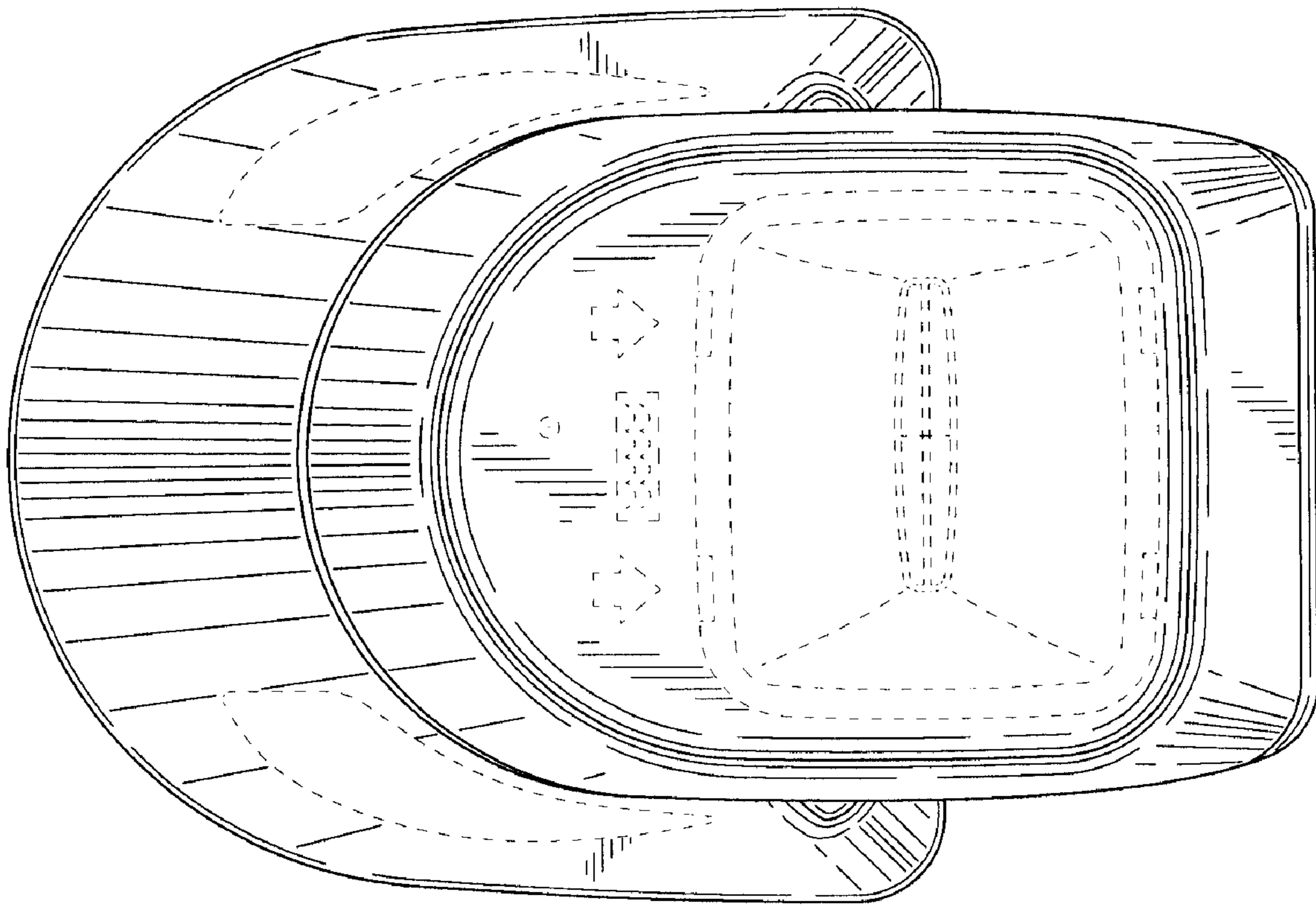

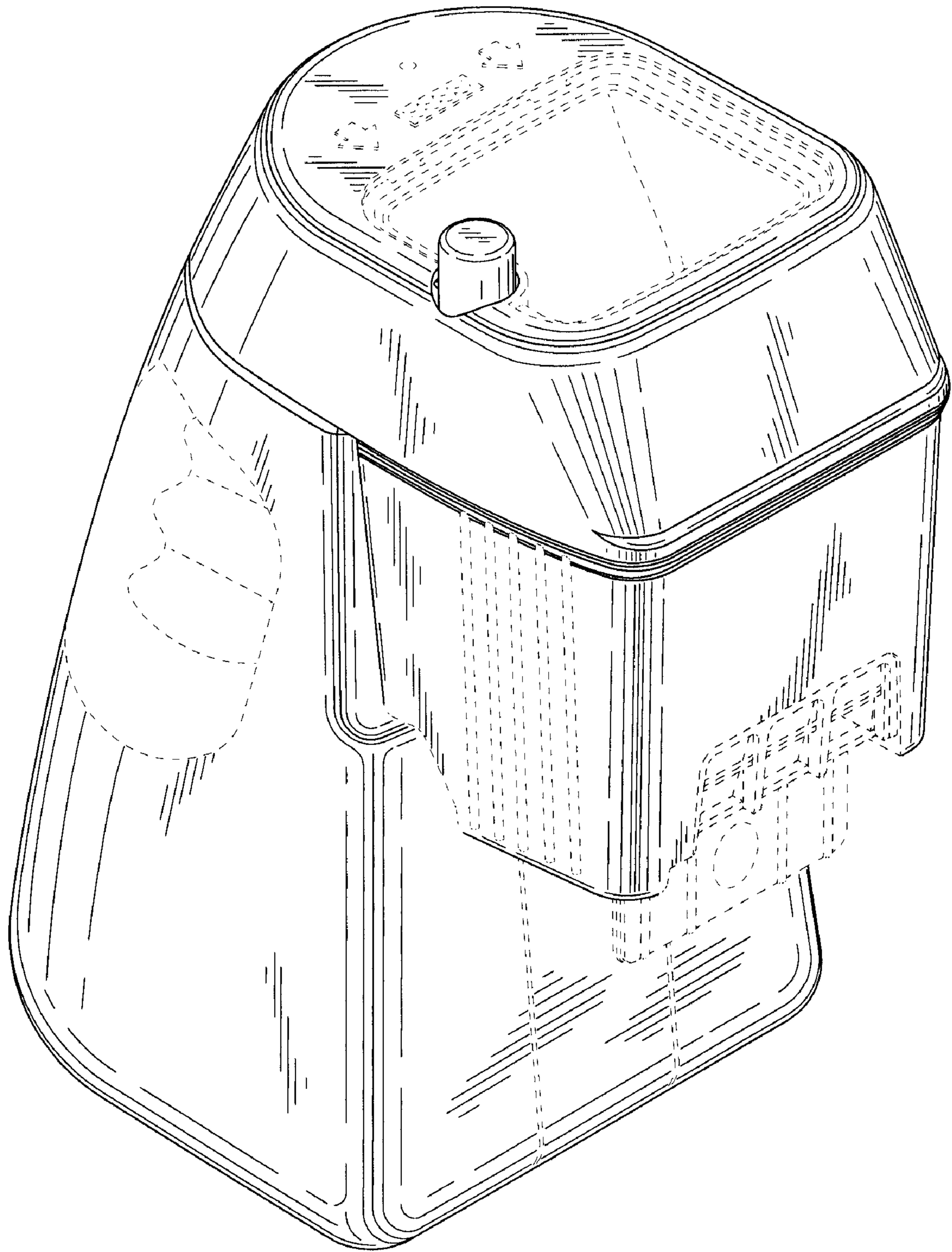

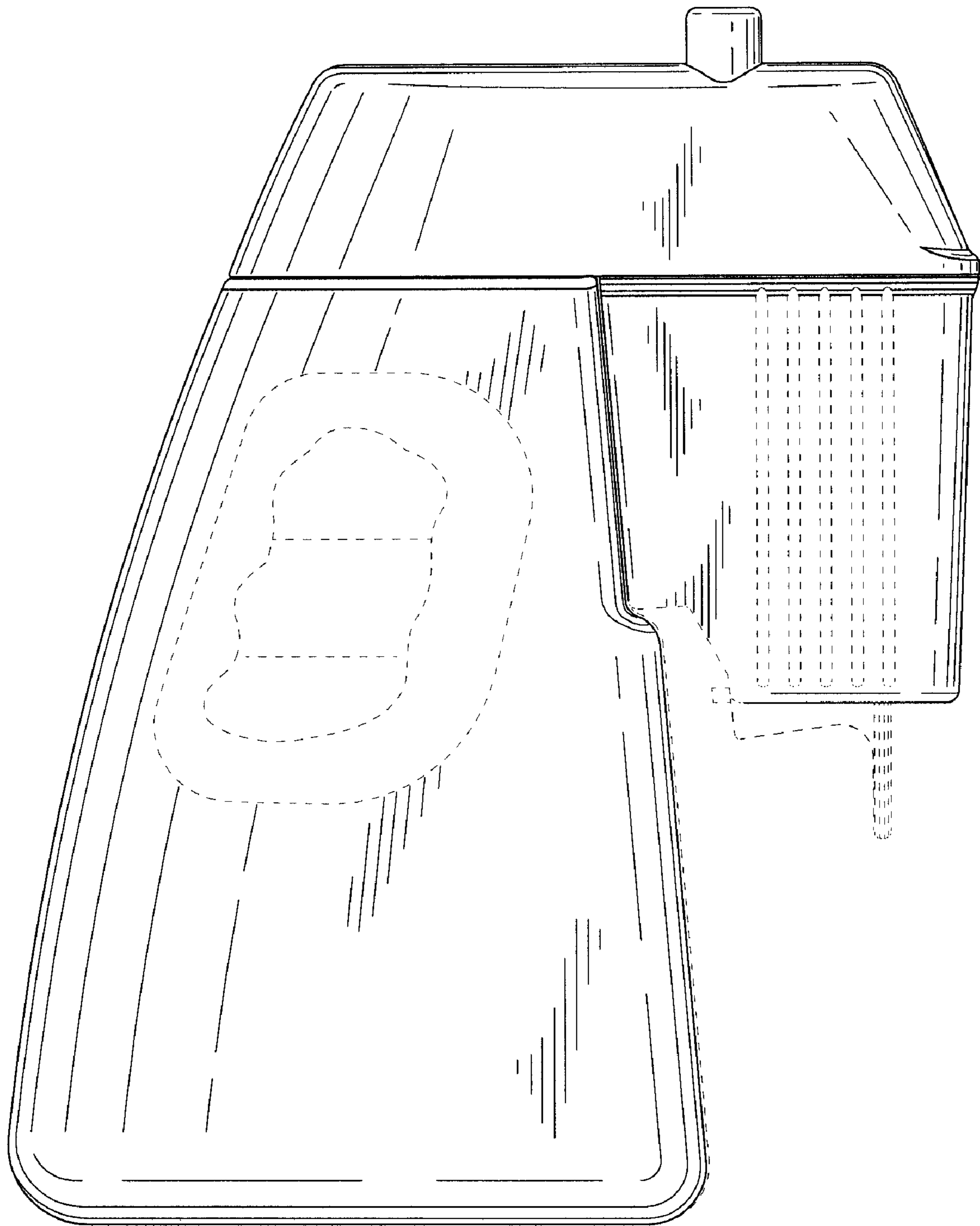

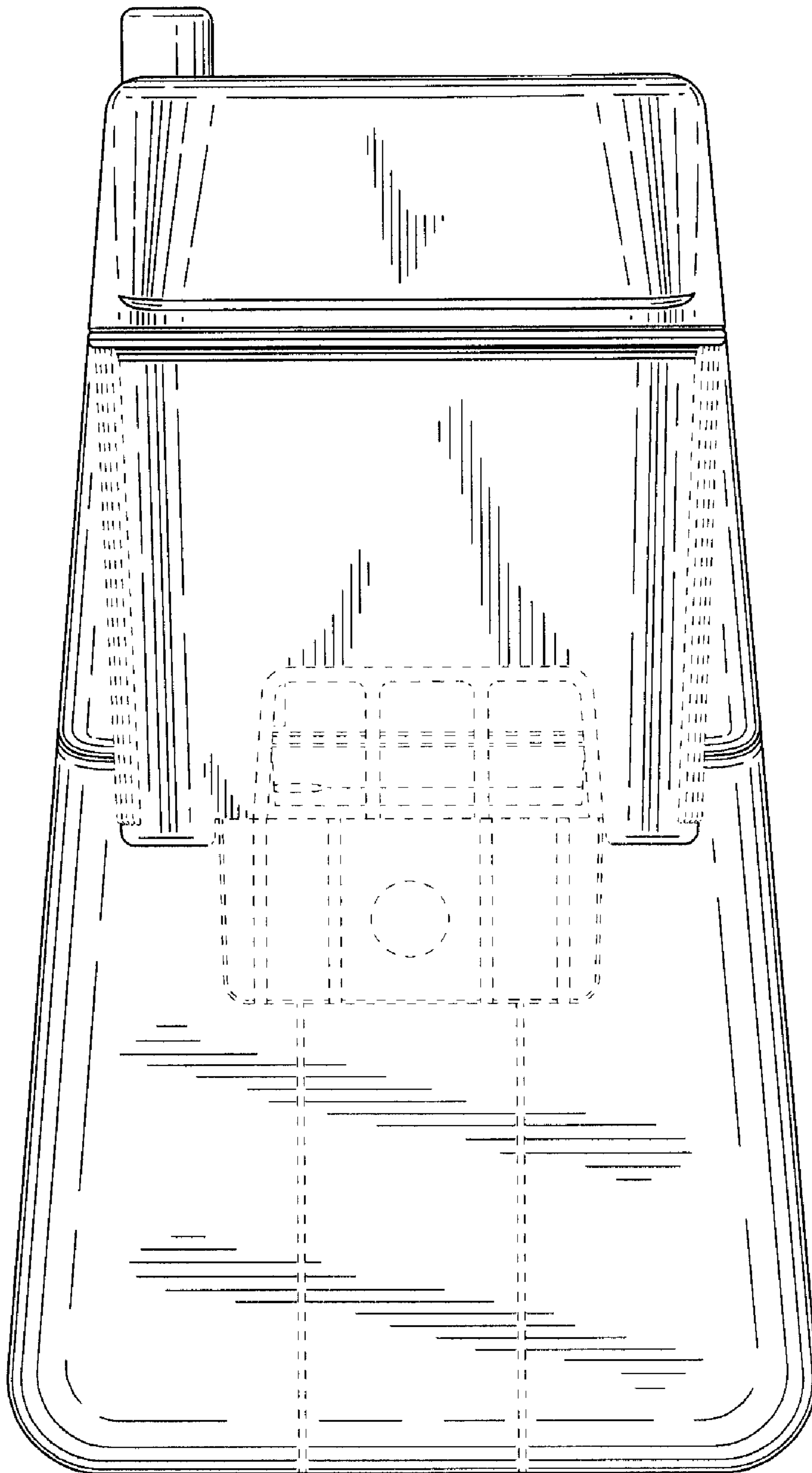

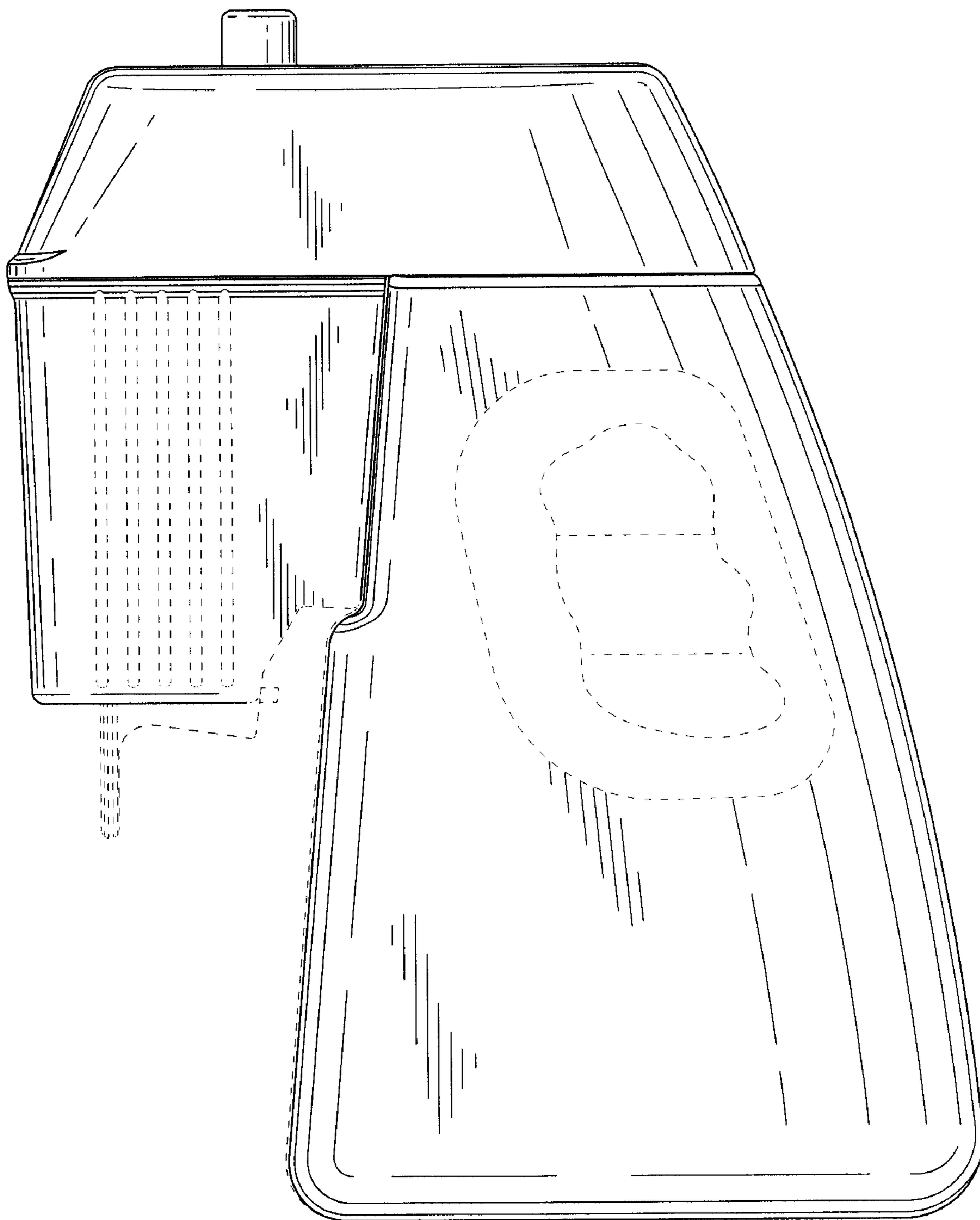

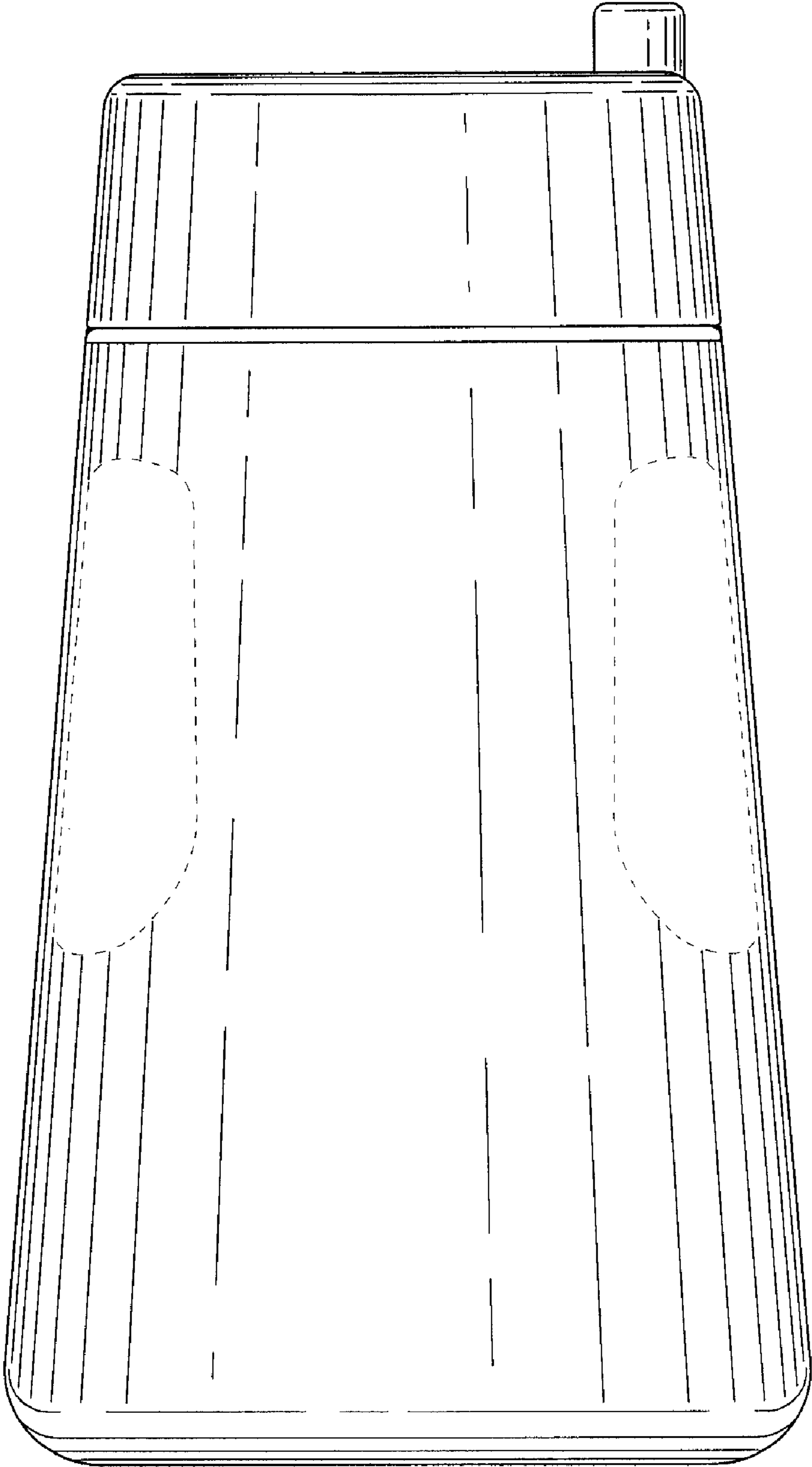

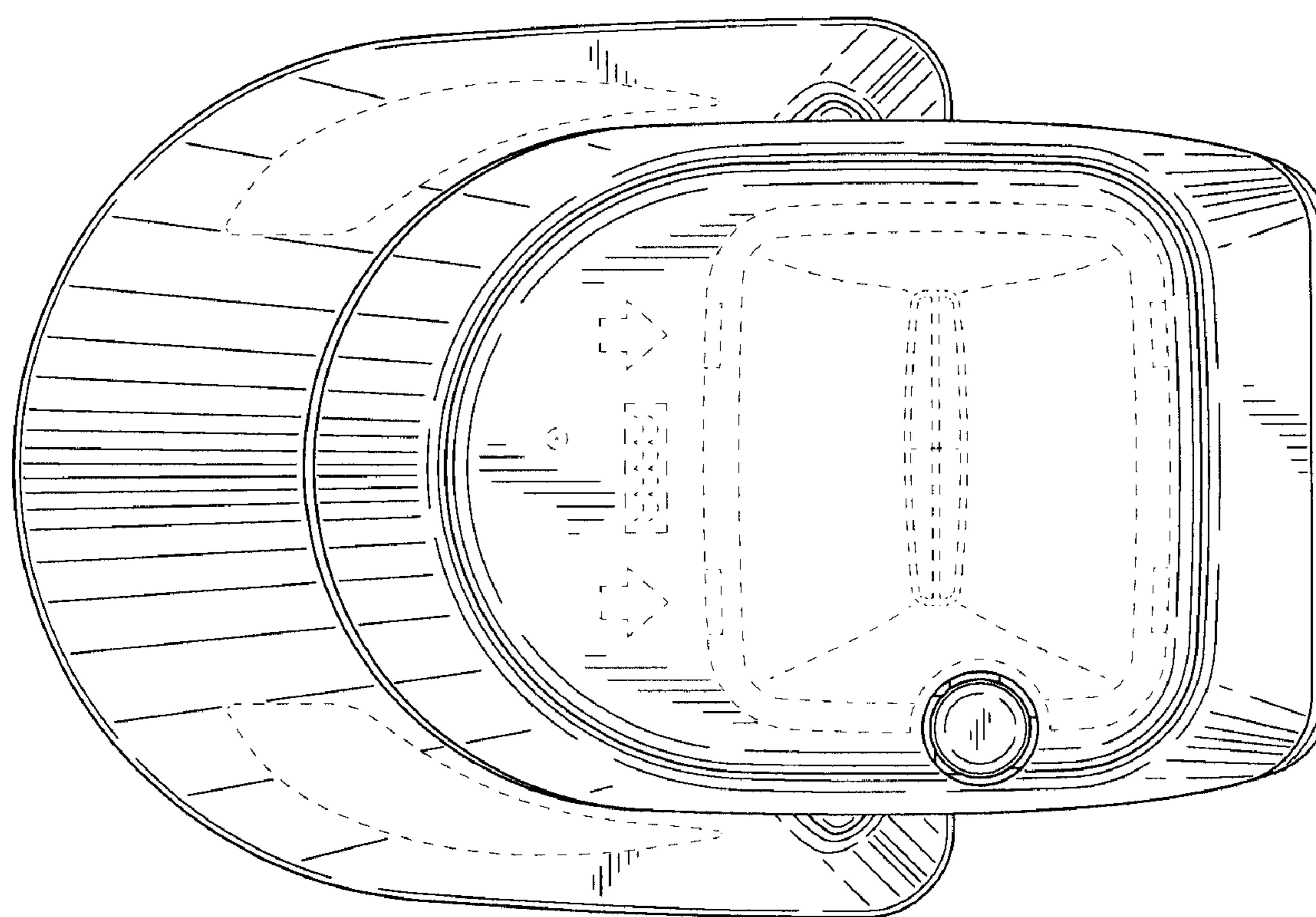
