The ornamental design for a castle humidifier, as shown and described.

**DESCRIPTION**

FIG. 1 is a top, front, and right side perspective of an embodiment of a castle humidifier embodying my new design.

FIG. 2 is a front elevation view of the embodiment of FIG. 1.

FIG. 3 is a rear elevation view of the embodiment of FIG. 1.

FIG. 4 is a right side view of the embodiment of FIG. 1.

FIG. 5 left side view of the embodiment of FIG. 1.

FIG. 6 is a top plan view of the embodiment of FIG. 1.

FIG. 7 is a bottom plan view of the embodiment of FIG. 1.

FIG. 8 is a top, front, and right side perspective of a second embodiment of a castle humidifier embodying my new design.

FIG. 9 is a front elevation view of the embodiment of FIG. 8.

FIG. 10 is a rear elevation view of the embodiment of FIG. 8.

FIG. 11 is a right side view of the embodiment of FIG. 8.

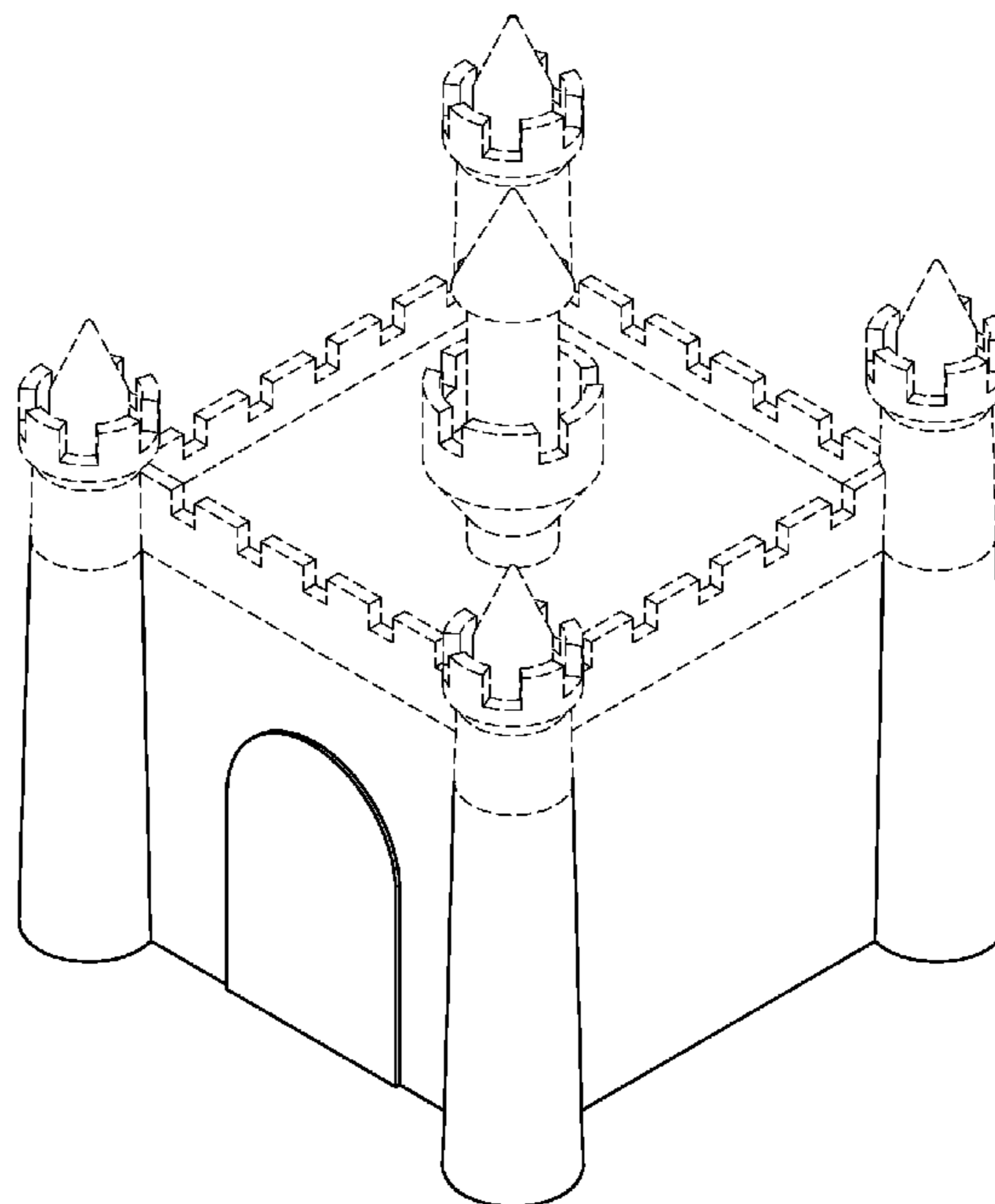
FIG. 12 left side view of the embodiment of FIG. 8.

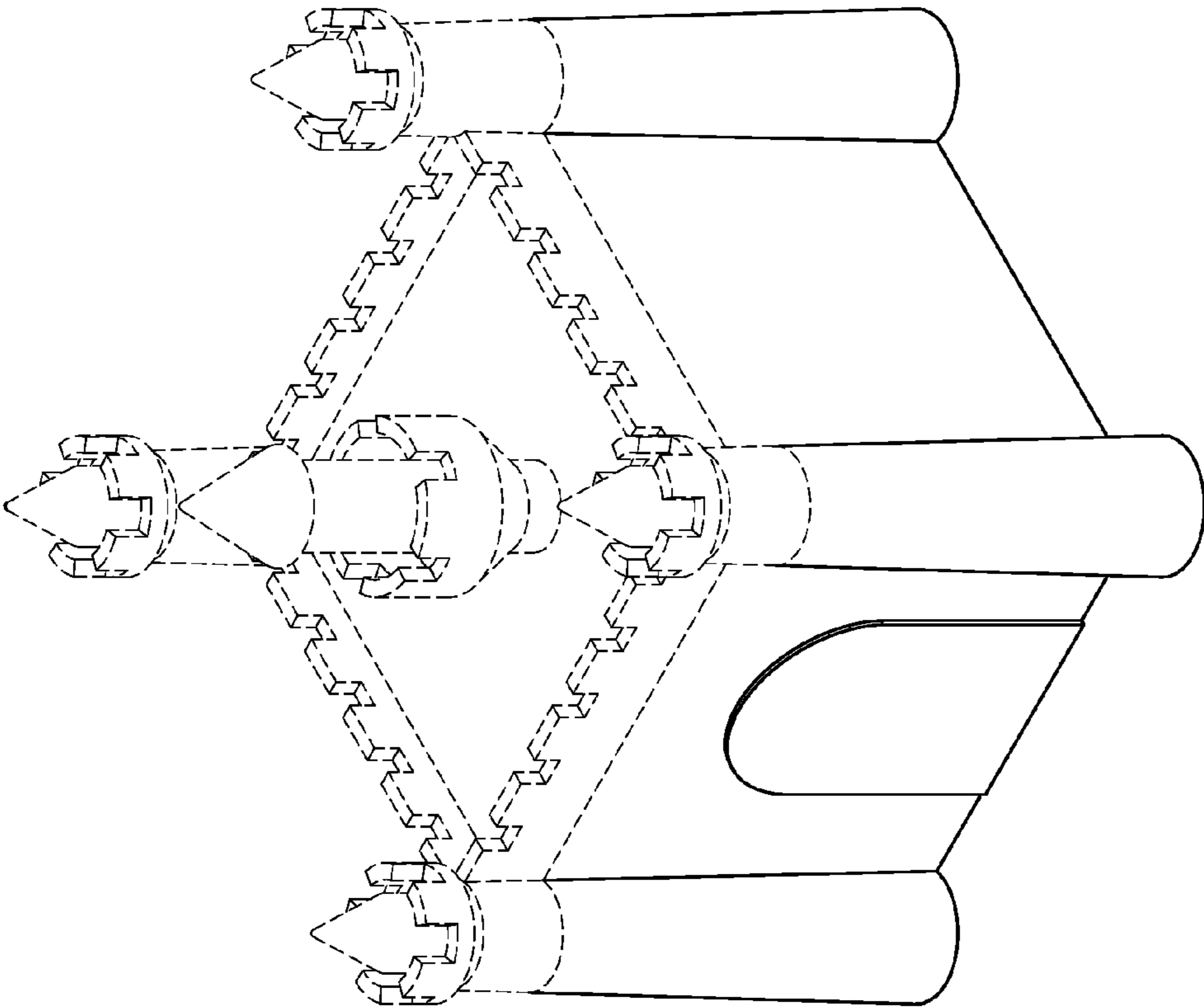

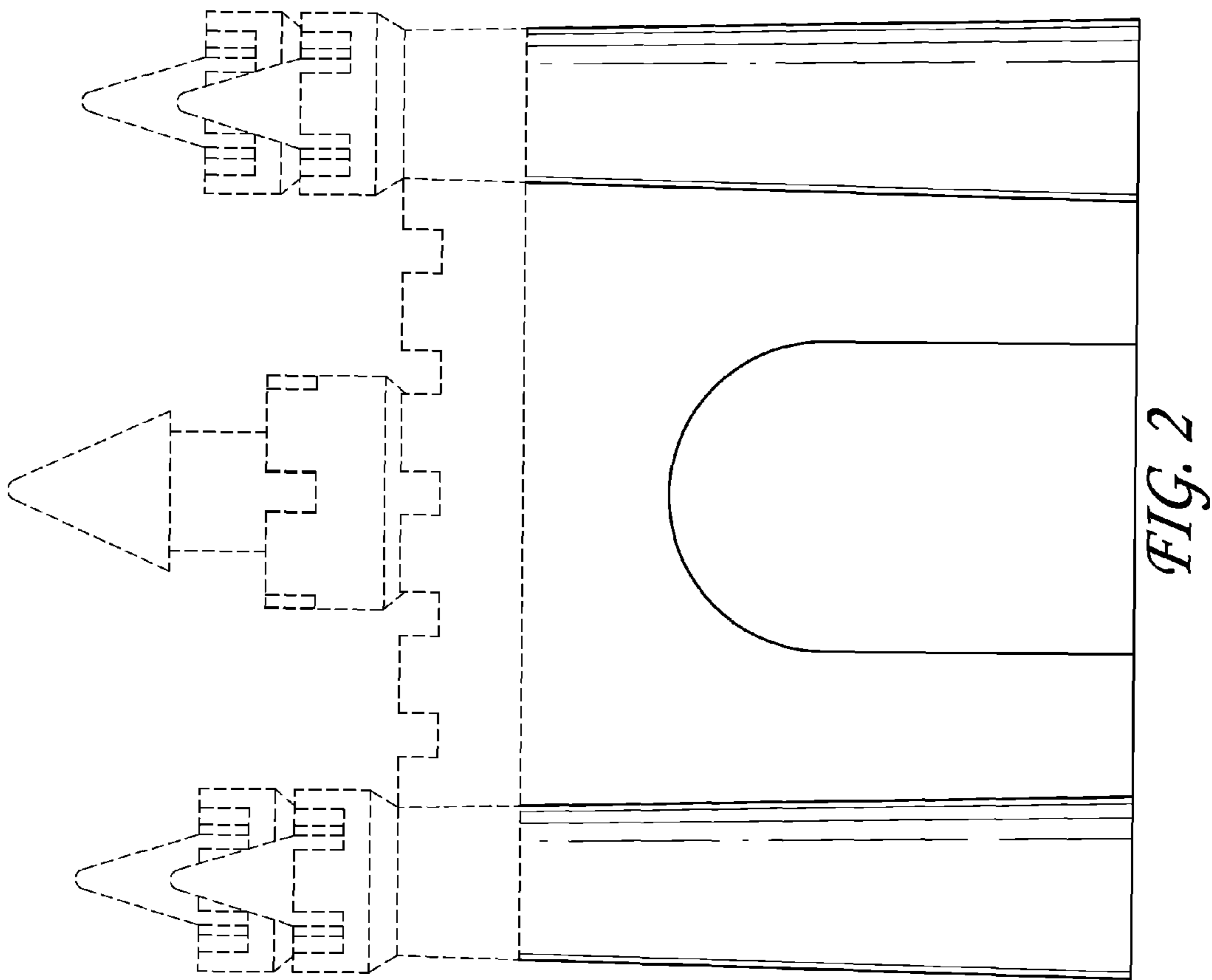

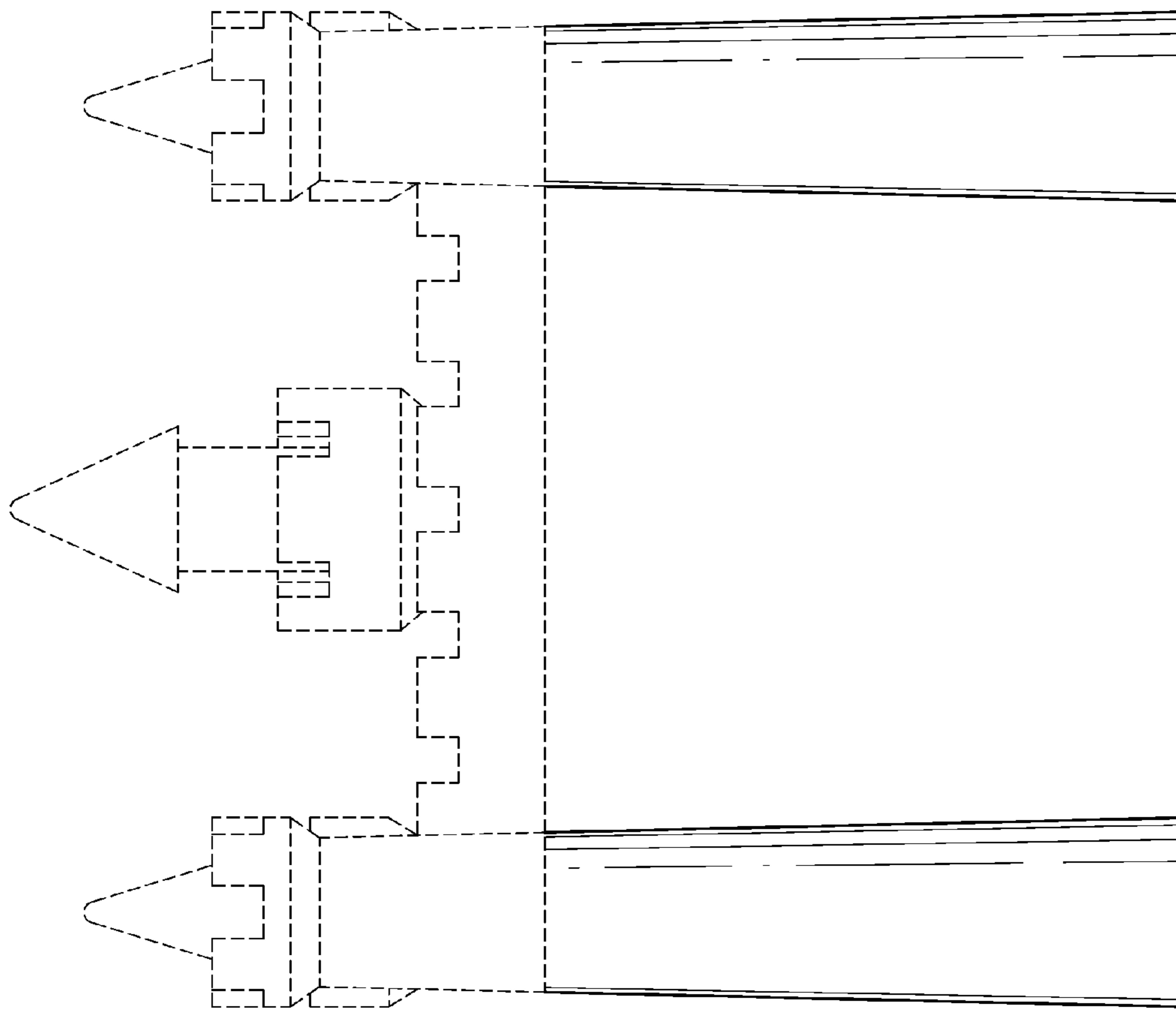

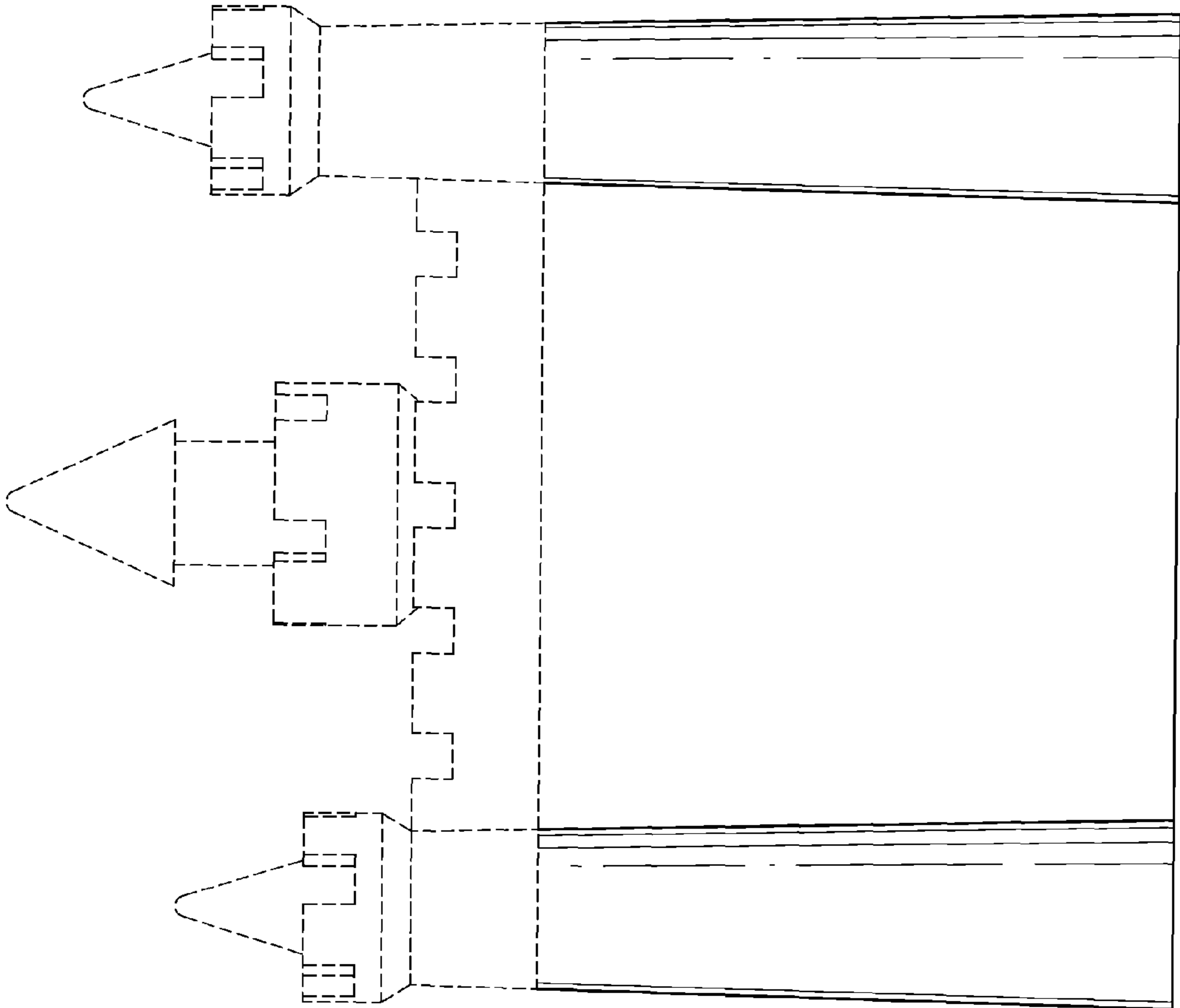
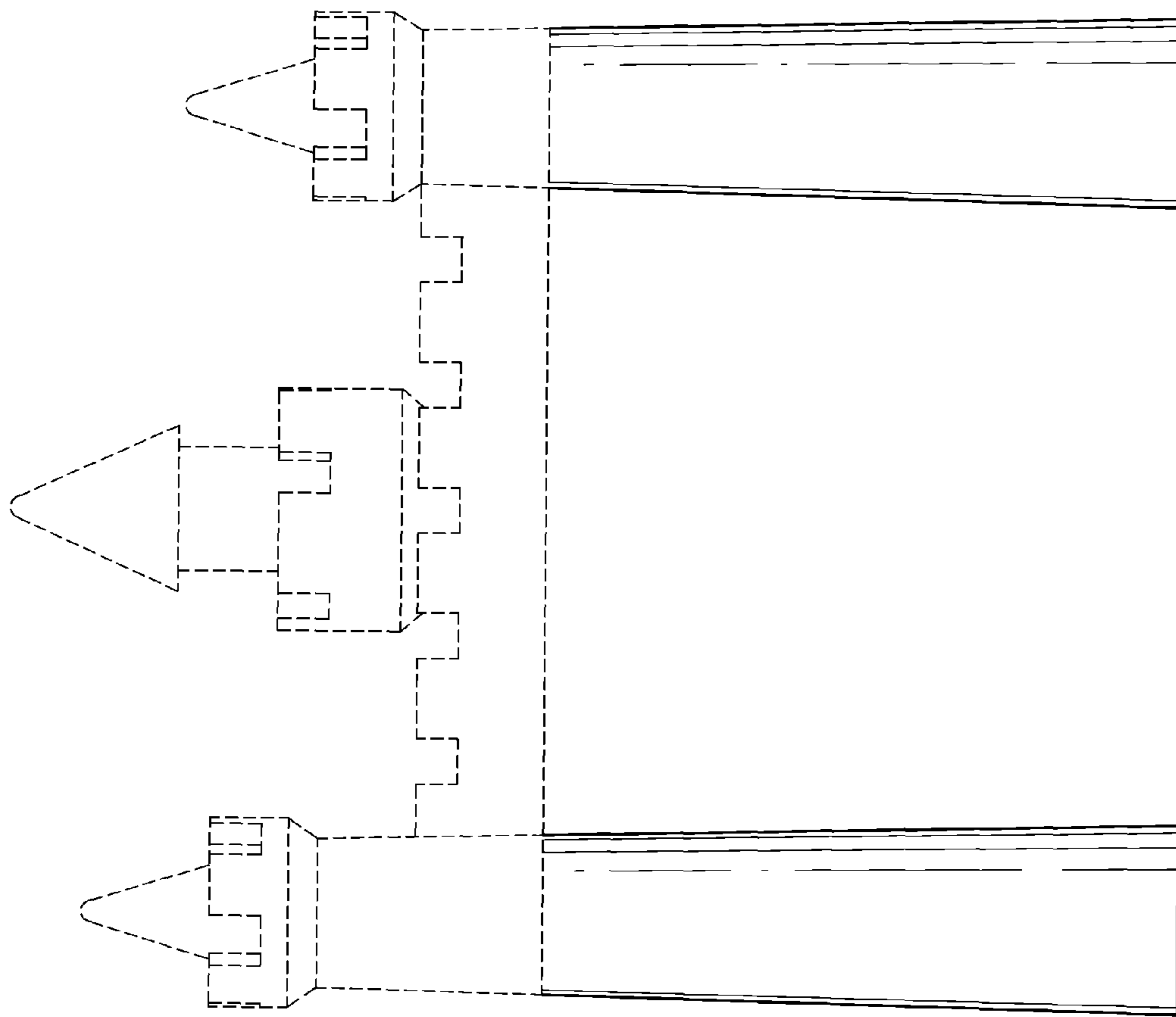
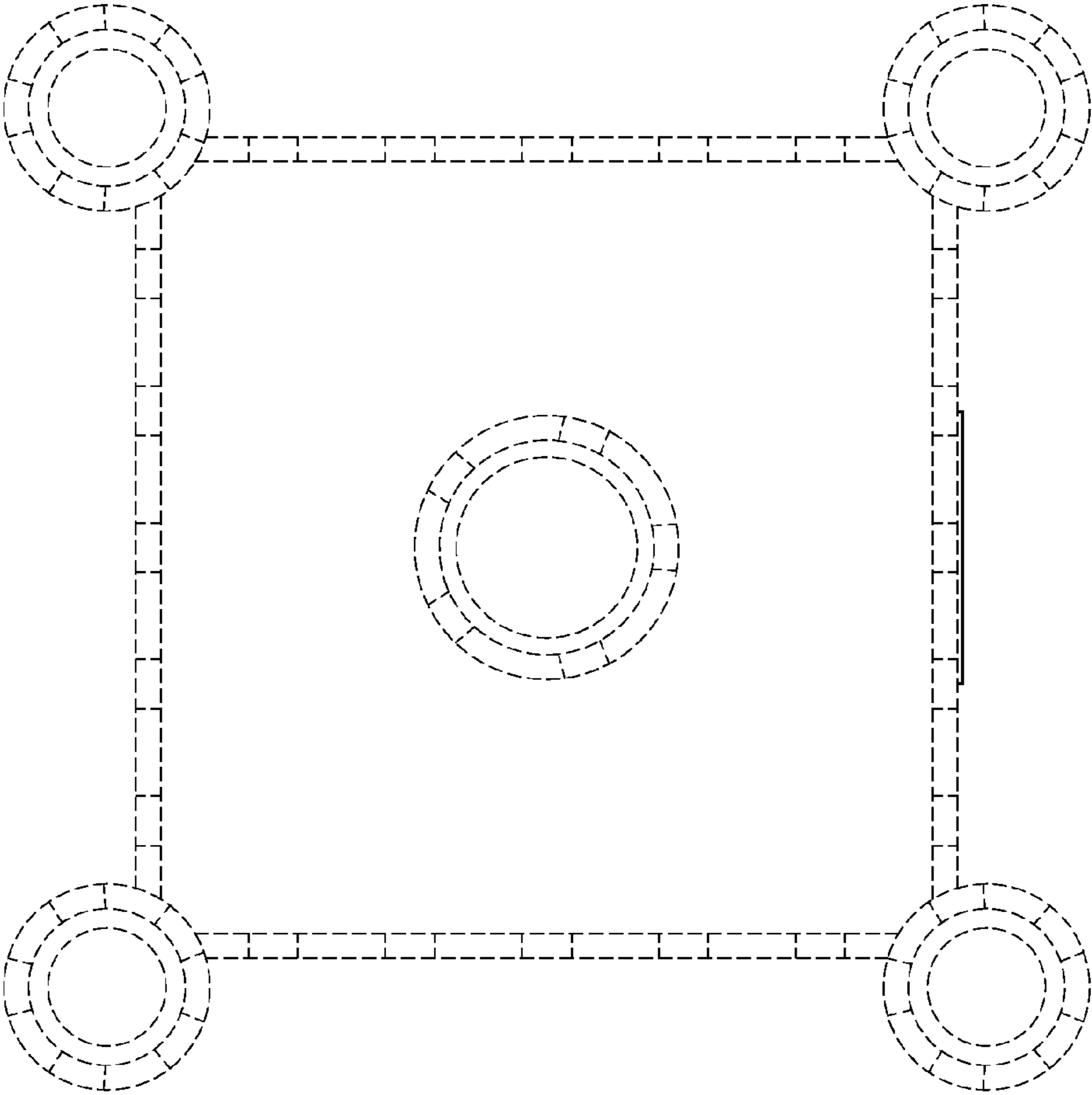

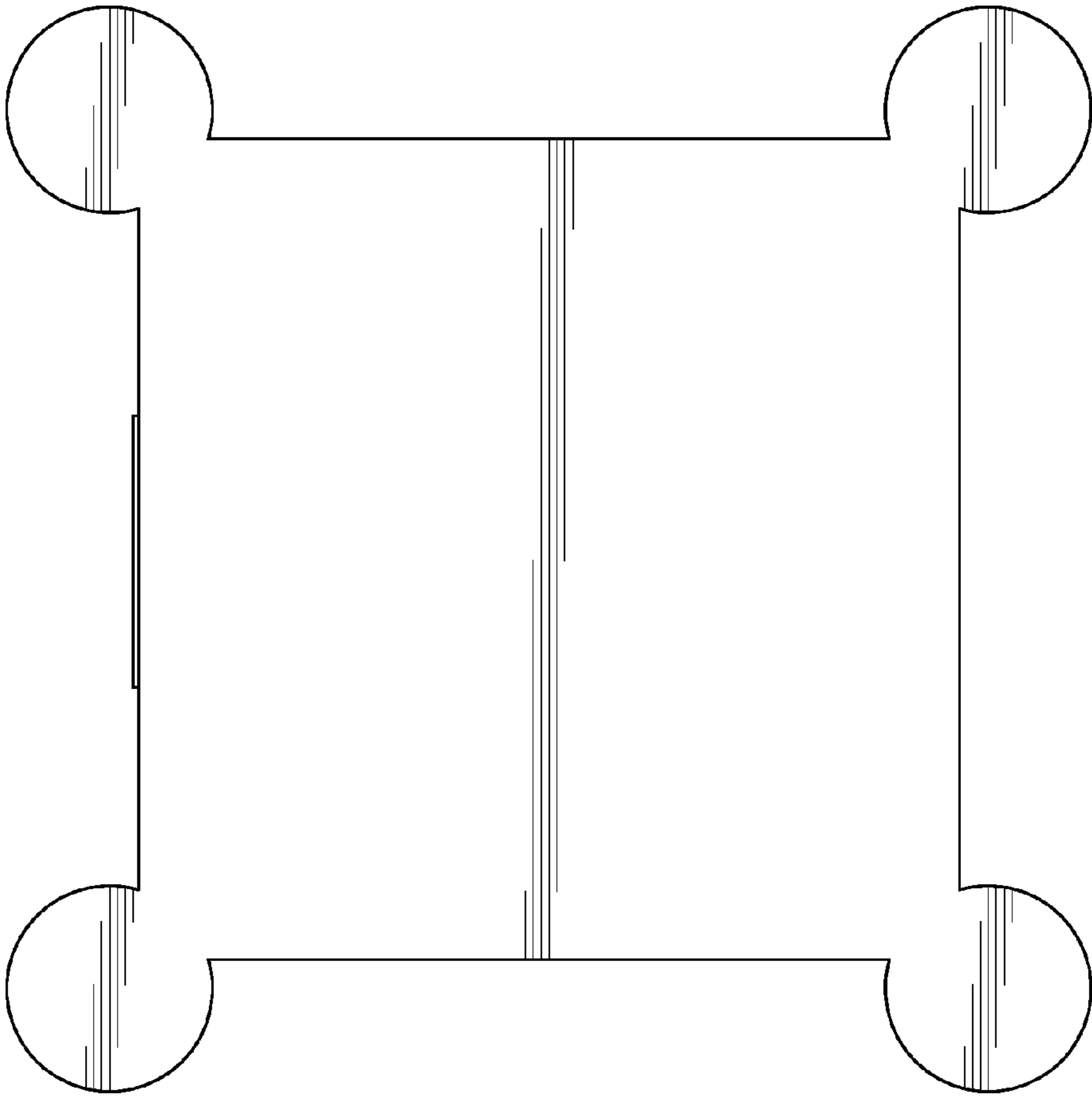

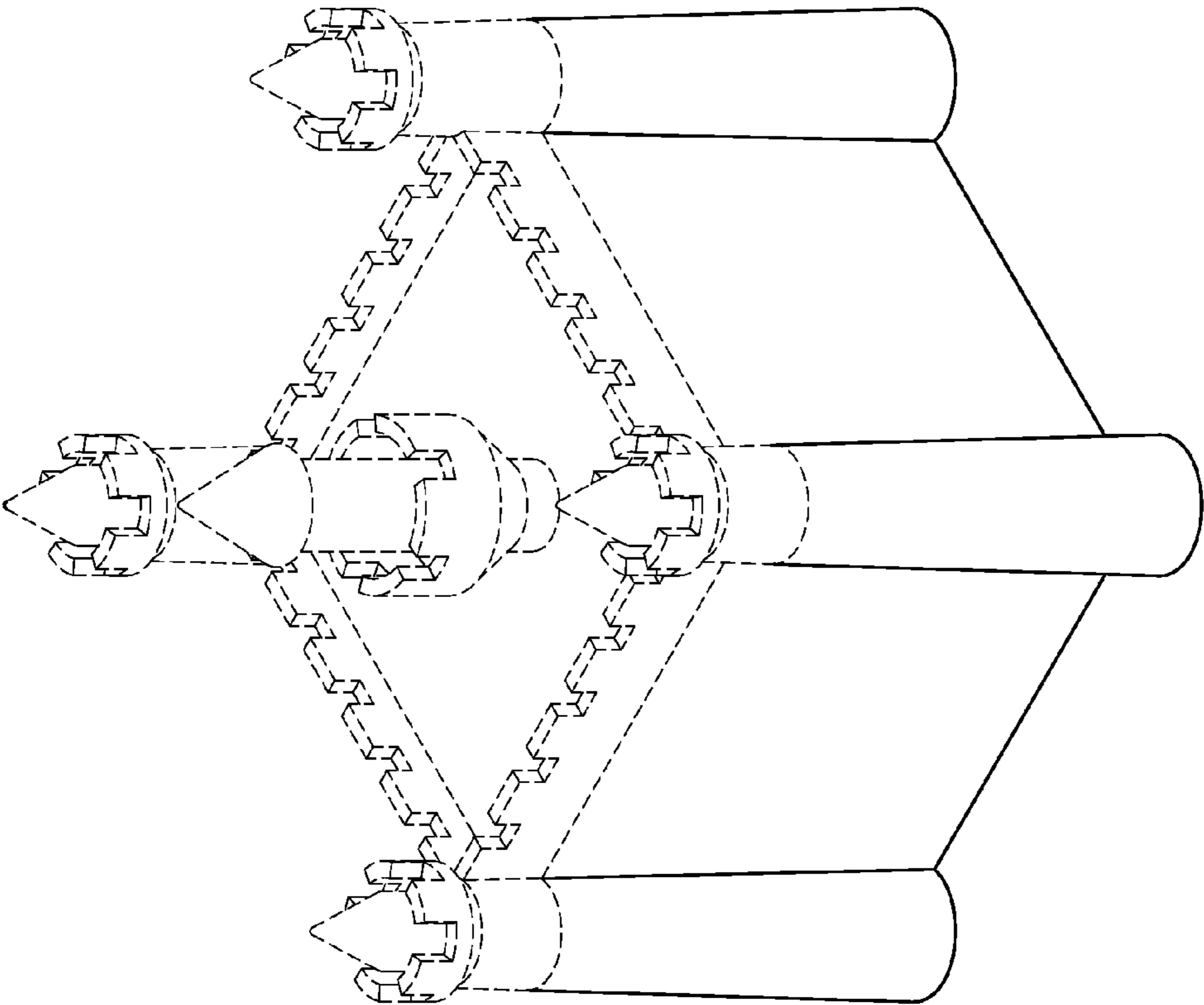

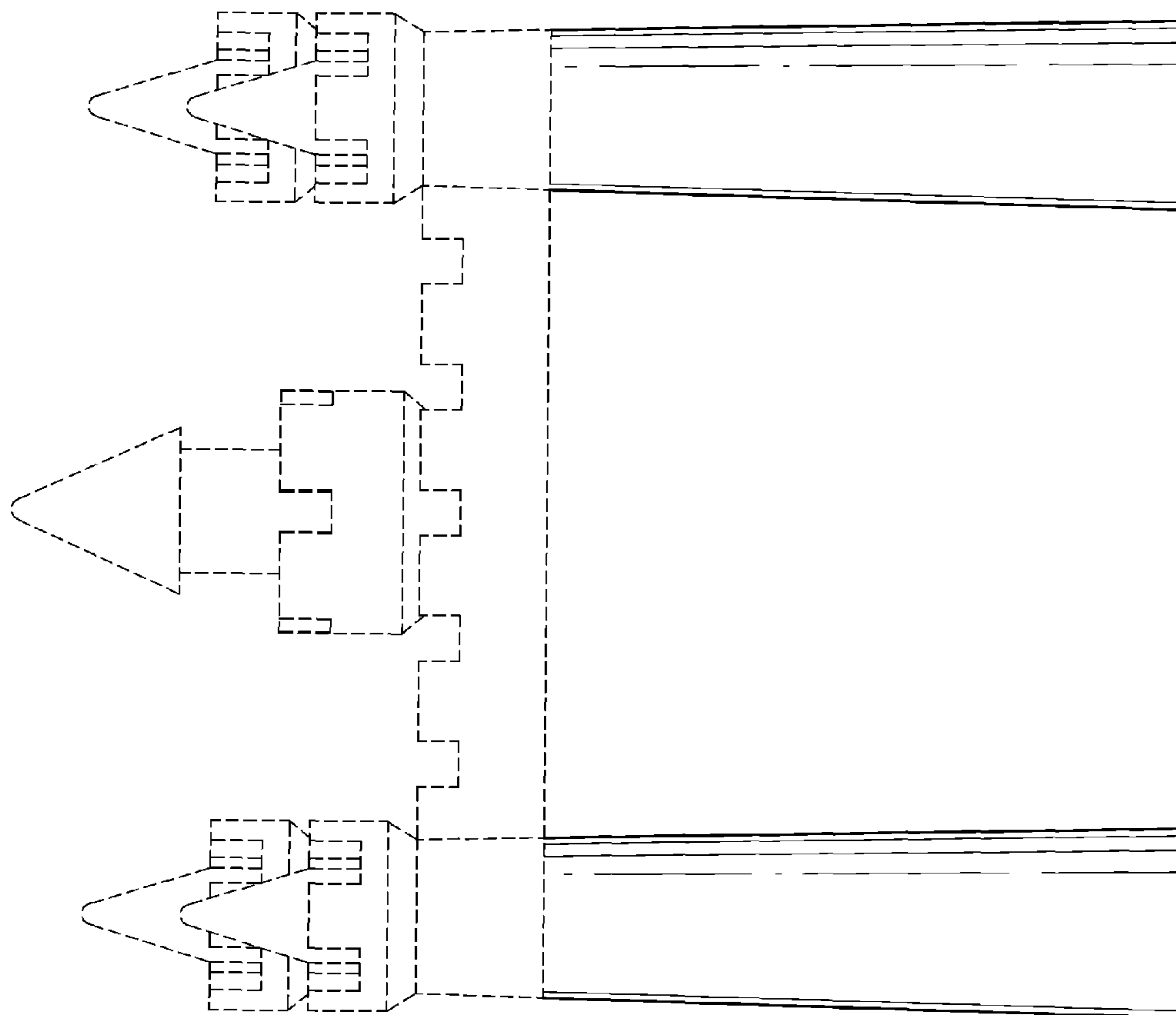




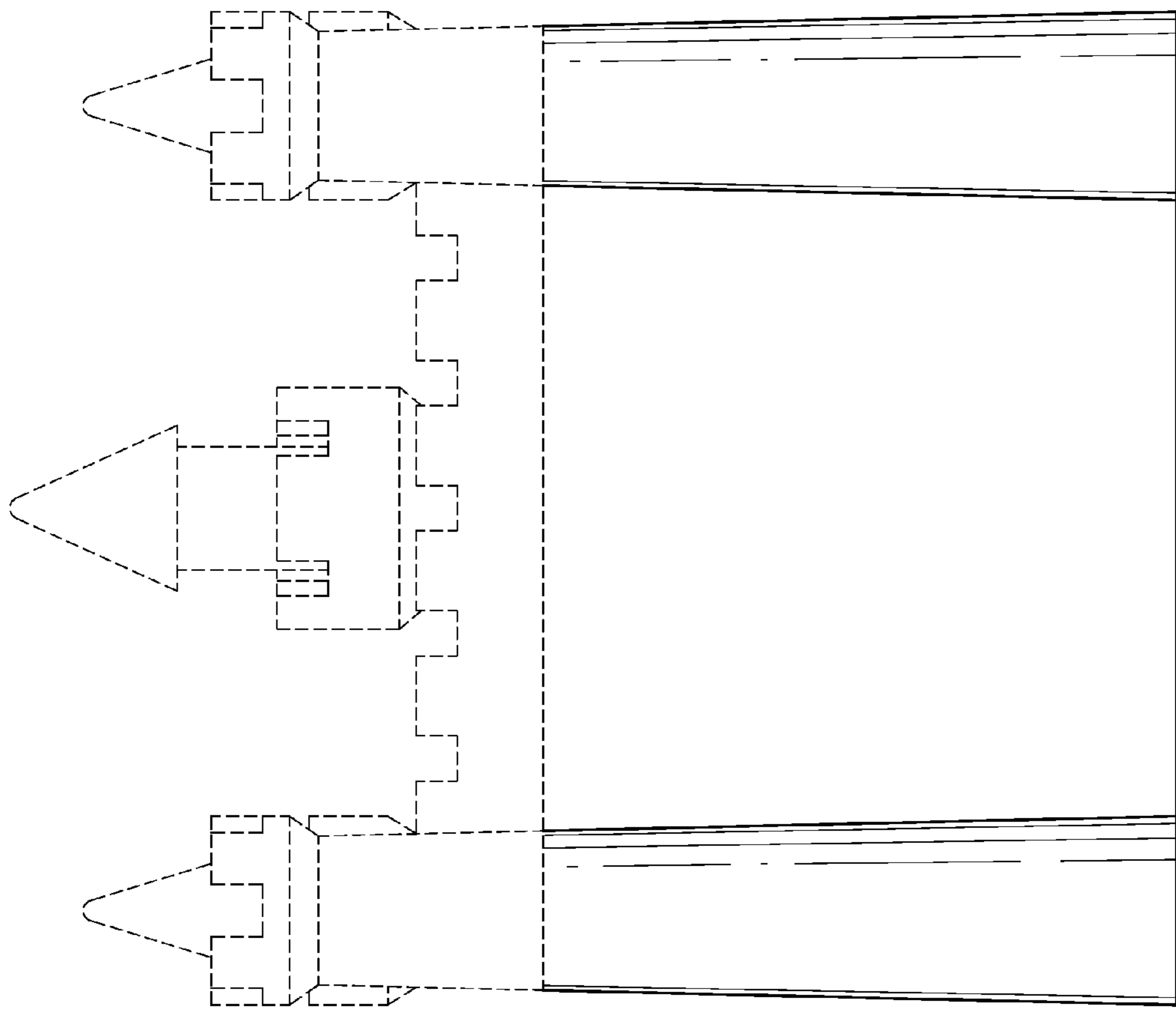

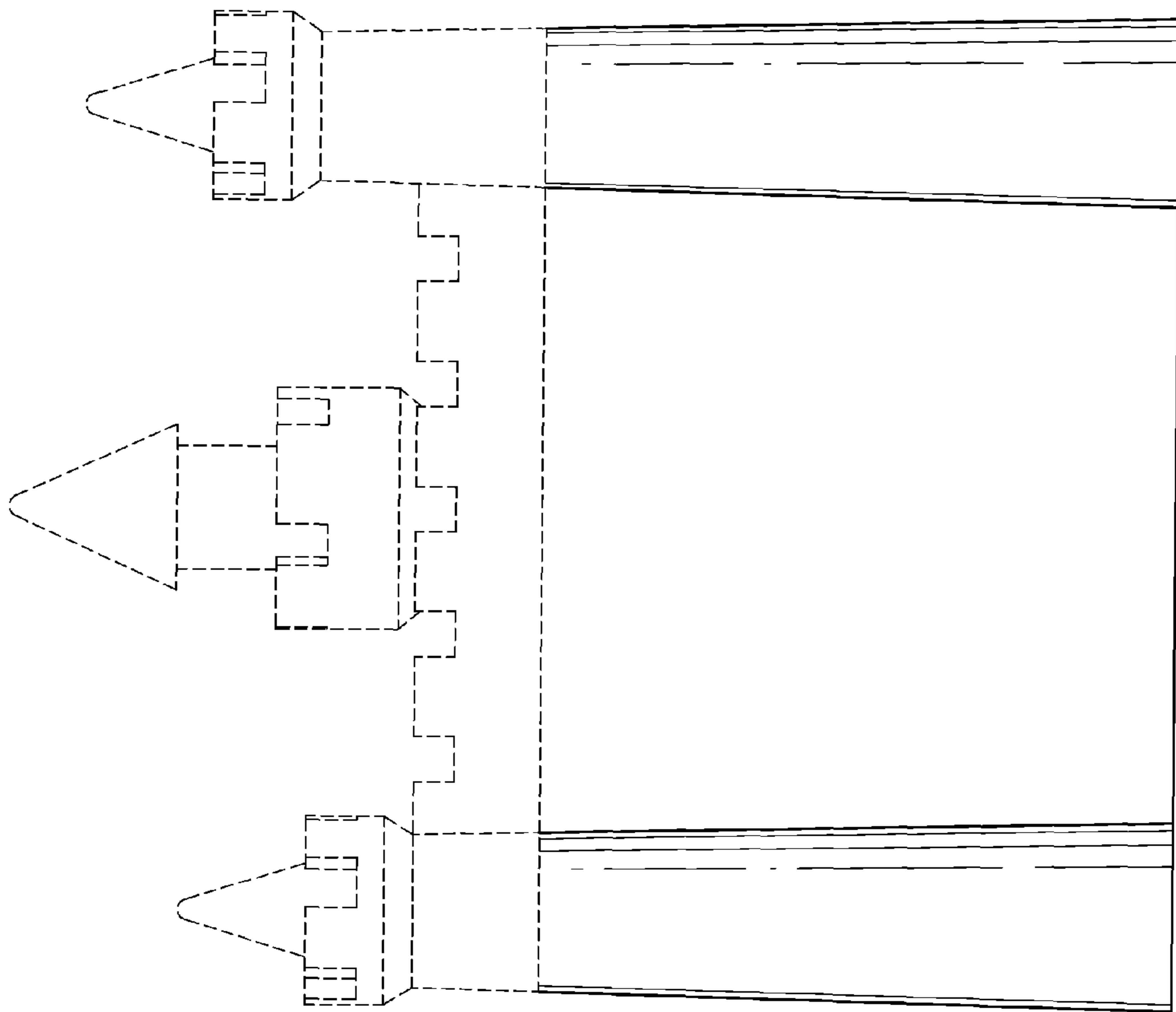

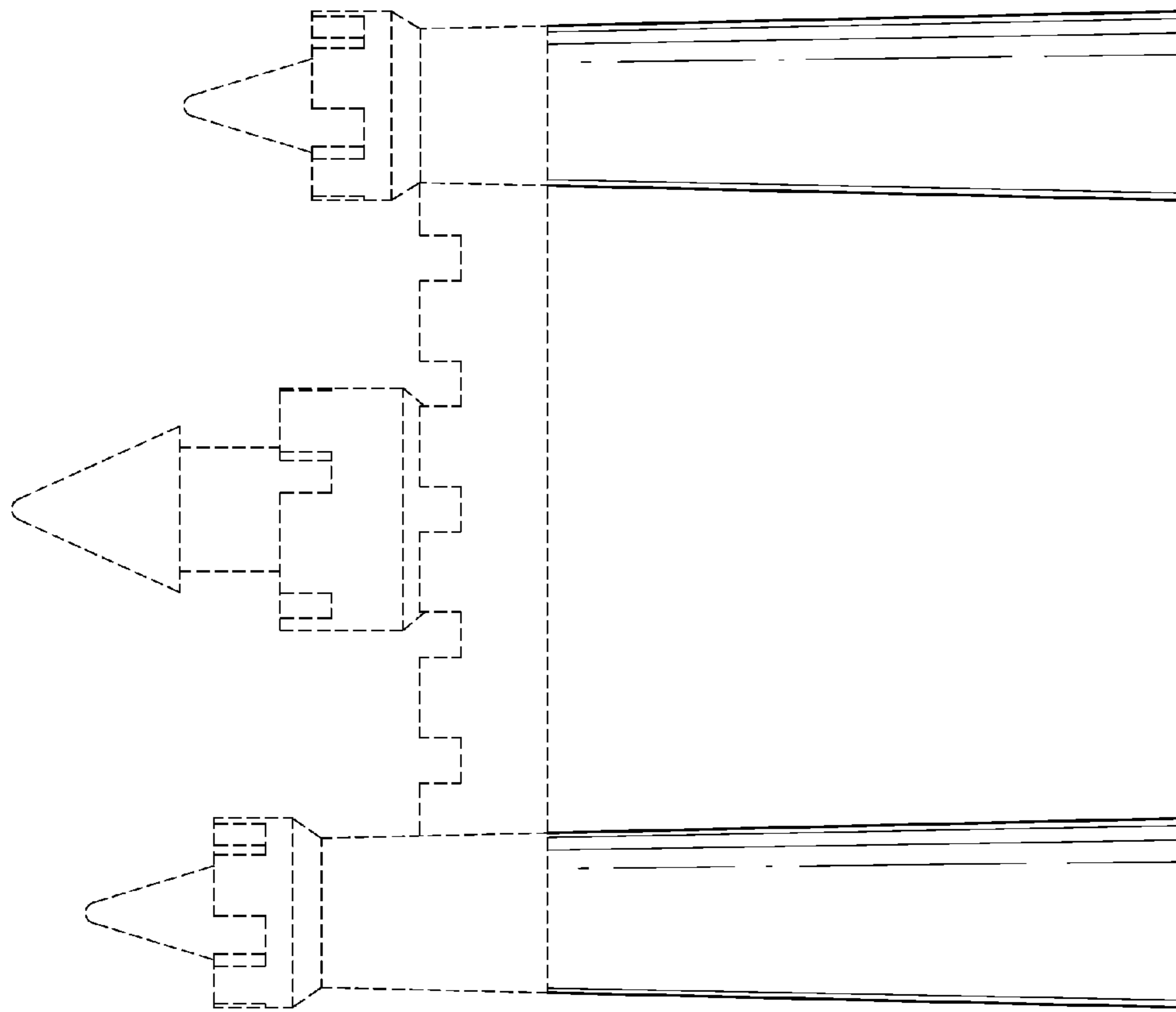

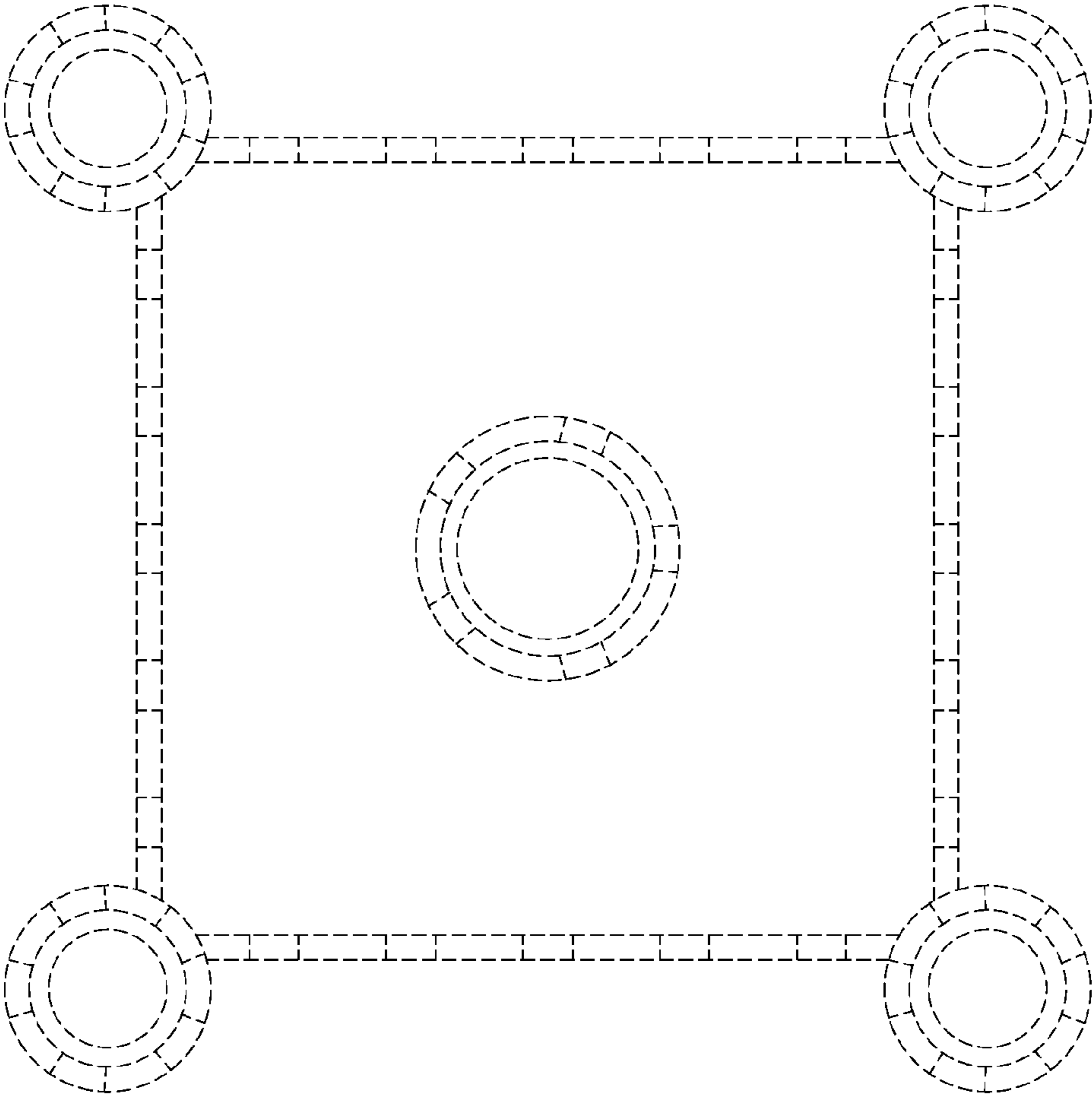

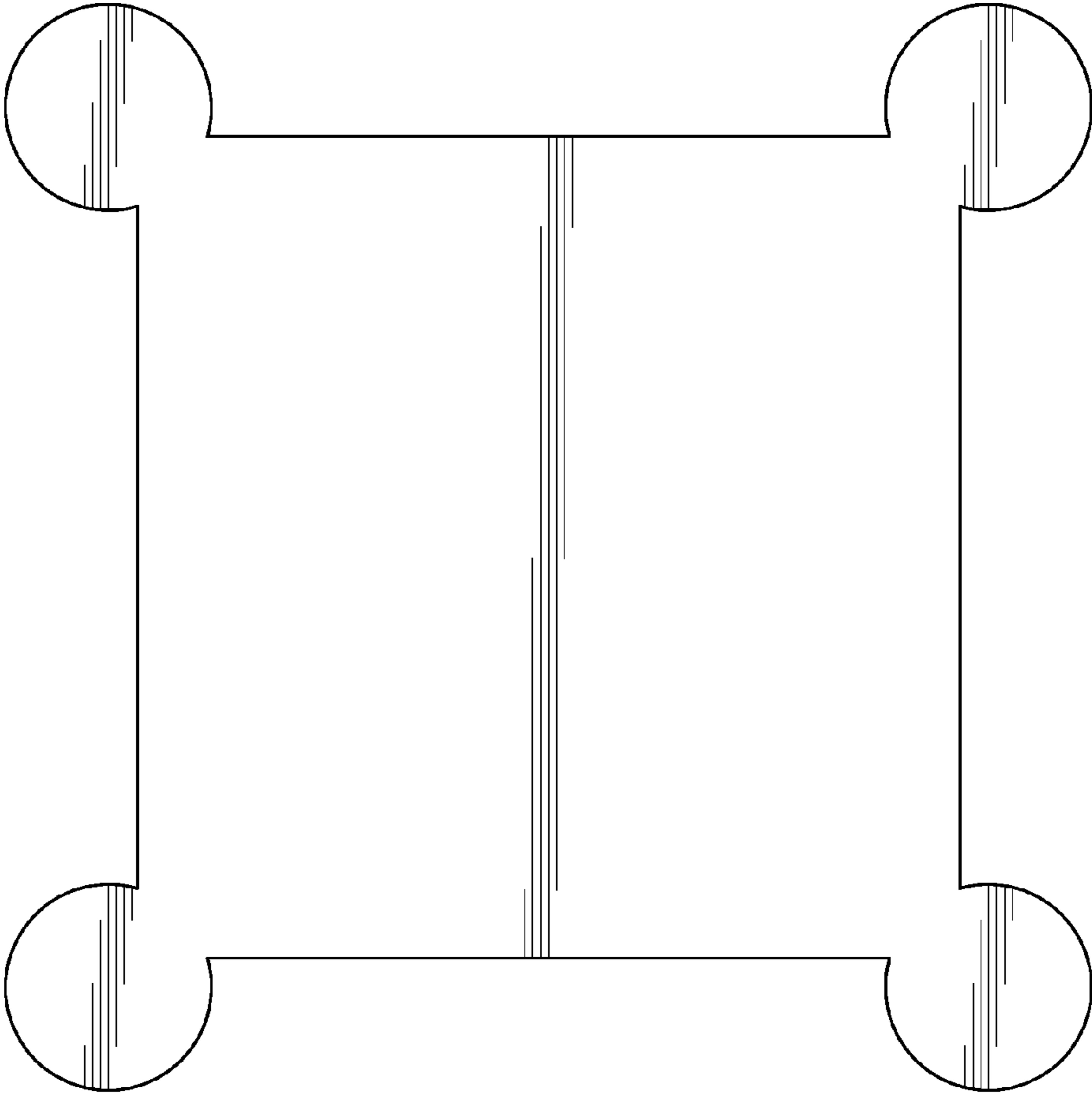
