**DESCRIPTION**

FIG. 1 is a perspective view of the chandelier of my design;

FIG. 2 is a top view of the chandelier;

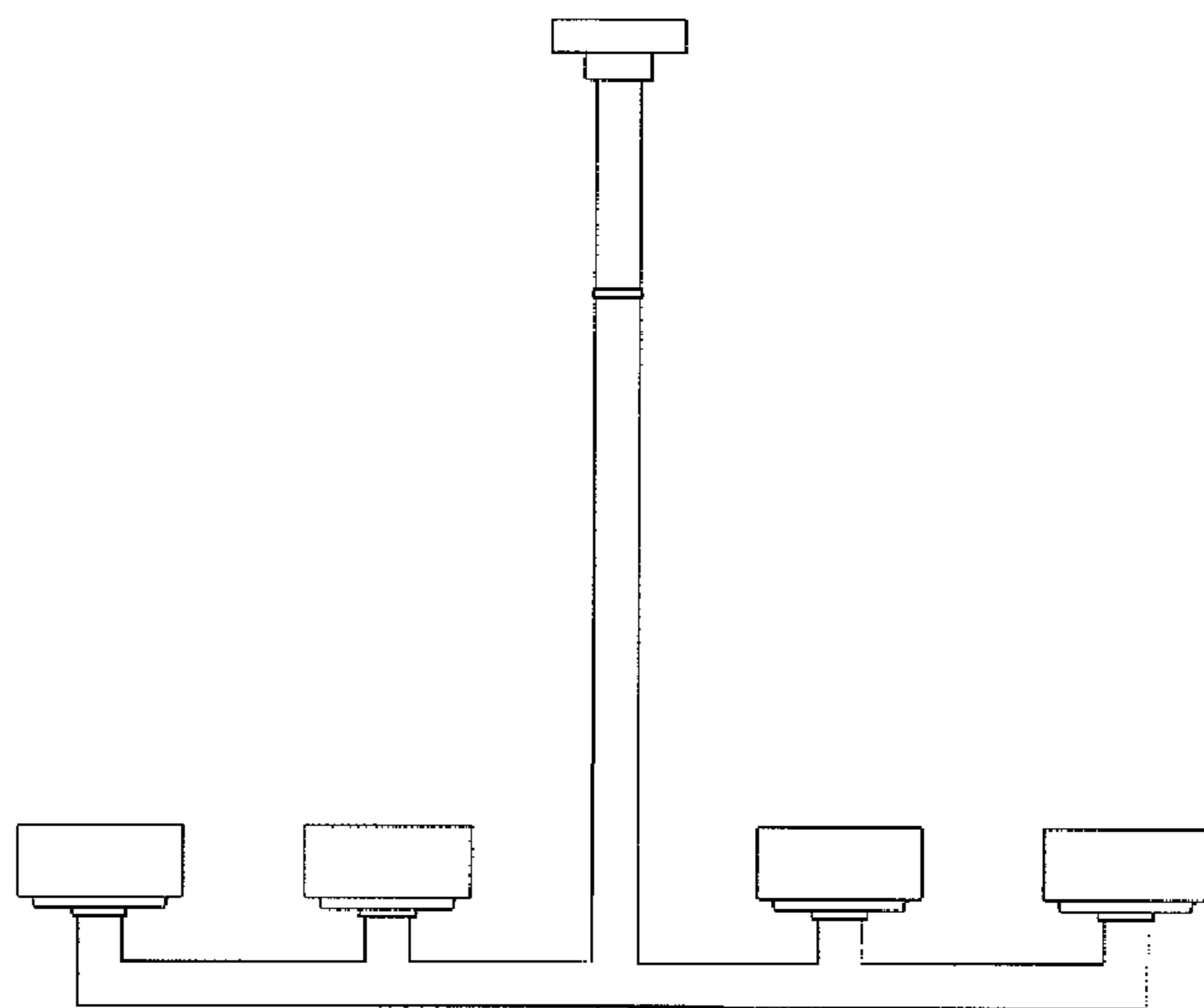
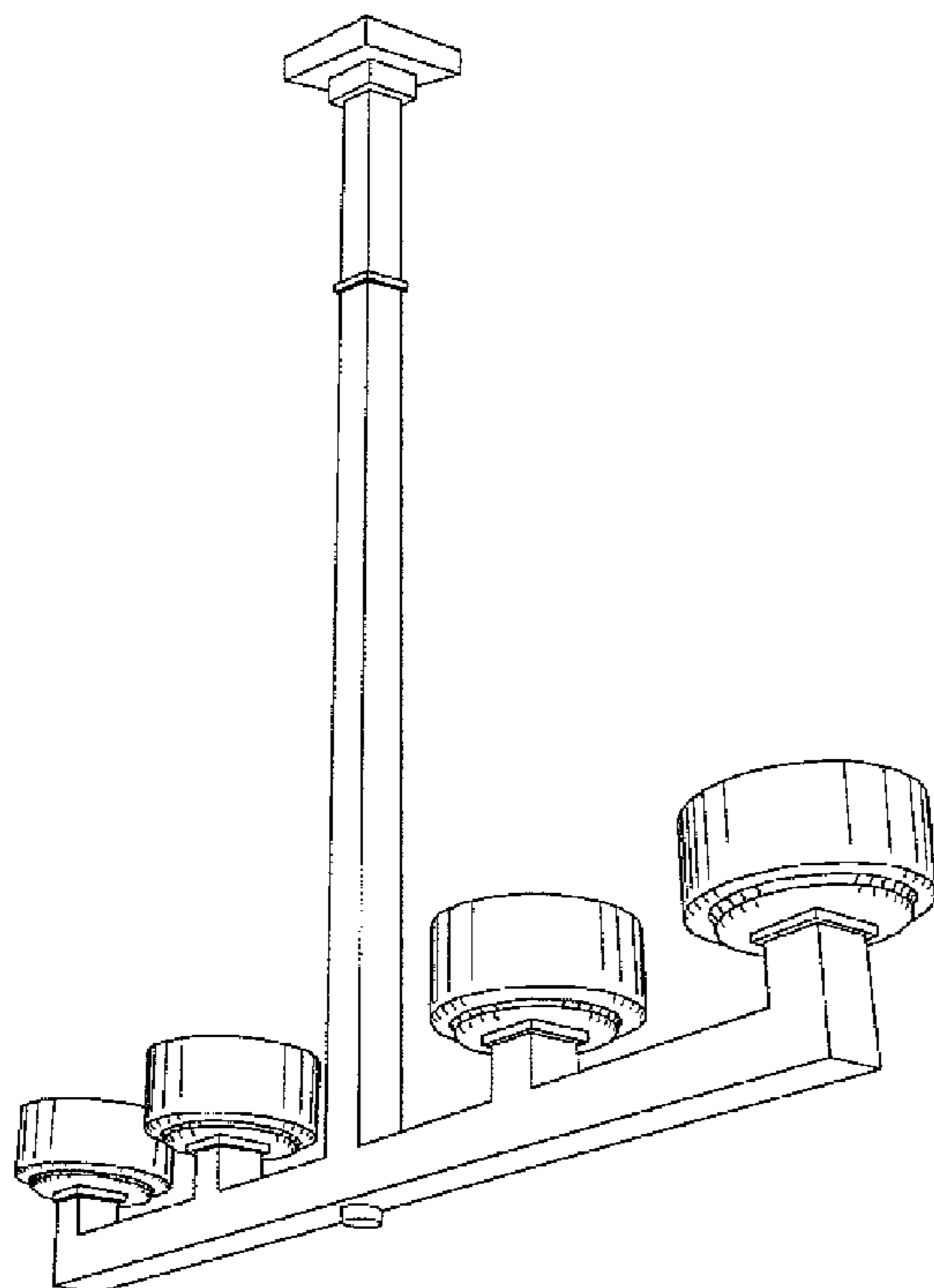
FIG. 3 is a front view of the chandelier (the back view, being a mirror image of the front view, is not shown);

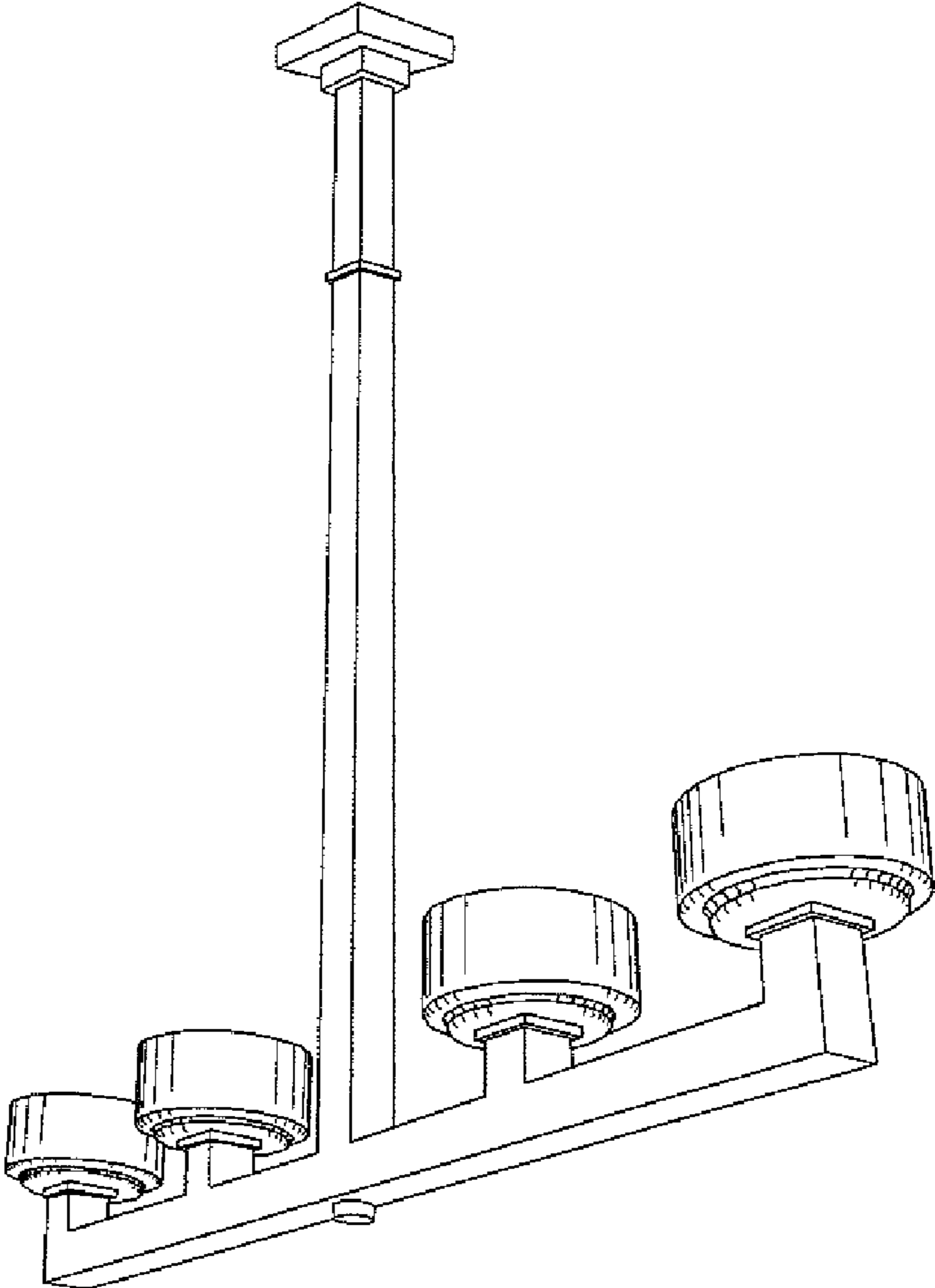

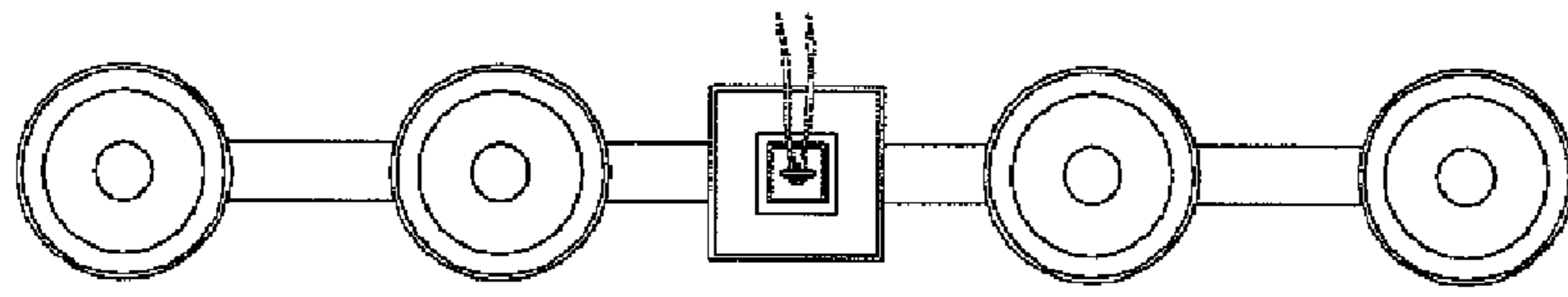

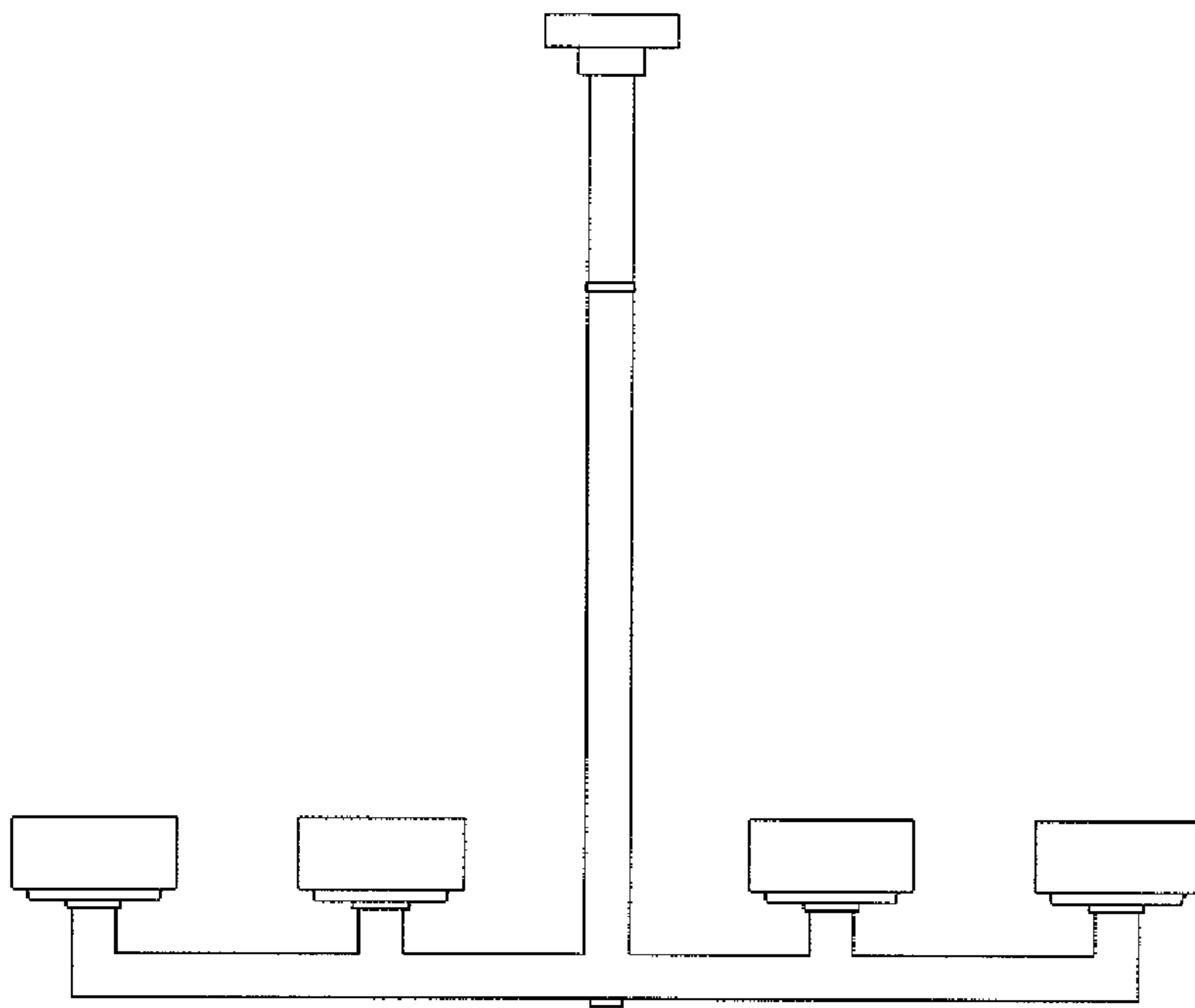

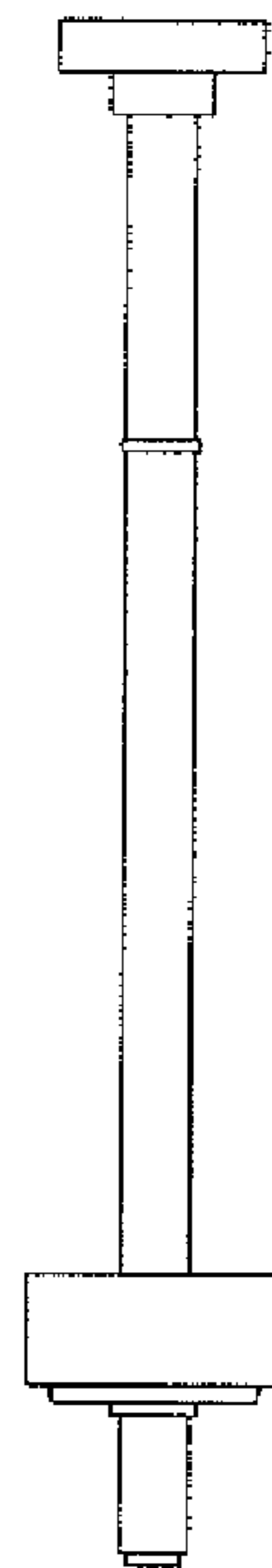

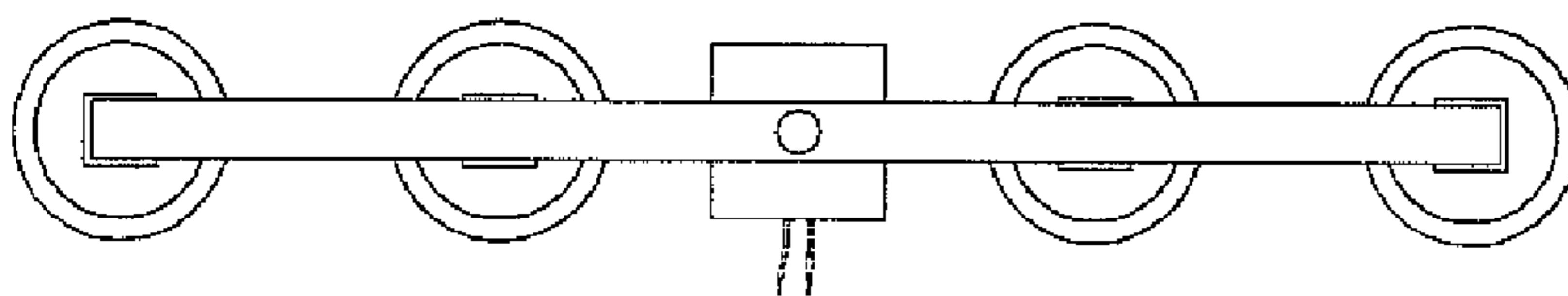
