(57) **CLAIM**

What is claimed is the ornamental design for a neck wrap, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a neck wrap, illustrated in a flat configuration, showing the new design;

FIG. 2 is a front elevational view thereof, illustrated in the flat configuration;

FIG. 3 is a rear elevational view thereof, illustrated in the flat configuration;

FIG. 4 is a left-side elevational view thereof;

FIG. 5 is a right-side elevational view thereof;

FIG. 6 is a top plan view thereof, illustrated in the flat configuration;

FIG. 7 is a bottom plan view thereof, illustrated in the flat configuration;

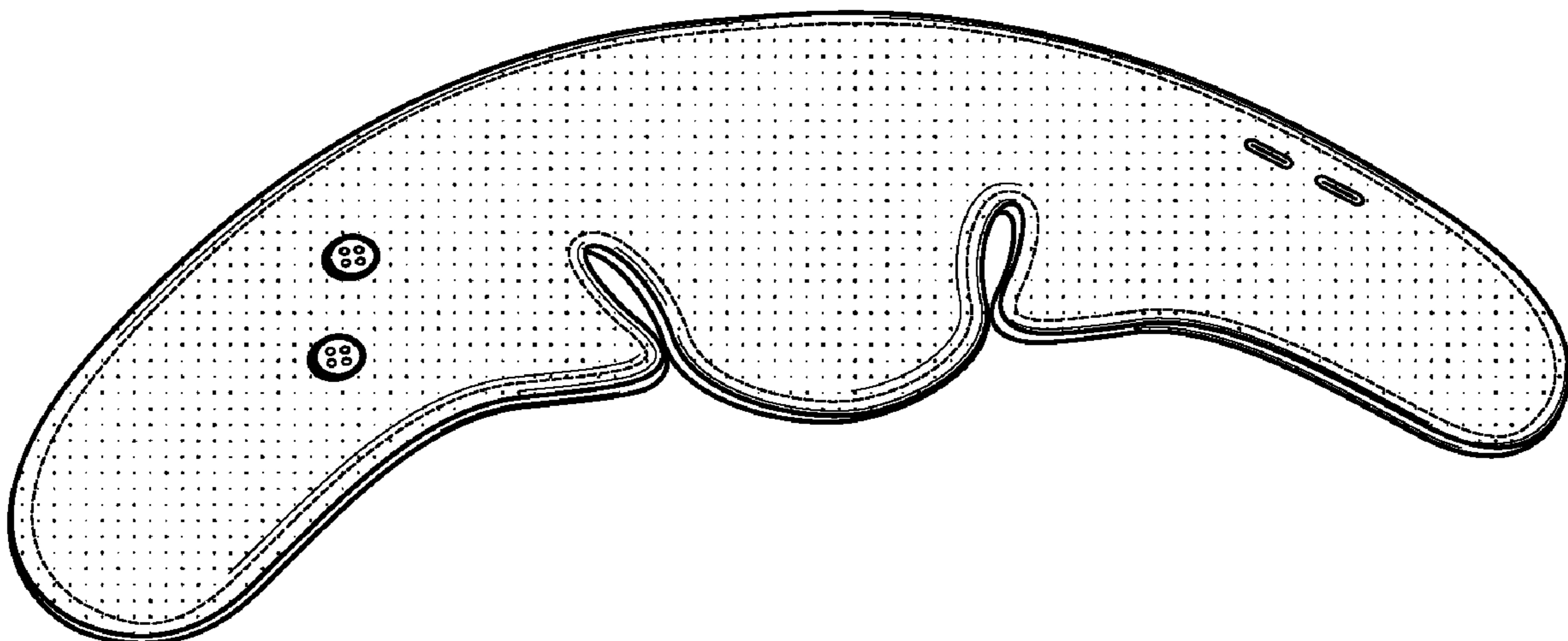
FIG. 8 is a front elevational view thereof, illustrated in a worn configuration; and,

FIG. 9 is a right-side elevational view thereof, illustrated in the worn configuration.

The broken lines showing a person in FIGS. 7 and 8 are included for the purpose of illustrating the invention in use, and form no part of the claimed design. The top plan view, bottom plan view, and left-side elevational view of the design in the worn configuration are readily derived from the corresponding views of the design in the flat configuration.

The surface patterns shown throughout the figures are used to convey a contrast in color. The patterns do not represent specific colors.

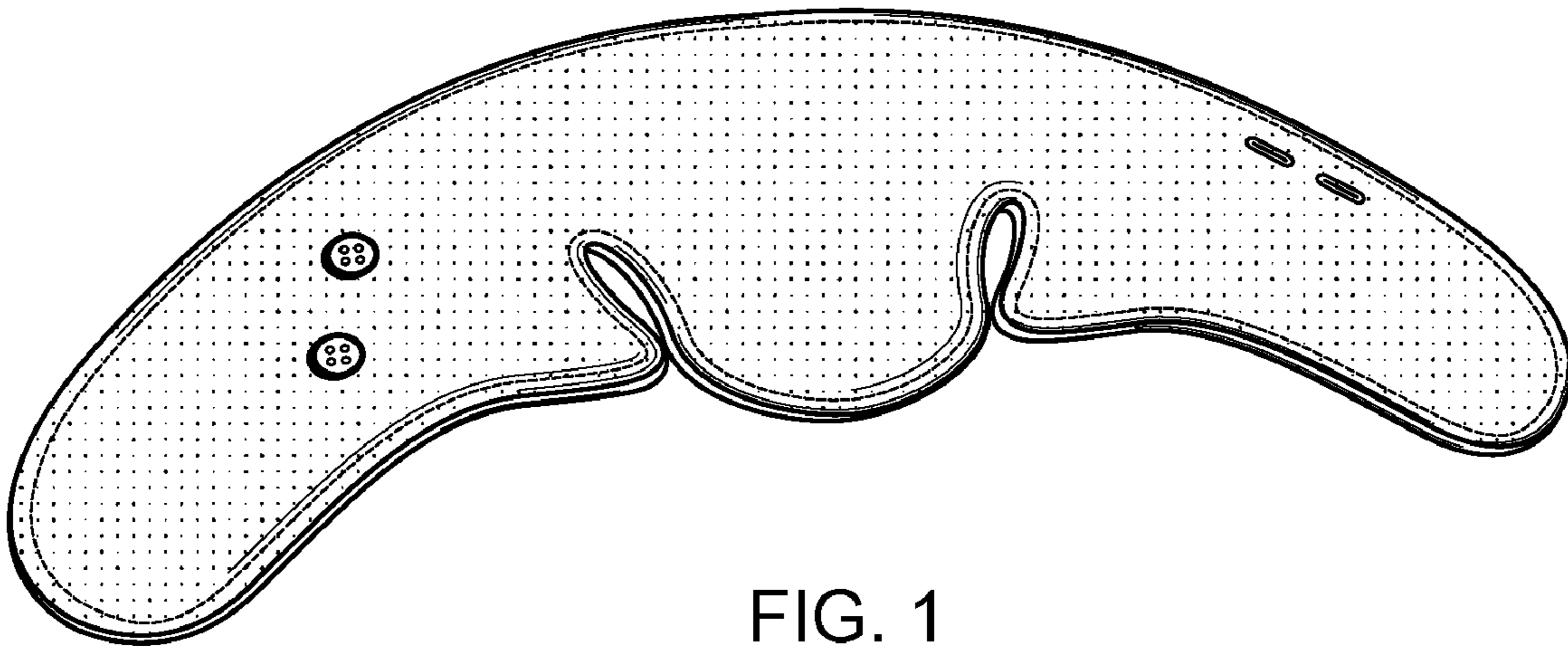

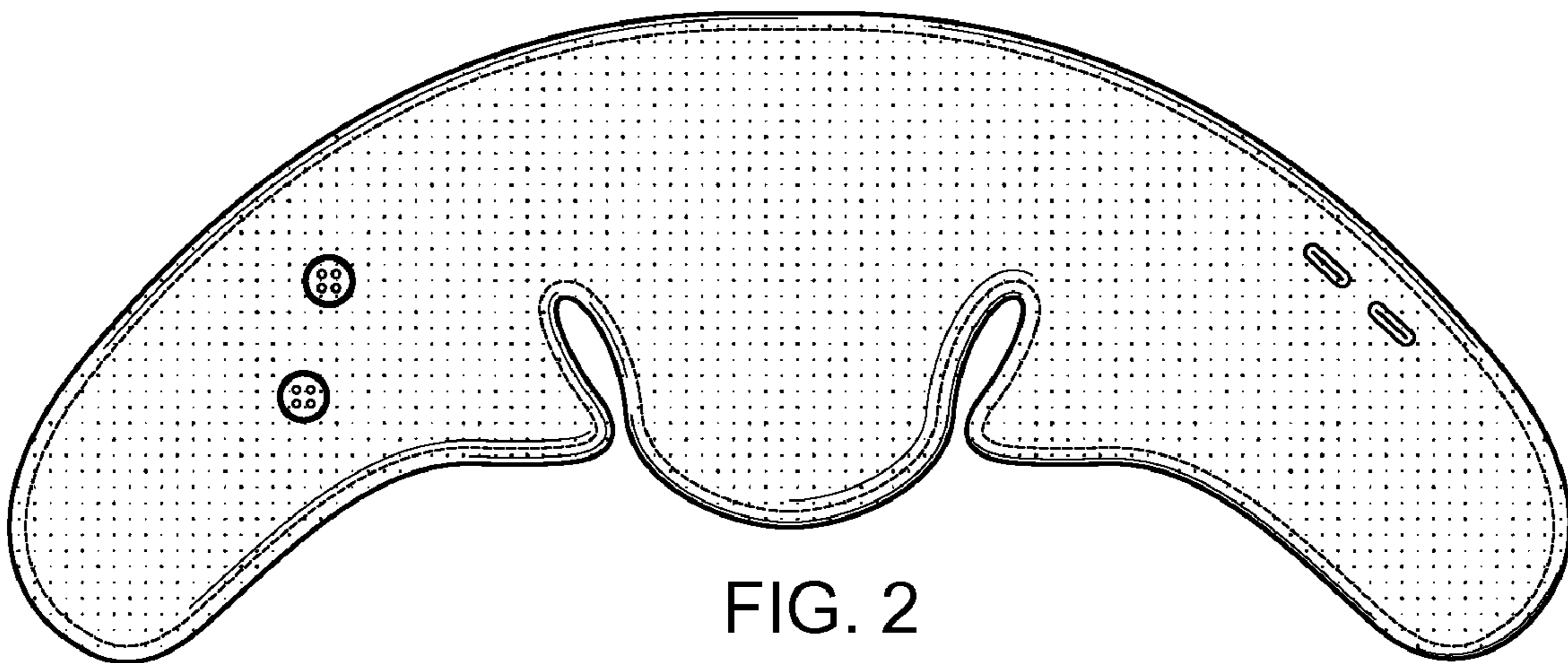

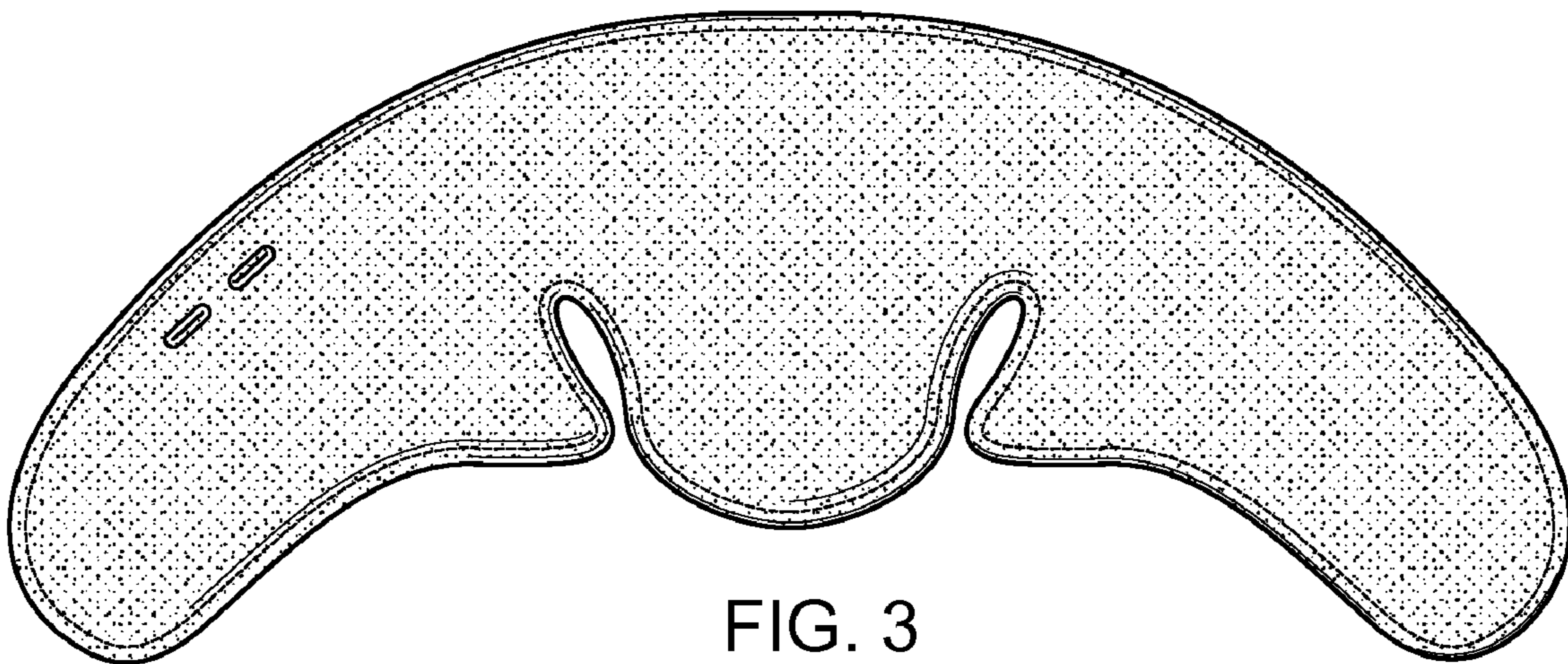

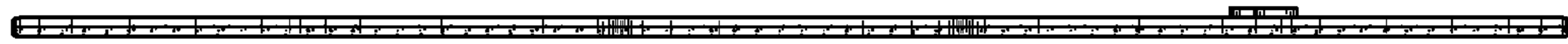

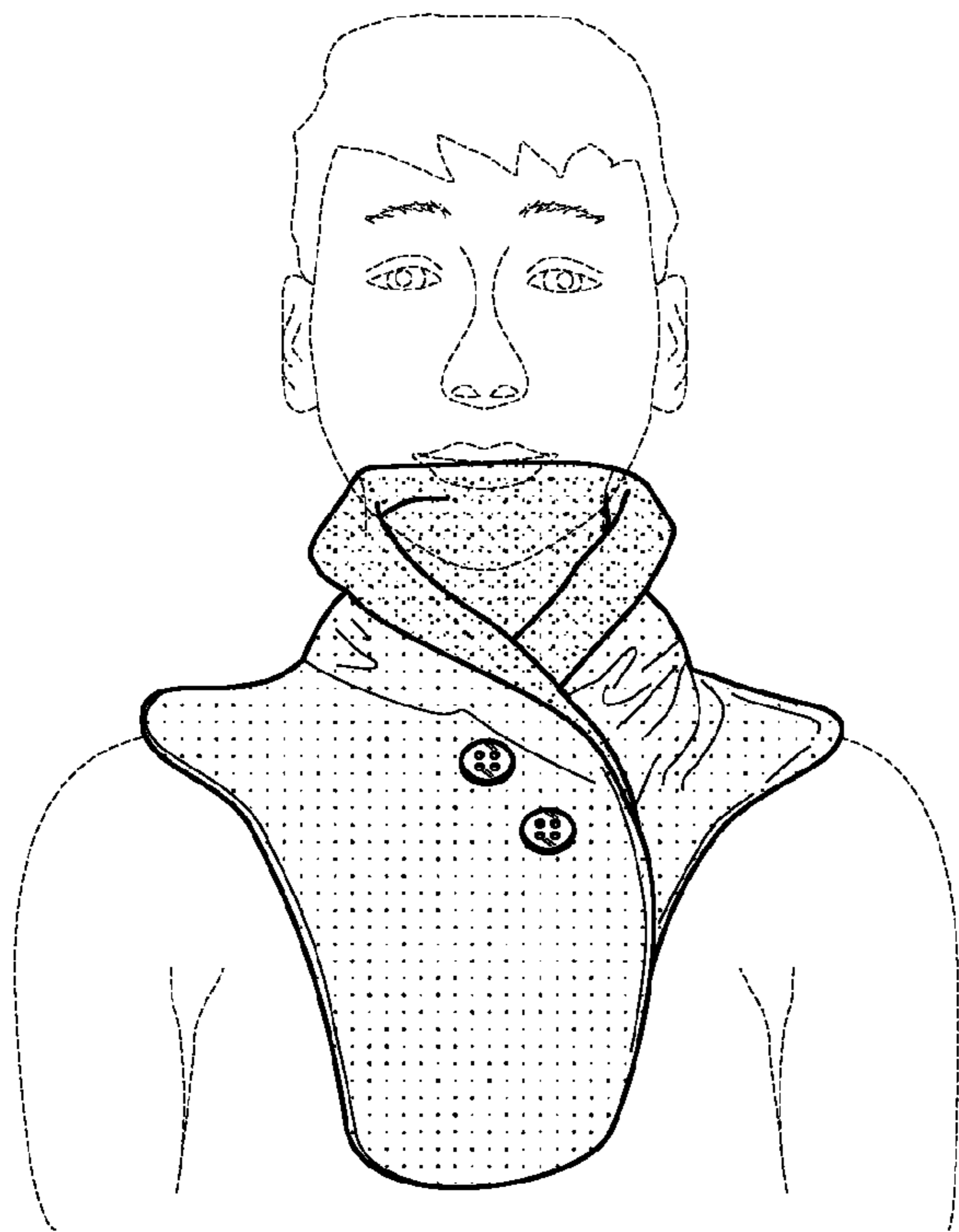

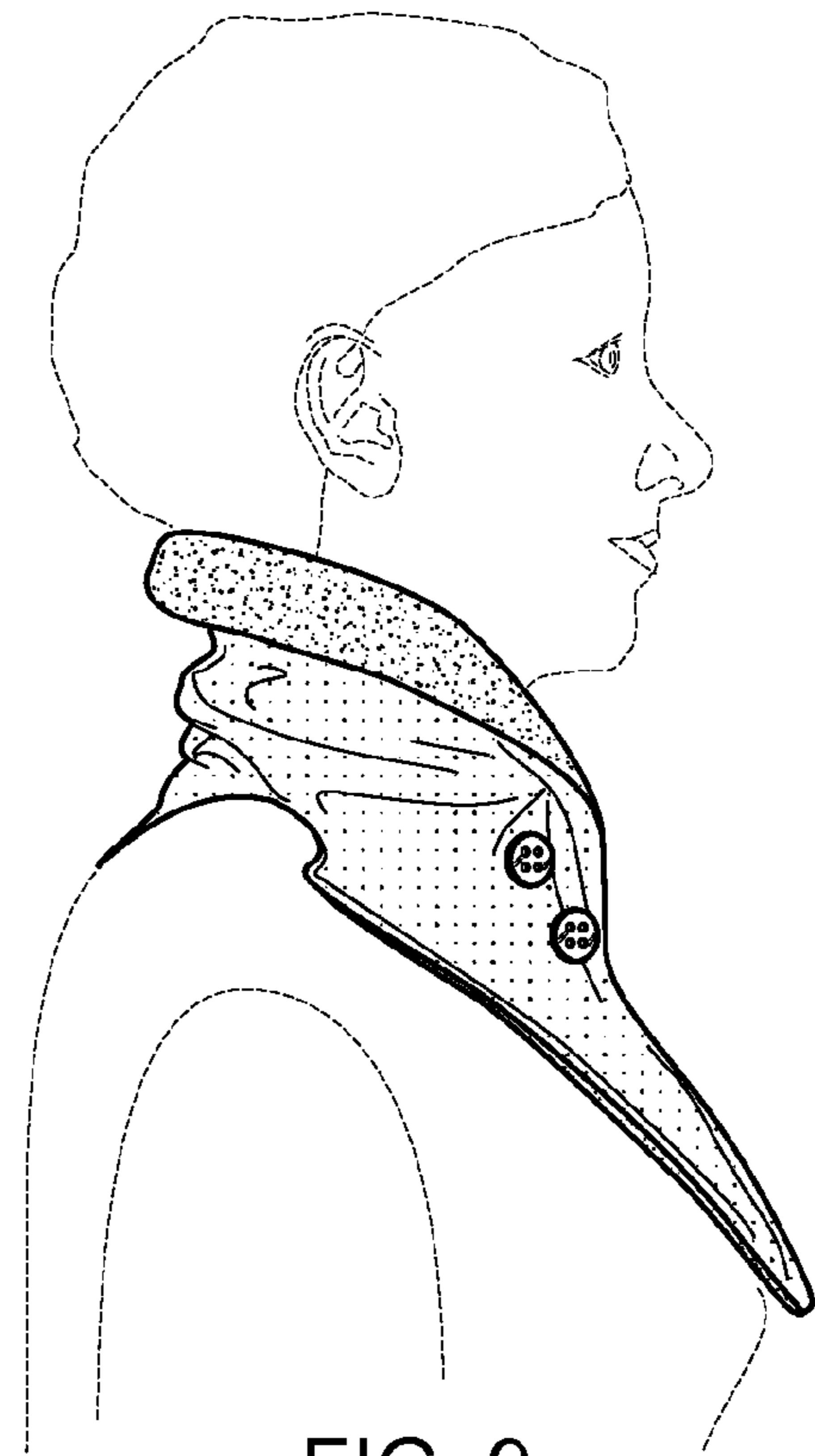
