FIG. 1 is a perspective view showing my new design, of a first embodiment, of a cap with peak offset approximately 45 degrees to the right of the front position.

FIG. 2 is a front elevational view thereof;

FIG. 5 is a rear elevational view thereof;

FIG. 6 is a top elevational view thereof;

FIG. 7 is a bottom elevational view thereof;

FIG. 8 is a perspective view showing my new design, of a second embodiment, of a cap with peak offset approximately 45 degrees to the left of the front position.

FIG. 9 is a front elevational view thereof;

FIG. 10 is a left side elevational view thereof;

FIG. 11 is a right side elevational view thereof;

FIG. 12 is a rear elevational view thereof;

FIG. 13 is a top elevational view thereof; and,

FIG. 14 is a bottom elevational view thereof.

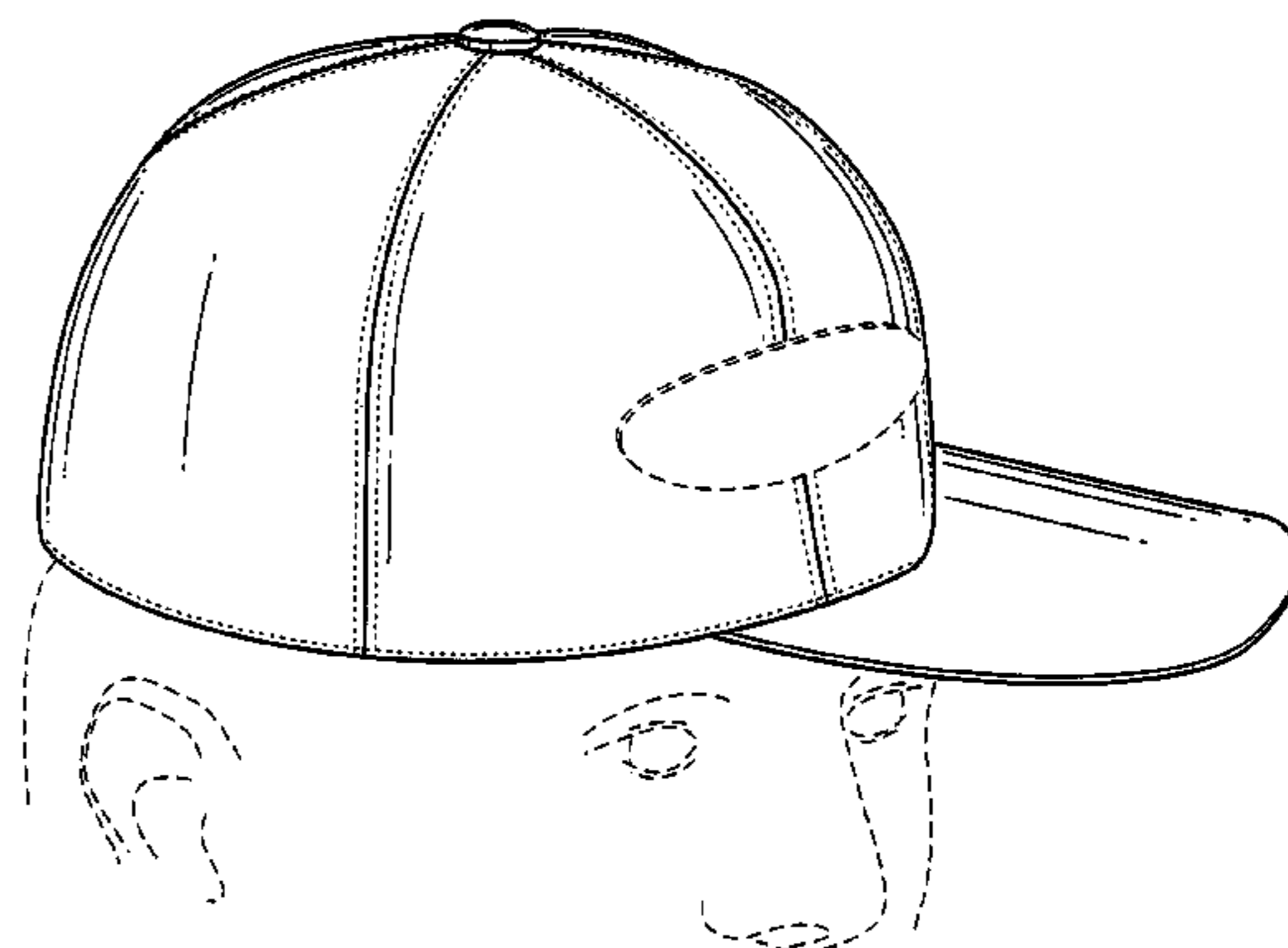
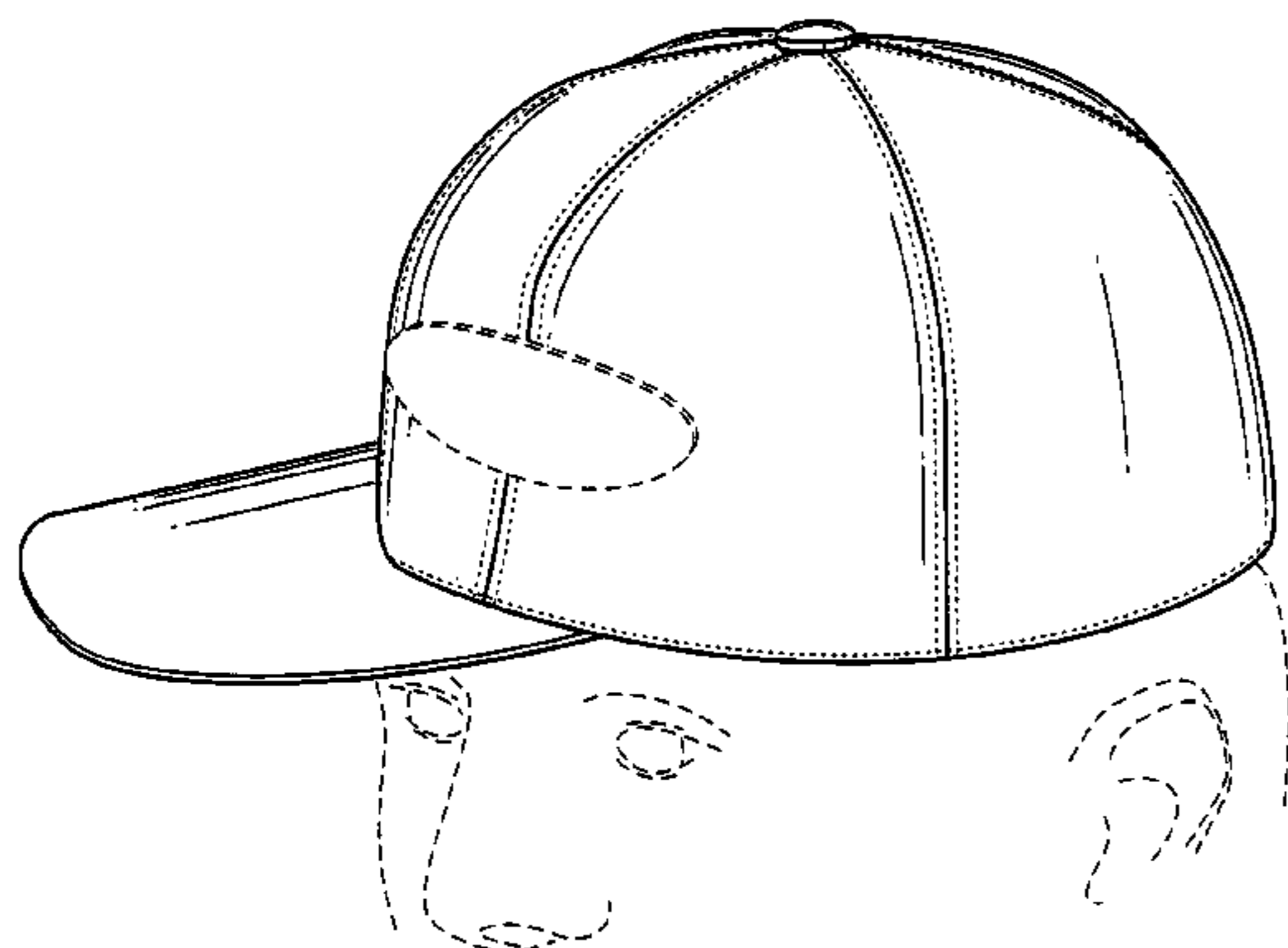

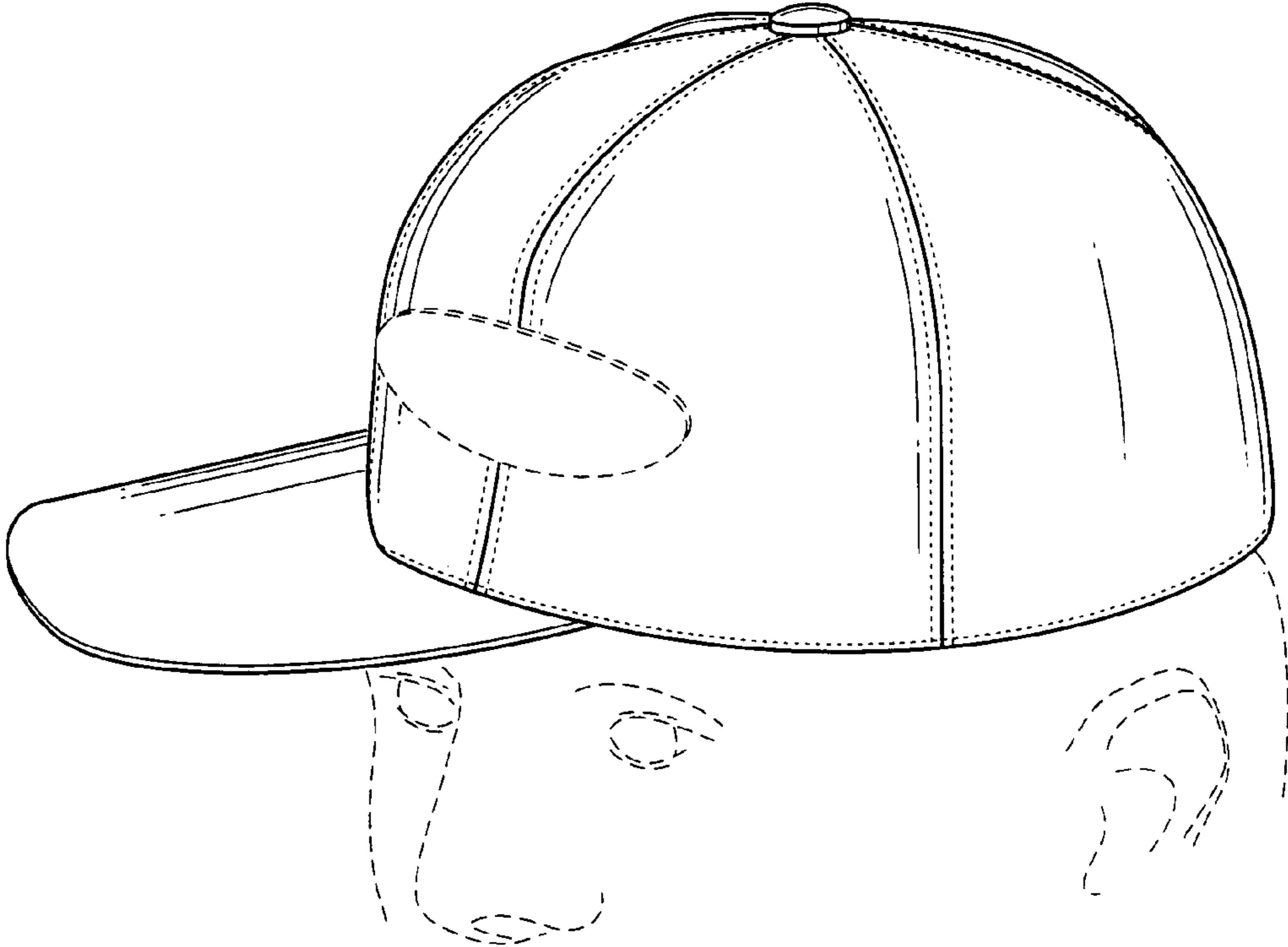

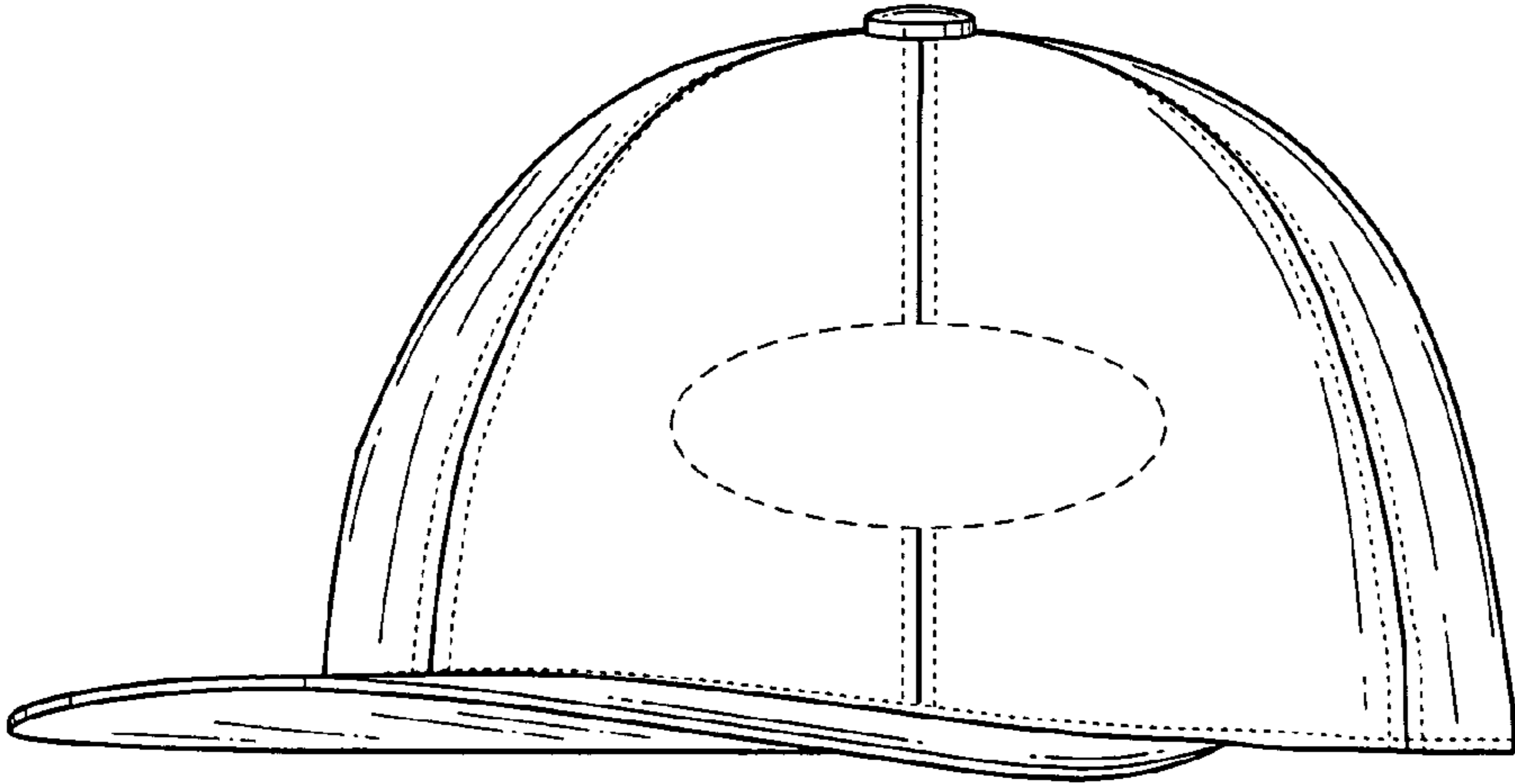

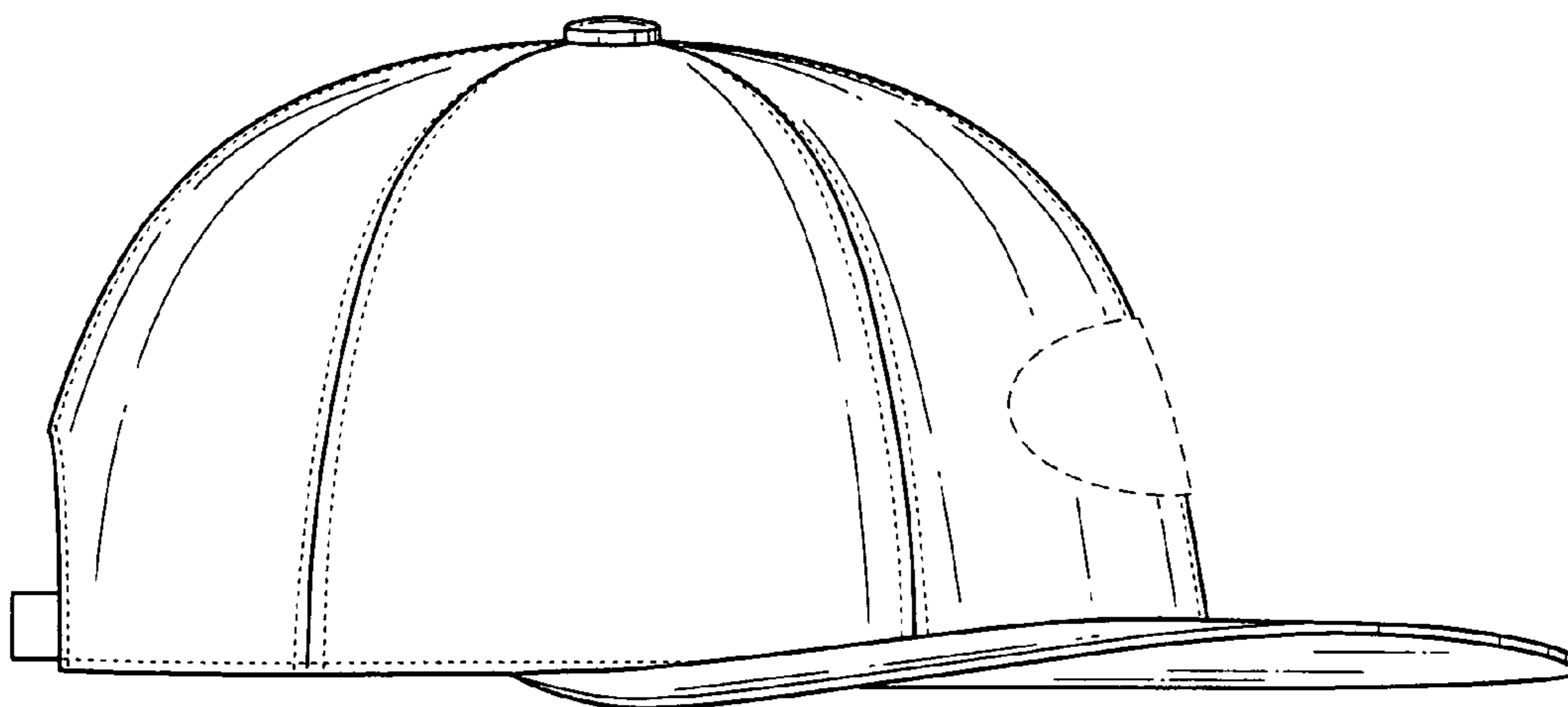

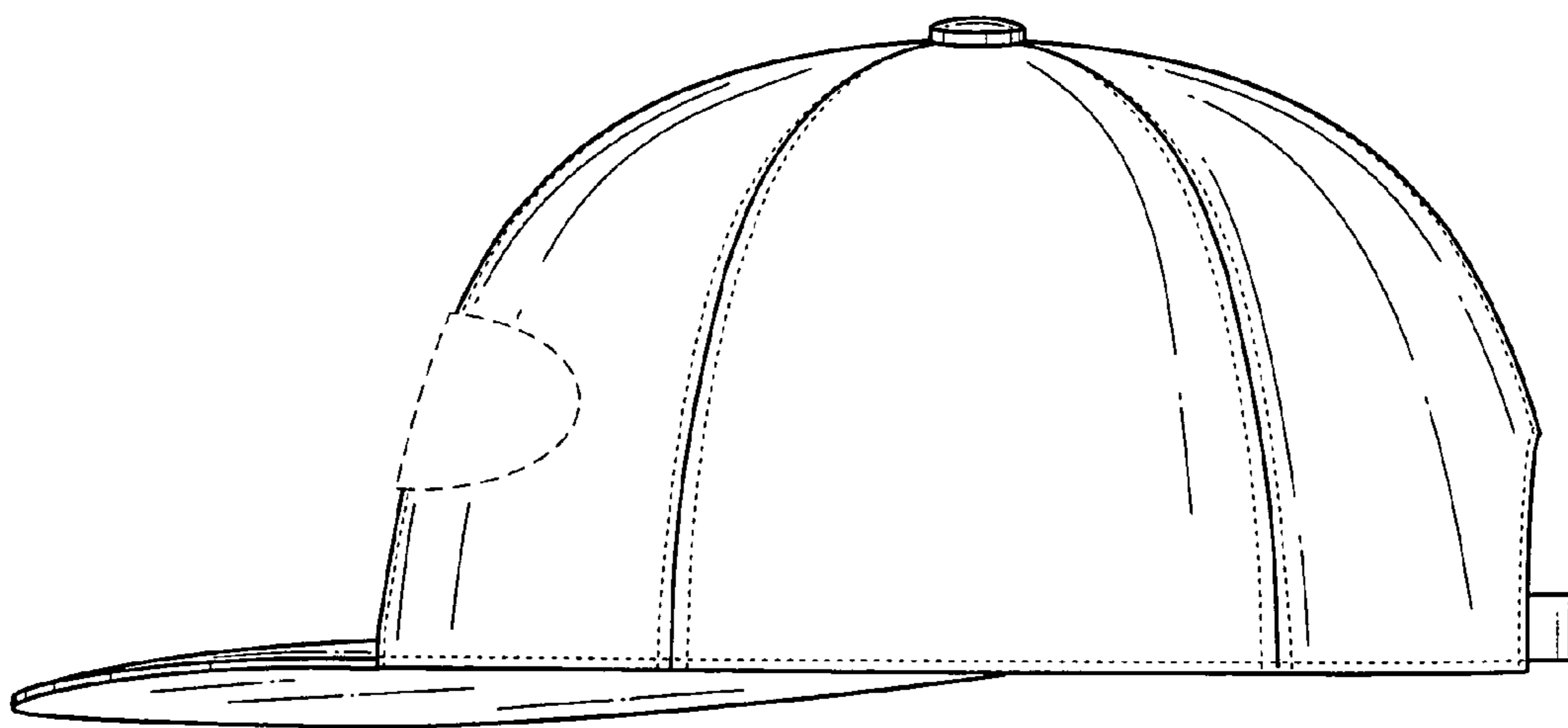

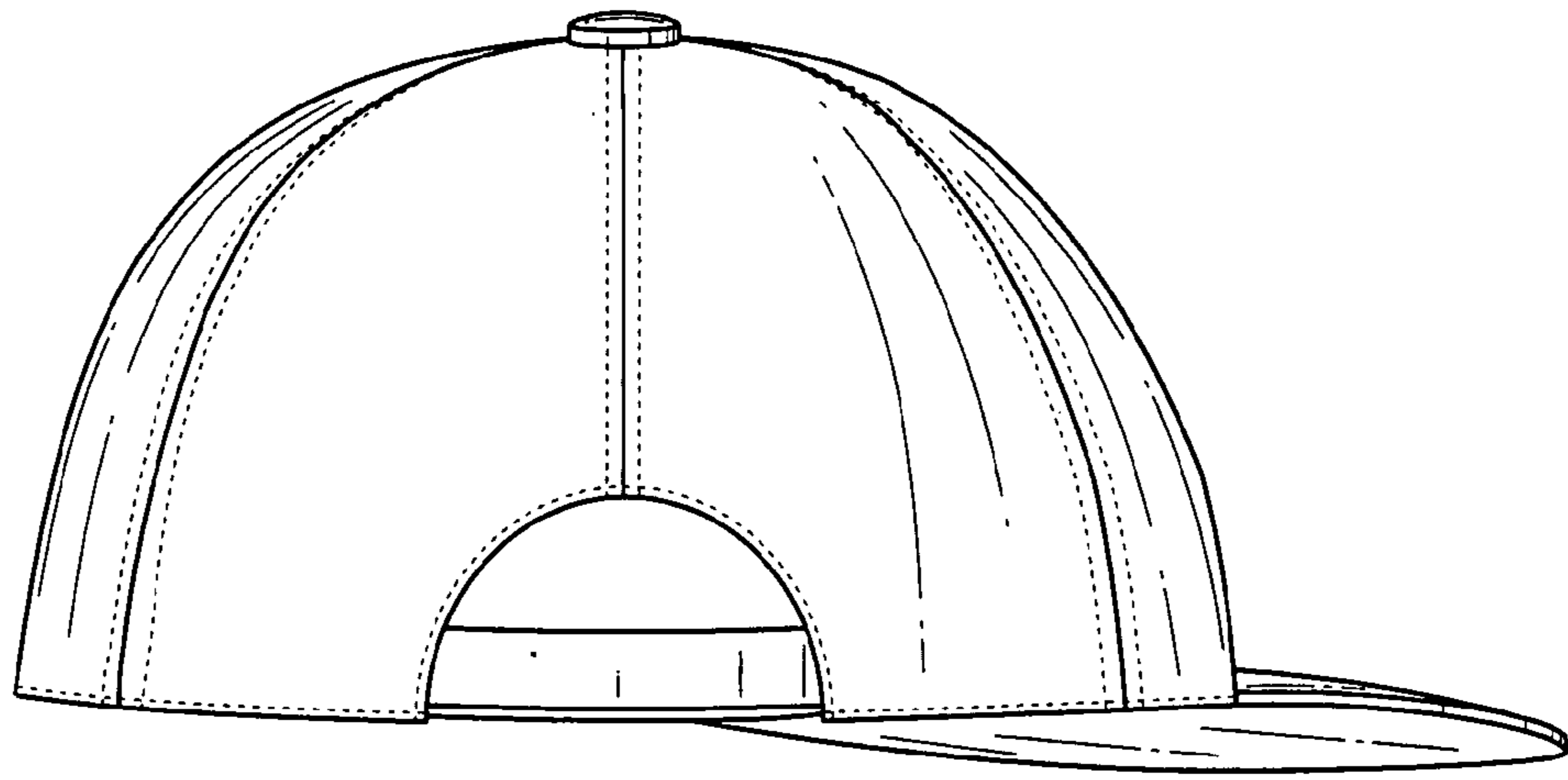

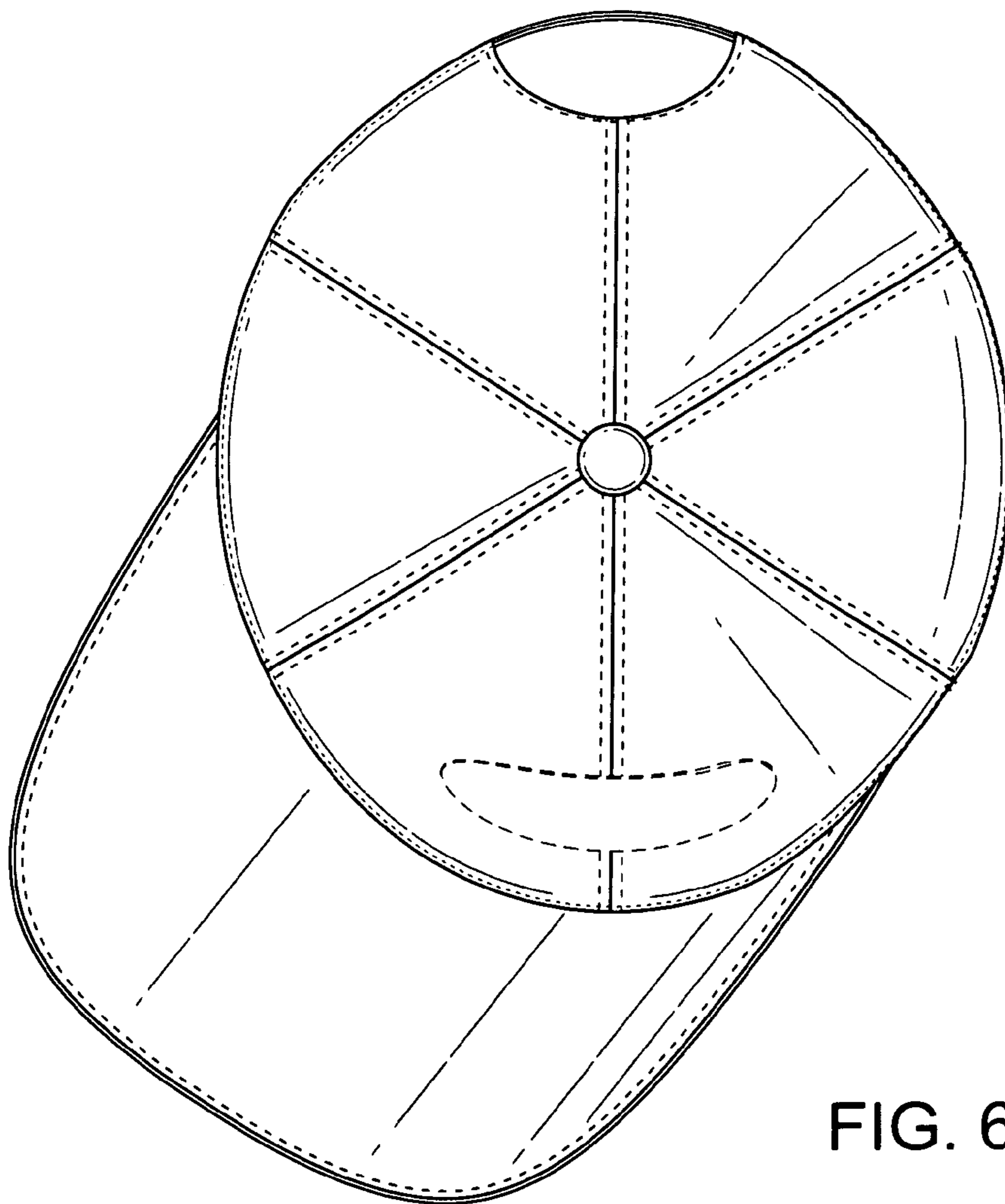

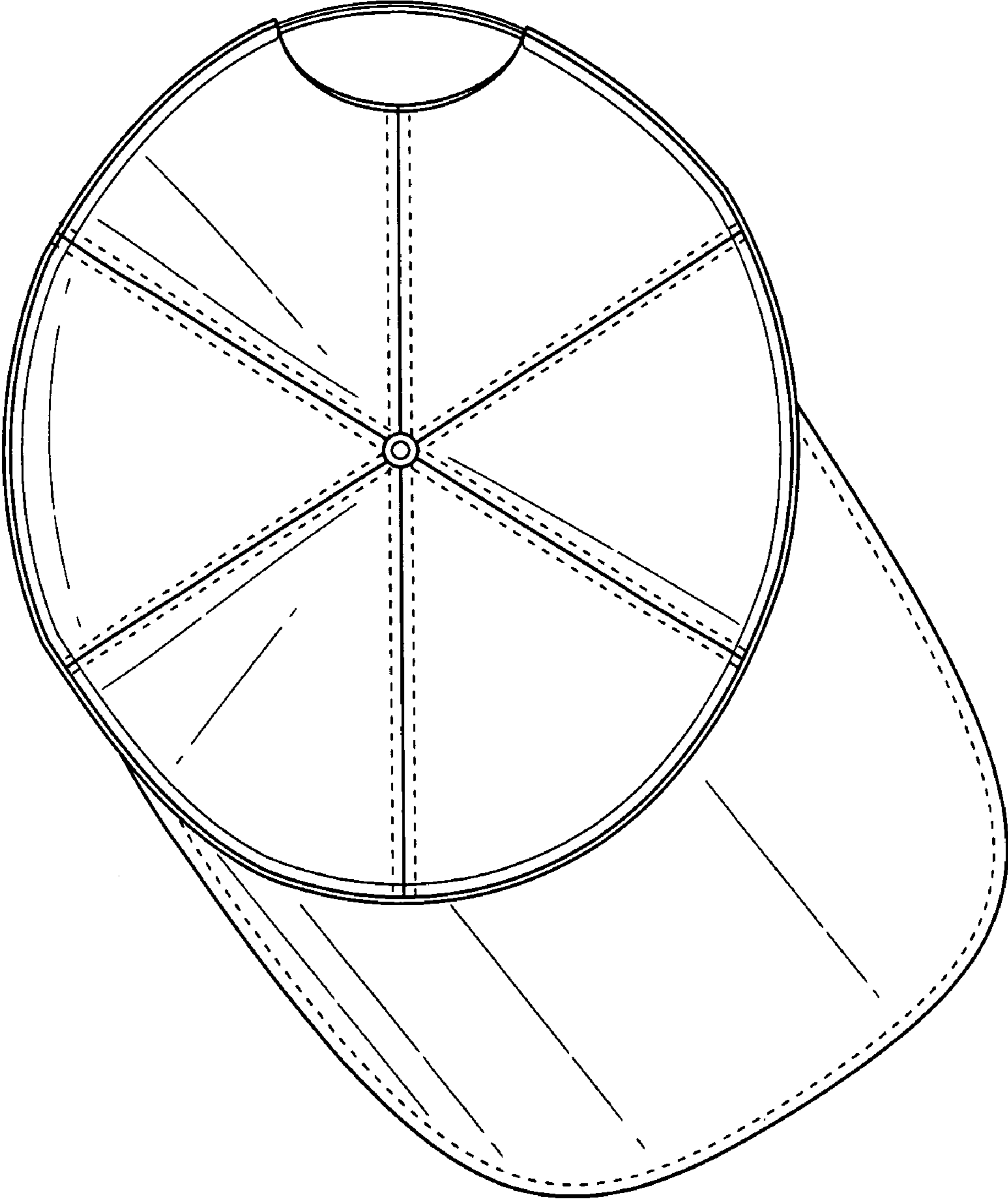

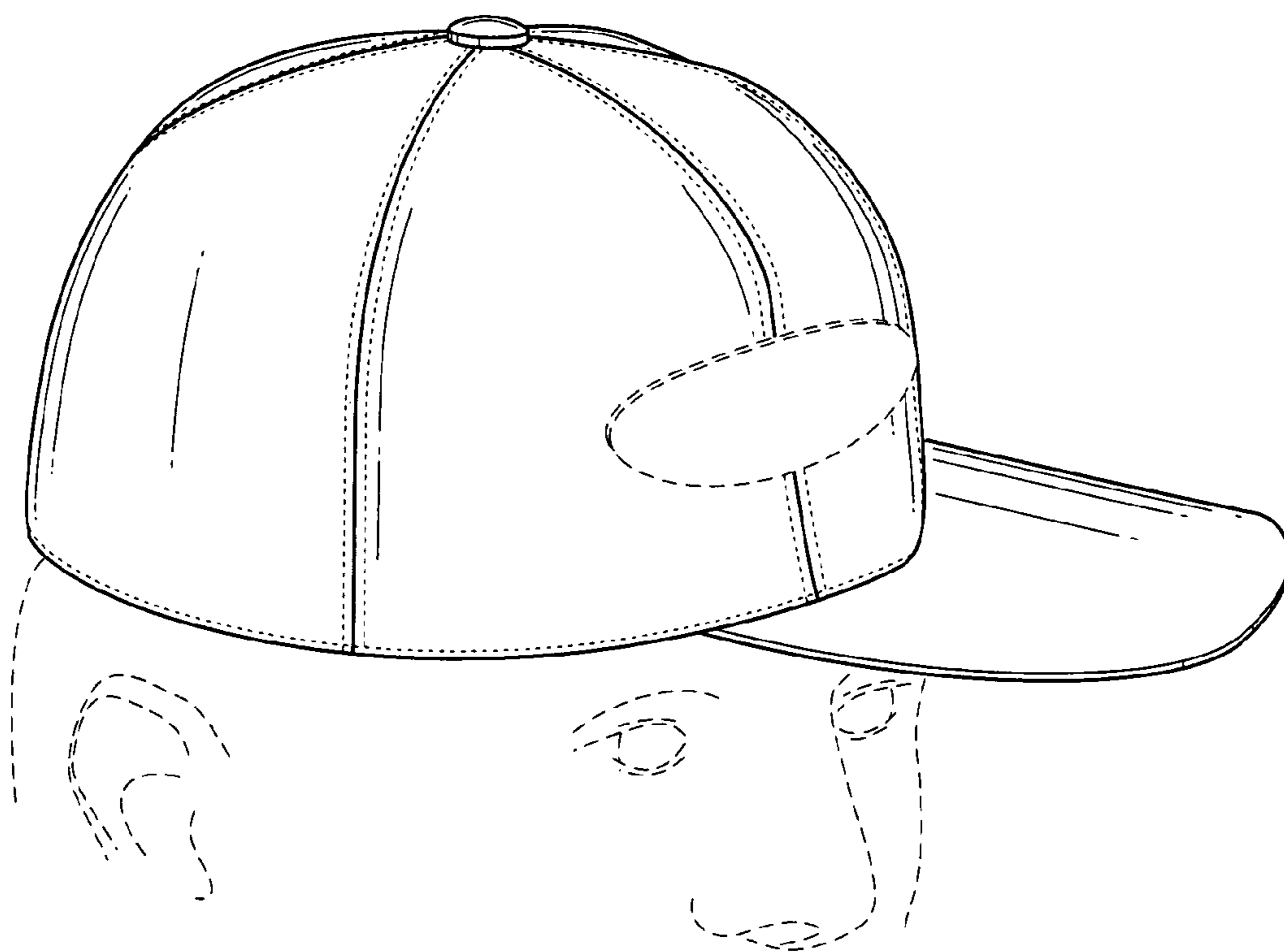

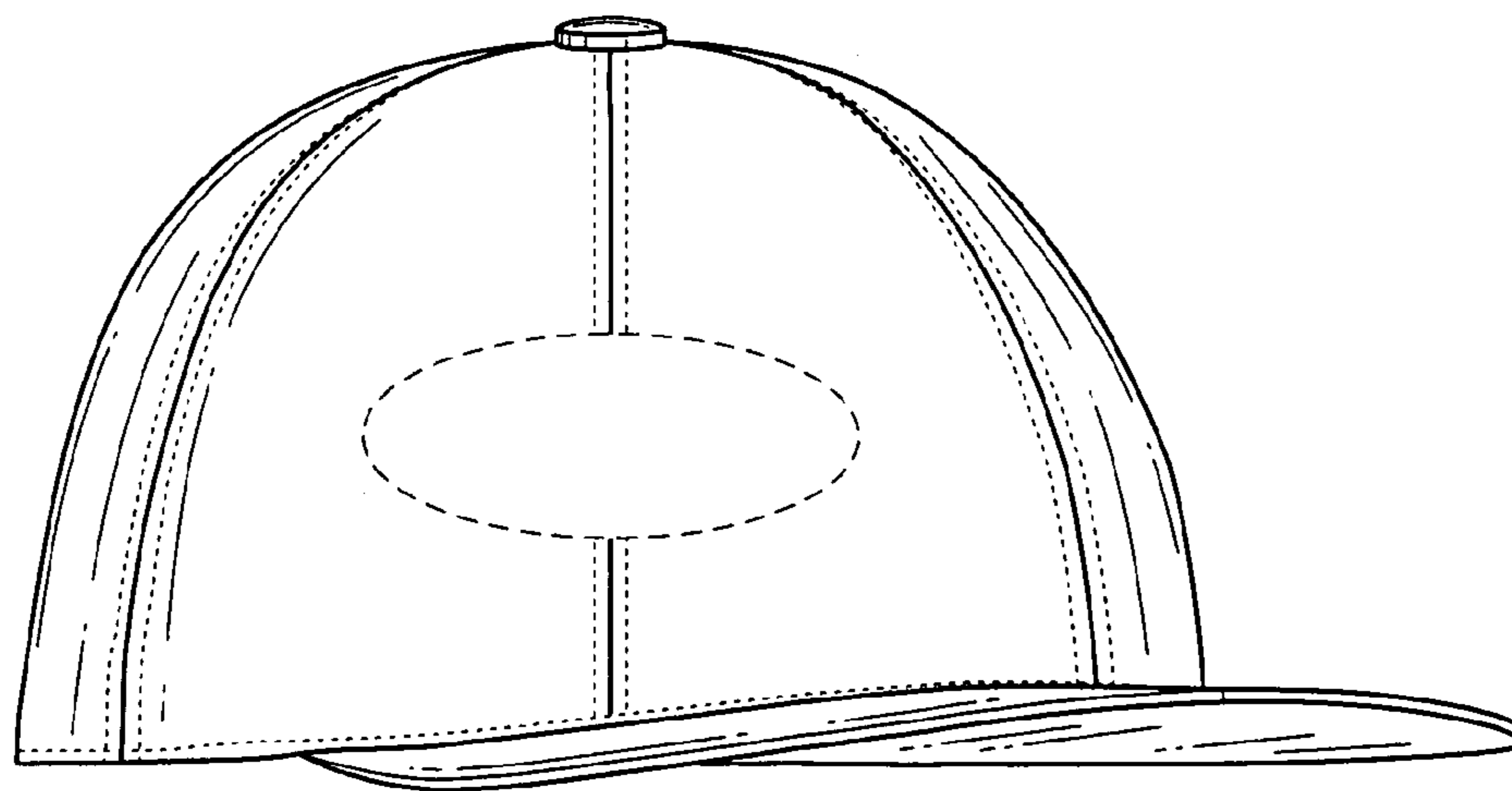

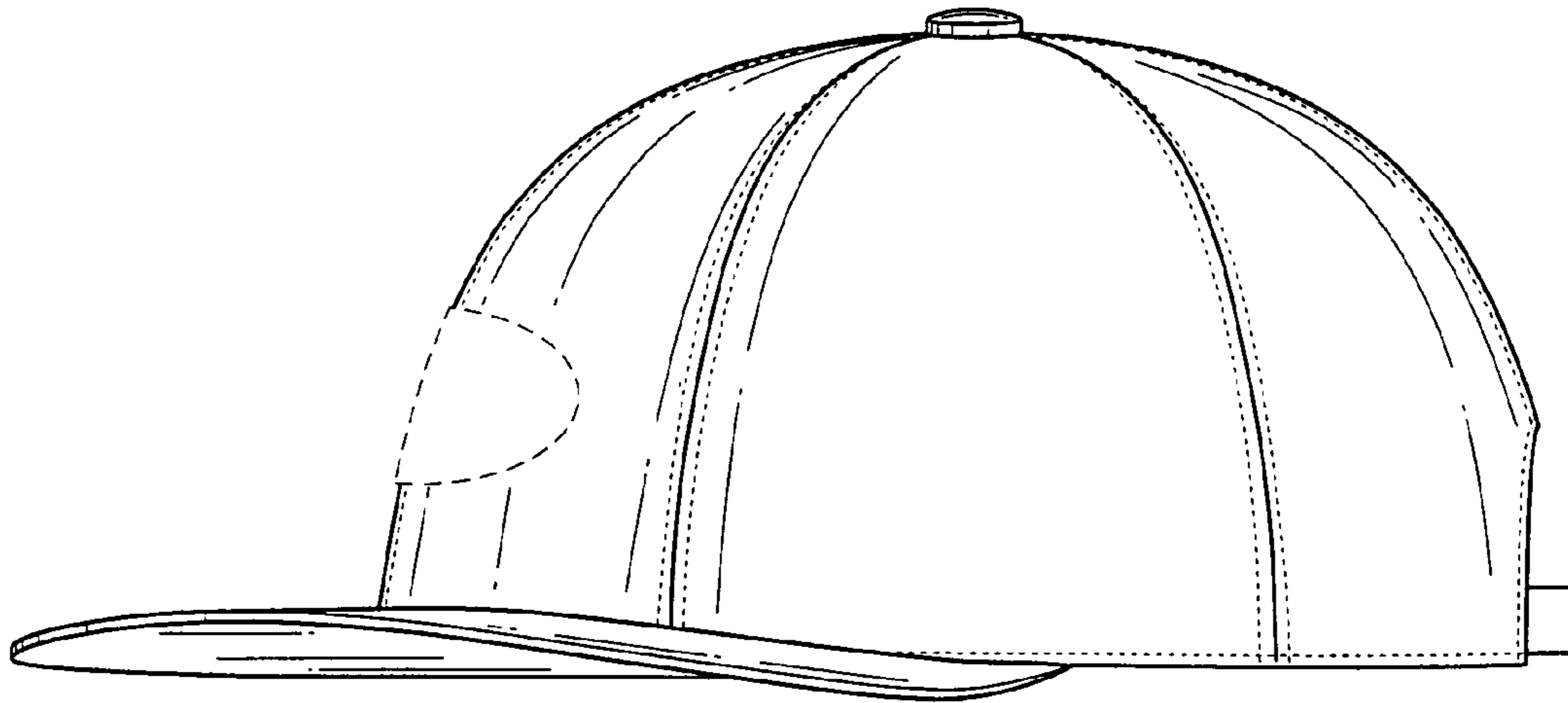

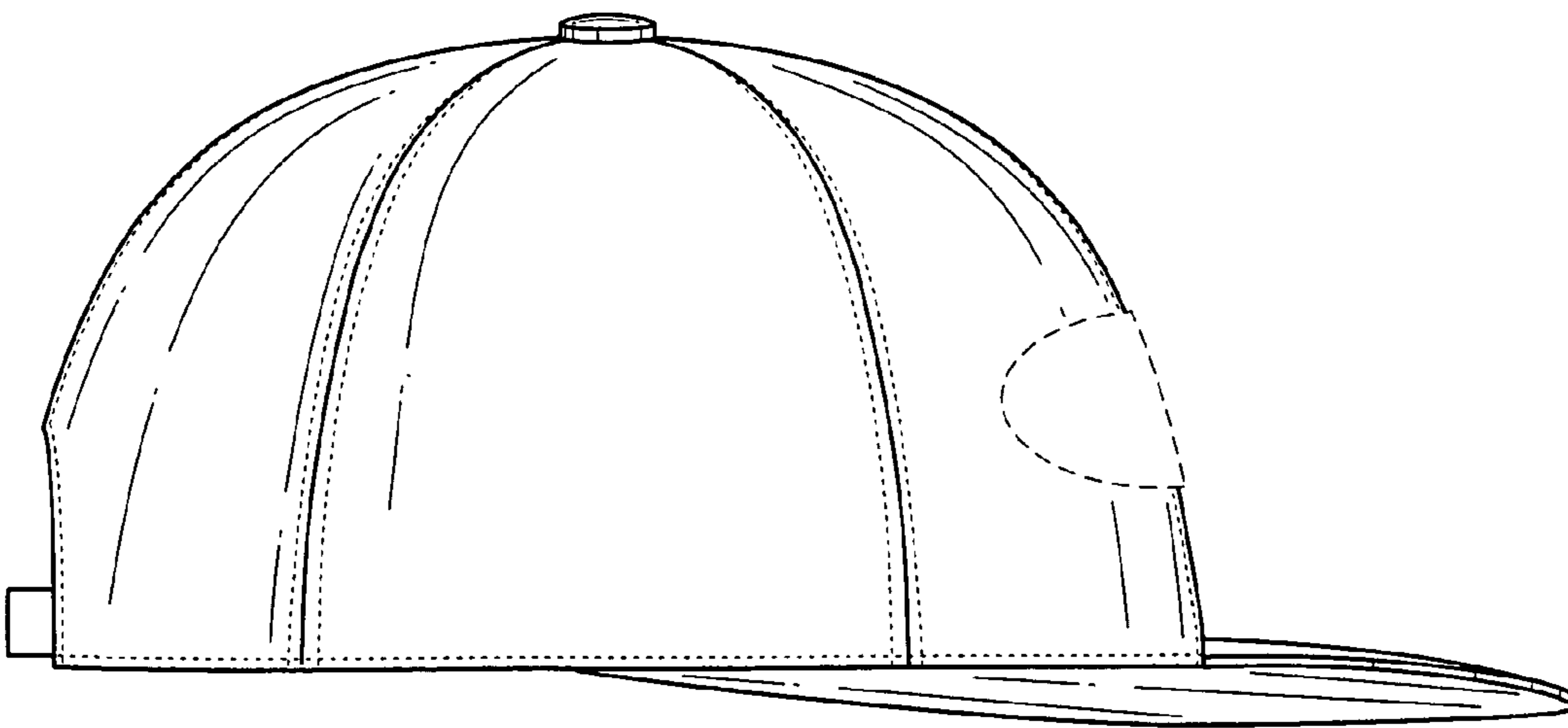

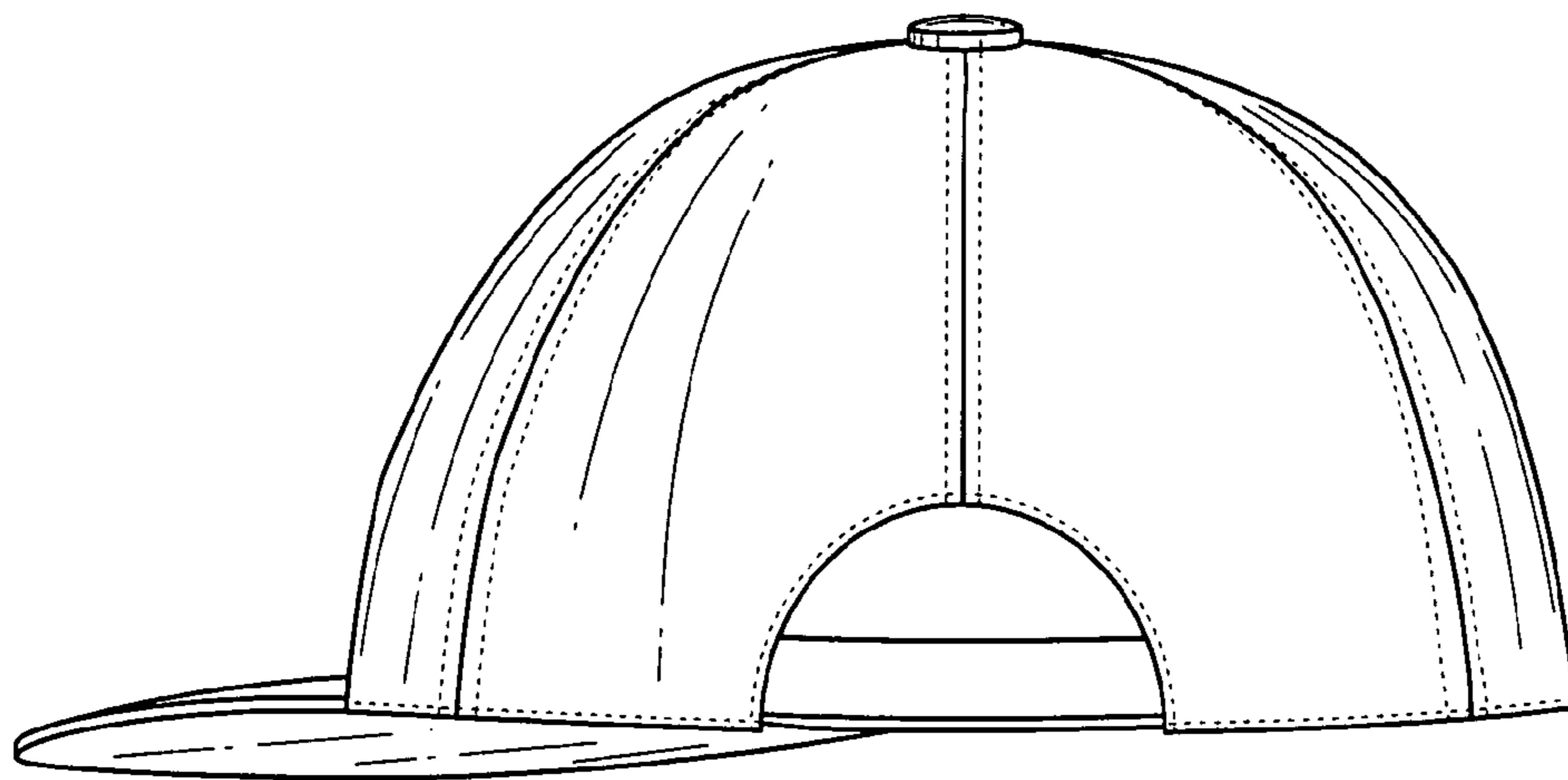

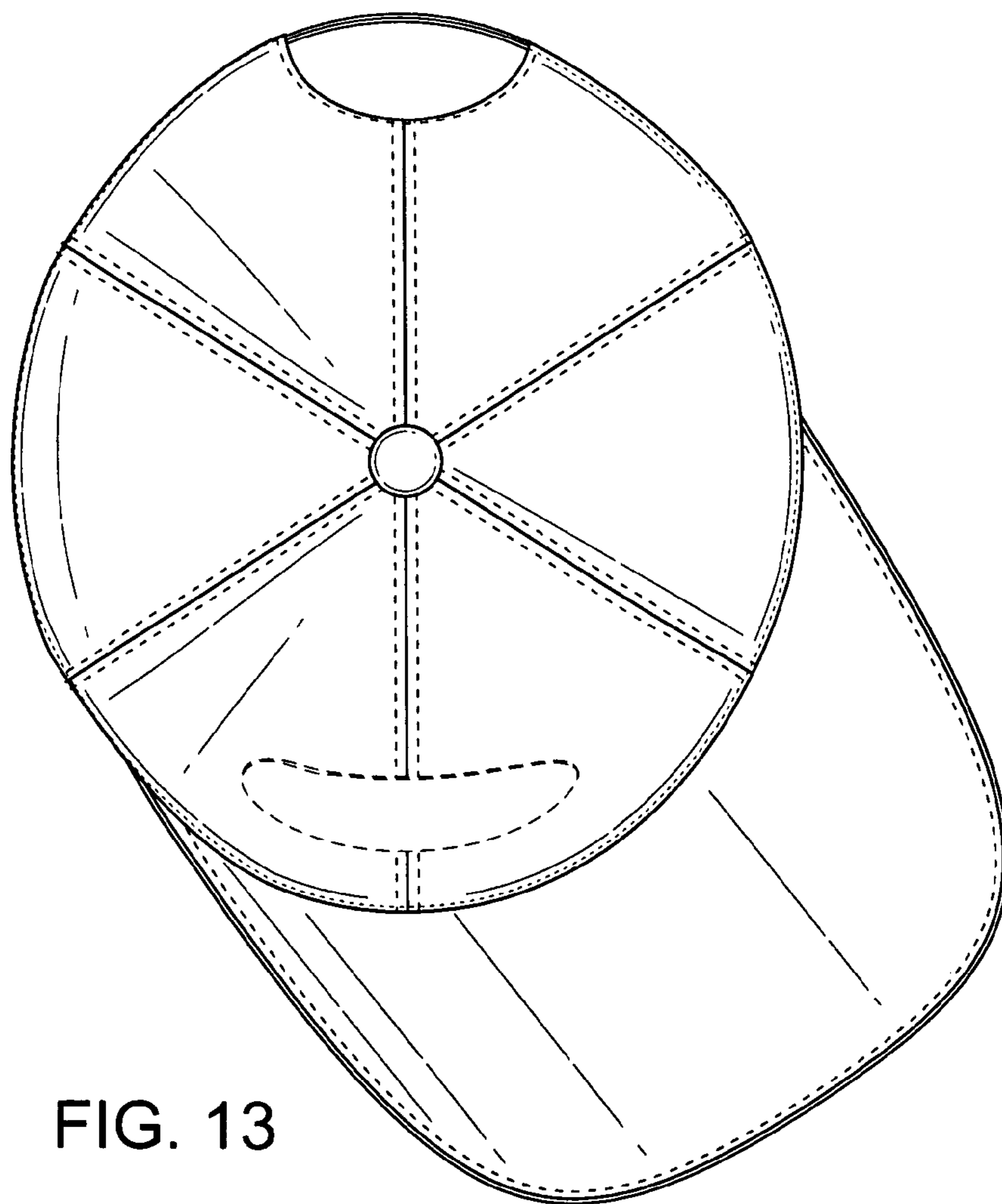

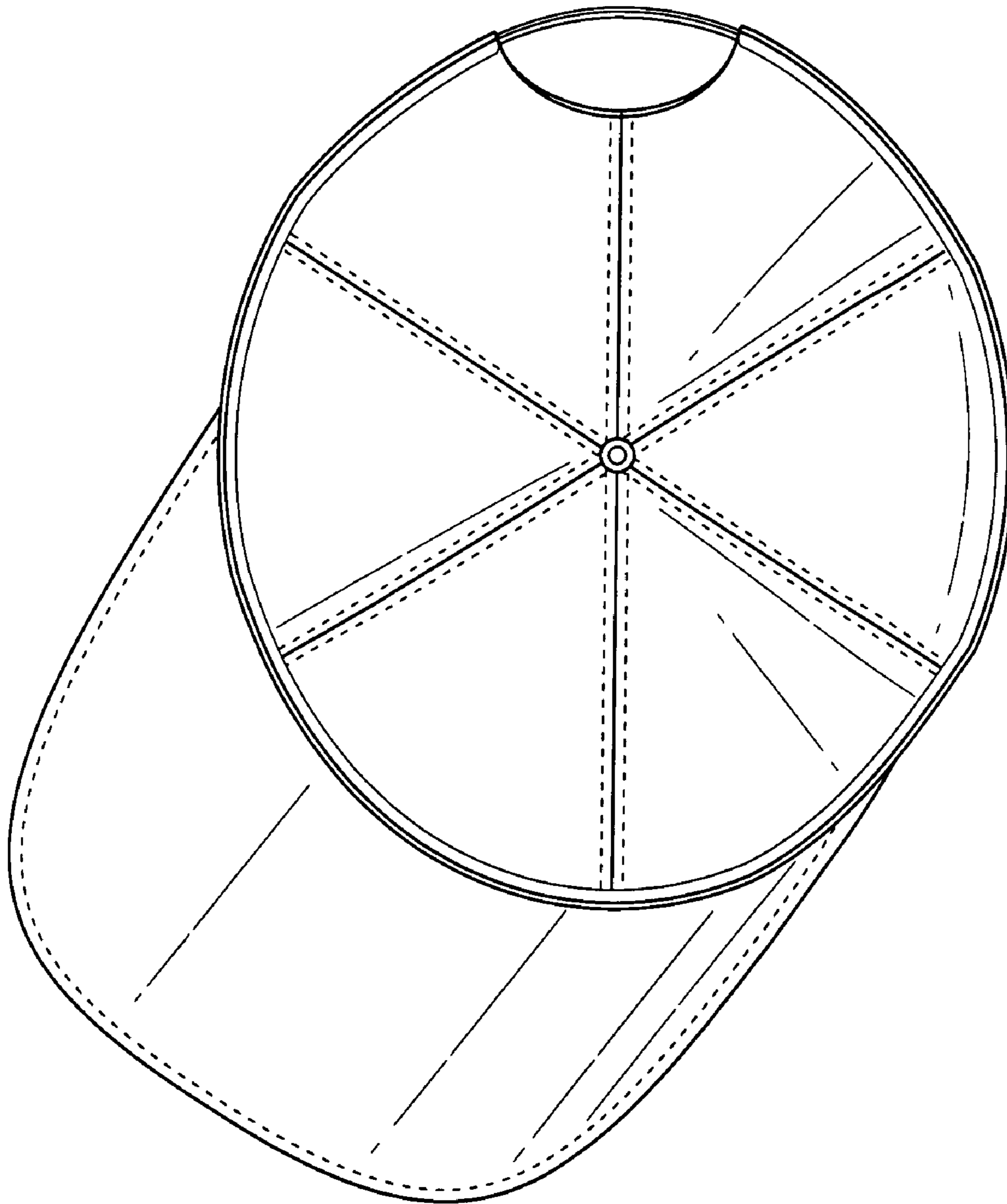
