FIG. 3 is a rear view thereof,

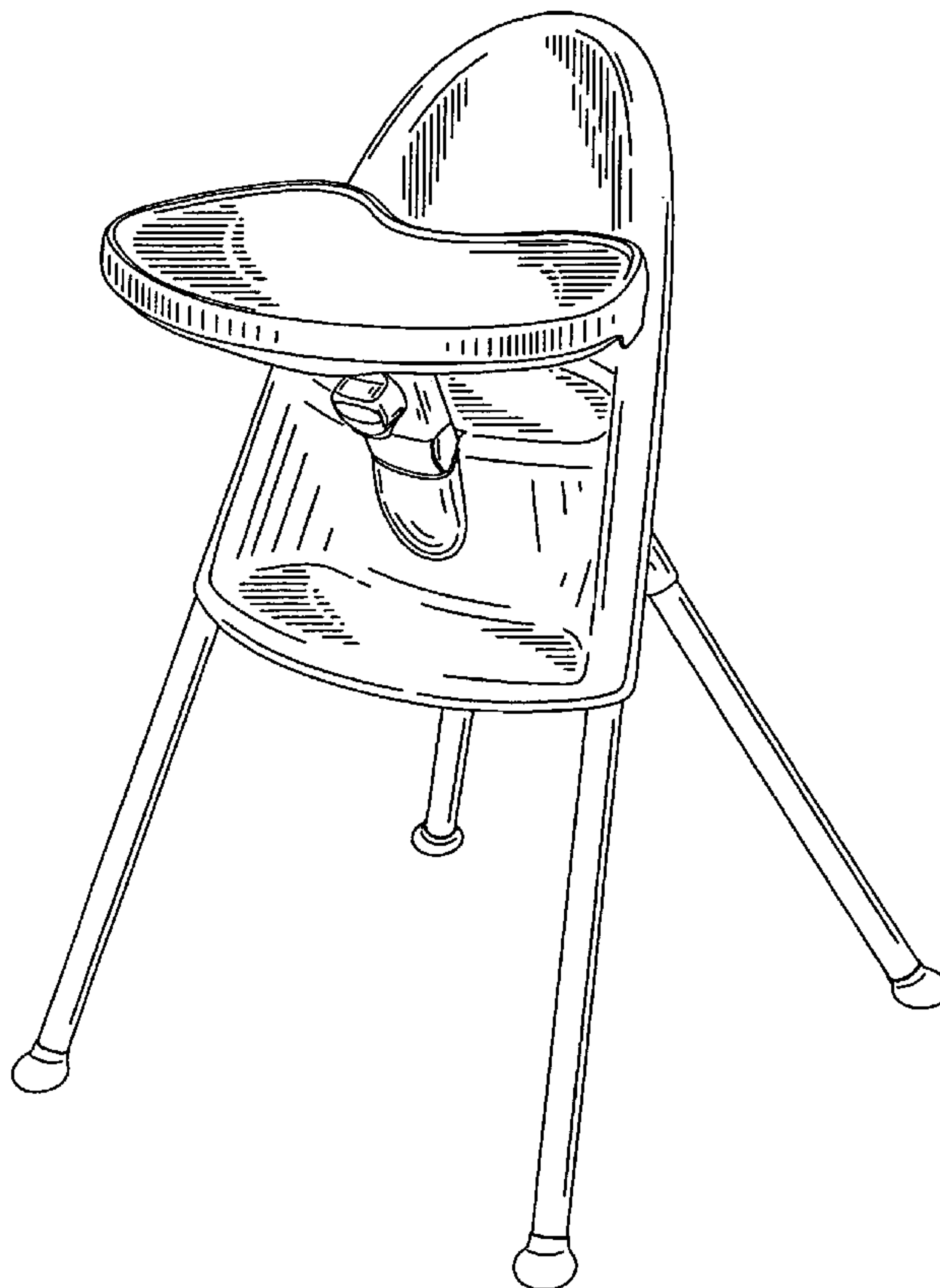
FIG. 4 is a left side view thereof, the right side being a mirror image,

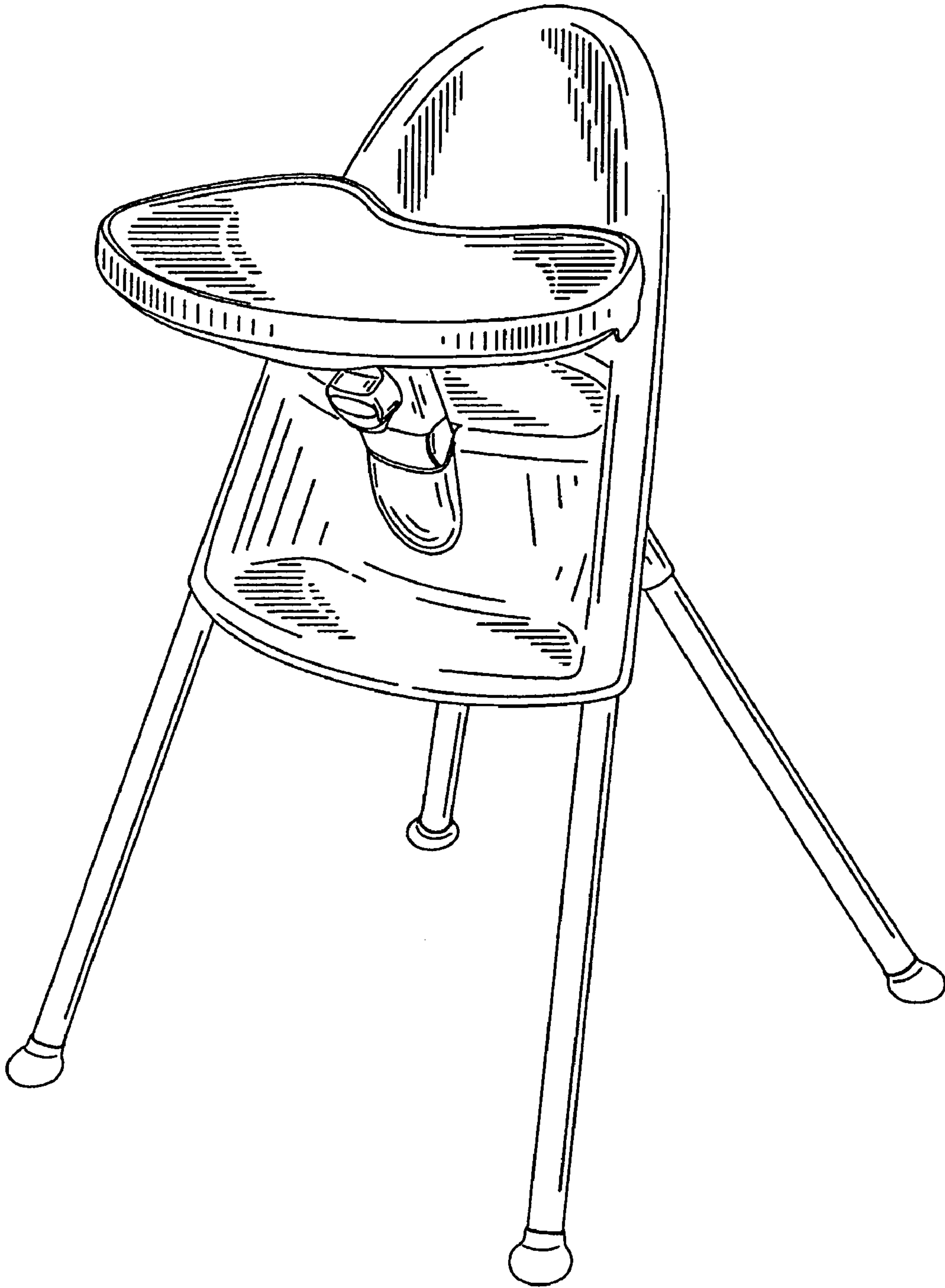

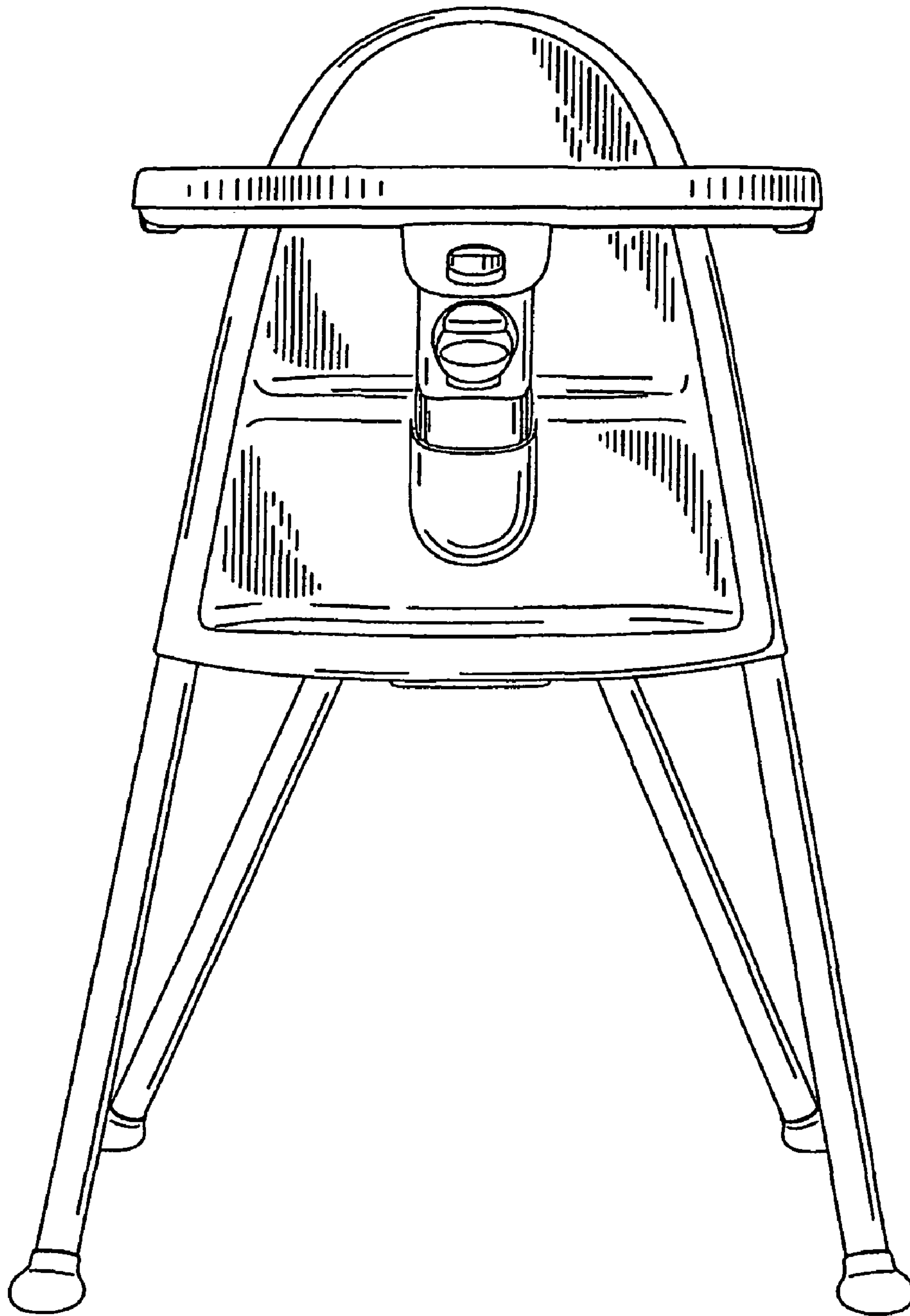

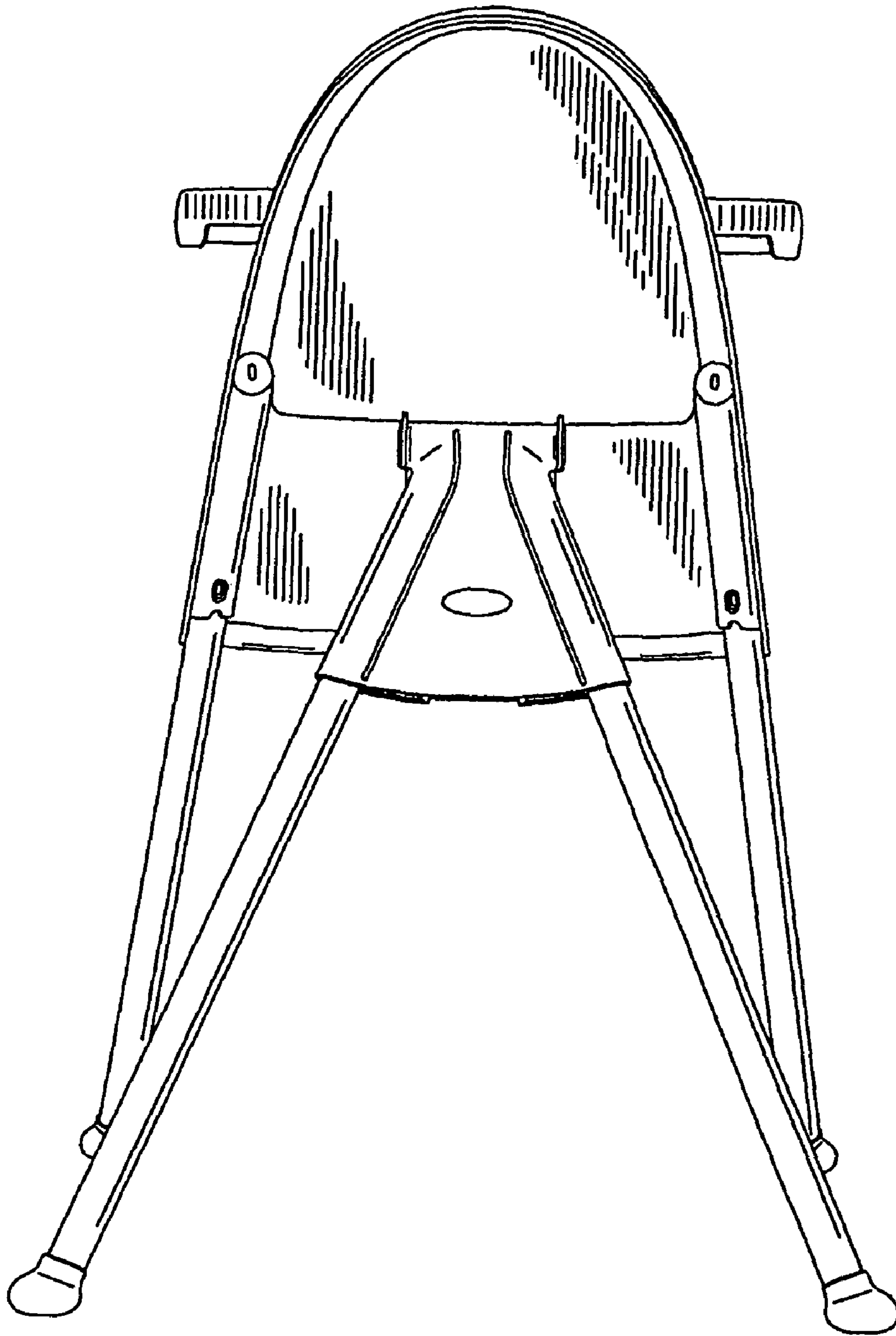

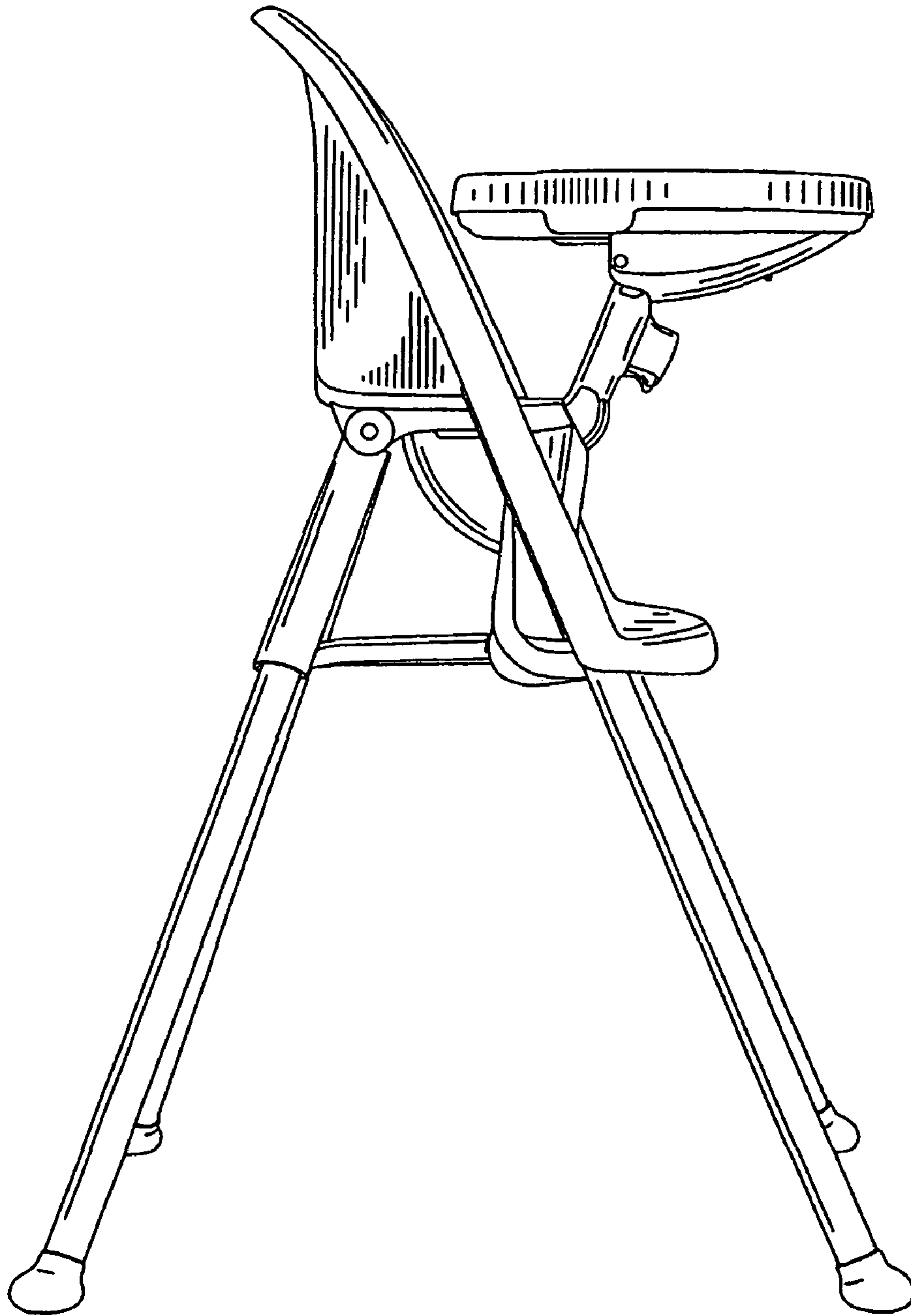

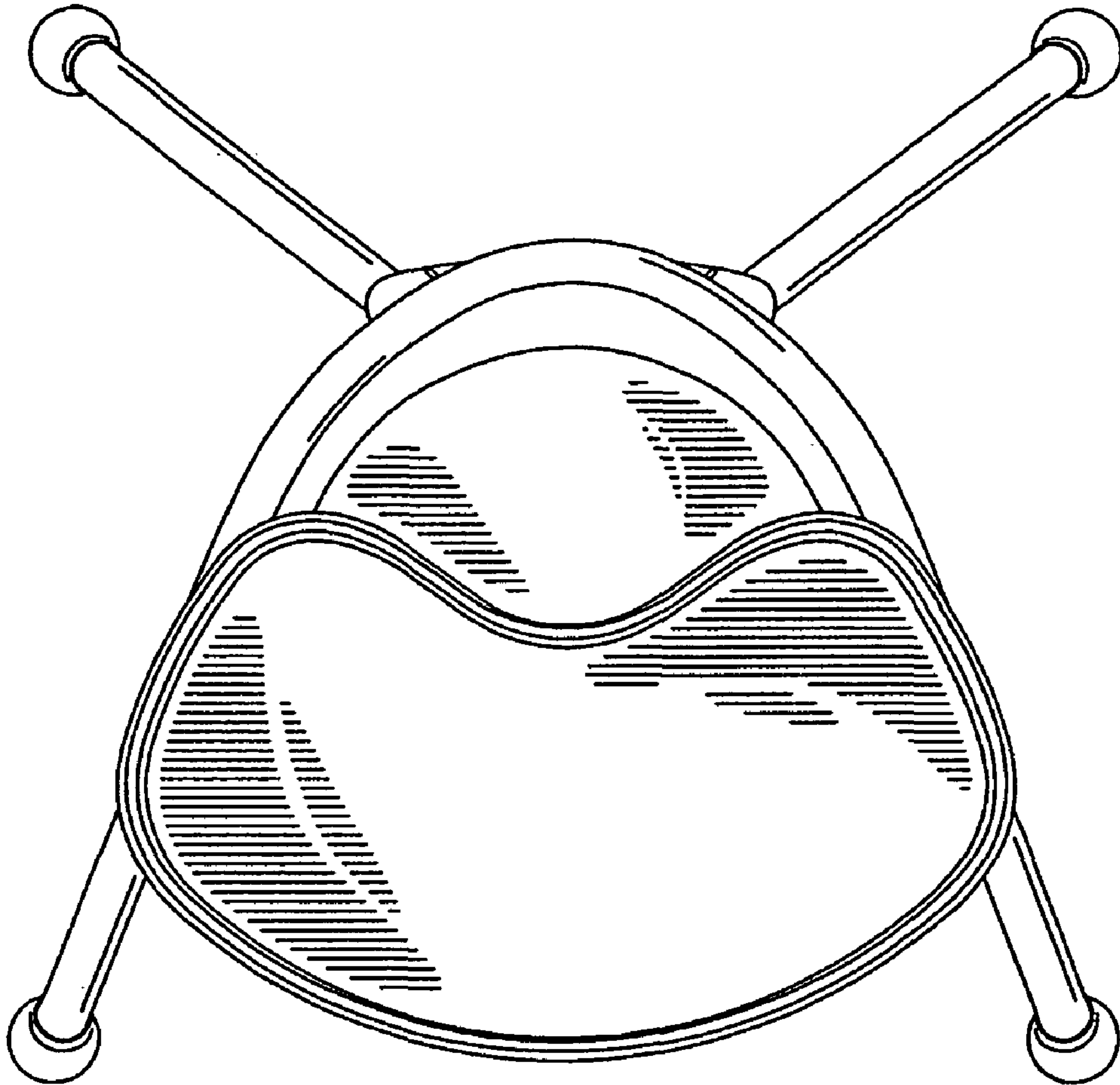

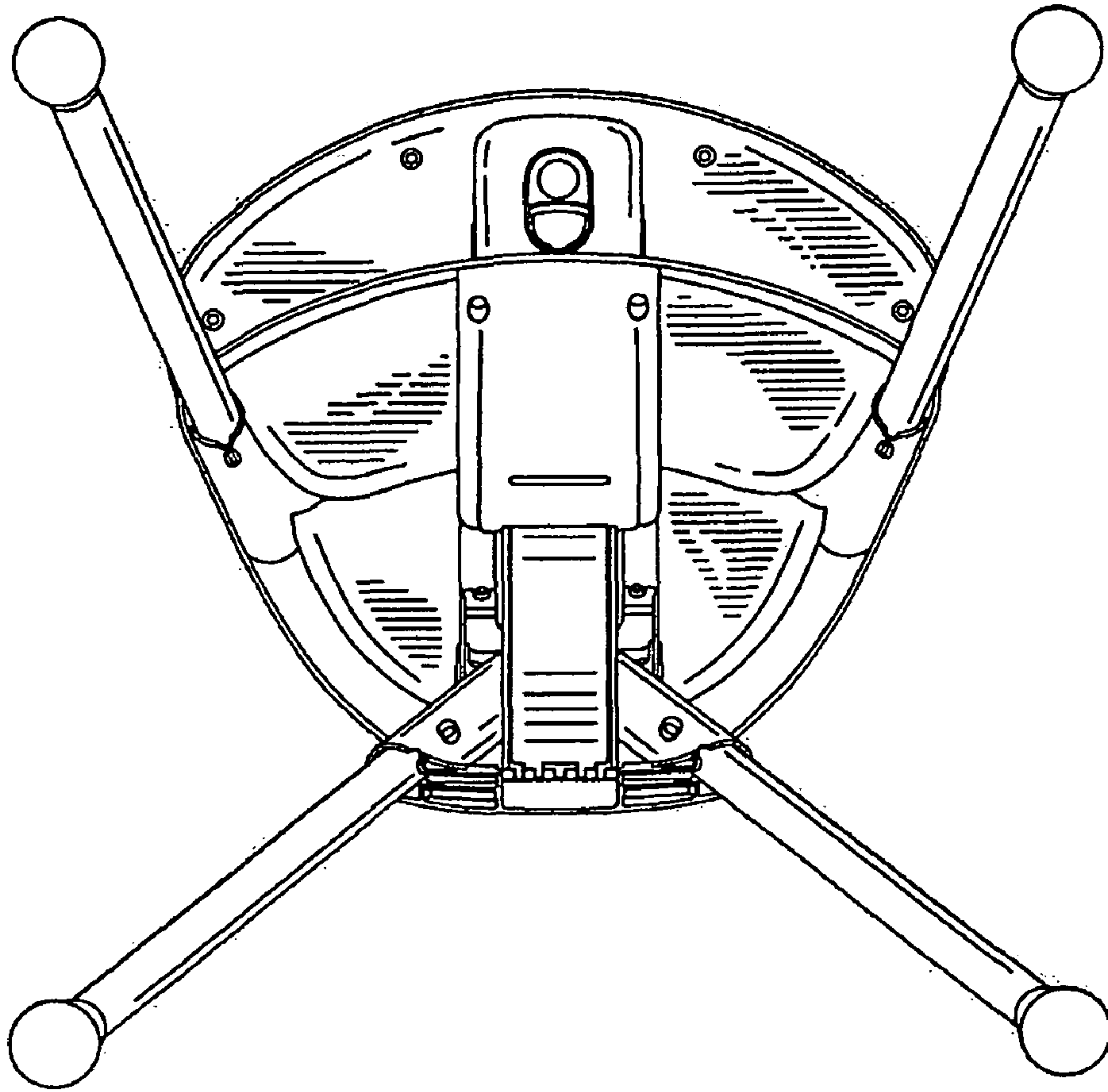

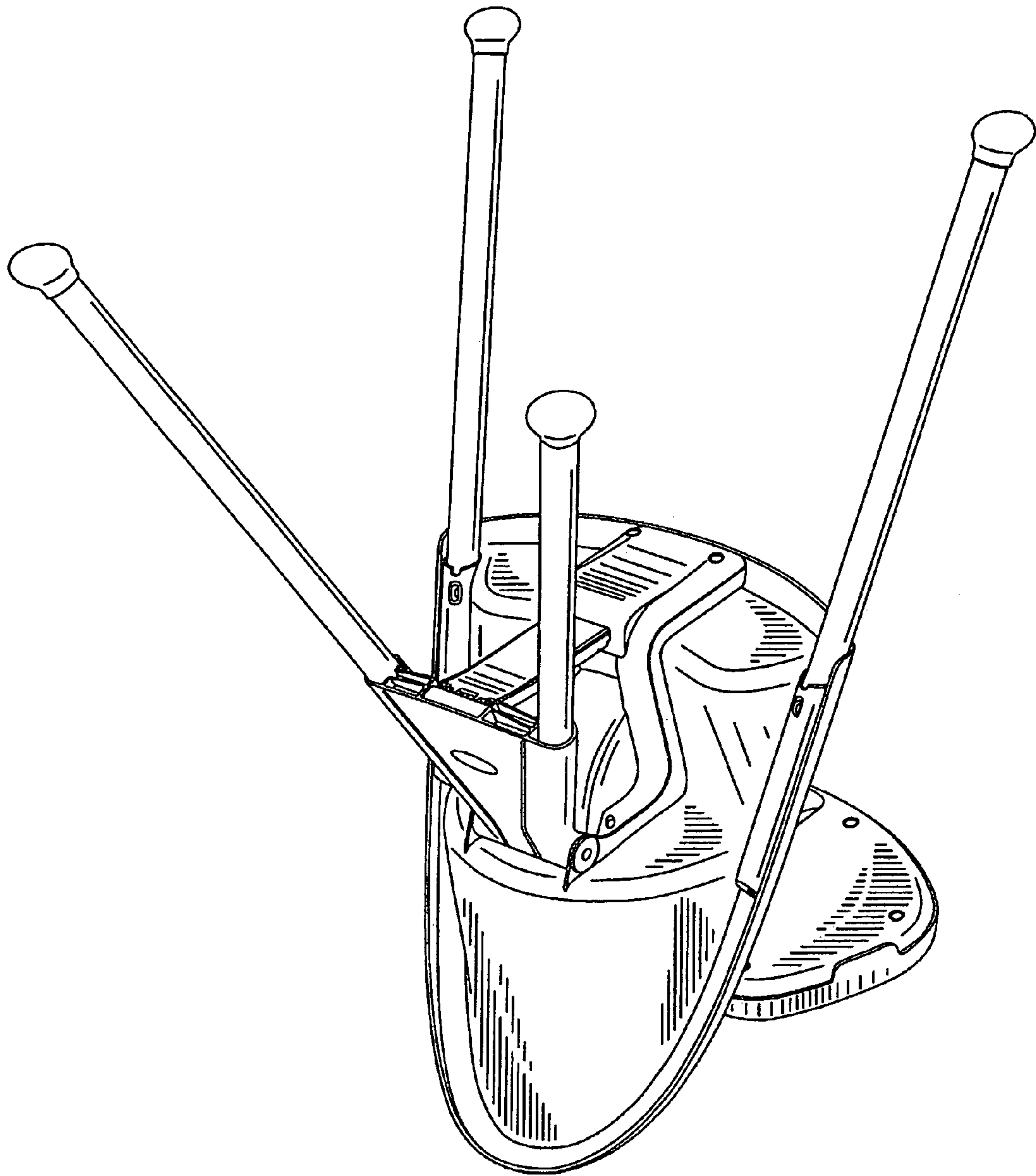
