DESCRIPTION

FIG. 4 is a left side view of the whale tub toy holder illustrated in FIG. 1.

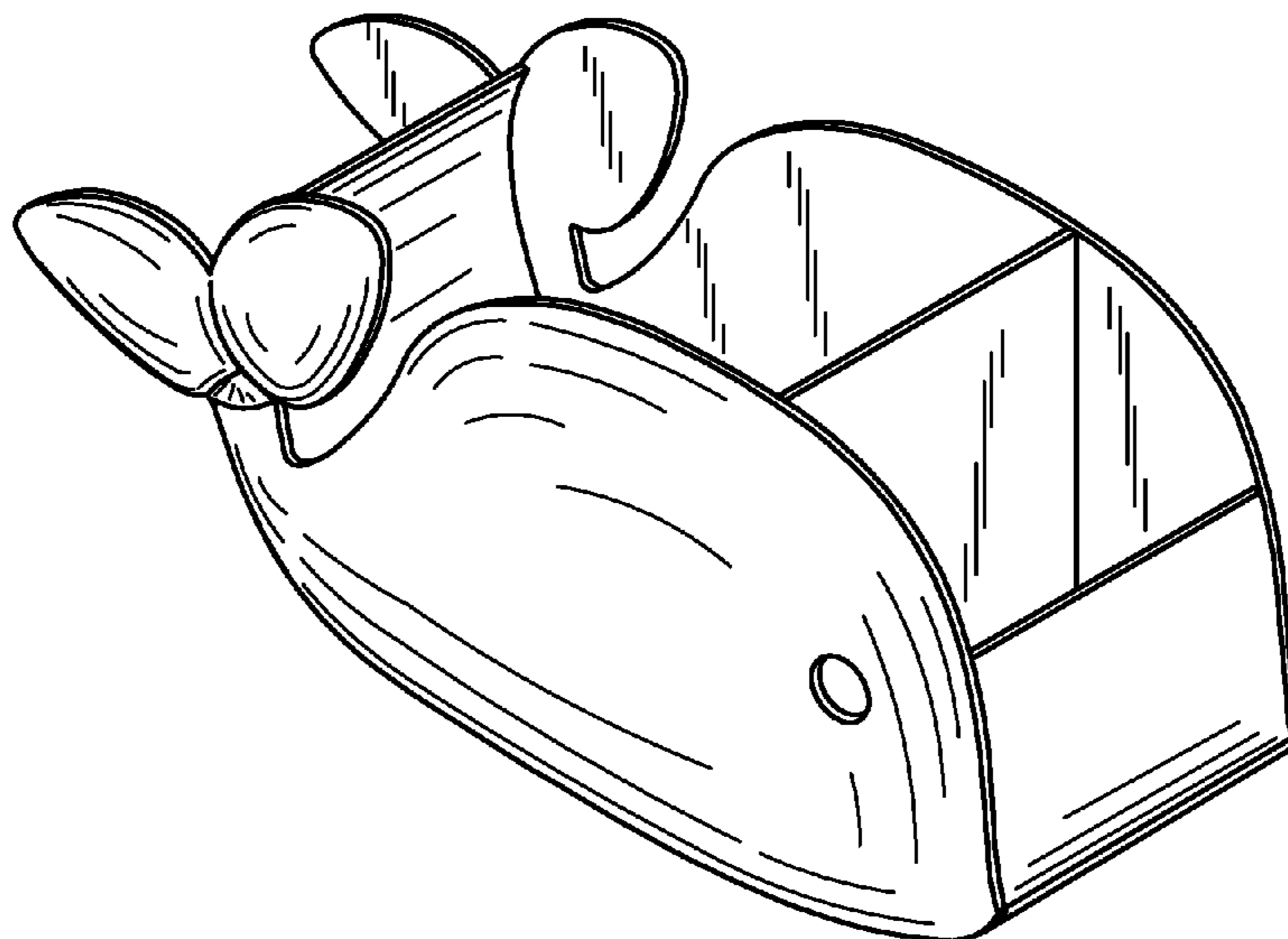
FIG. 5 is a right side view of the whale tub toy holder illustrated in FIG. 1.

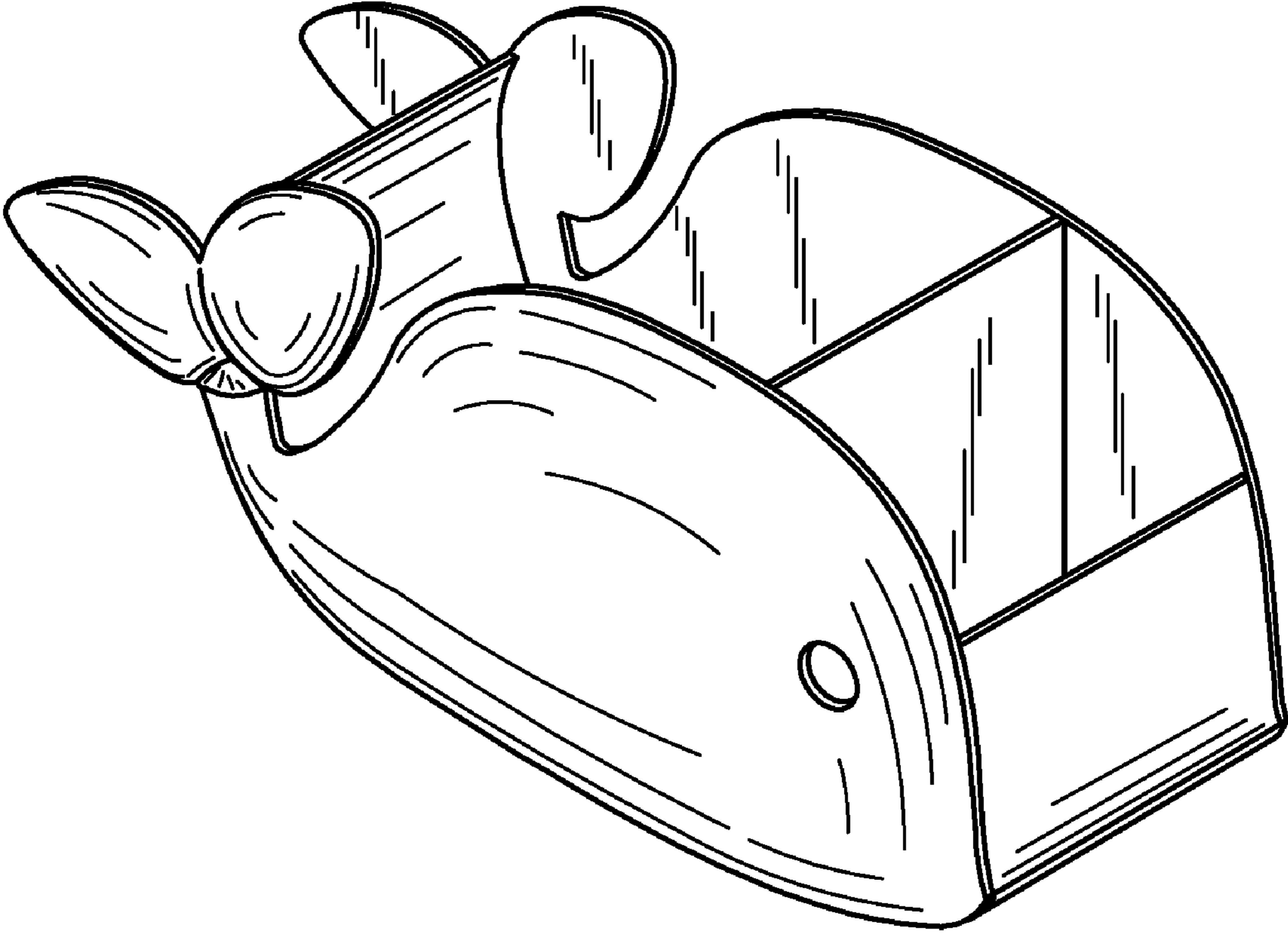

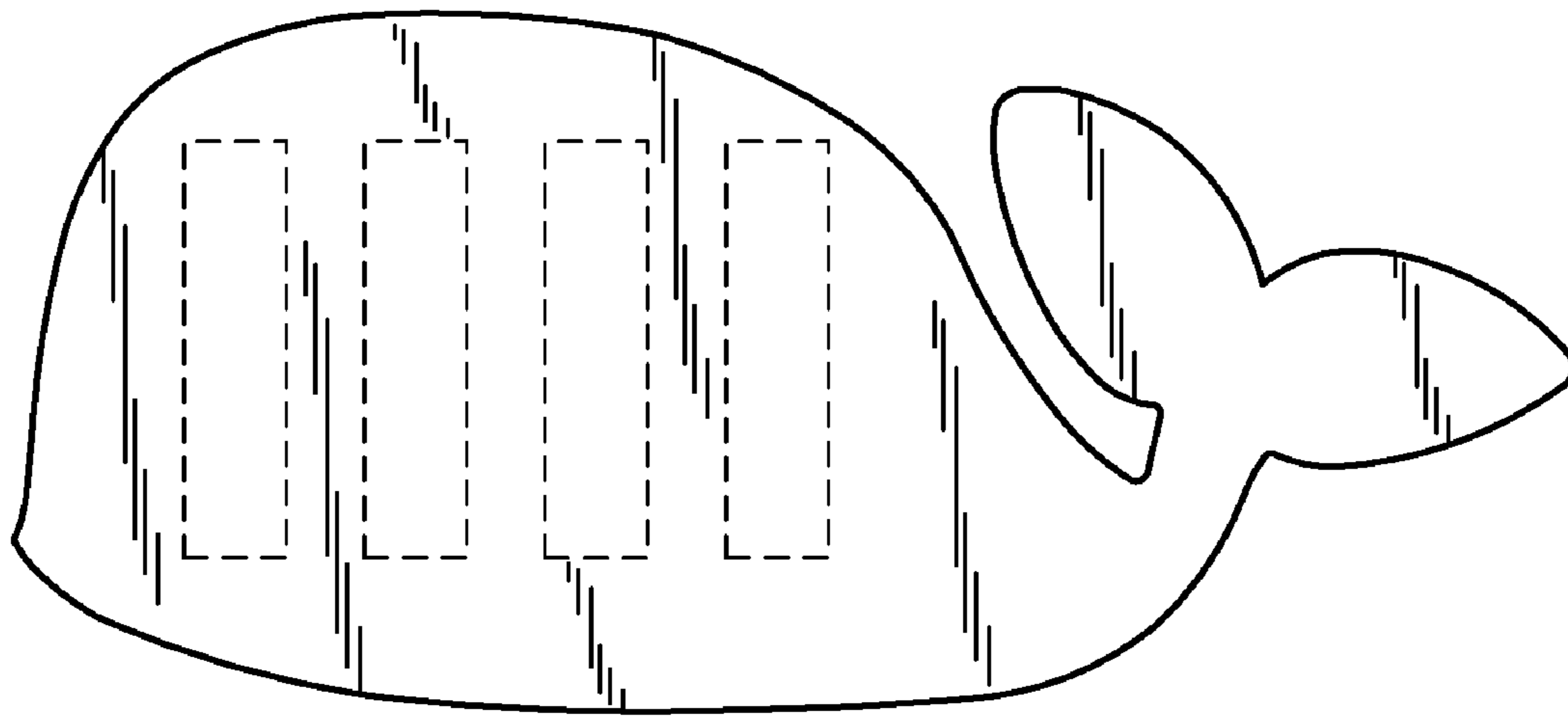

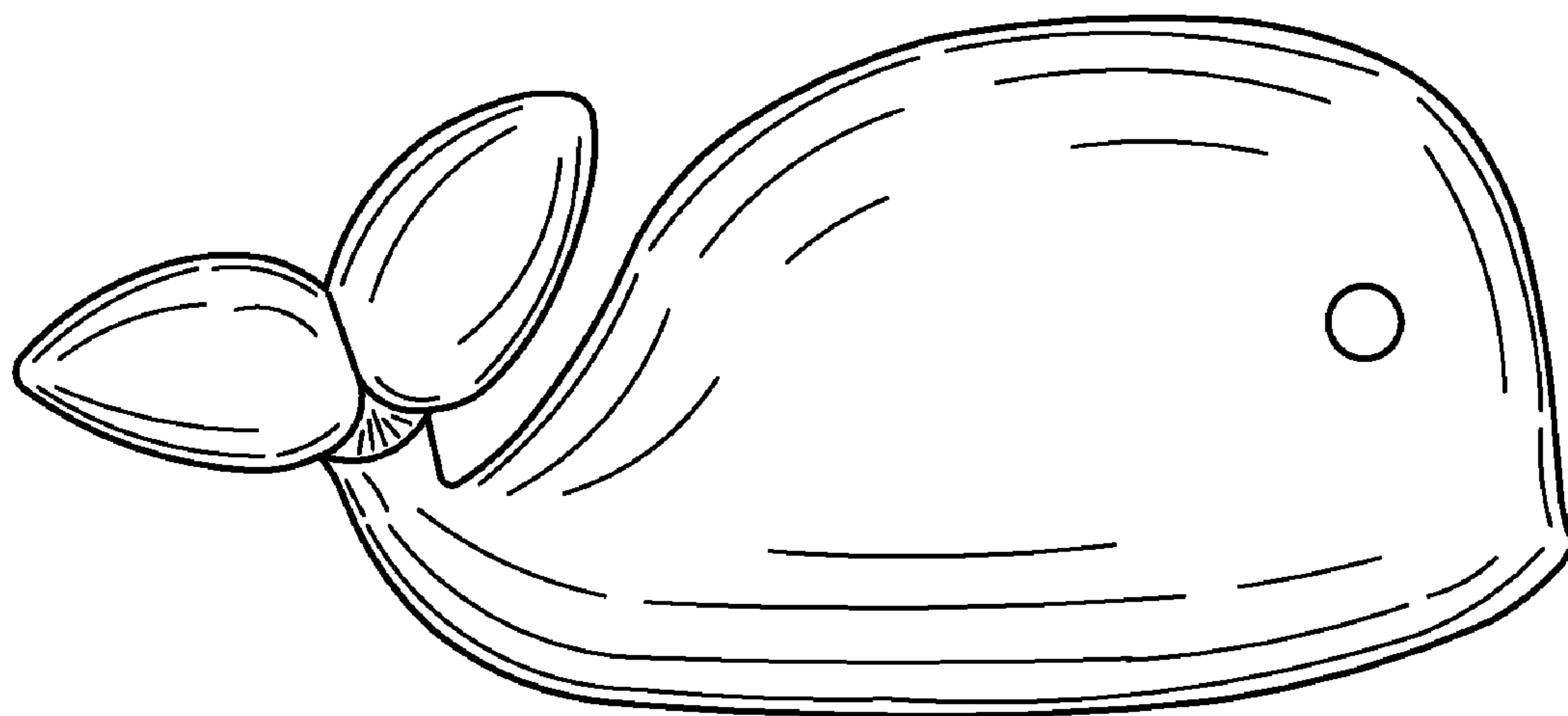

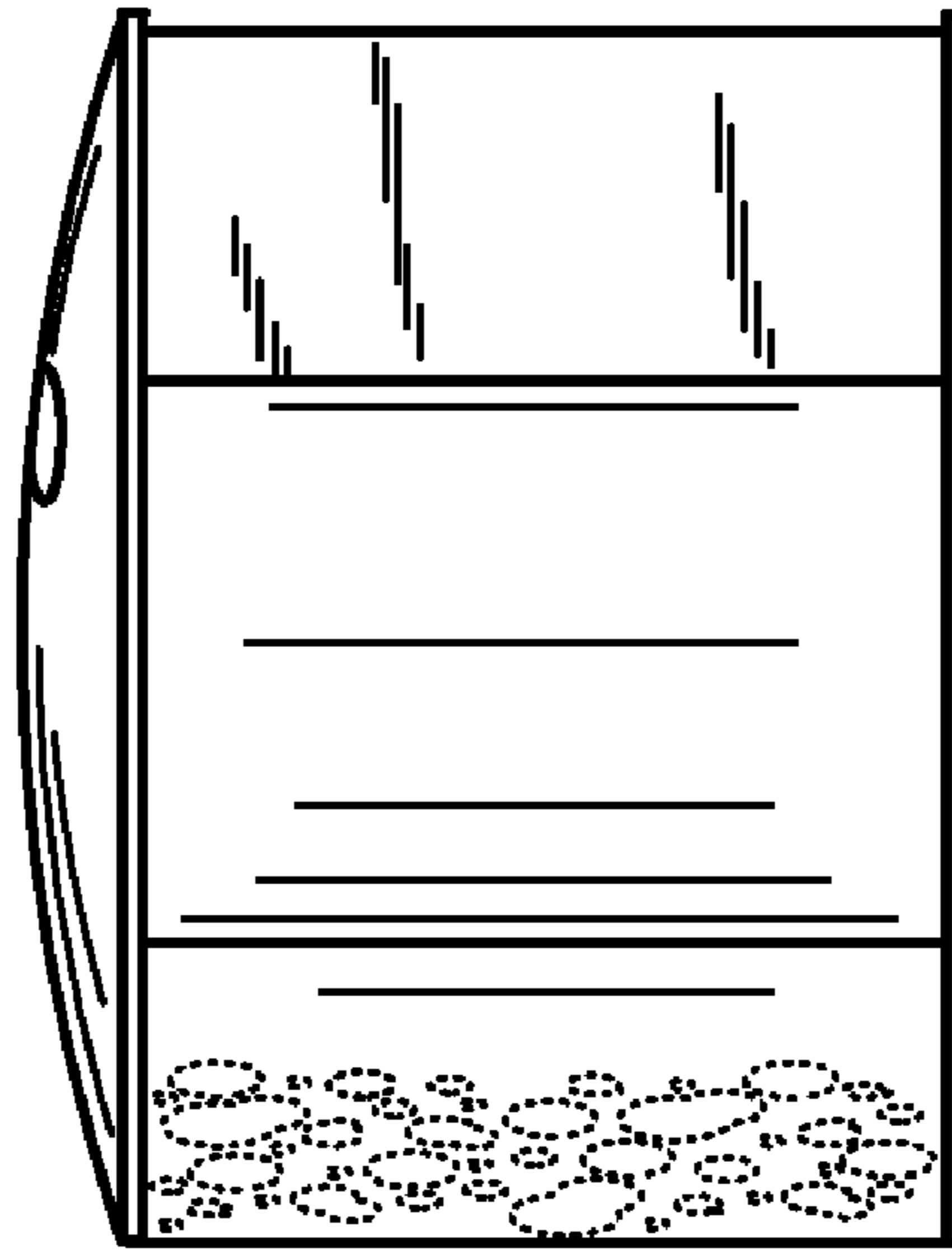

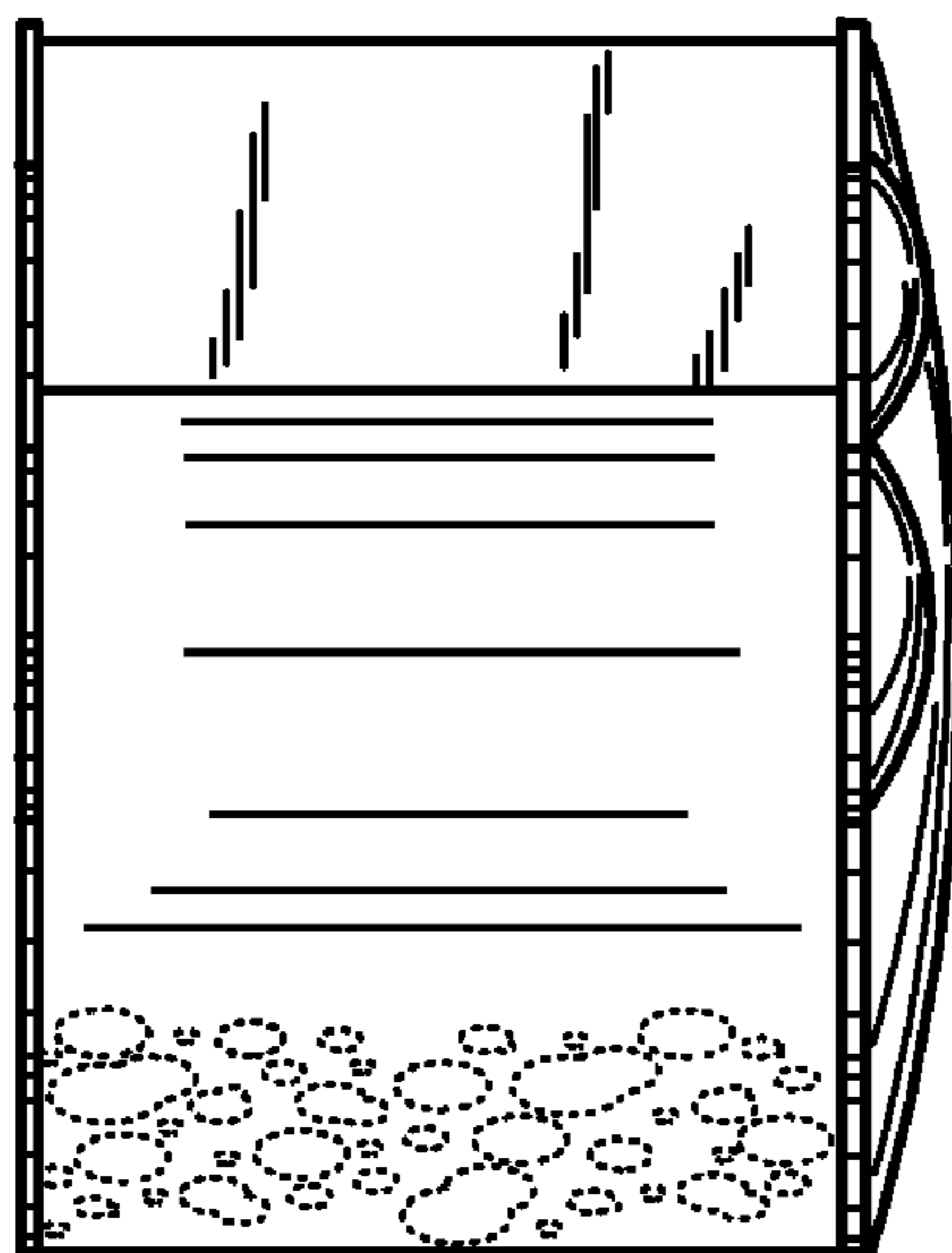

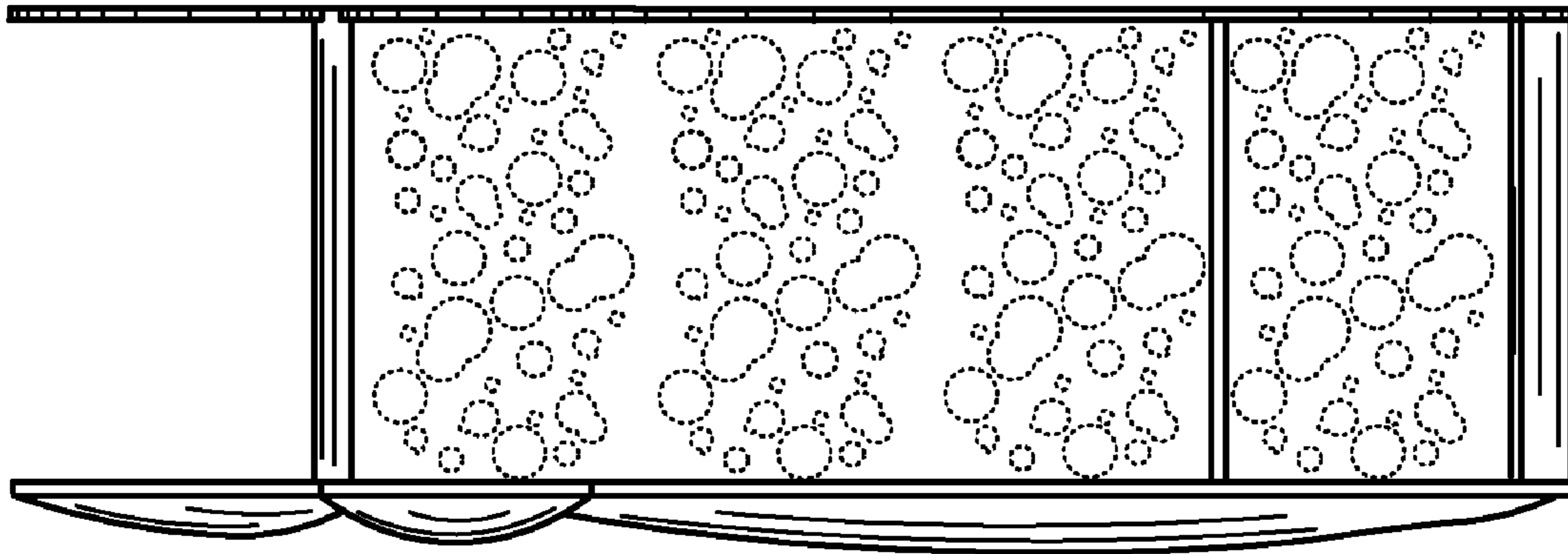

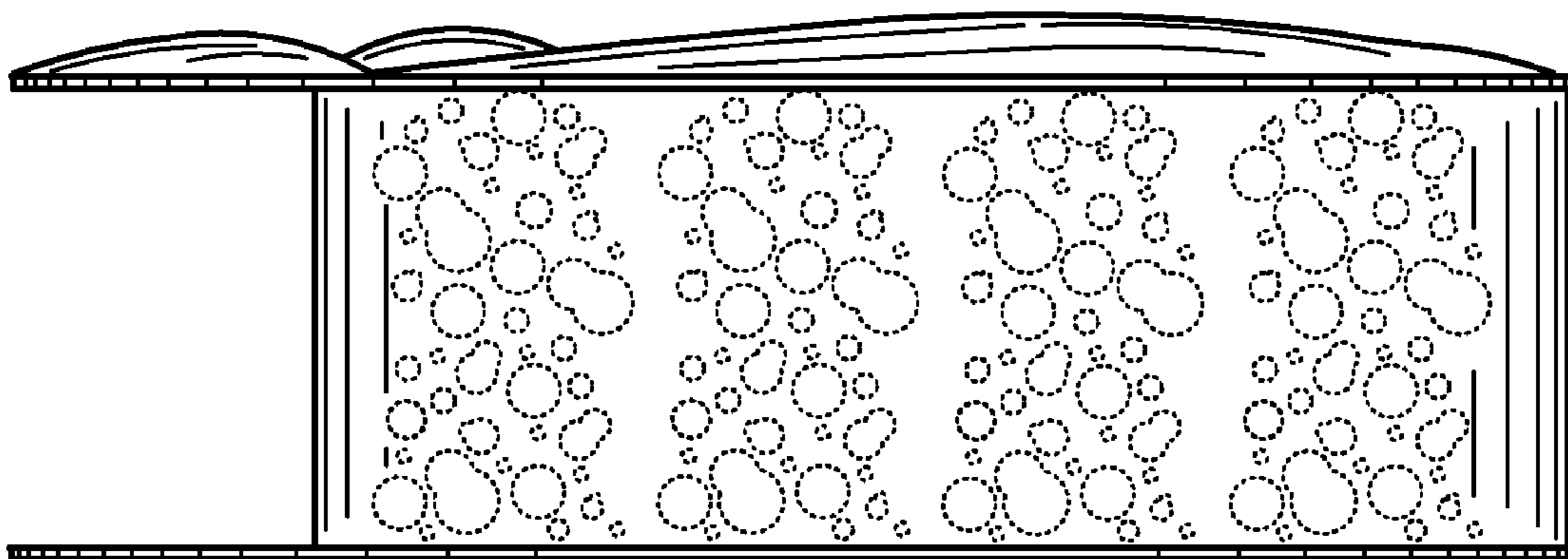
