FIG. 6 is a expanded bottom perspective view thereof;

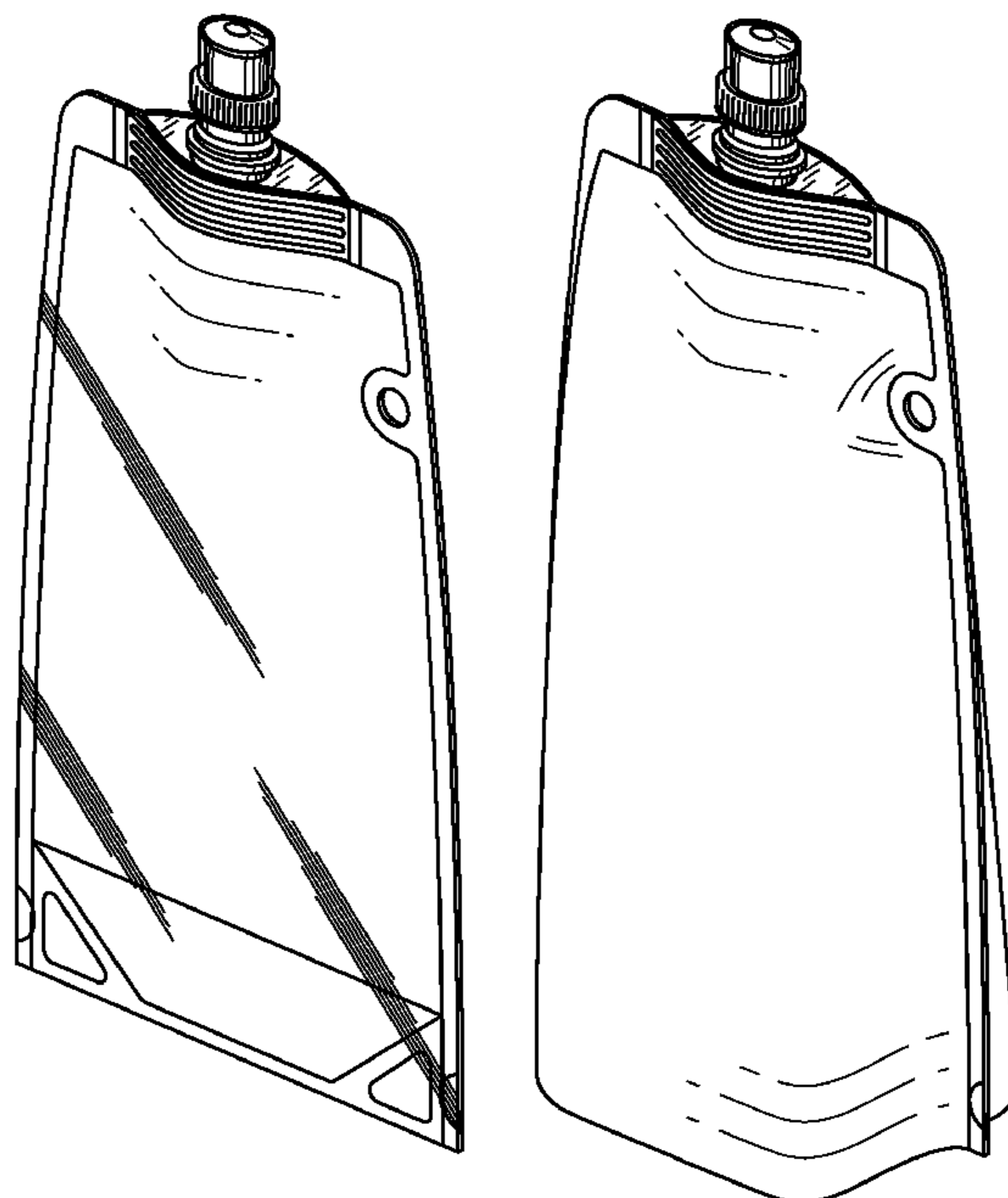
FIG. 7 is a right side perspective view thereof;

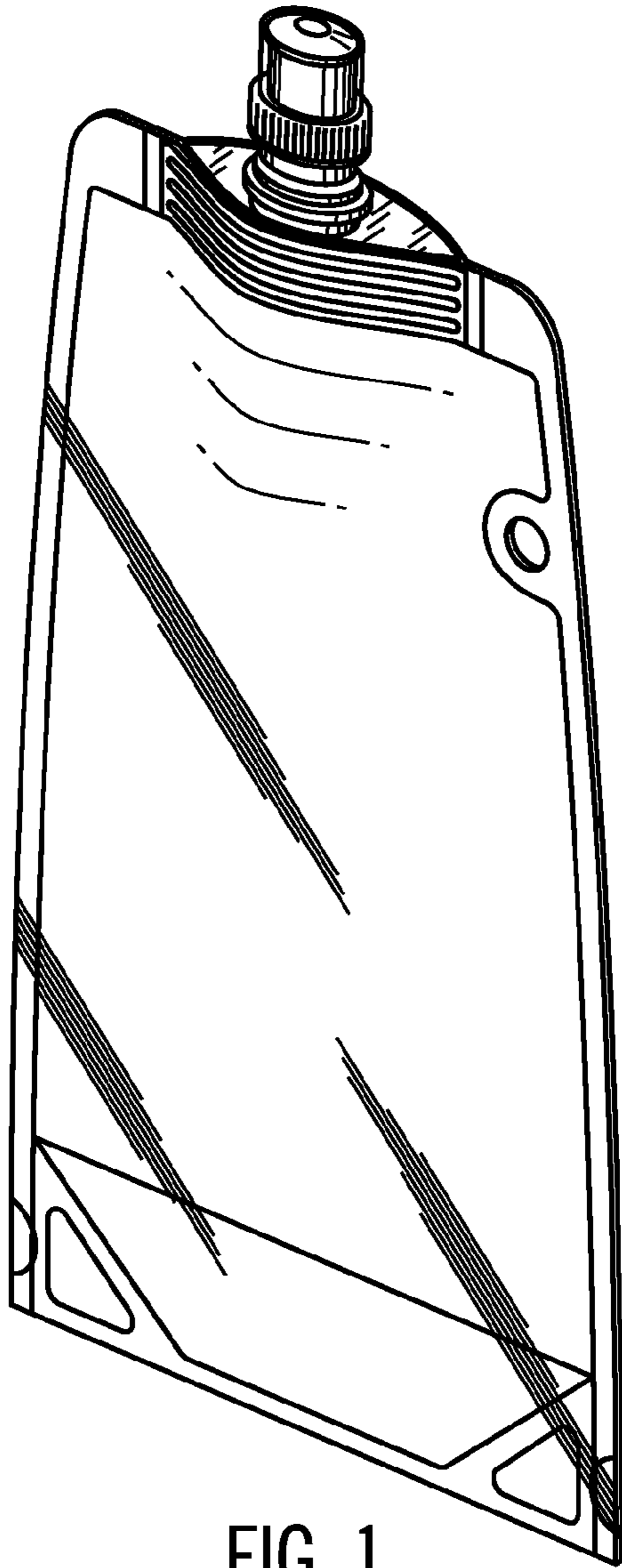

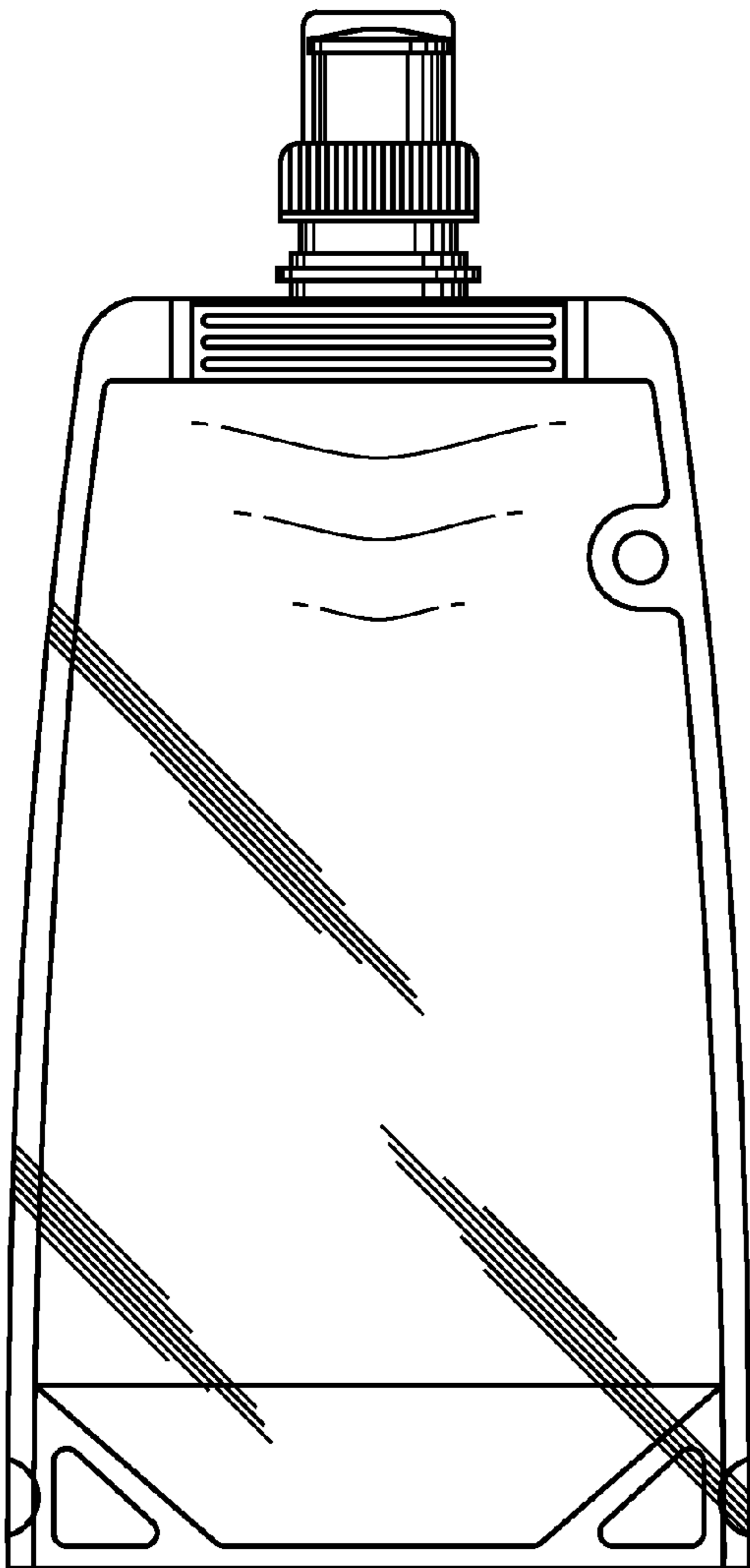

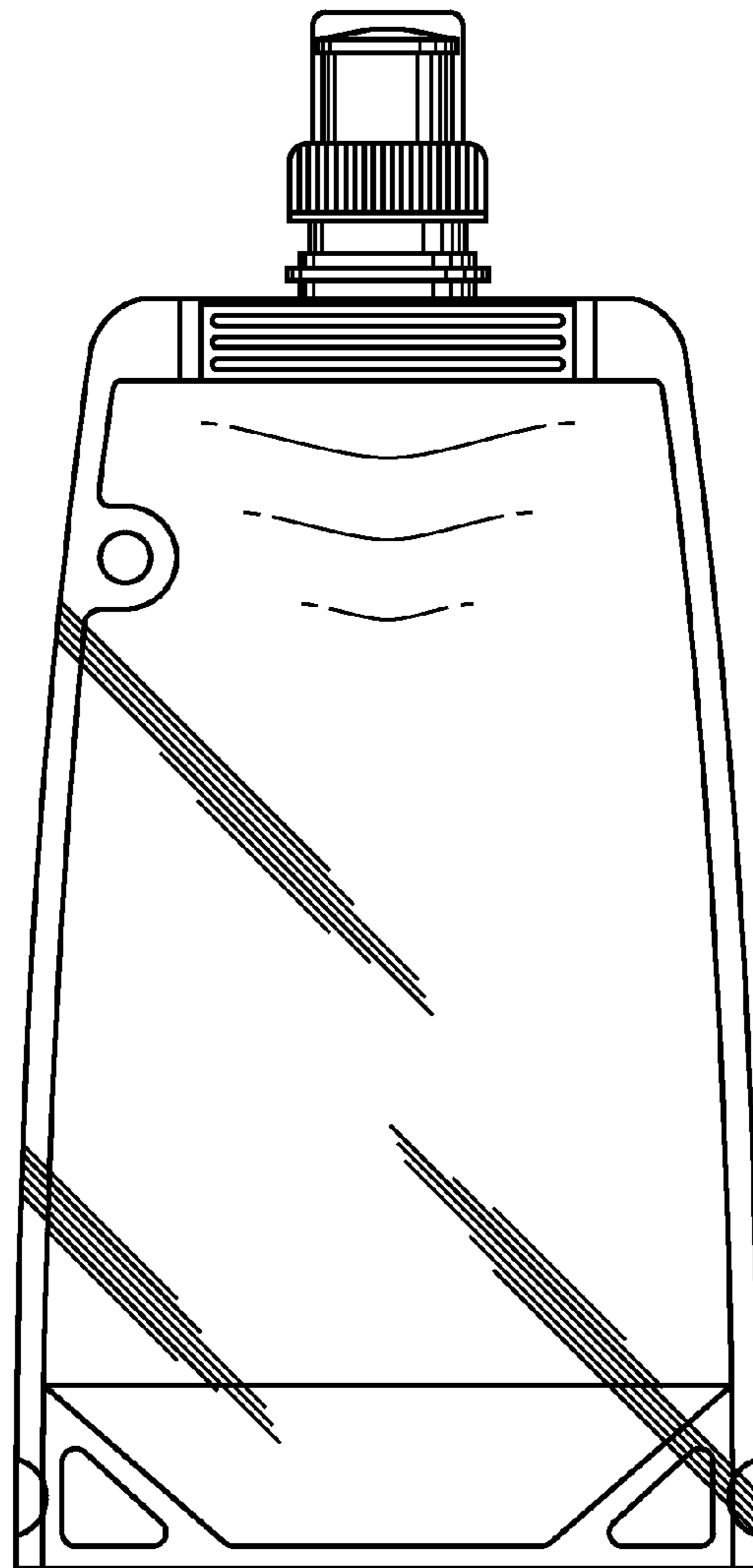

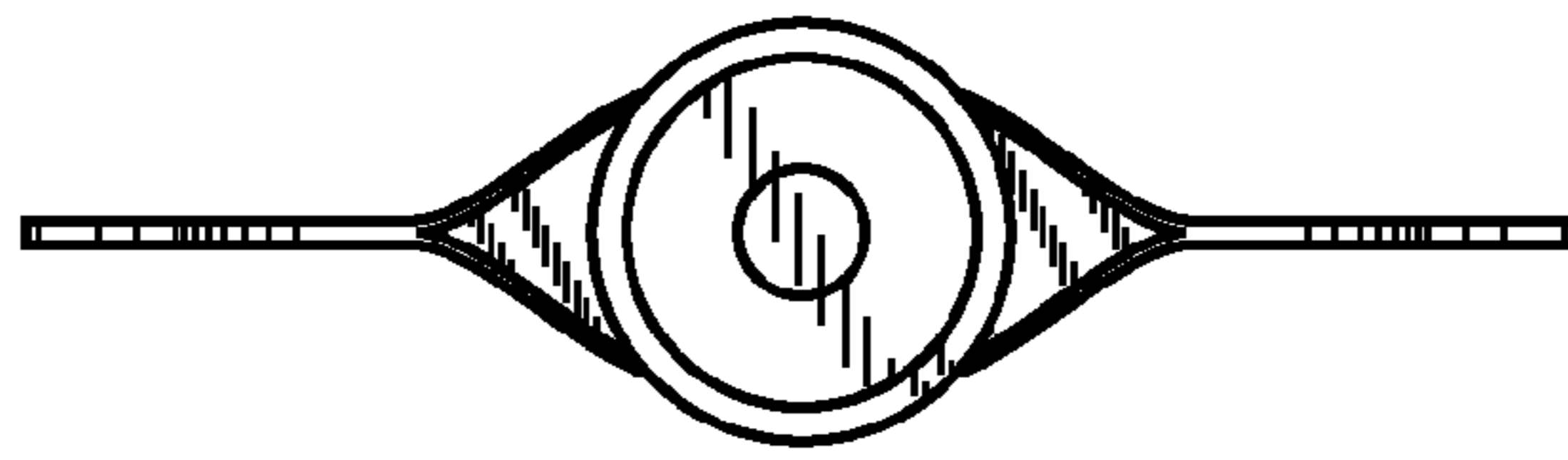

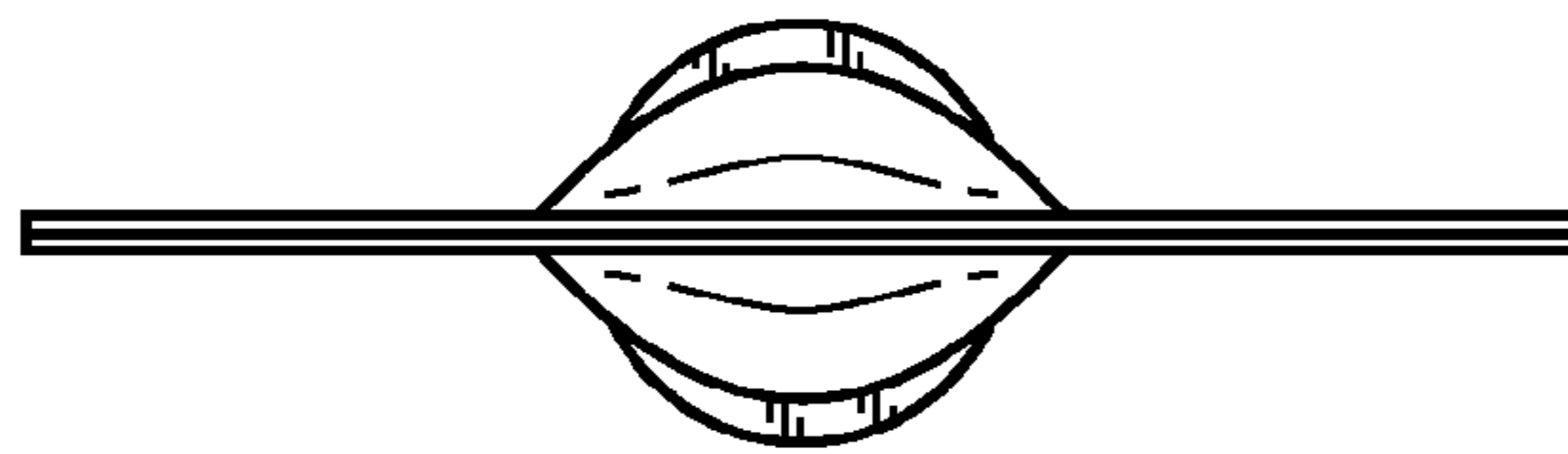

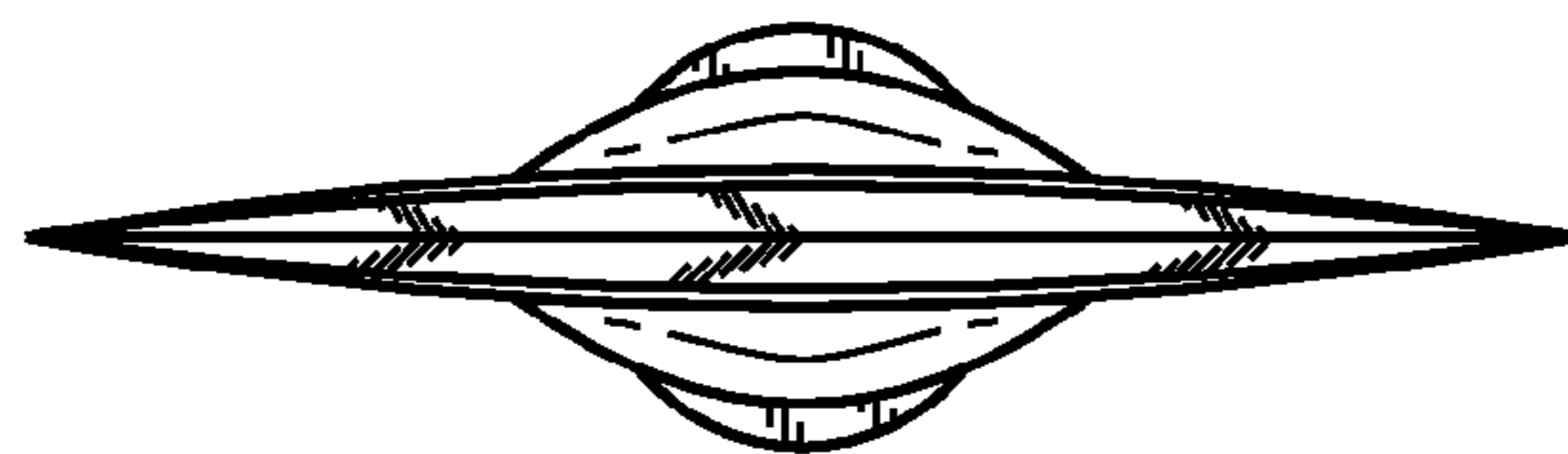

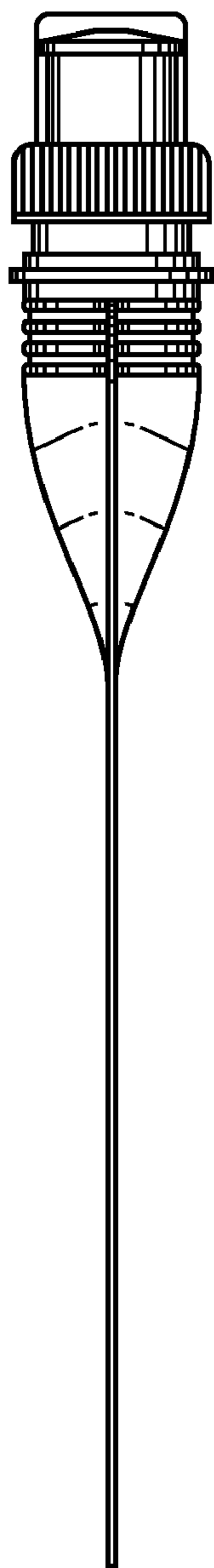

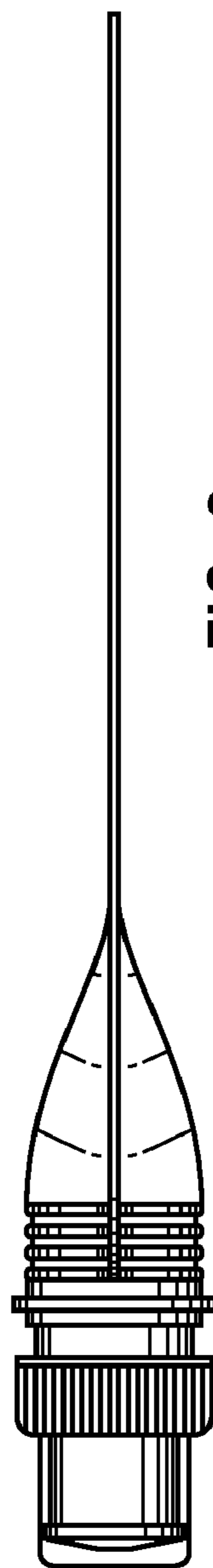

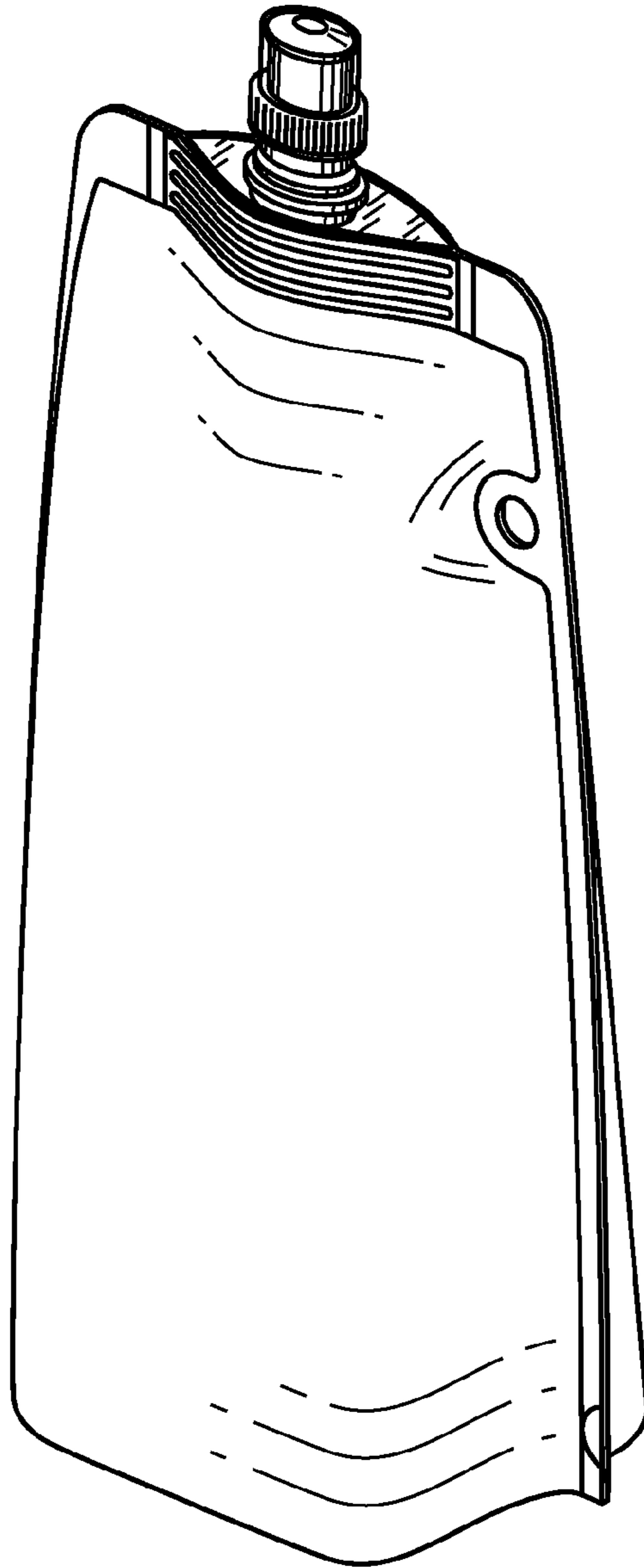
