DESCRIPTION

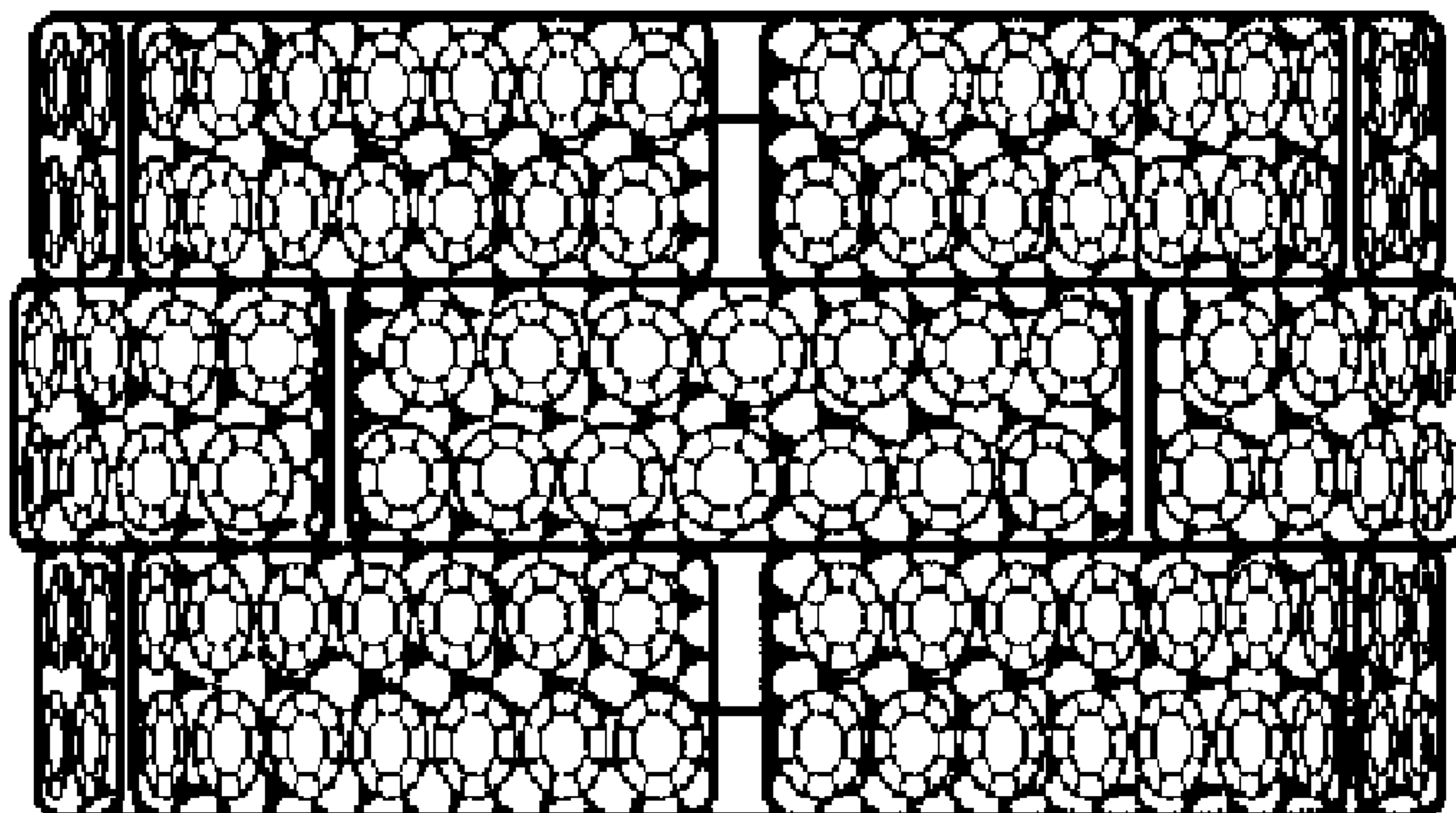
FIG. 1 is a top view of the ring; a bottom view being identical.

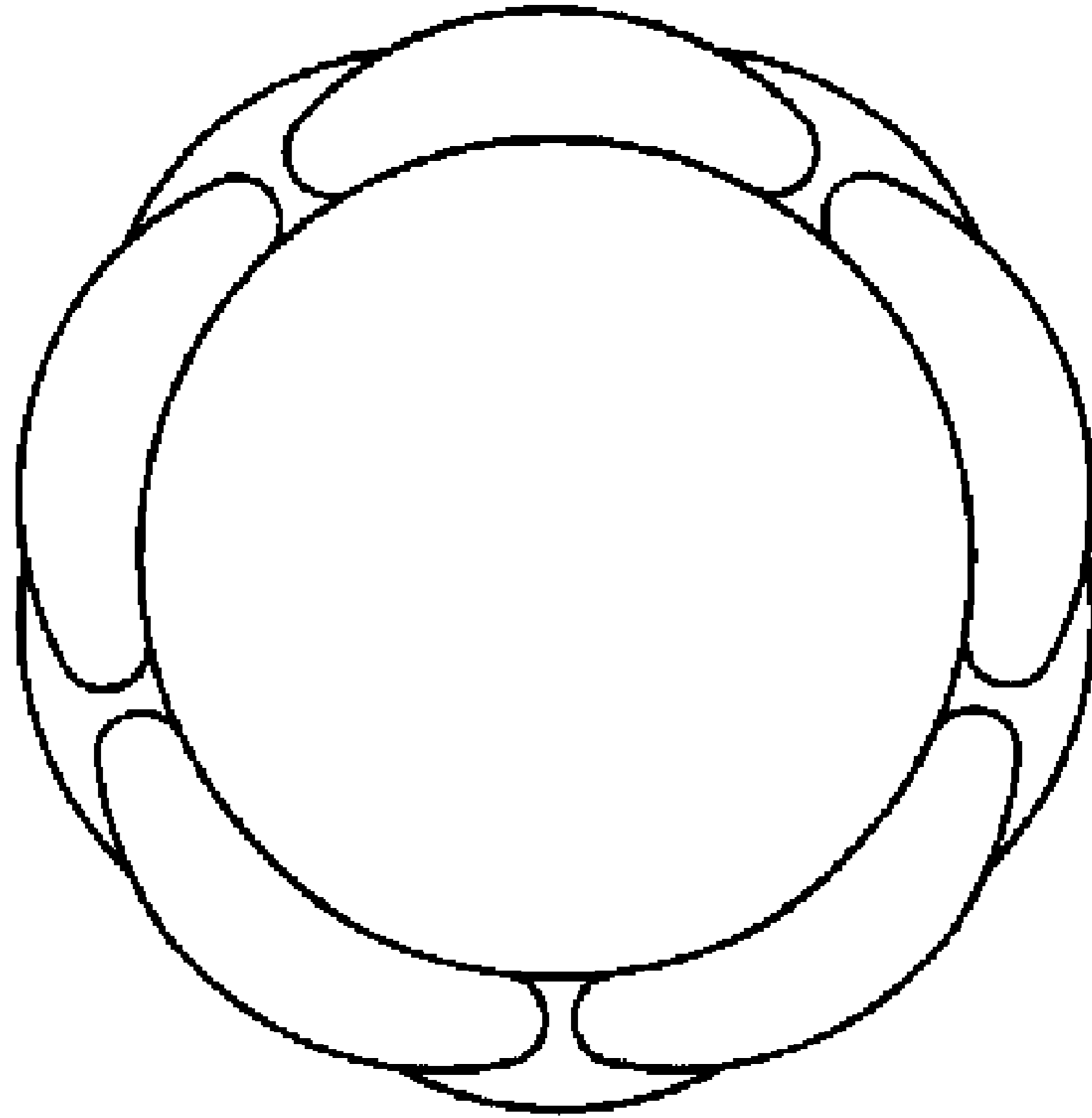

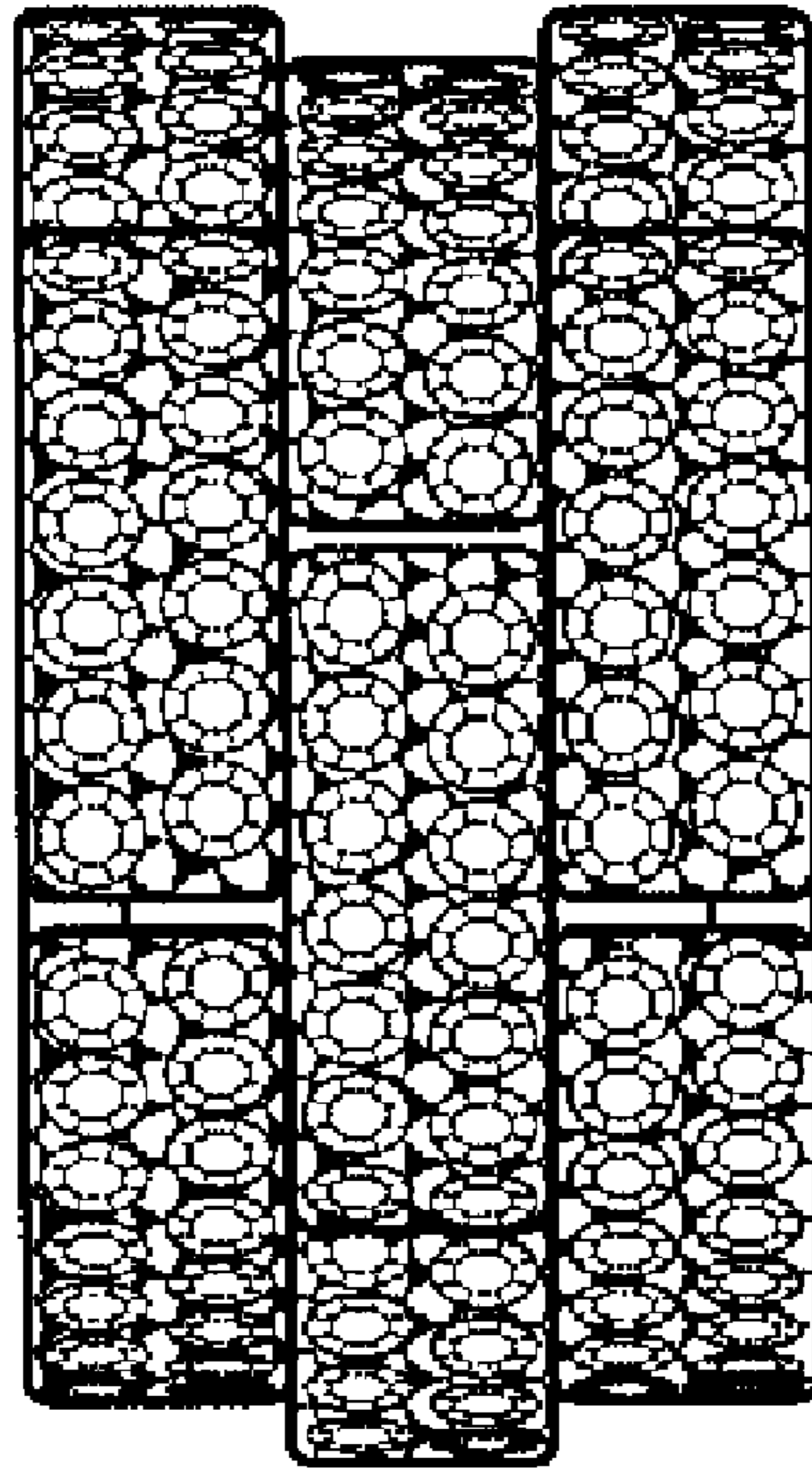

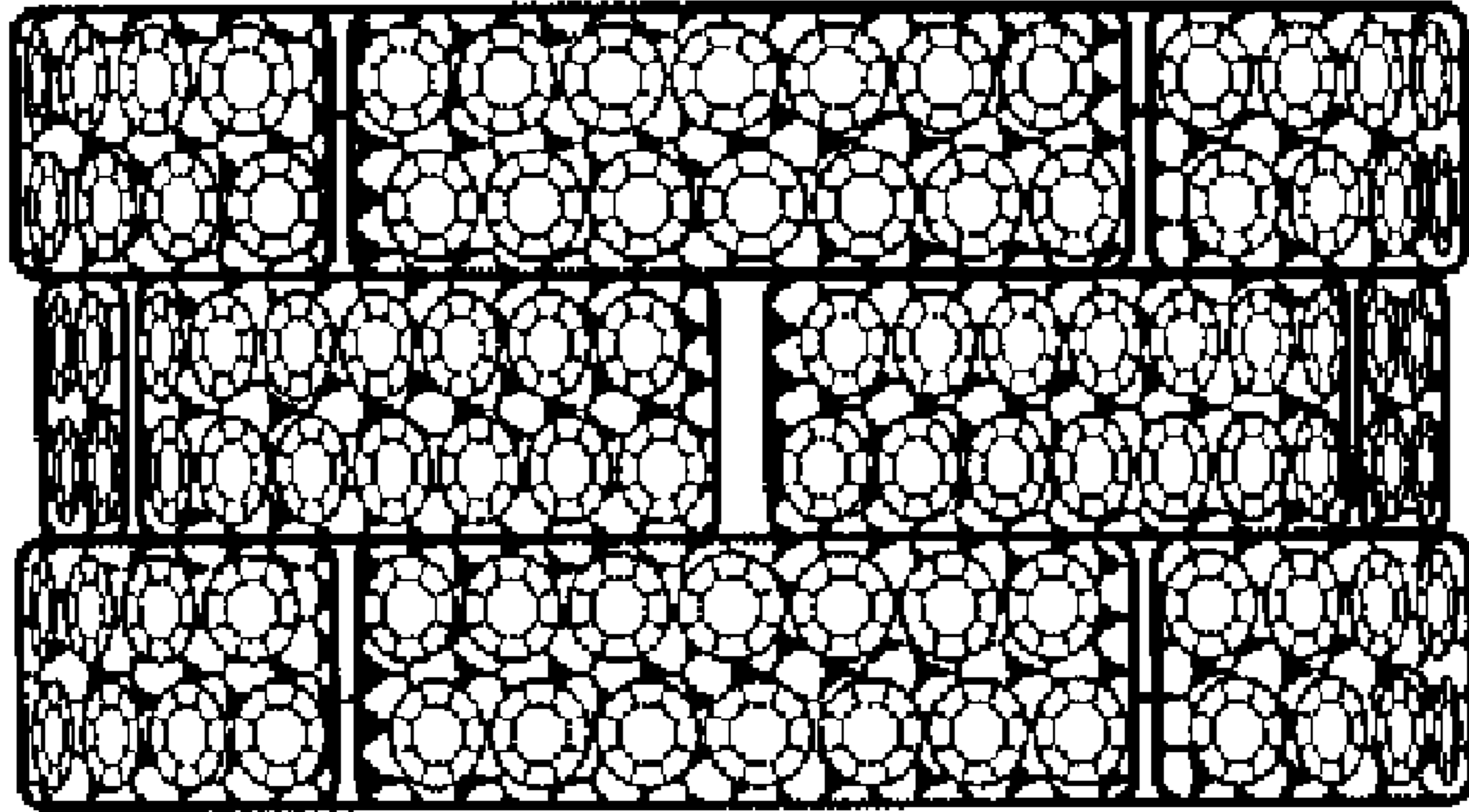

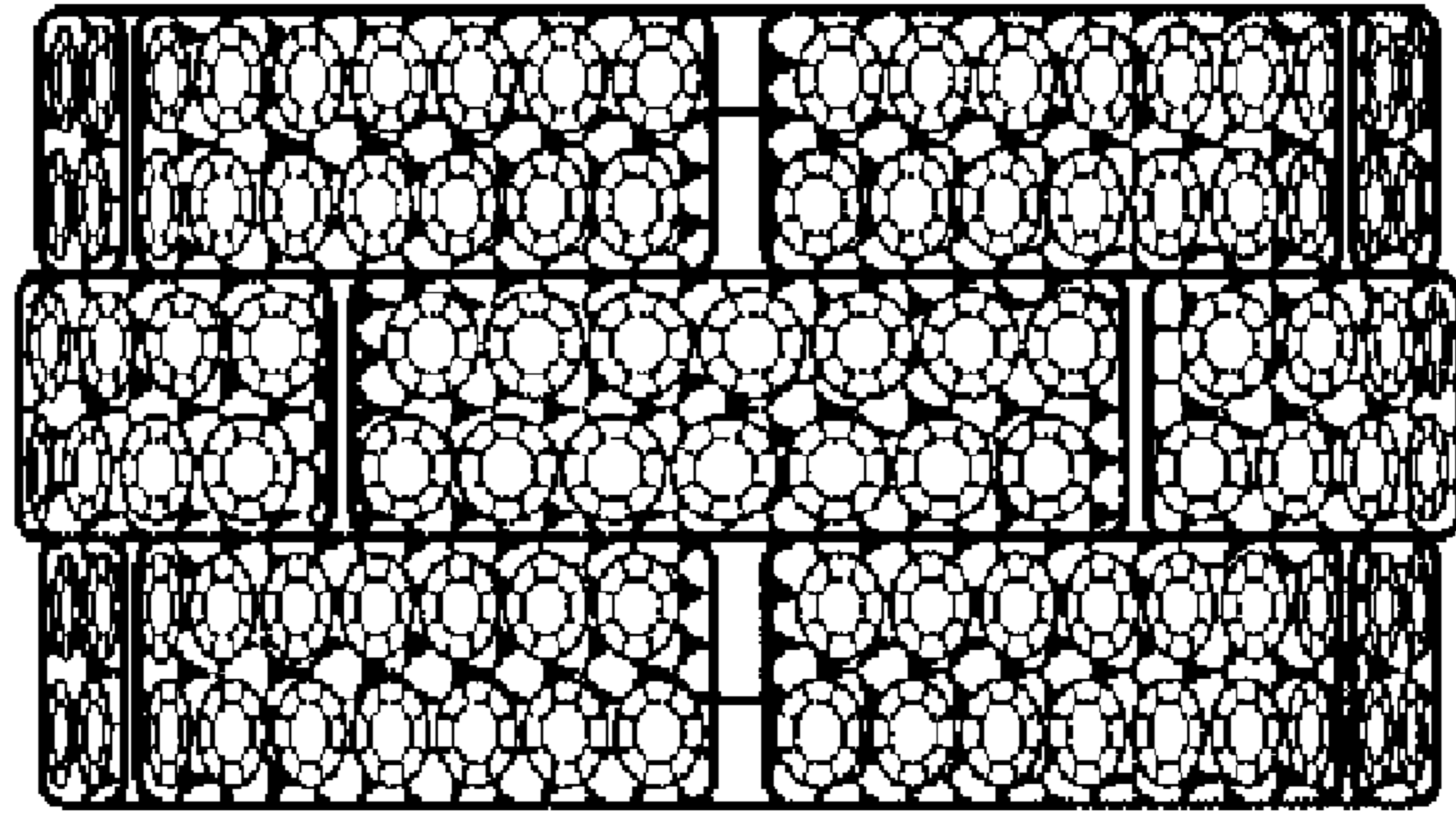
