The ornamental design for a buckle for watch bracelet, as shown.

DESCRIPTION

FIG. 1 is a top plan view of a buckle for watch bracelet showing our new design;

FIG. 2 is a bottom plan view thereof;

FIG. 3 is a view thereof from the right of FIG. 1;

FIG. 4 is a view thereof from the left of FIG. 1;

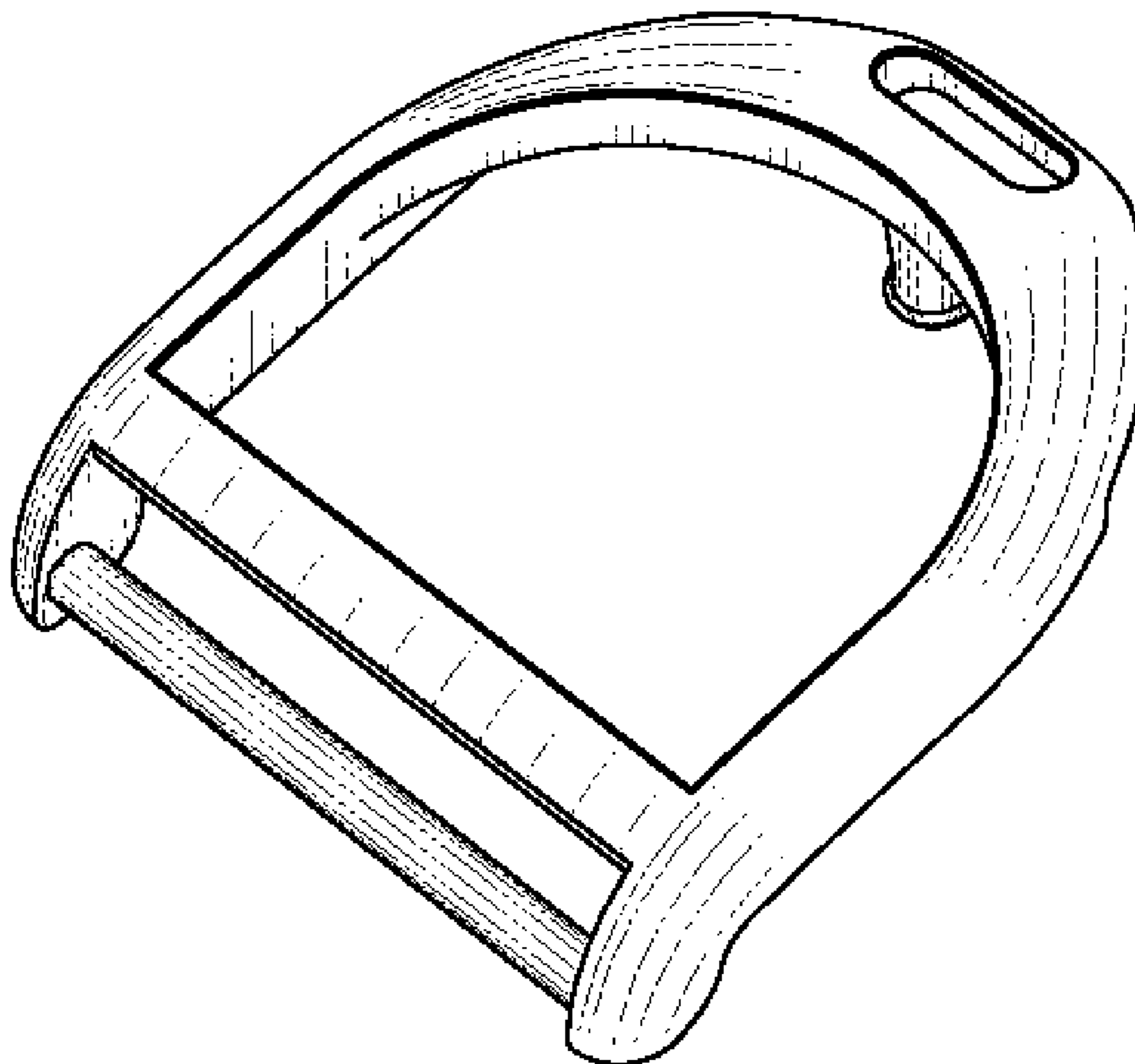

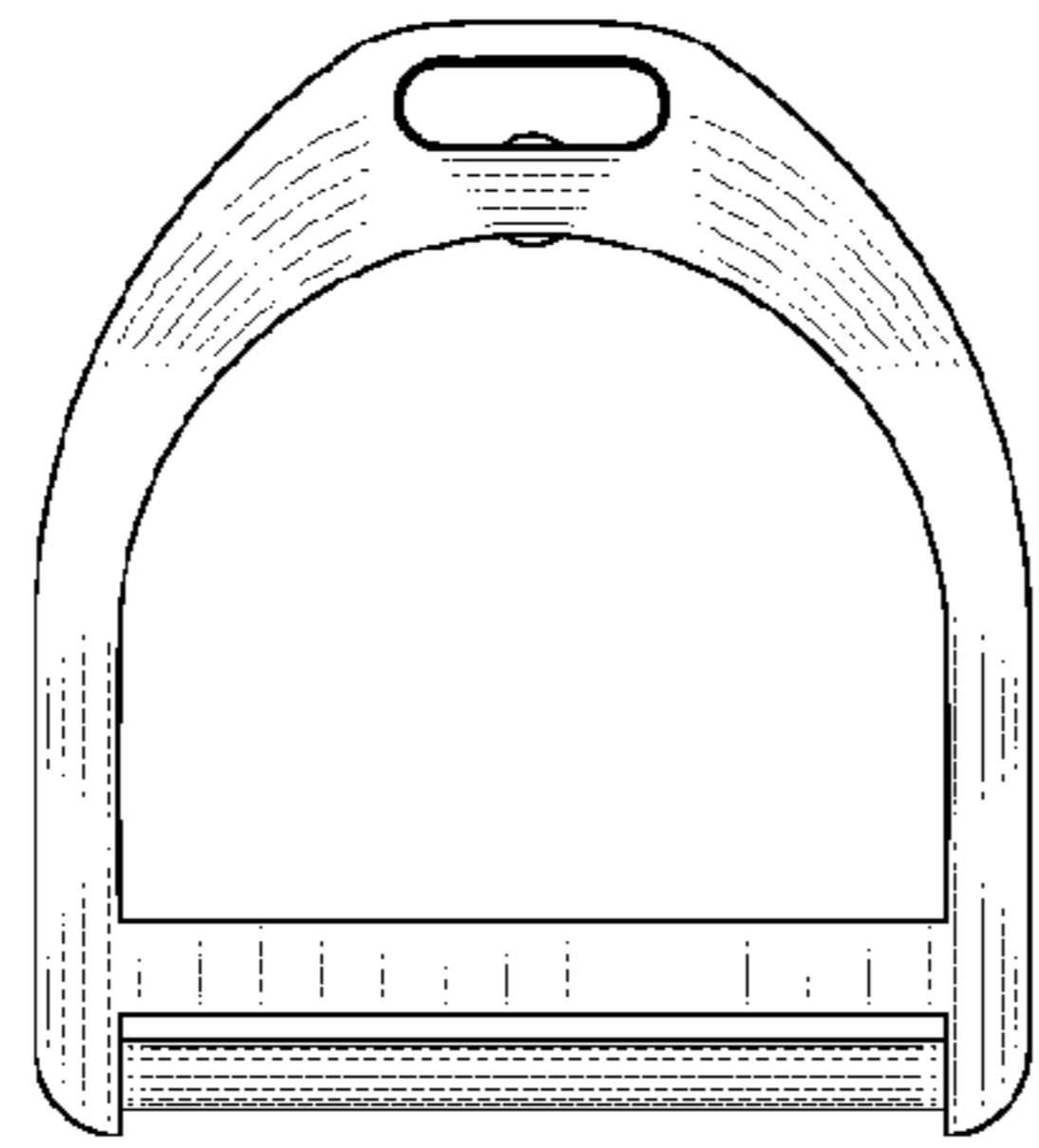

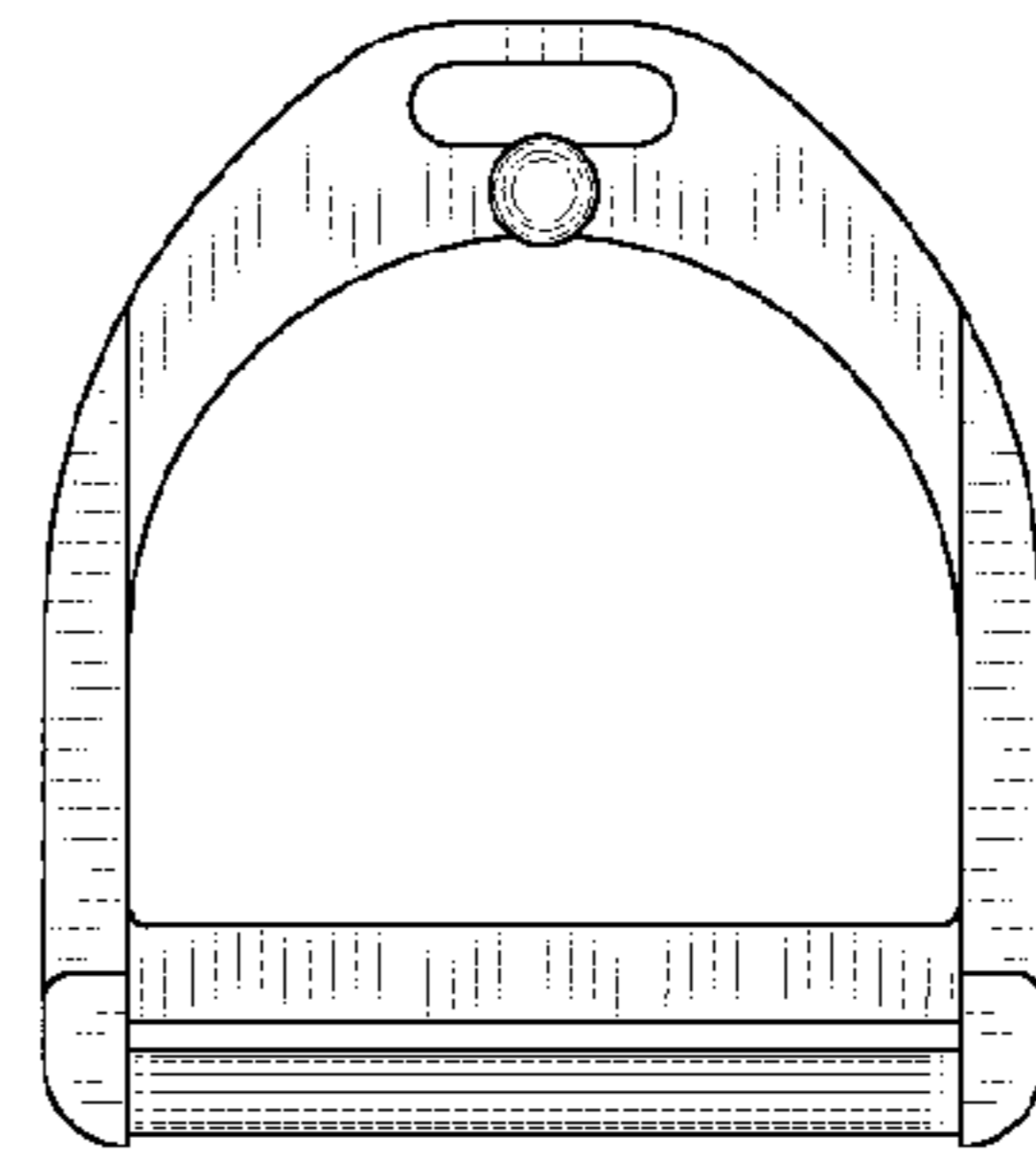

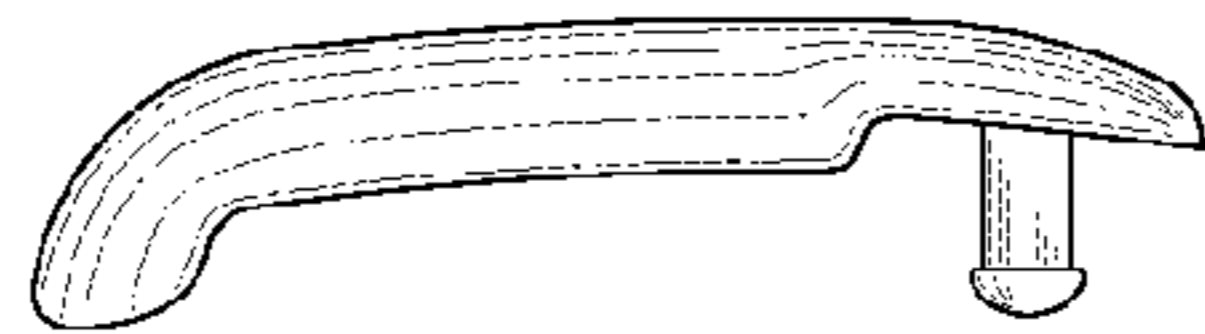

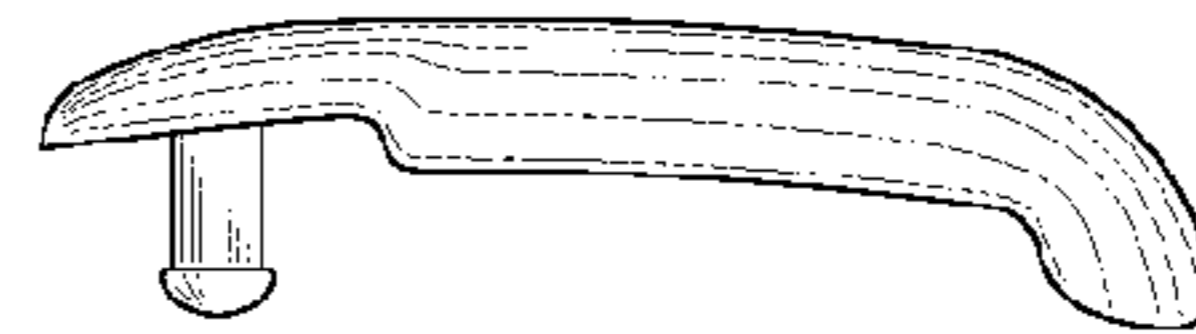

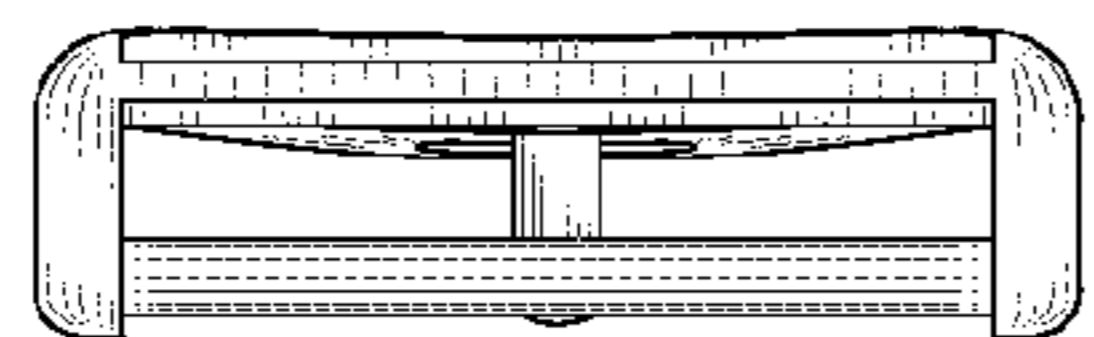

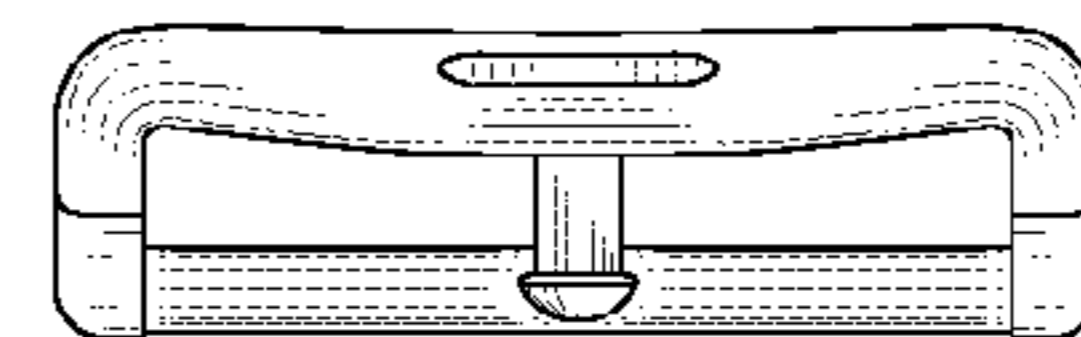
