DESCRIPTION

FIG. 1 is a perspective view of a passenger car according to
the present invention.

FIG. 2 is a front view of the passenger car of FIG. 1.

FIG. 3 is a rear view of the passenger car of FIG. 1.

FIG. 4 is a left side view of the passenger car of FIG. 1.

FIG. 5 is a right side view of the passenger car of FIG. 1; and,

FIG. 6 is a top view of the passenger car of FIG. 1.

A view of the bottom of the passenger car of FIG. 1 is omitted
since the bottom is devoid of surface ornamentation.

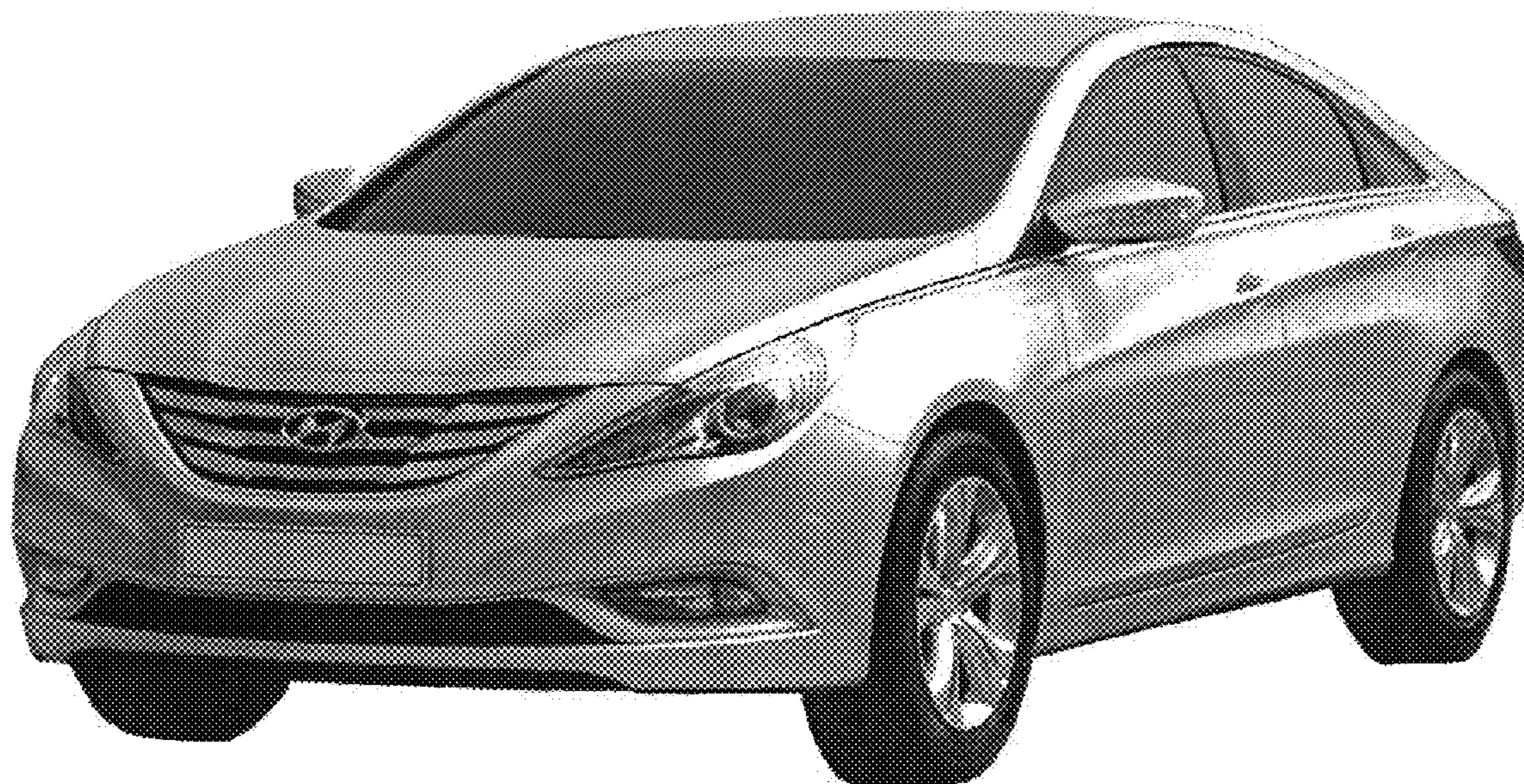

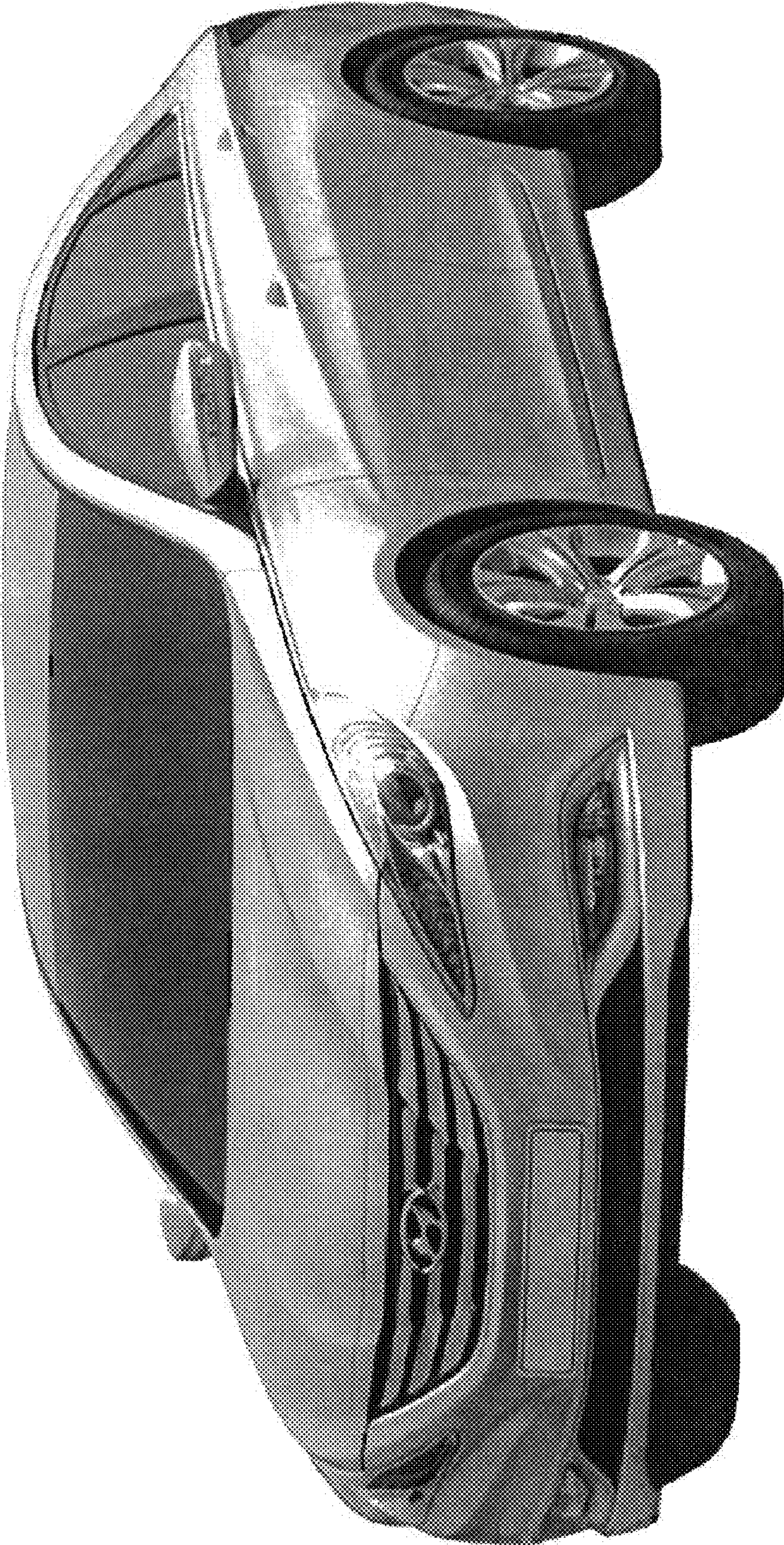

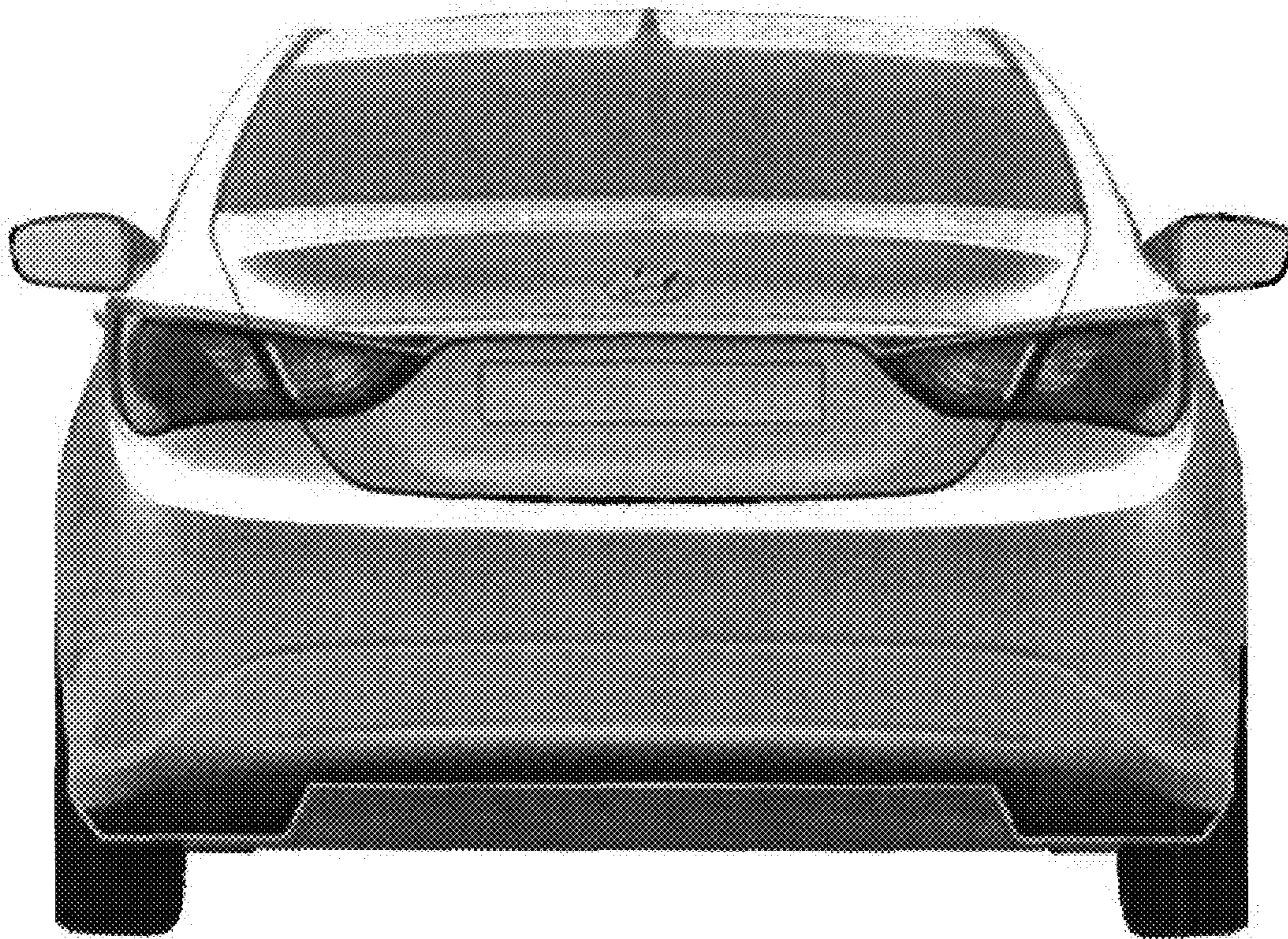

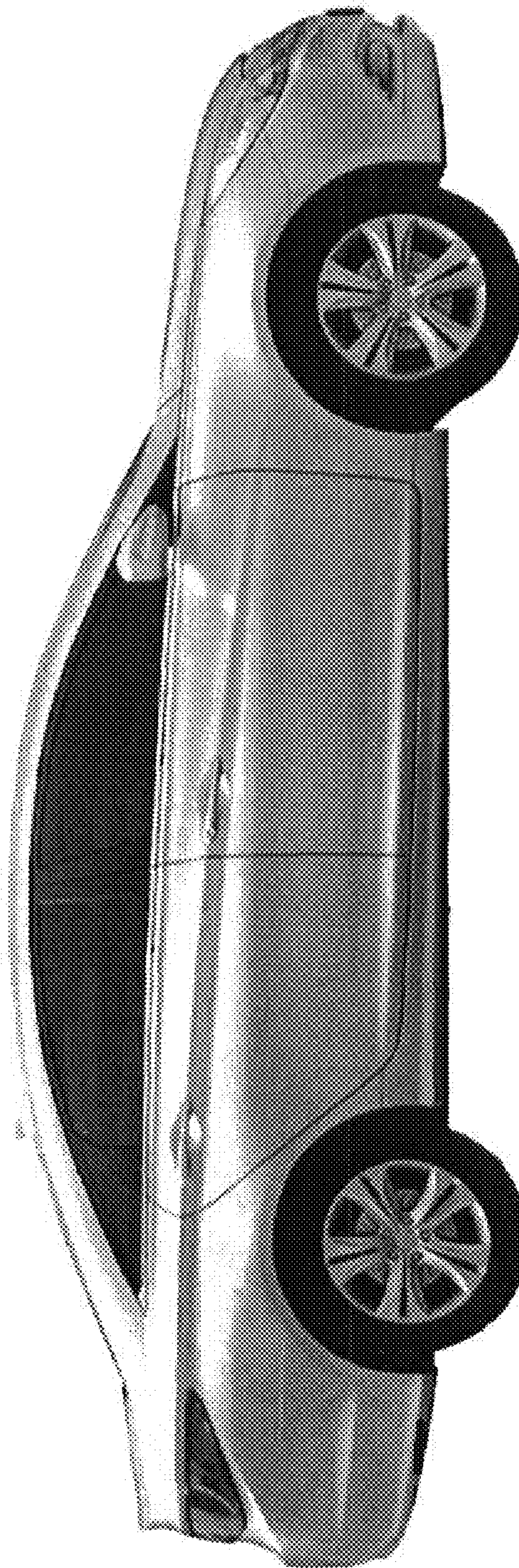

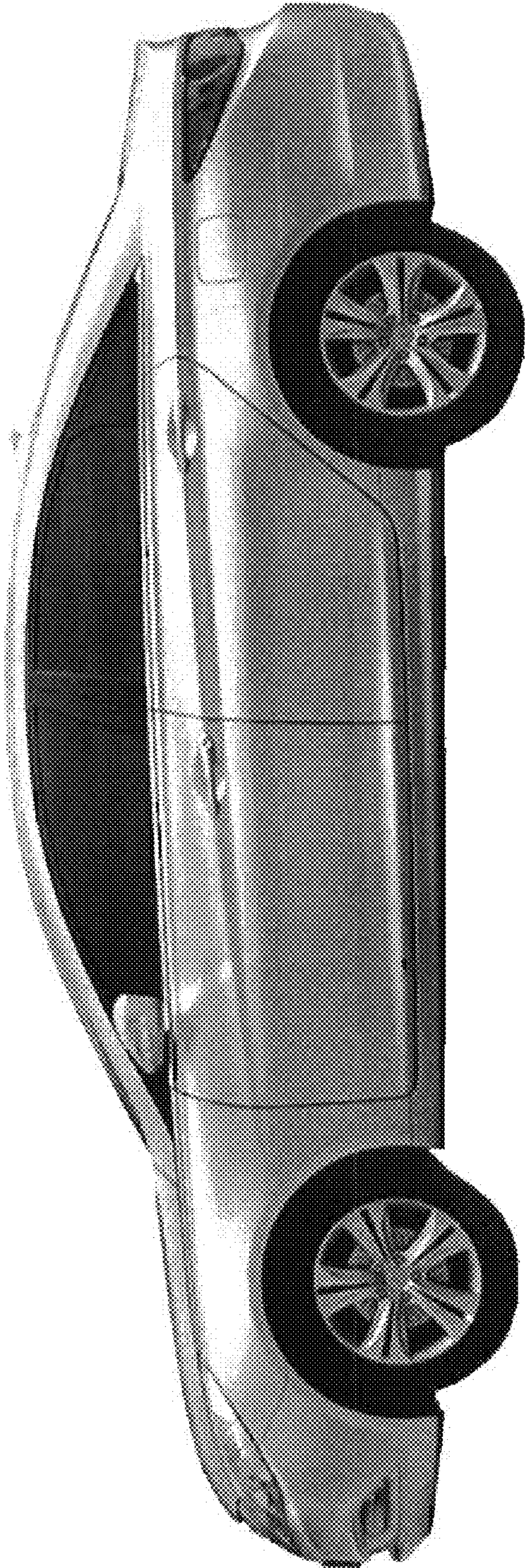
