FIG. 4 is a right side elevational view thereof;

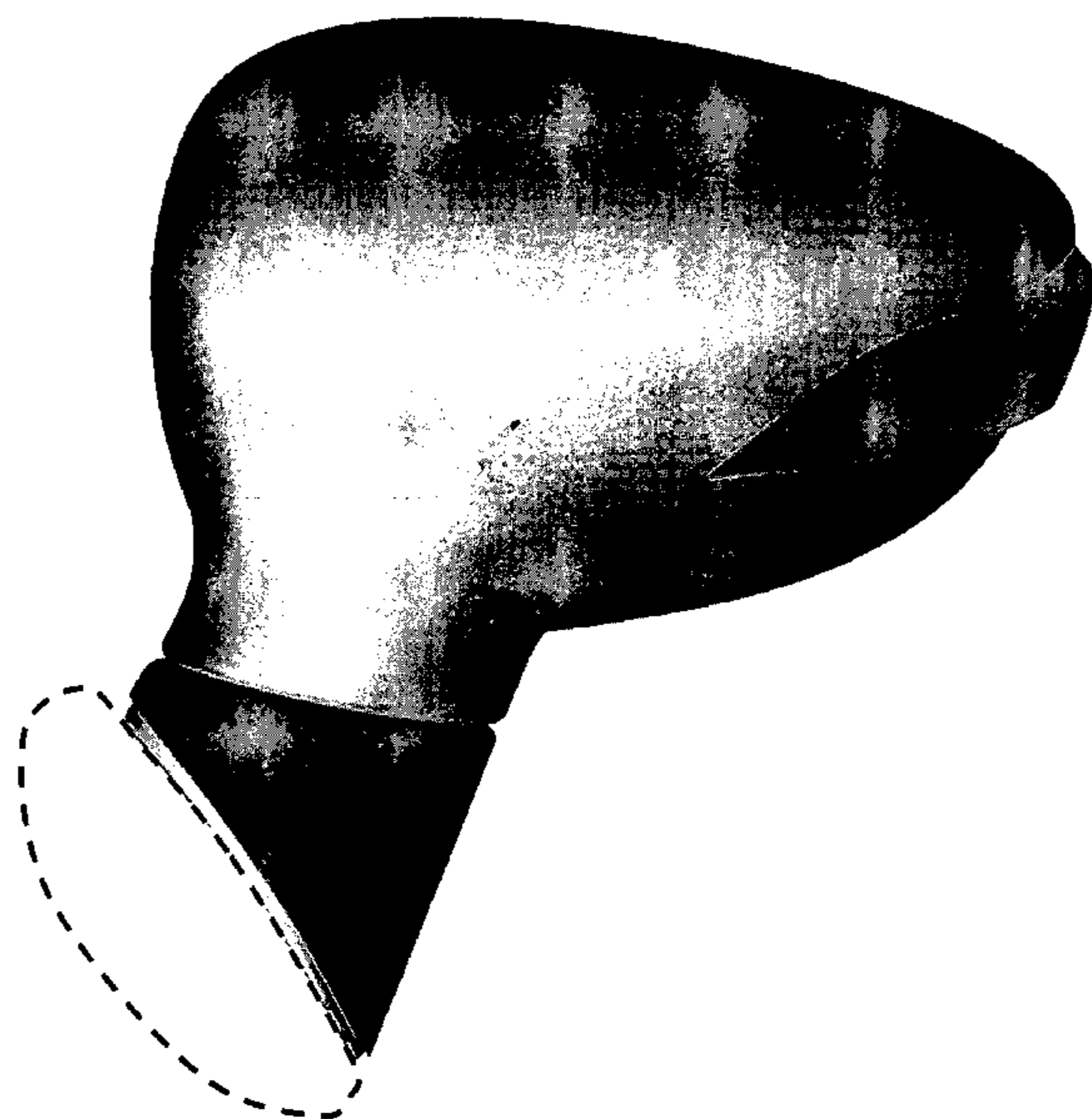
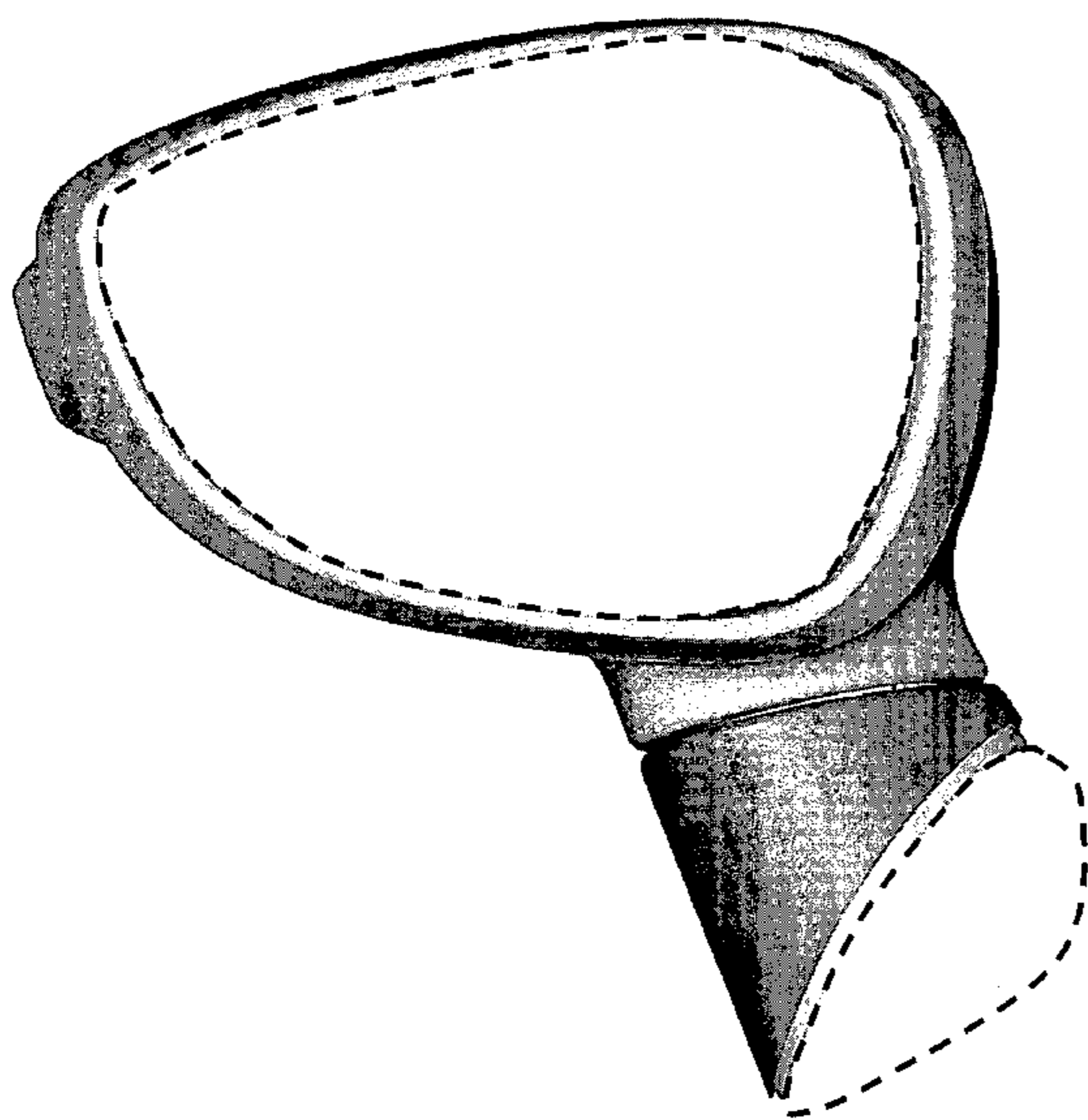
FIG. 5 is a top plan view thereof;

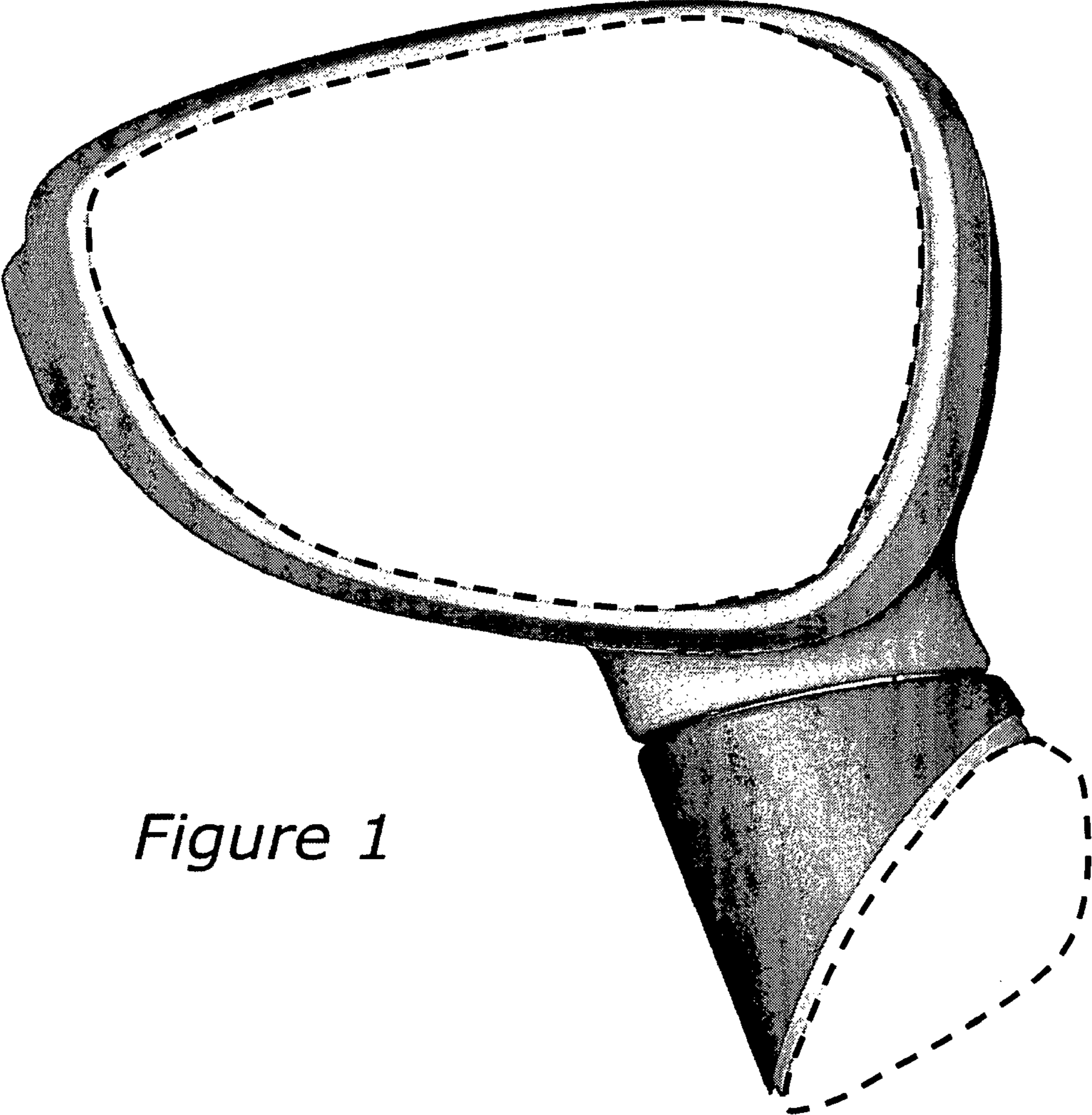
FIG. 6 is a bottom plan view thereof; and,

FIG. 7 is a rear elevational view thereof.

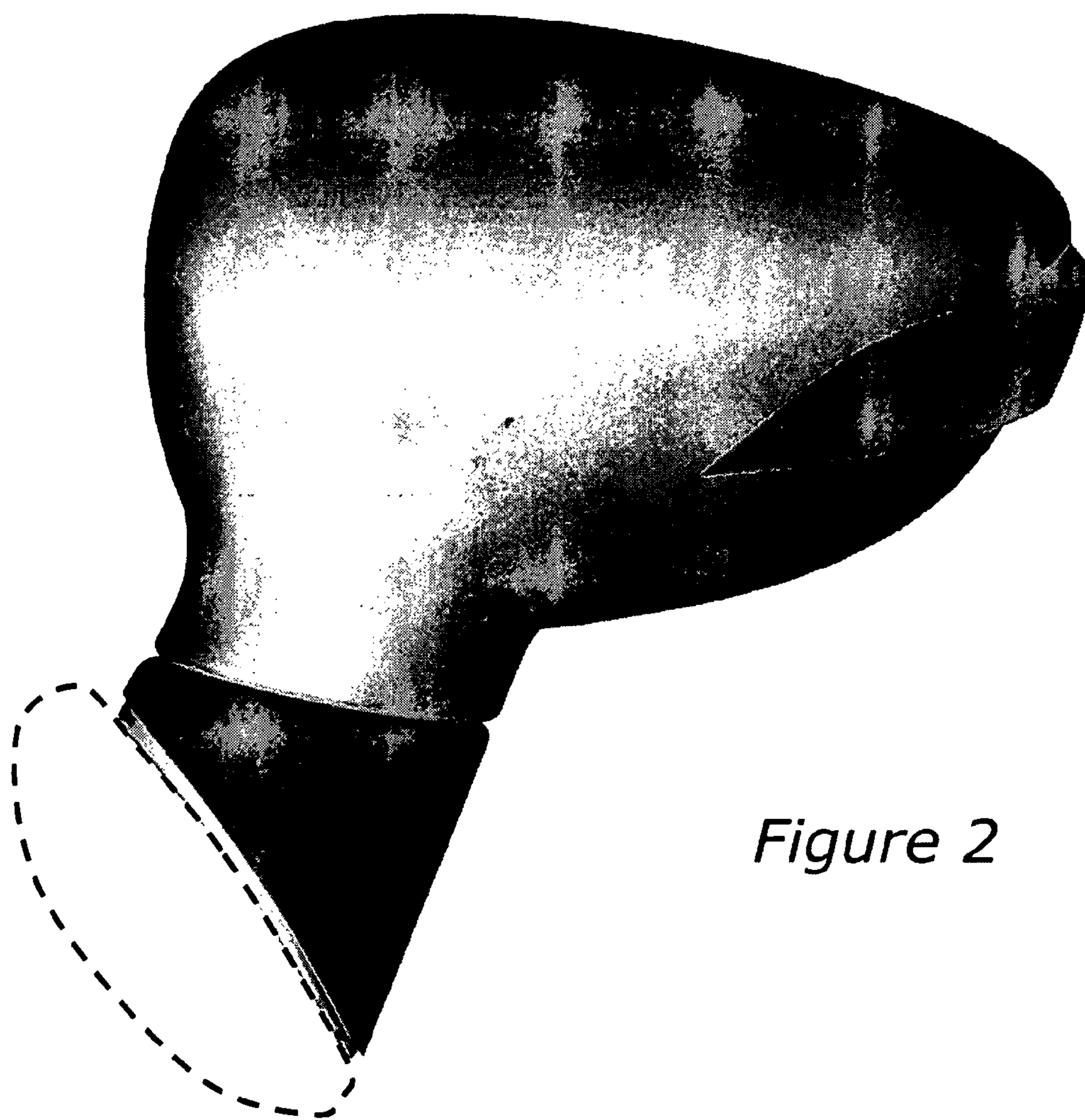
In the drawing figures, the broken lines show the inner boundary of the vehicle side mirror and form no part of the claimed design.

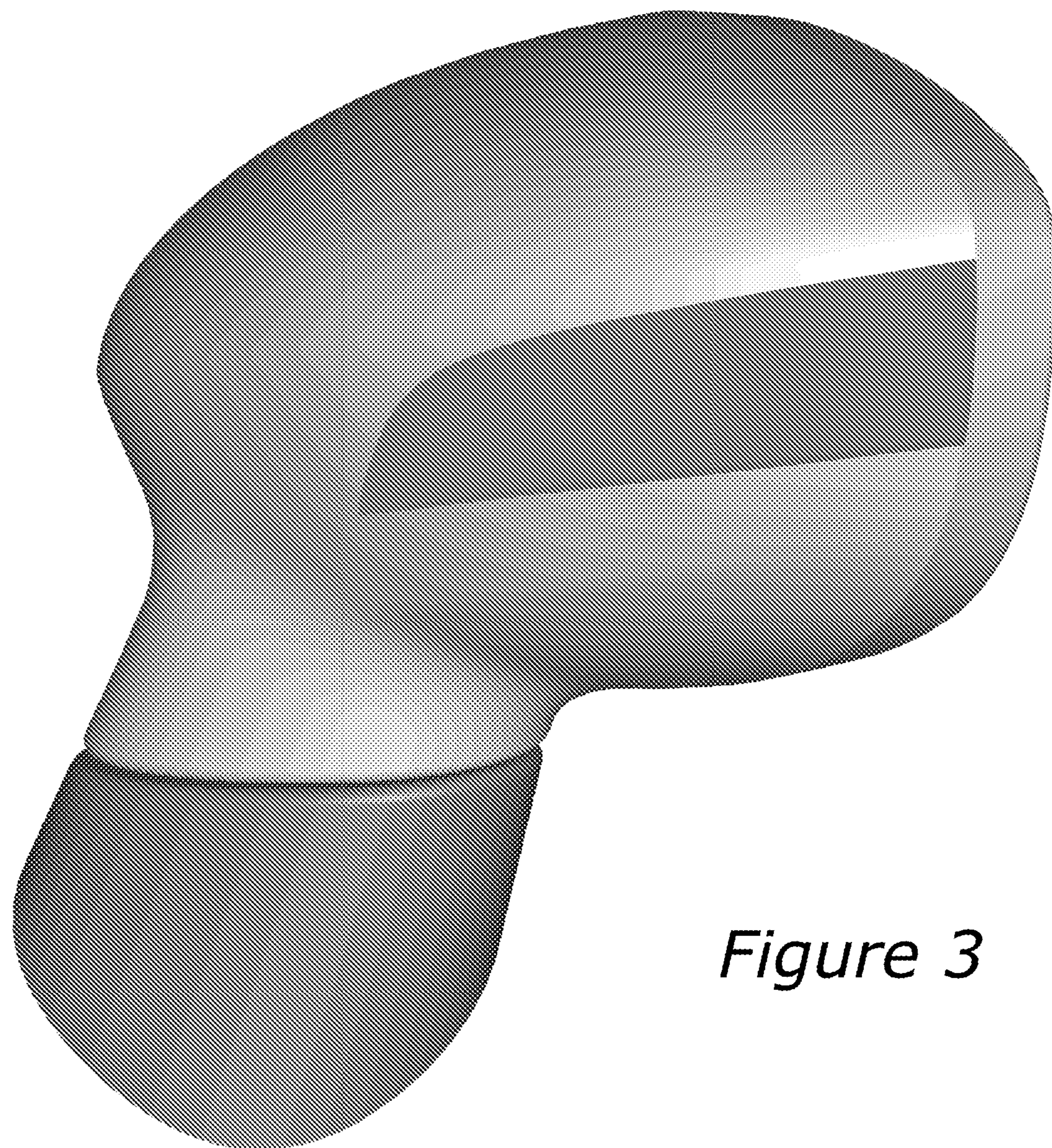




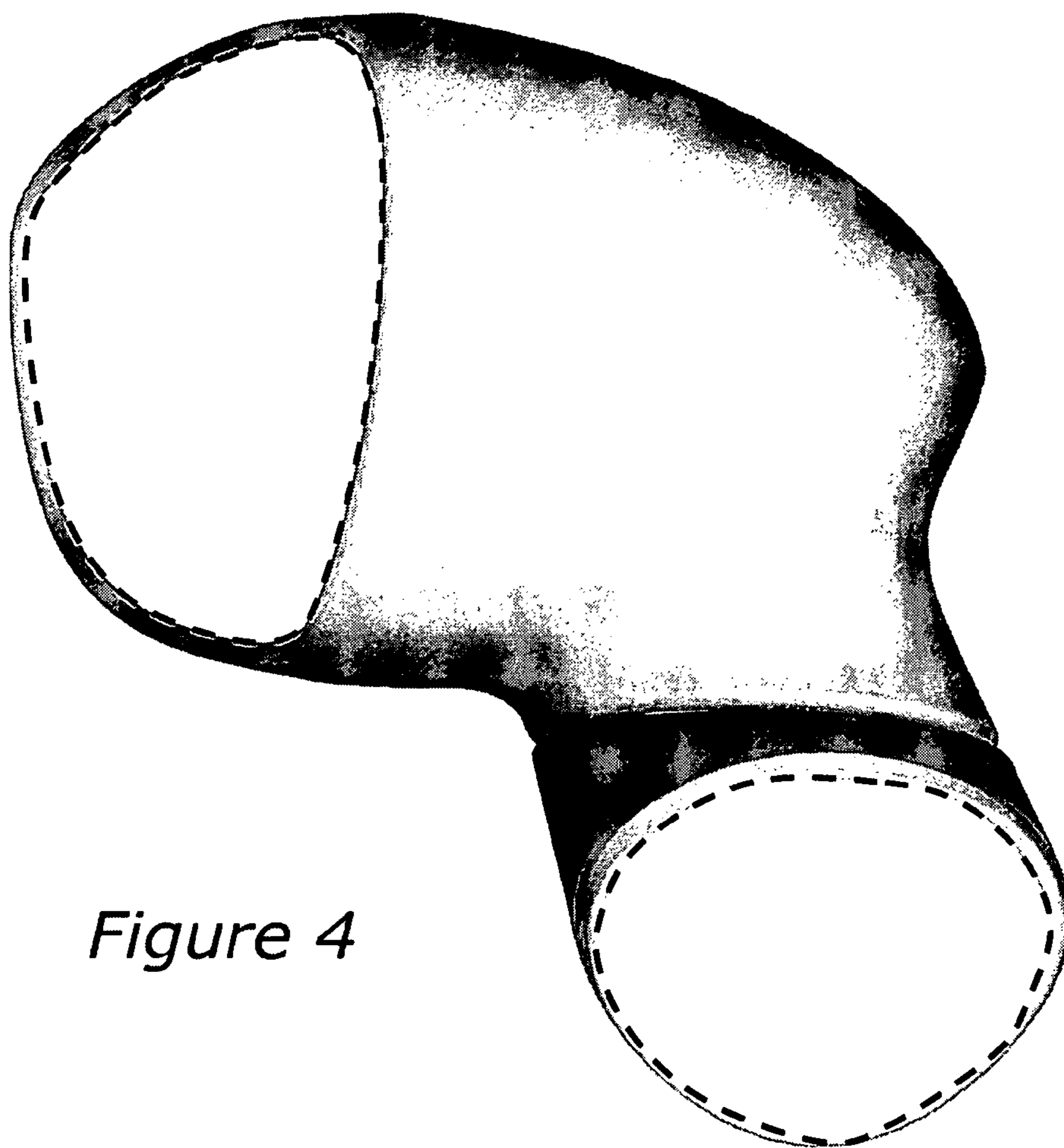

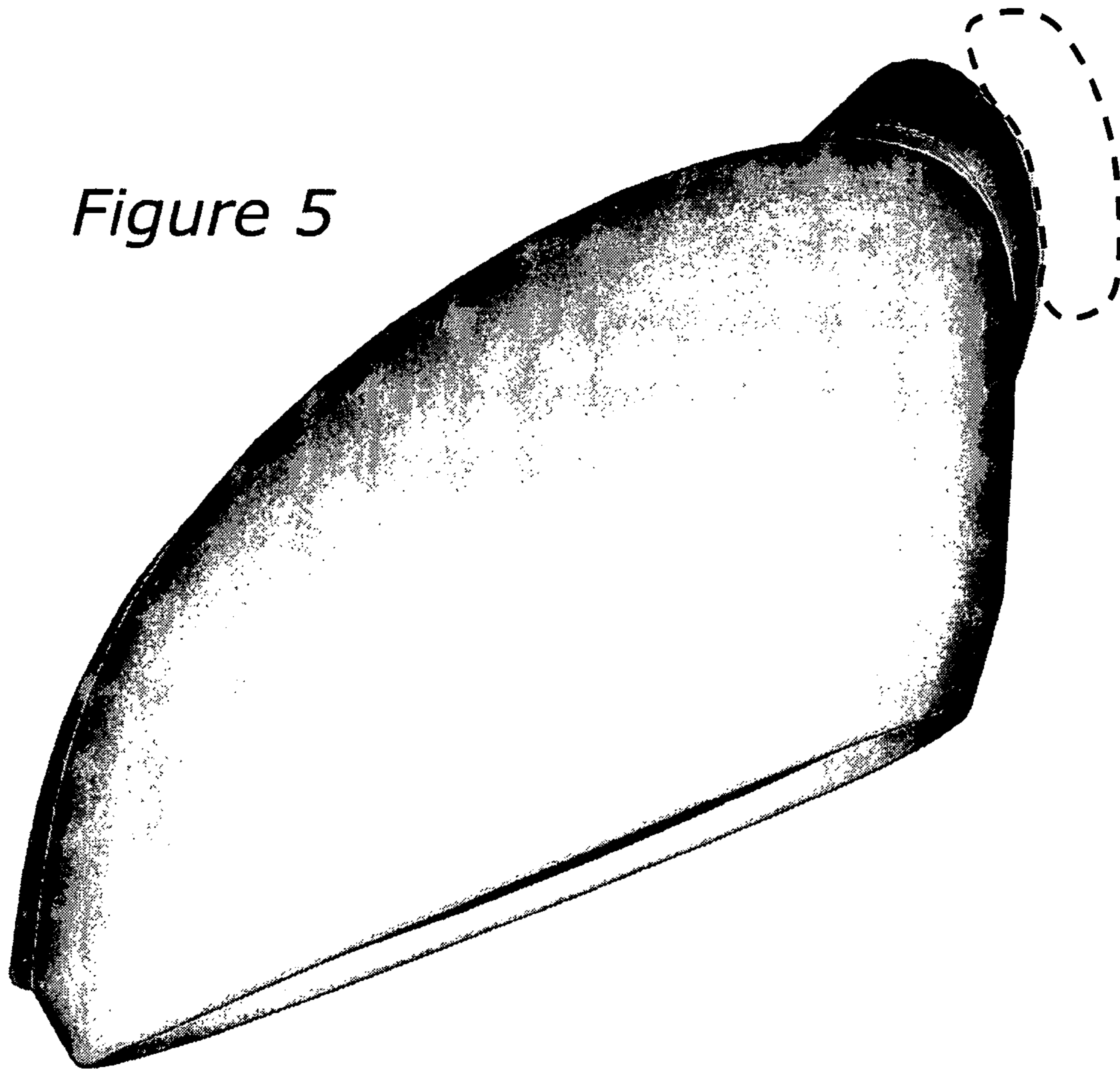


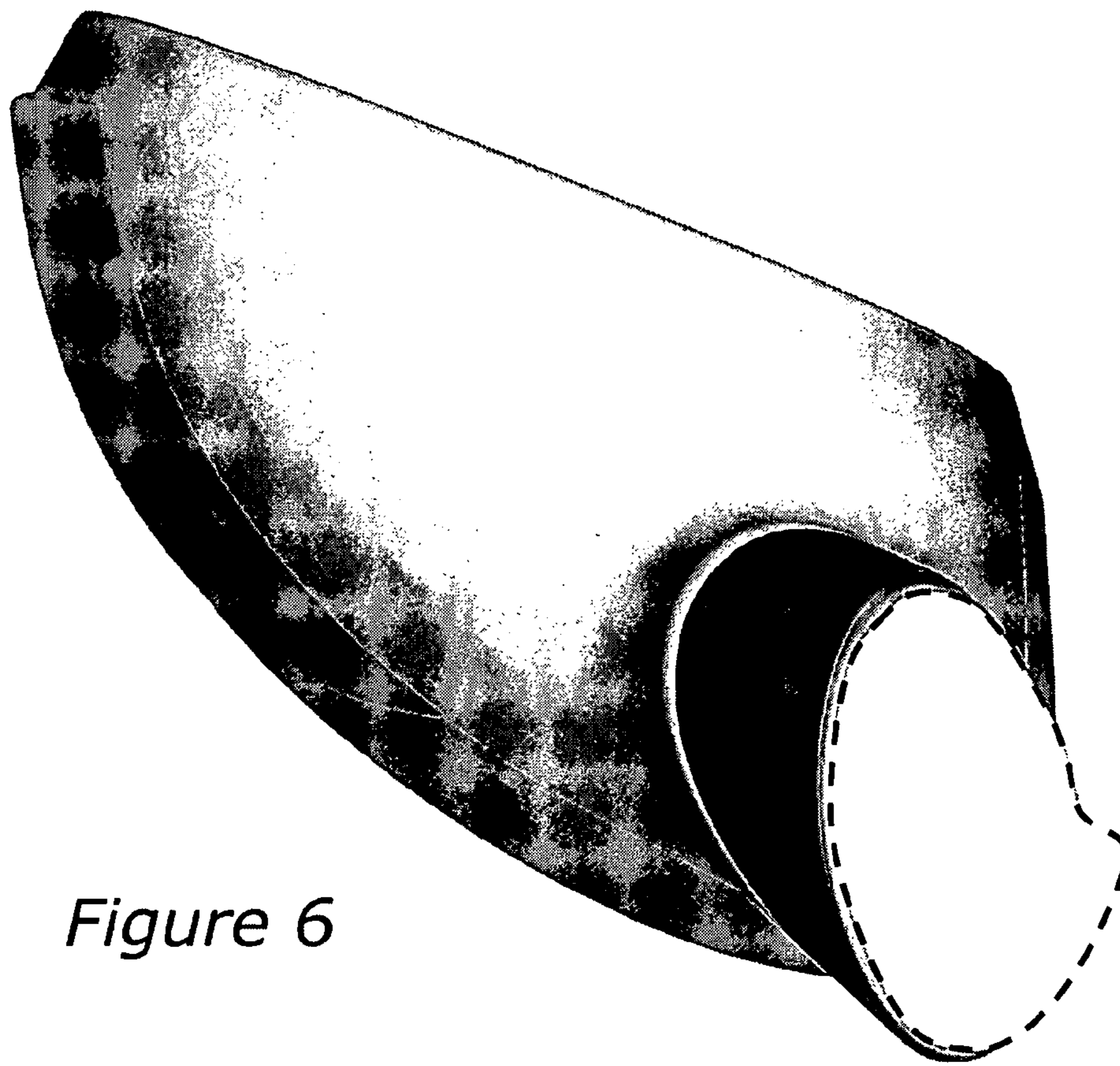

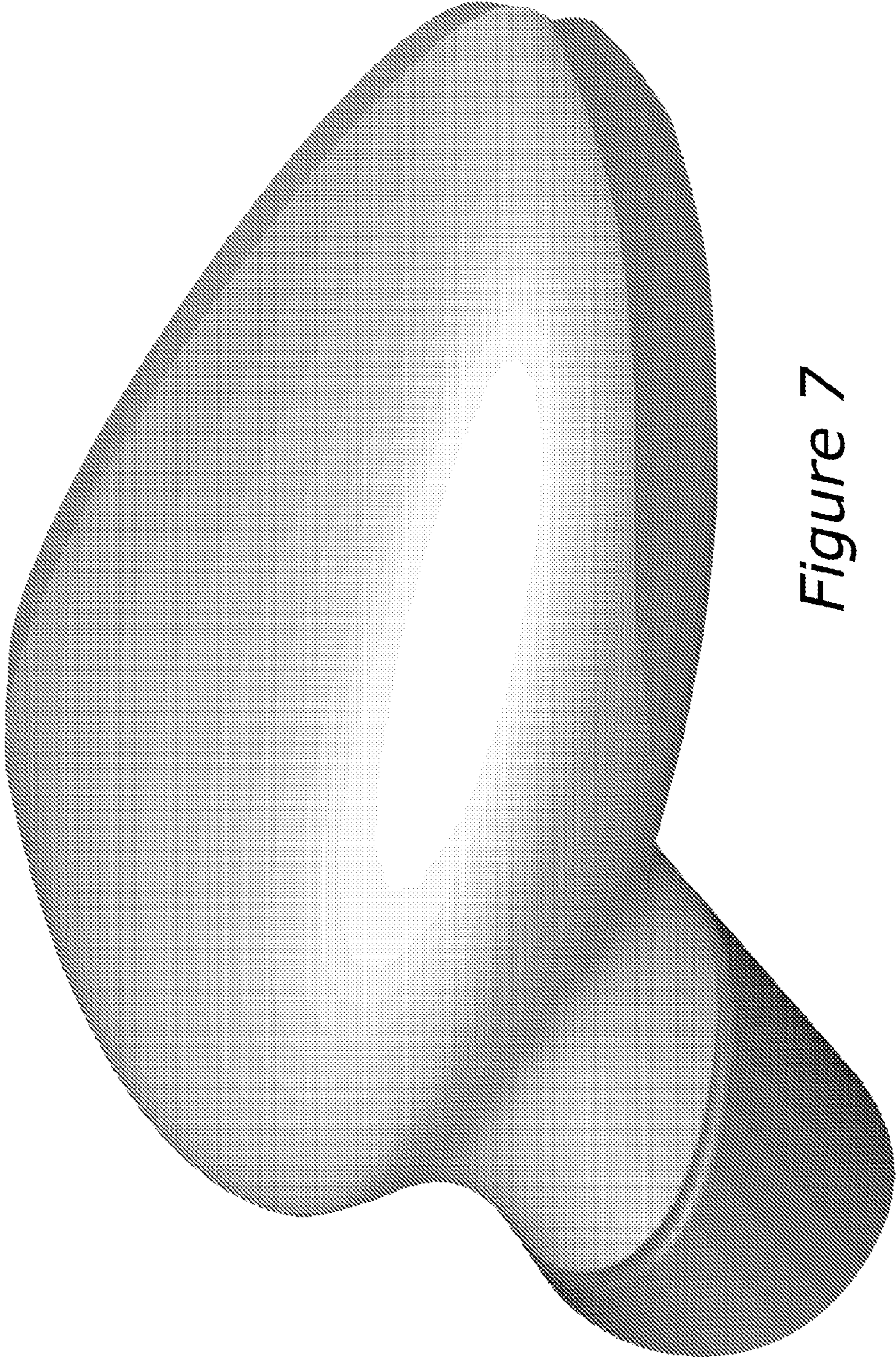
