DESCRIPTION

FIG. 7 is a bottom plan view thereof;

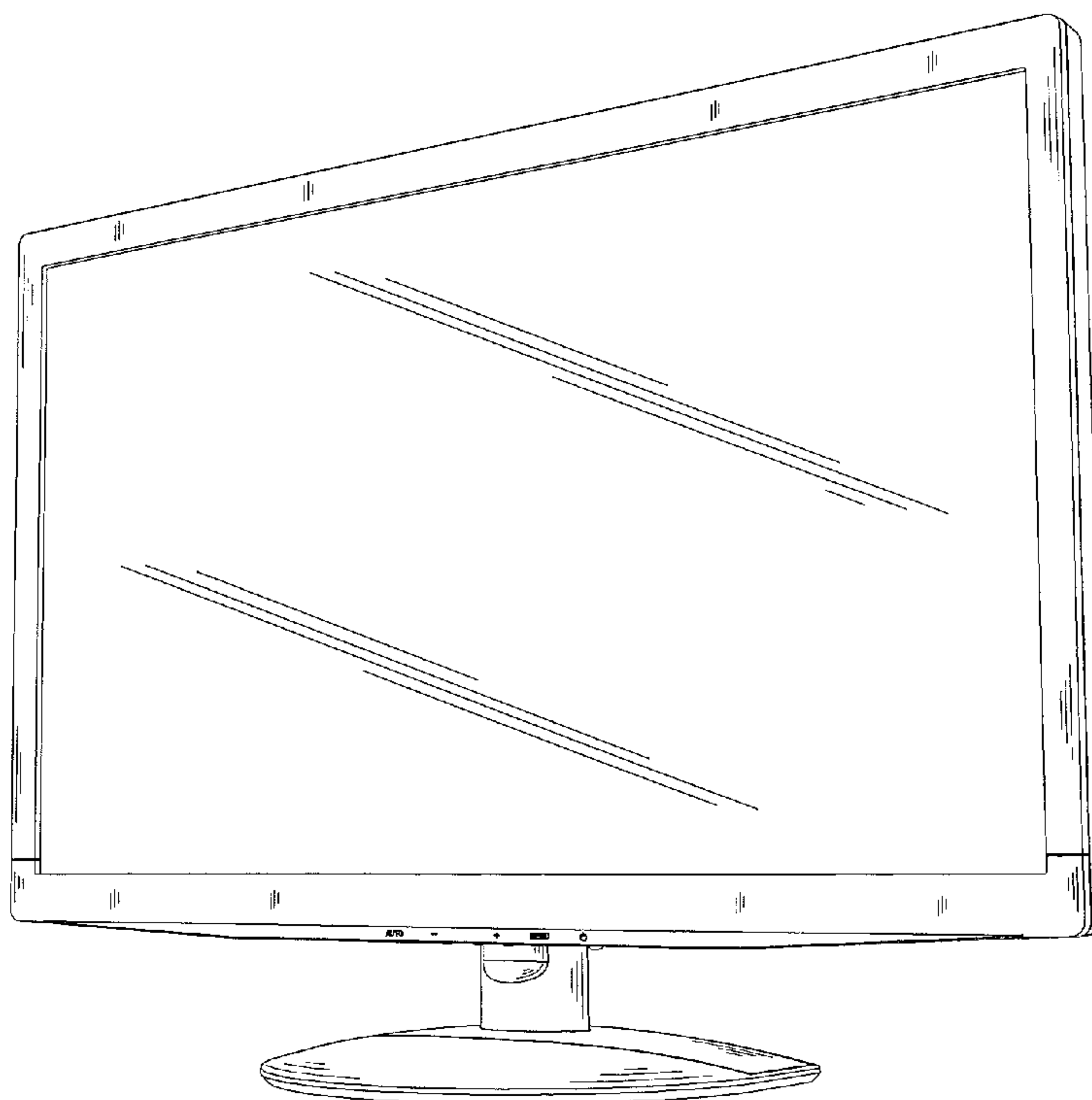
FIG. 8 is a second perspective view of a liquid crystal display

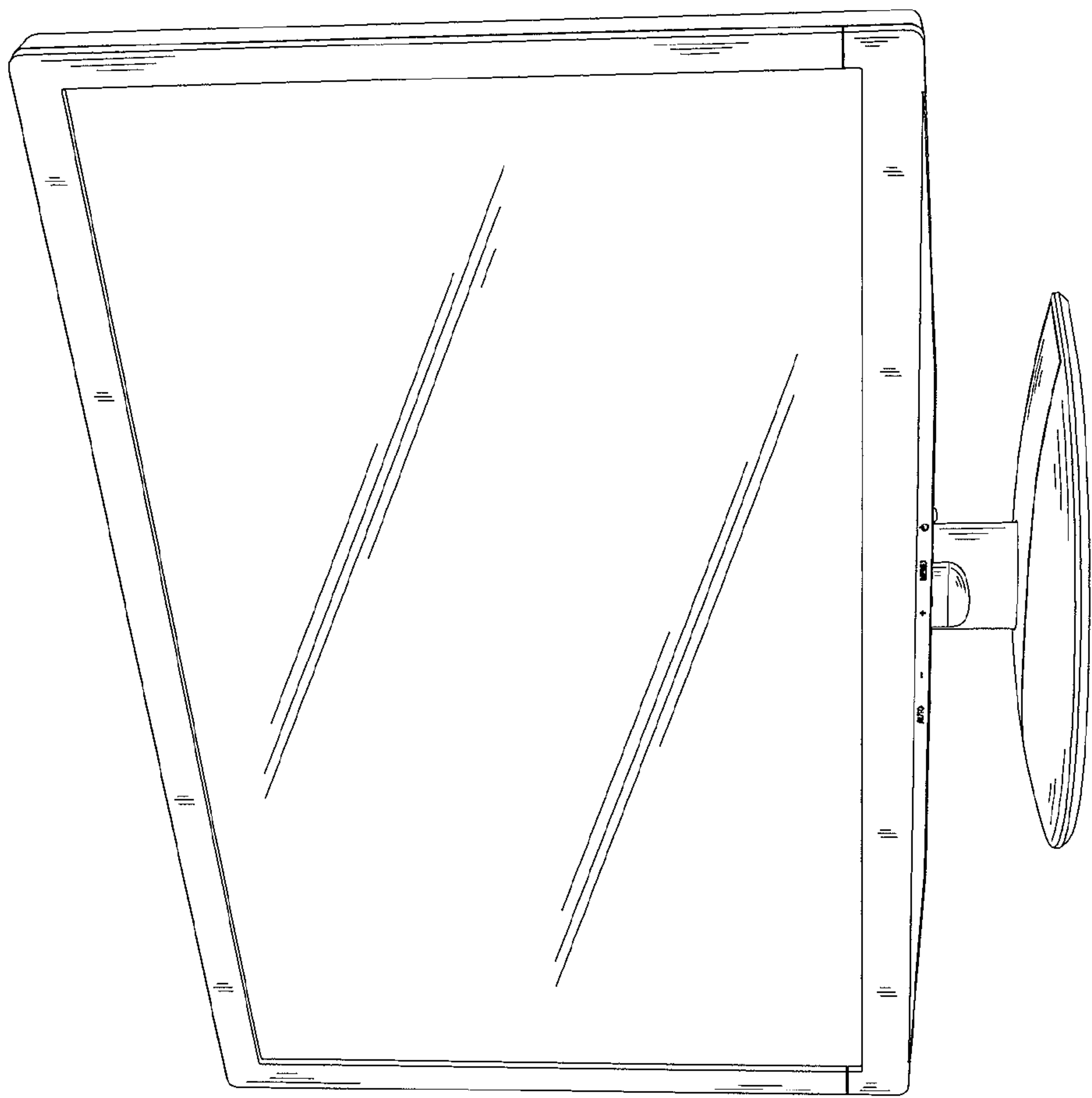

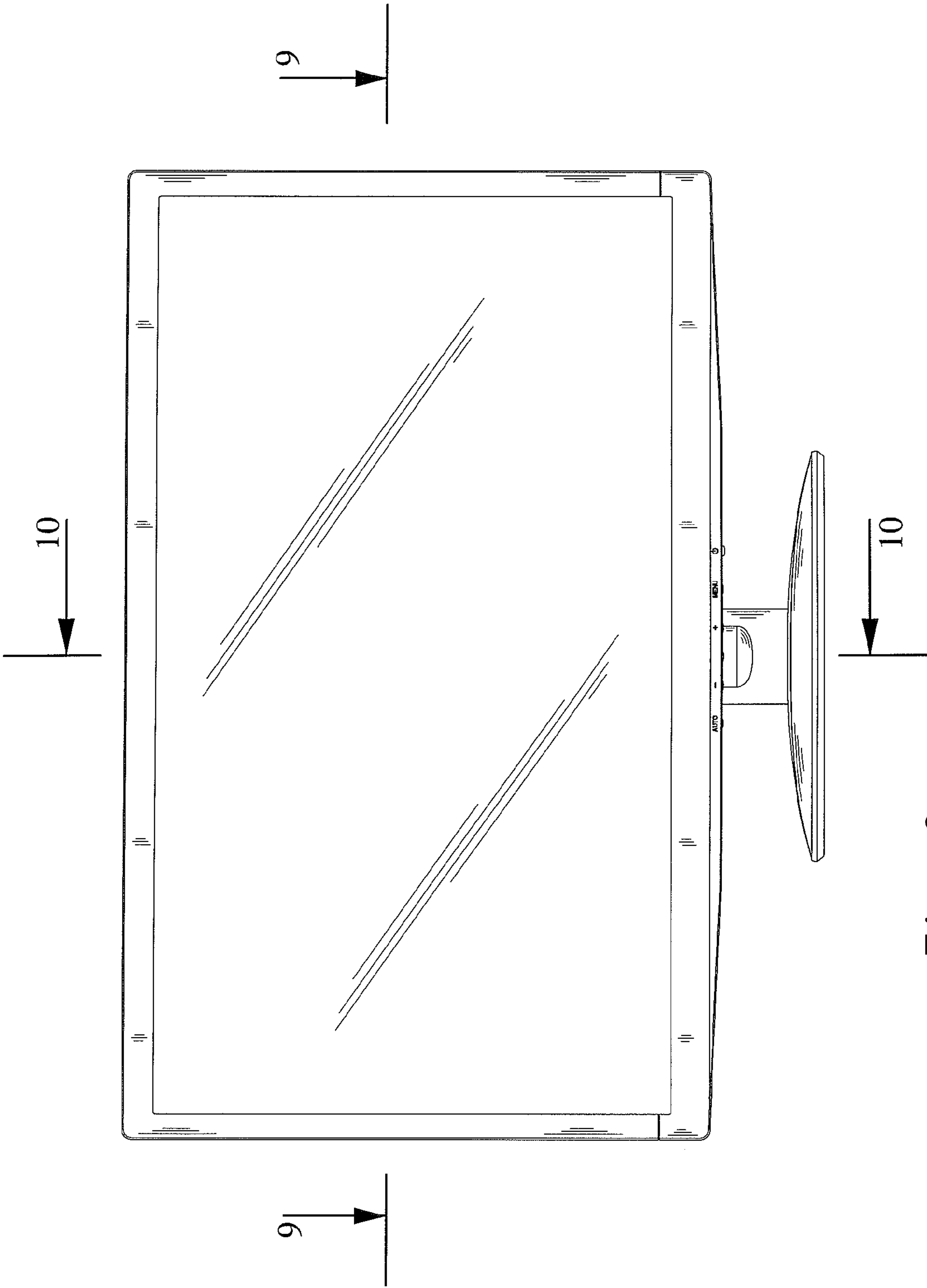

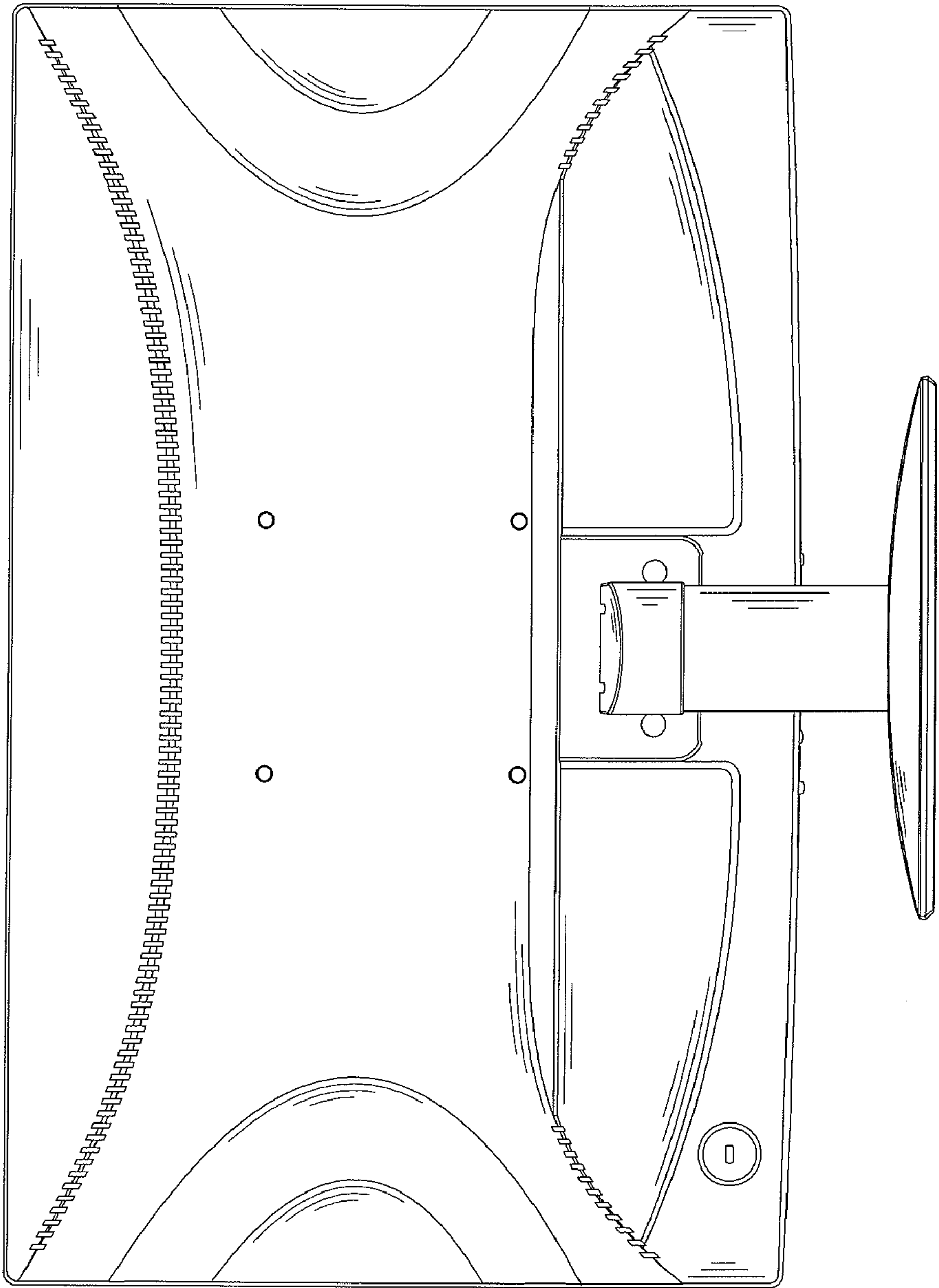

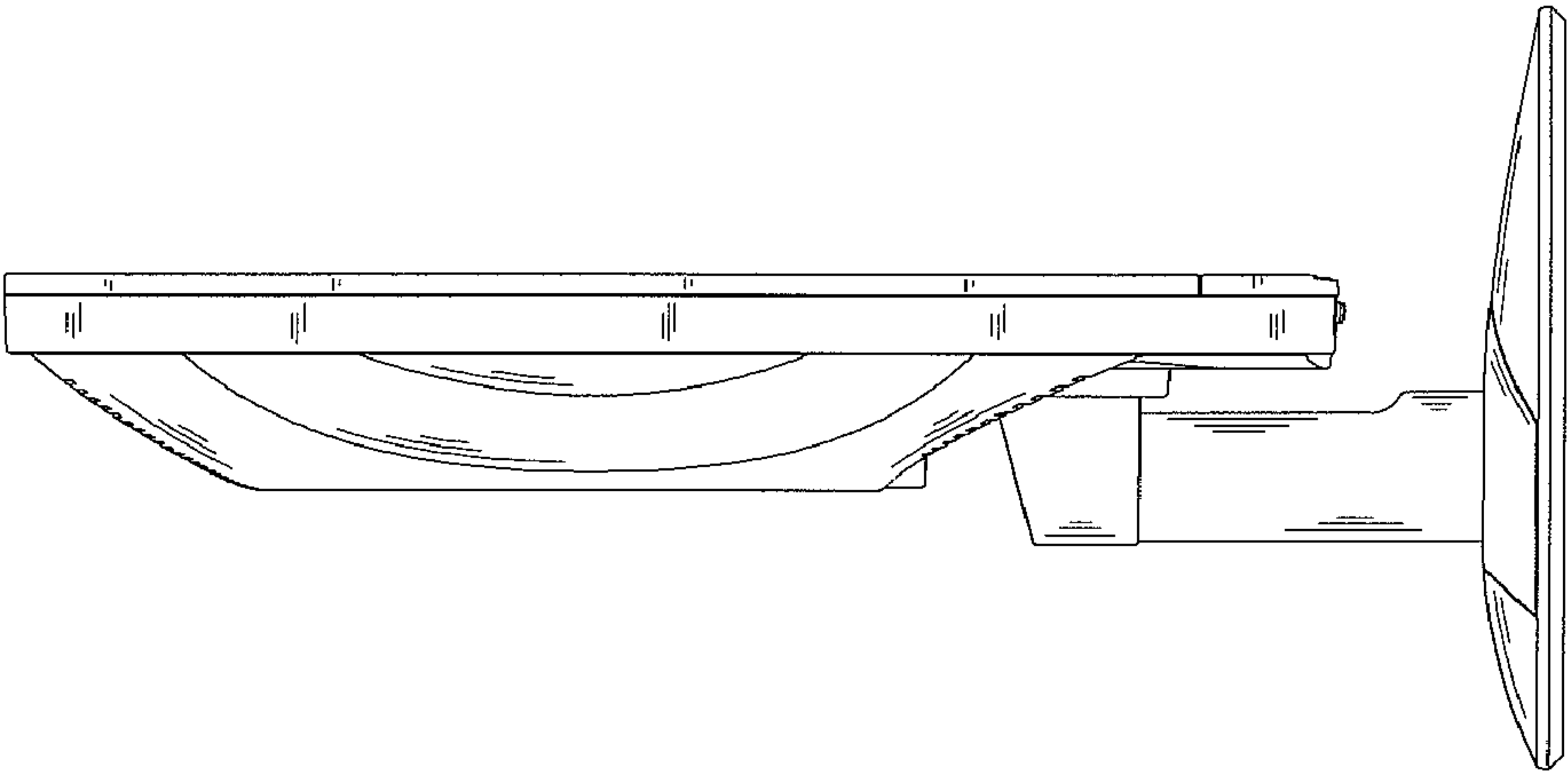

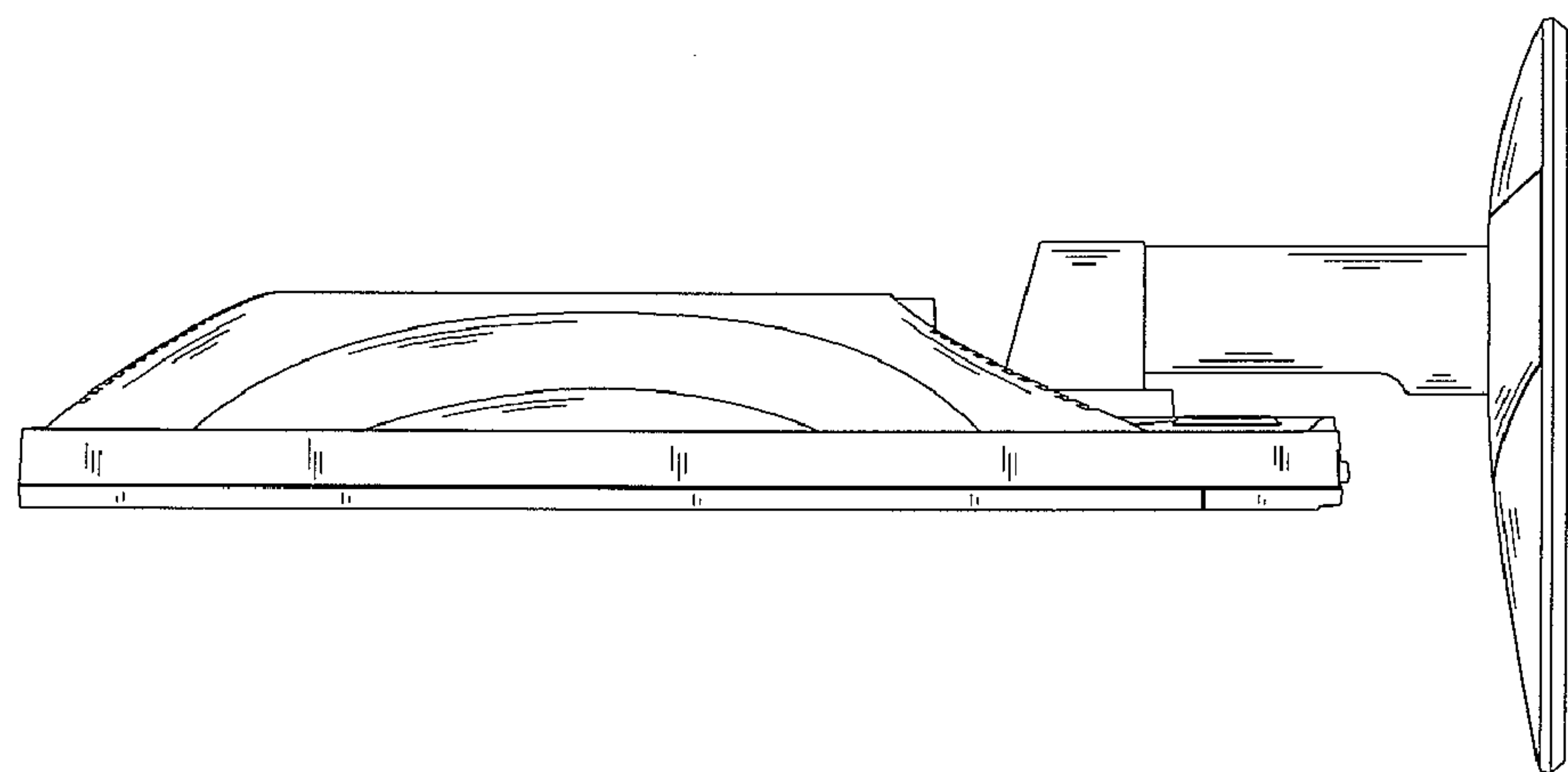

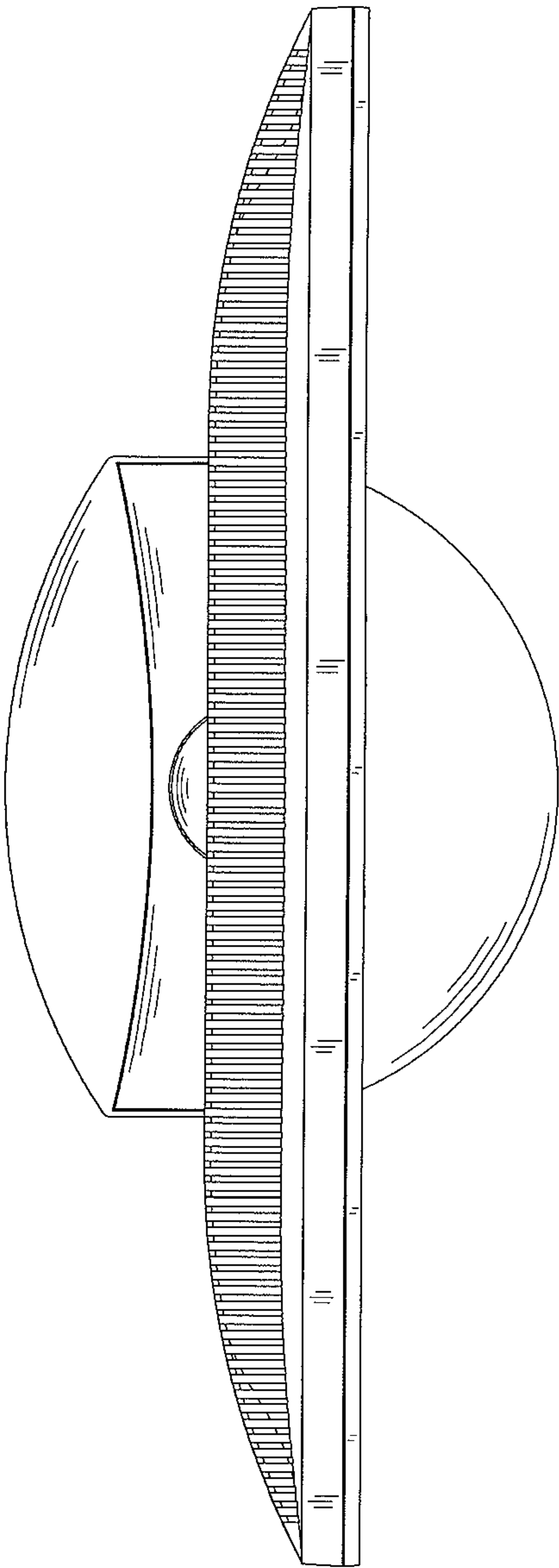

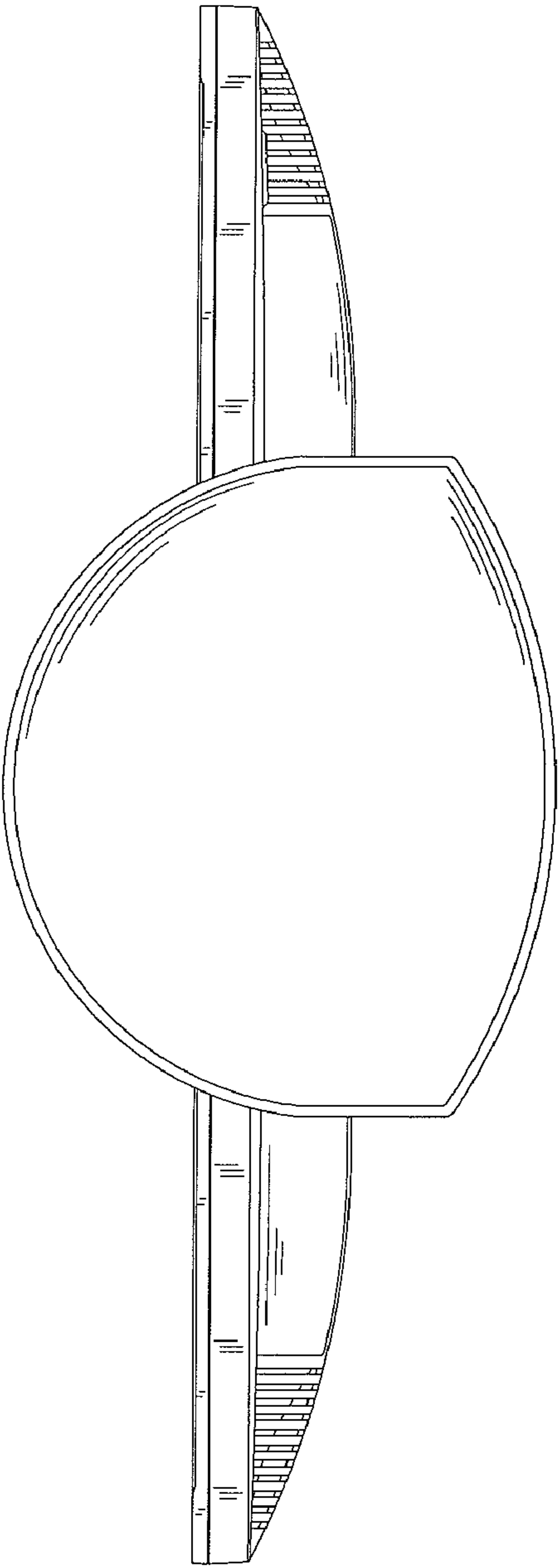

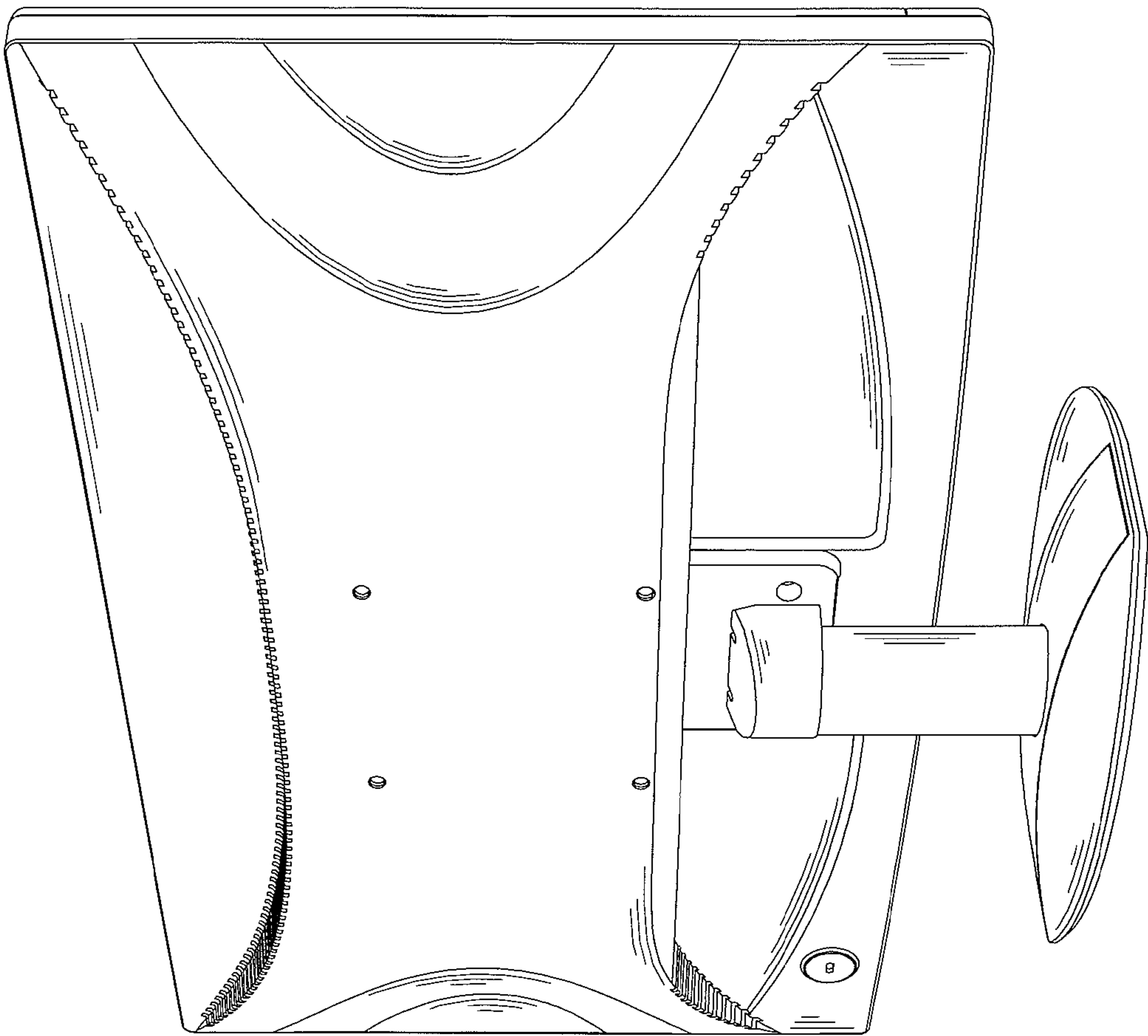

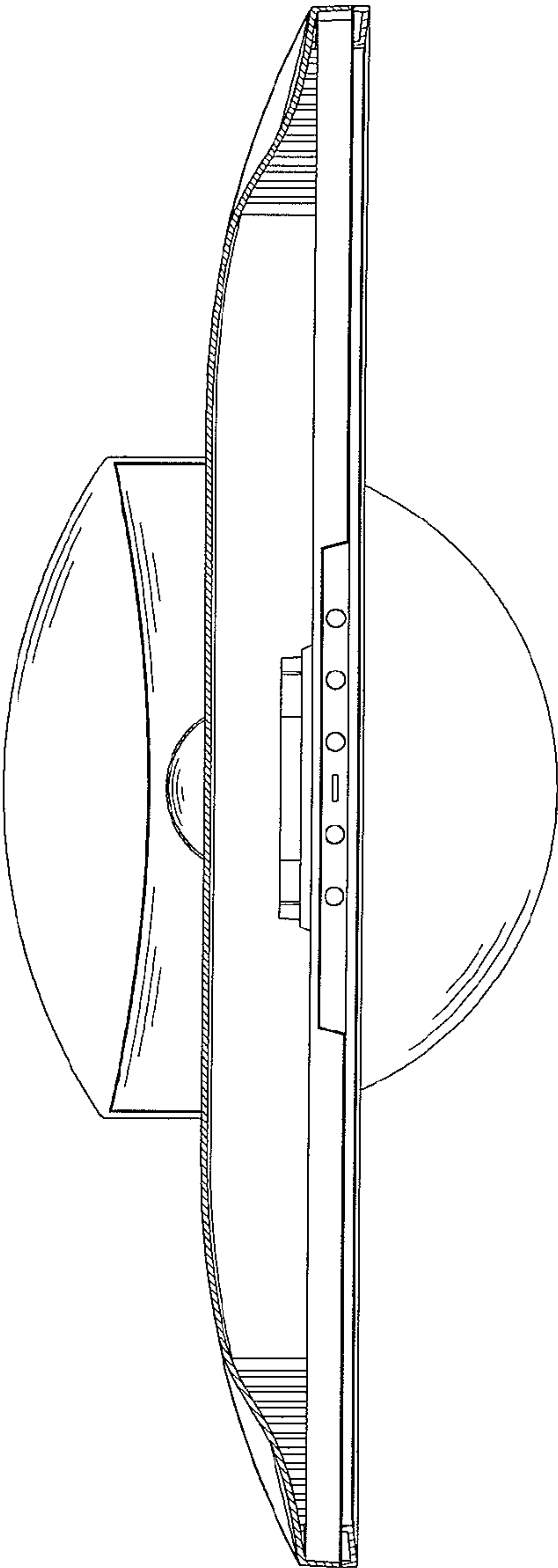

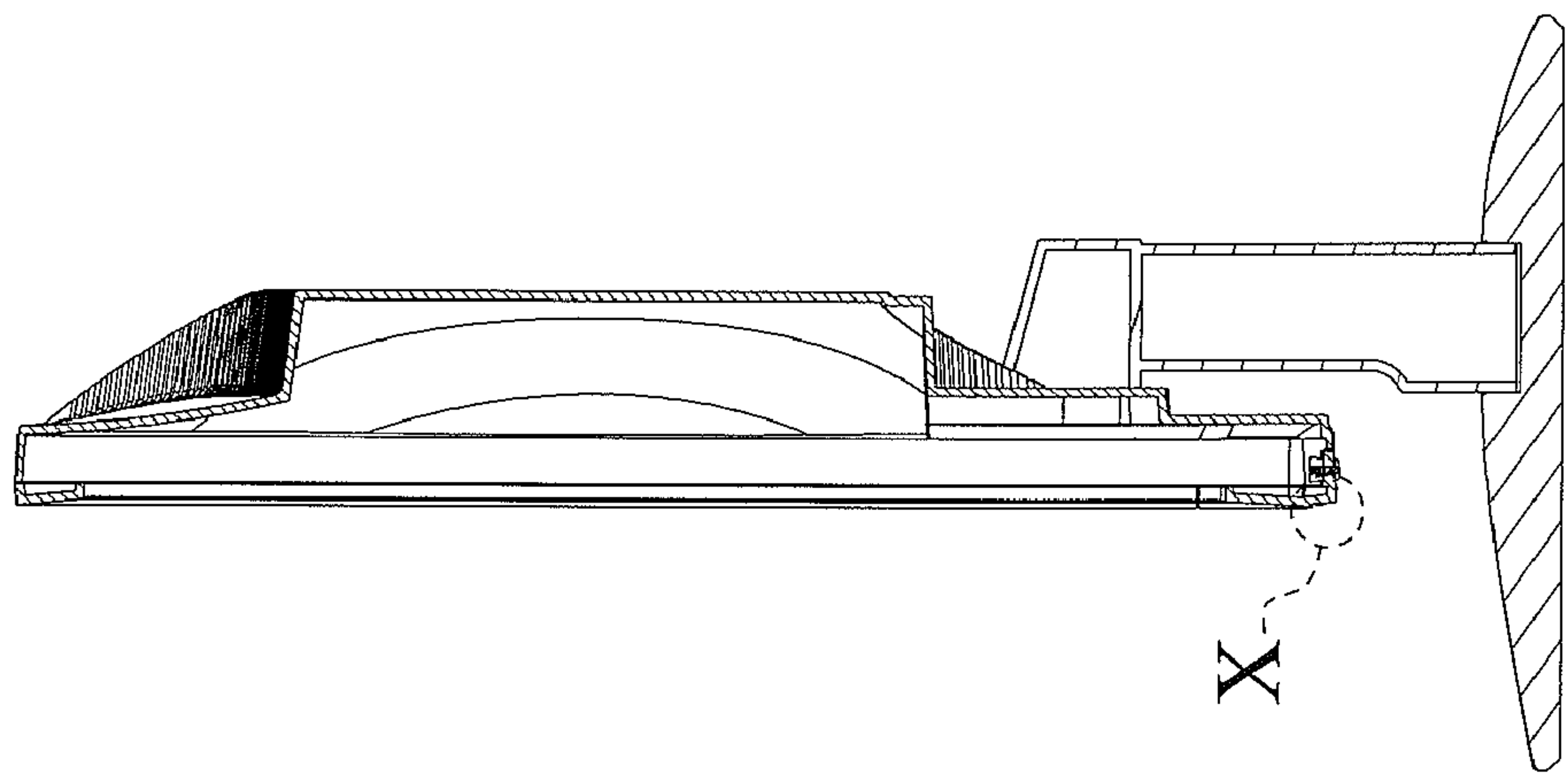

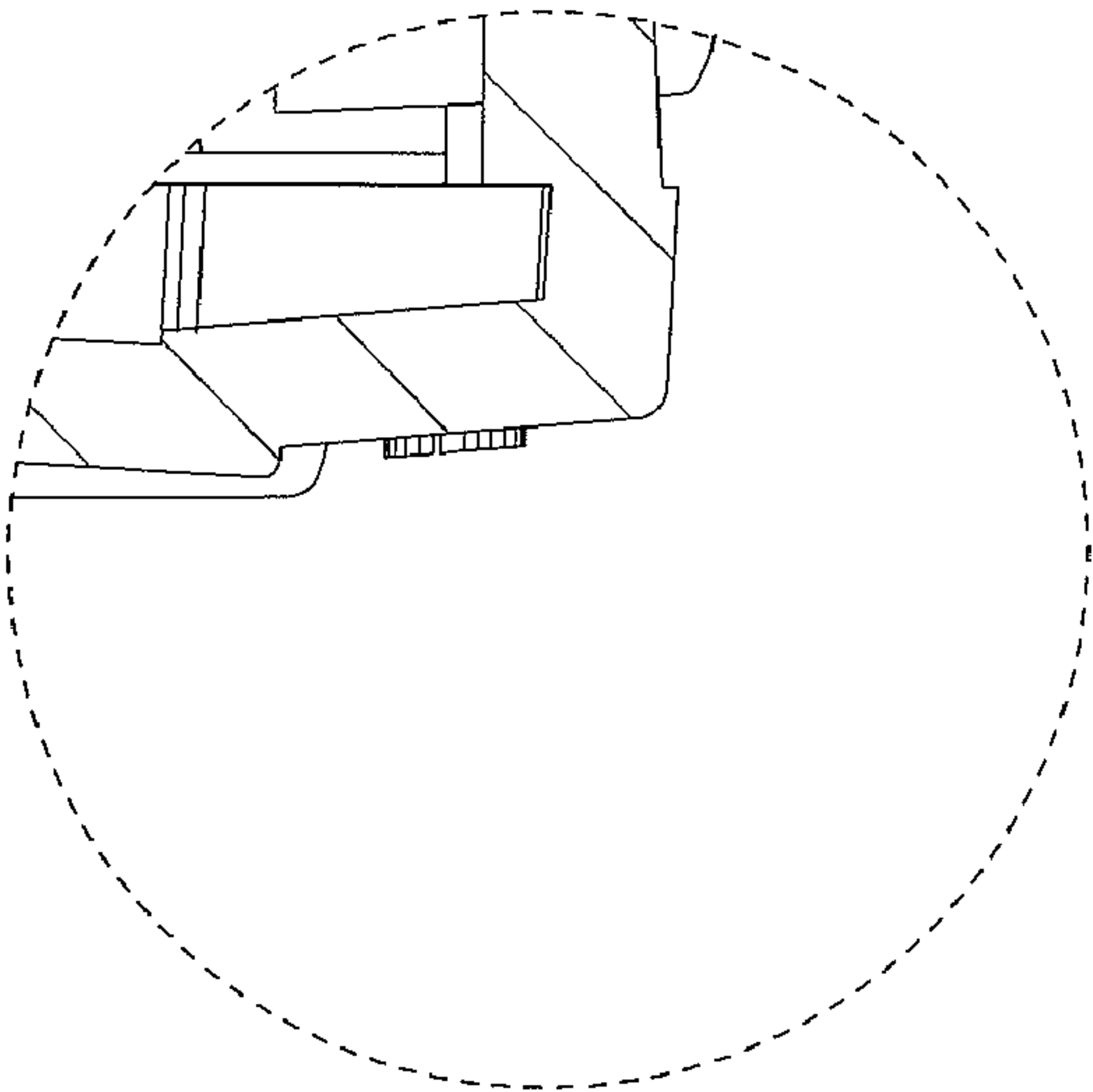
