(57) **CLAIM**

The ornamental design for a transitional icon for a portion of a display screen, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a transitional icon for a portion of a display screen showing the new design in a first state;

FIG. 11 is a front view thereof in an eleventh state;

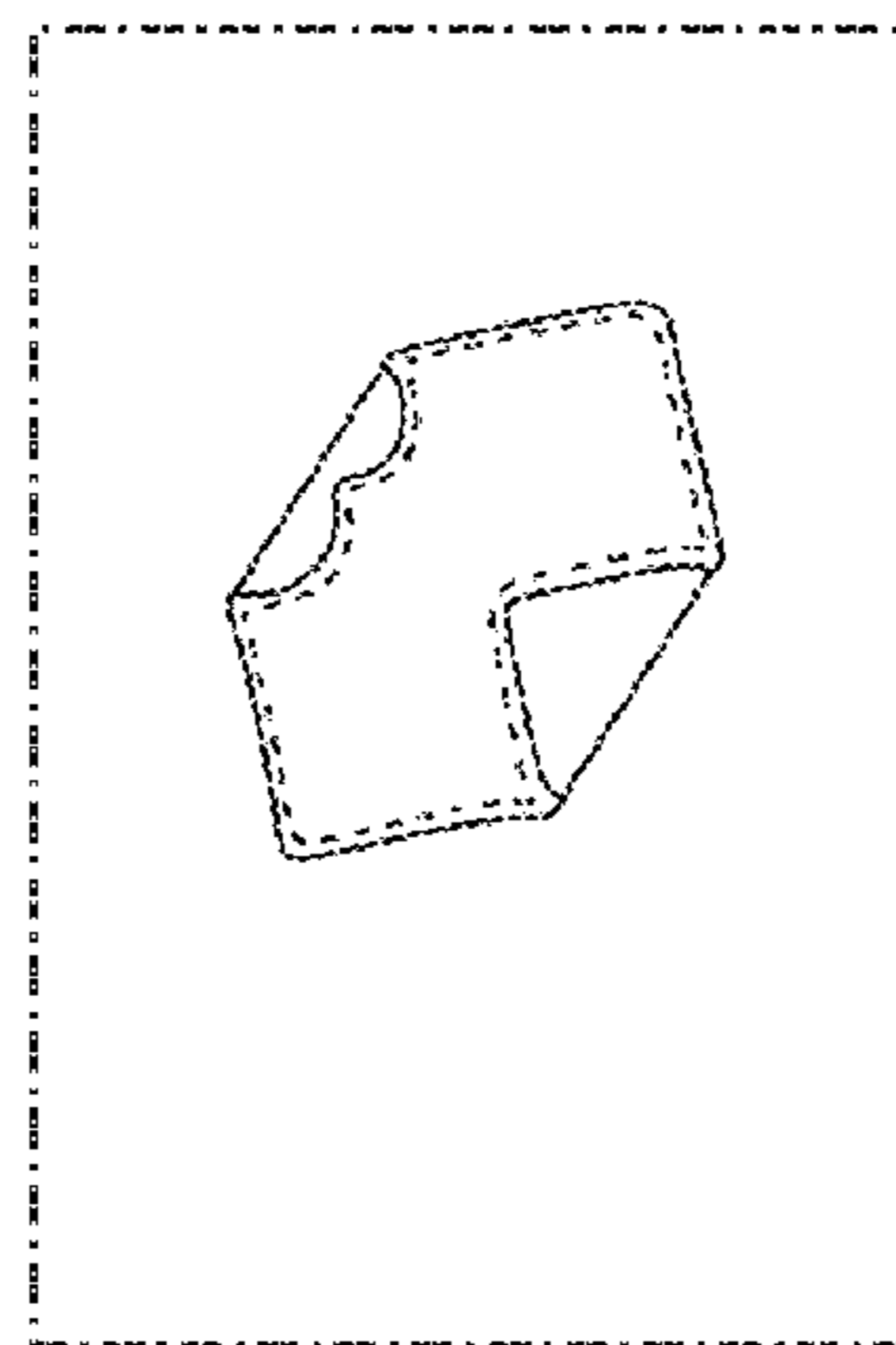
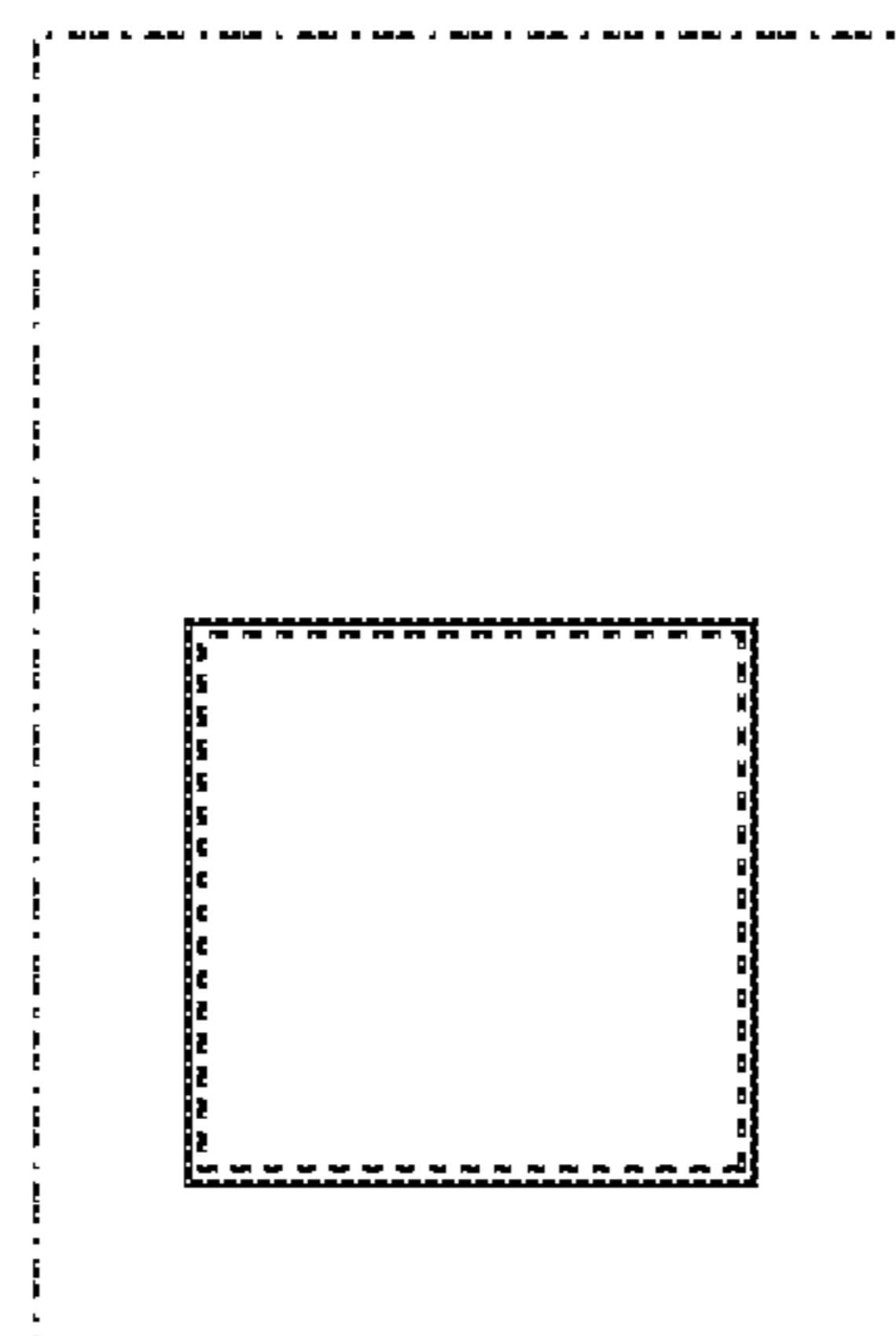


FIG. 12 is a front view thereof in a twelfth state;

The broken line showing an area within the transitional icon in FIGS. 1-14 and the broken line showing the portion of a display screen in FIGS. 1-27 are for the purpose of illustrating environmental structure and form no part of the claimed design.

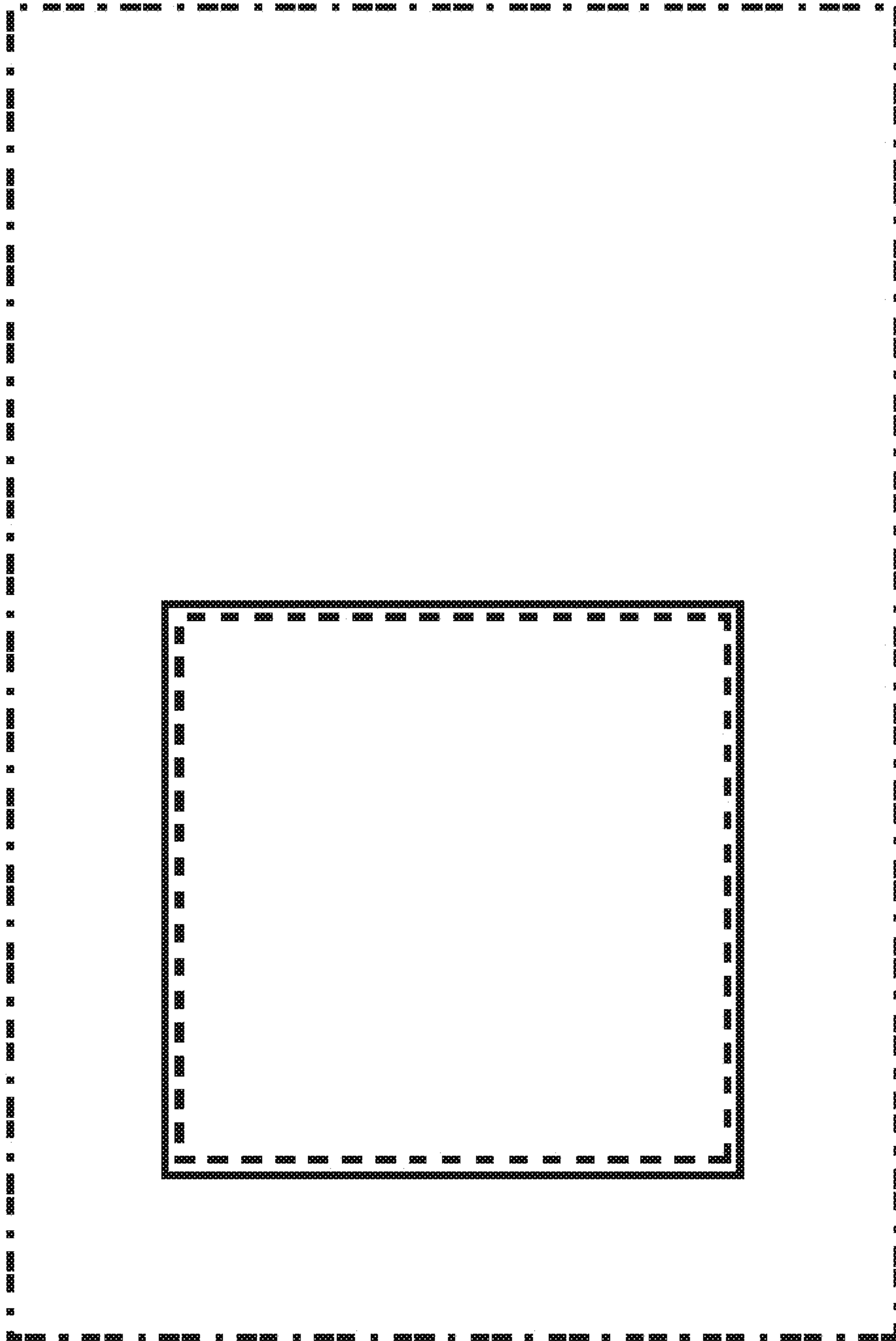

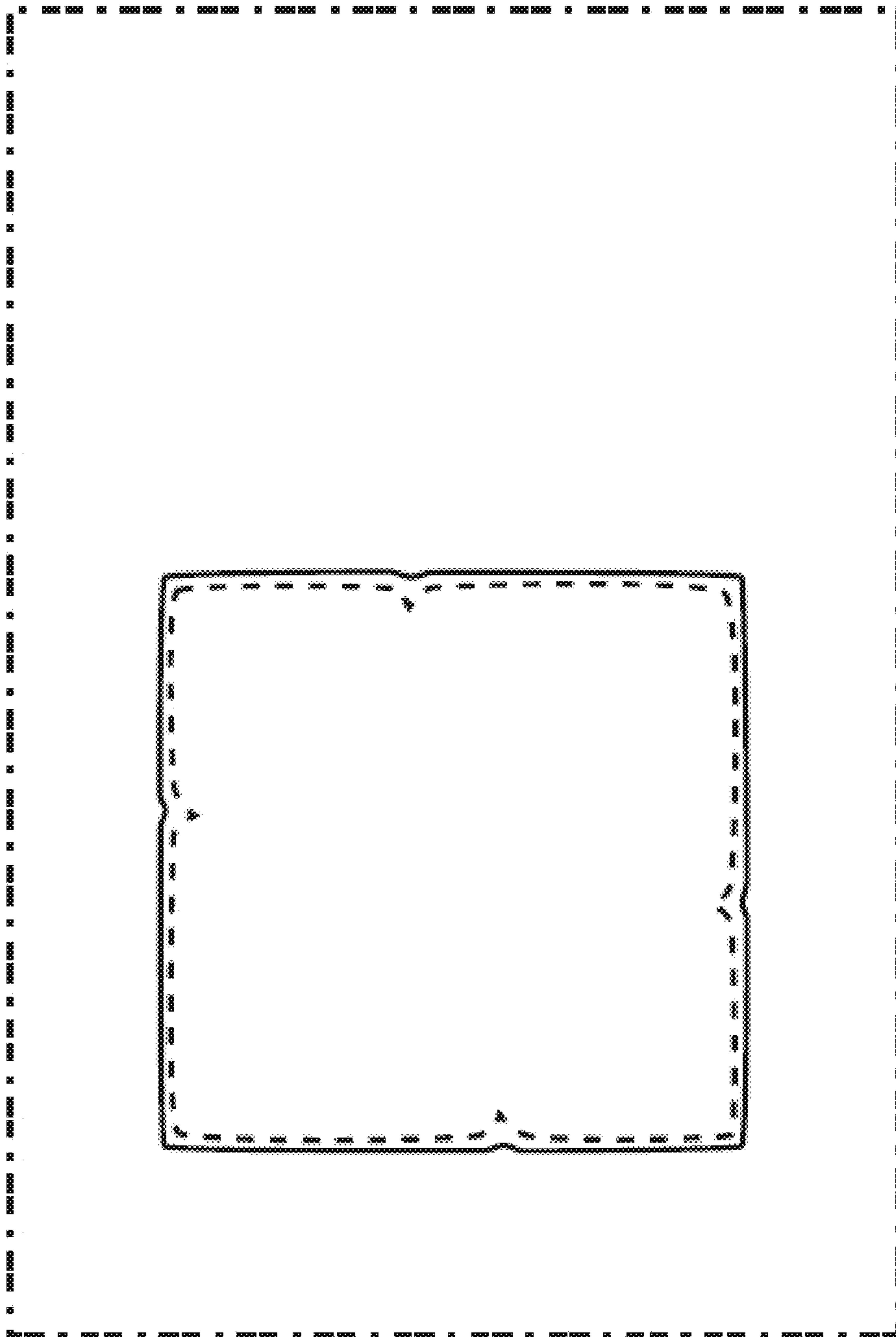

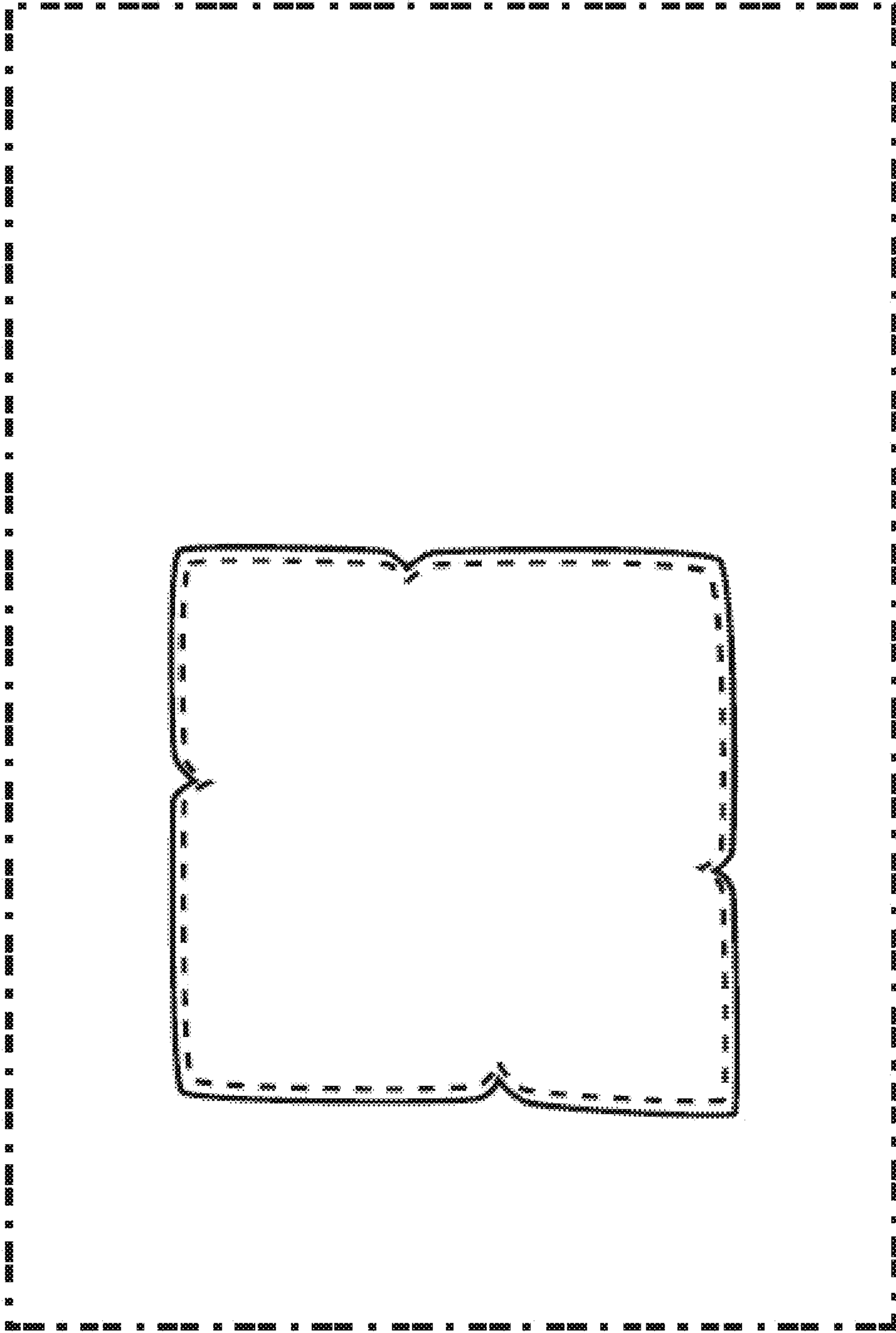

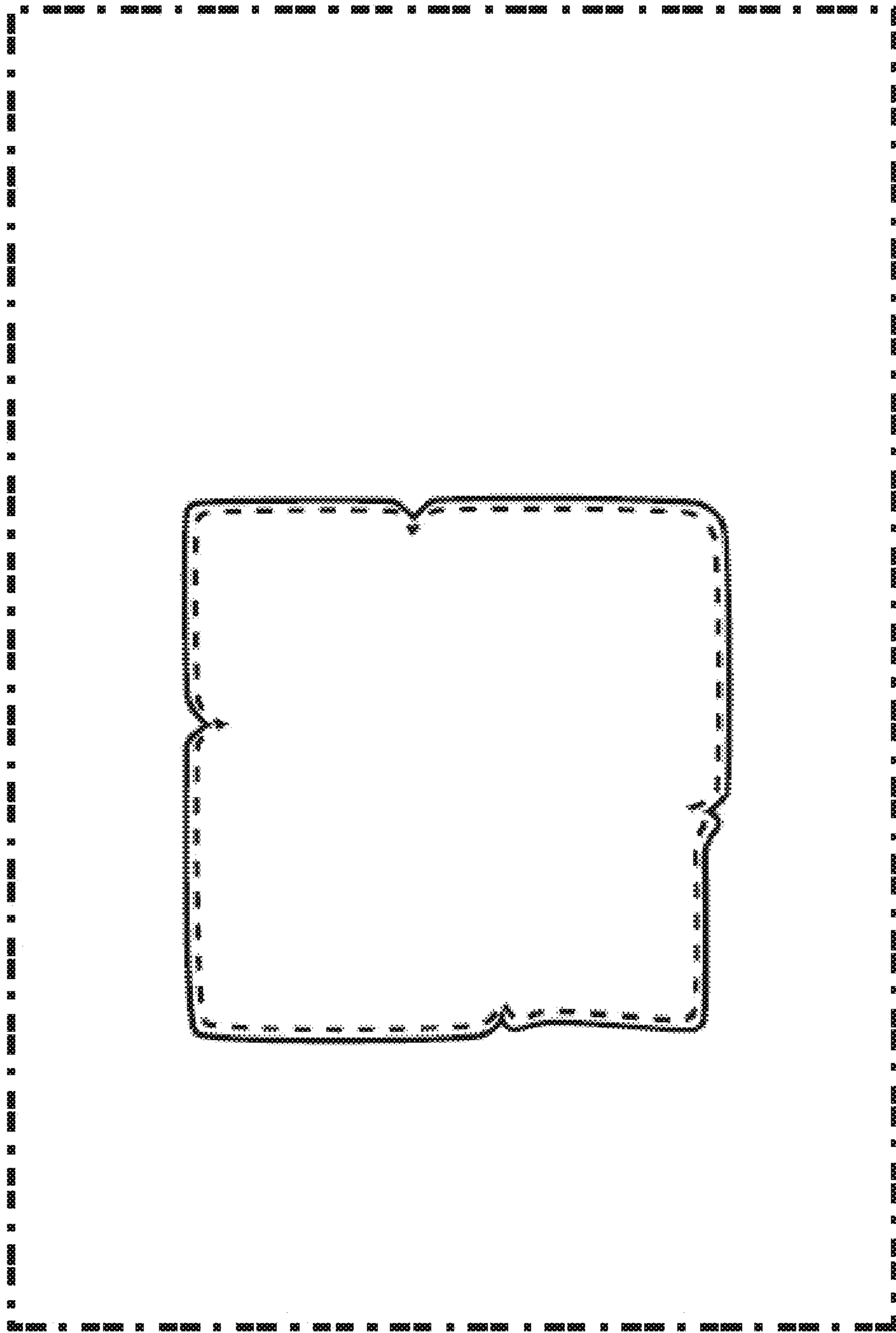

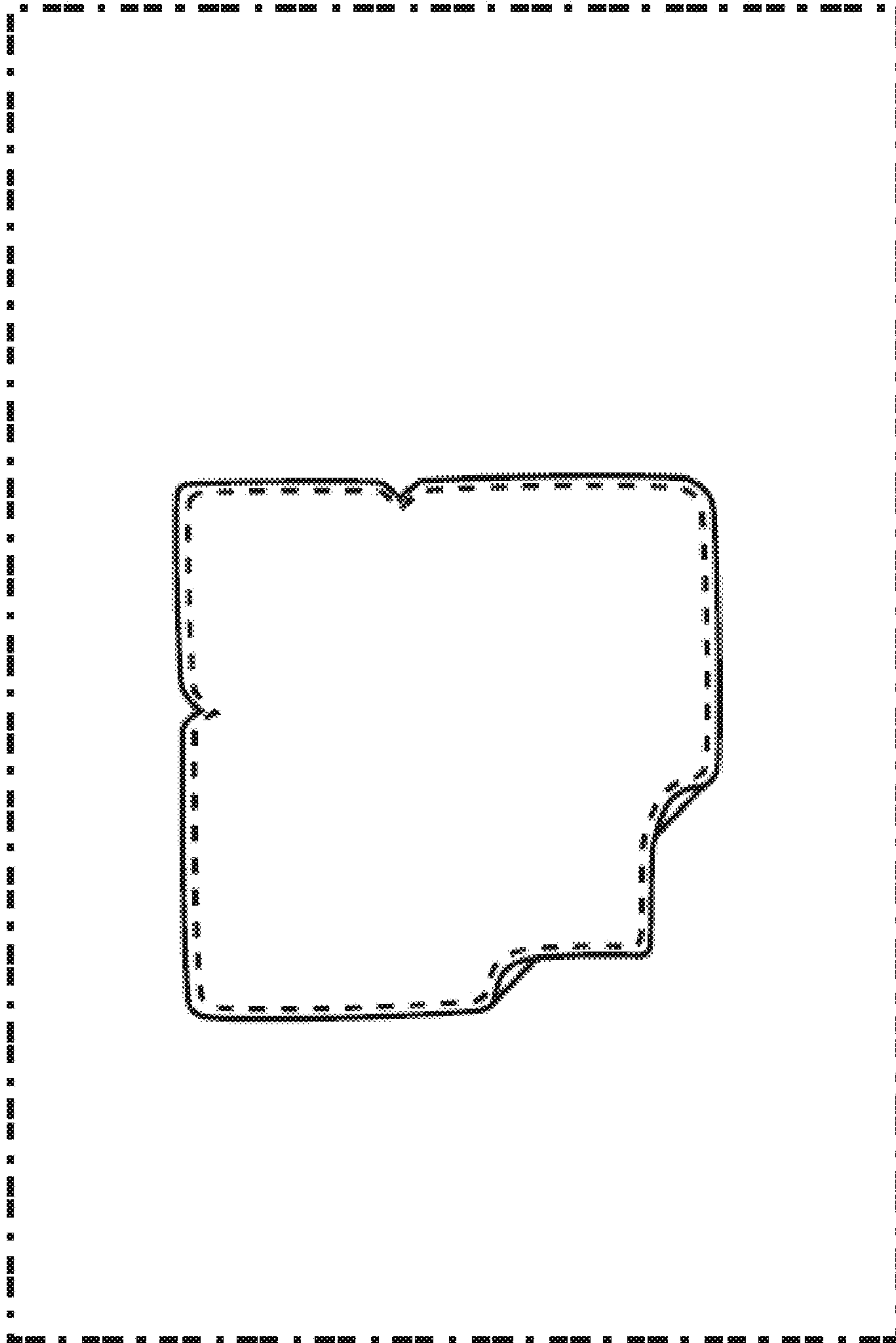

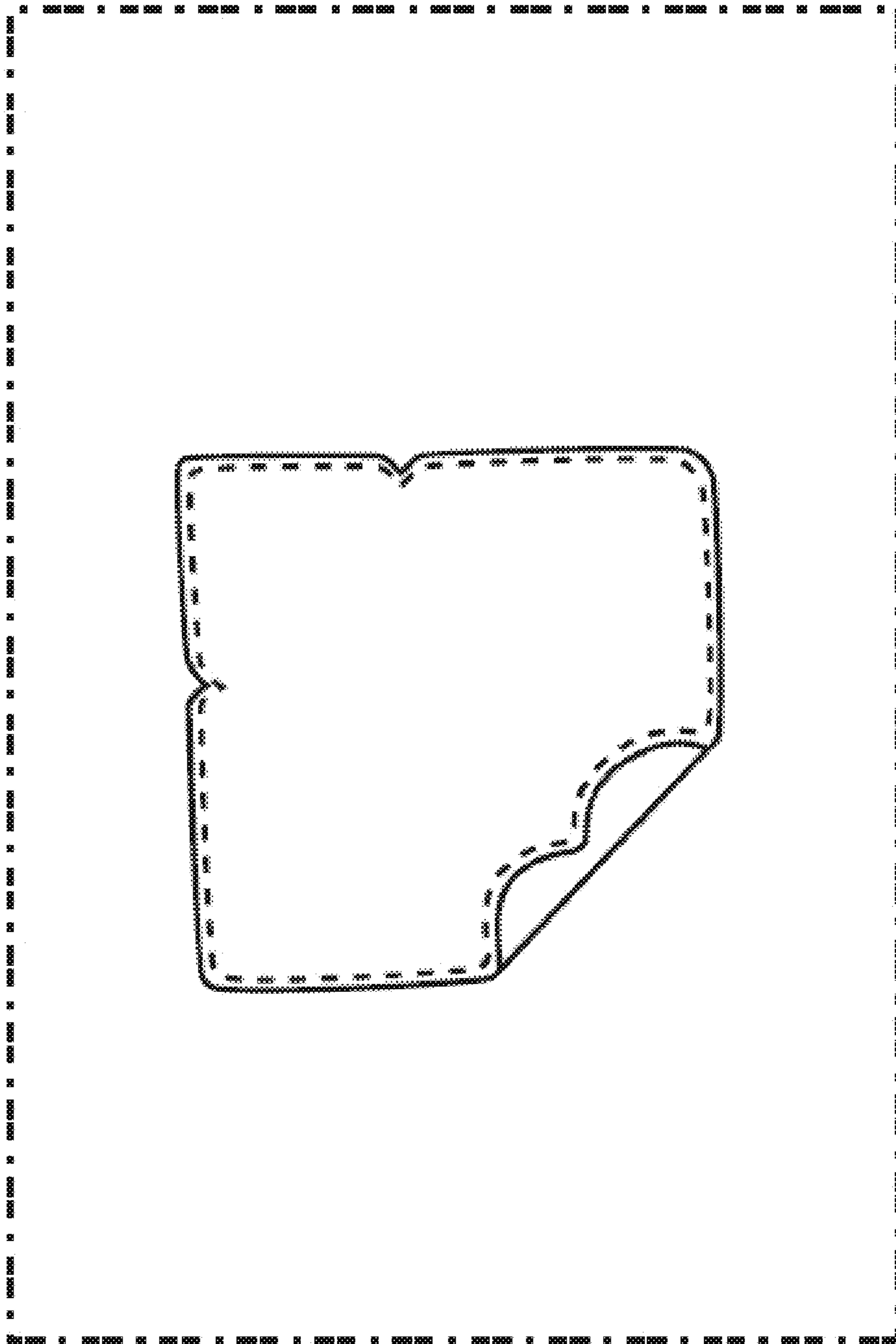

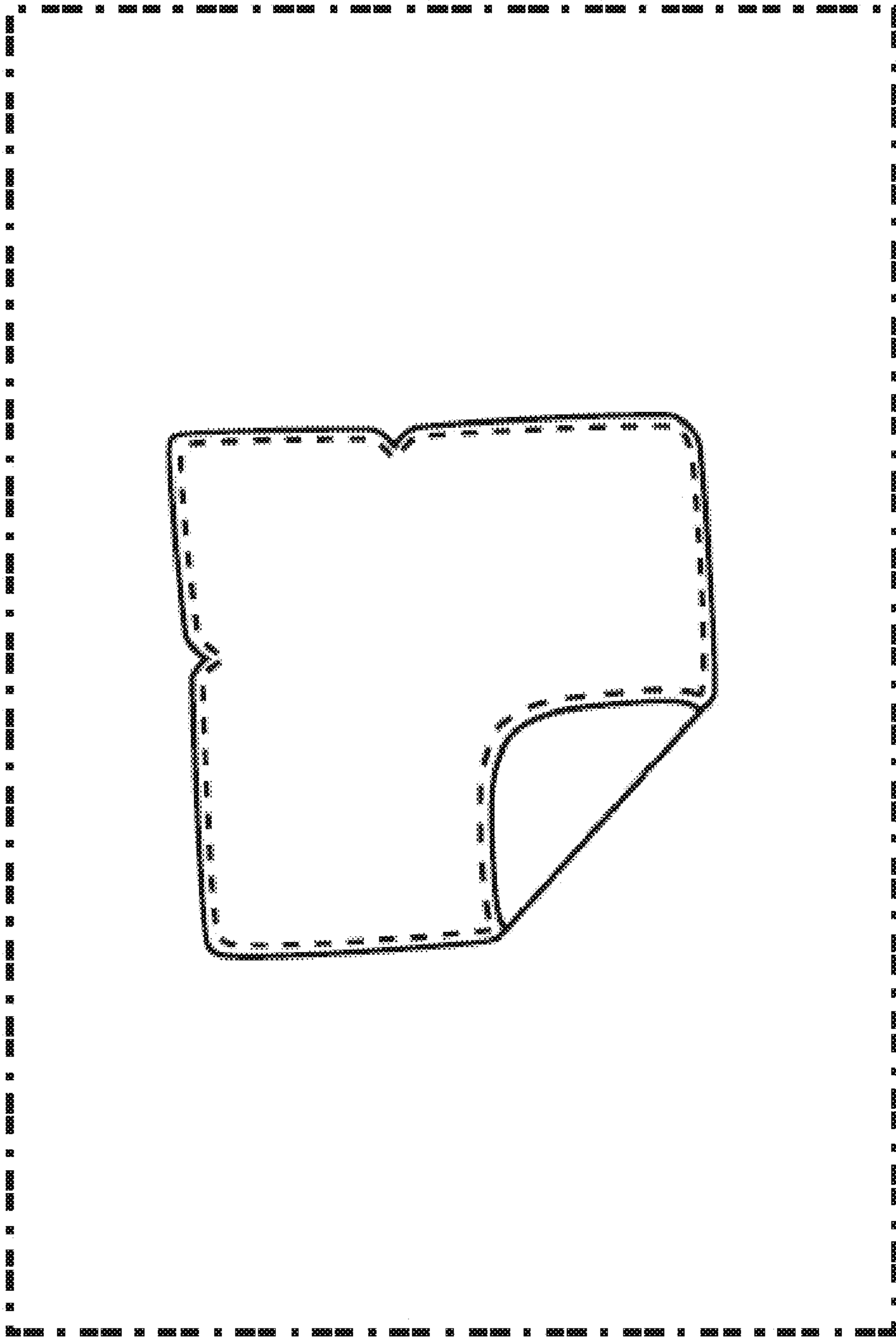

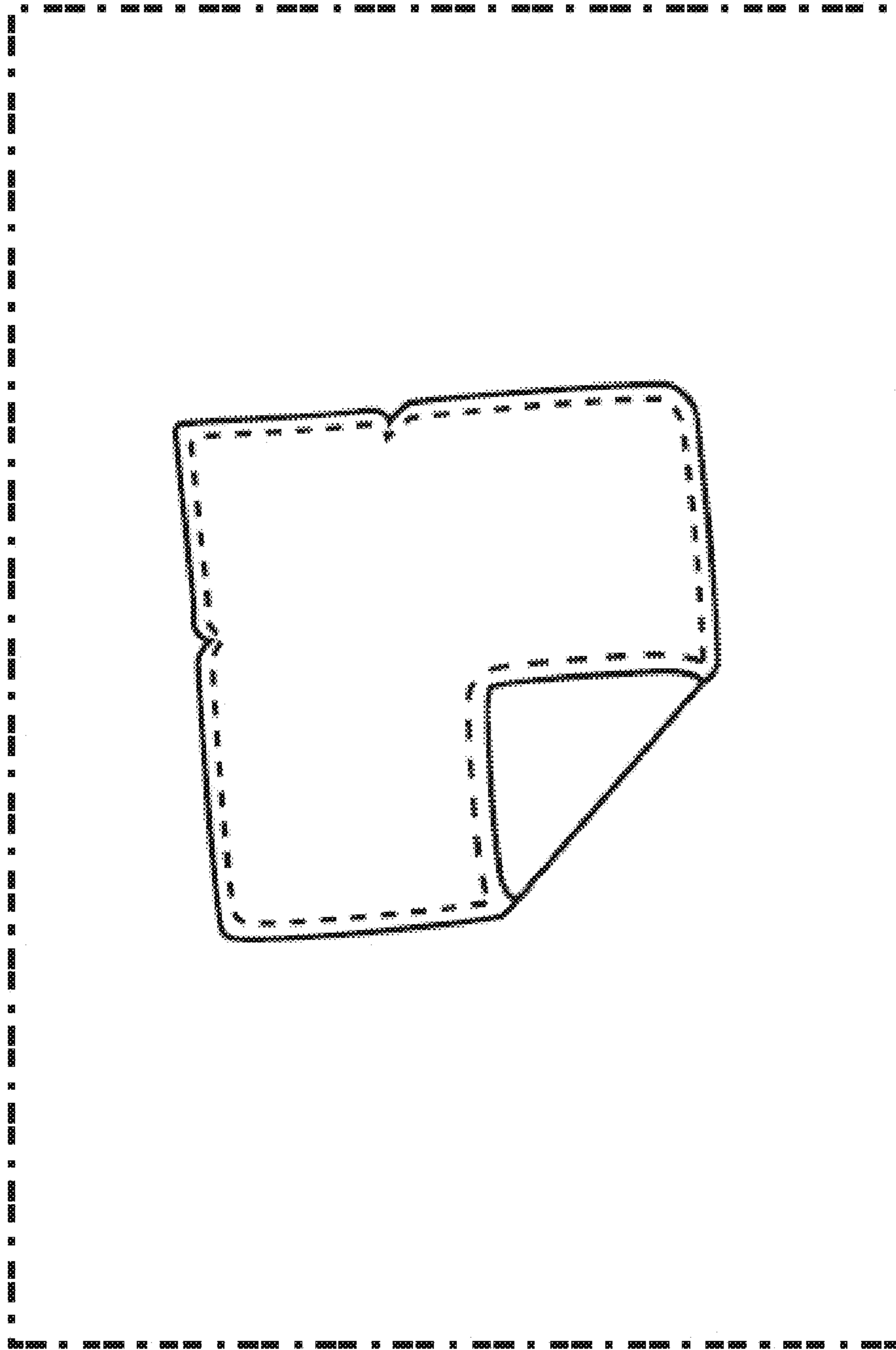

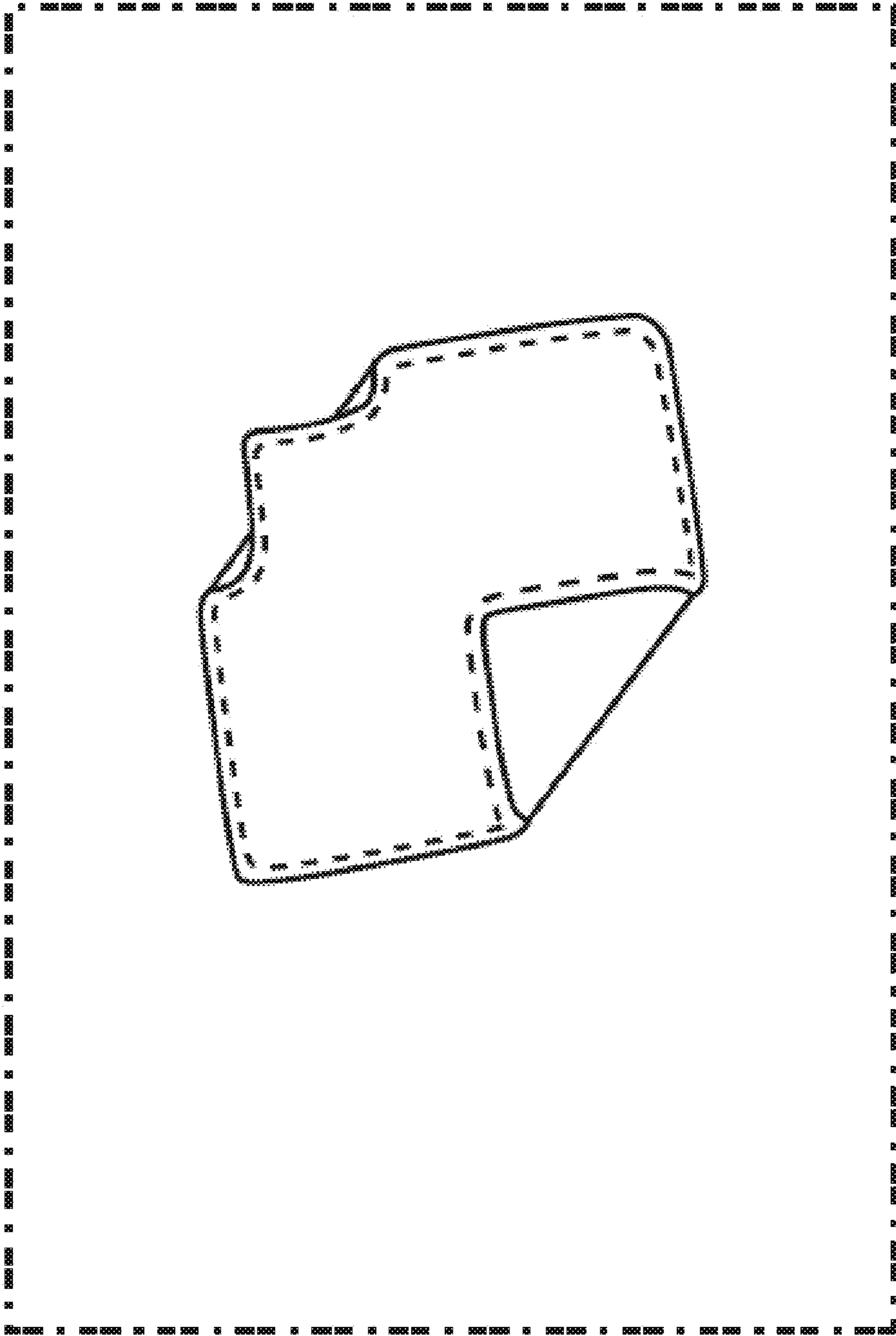

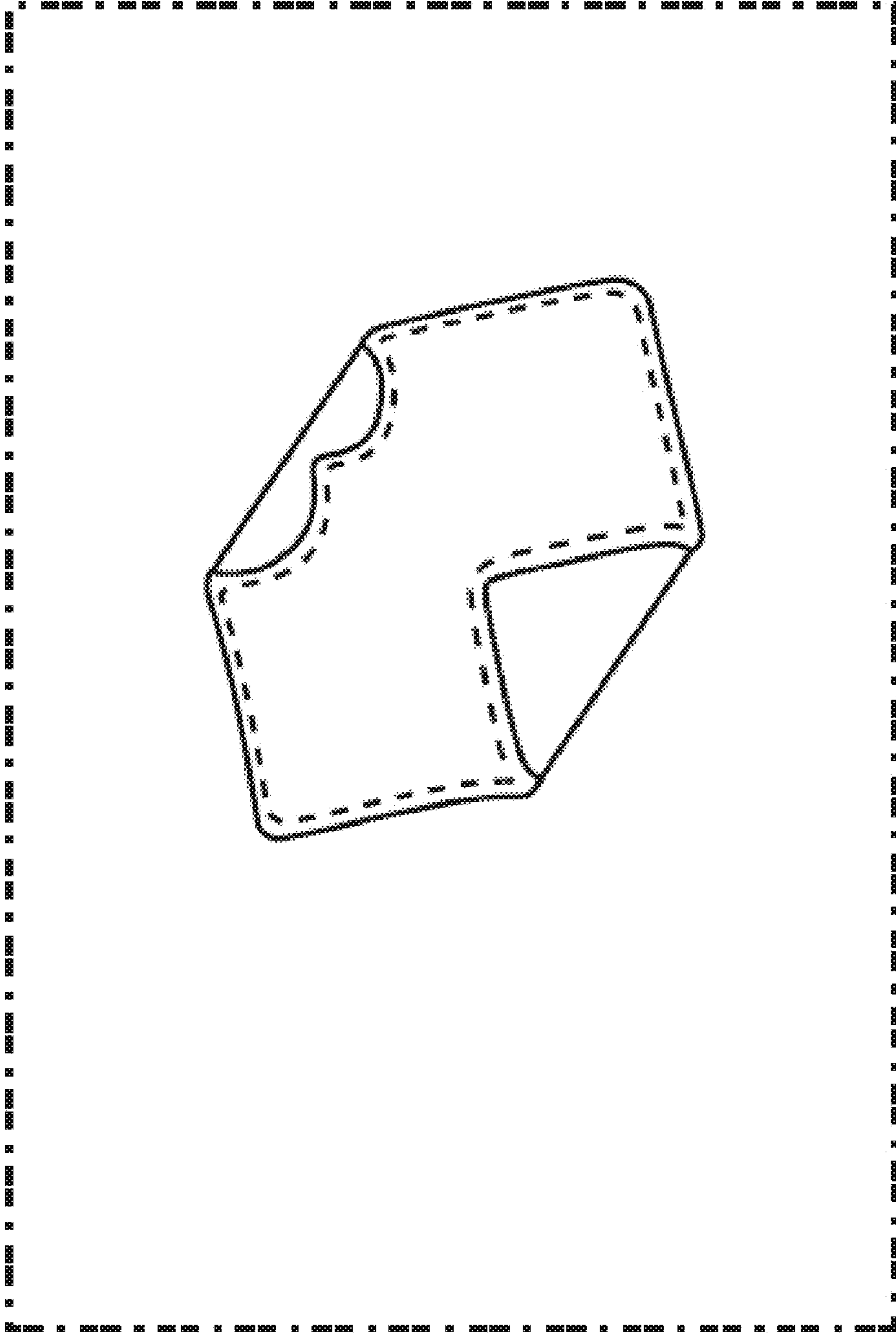

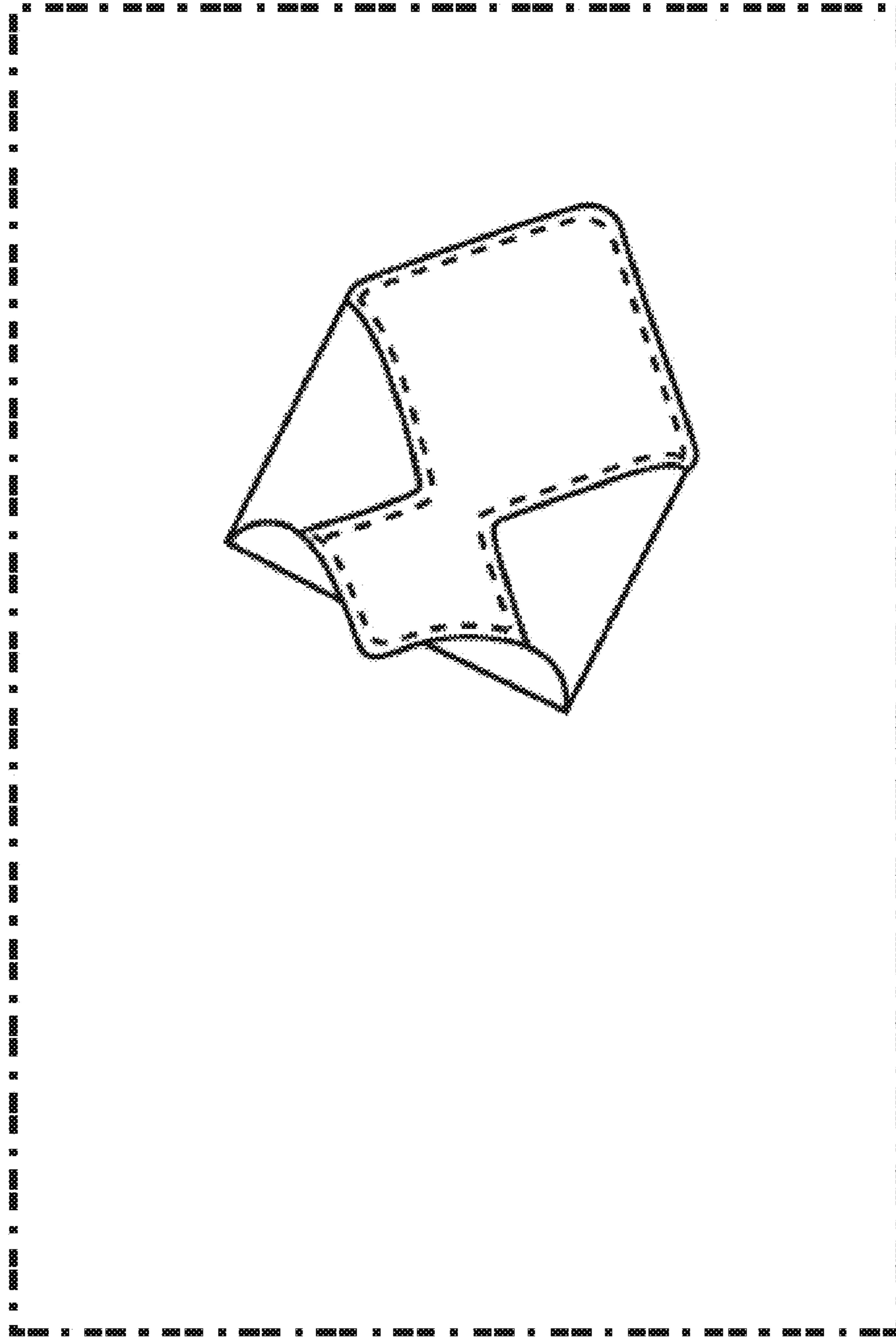

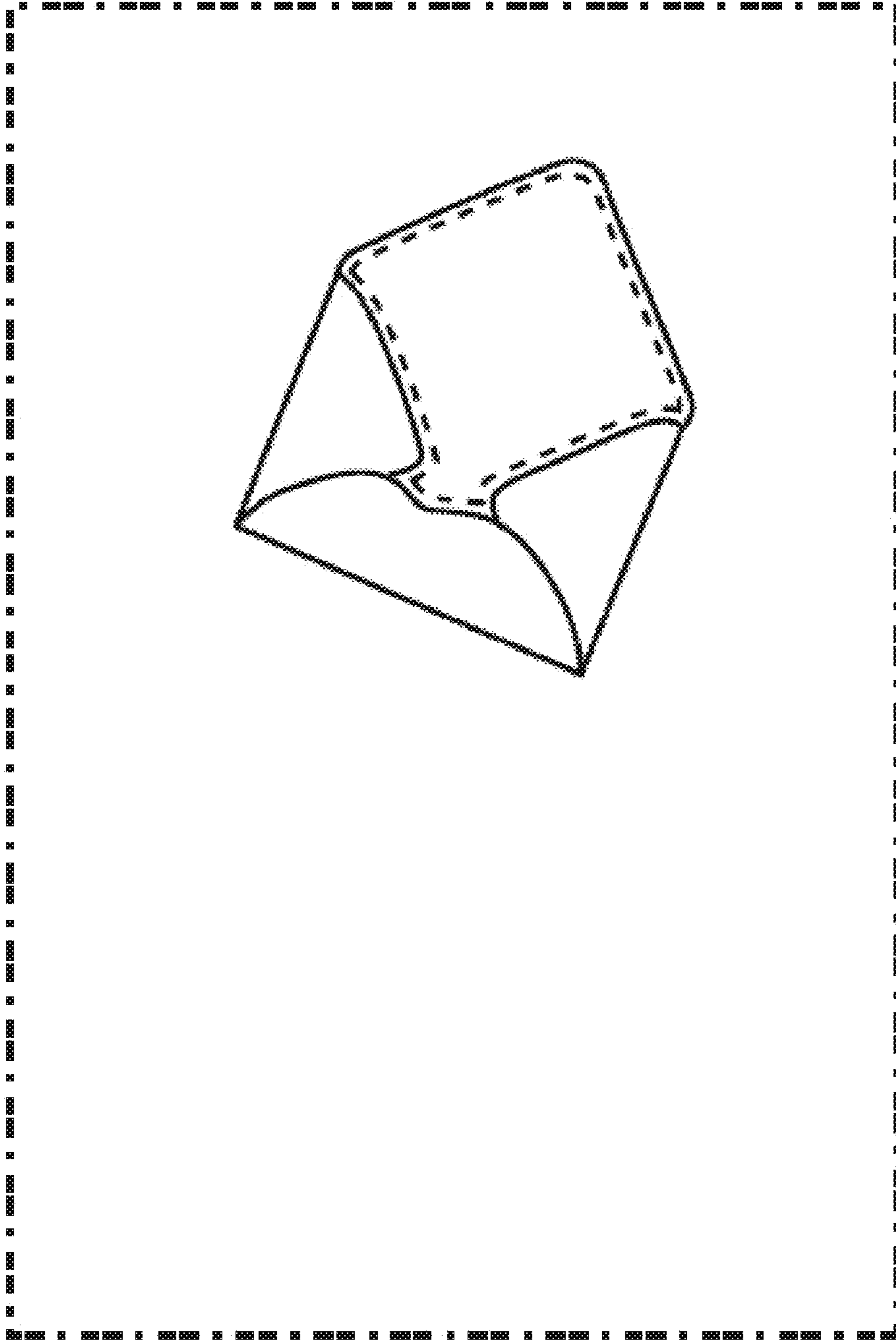

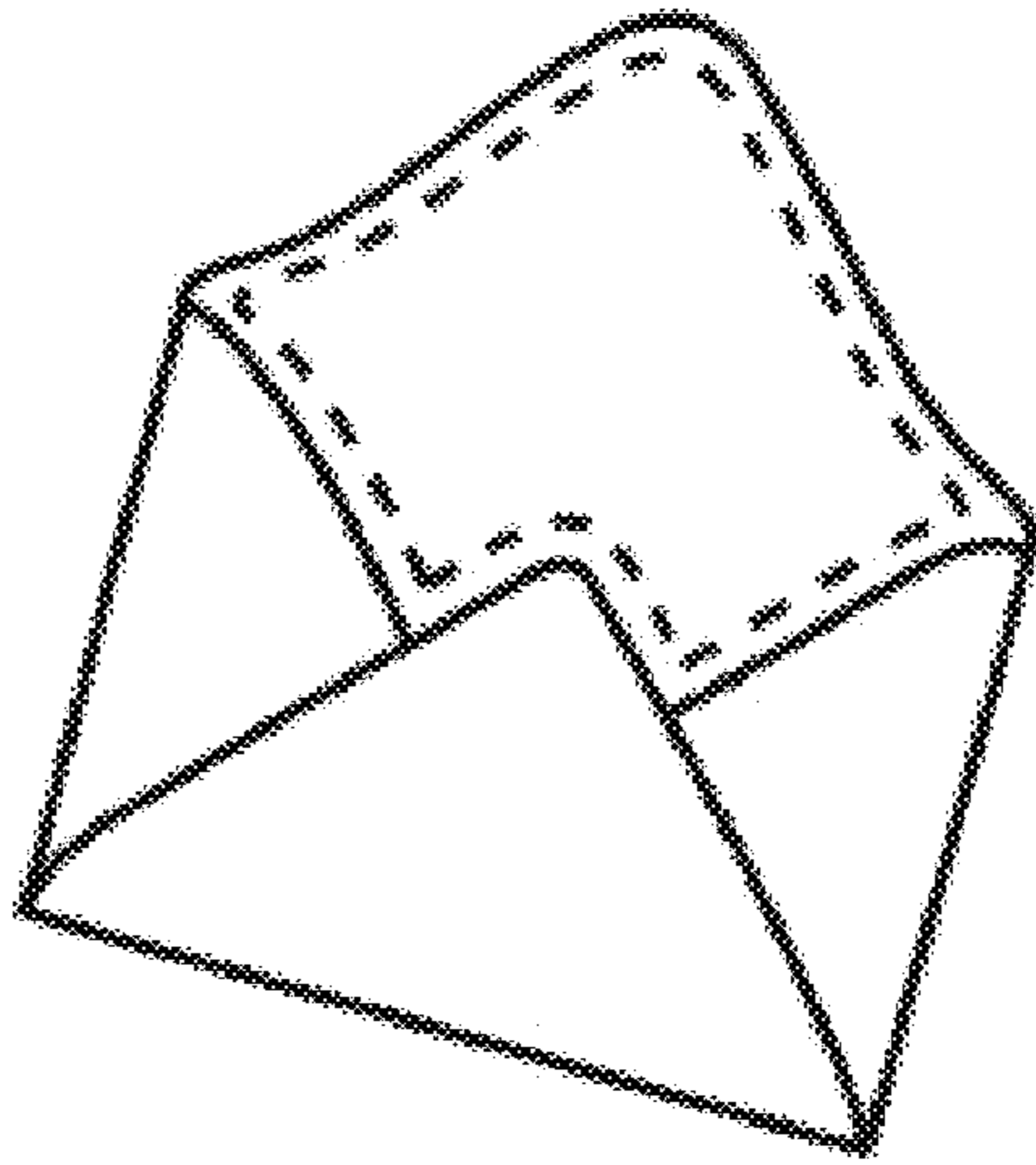

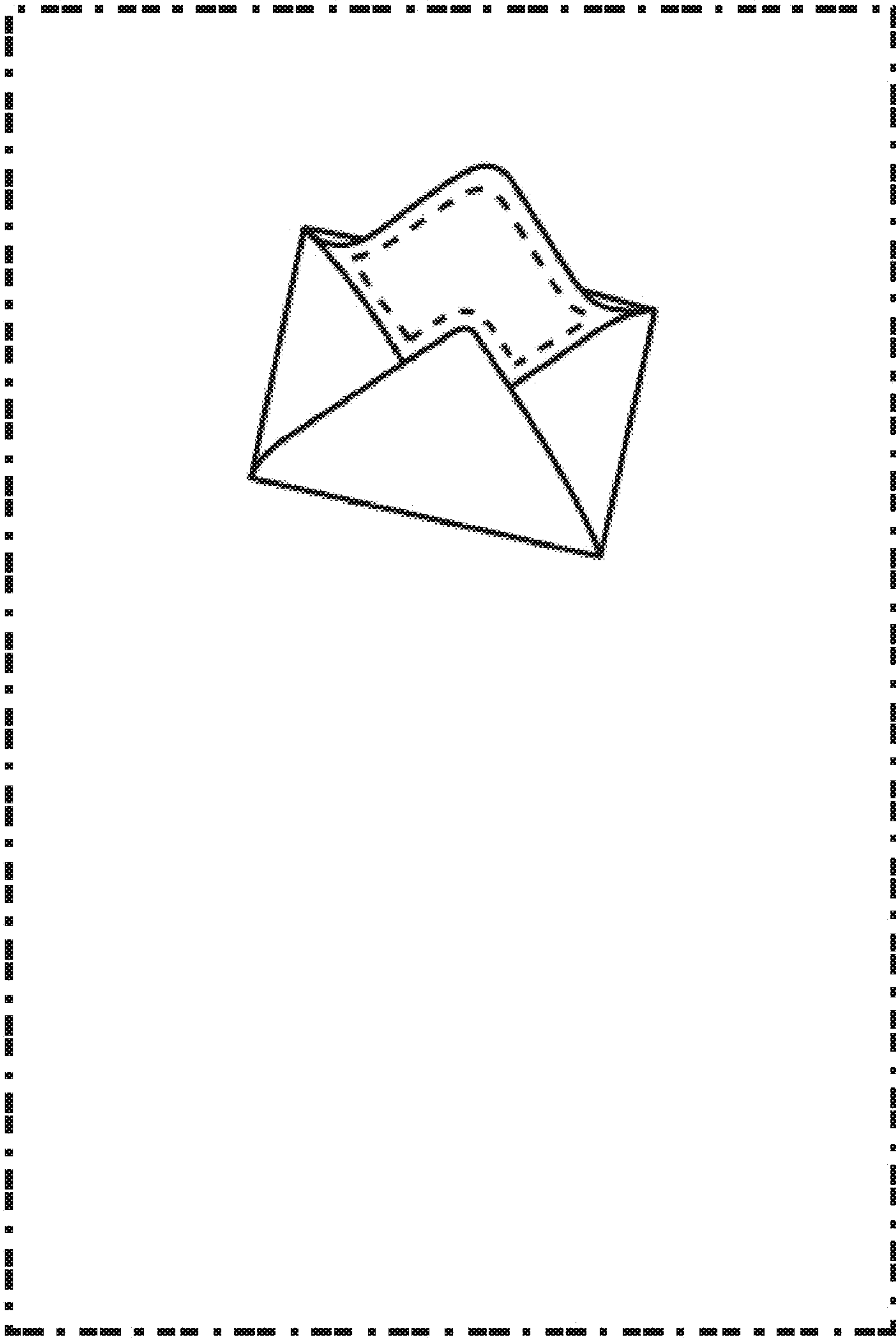

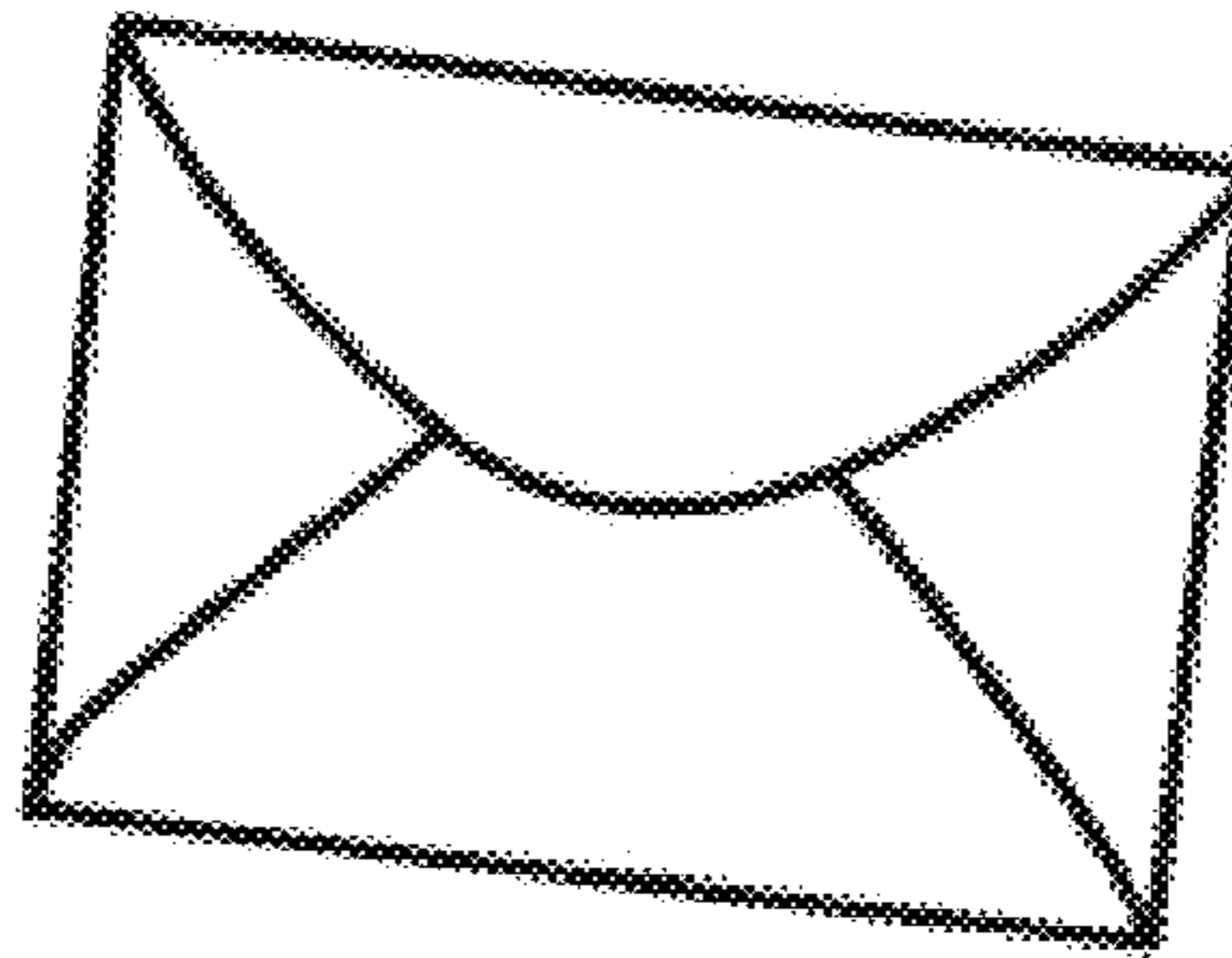

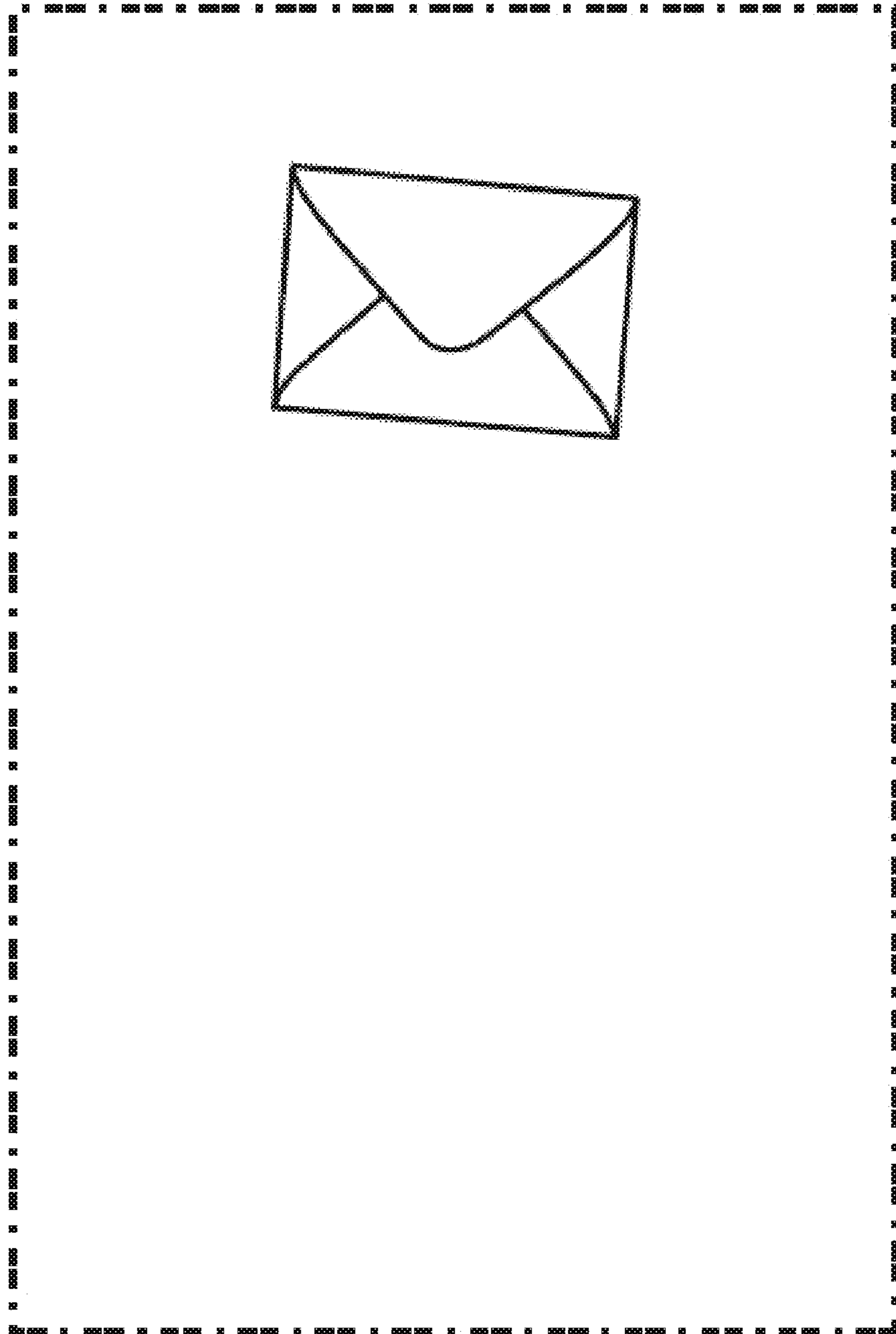

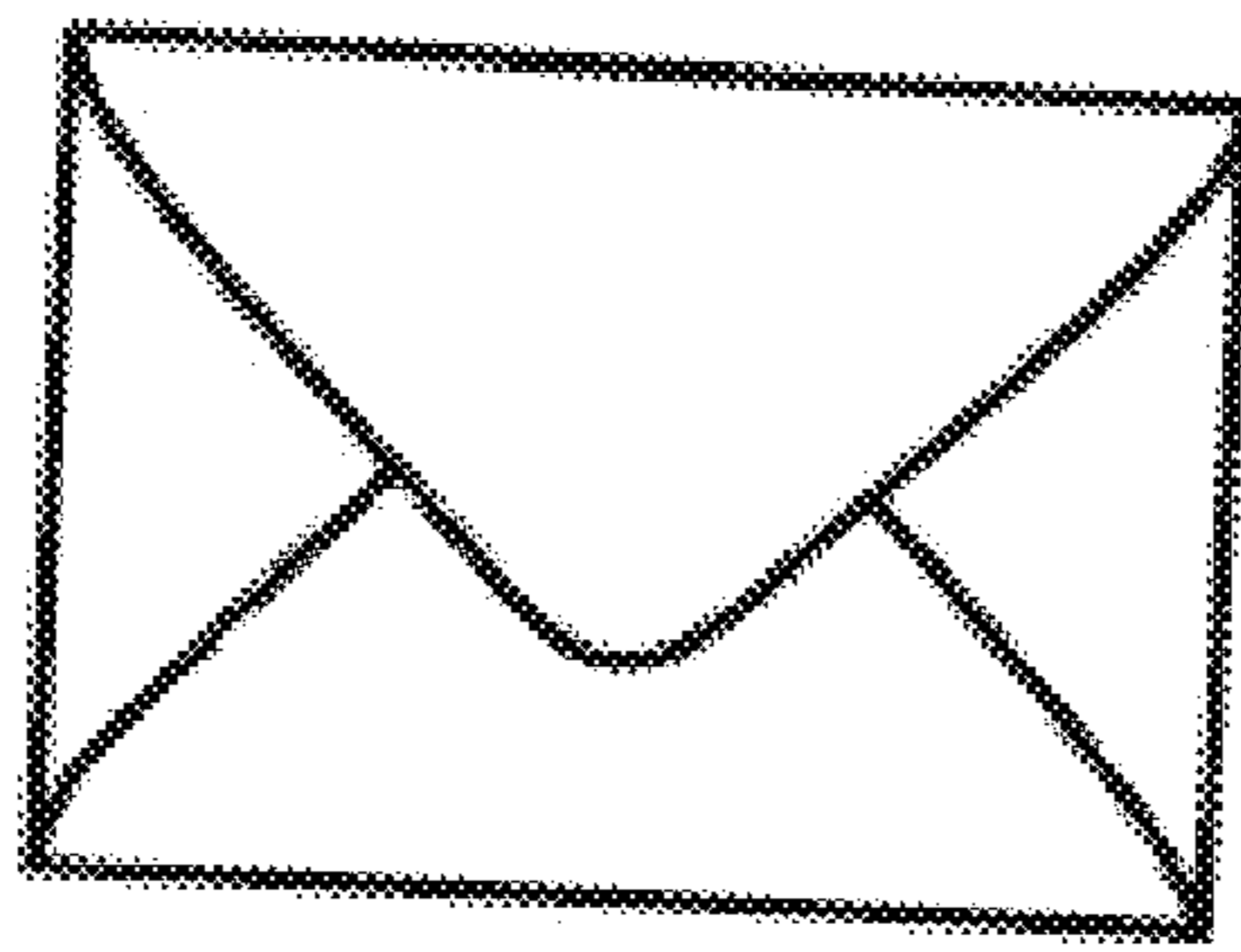

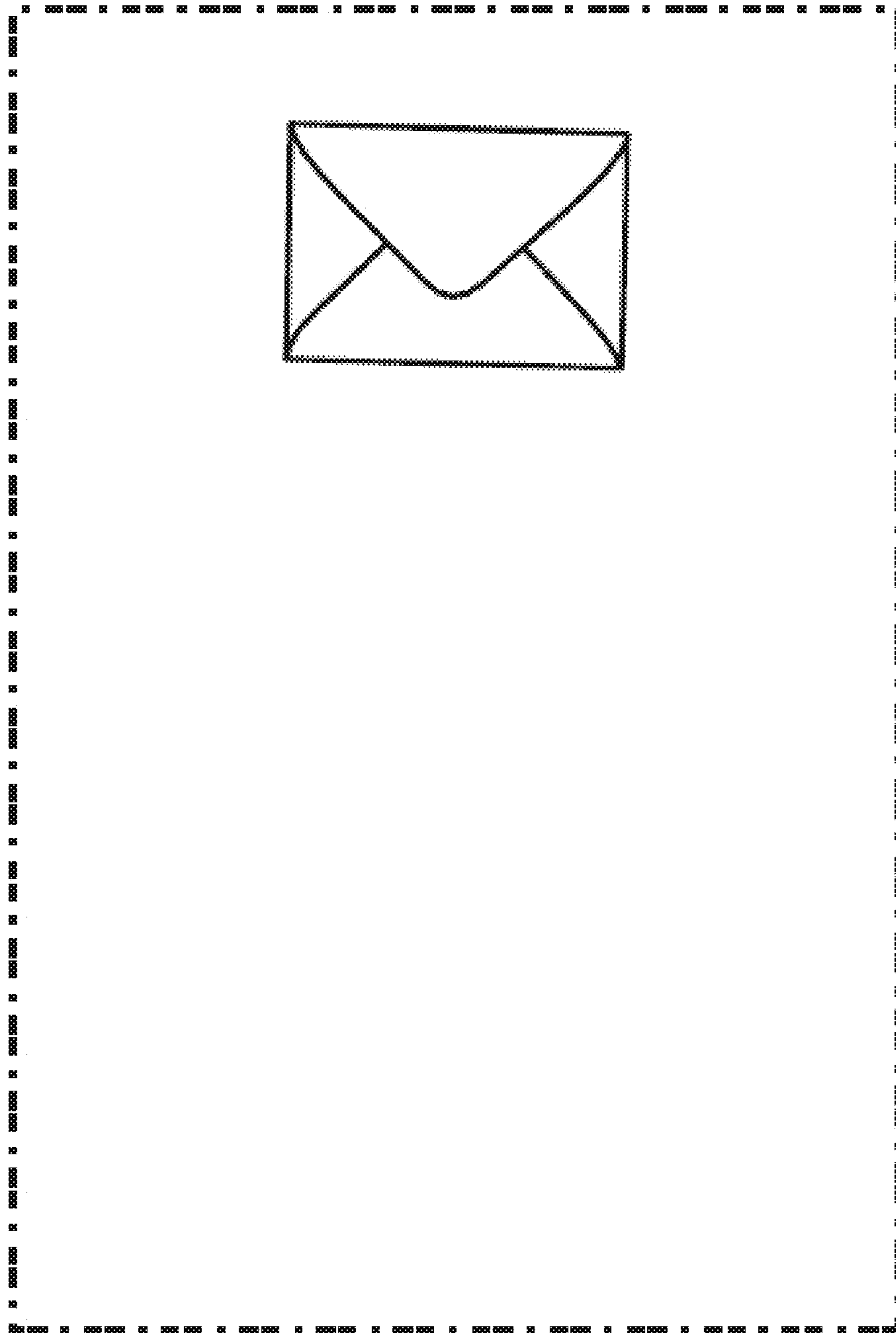

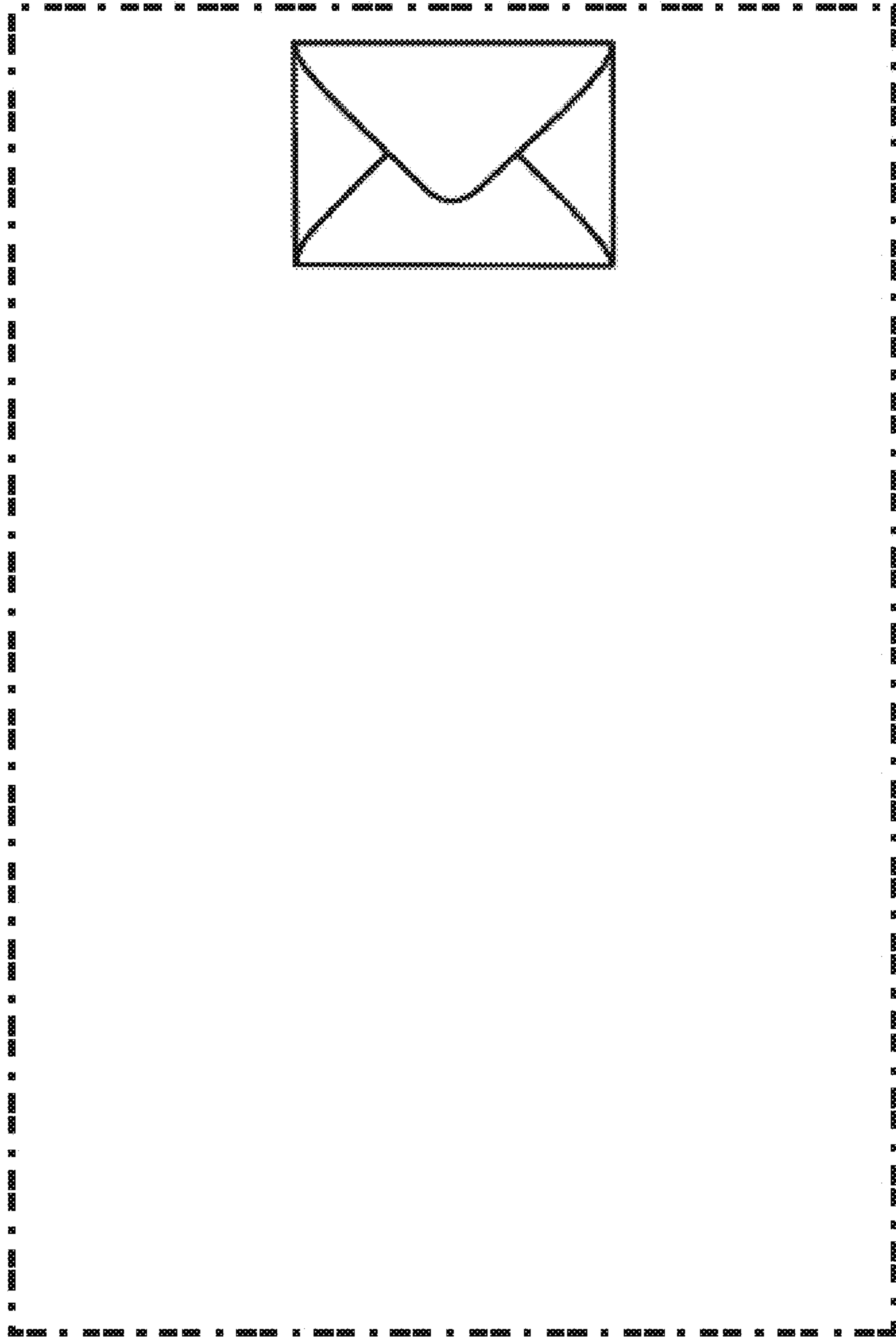

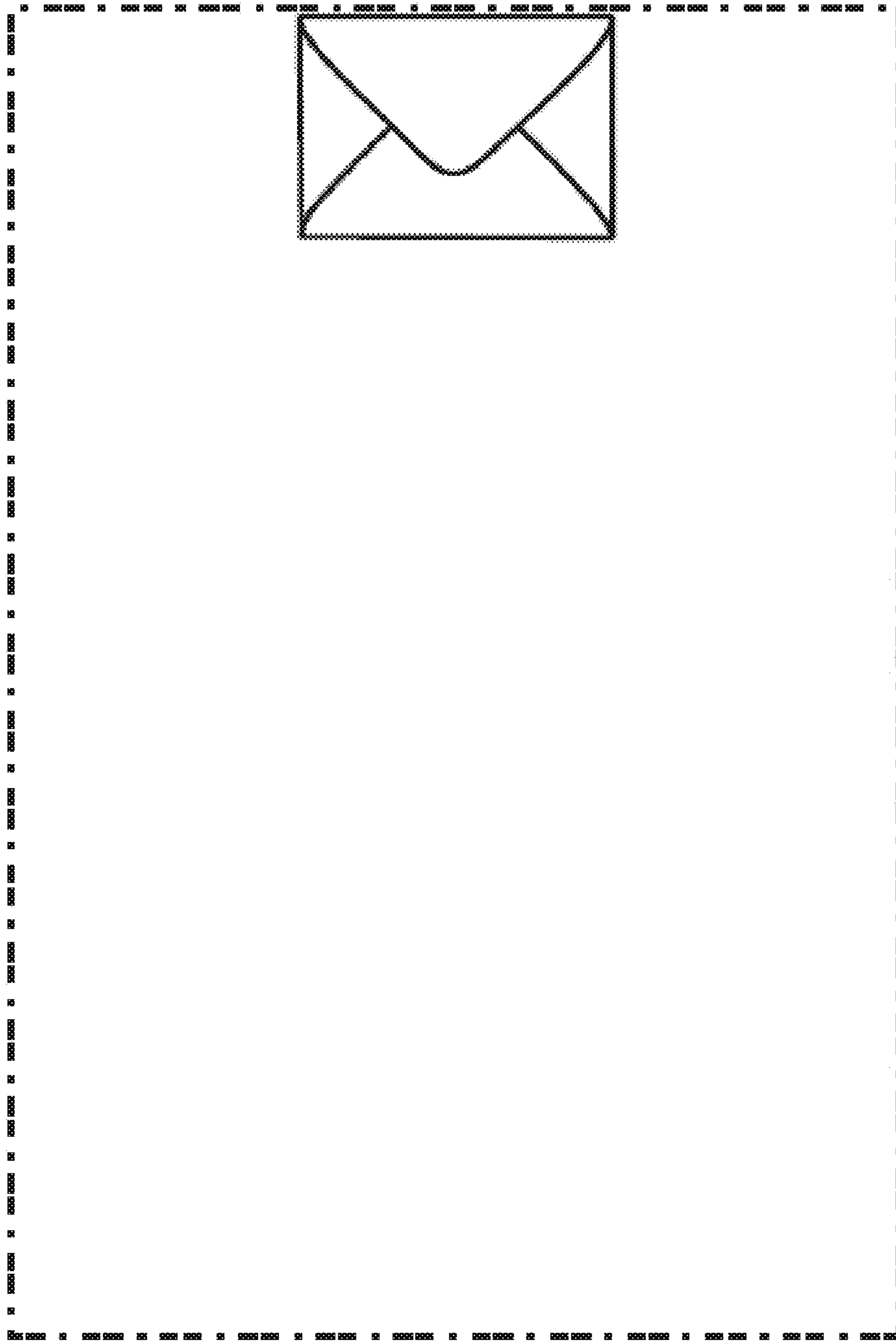

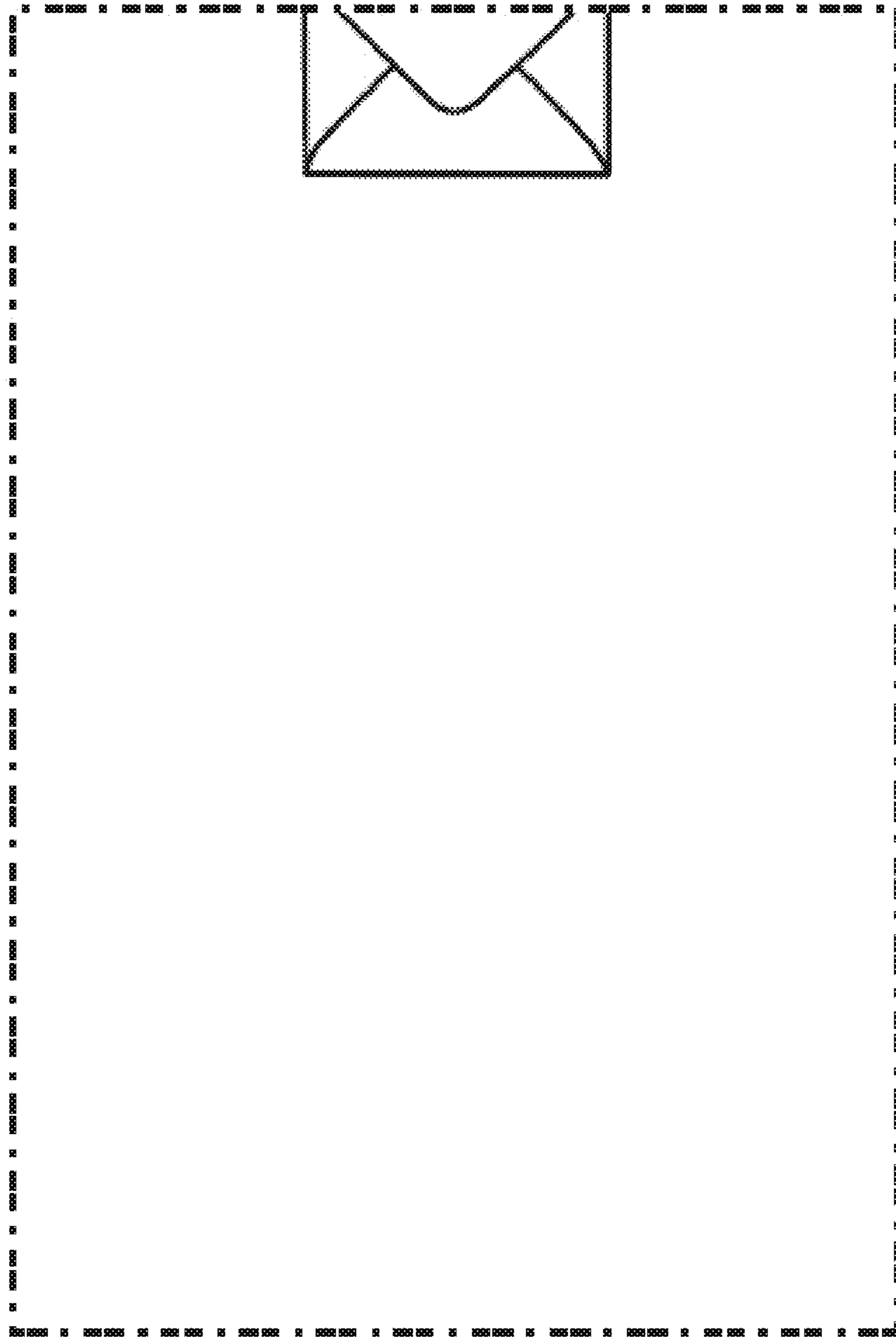

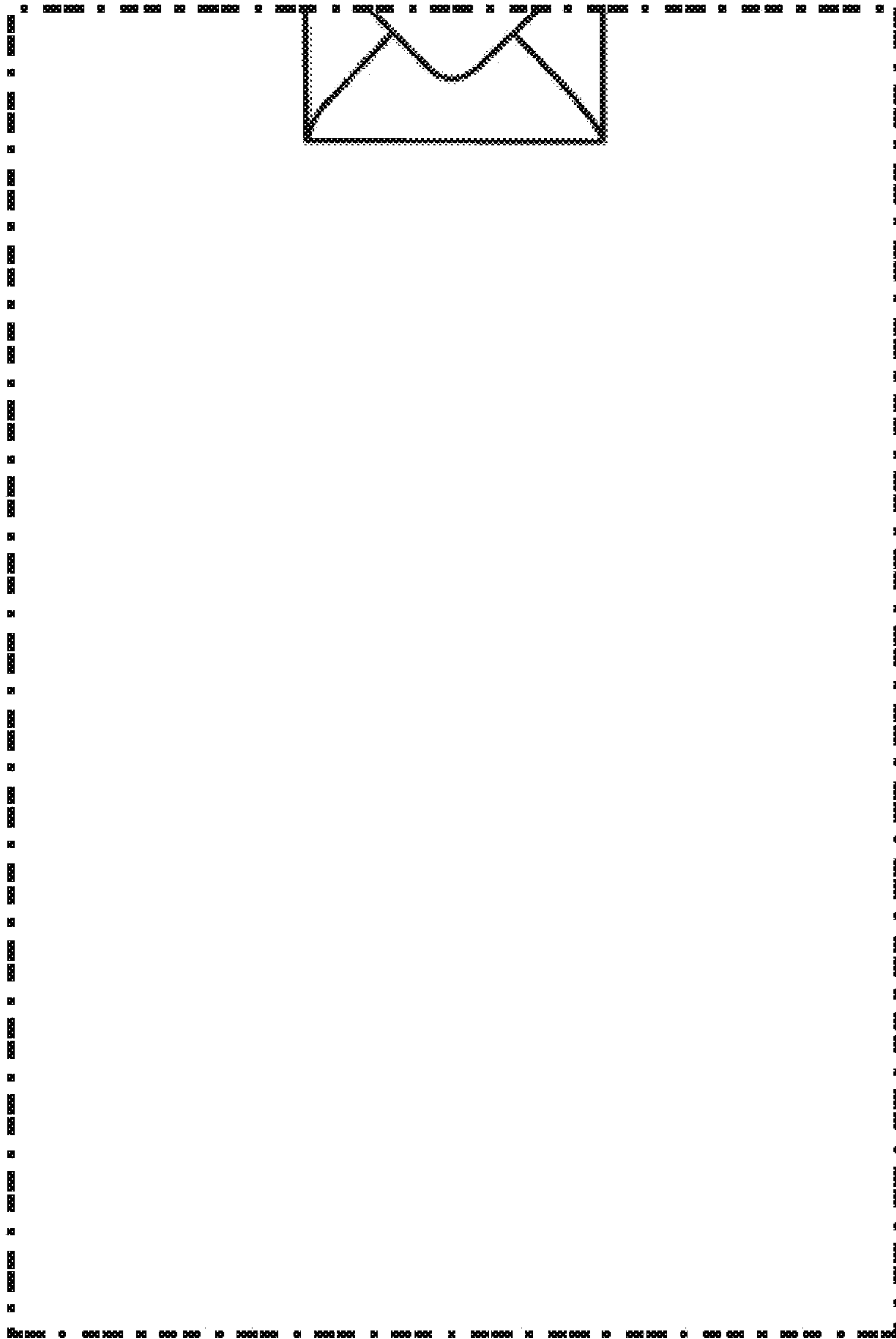

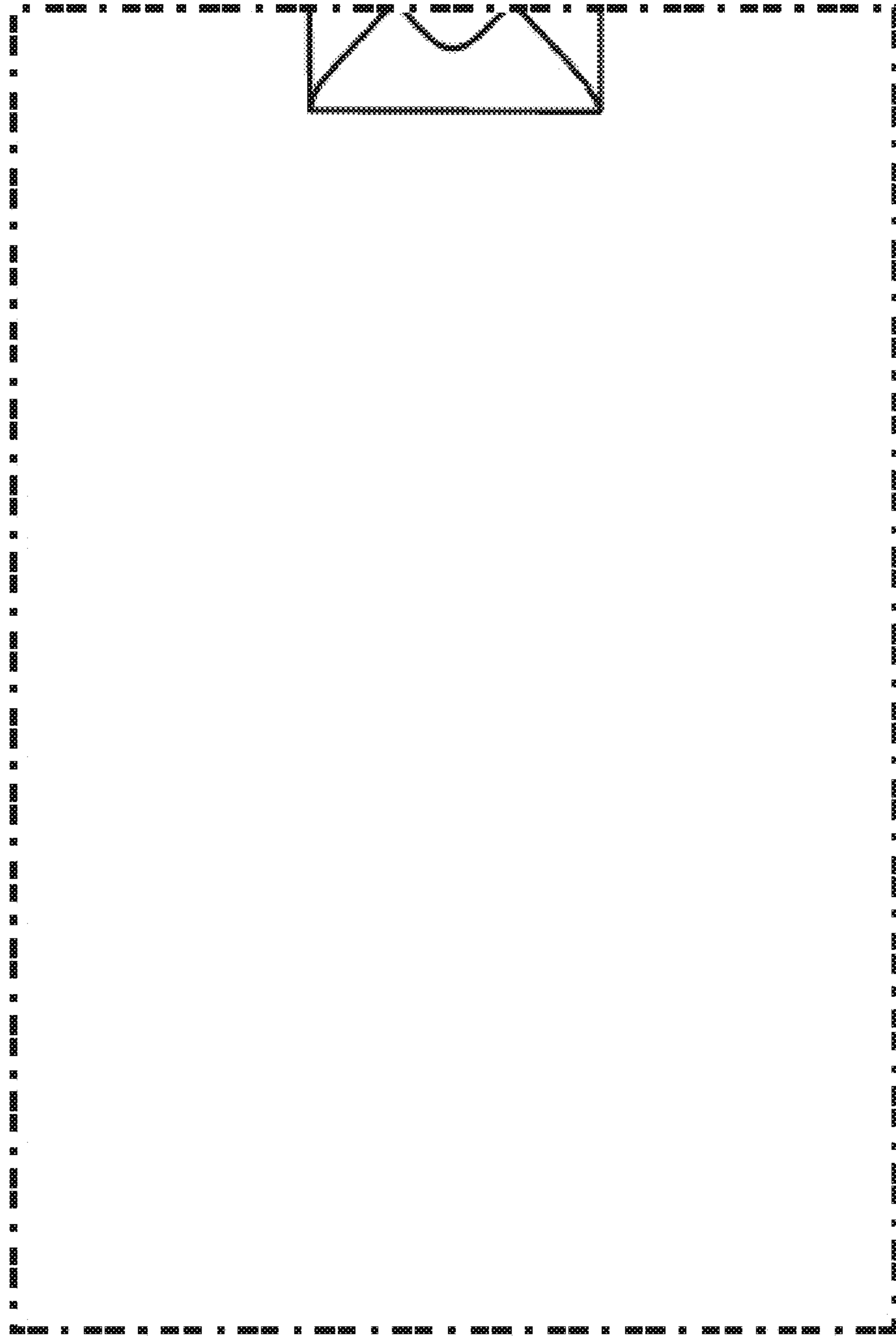

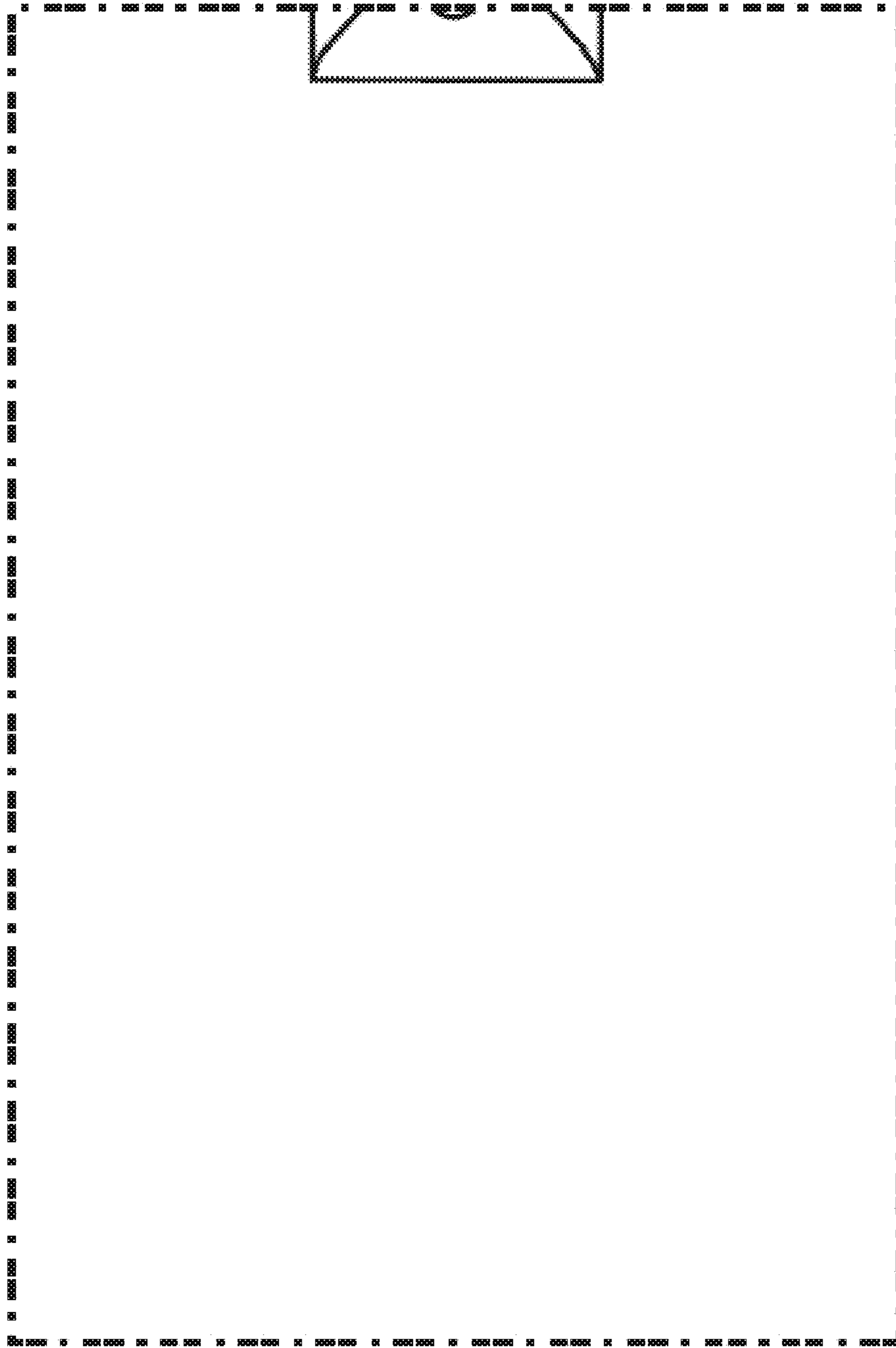

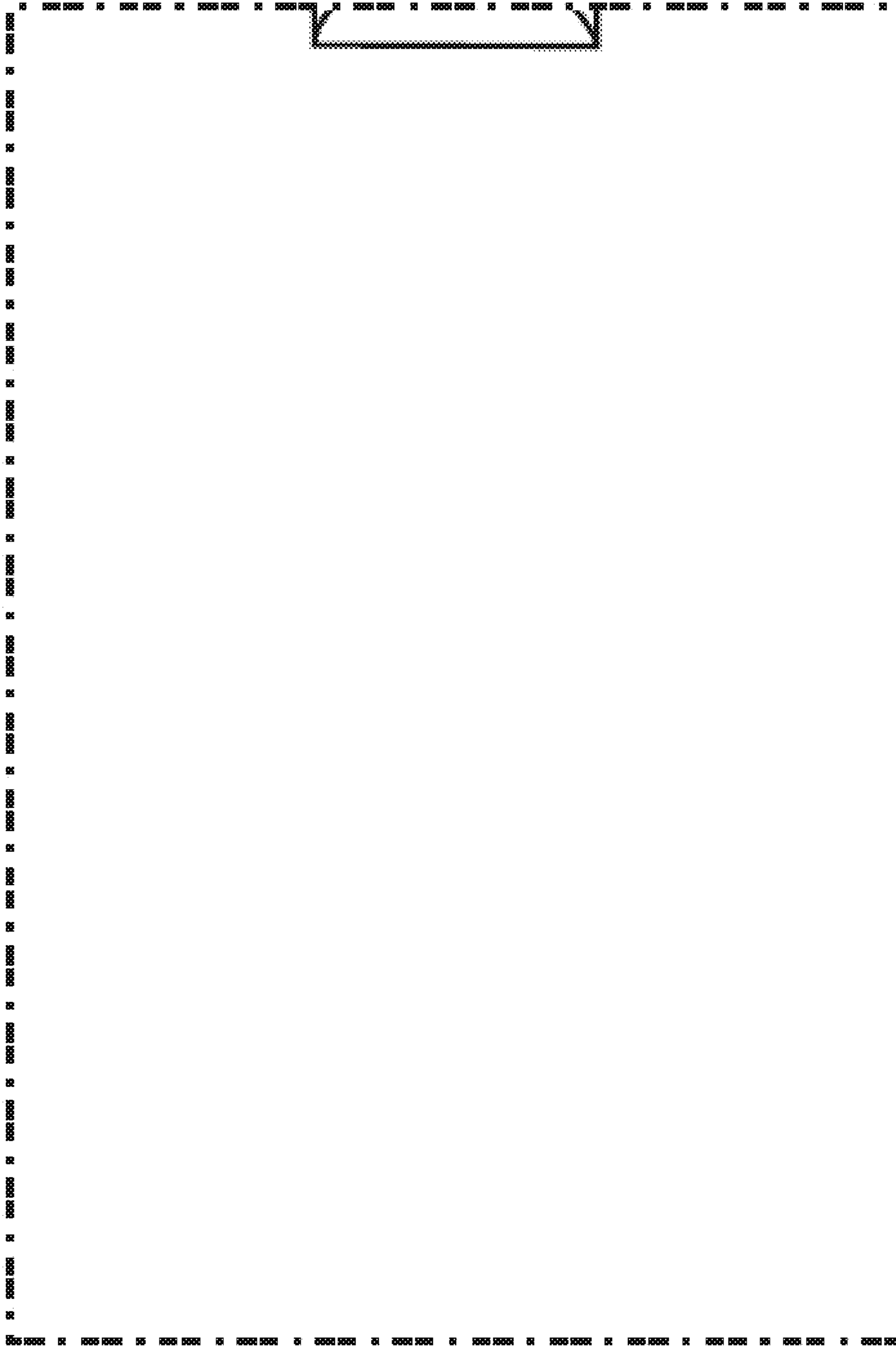
