The ornamental design for an animated avatar for a display screen, as shown and described.

DESCRIPTION

FIG. 11 is a front view of the eleventh image thereof;

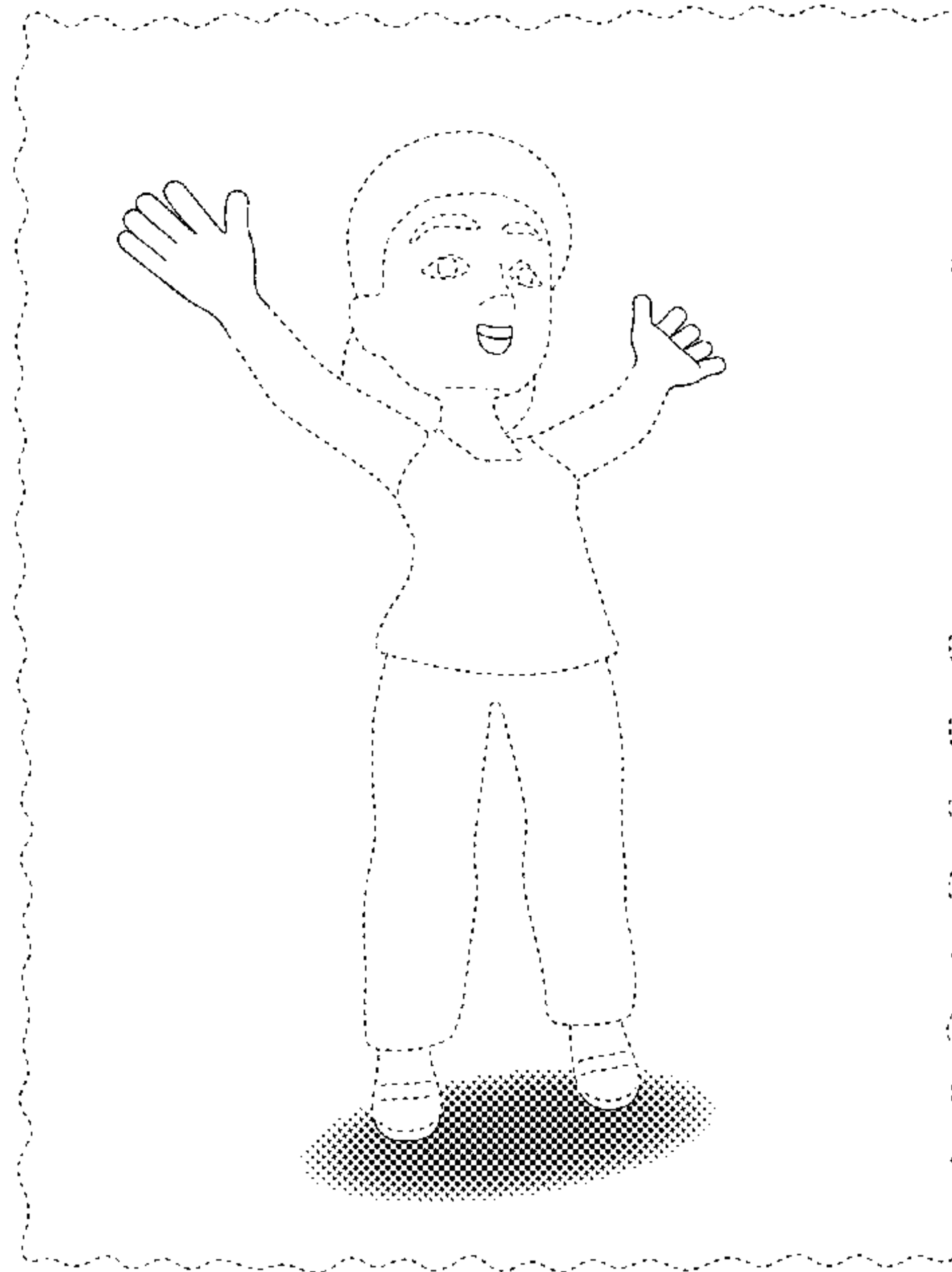
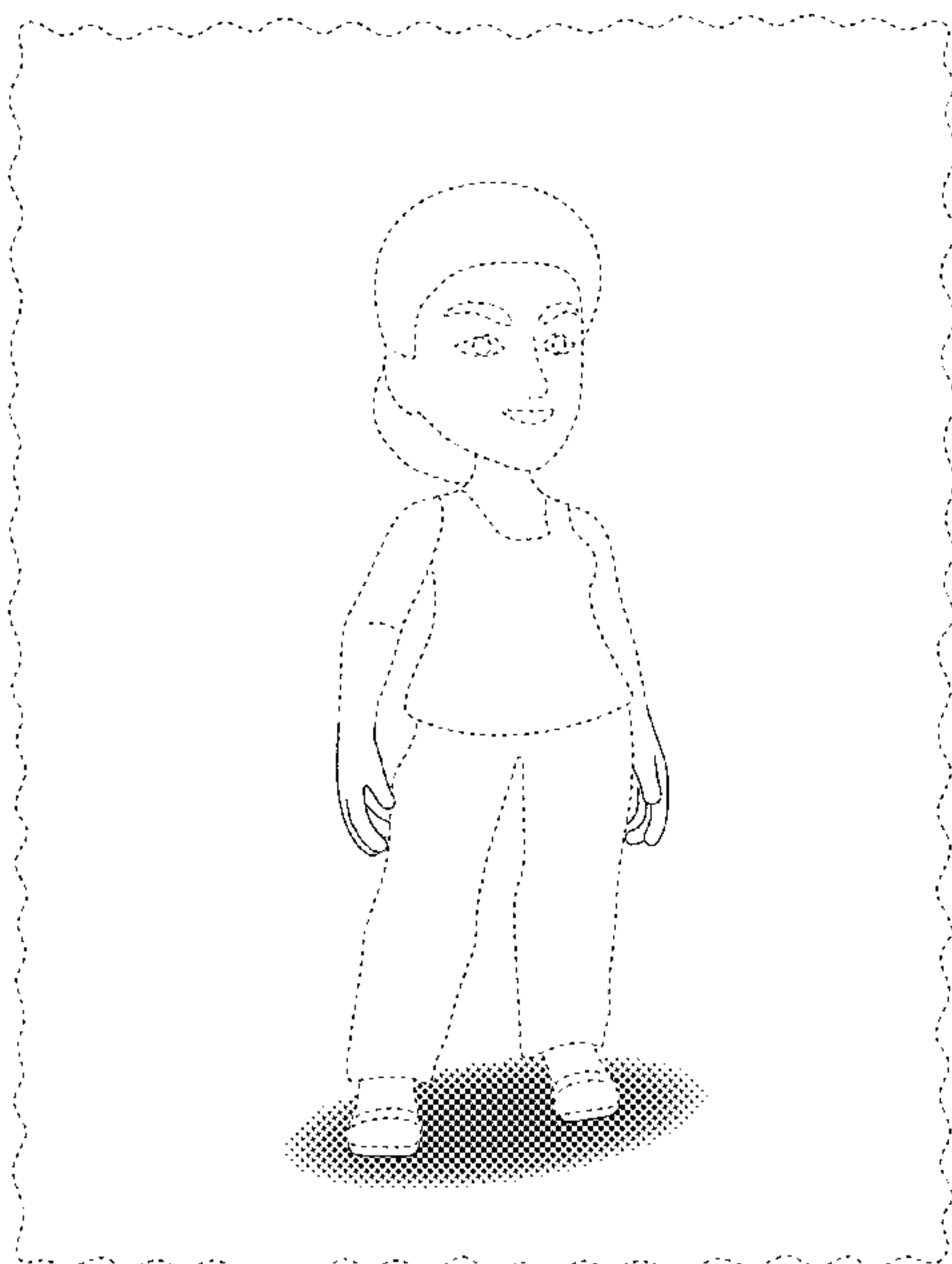
FIG. 12 is a front view of the twelfth image thereof;

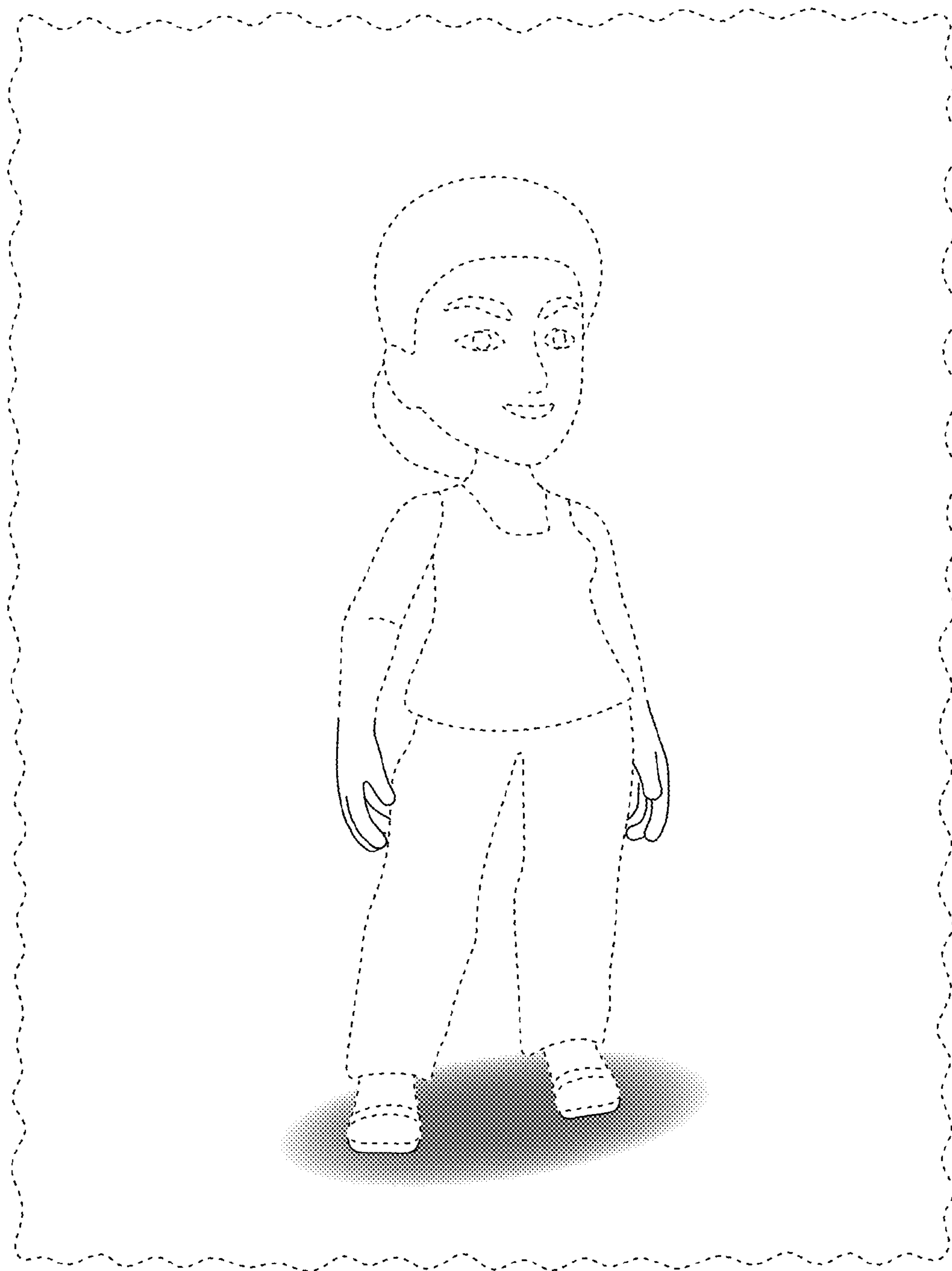

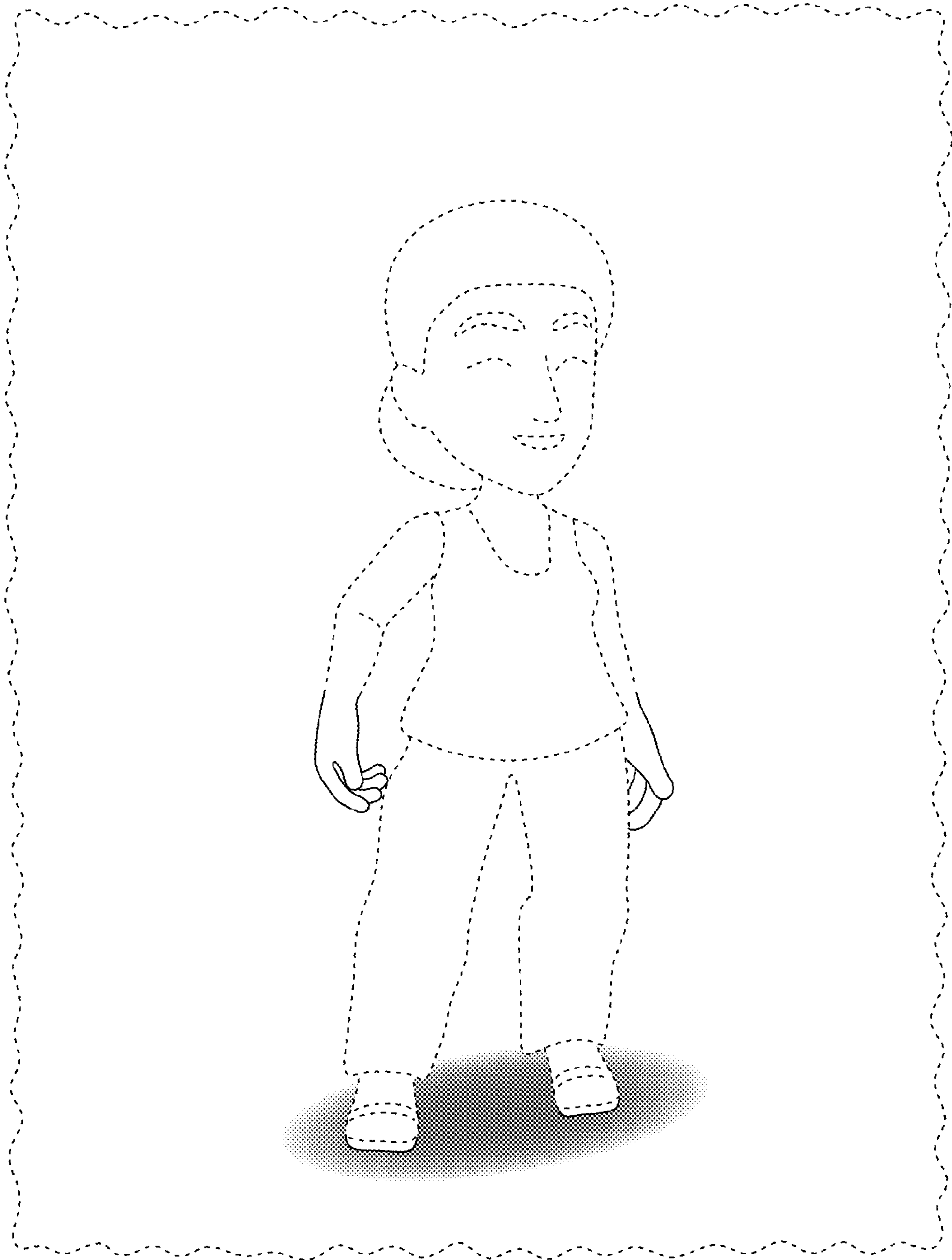

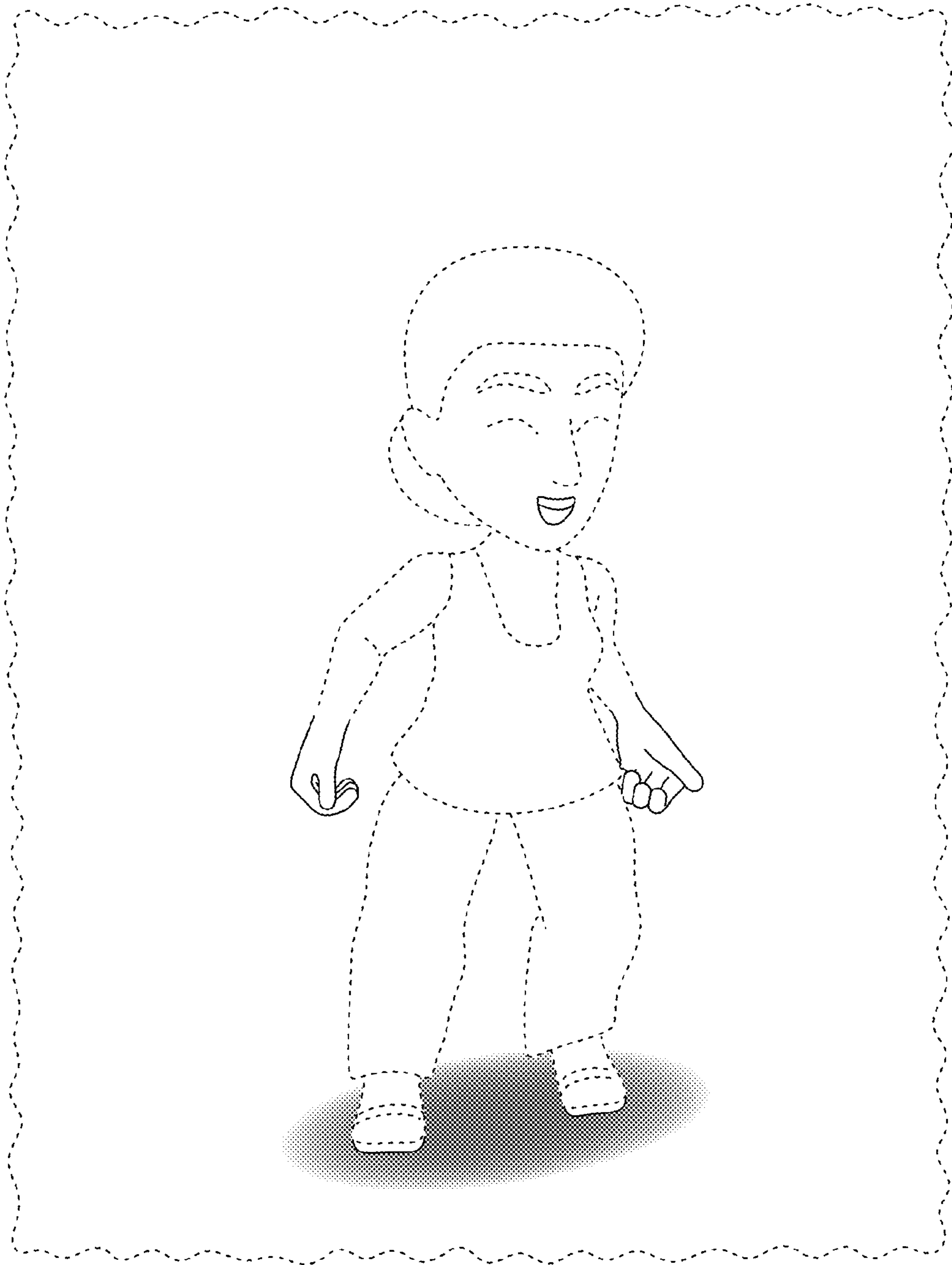

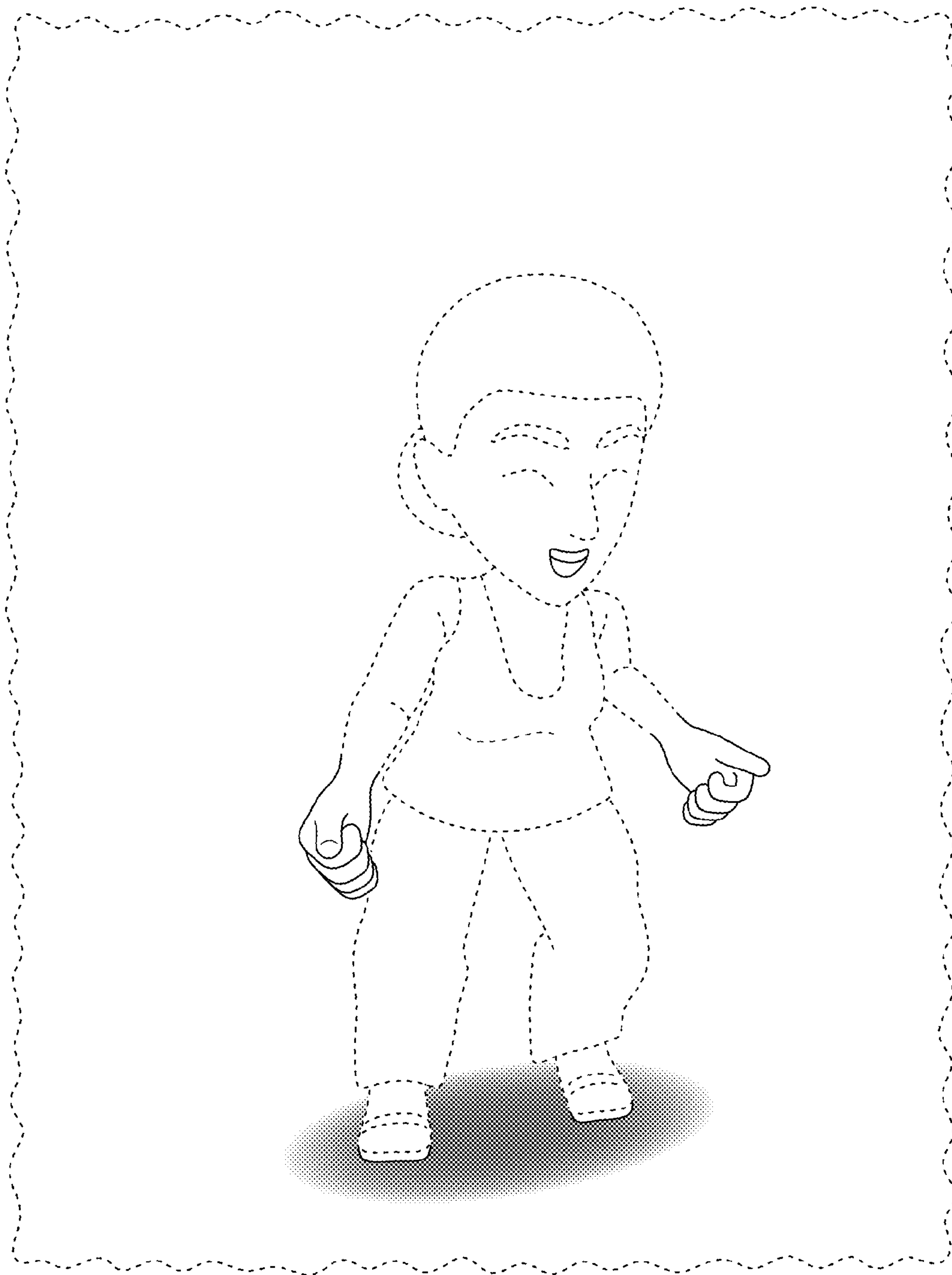

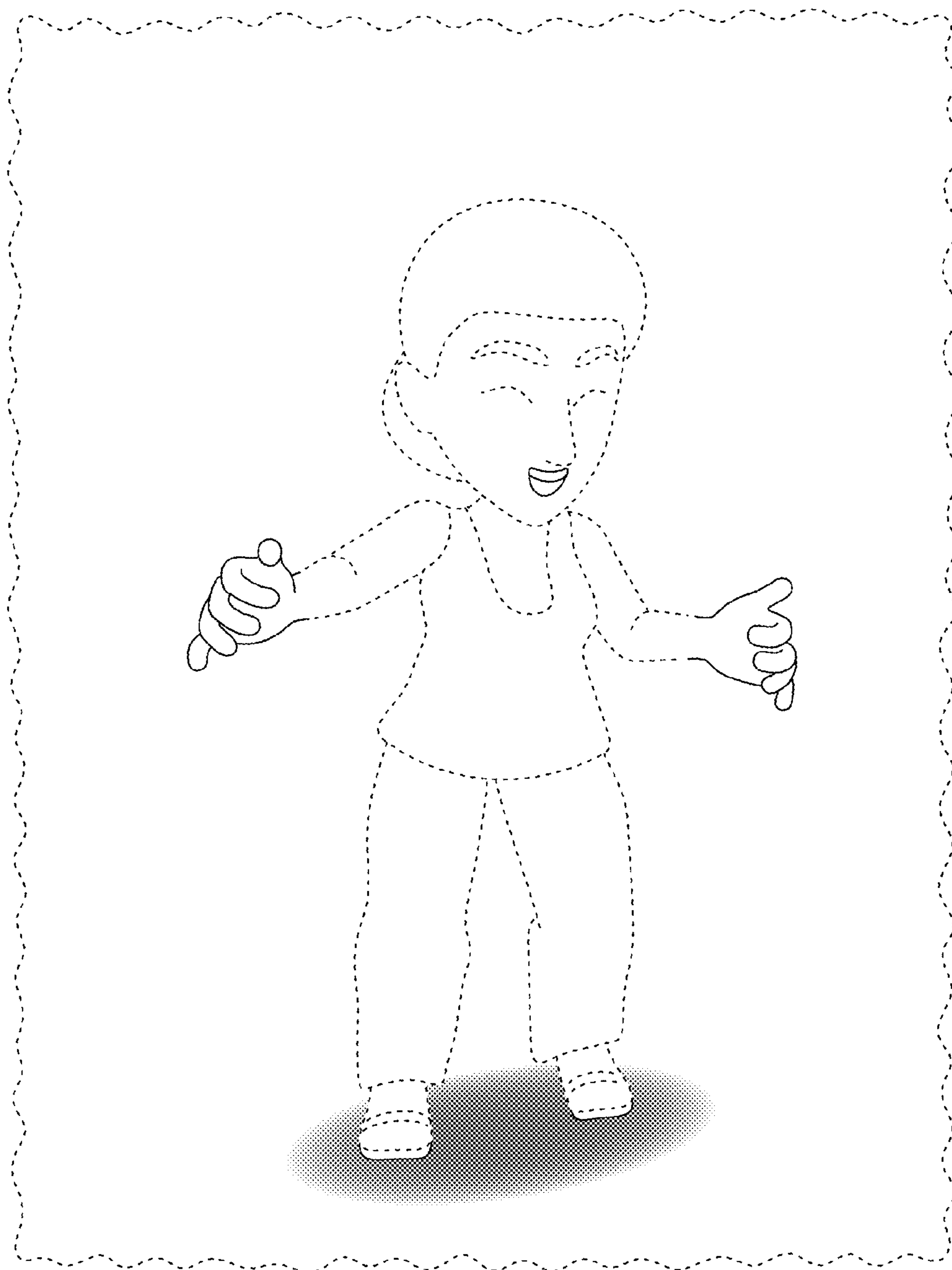

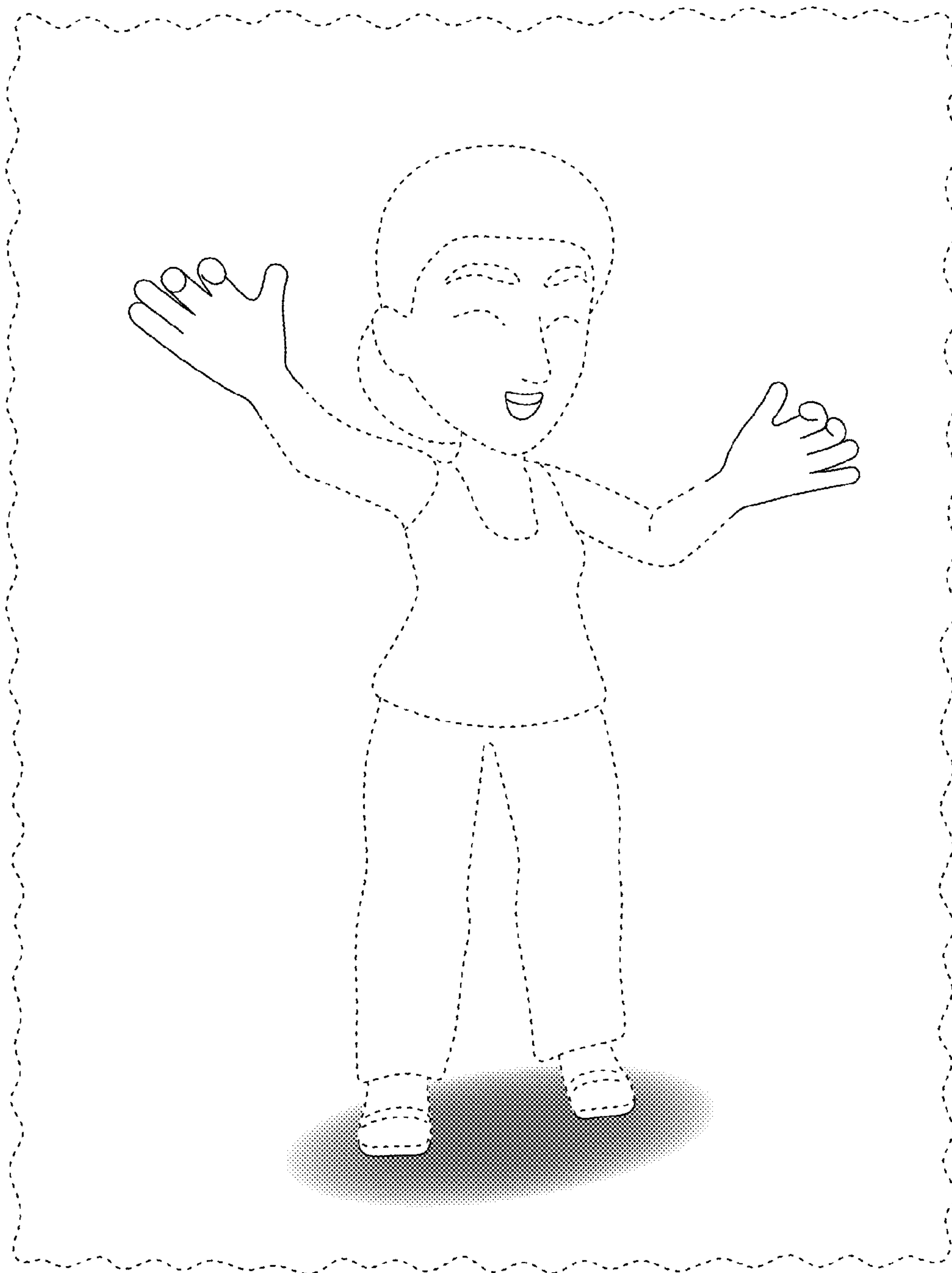

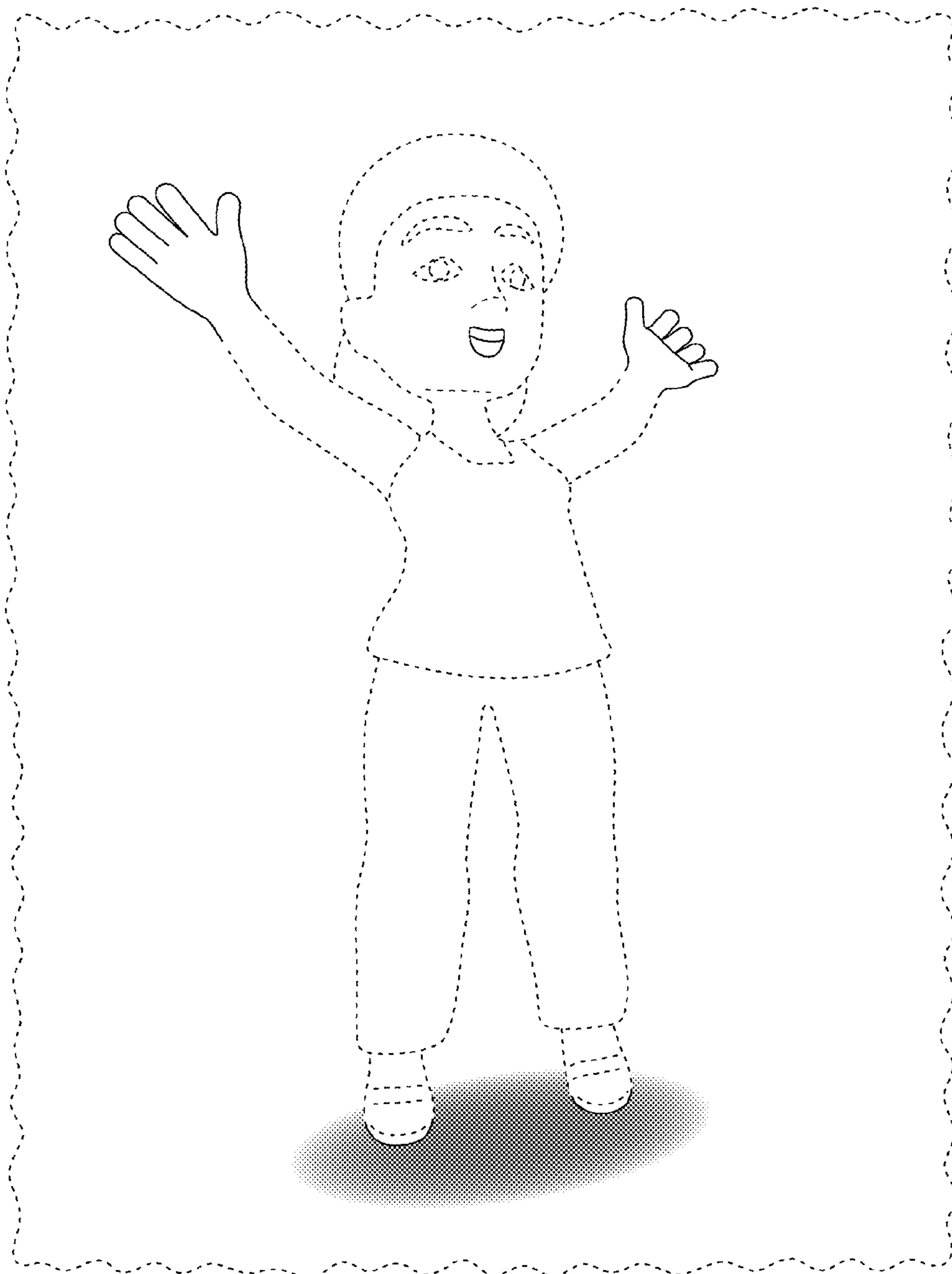

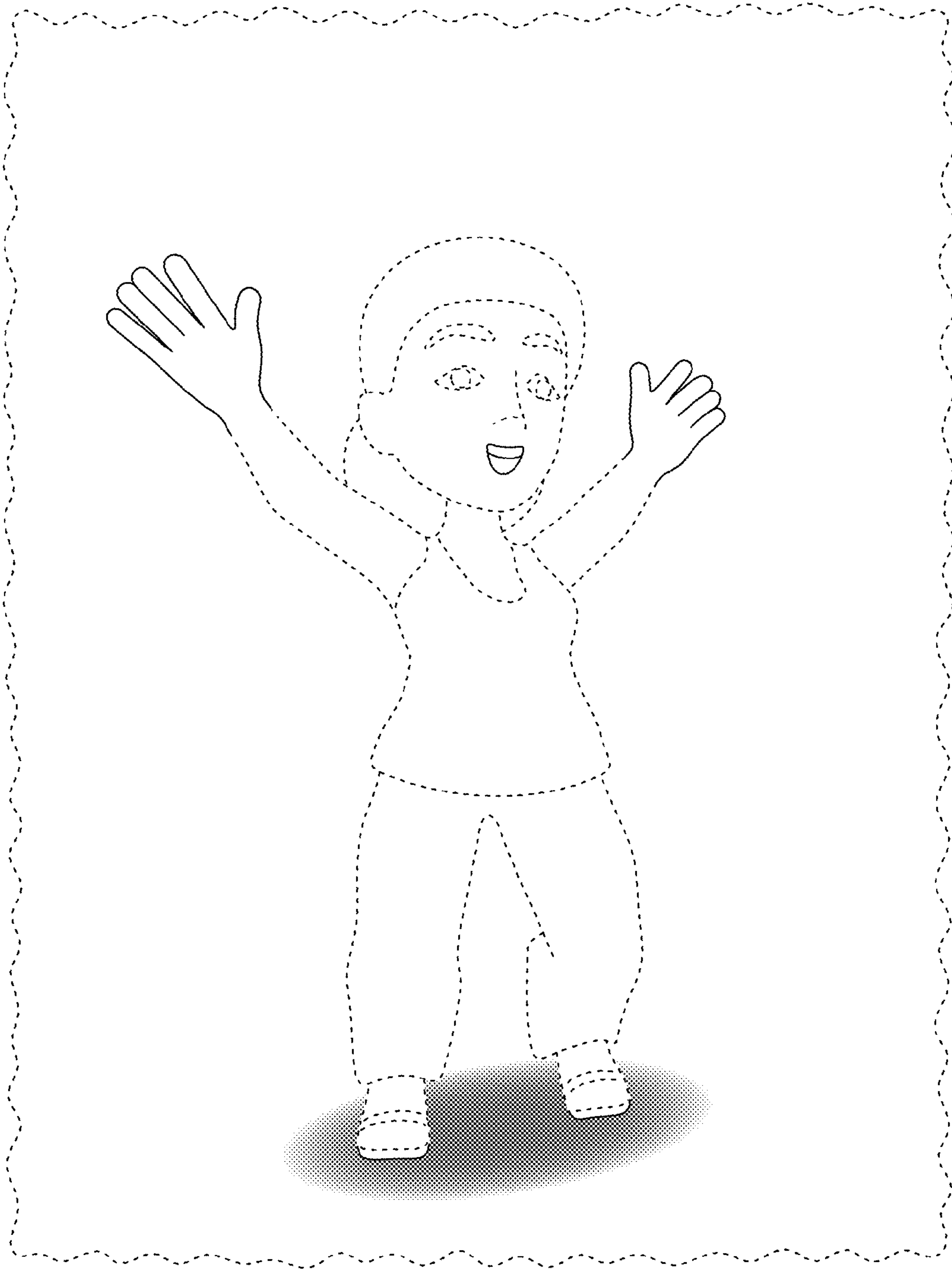

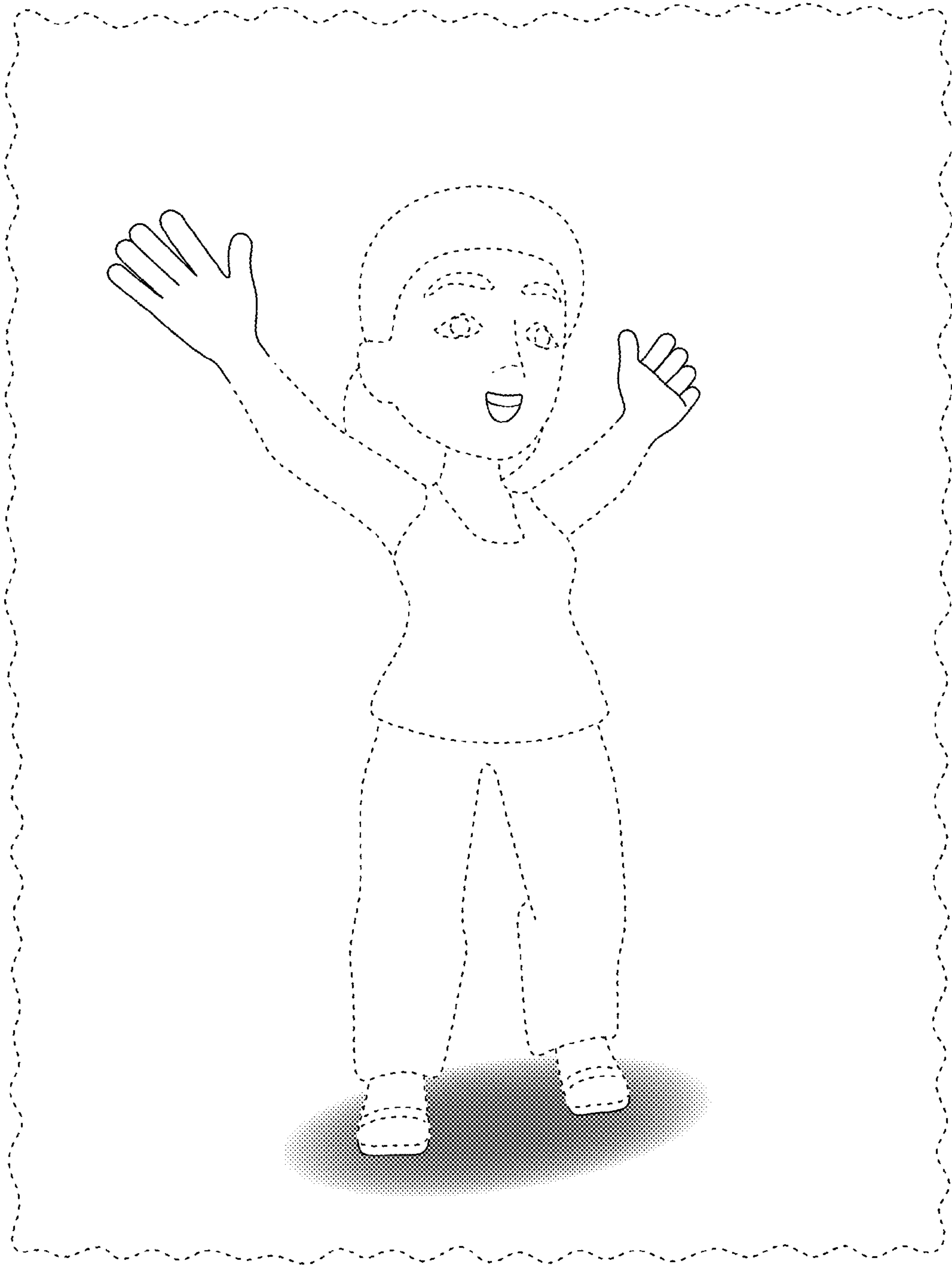

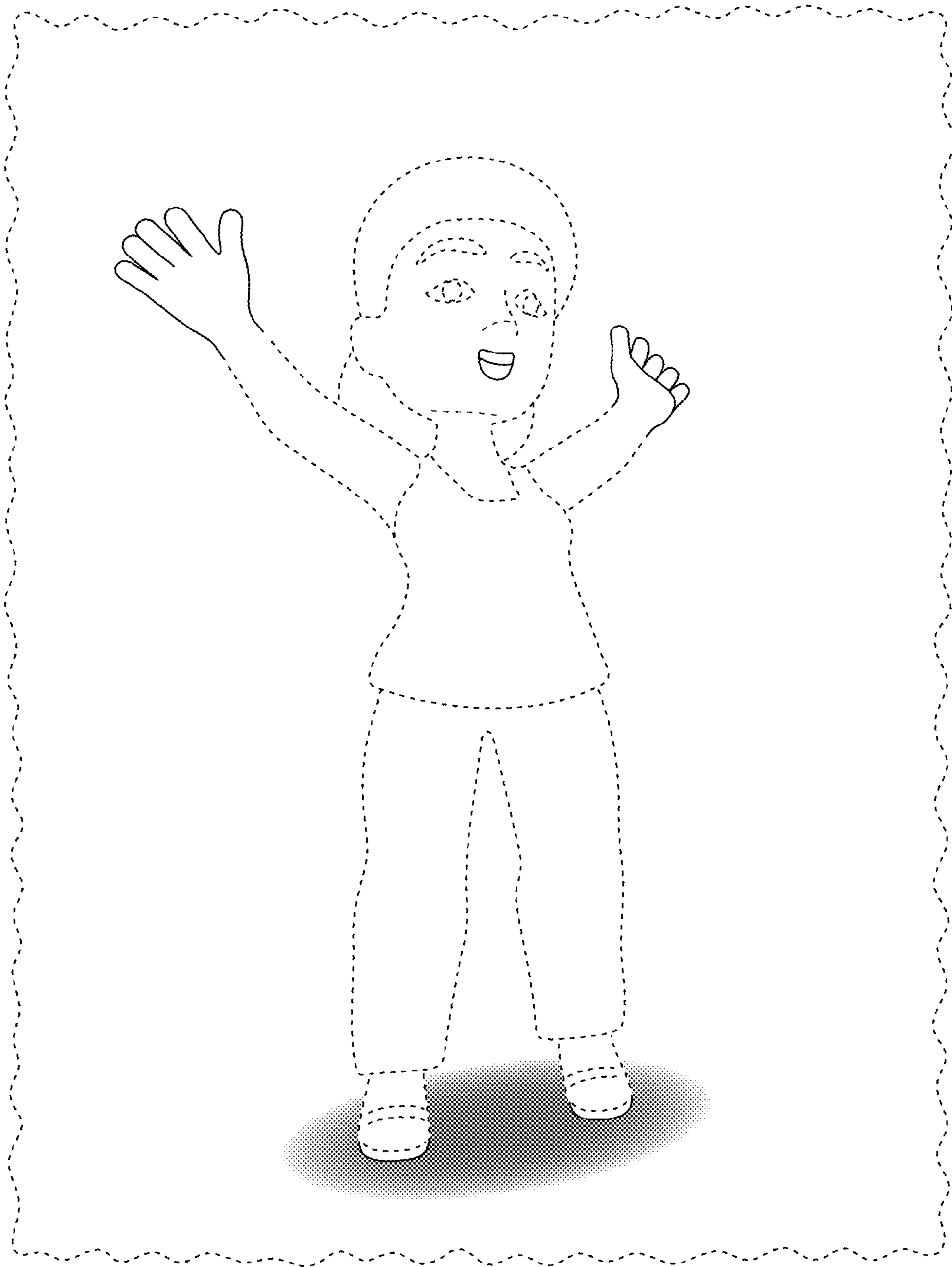

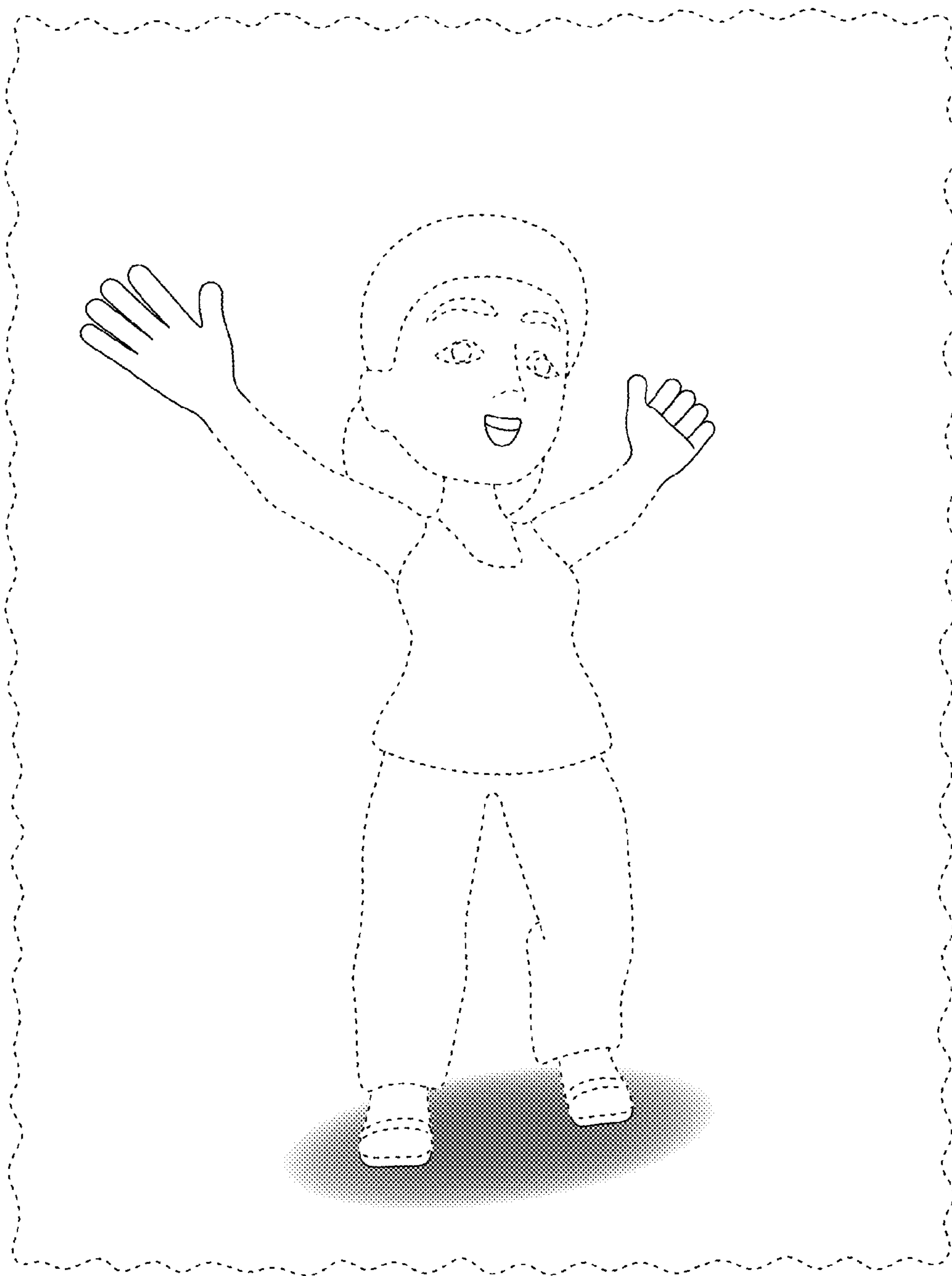

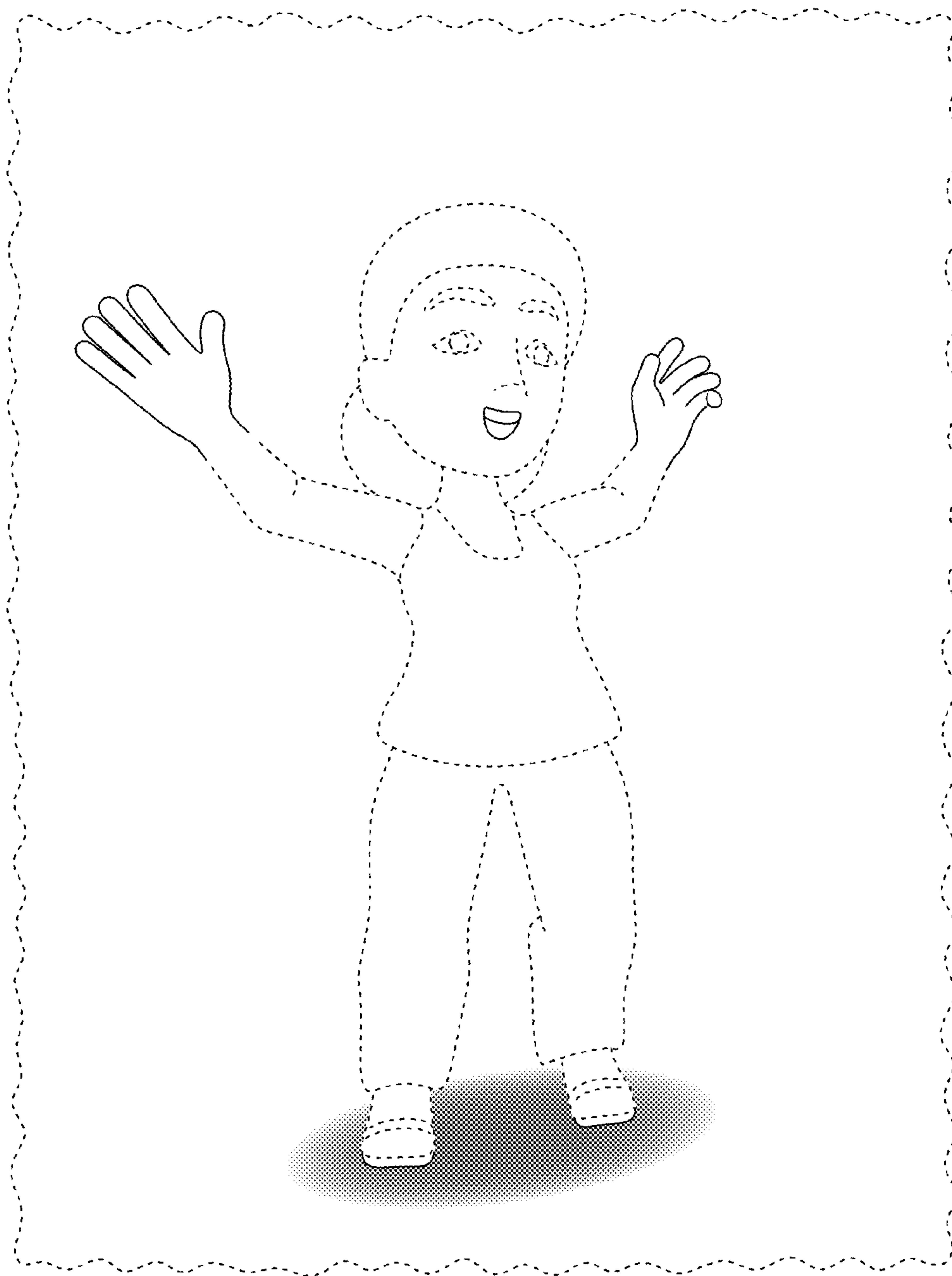

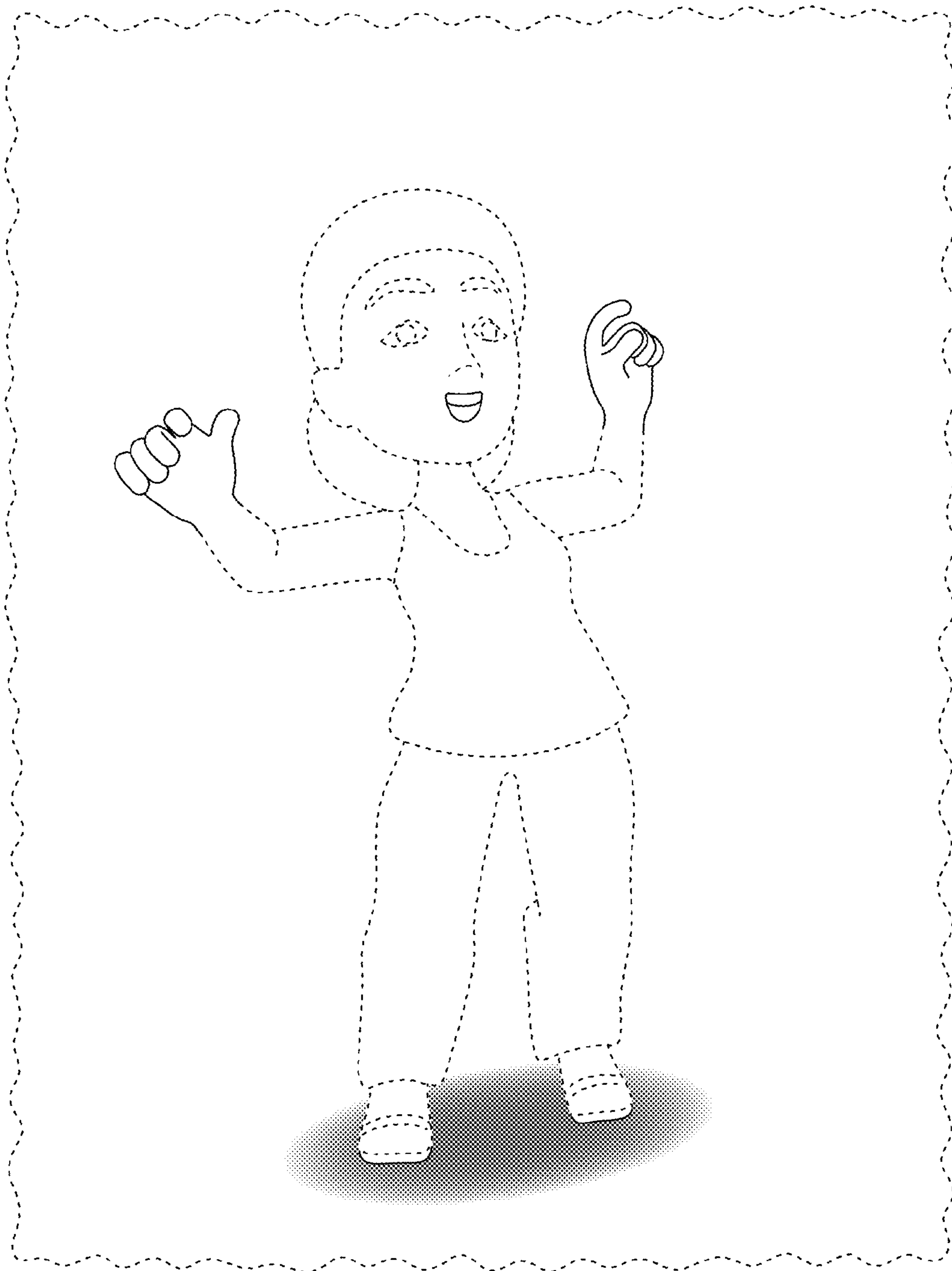

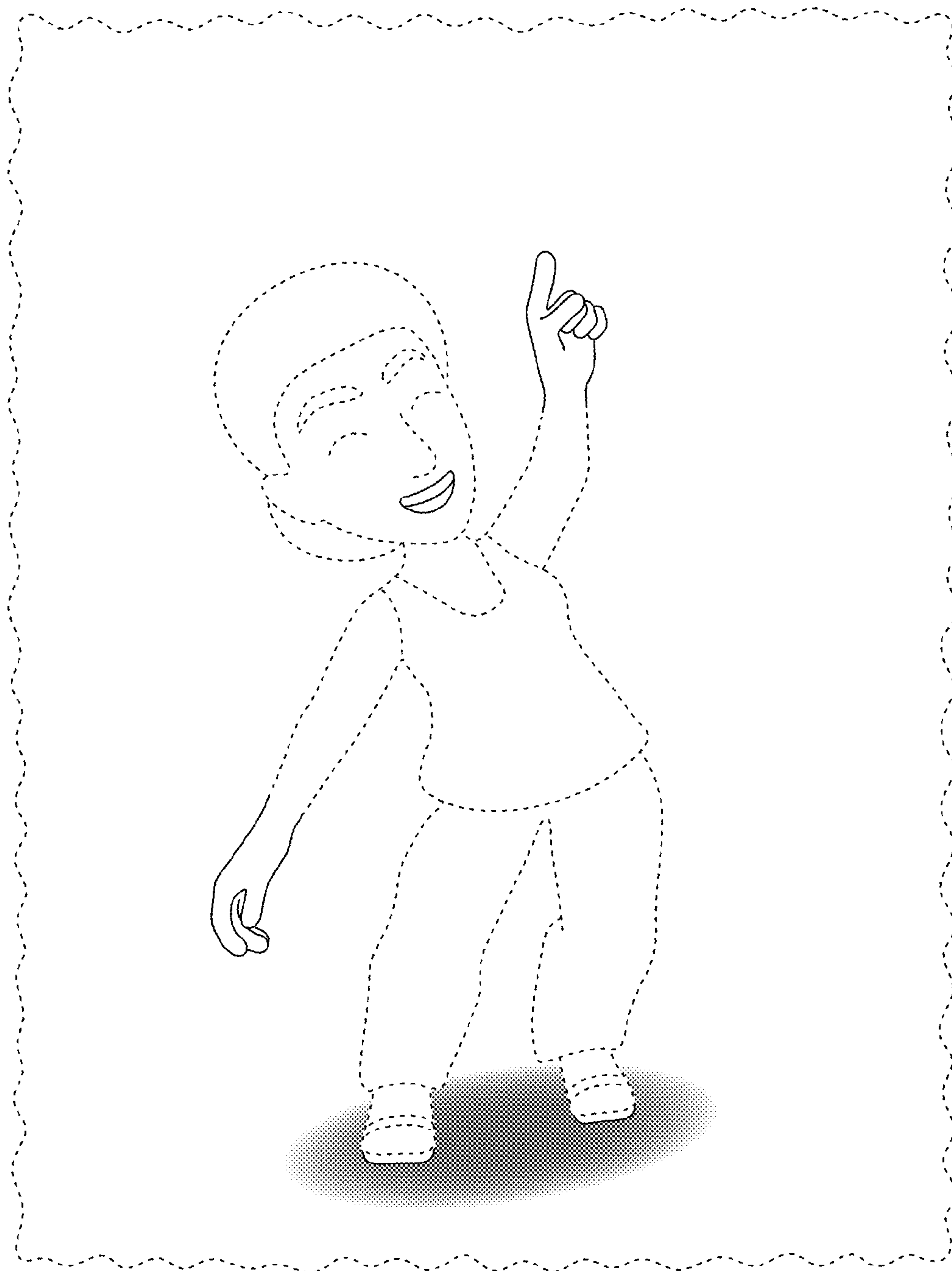
