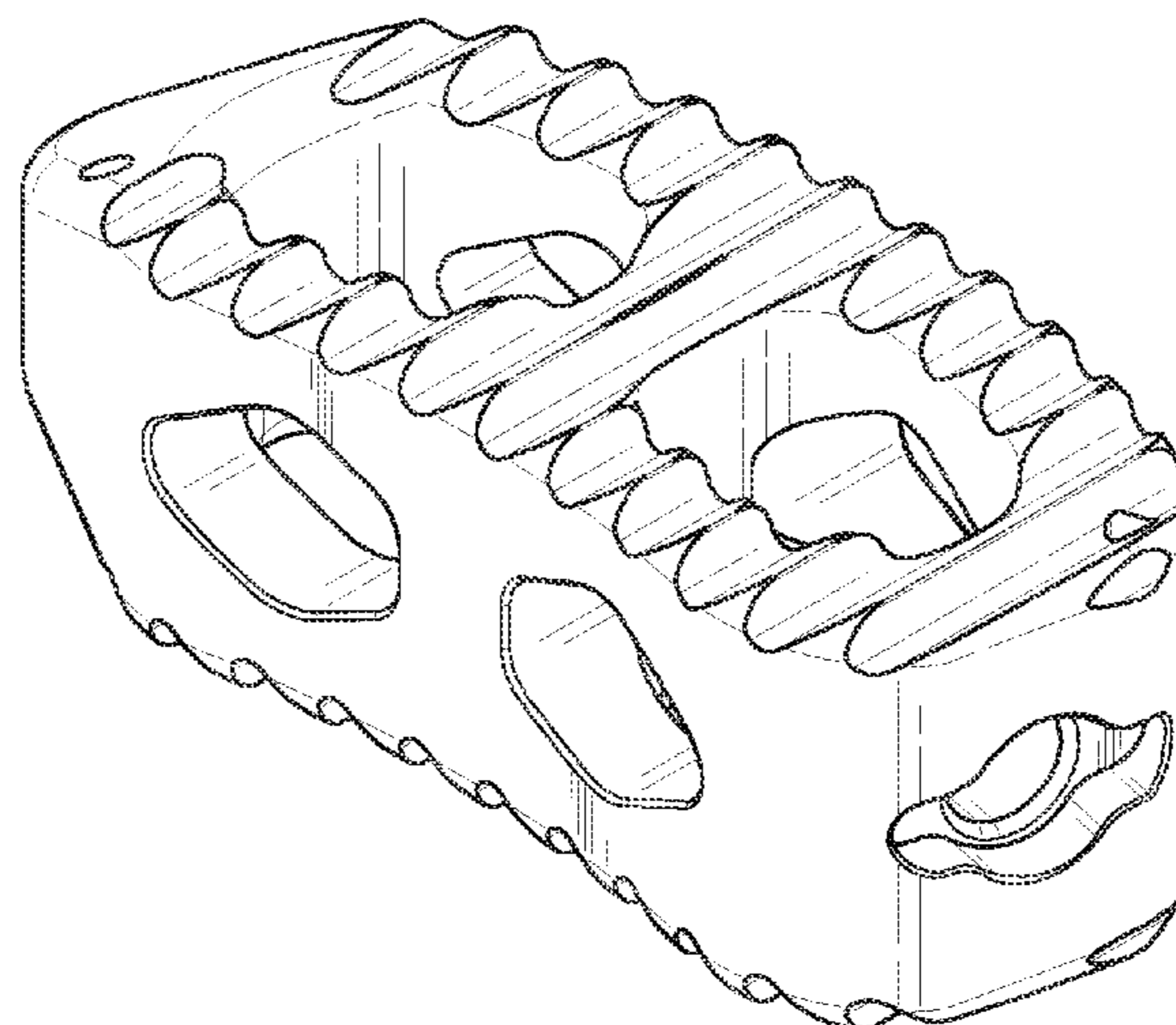
(57) **CLAIM**

The ornamental design for an interbody fusion device implant, as shown and described.

DESCRIPTION

FIG. 1 is a top and front perspective view of an interbody fusion device implant showing our new design;
FIG. 2 is a bottom and rear perspective view thereof;
FIG. 3 is a front elevation thereof;
FIG. 4 is a rear elevation thereof;
FIG. 5 is a left side elevation thereof;
FIG. 6 is a right side elevation thereof;
FIG. 7 is a top plan view thereof; and,
FIG. 8 is a bottom plan view thereof.

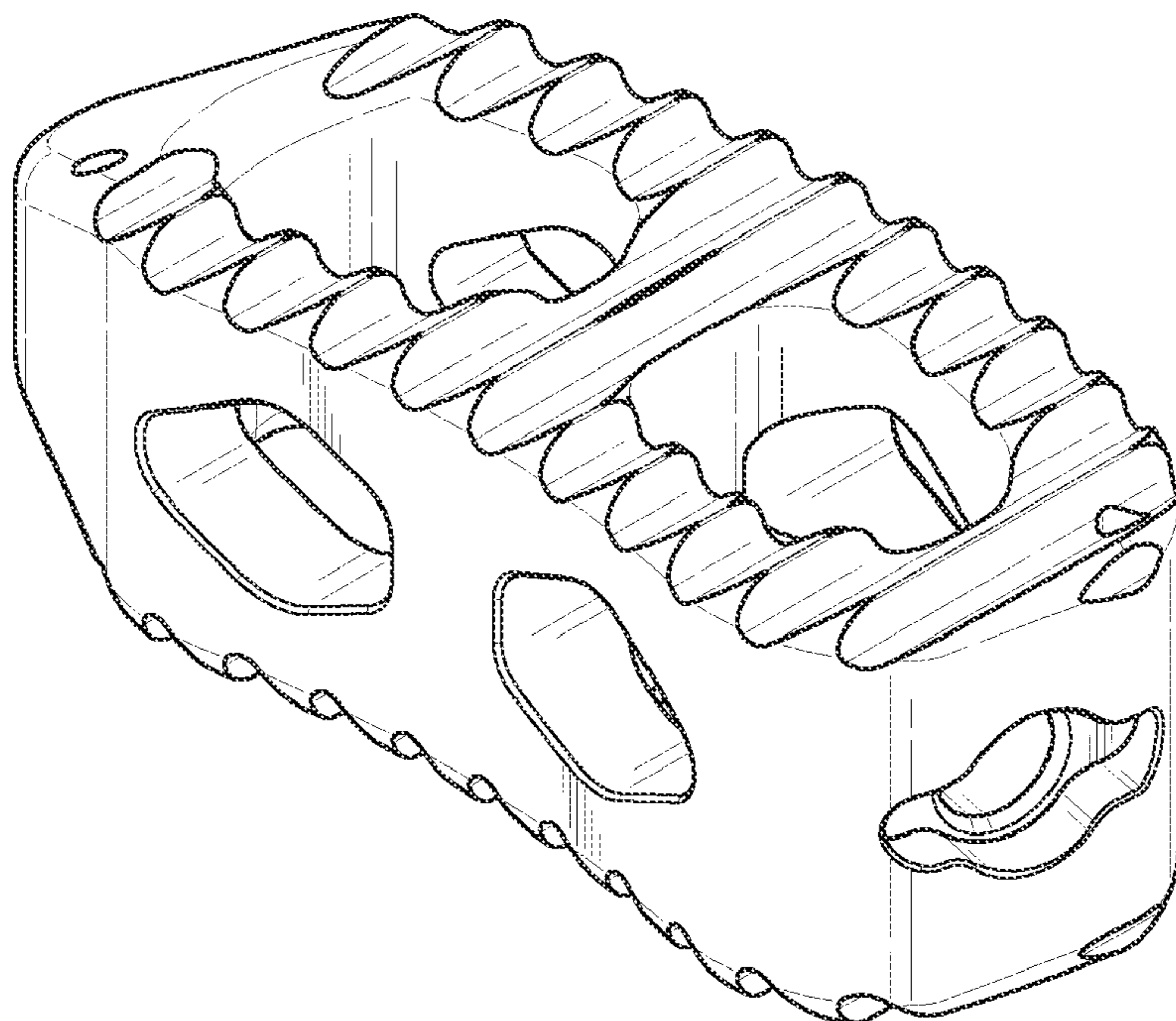

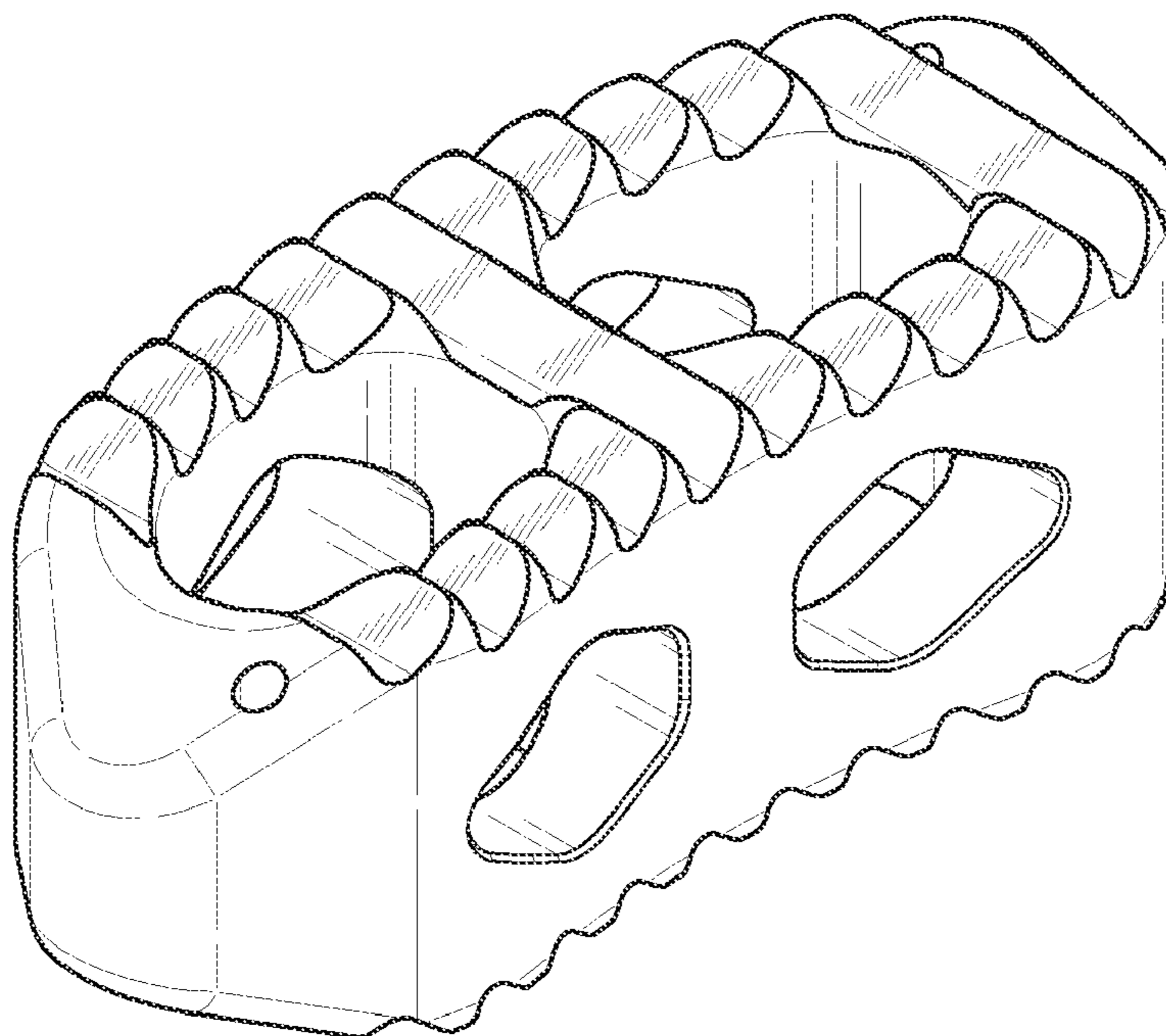

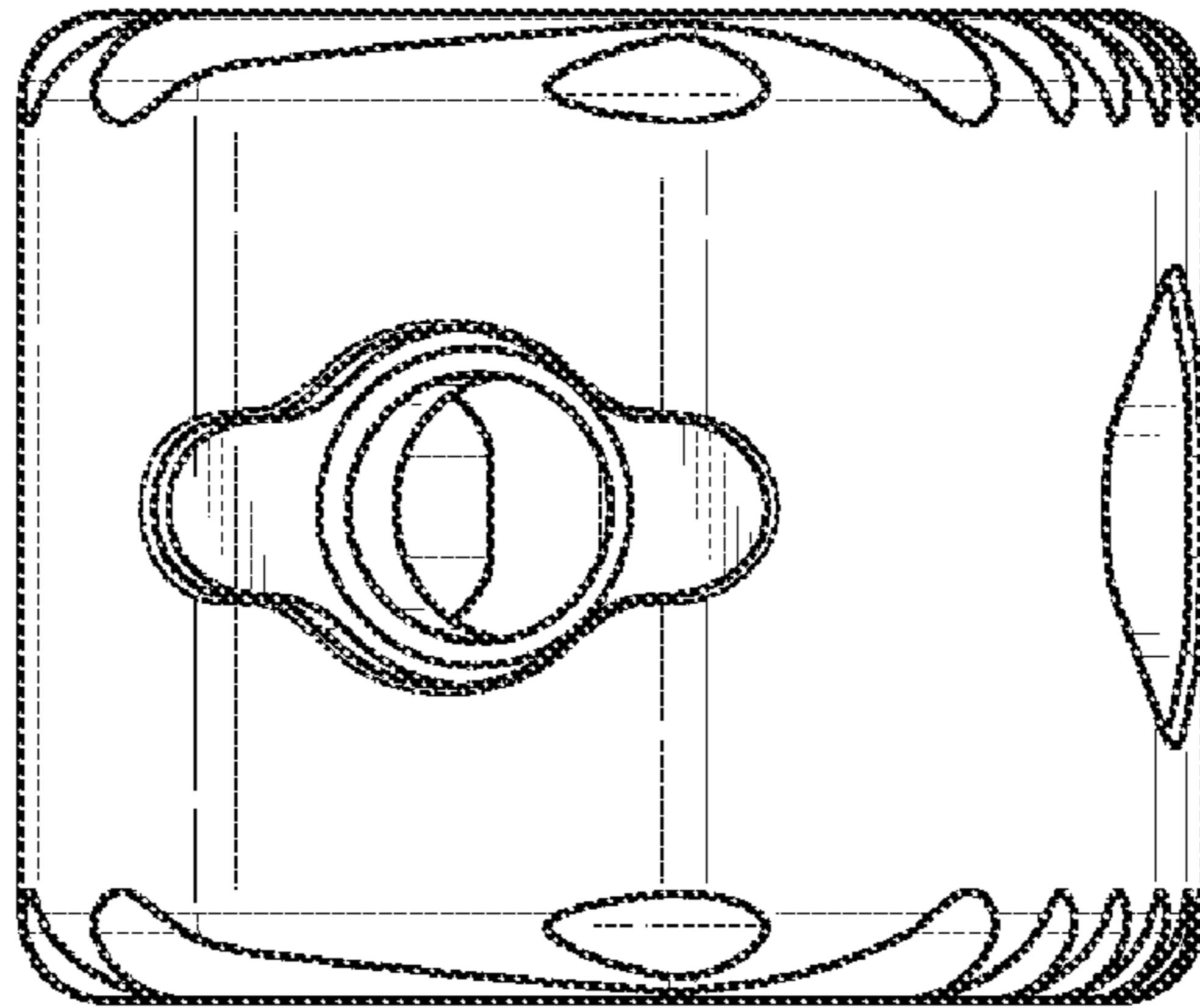

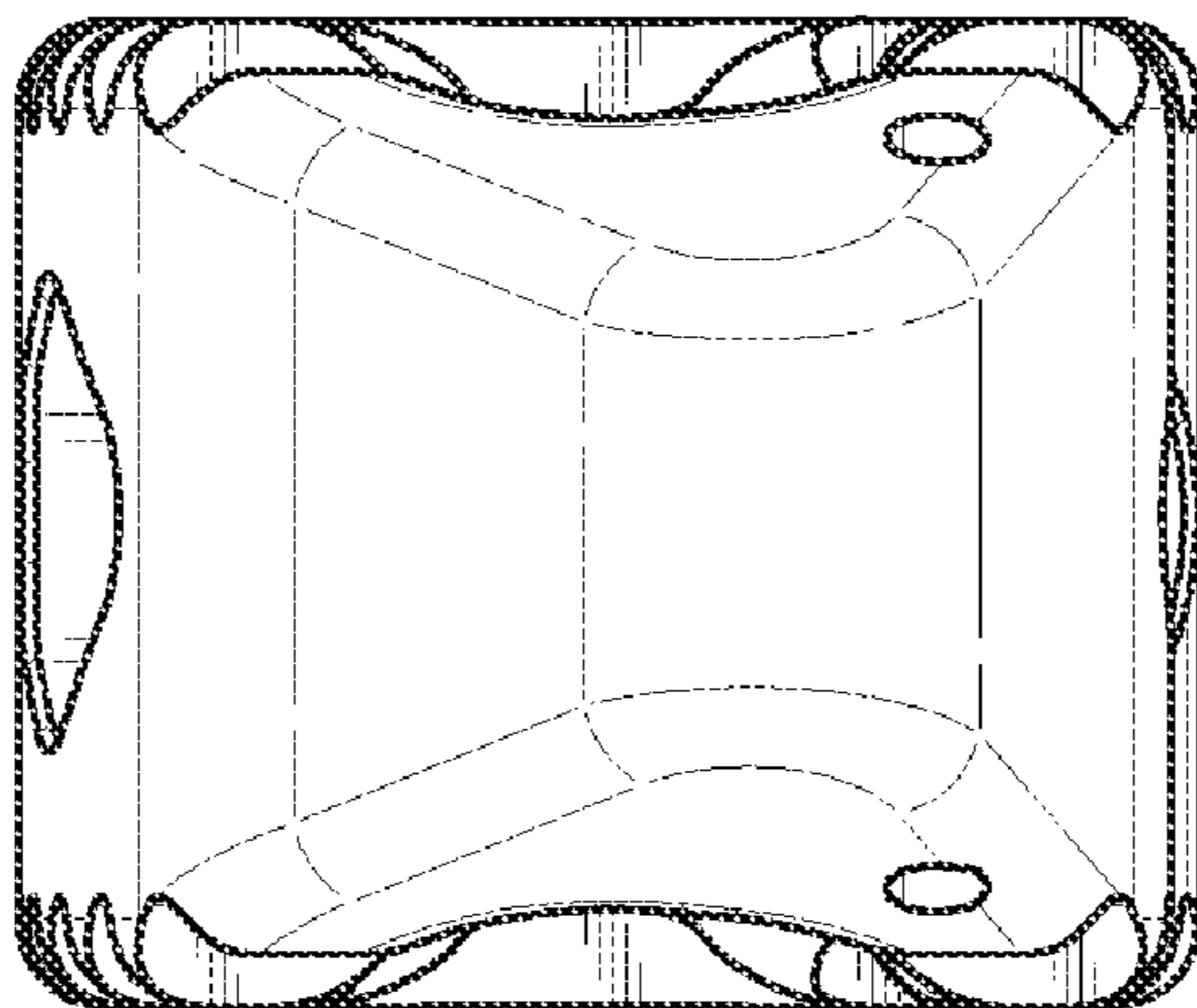

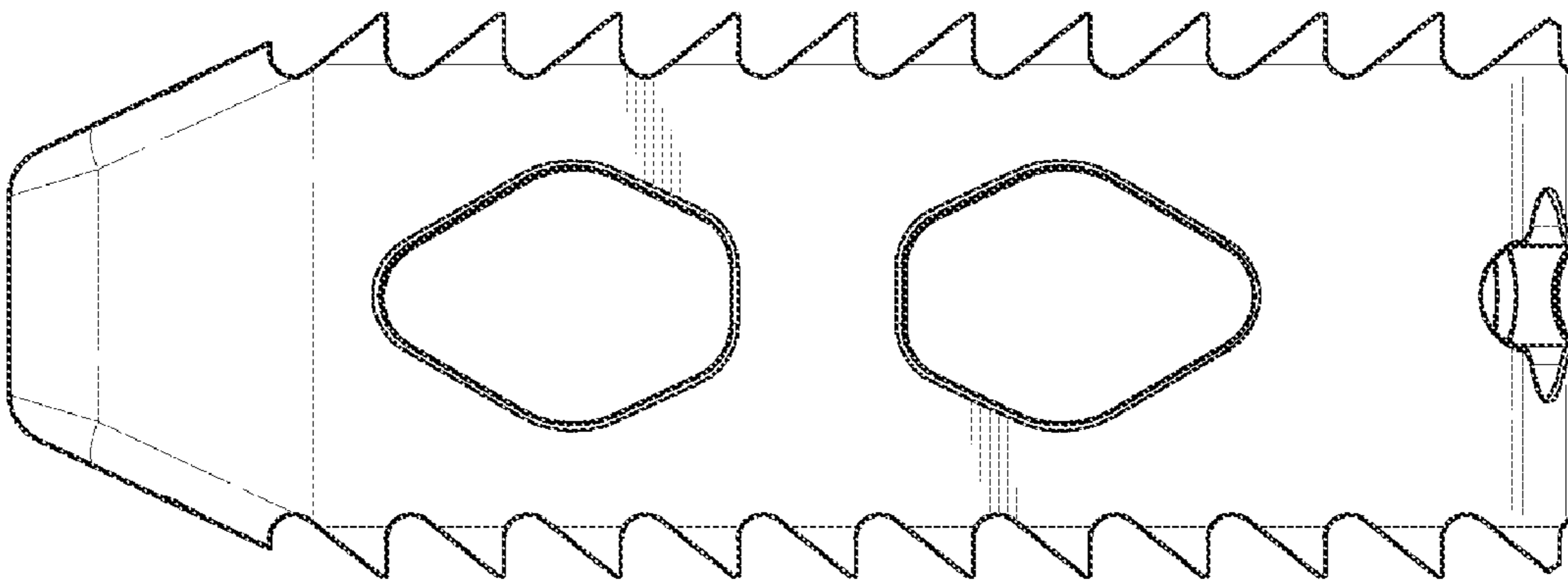

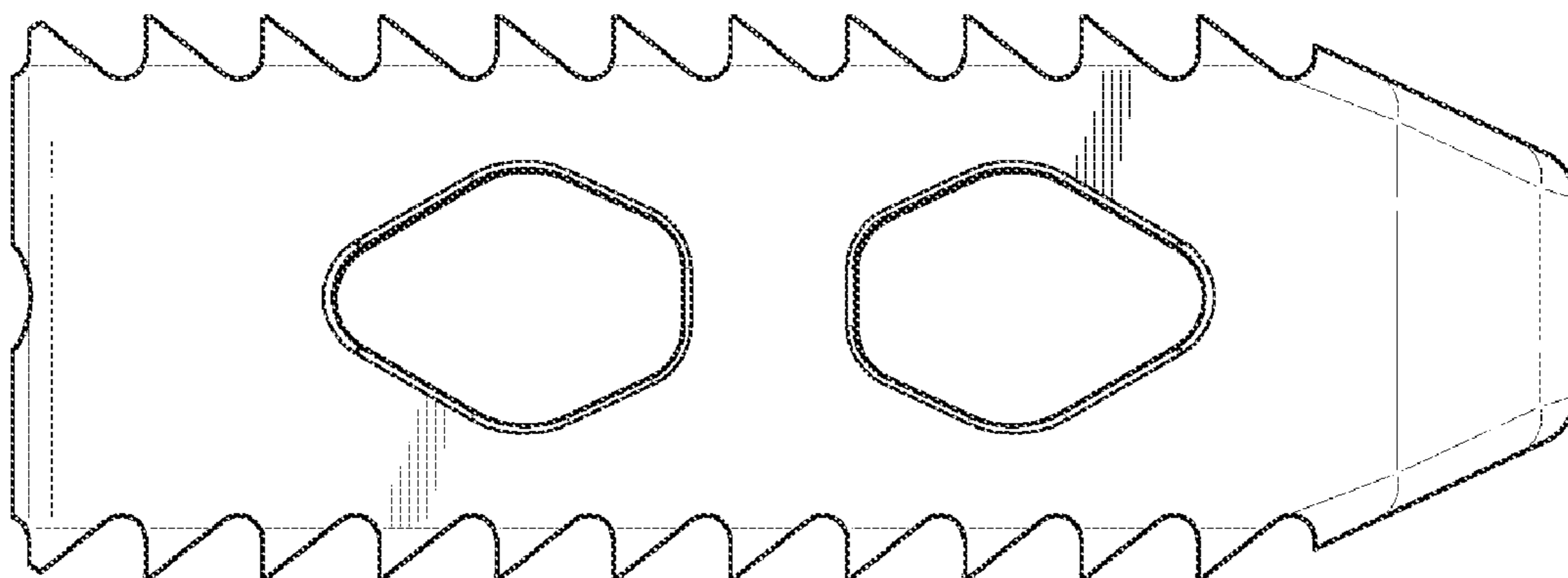

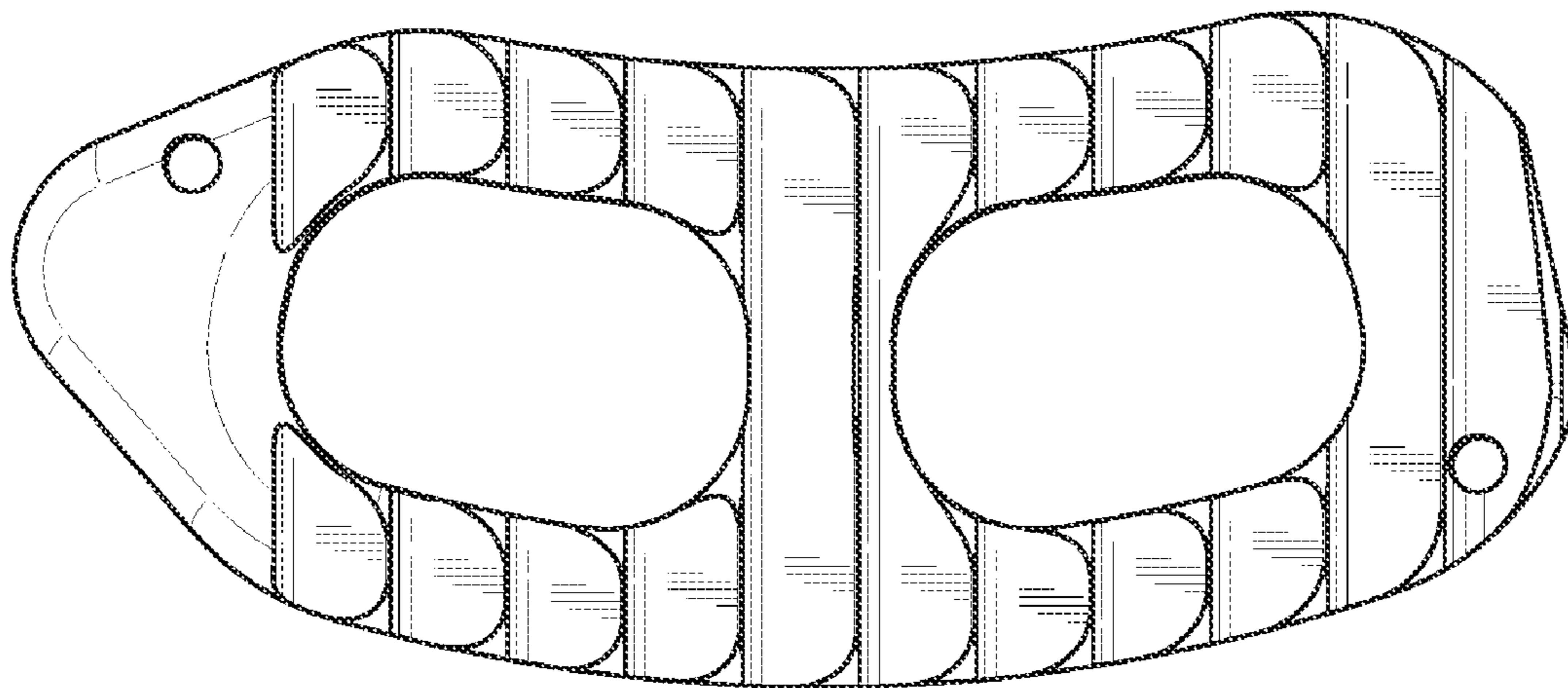

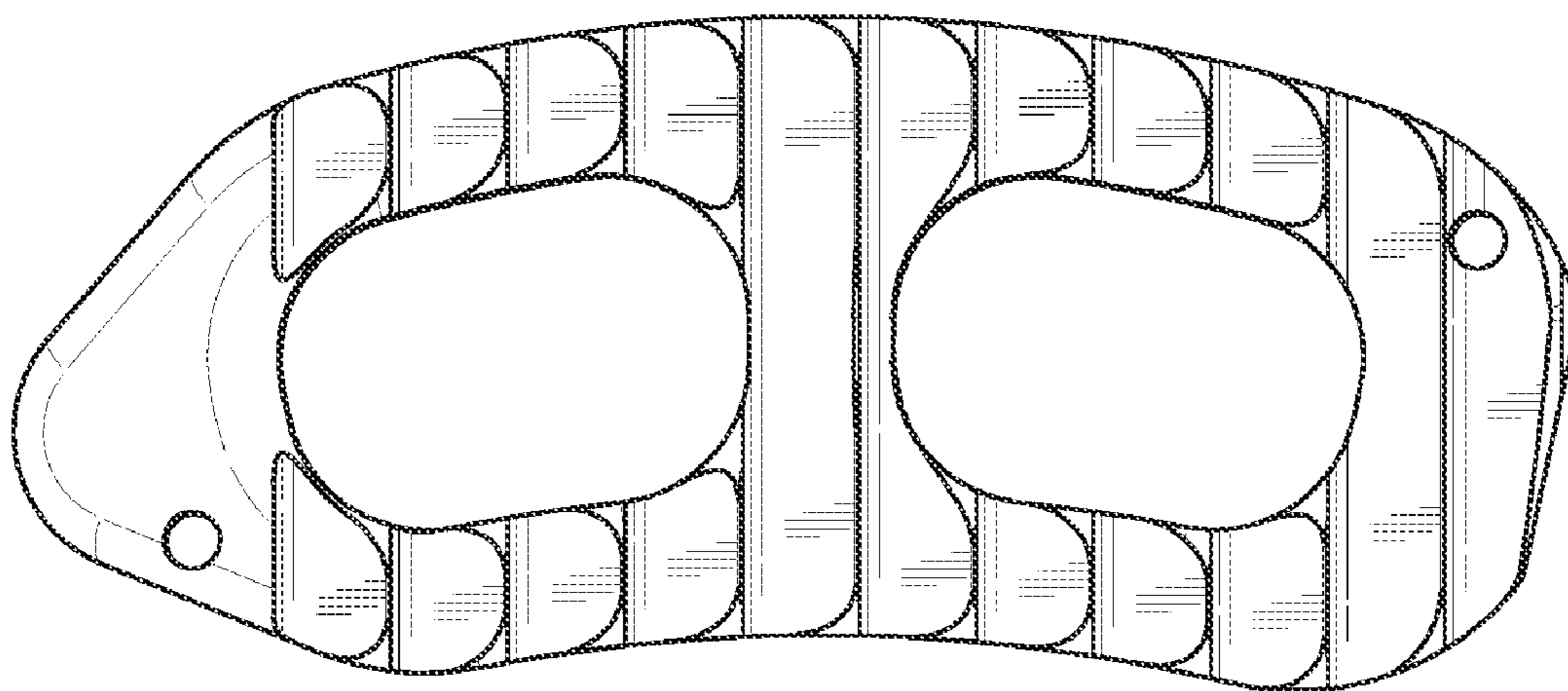
