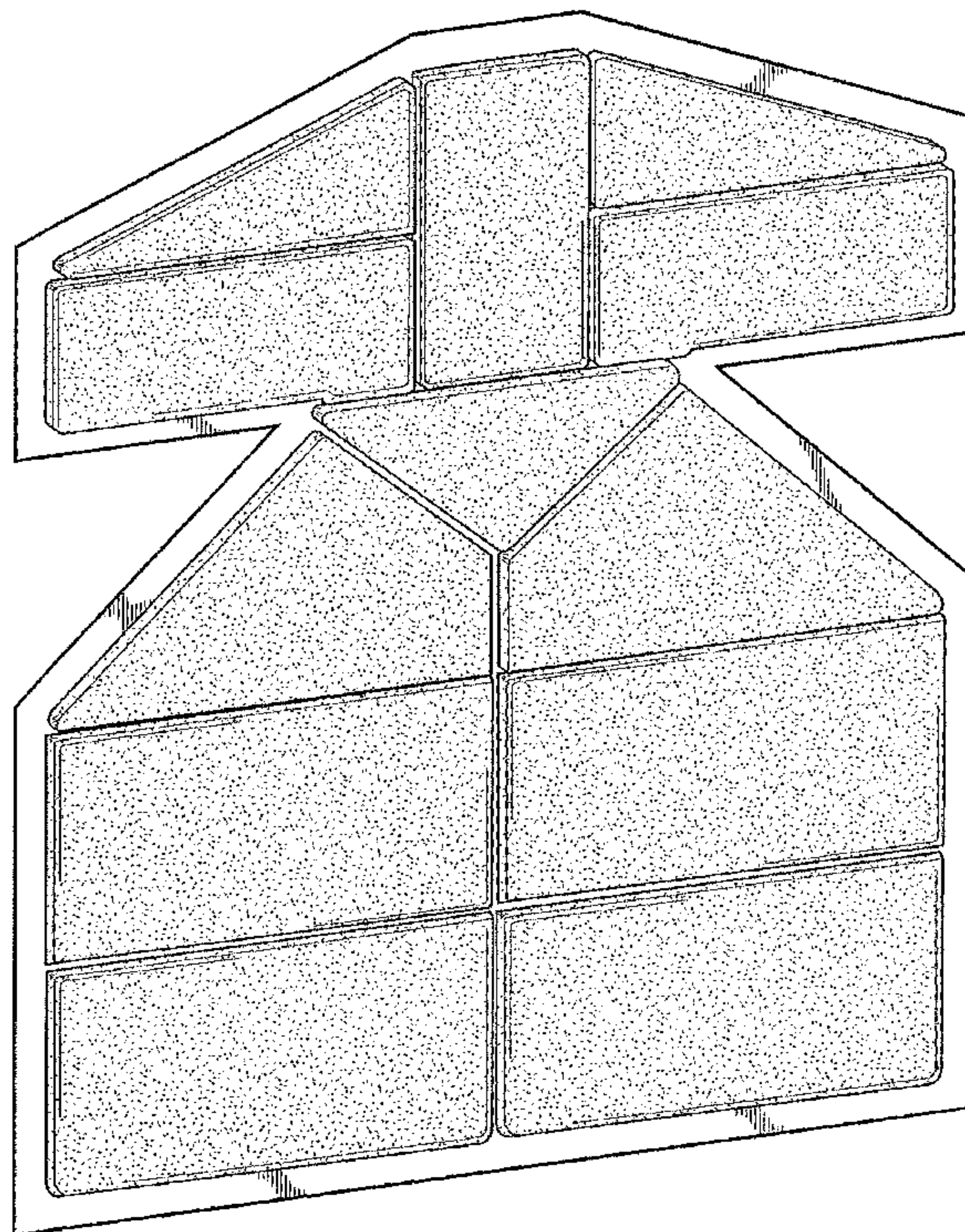
(57) **CLAIM**

The ornamental design for a foot dressing, as shown and described.

**DESCRIPTION**

FIG. 1 is a front elevational view of a foot dressing in accordance with the invention;  
FIG. 2 is a top view of the foot dressing of FIG. 1;  
FIG. 3 is a bottom view of the foot dressing of FIG. 1;  
FIG. 4 is a left side view of the foot dressing of FIG. 1, with a mirror image right side view omitted;  
FIG. 5 is a rear view of the foot dressing of FIG. 1; and,  
FIG. 6 is a front perspective view of the foot dressing of FIG. 1.

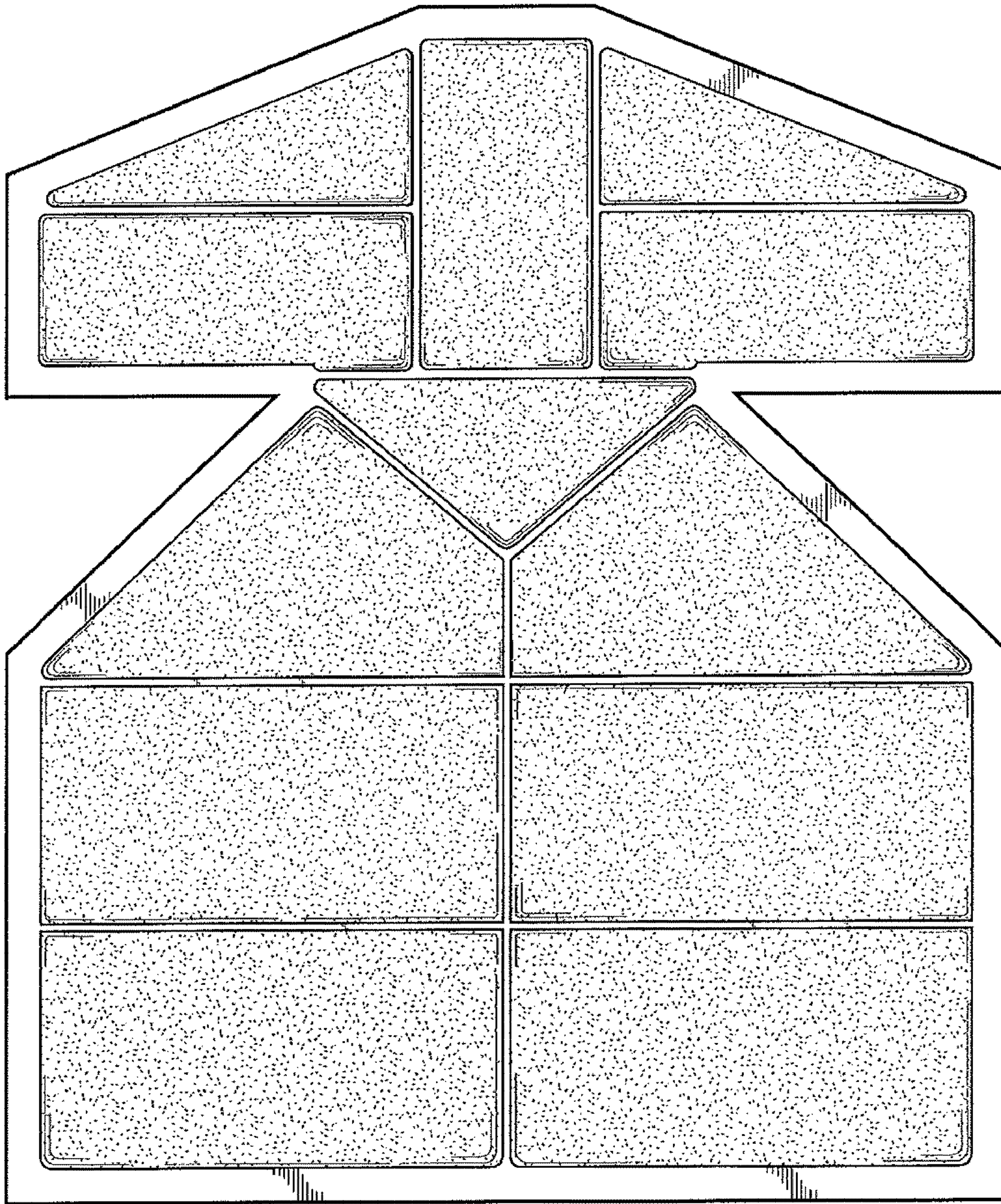

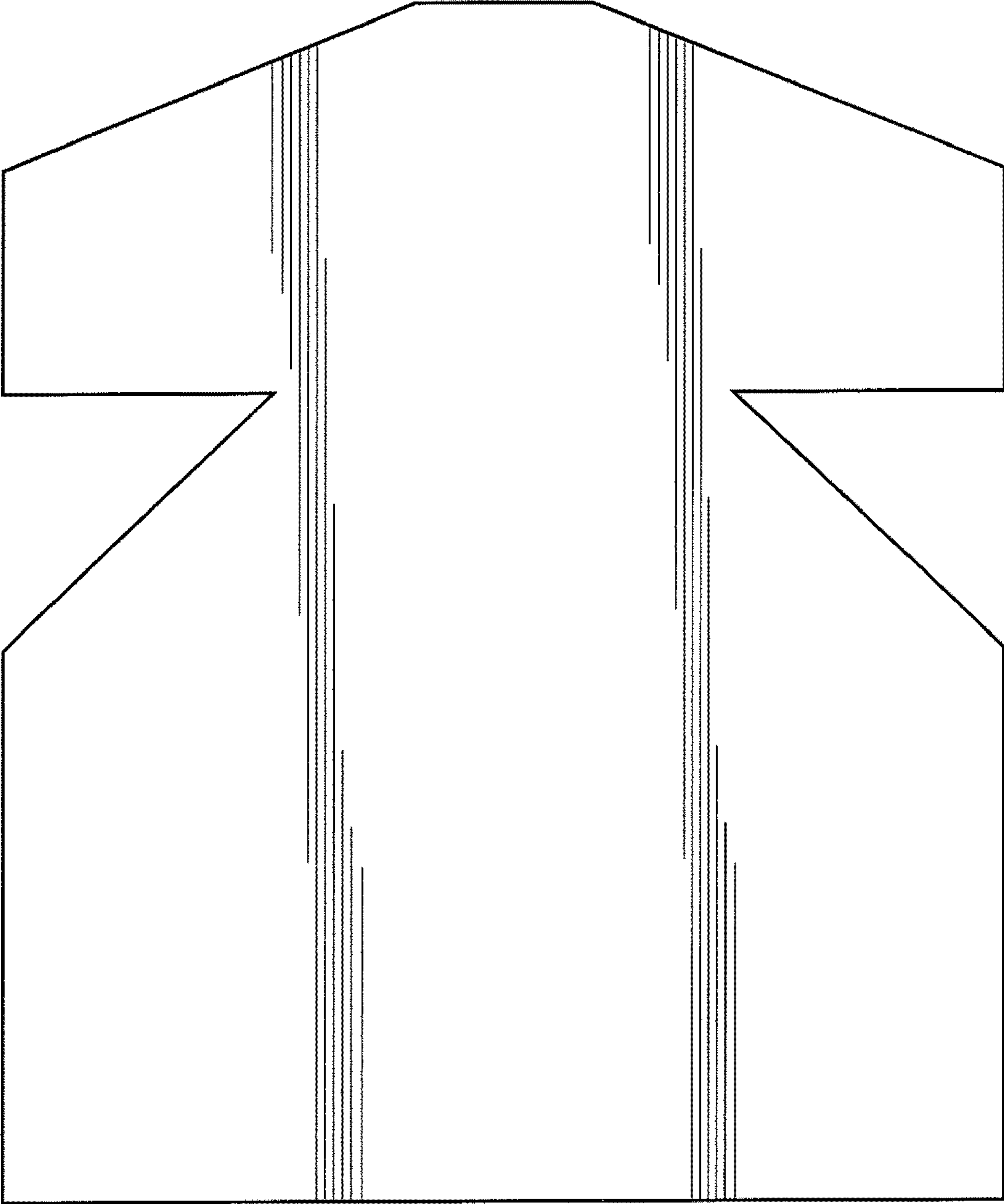

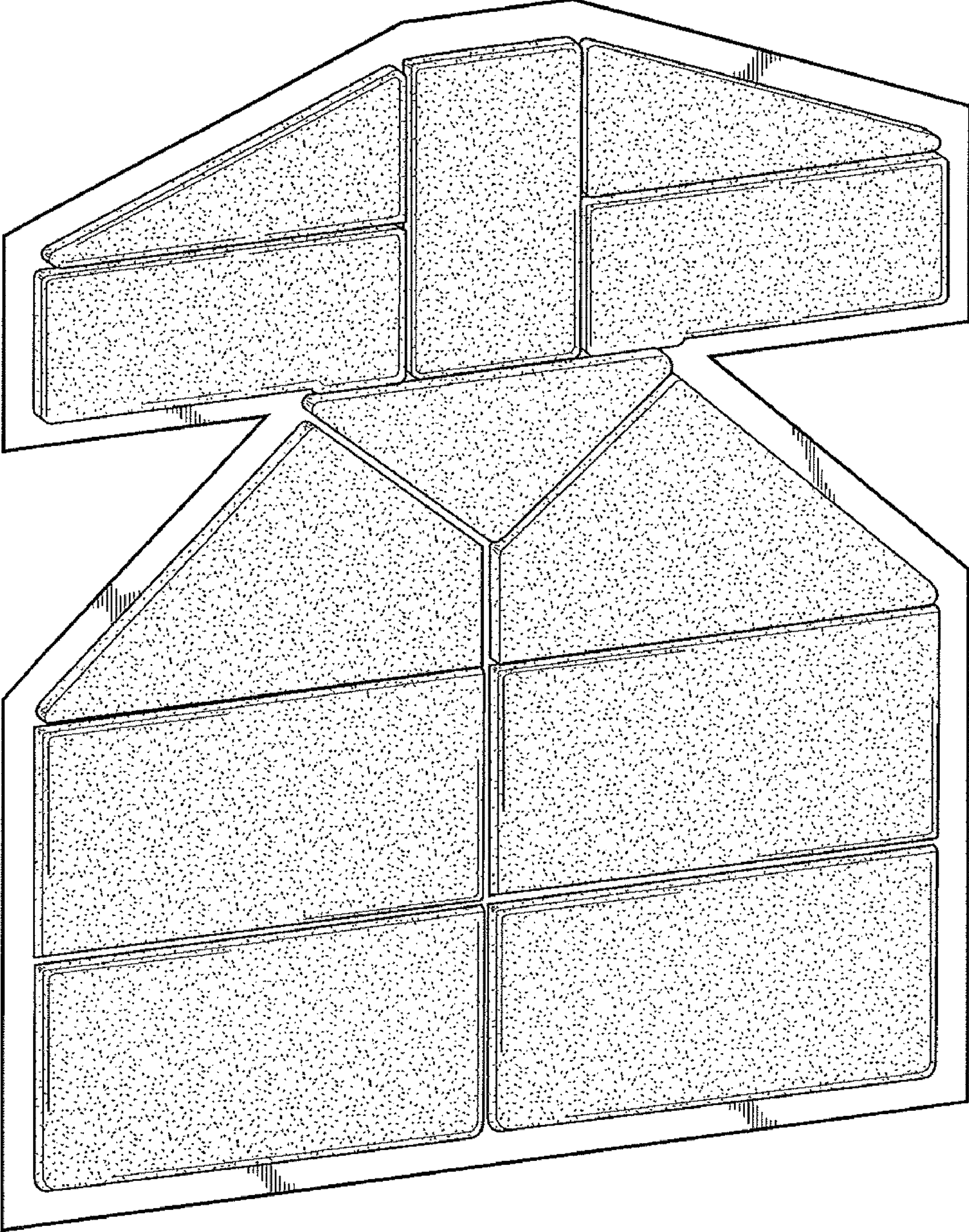
