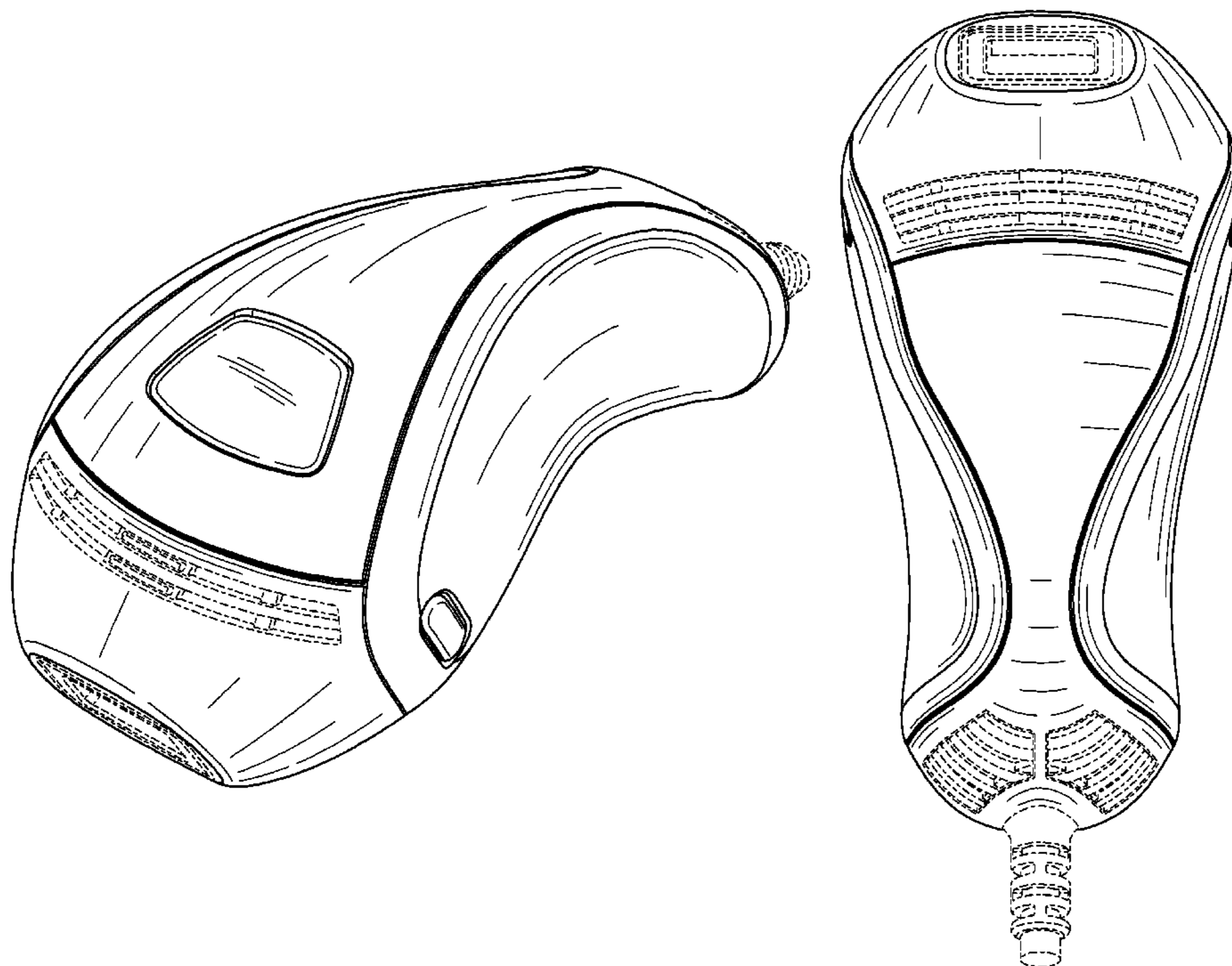
FIG. 5 is a left side view thereof;

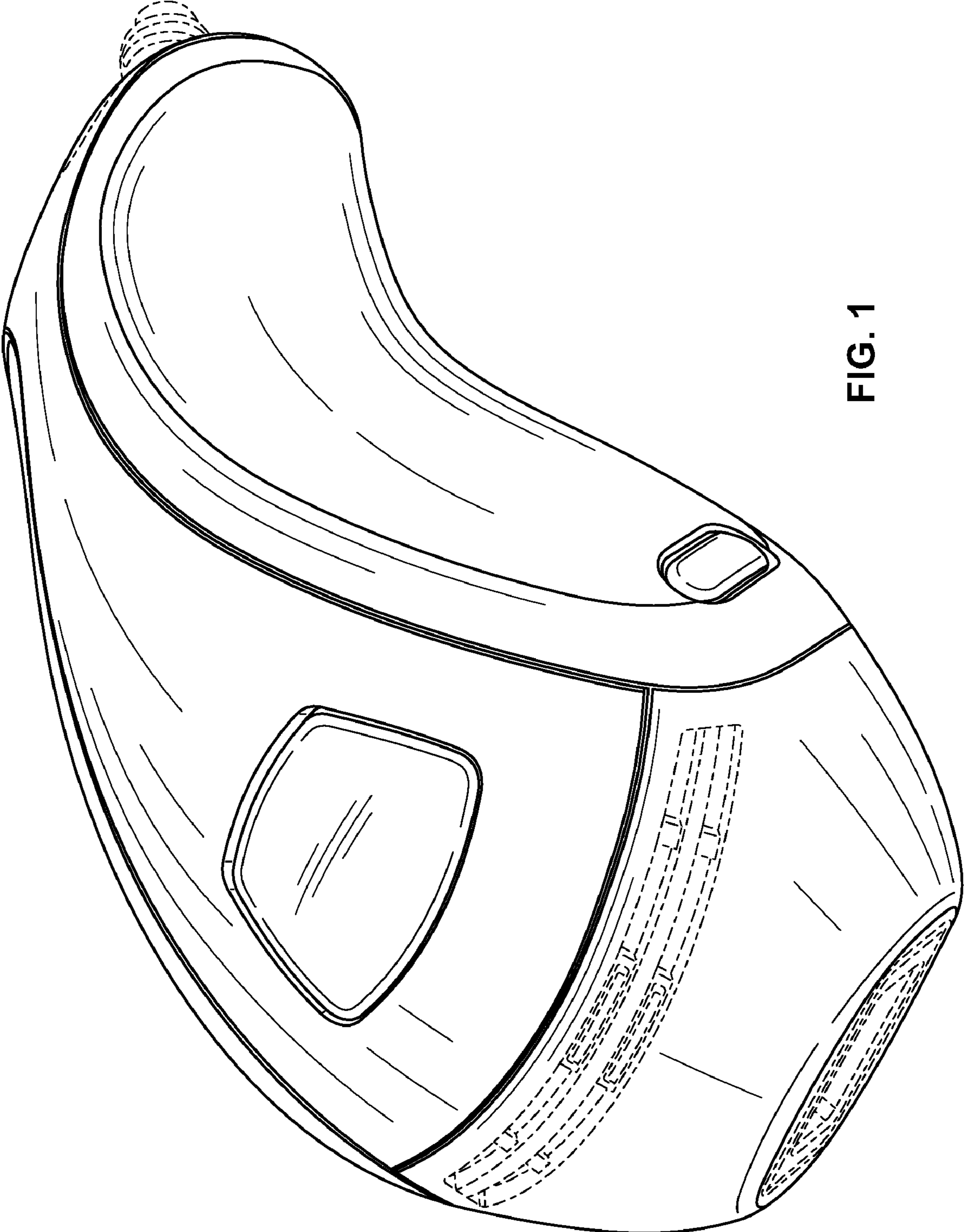

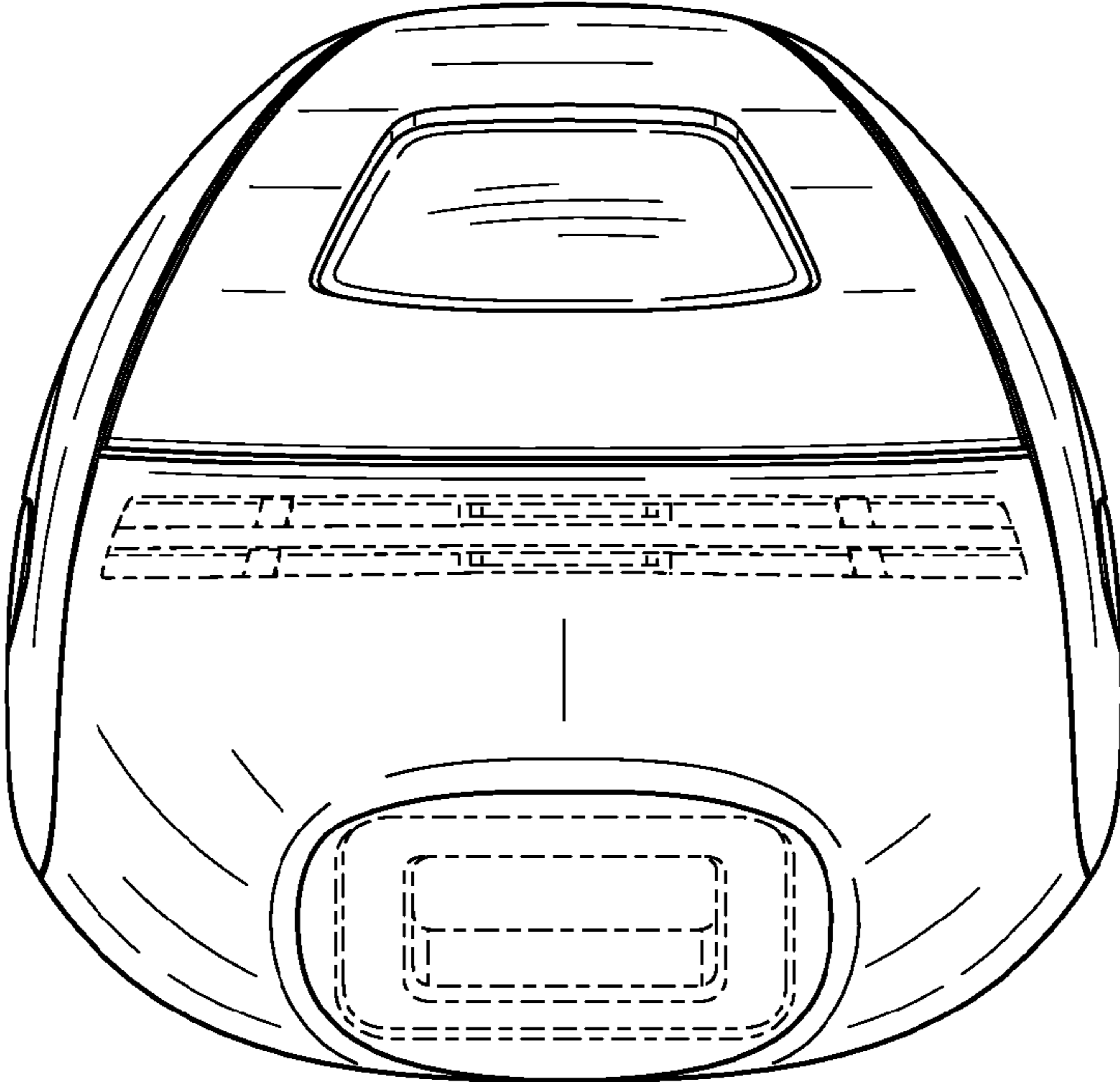

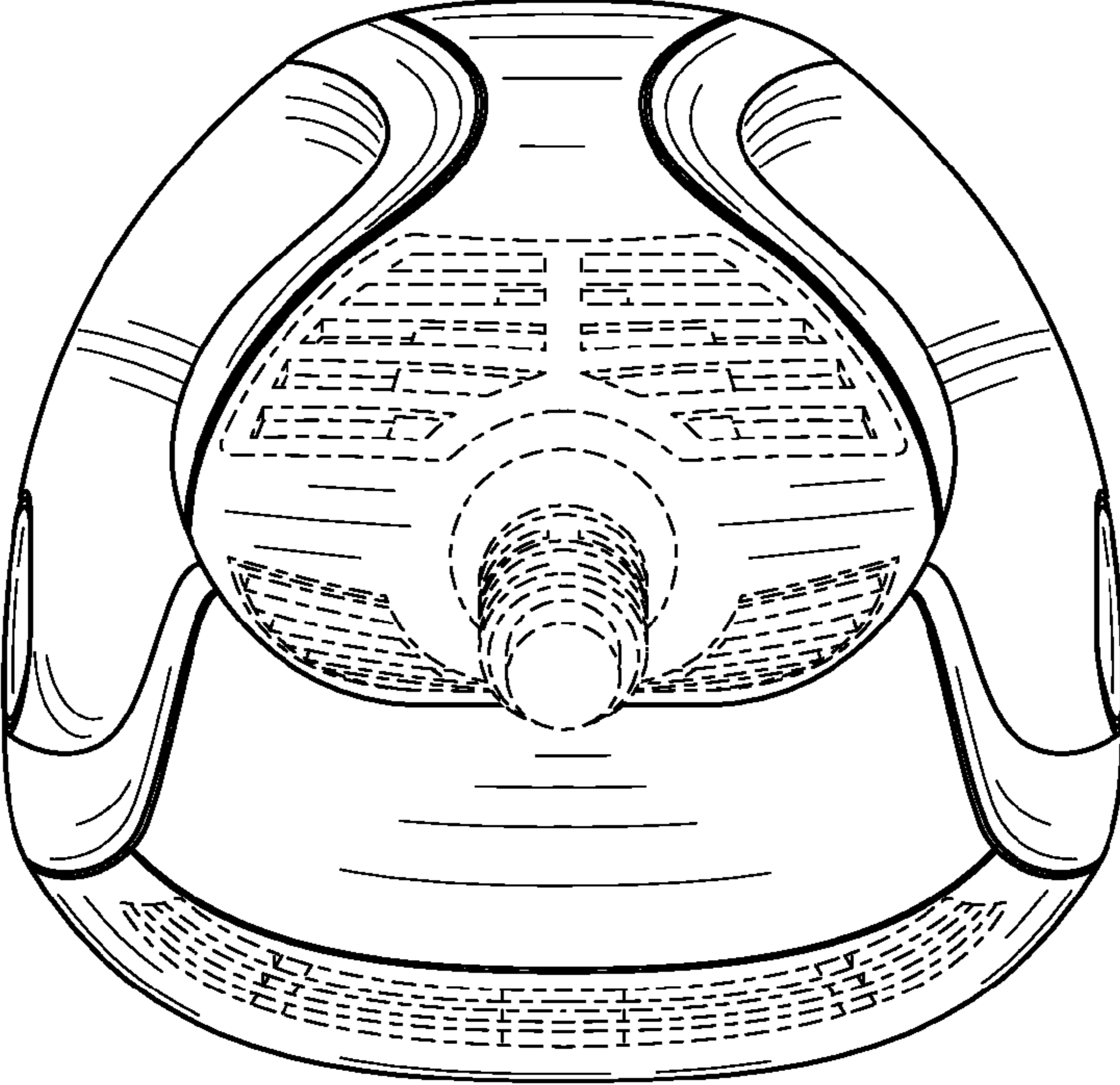

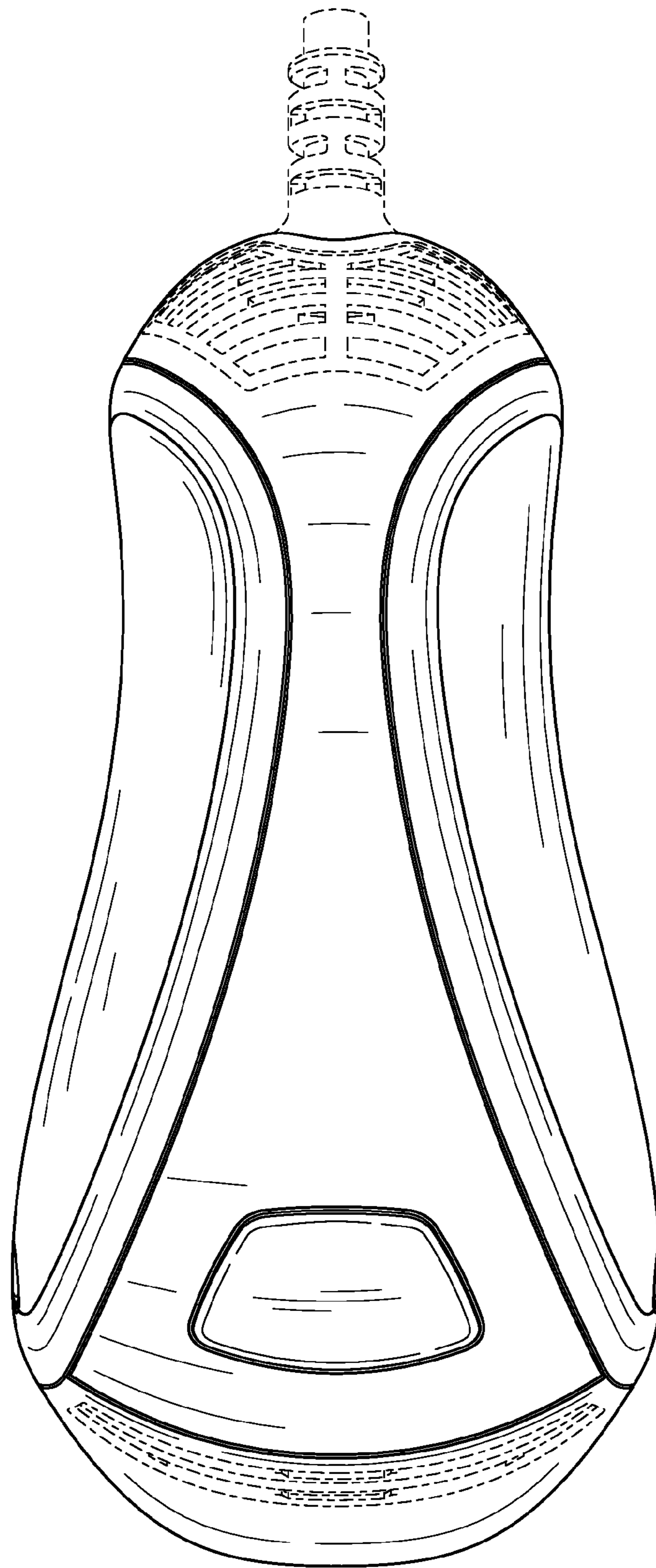

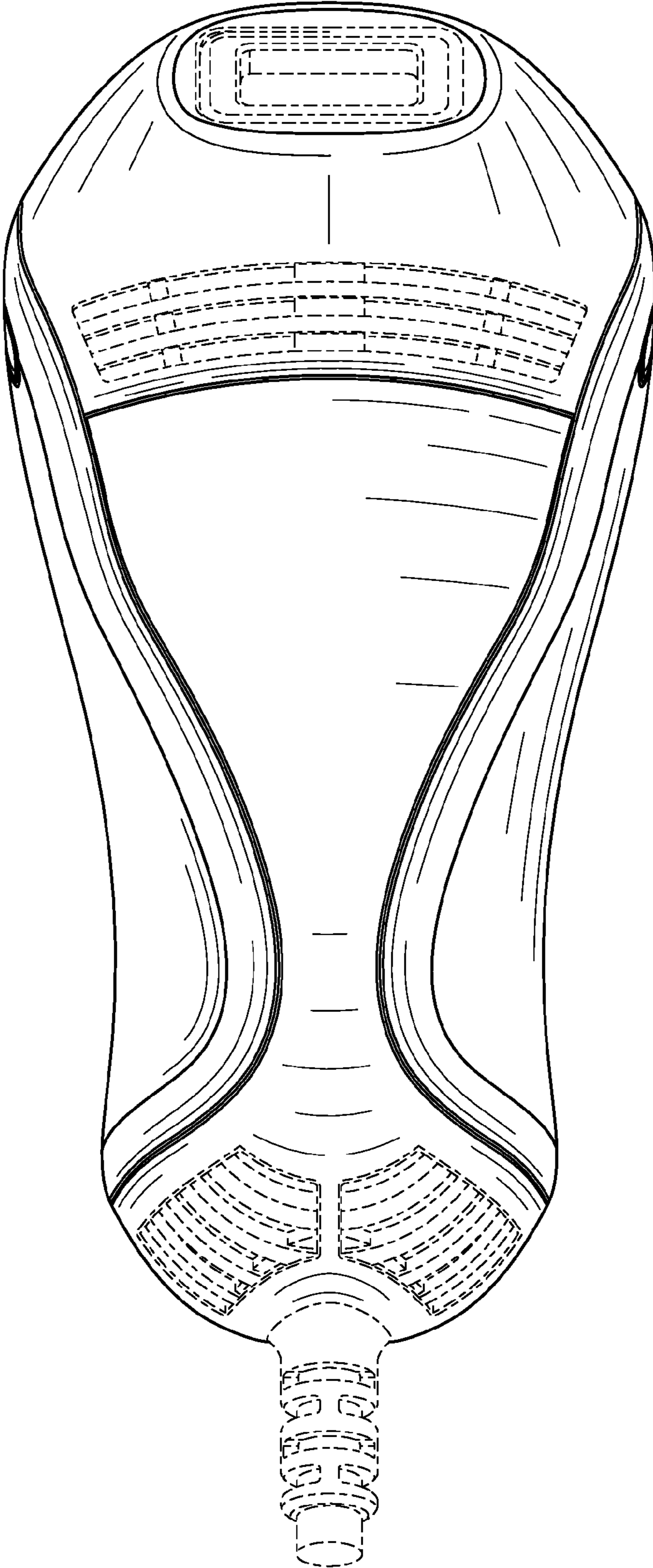
