(57) **CLAIM**

The ornamental design for a miniature steamer, as shown and described.

**DESCRIPTION**

FIG. 1 is a left-side perspective view of a miniature steamer showing my new design;

FIG. 2 is a front elevational view thereof;

FIG. 4 is a rear elevational view thereof;

FIG. 5 is a left side elevational view thereof;

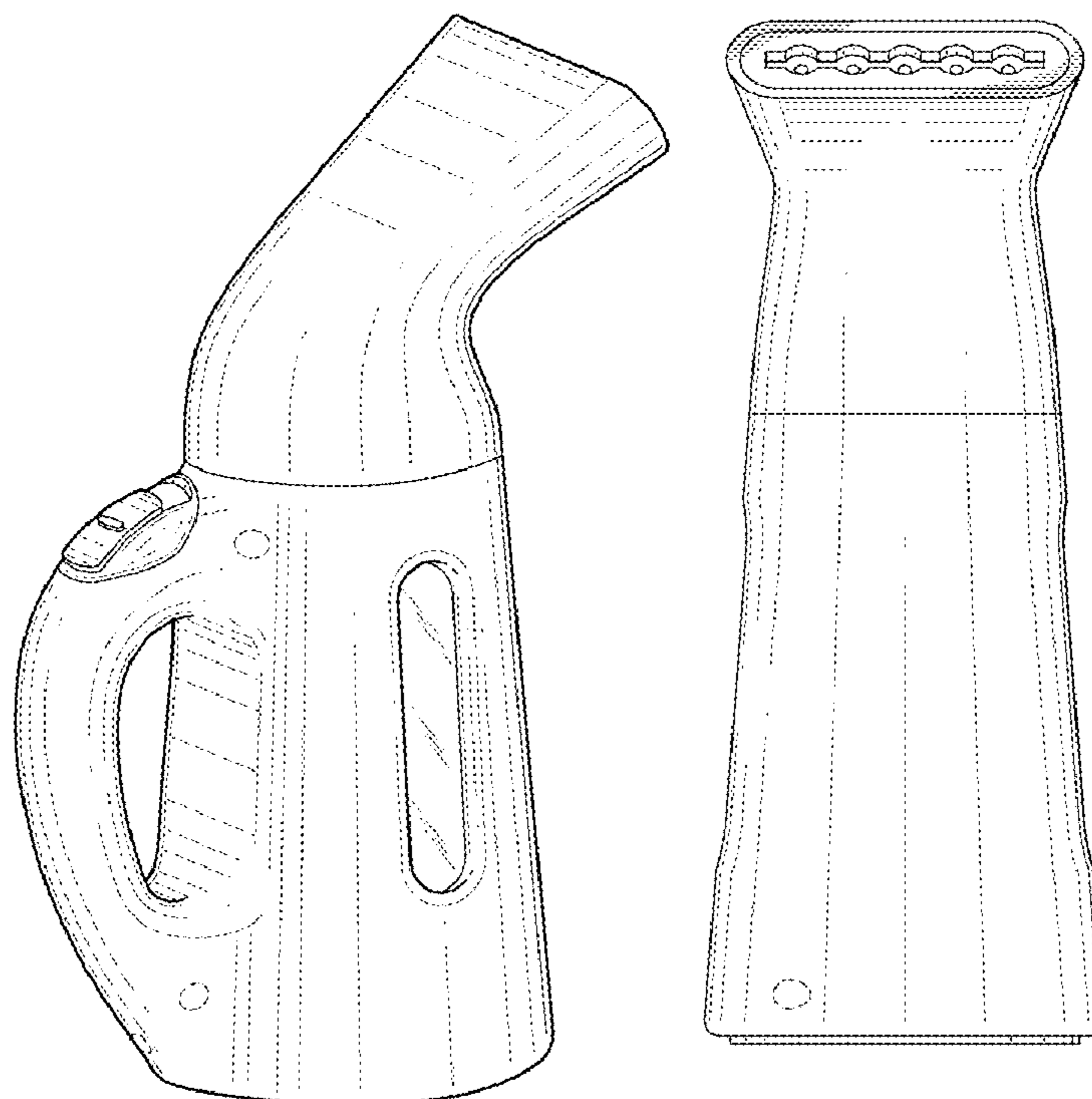

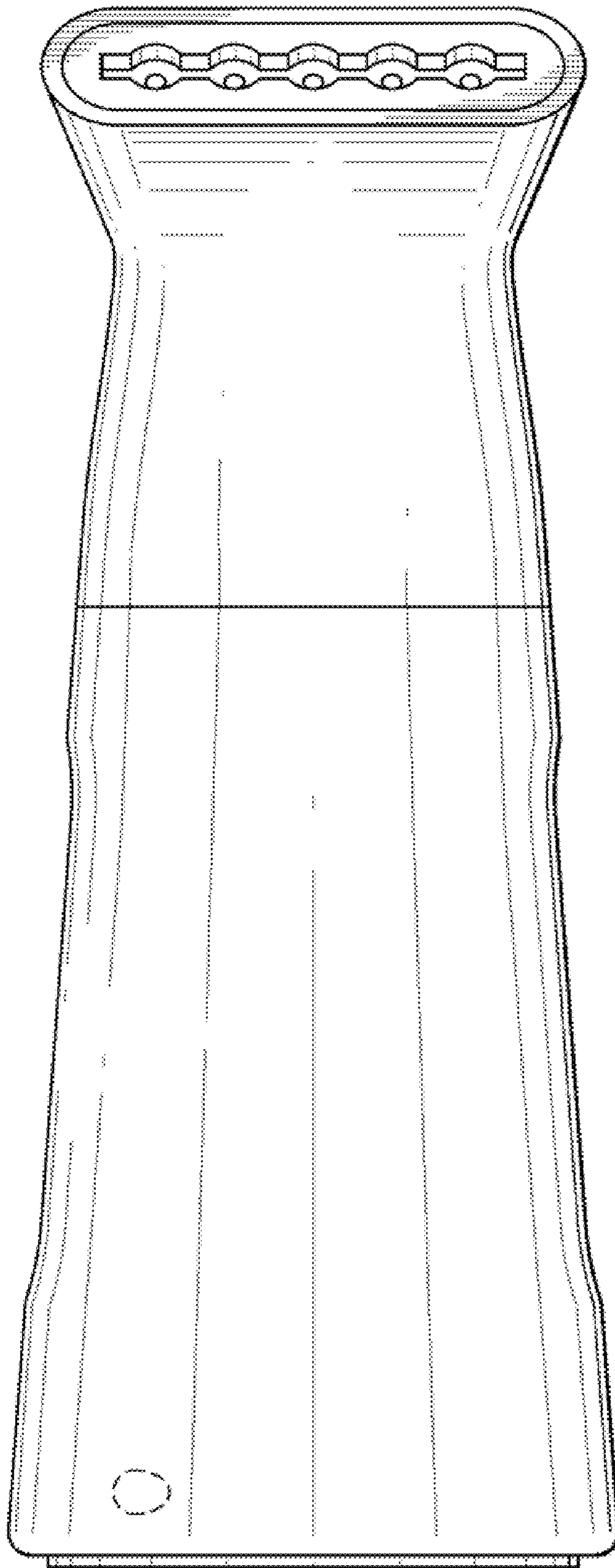

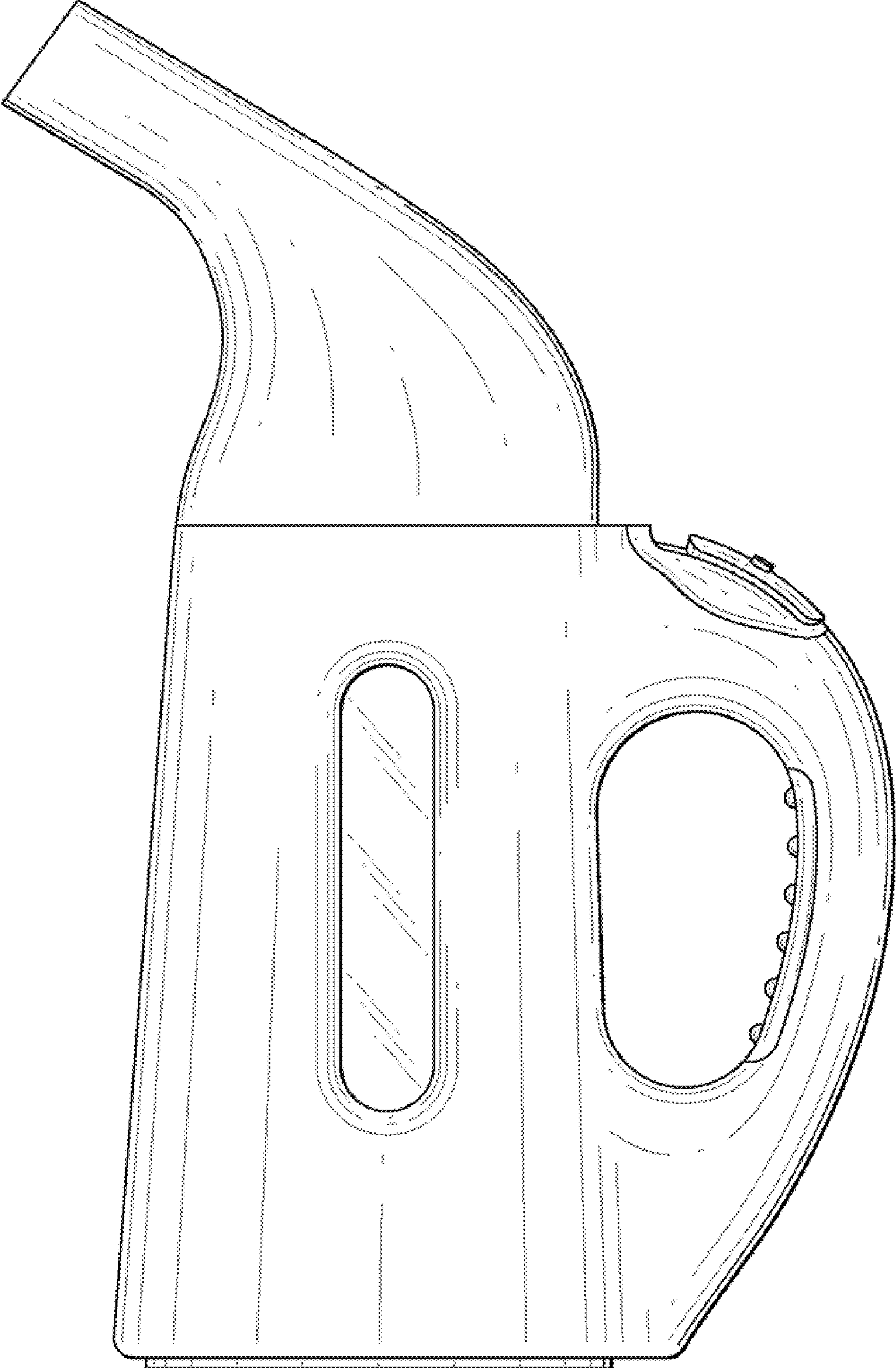

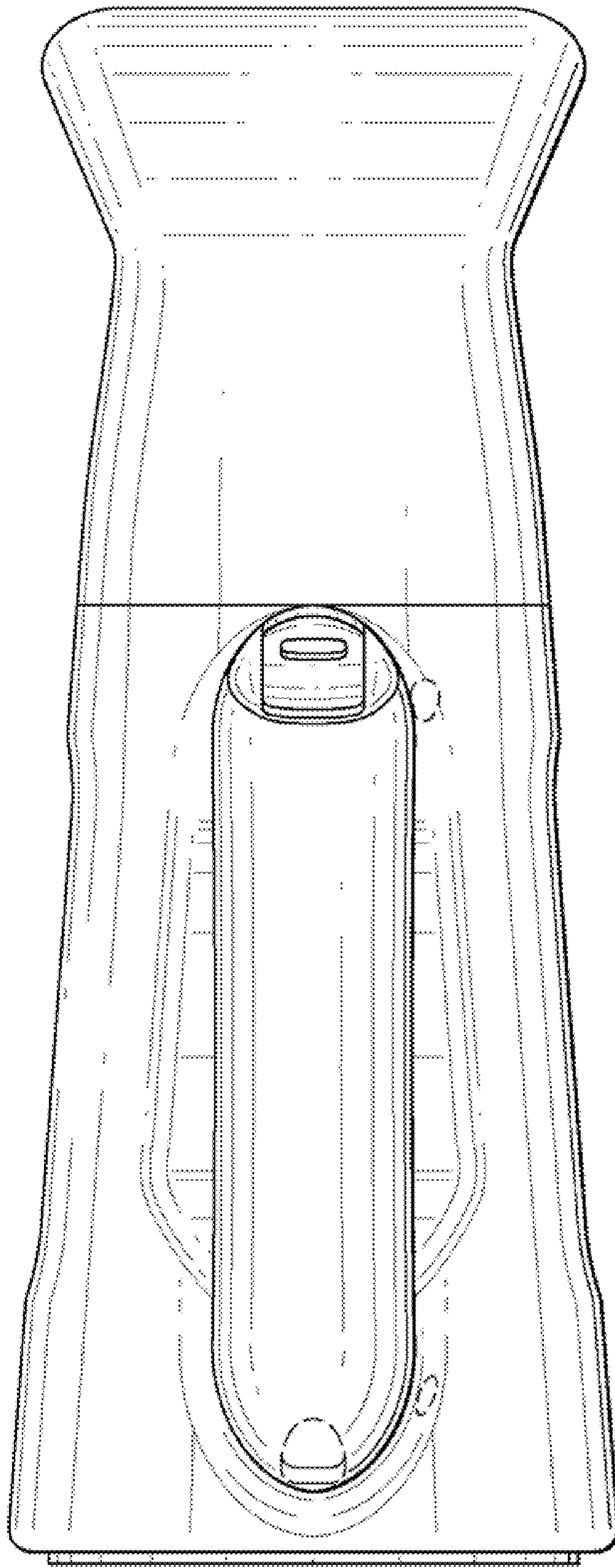

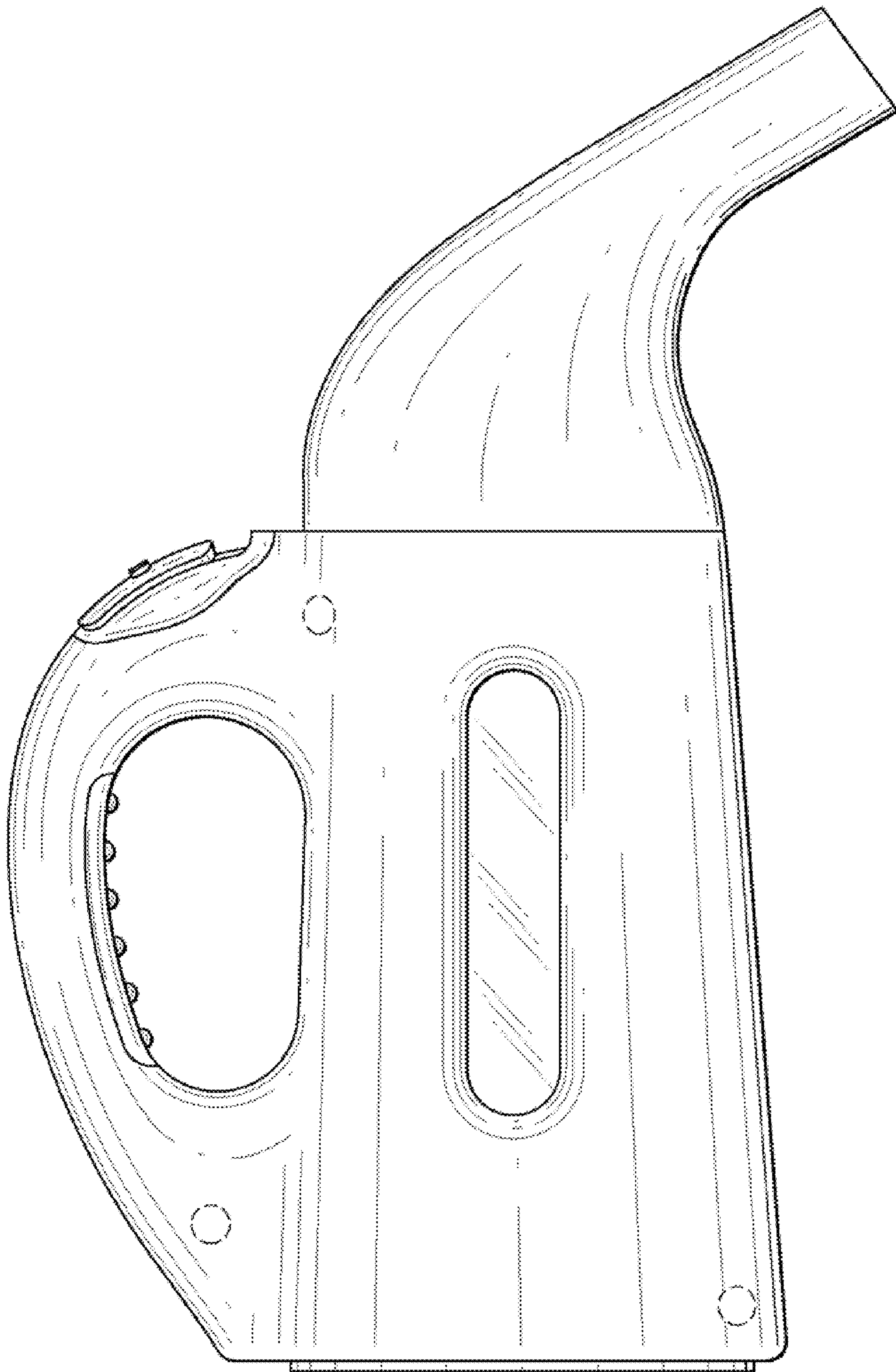

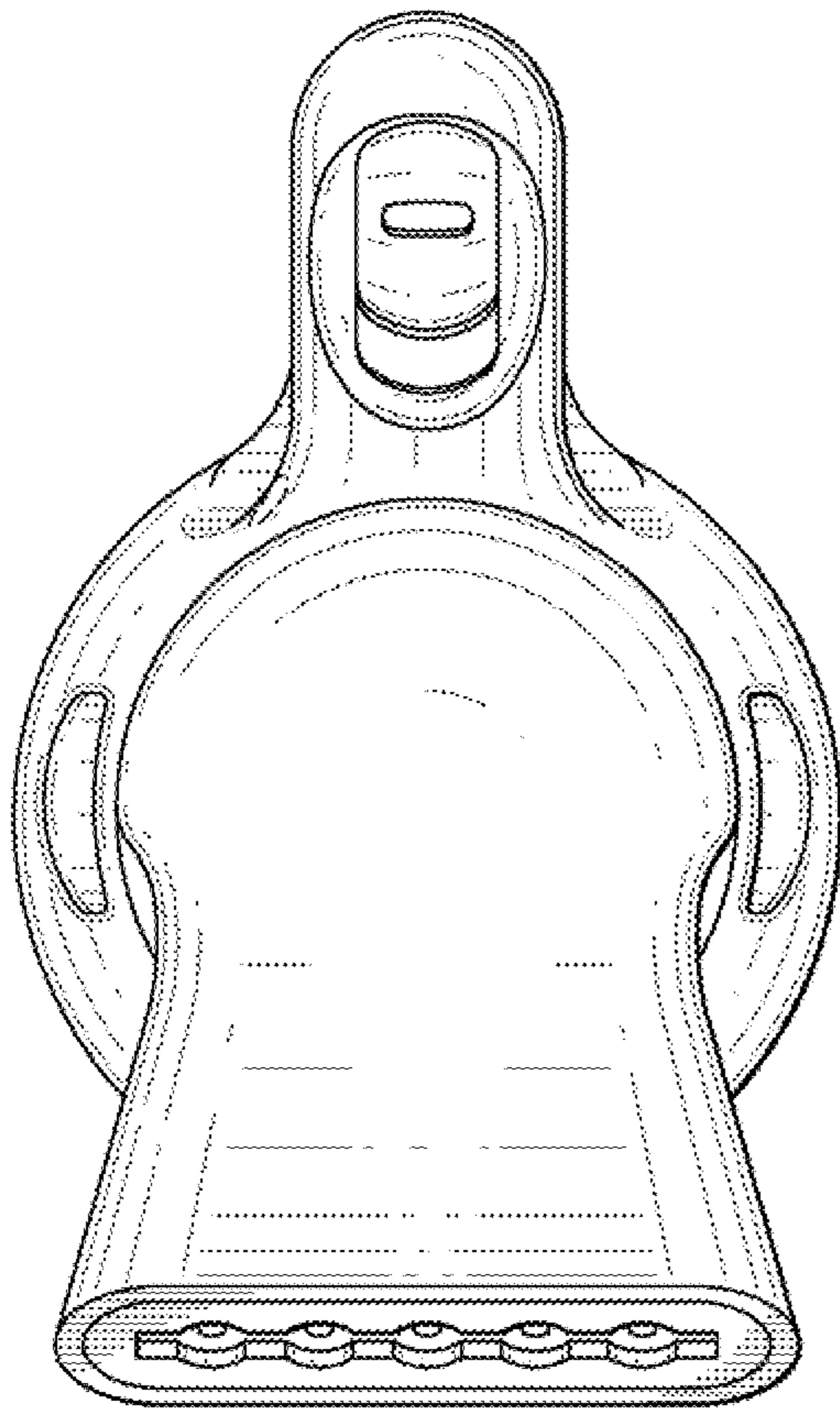

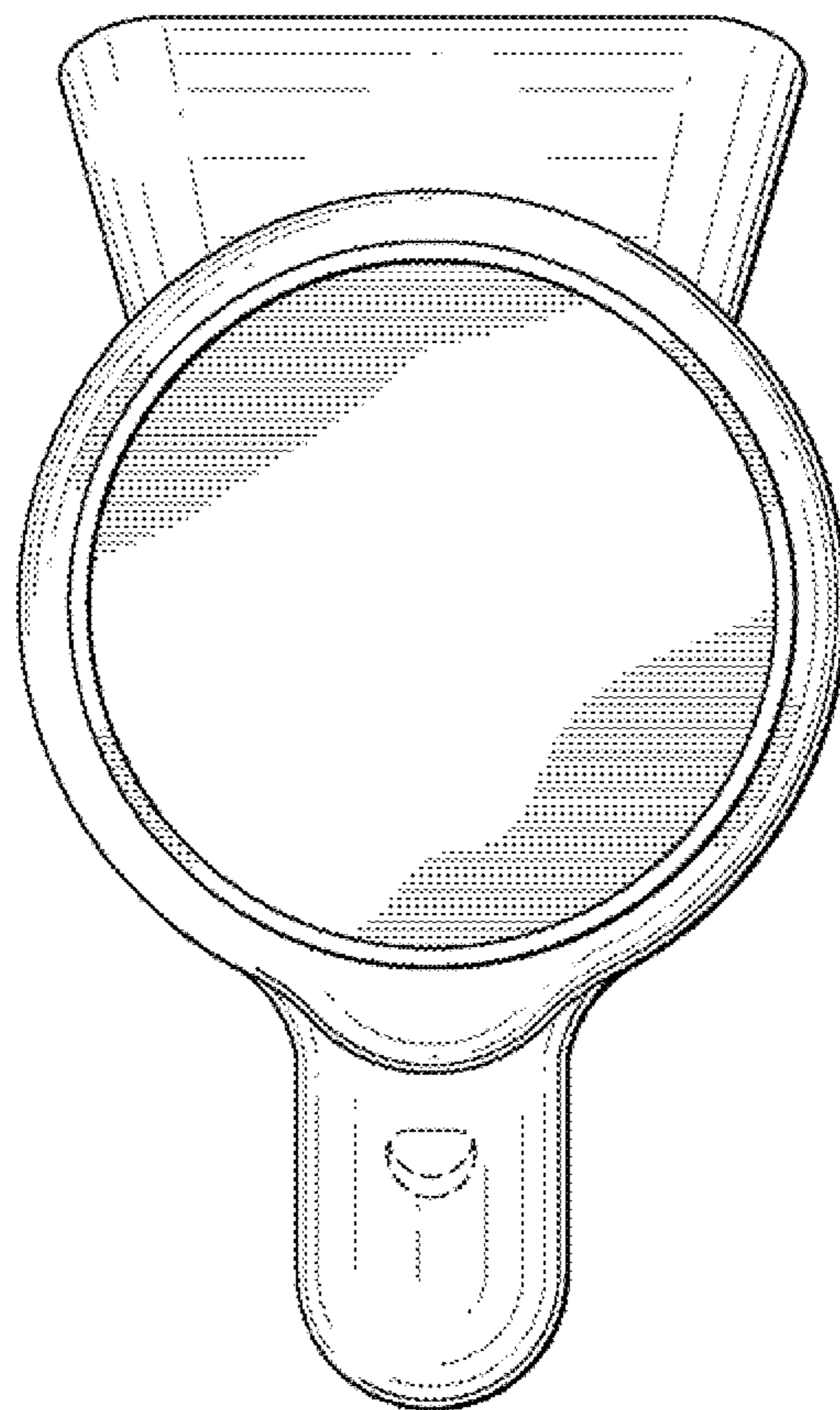
