(57) **CLAIM**

The ornamental design for an expandable protective sports spat for cleated or spiked sports shoe, as shown and described.

**DESCRIPTION**

FIG. 1 is a top view of an expandable protective spat for cleated or spiked sports shoe showing our new design functionally associated with a cleated or spiked sports shoe;

FIG. 2 is a bottom view thereof;

FIG. 3 is a front elevational view thereof;

FIG. 4 is a rear elevational view thereof wherein an expandable portion is stretched;

FIG. 5 is another rear elevational view thereof wherein an expandable portion thereof is less stretched; and,

FIG. 6 is a side elevational view thereof.

The dashed lines showing a shoe inserted in the protective sports spat for cleated or spiked sports shoes in FIGS. 1-6 are for illustrative purposes only and form no part of the claimed design.

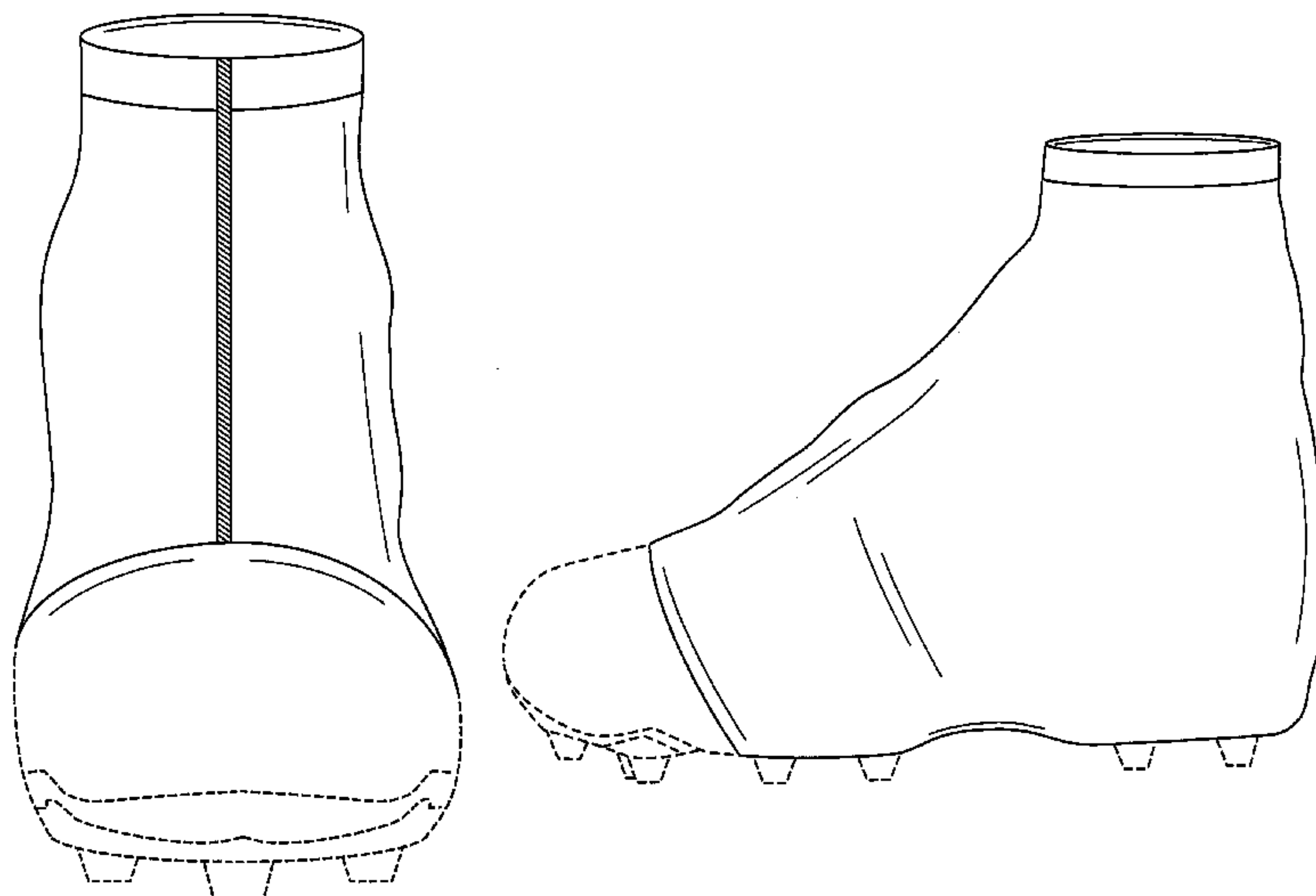
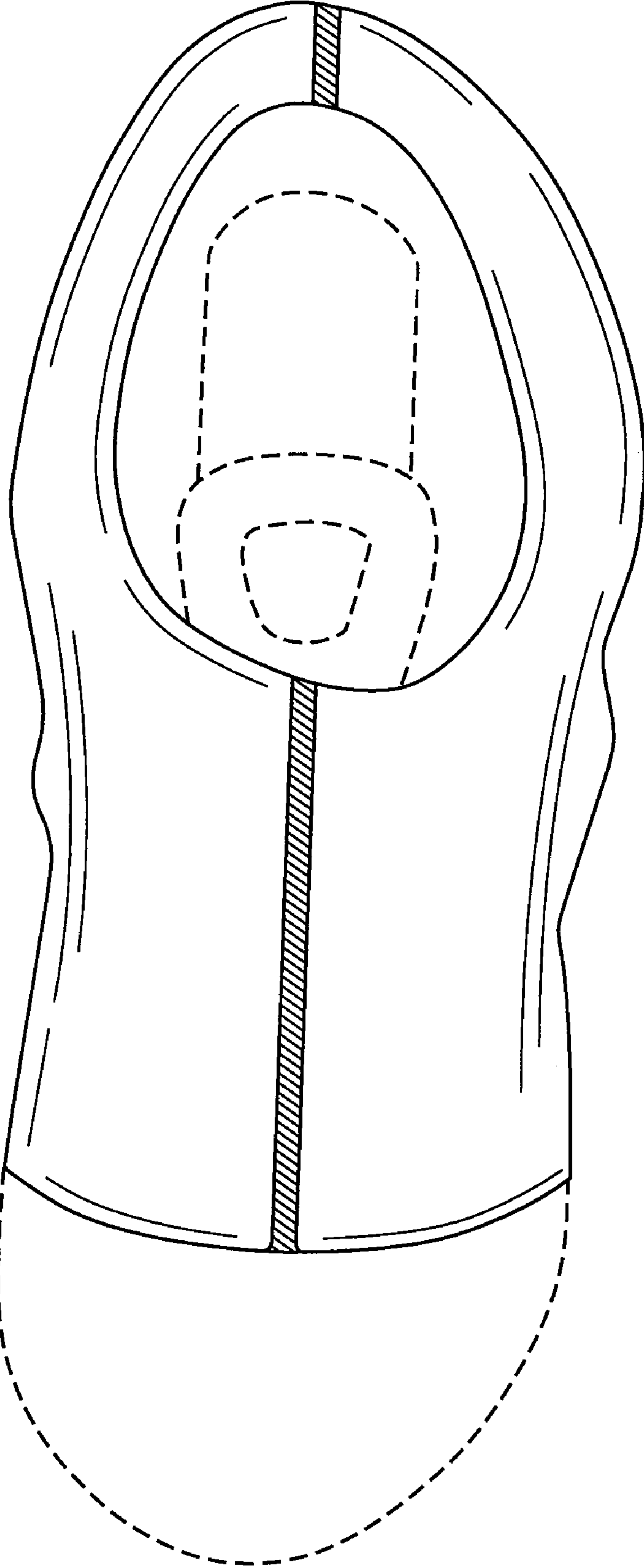

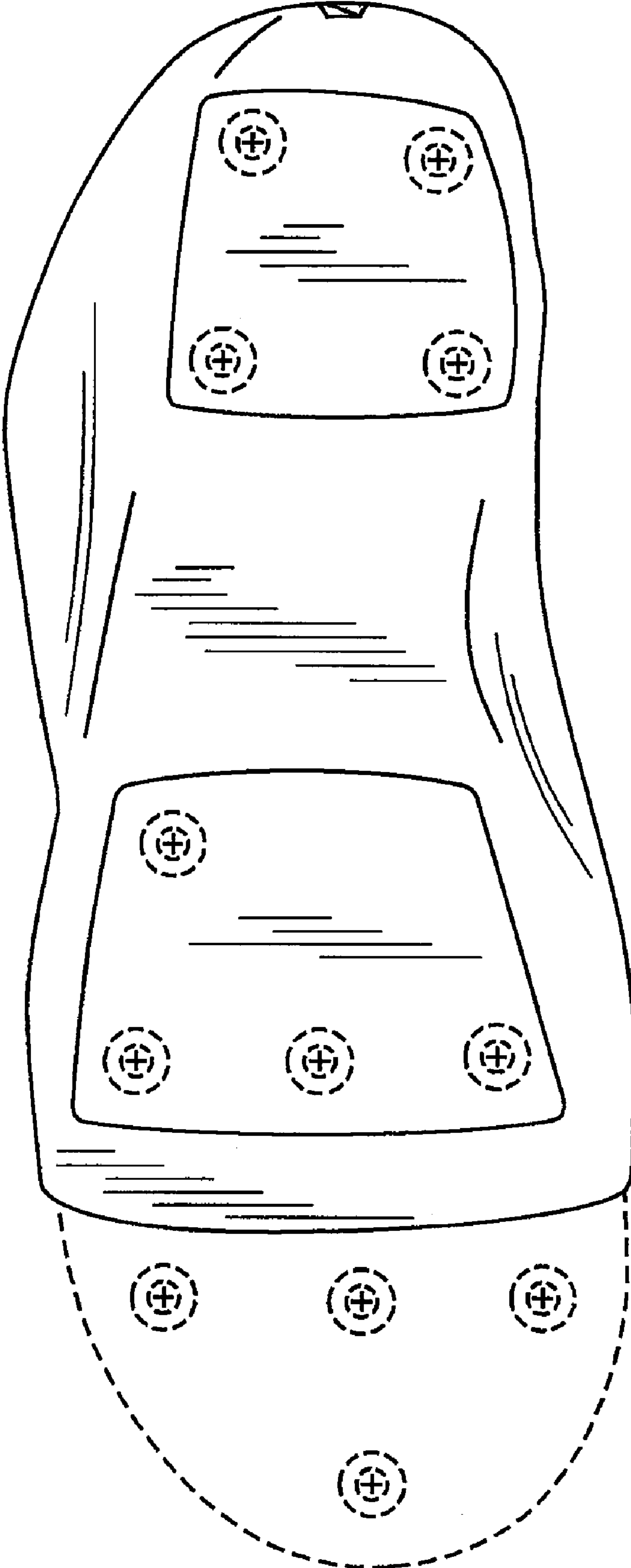

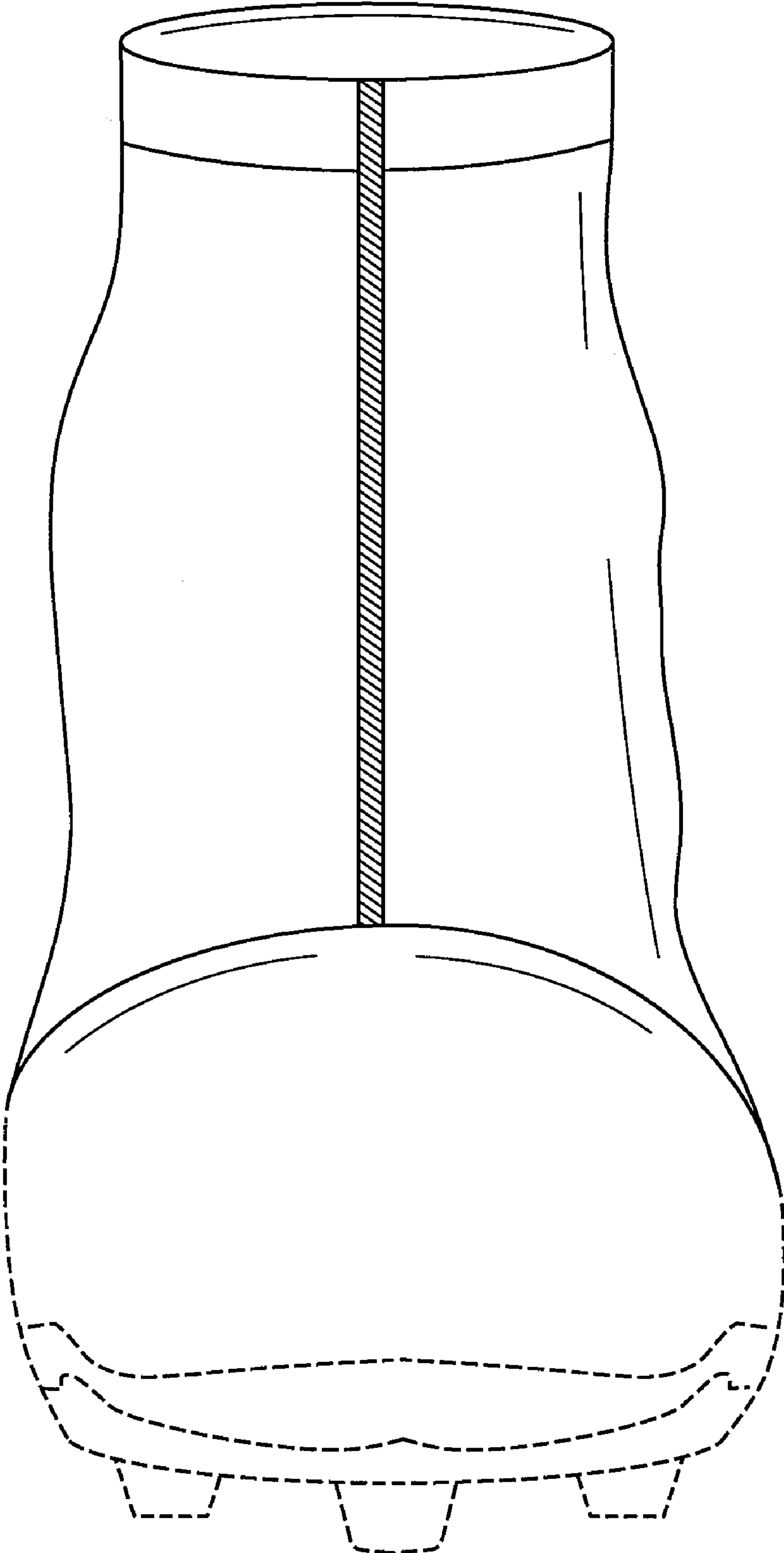

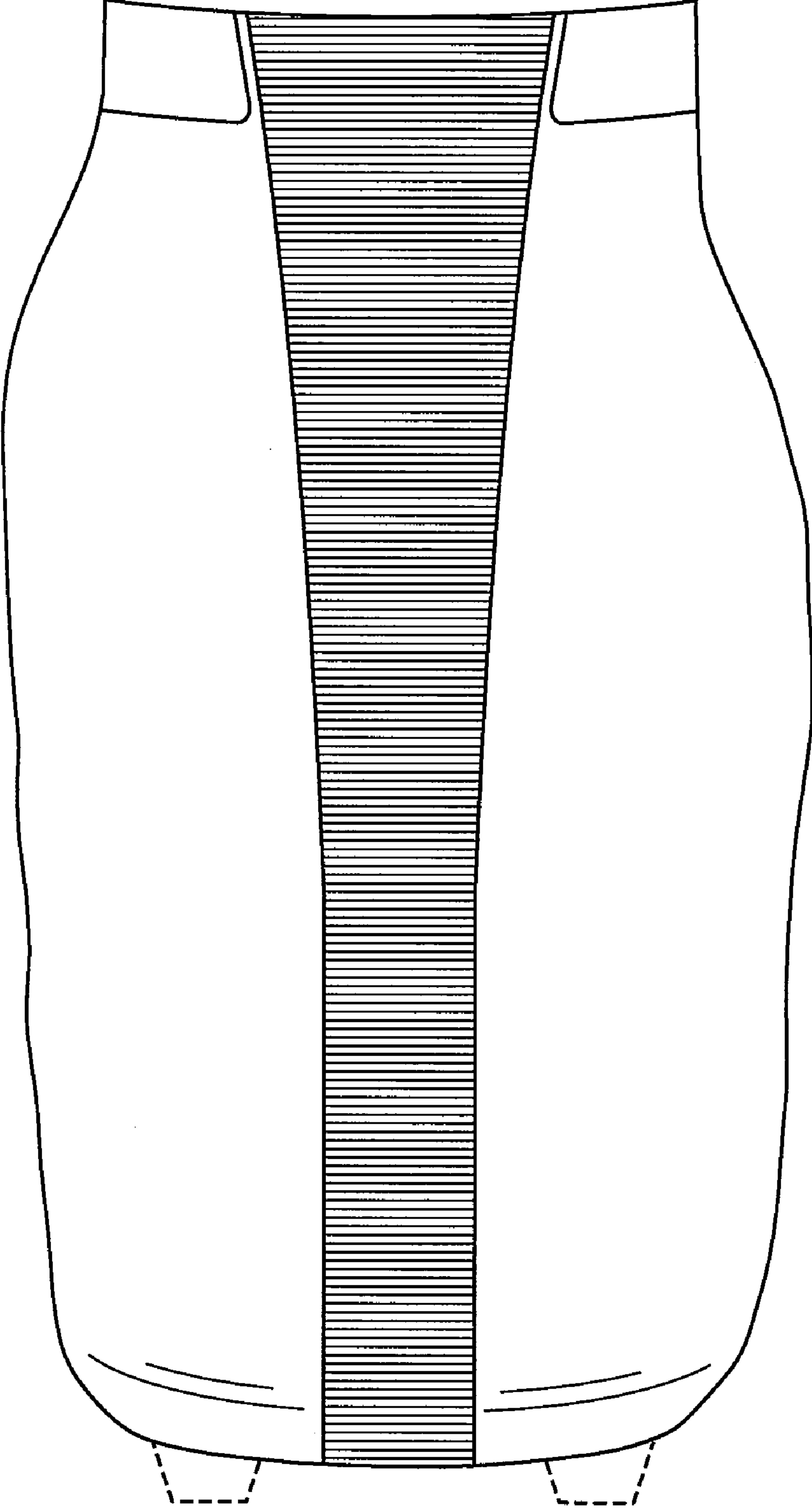
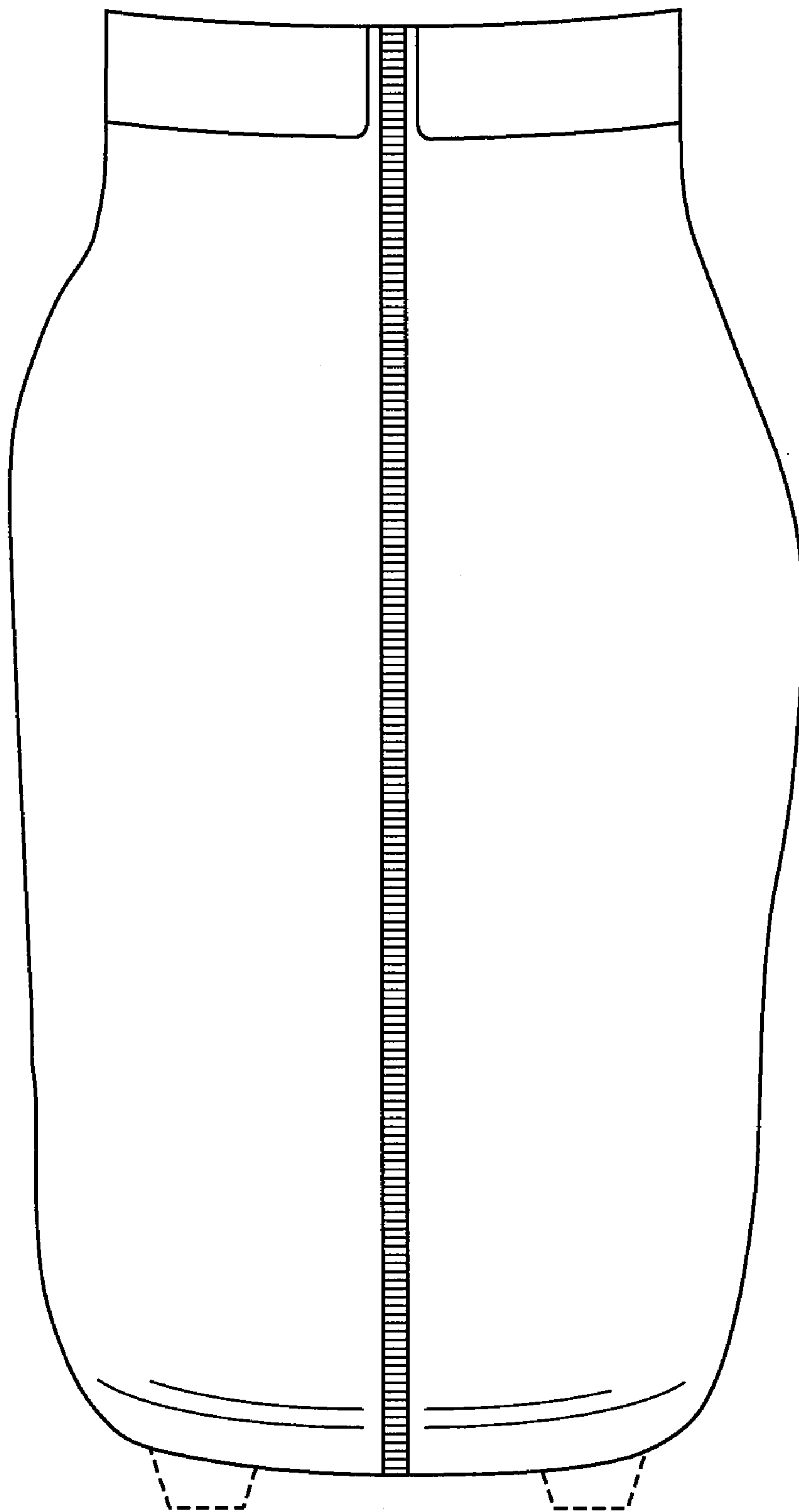

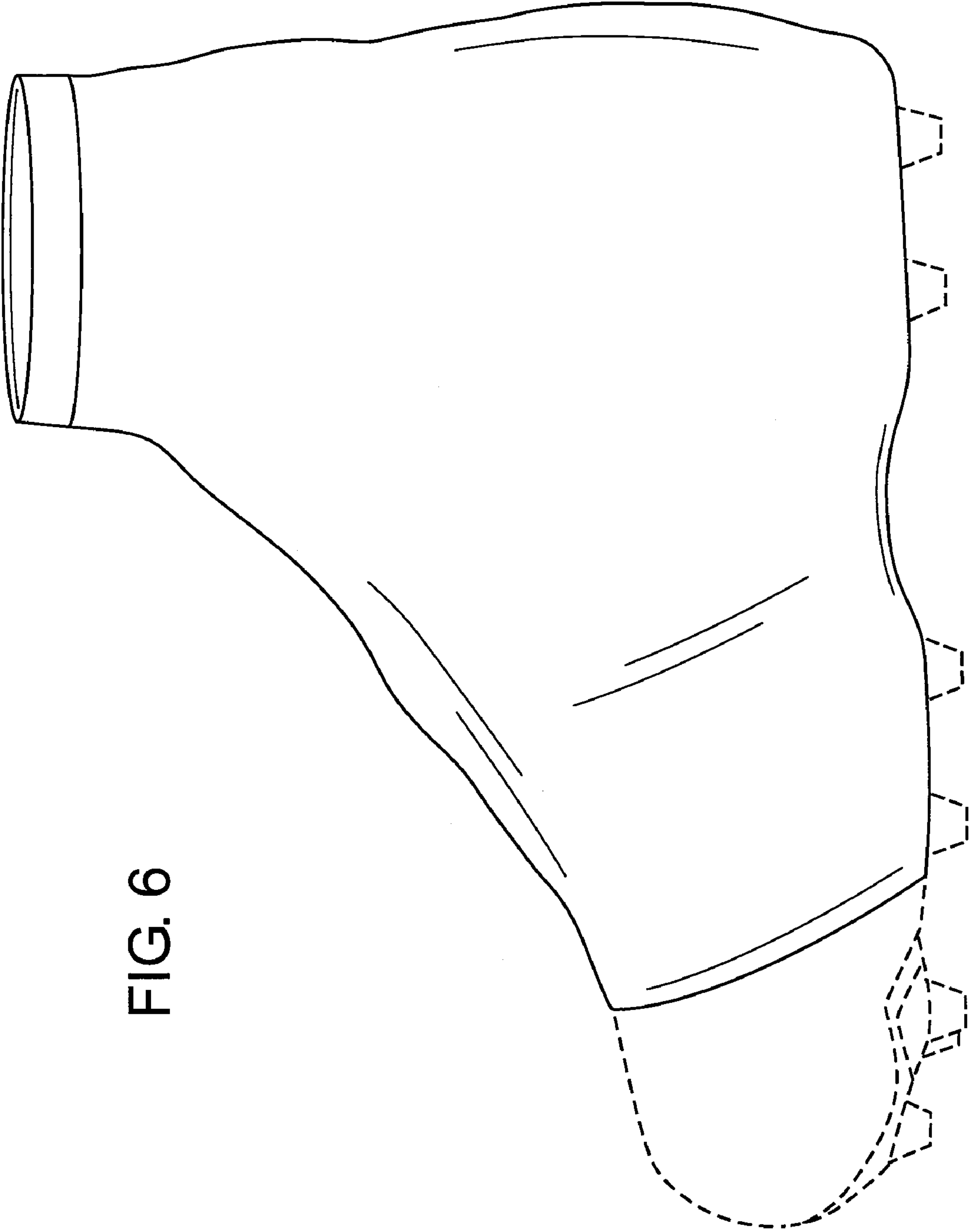
