**DESCRIPTION**

FIG. 1 is a lateral perspective view of a shoe showing my new design;

FIG. 2 is a lateral side elevational view thereof;

FIG. 3 is a medial side elevational view thereof;

FIG. 4 is a top plan view thereof;

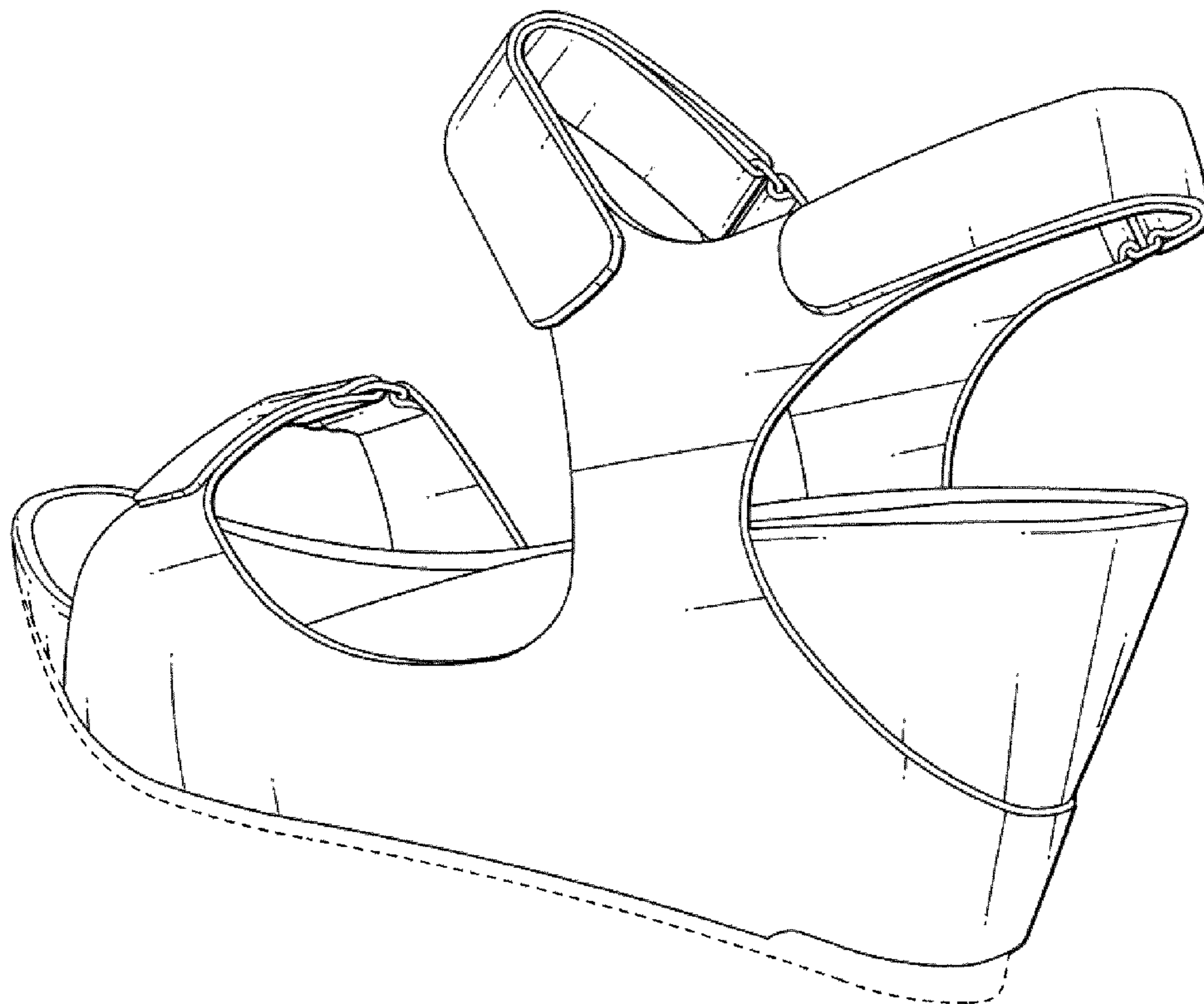
FIG. 5 is a front elevational view thereof.

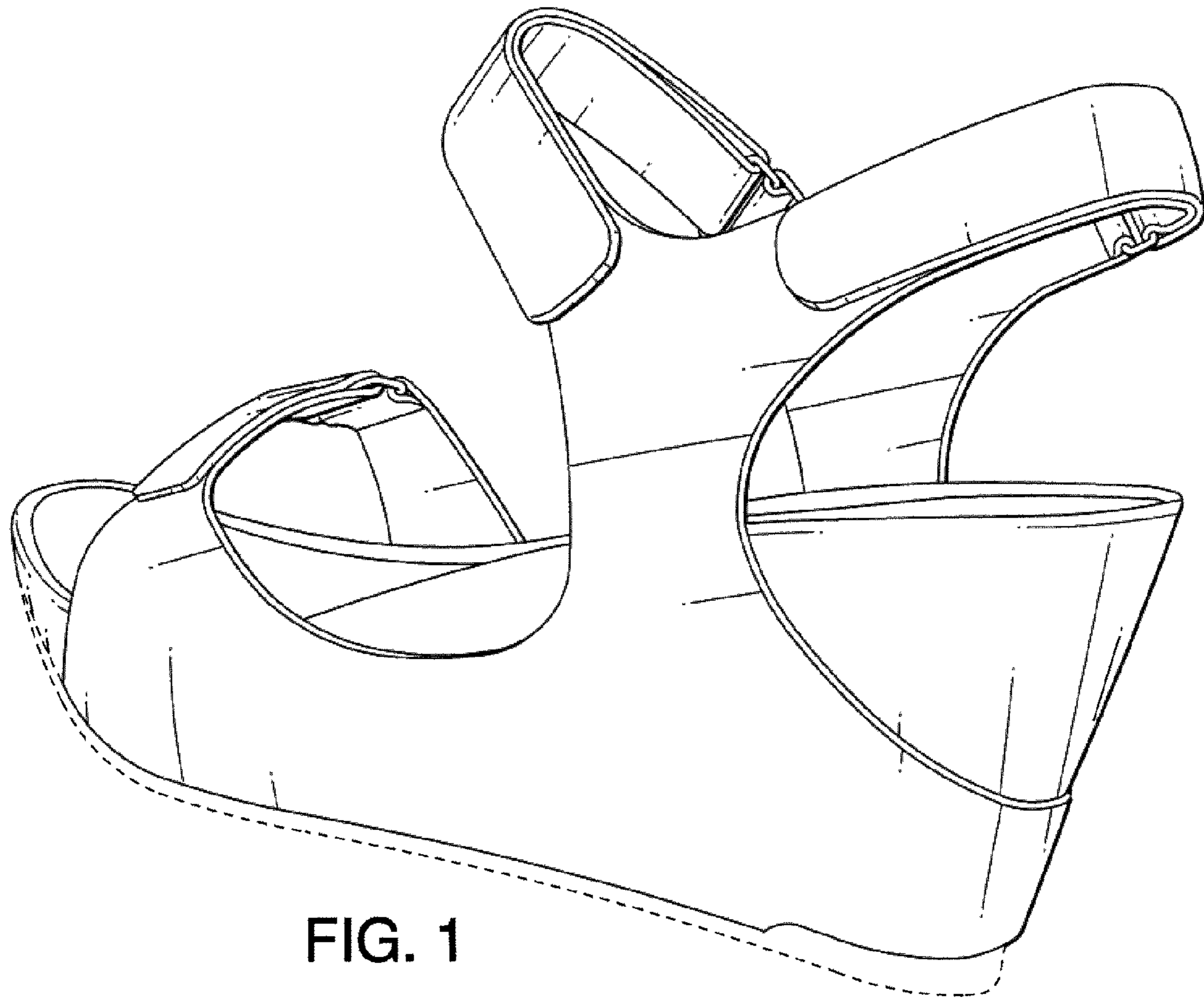

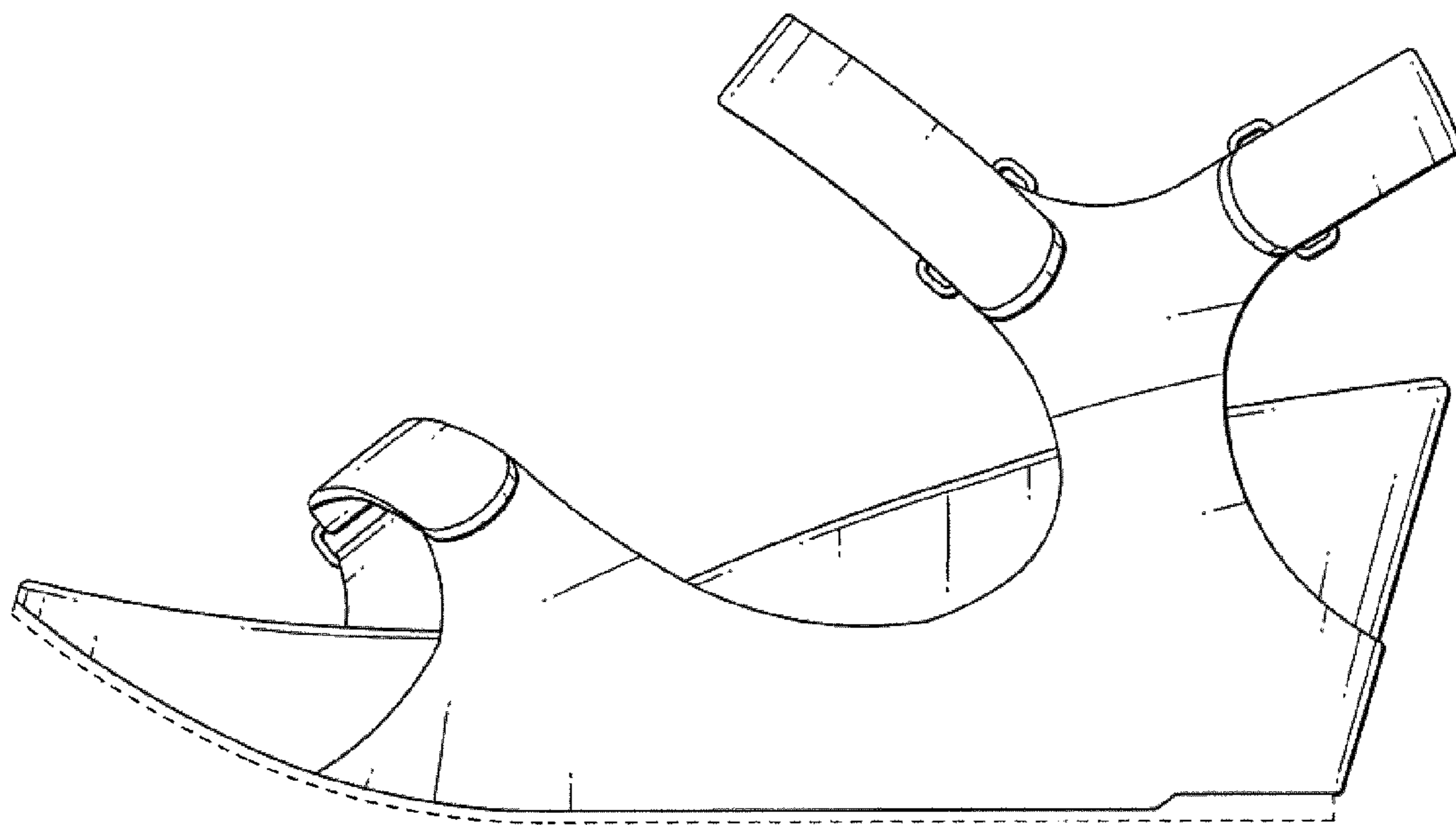

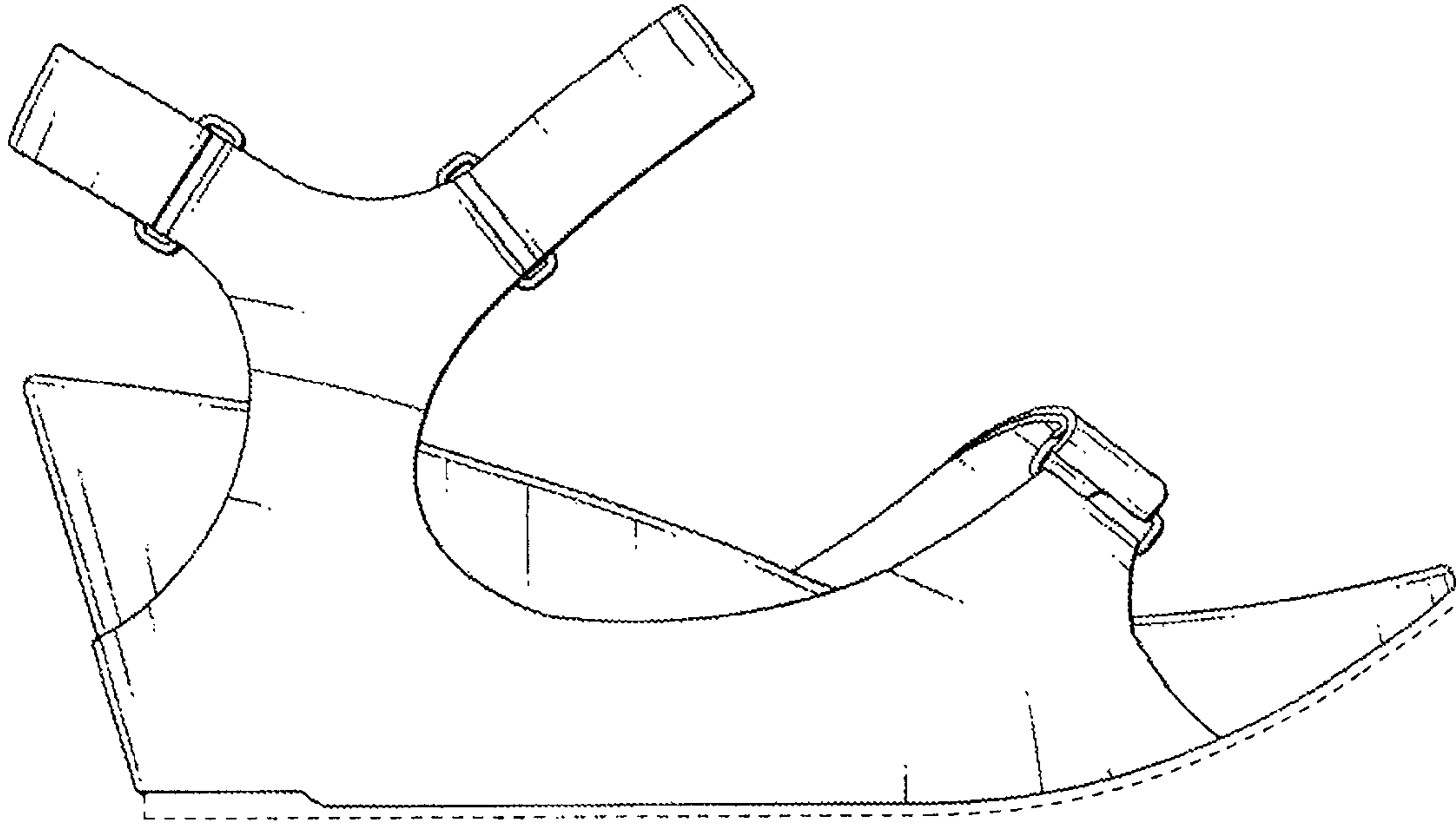

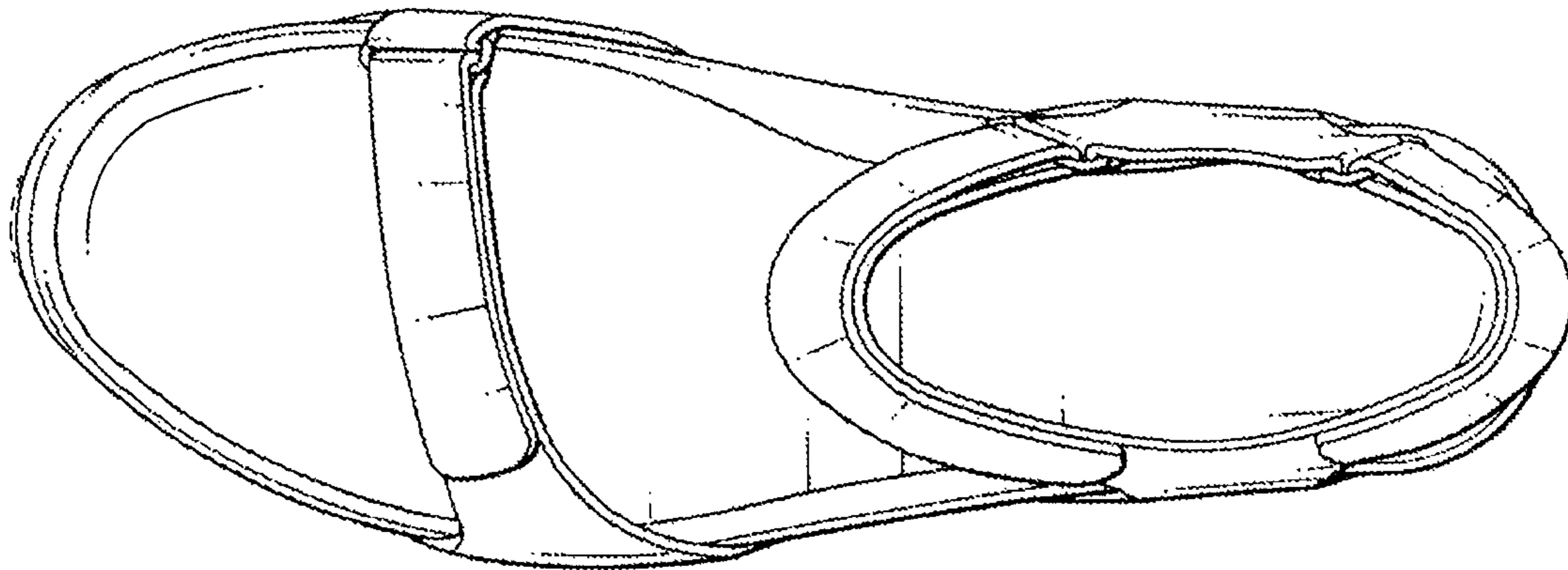

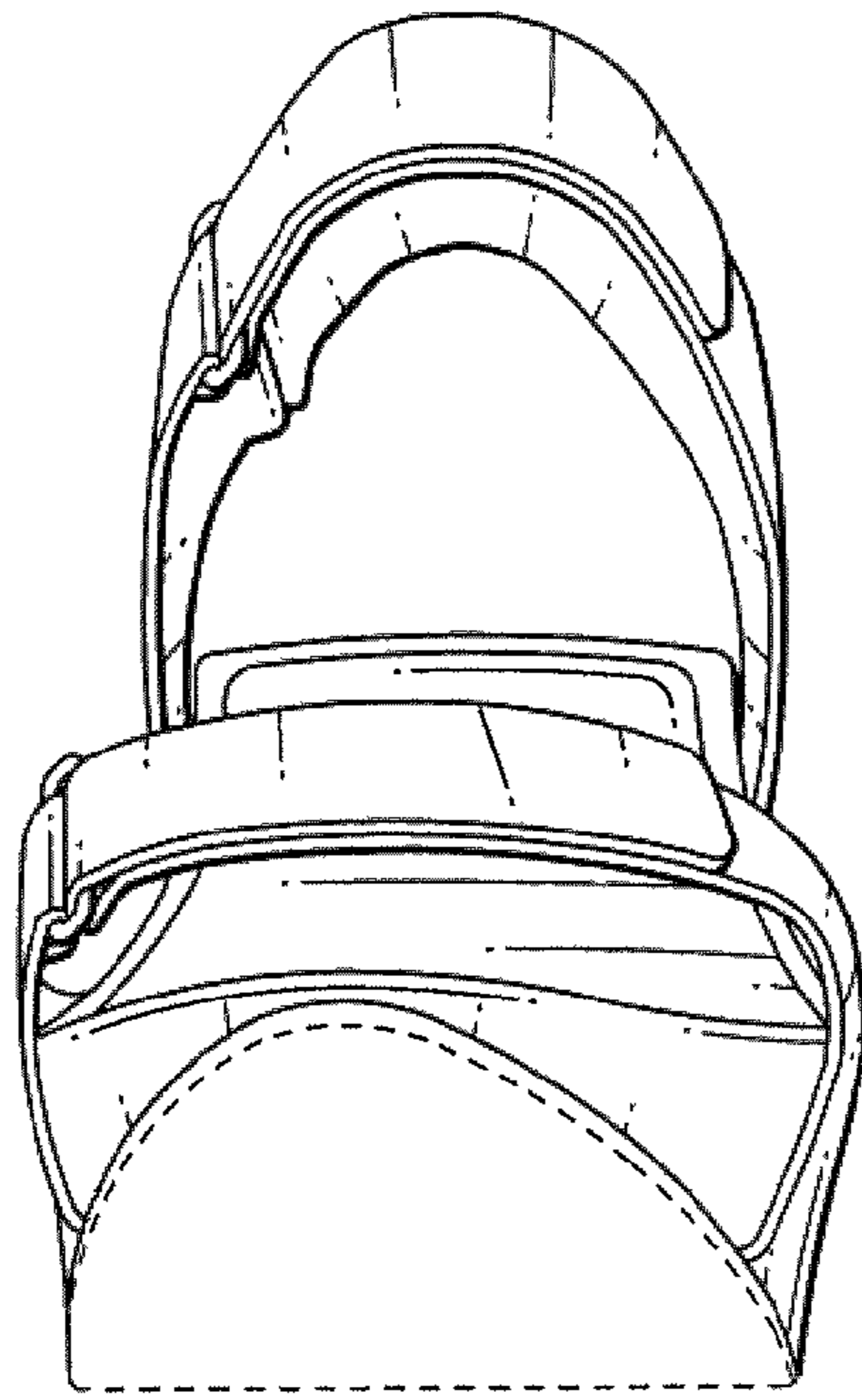

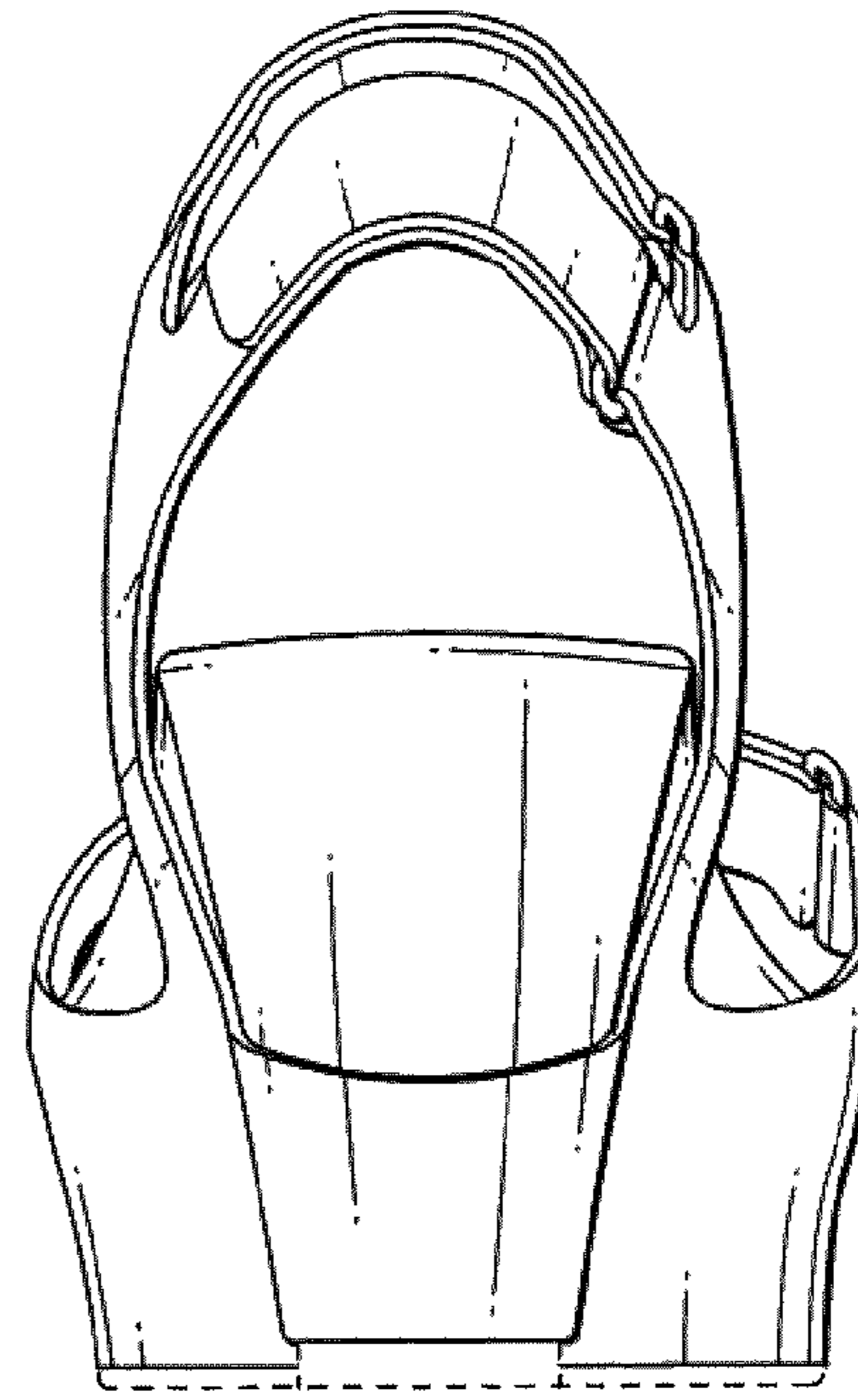

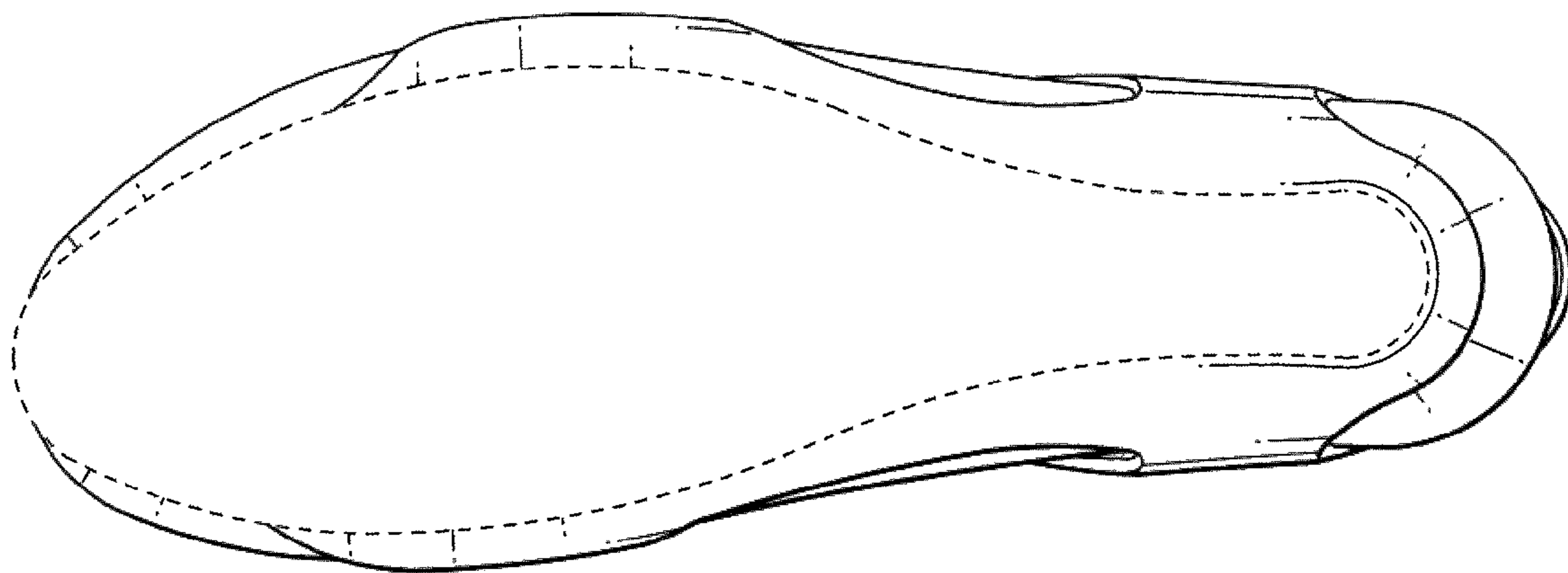
