DESCRIPTION

FIG. 1 is a front, right top perspective view showing the shoe sole of my new design;

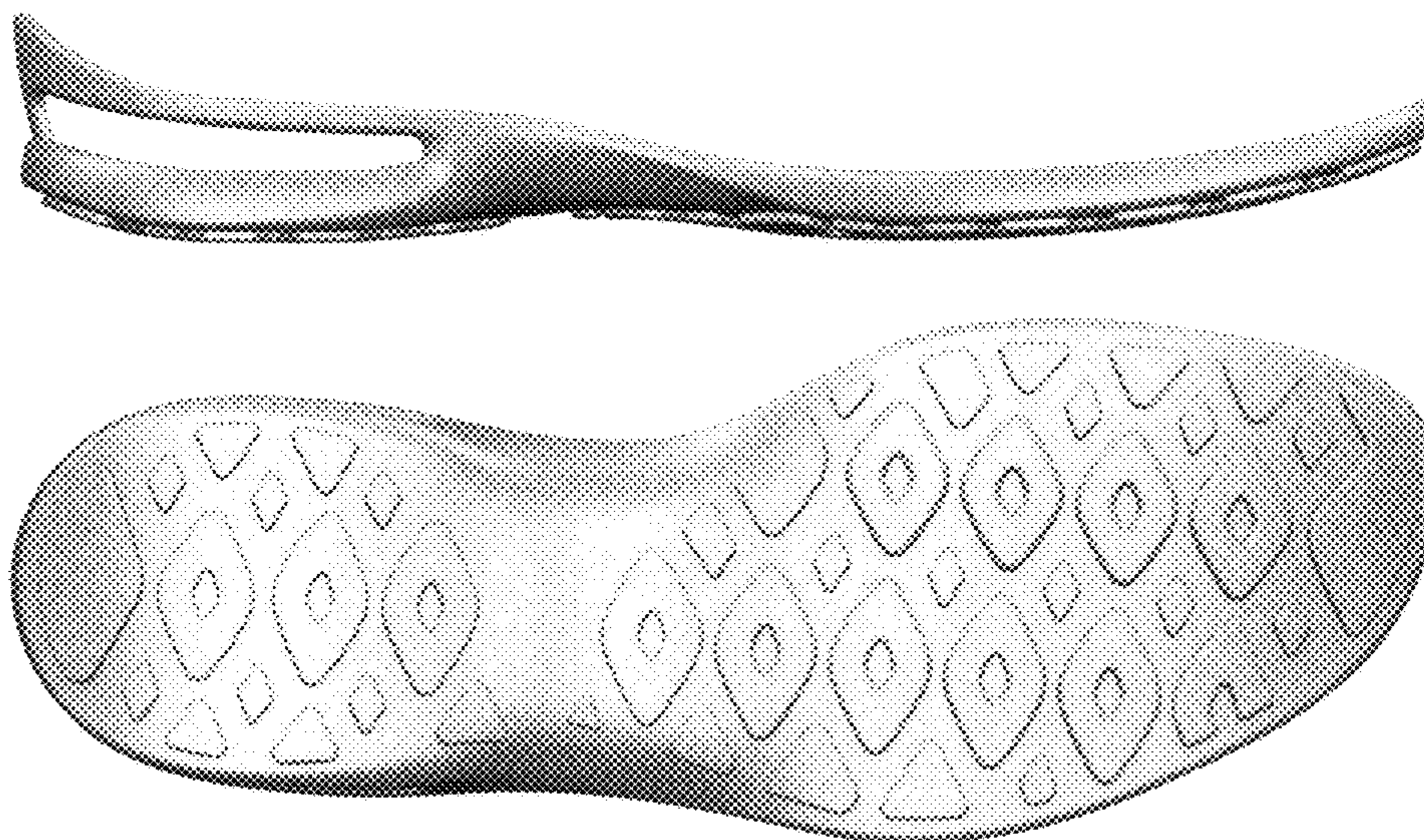

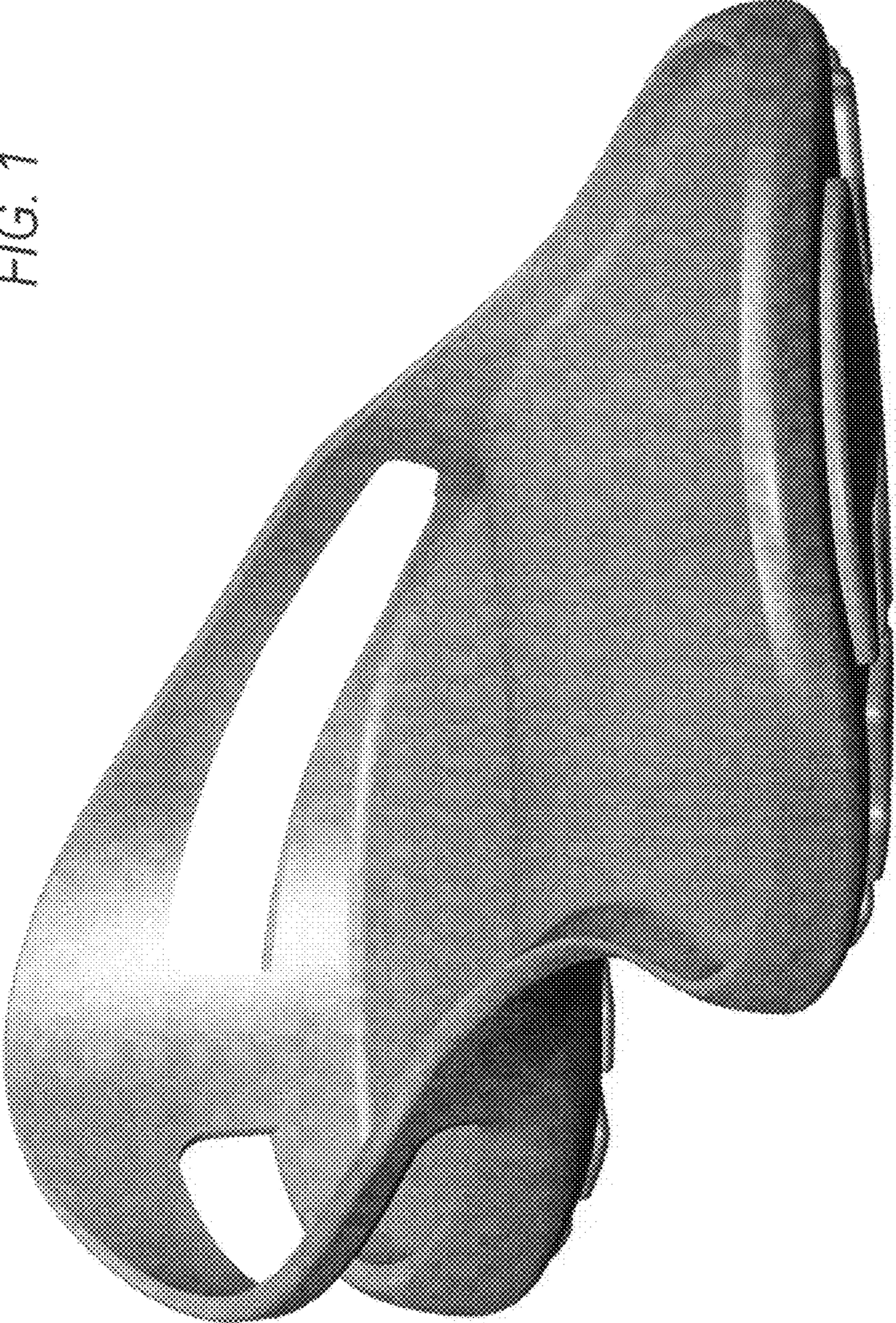

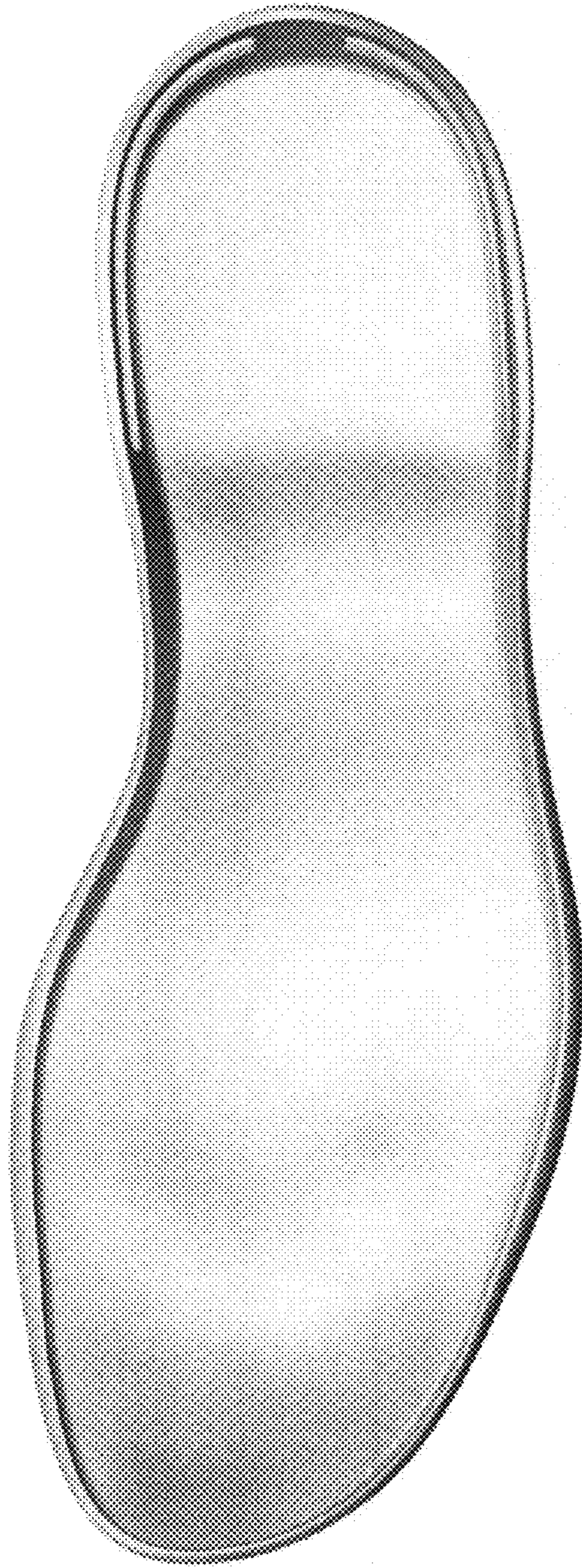

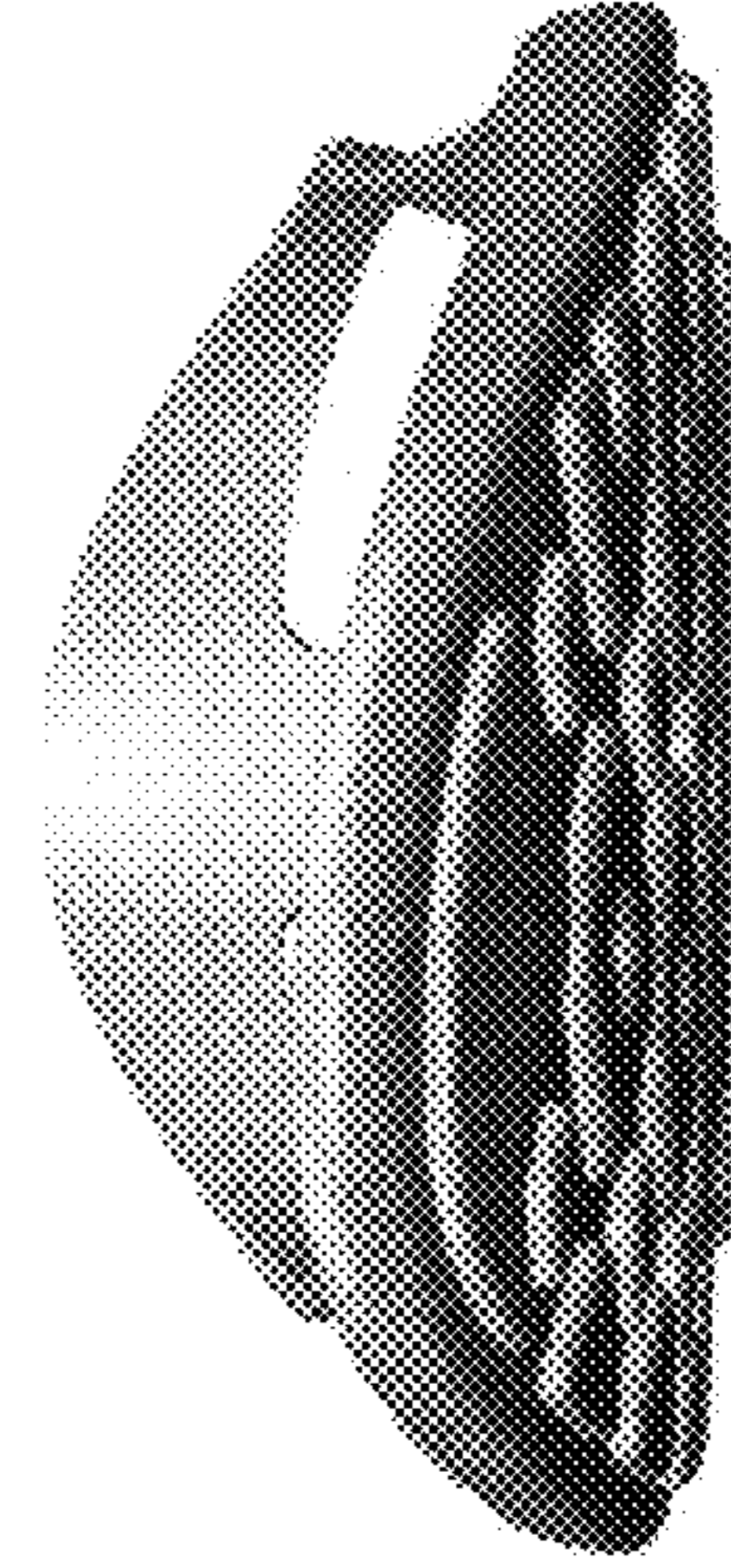

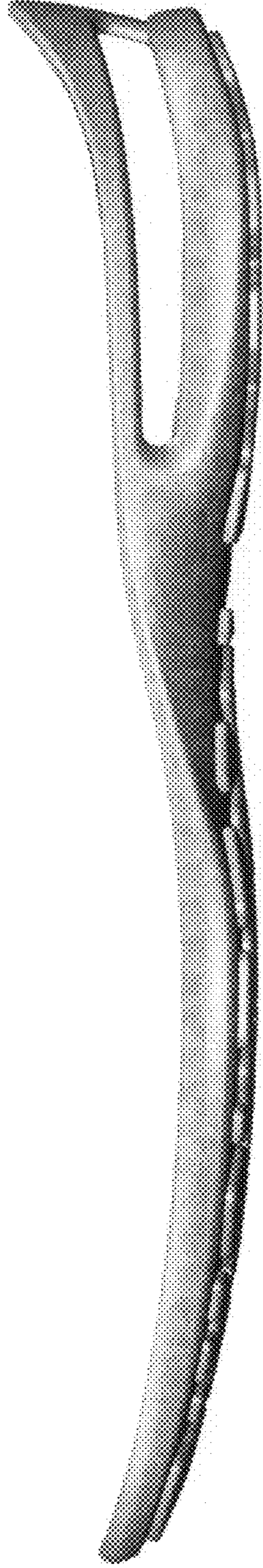

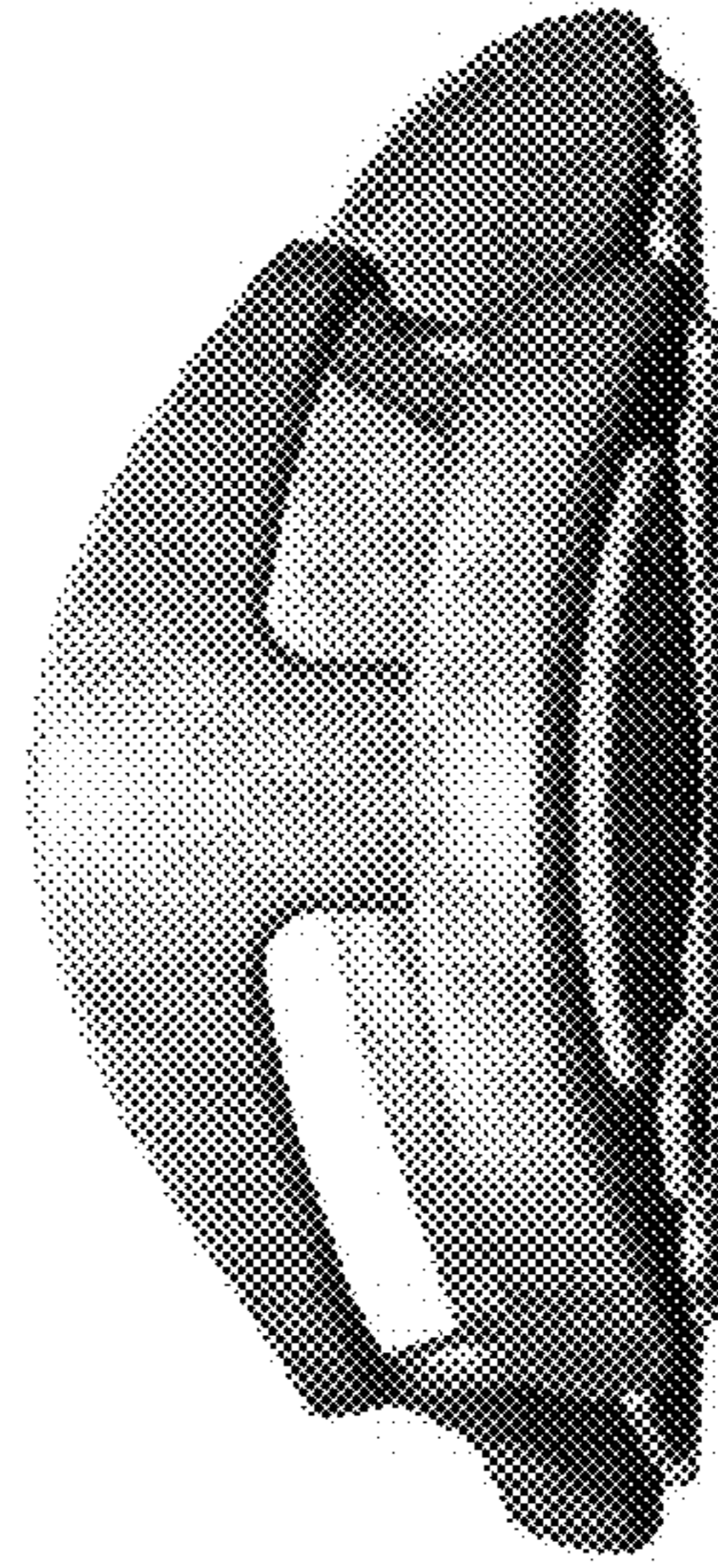

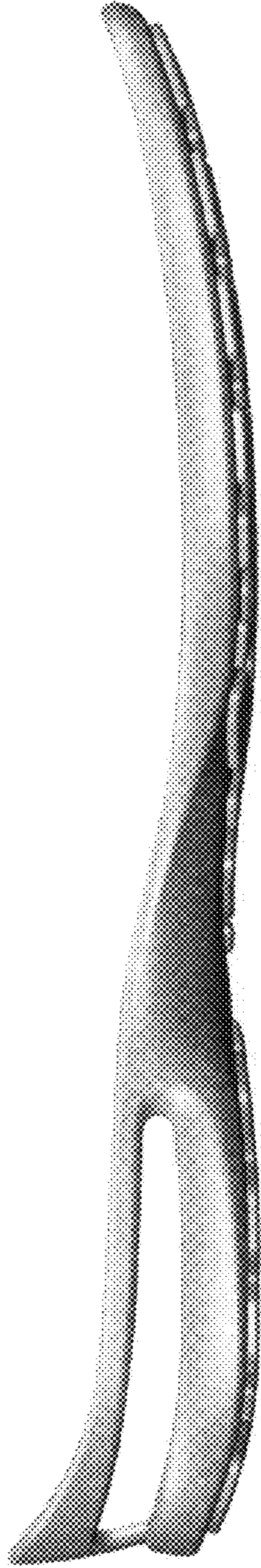
