FIG. 4 is a rear elevation thereof;

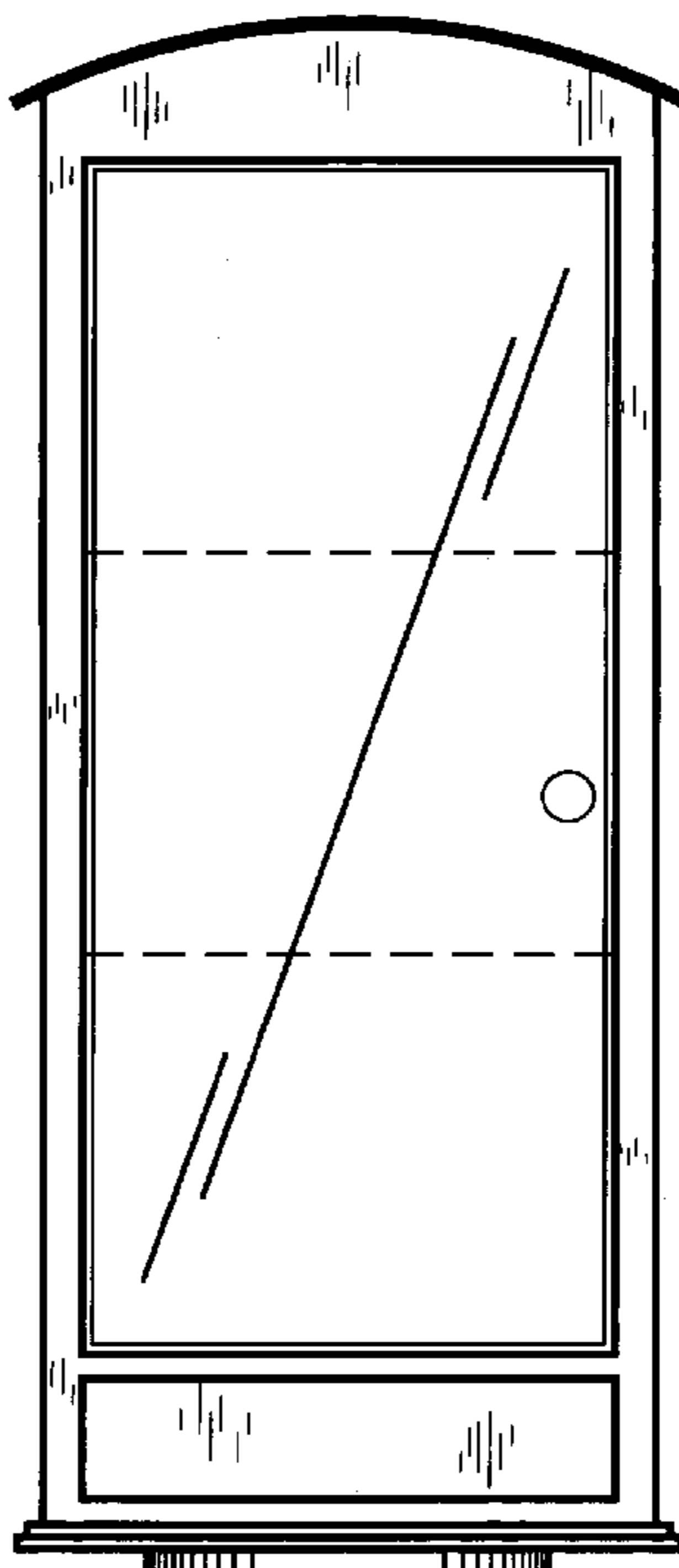
FIG. 5 is a front and right side perspective view thereof;

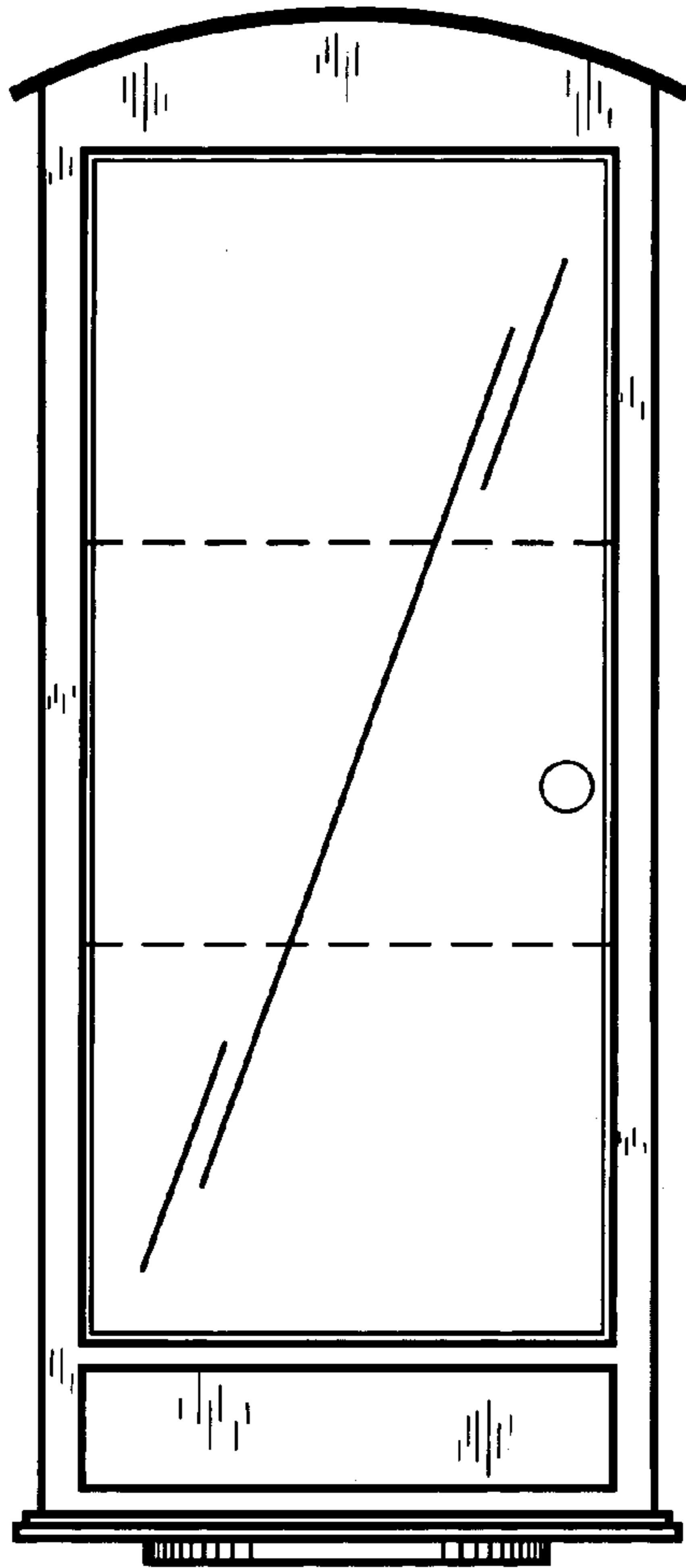

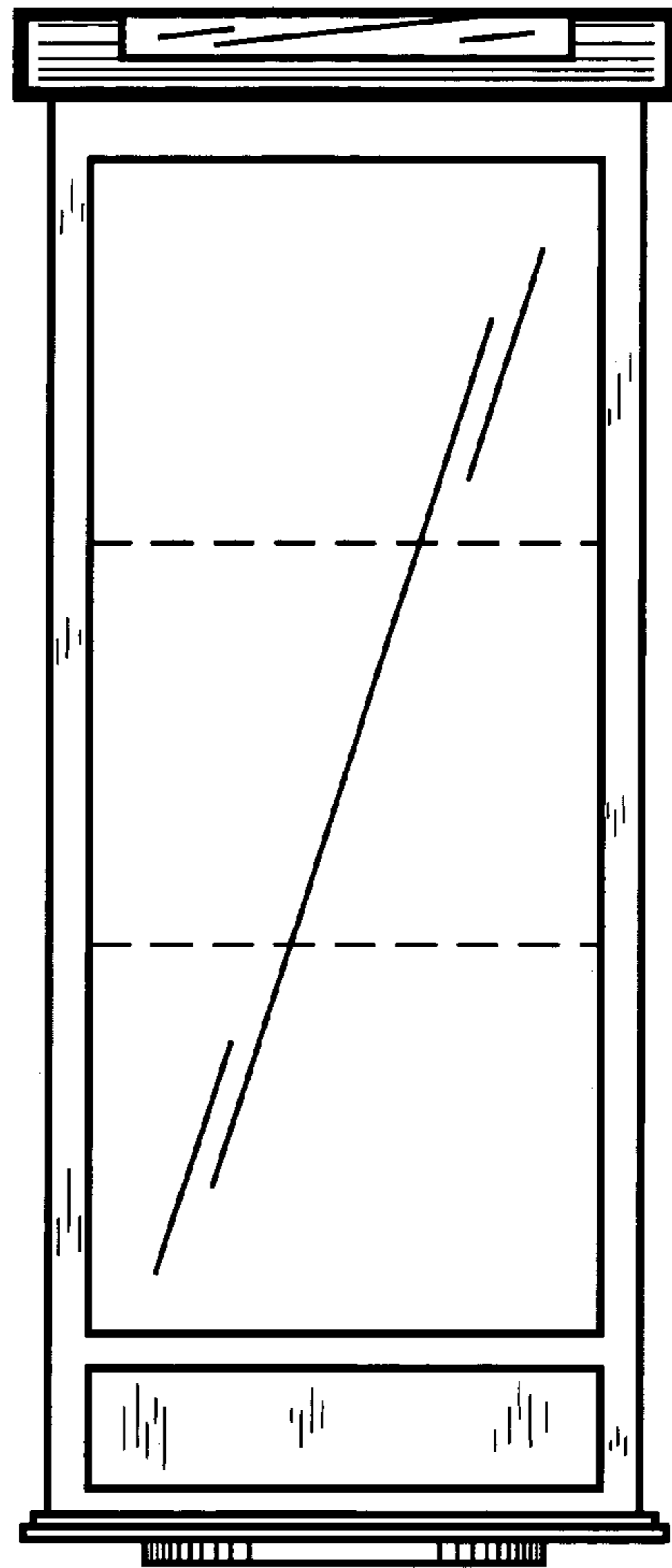

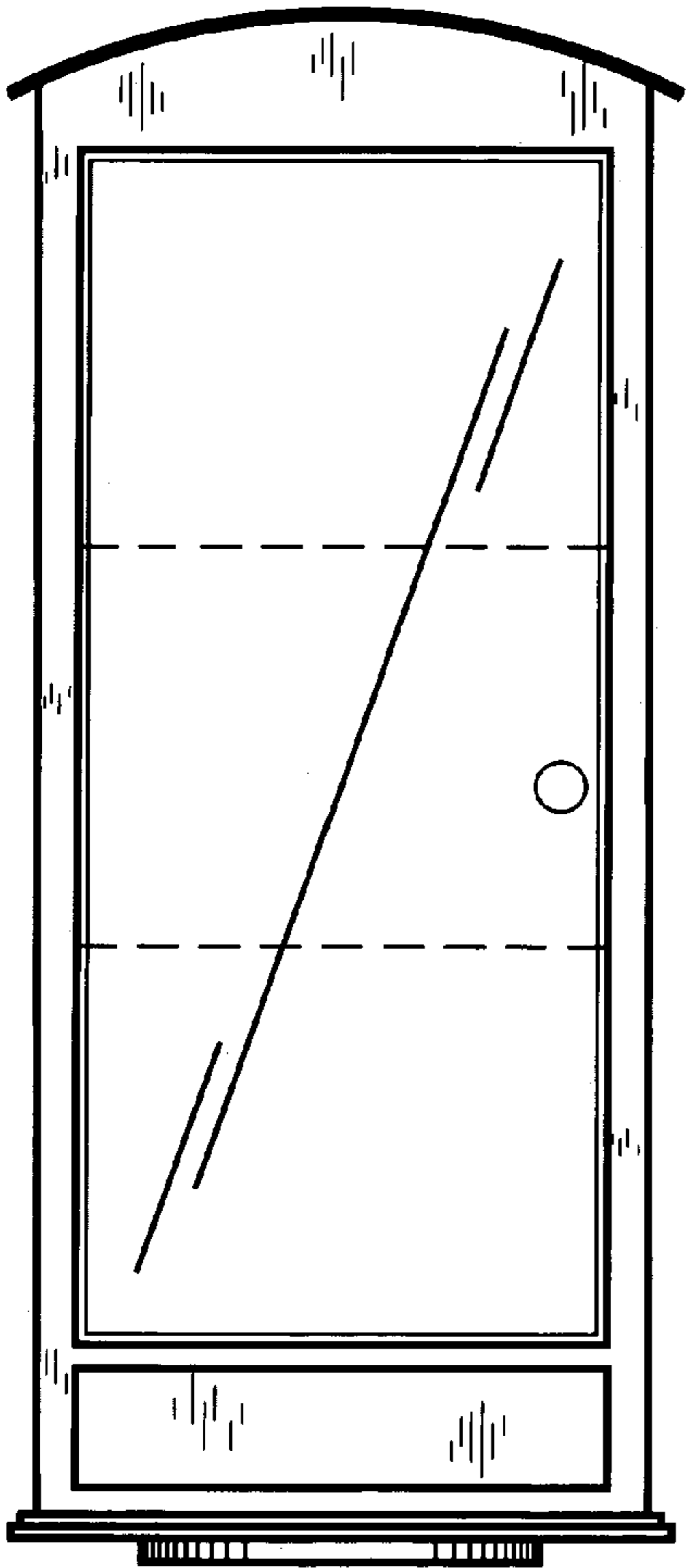

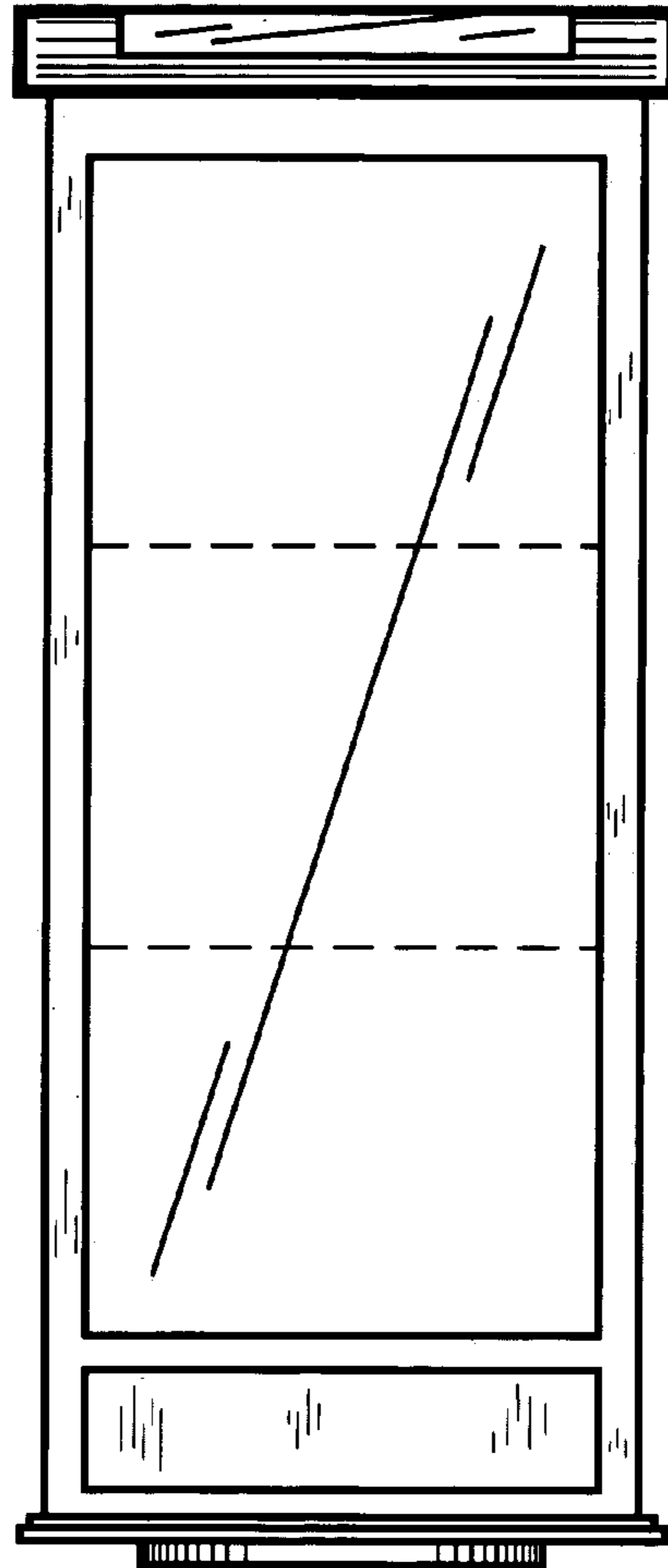

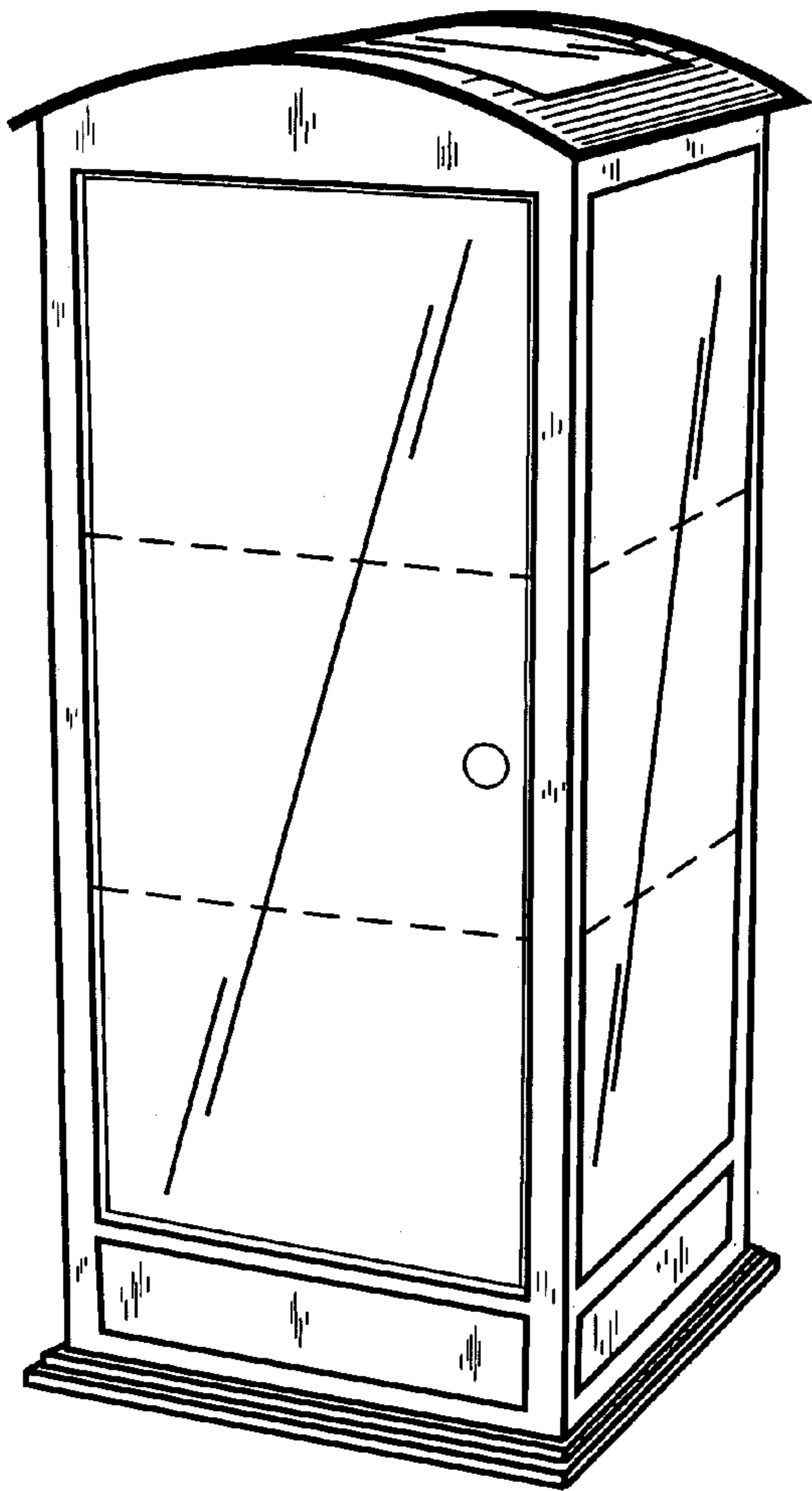

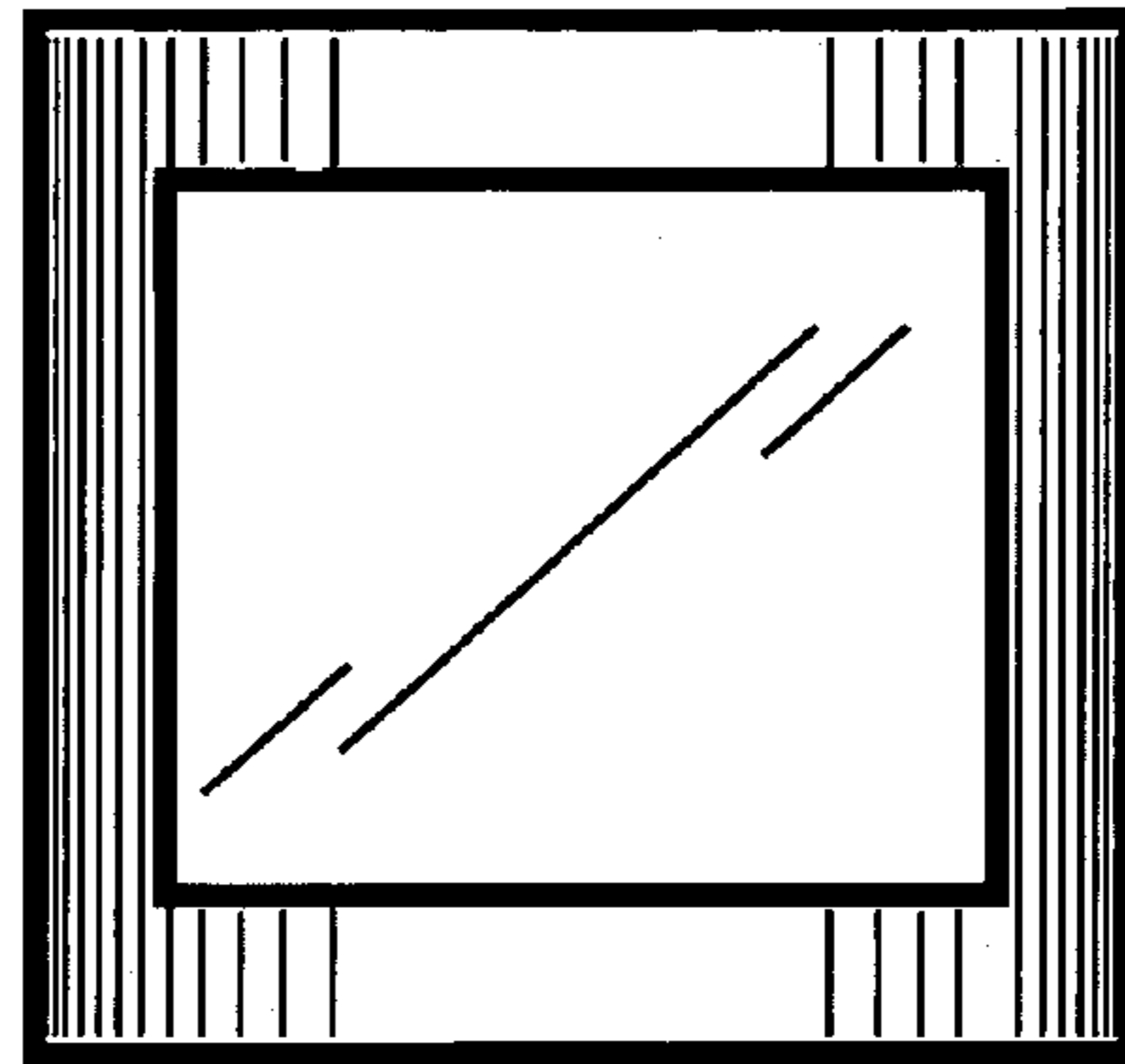

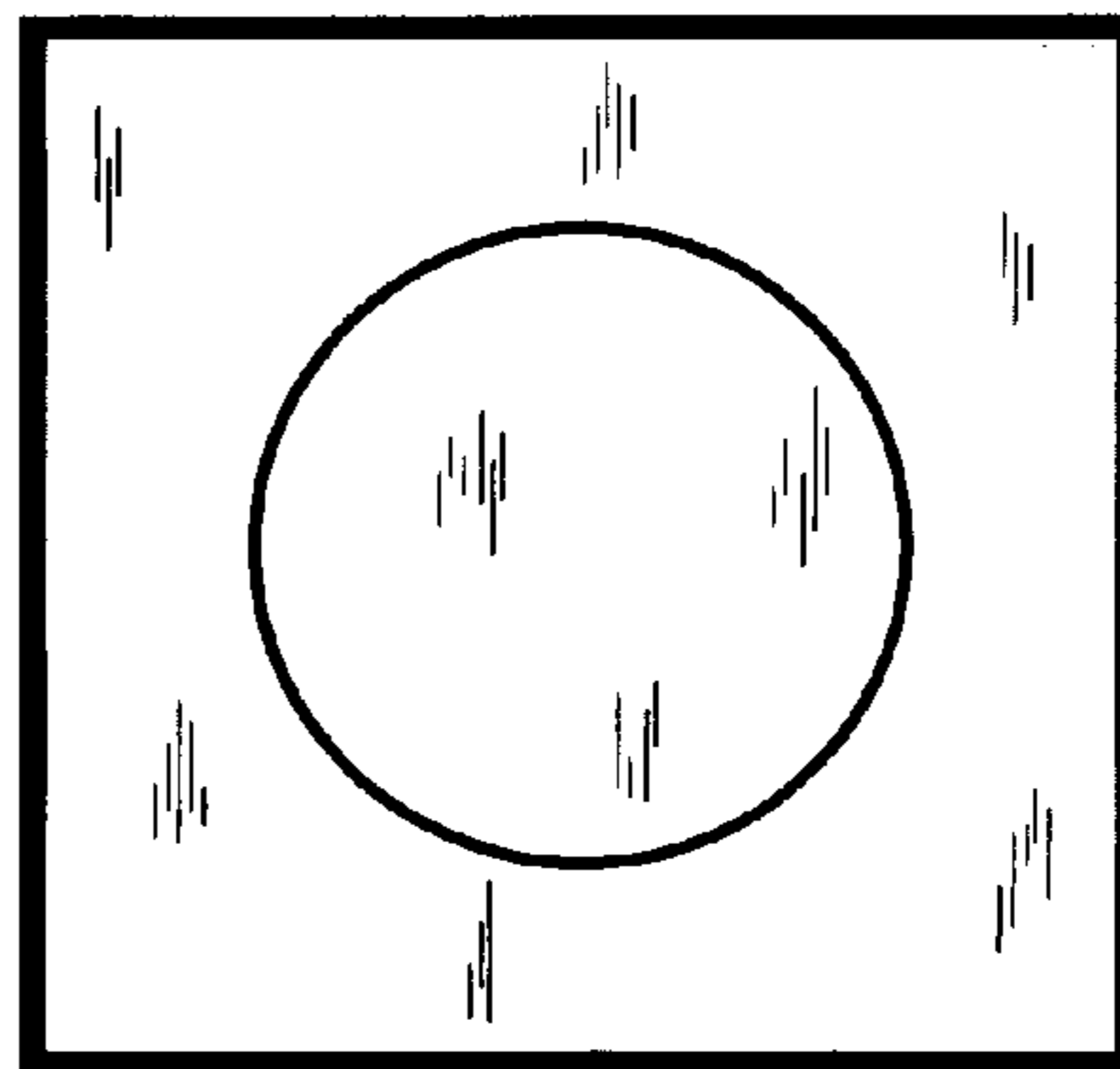
