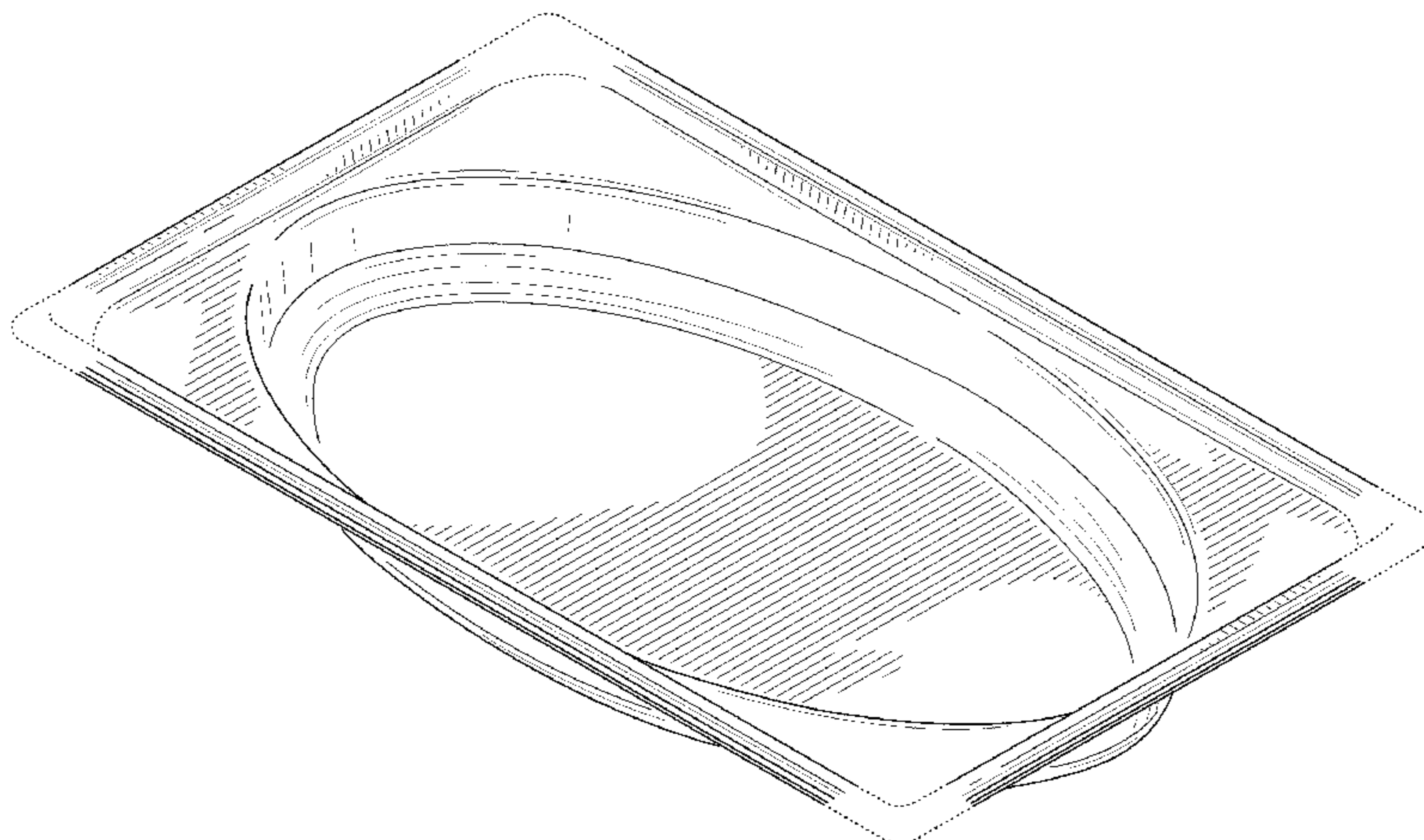
(57) **CLAIM**

We claim the ornamental design for a food pan, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of the claimed design;
FIG. 2 is a top view thereof;
FIG. 3 is a bottom view thereof;
FIG. 4 is a front view thereof, the rear view is a mirror image of FIG. 4; and,
FIG. 5 is a right side view thereof, the left side view is a mirror image of FIG. 5.

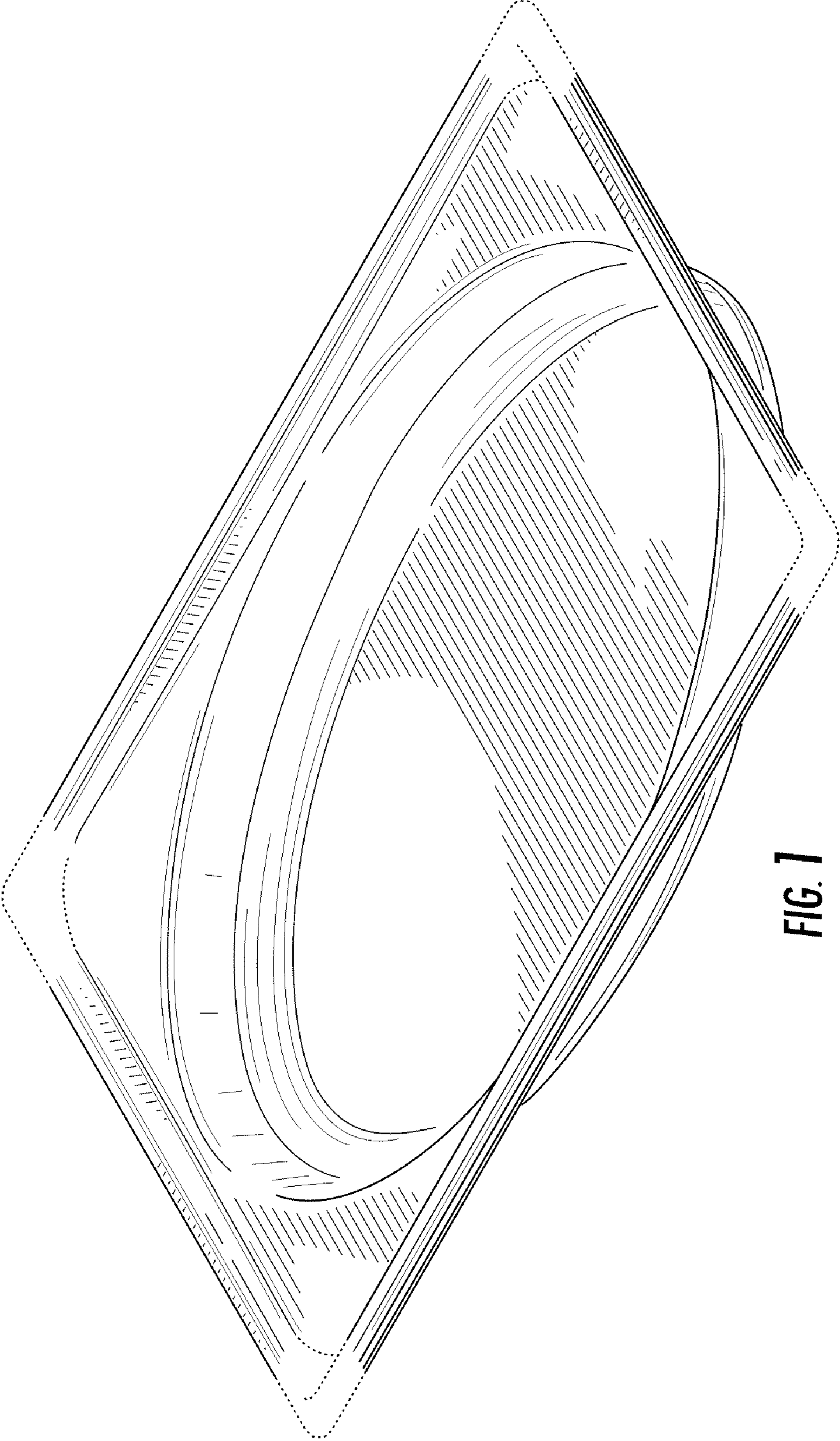

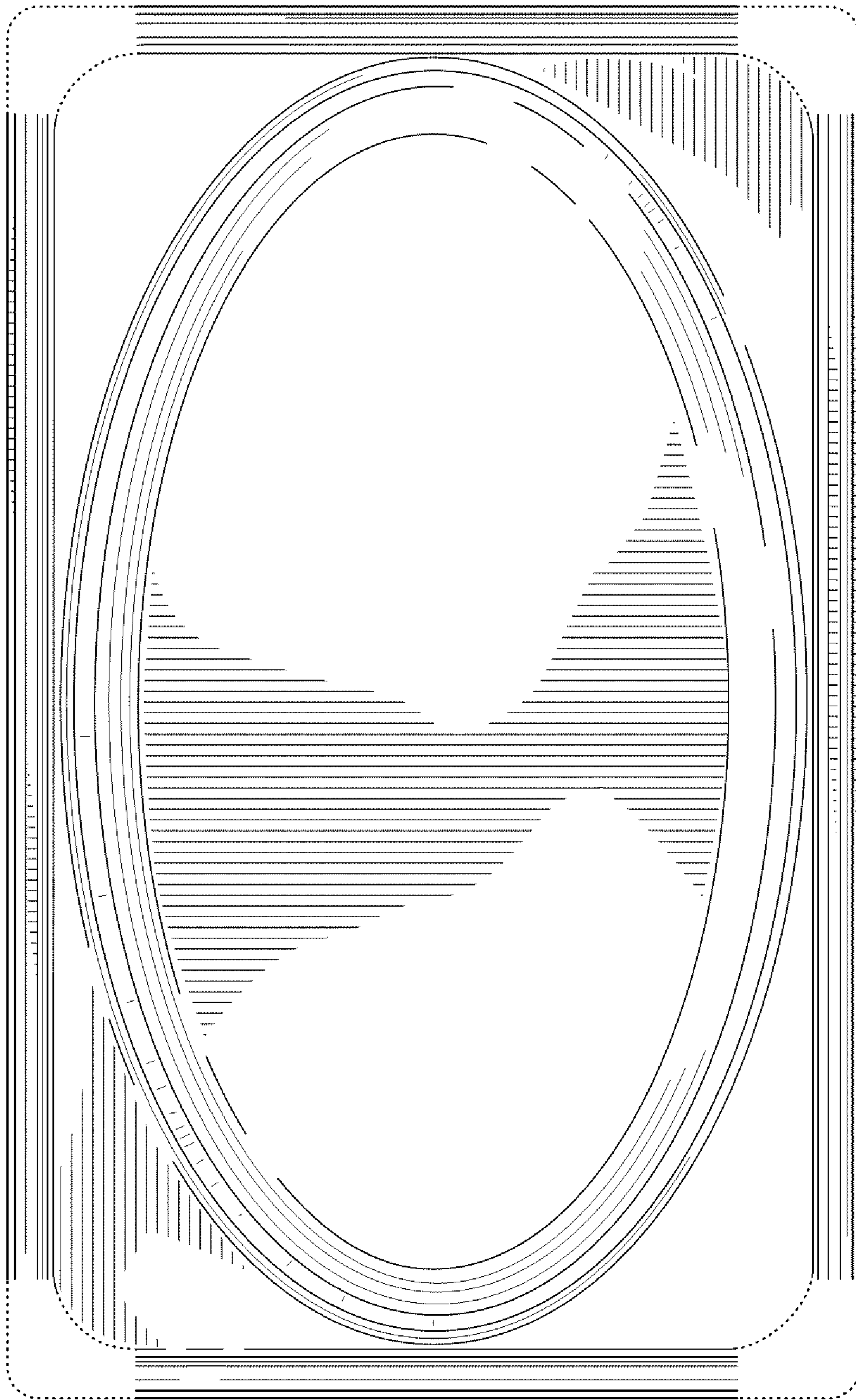

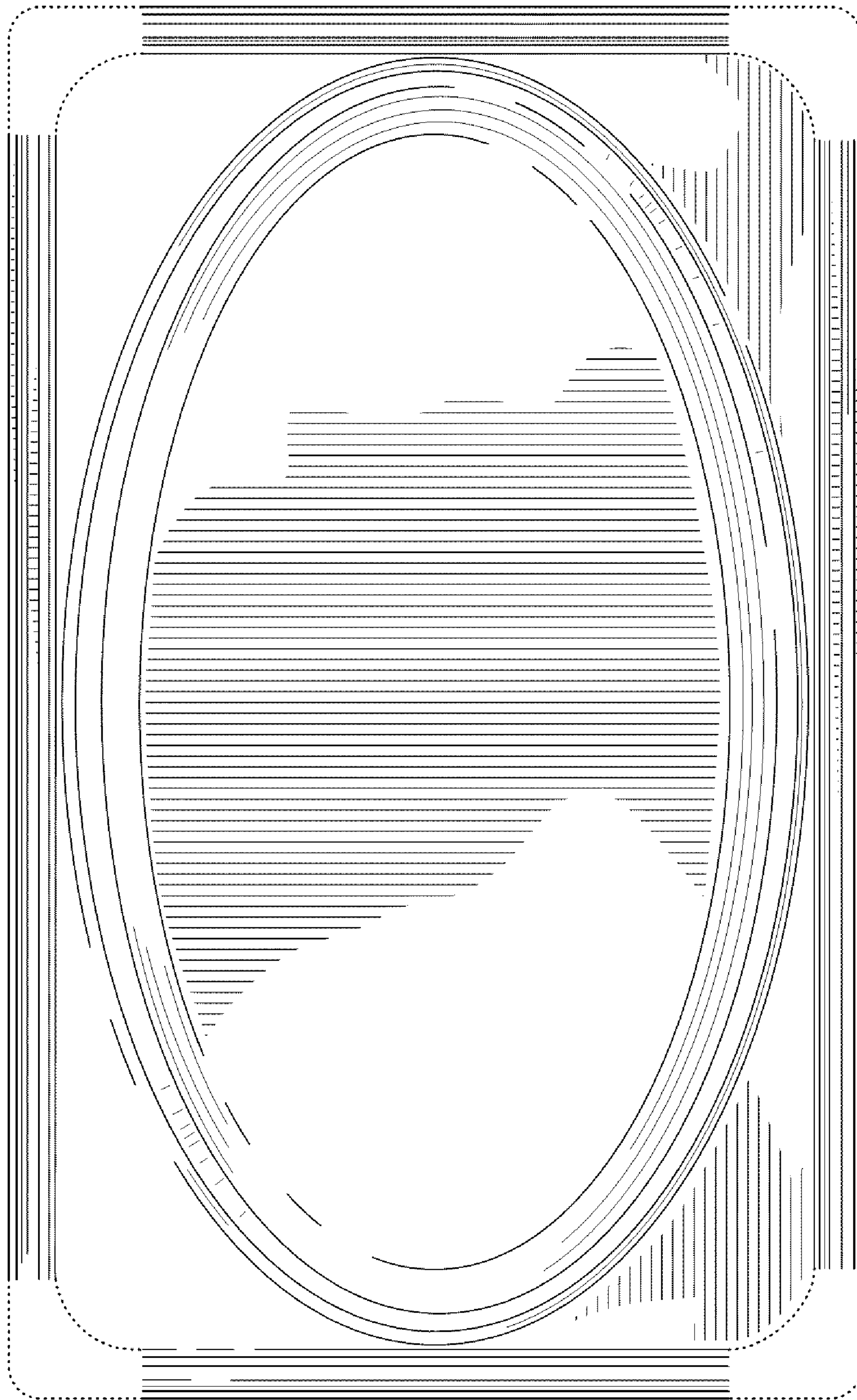

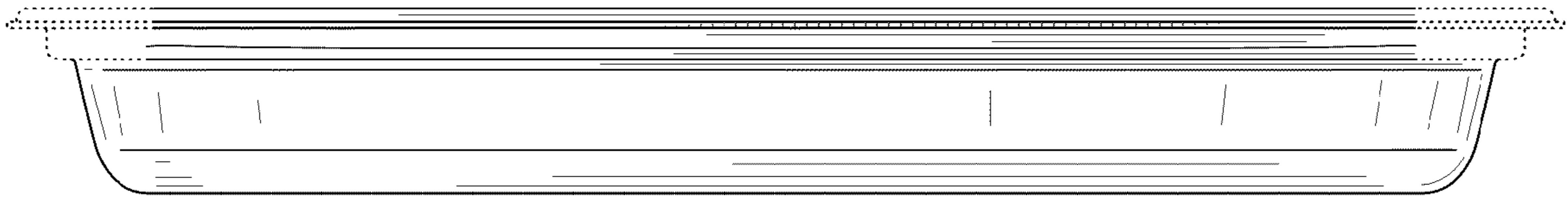

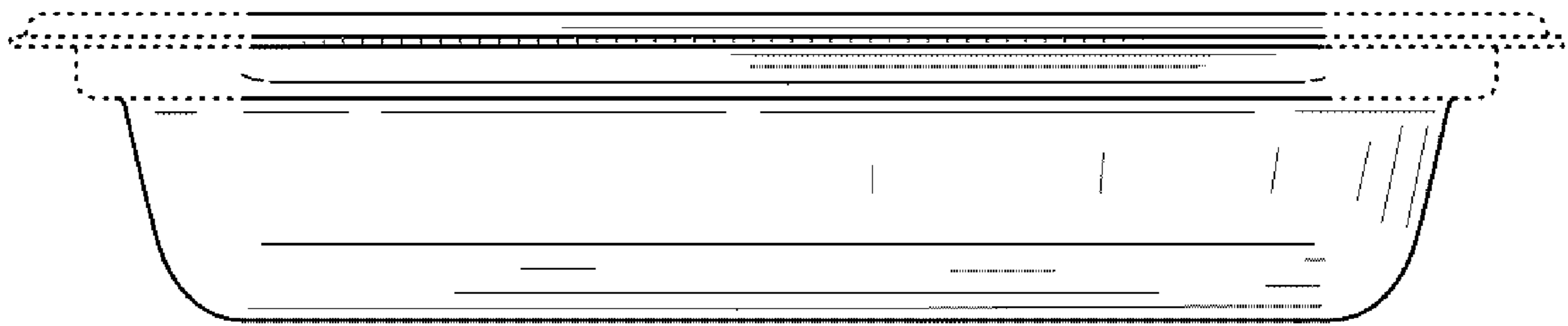
