(57) **CLAIM**

I claim the ornamental design for a wood boring bit, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a wood boring bit embodying the invention.

FIG. 3 is a rear view of the wood boring bit shown in FIG. 1.

FIG. 4 is a left side view of the wood boring bit shown in FIG. 1.

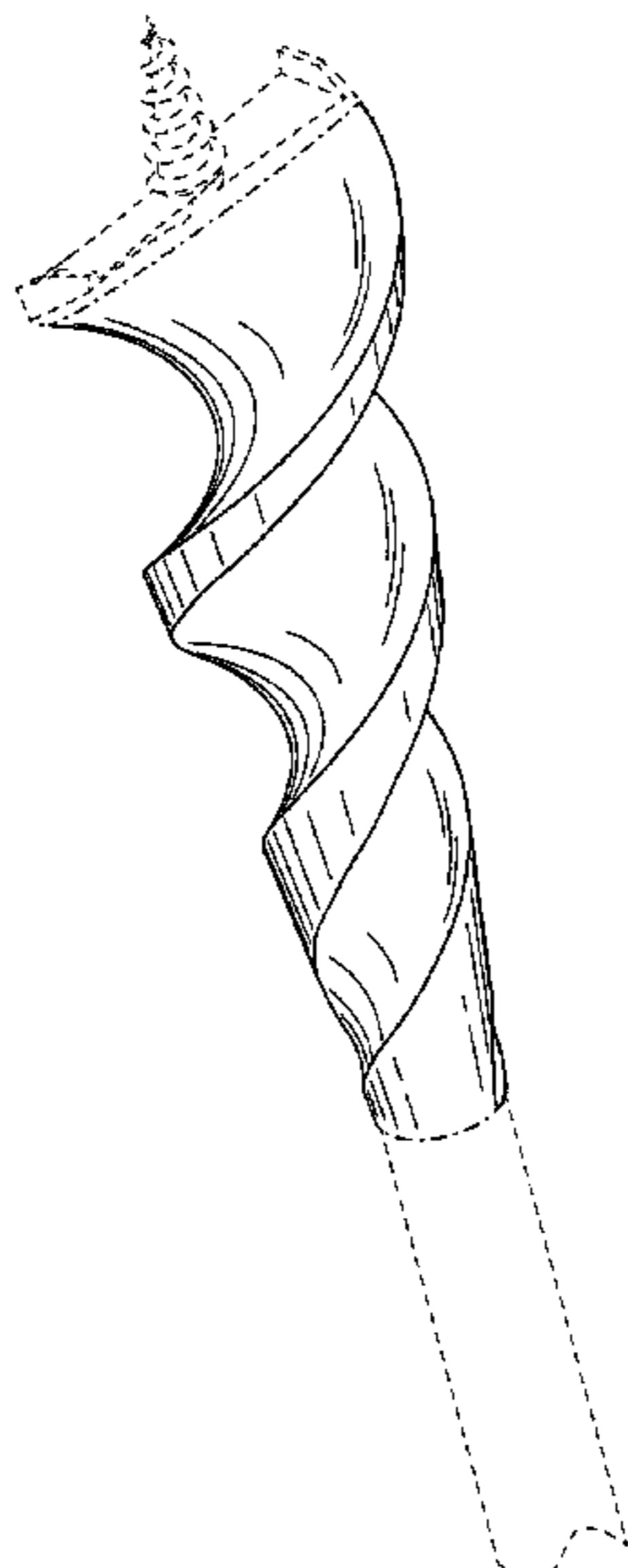
FIG. 5 is a right side view of the wood boring bit shown in FIG. 1.

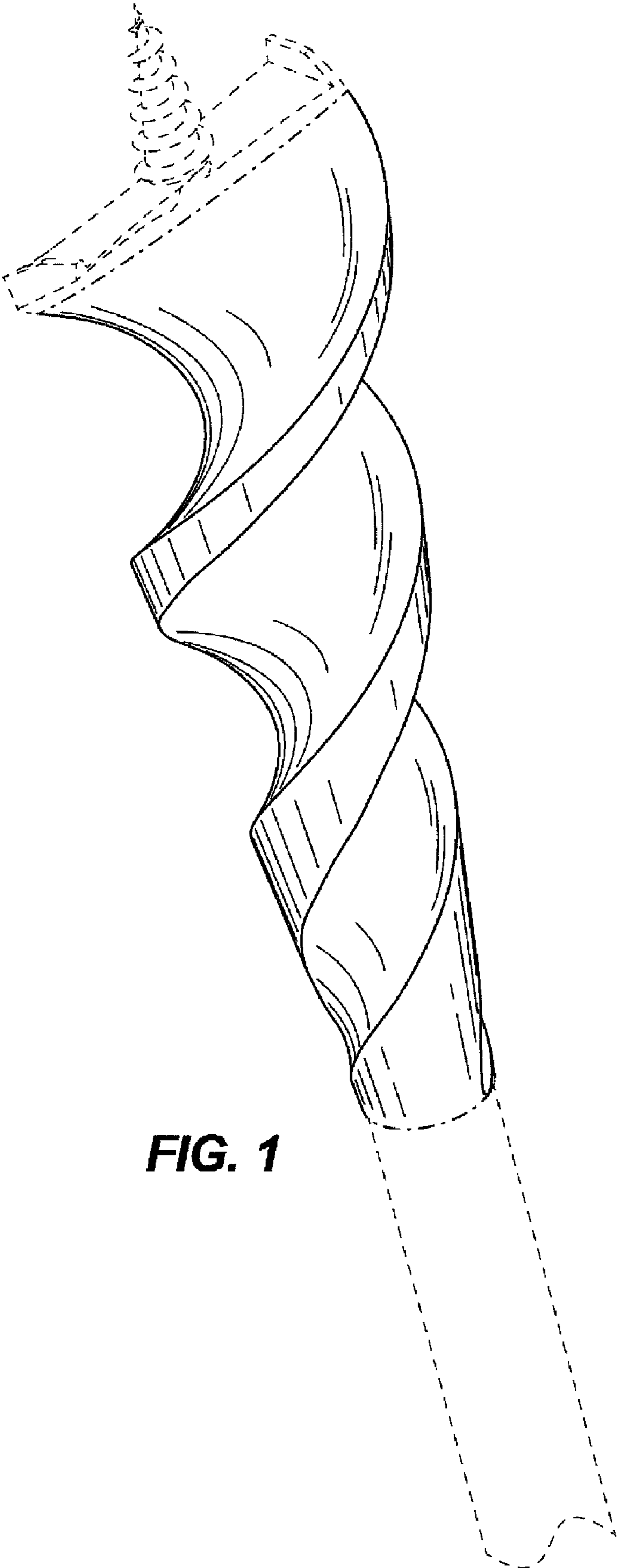
FIG. 6 is a top view of the wood boring bit shown in FIG. 1; and,

FIG. 7 is a bottom view of the wood boring bit shown in FIG. 1.

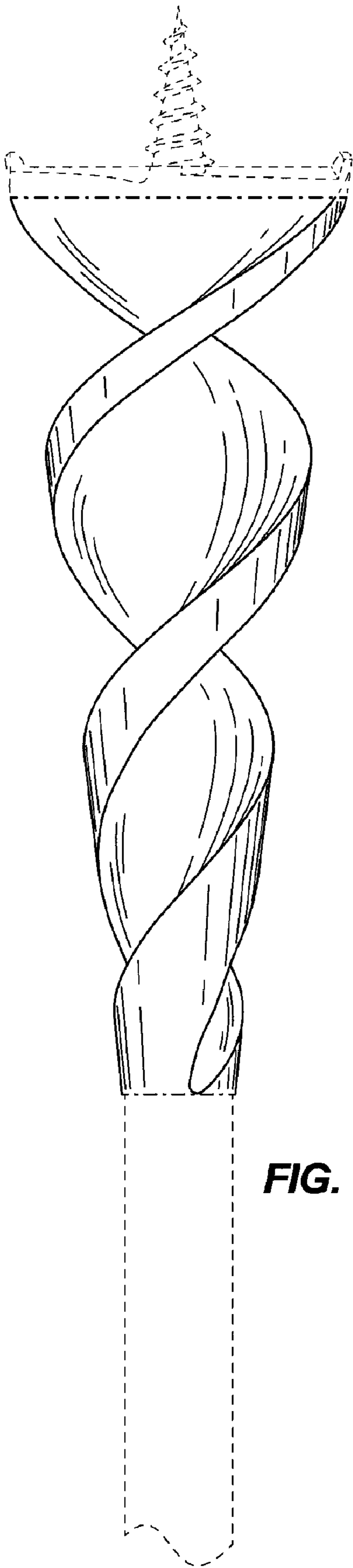

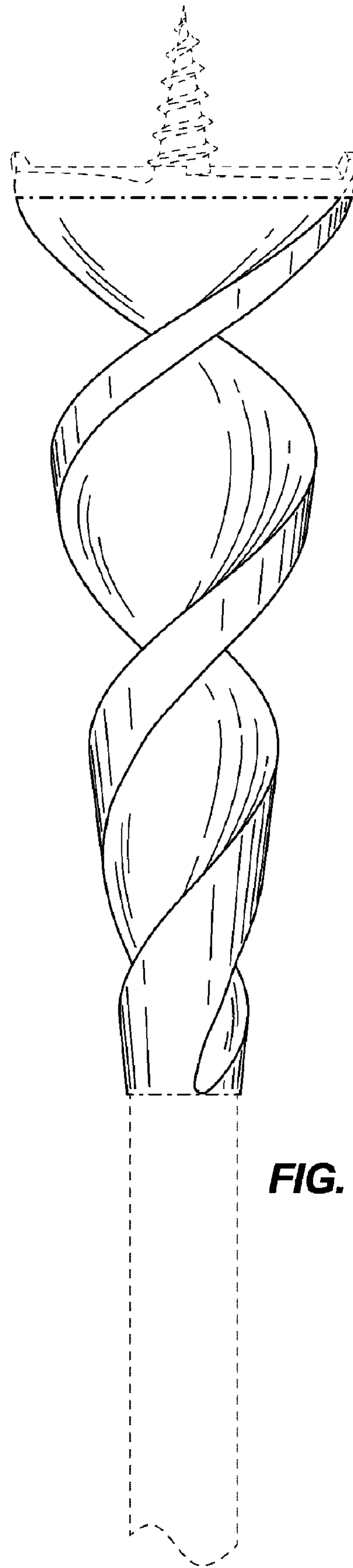




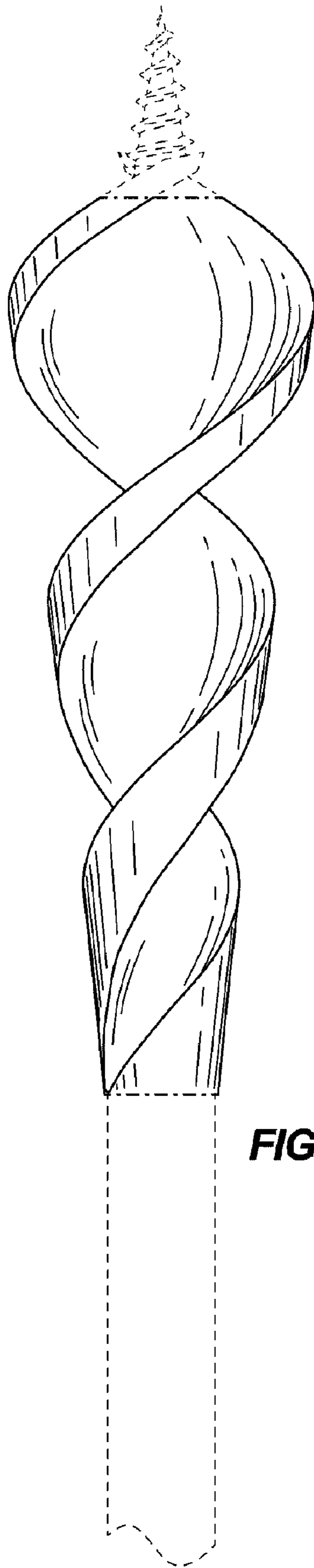

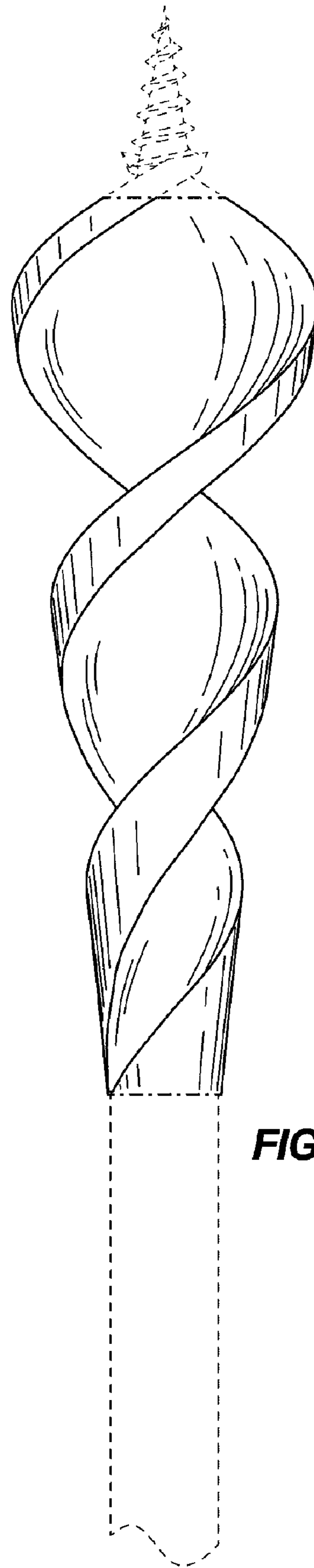

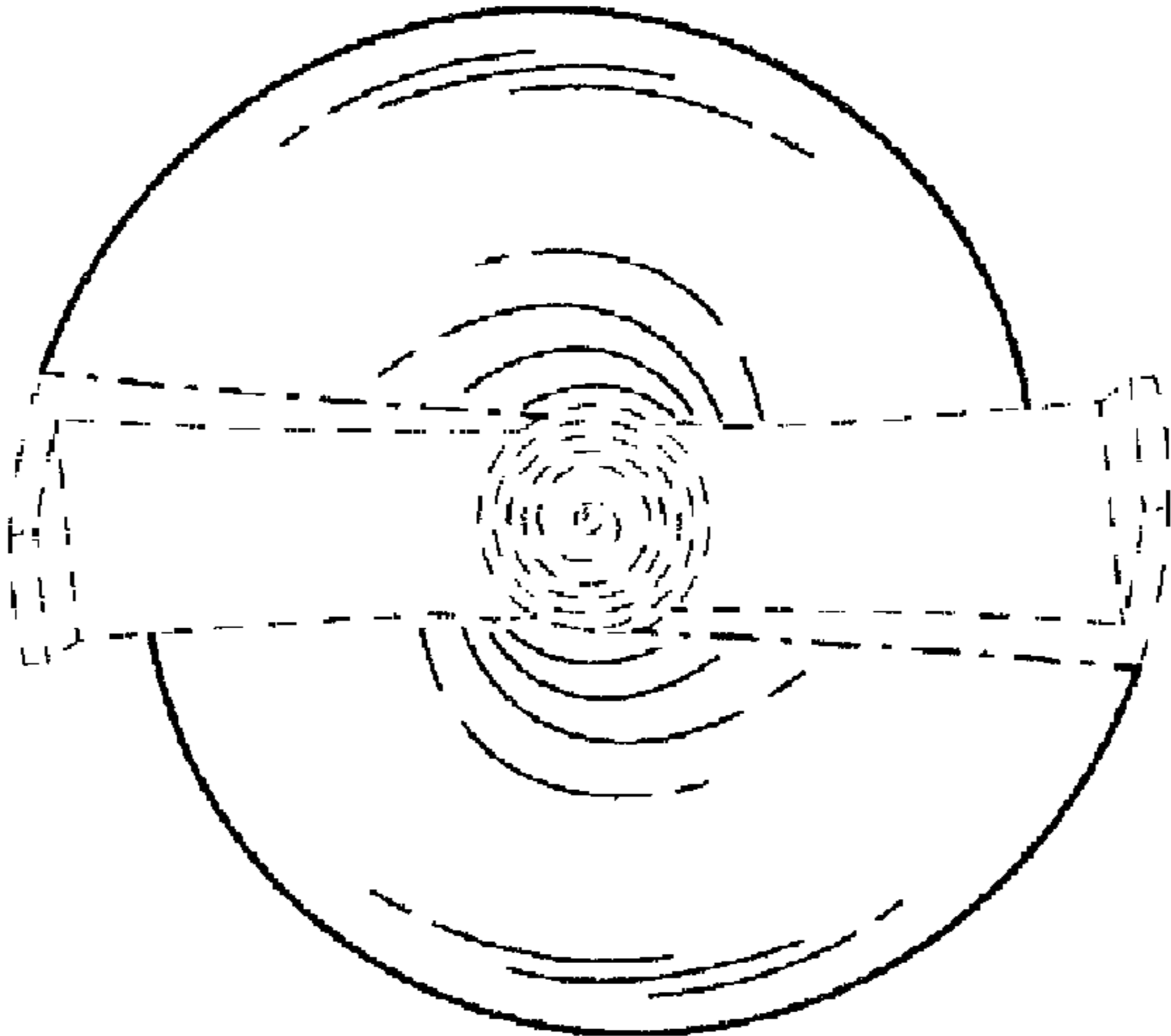

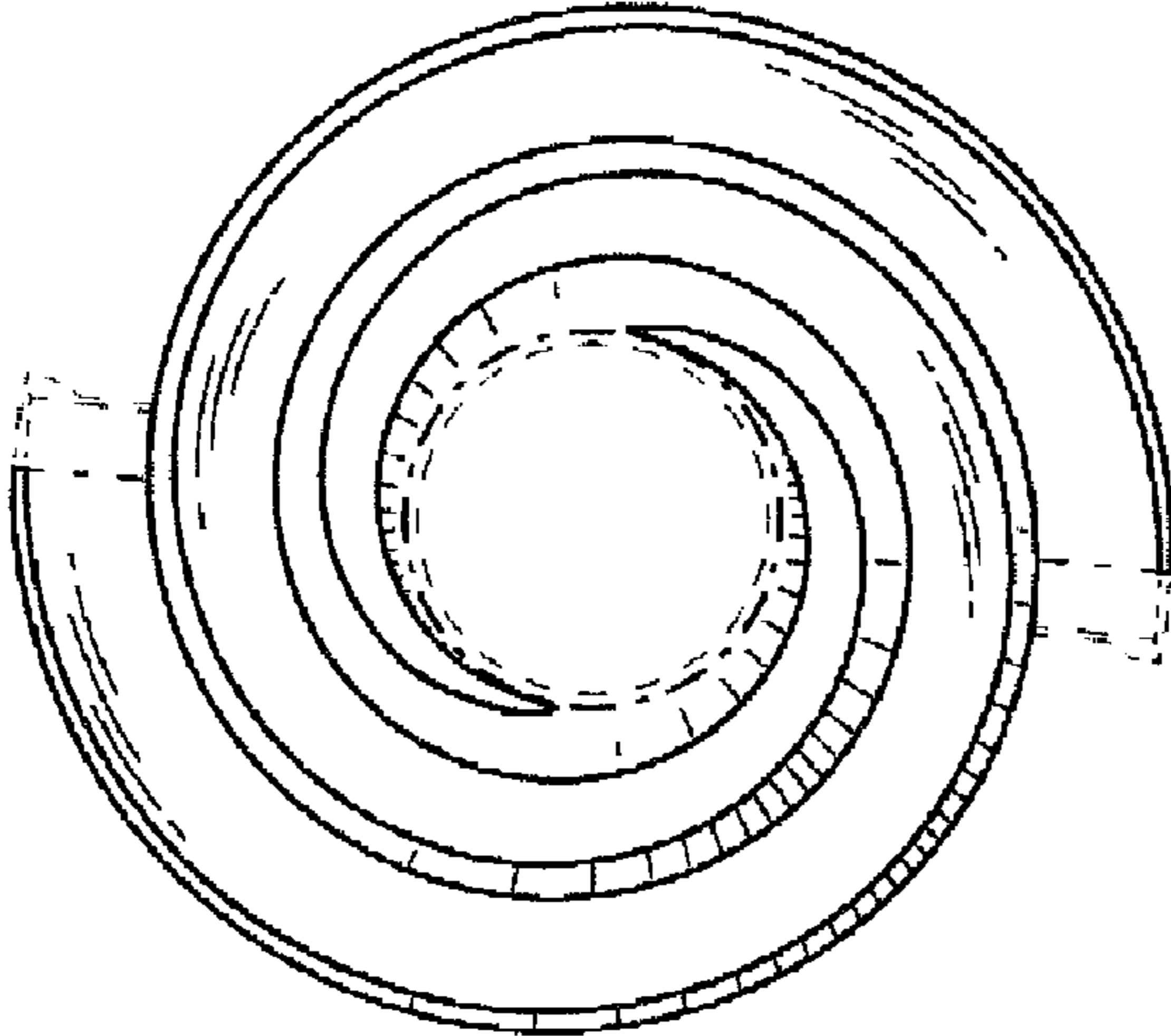
