(57) **CLAIM**

The ornamental design for an arthritic-friendly bottle cap, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of an arthritic-friendly bottle cap; FIG. 2 is a front view of the bottle cap, where the rear view is a mirror image;

FIG. 3 is a right view of the bottle cap, where the left view is a mirror image;

FIG. 4 is a plan view of the bottle cap; and,

FIG. 5 is a bottom view of the bottle cap.

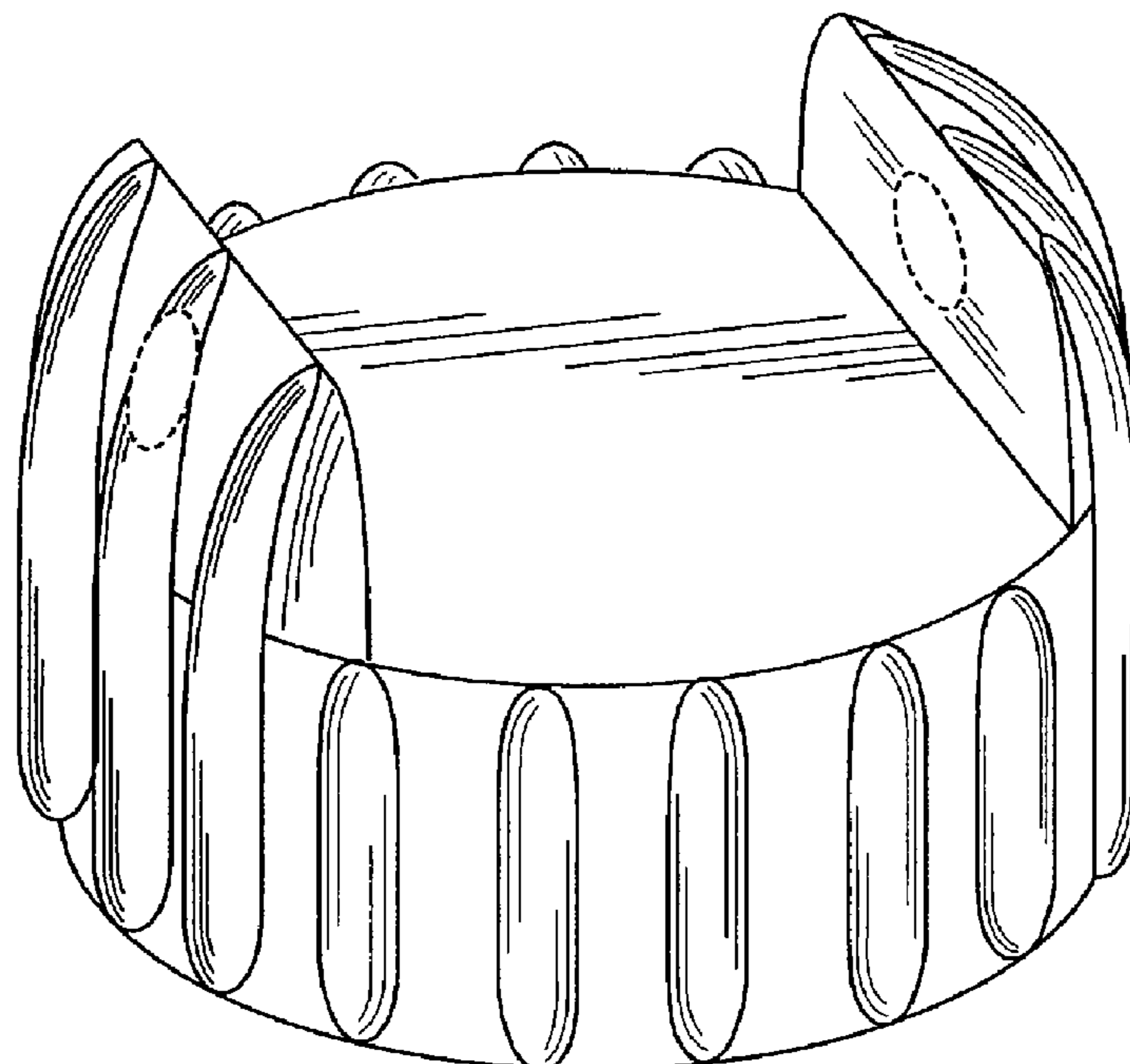

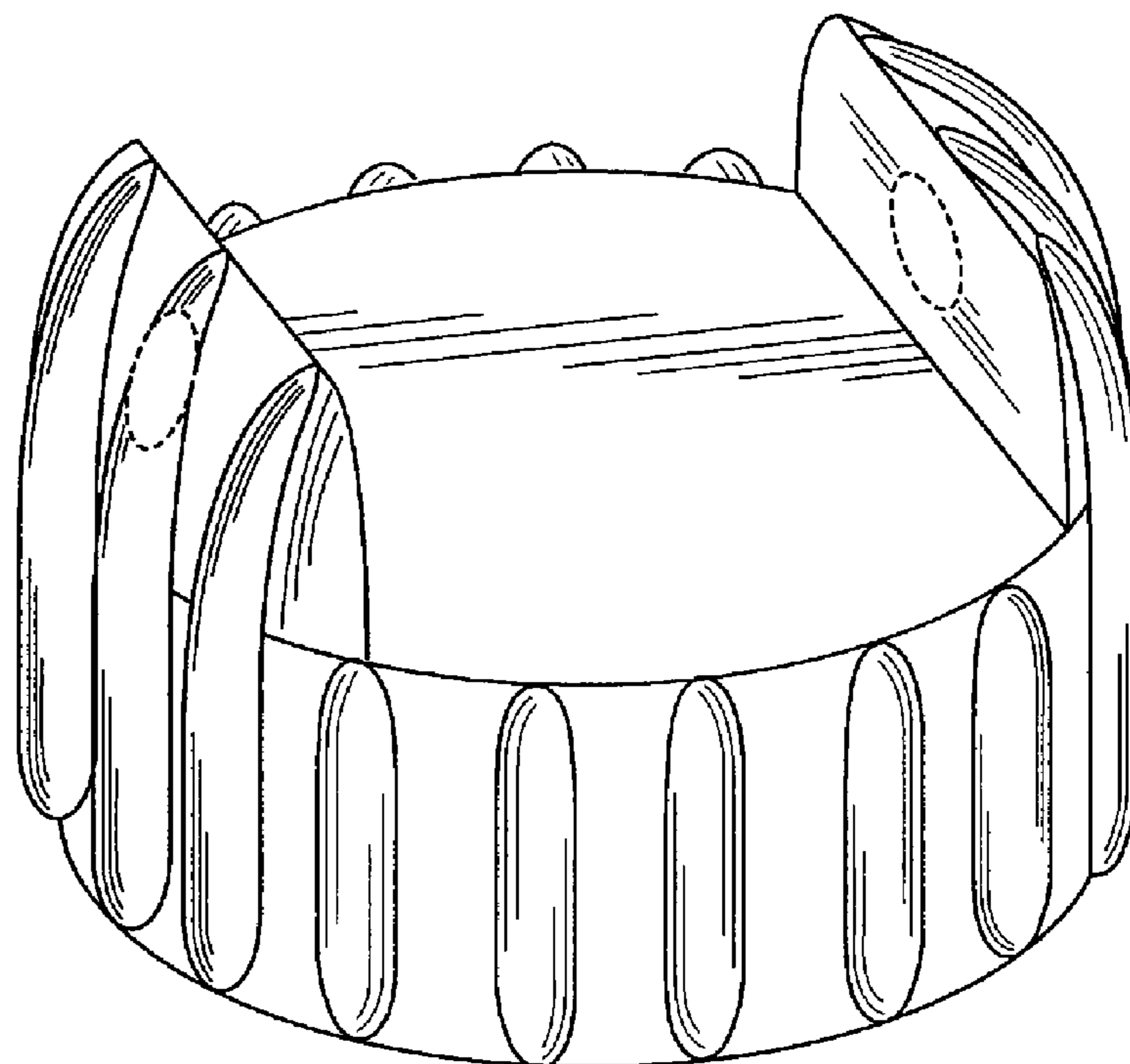

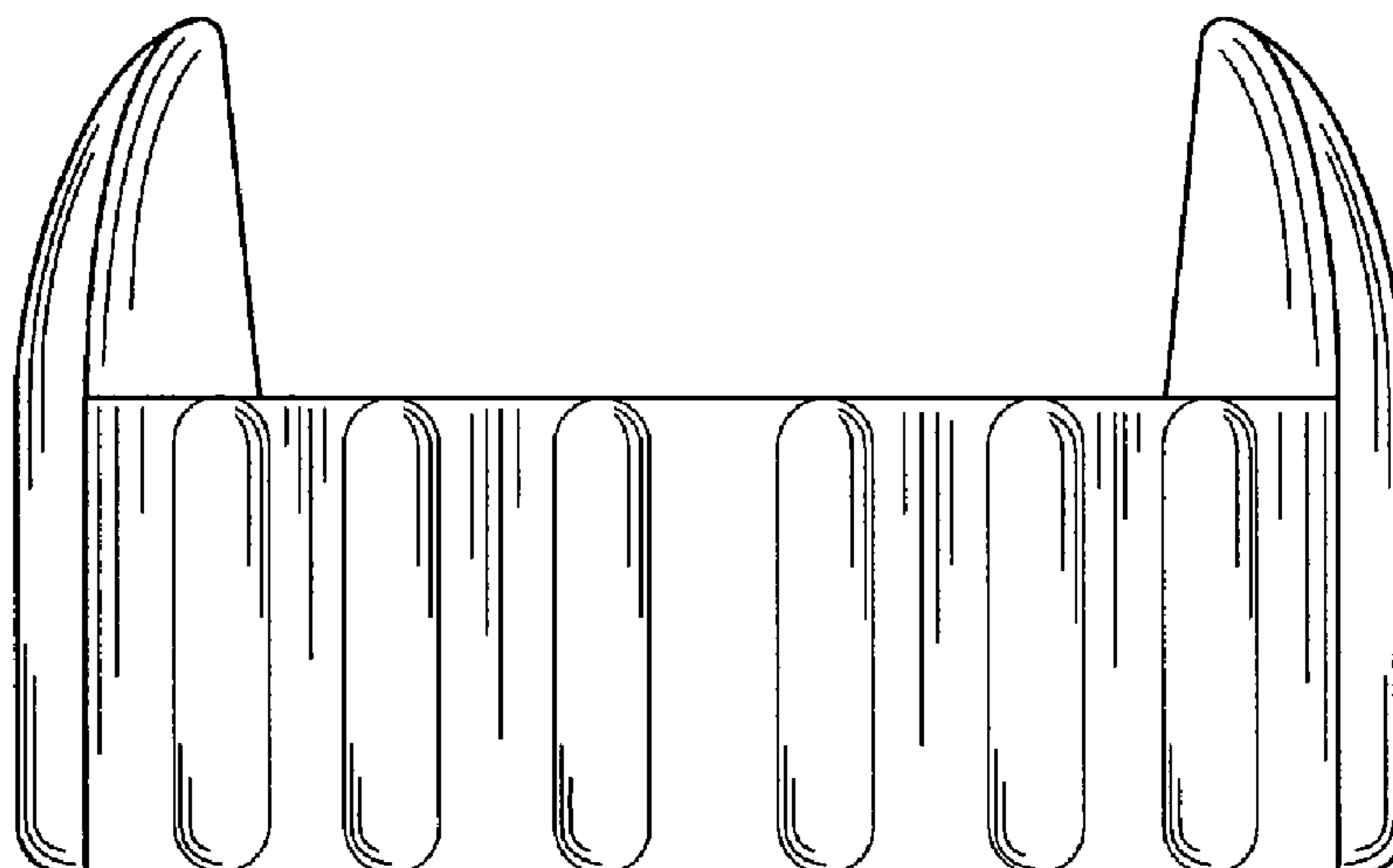

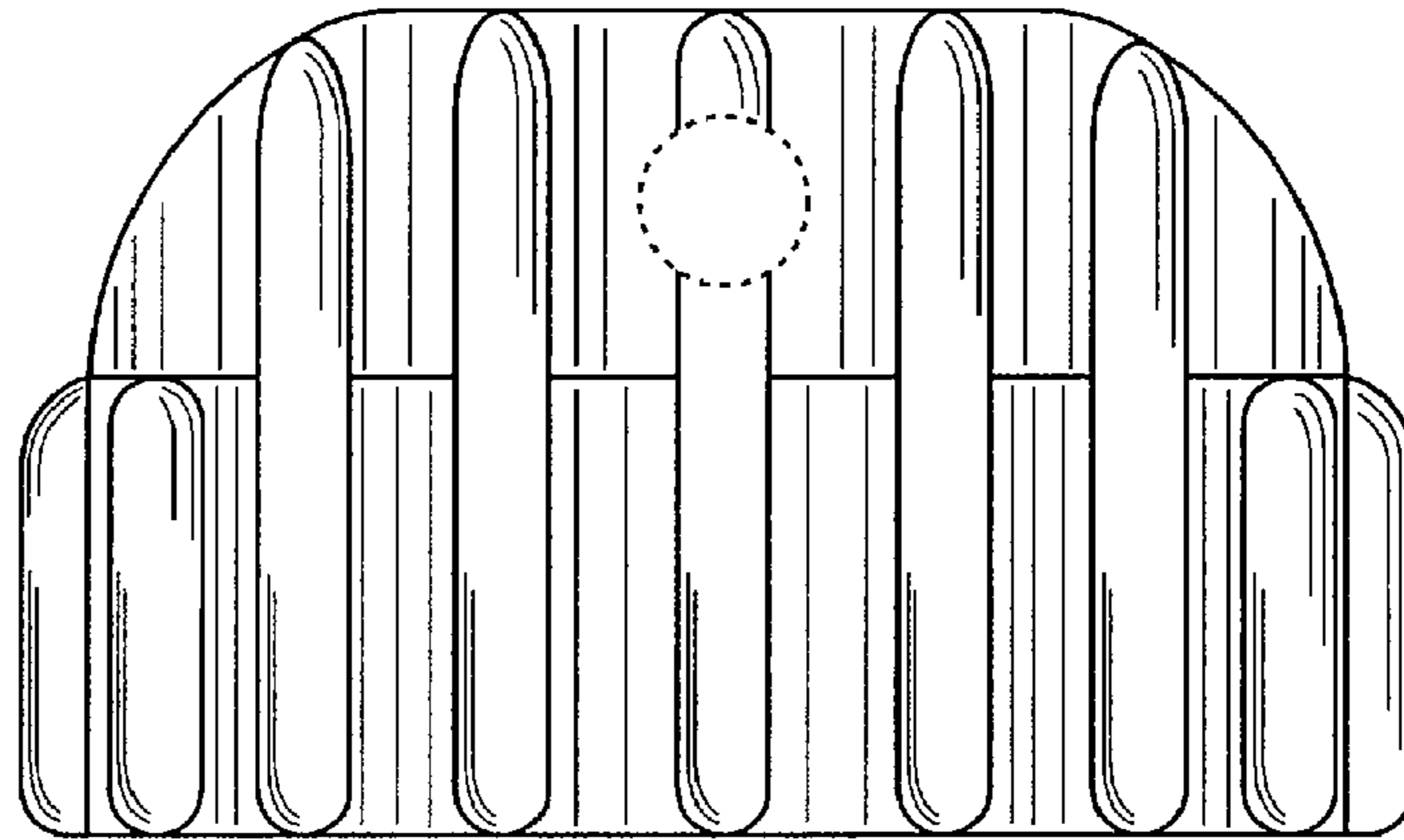

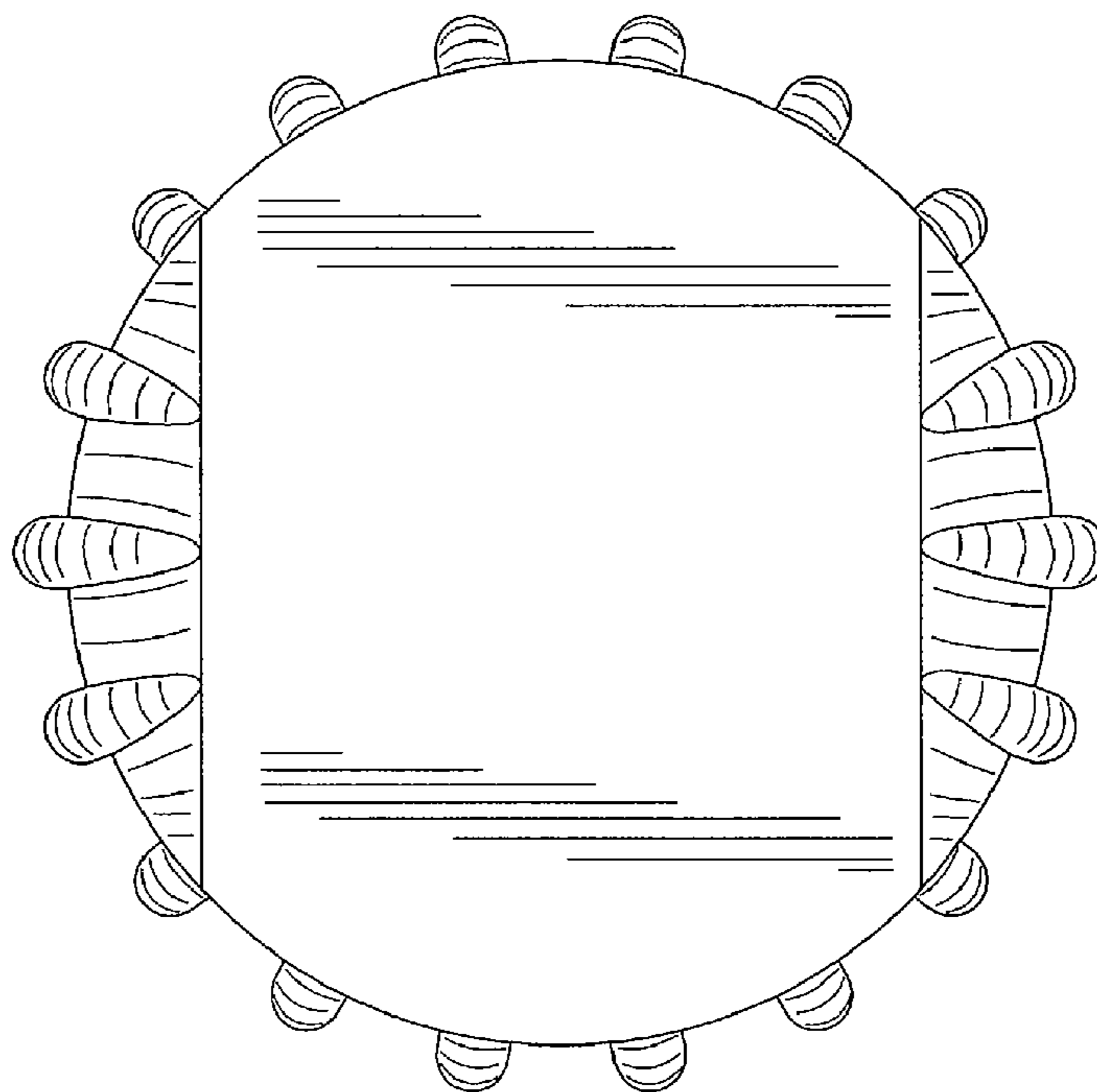
