FIG. 1 is a left, front, top perspective view of a blister;

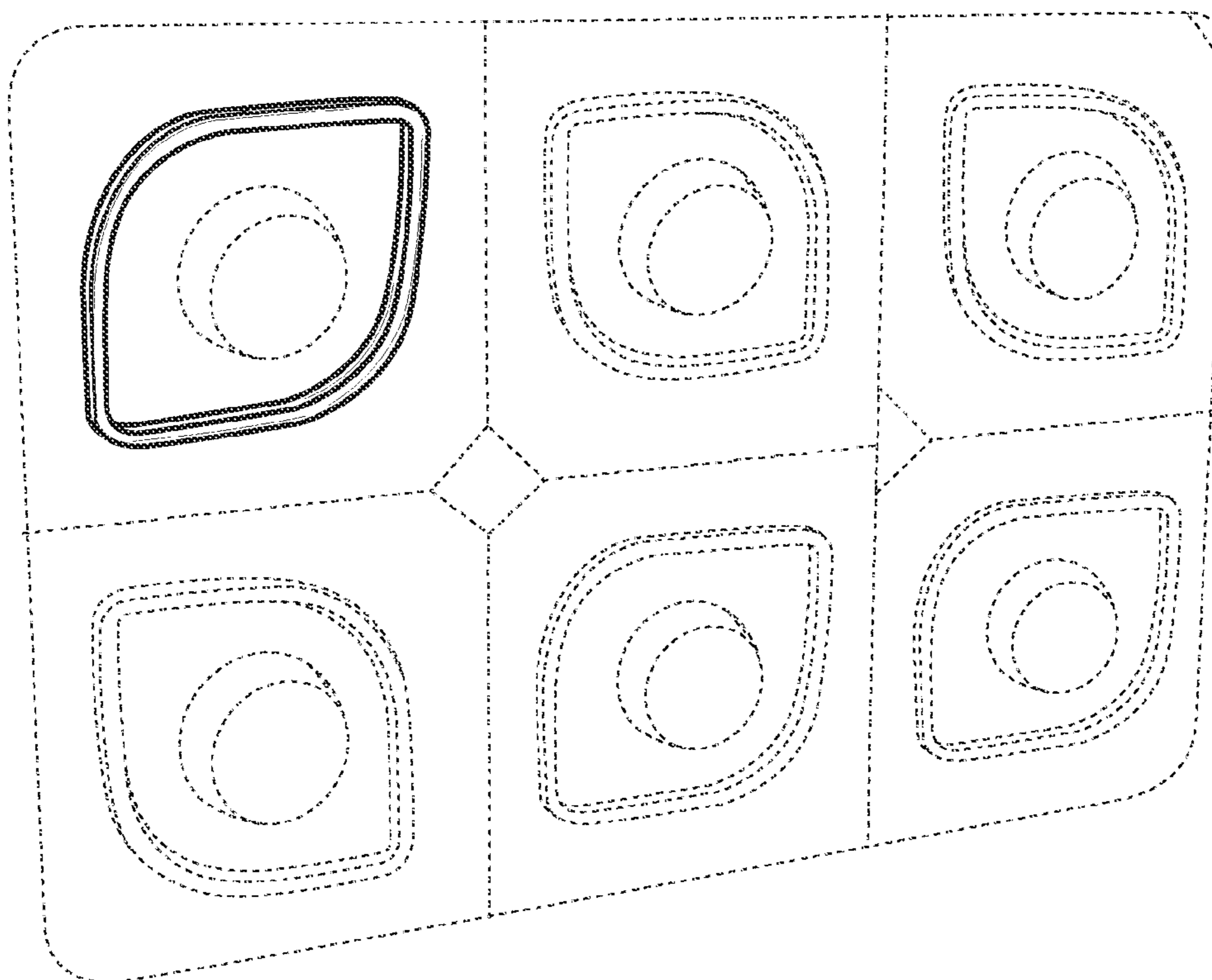
FIG. 2 is a front elevational view thereof; and,

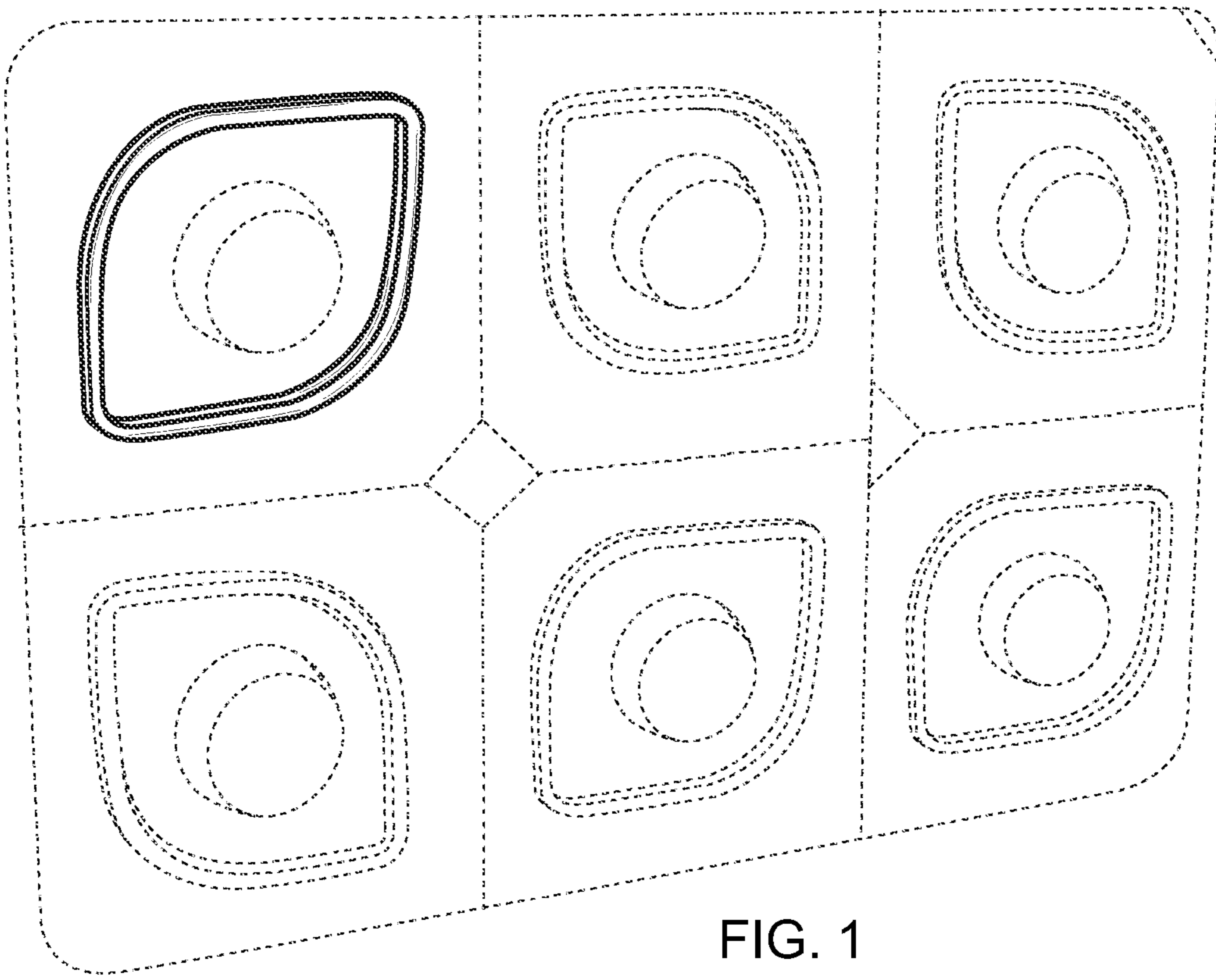

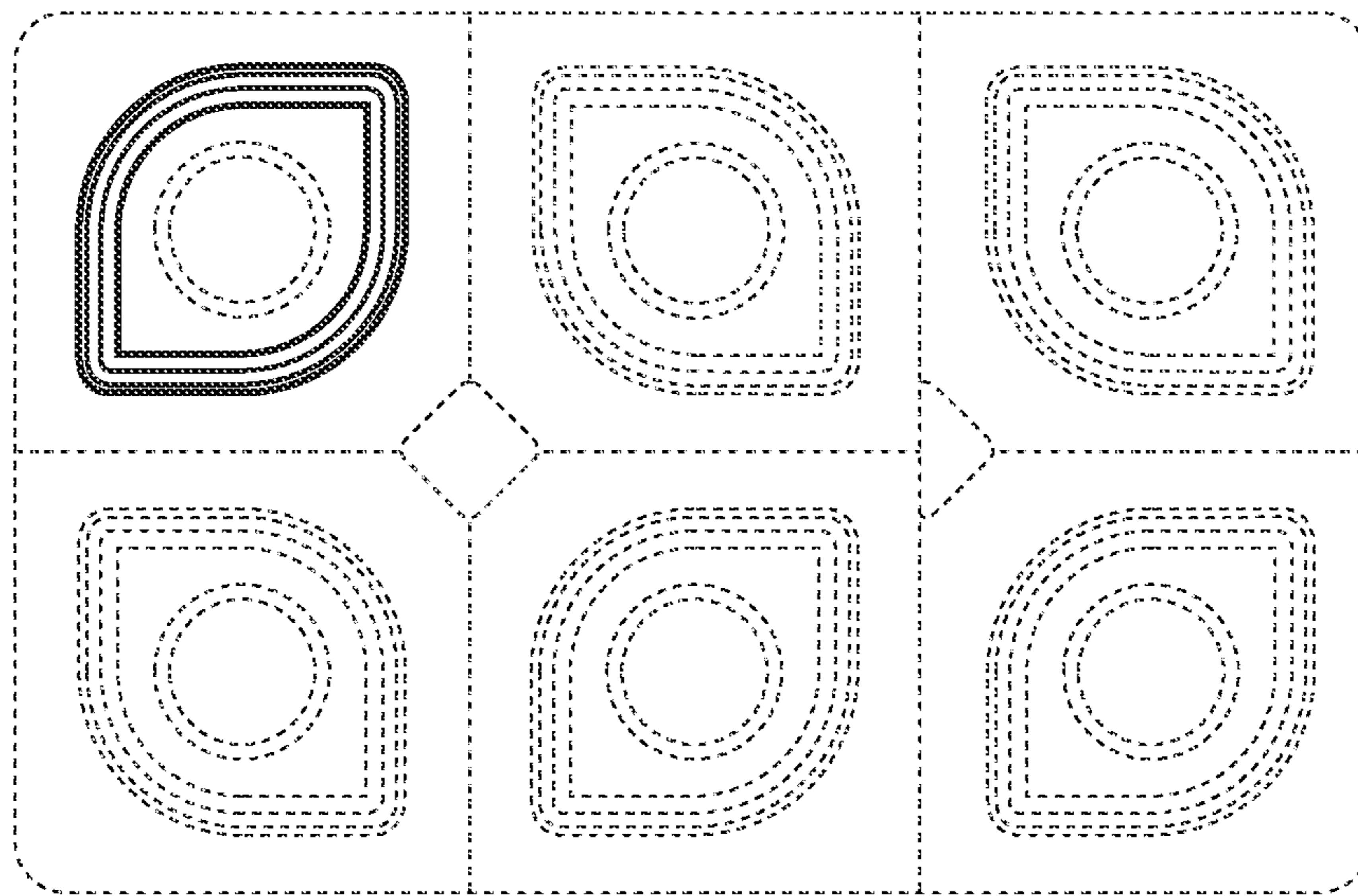
