FIG. 1 is a top front perspective view of an operating panel, showing my new design.  
FIG. 2 is a front elevation view thereof;

FIG. 5 is a bottom plan view thereof; and,

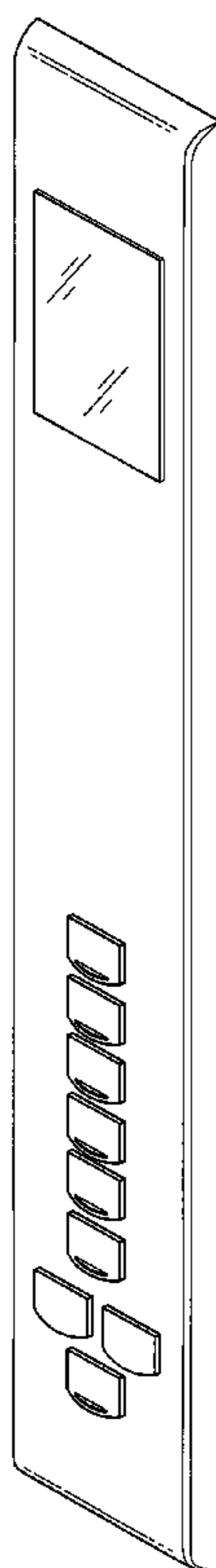

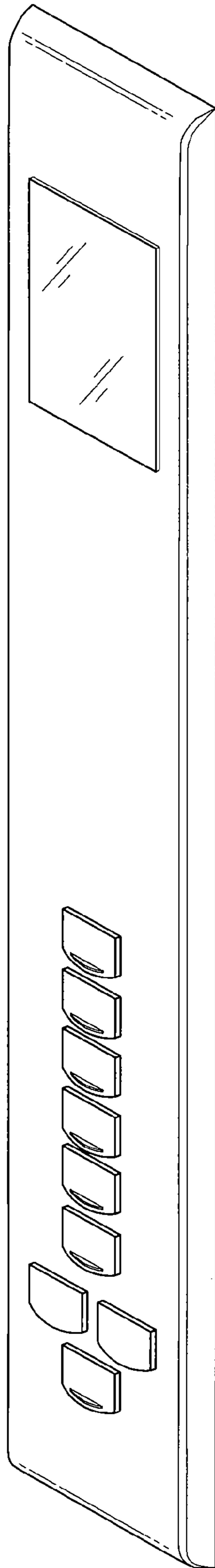

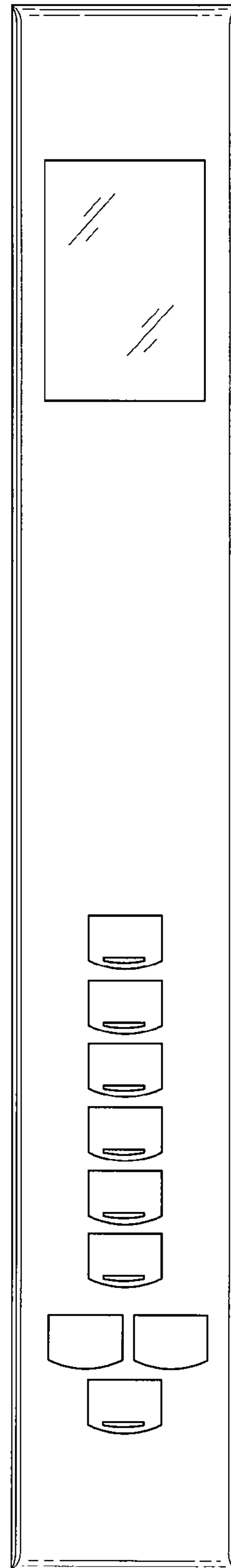

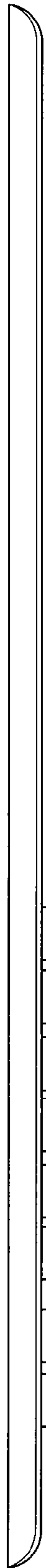
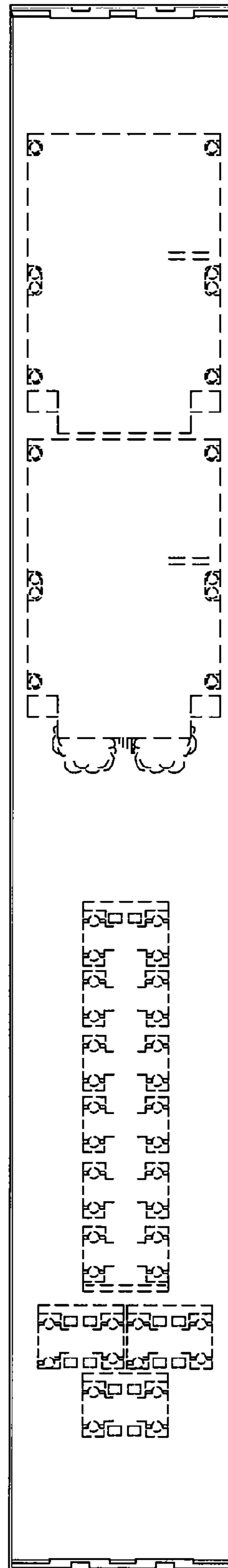
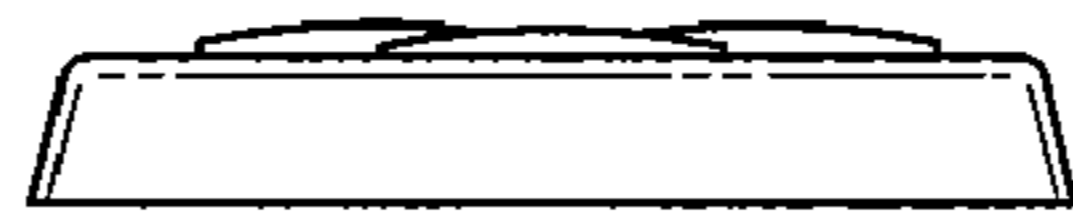
