FIG. 1 is a front side perspective view of the invention. The view from the opposite front side being a mirror image thereof.

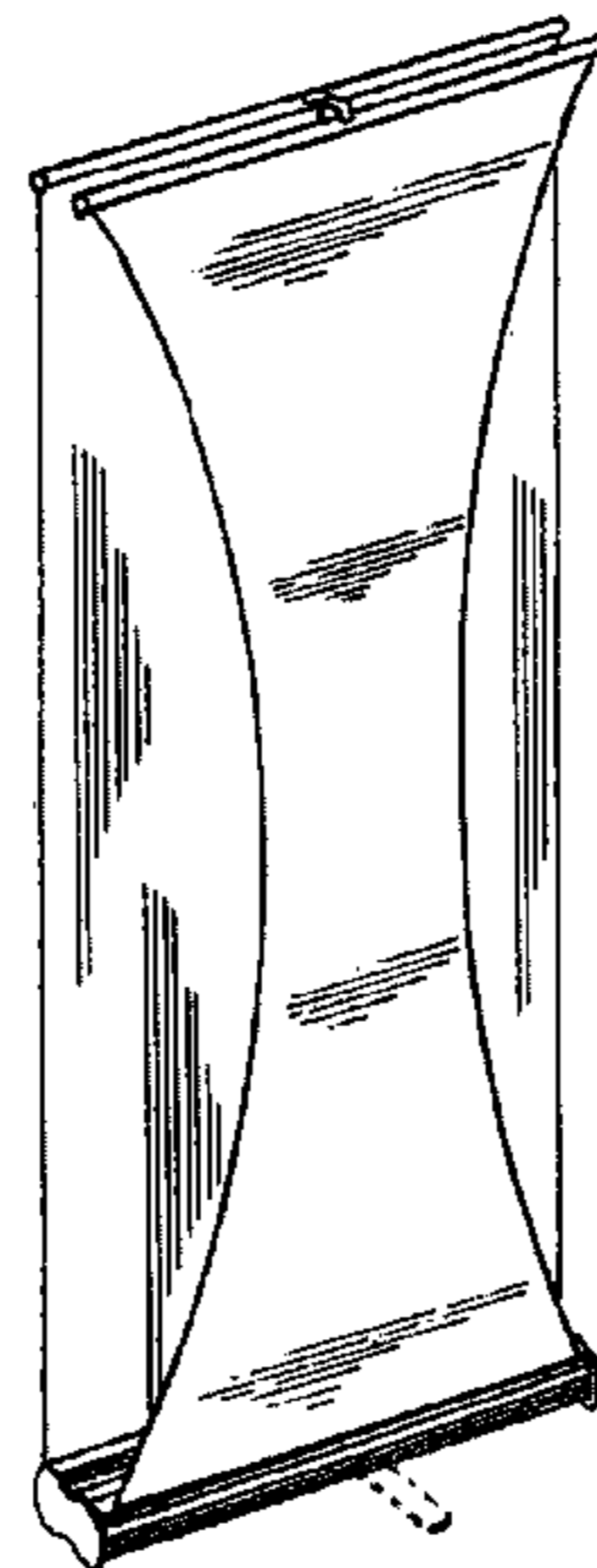

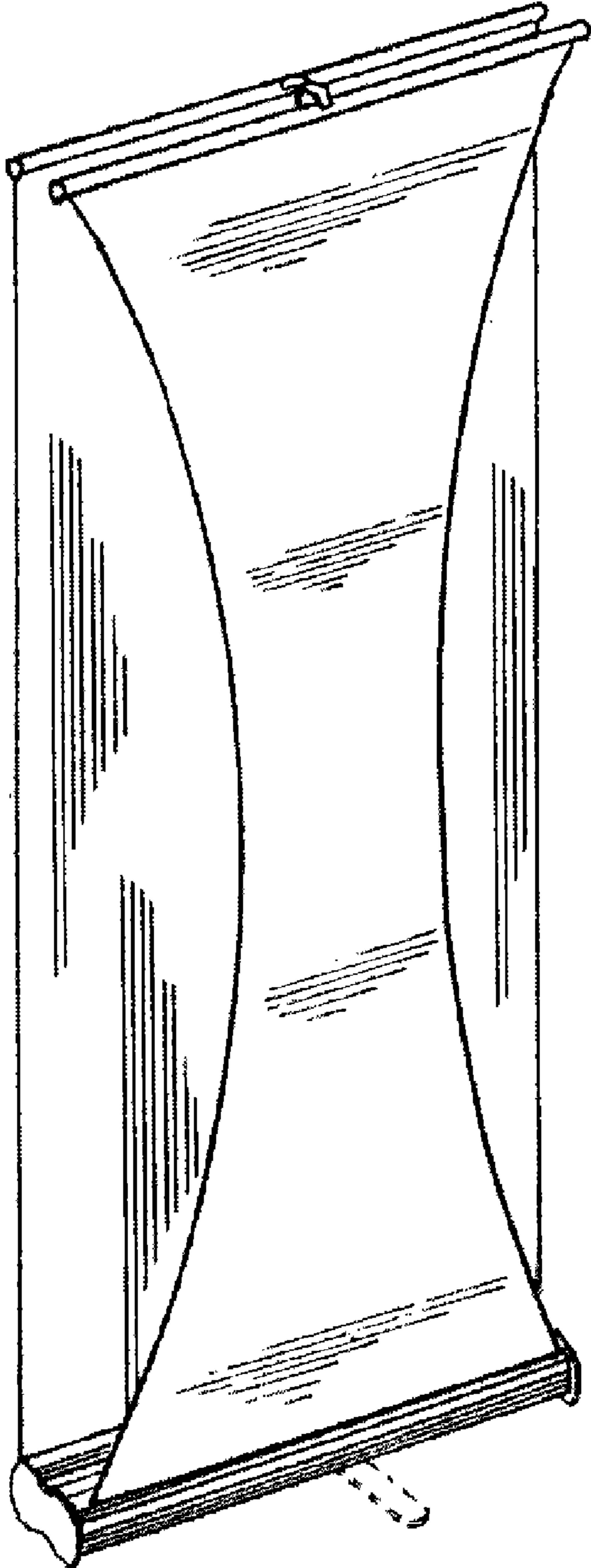

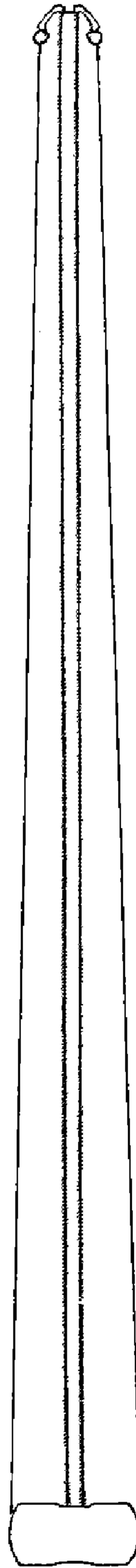

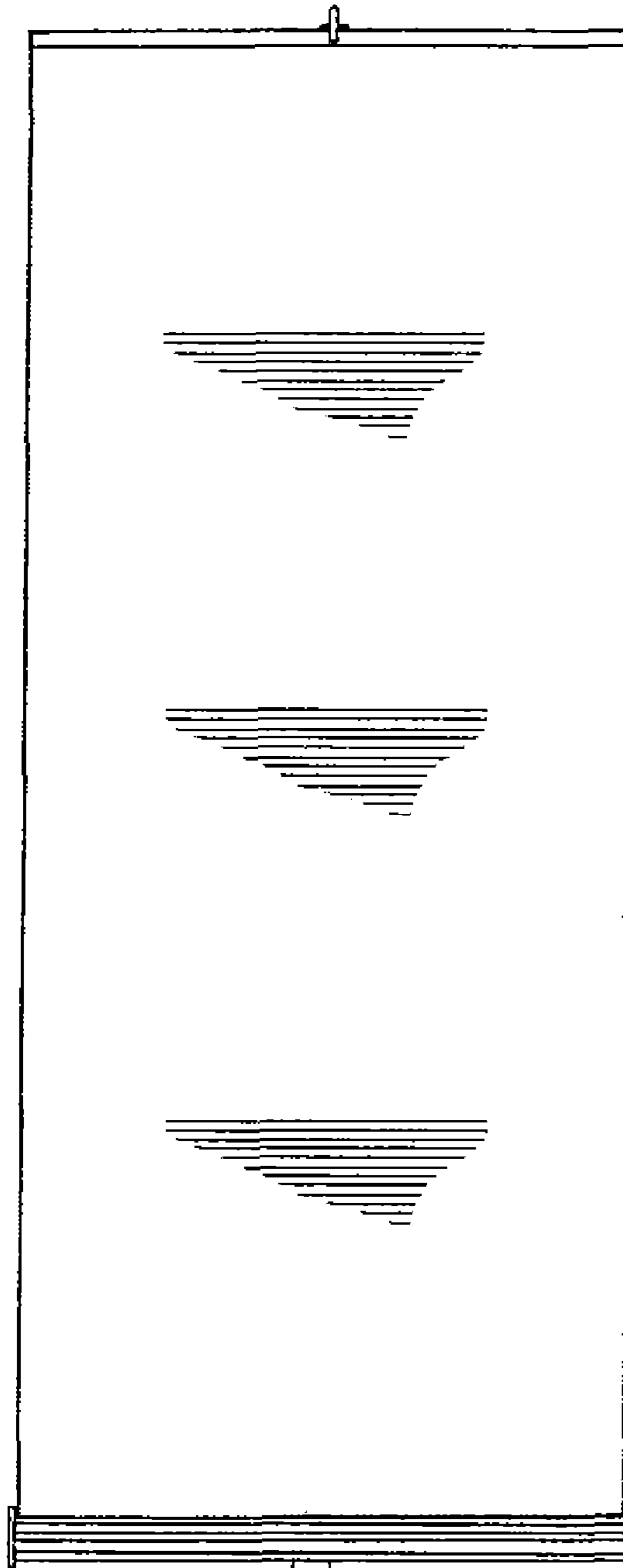
