**DESCRIPTION**

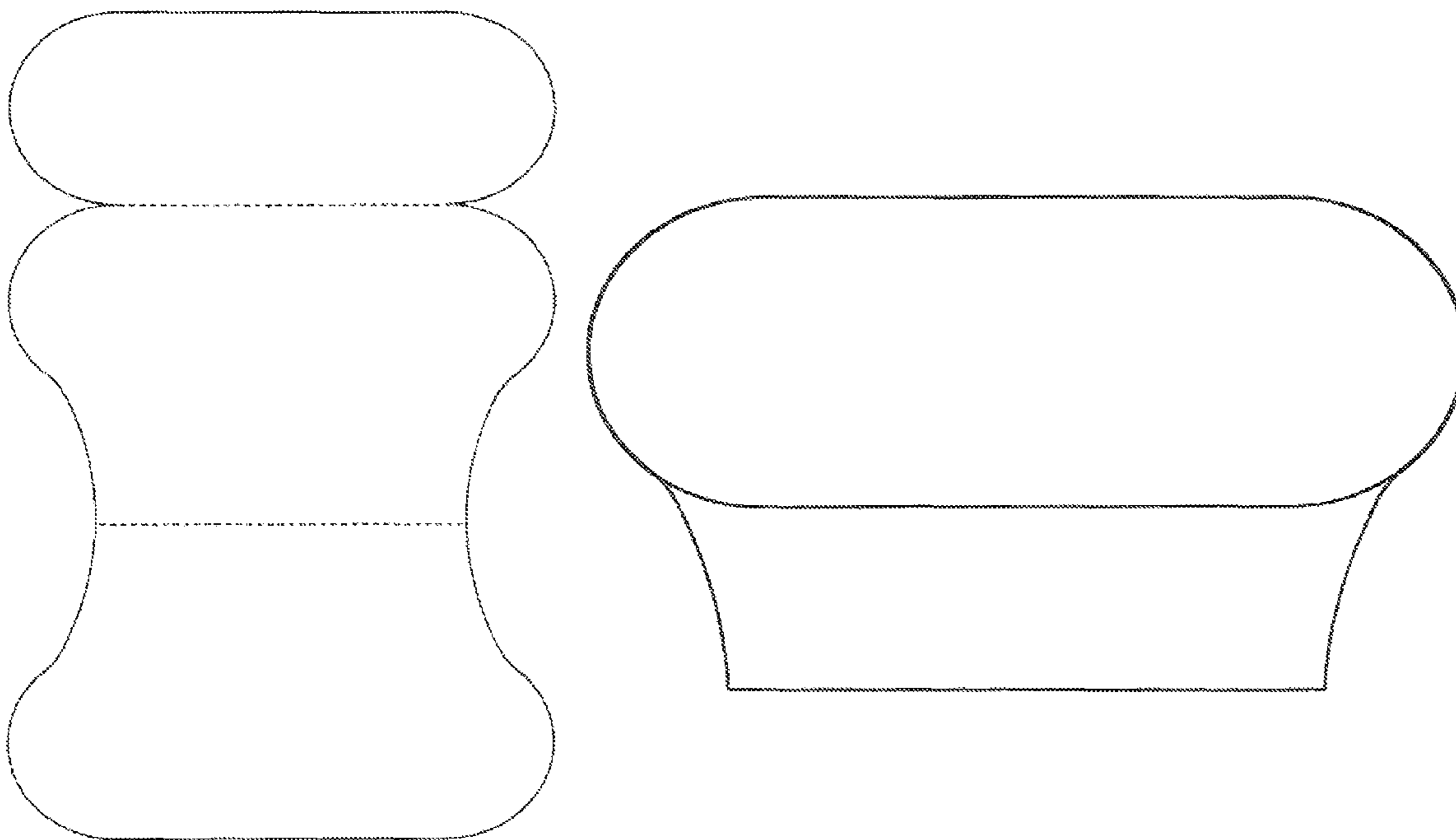
FIG. 1 is a top view of the label in an open position;

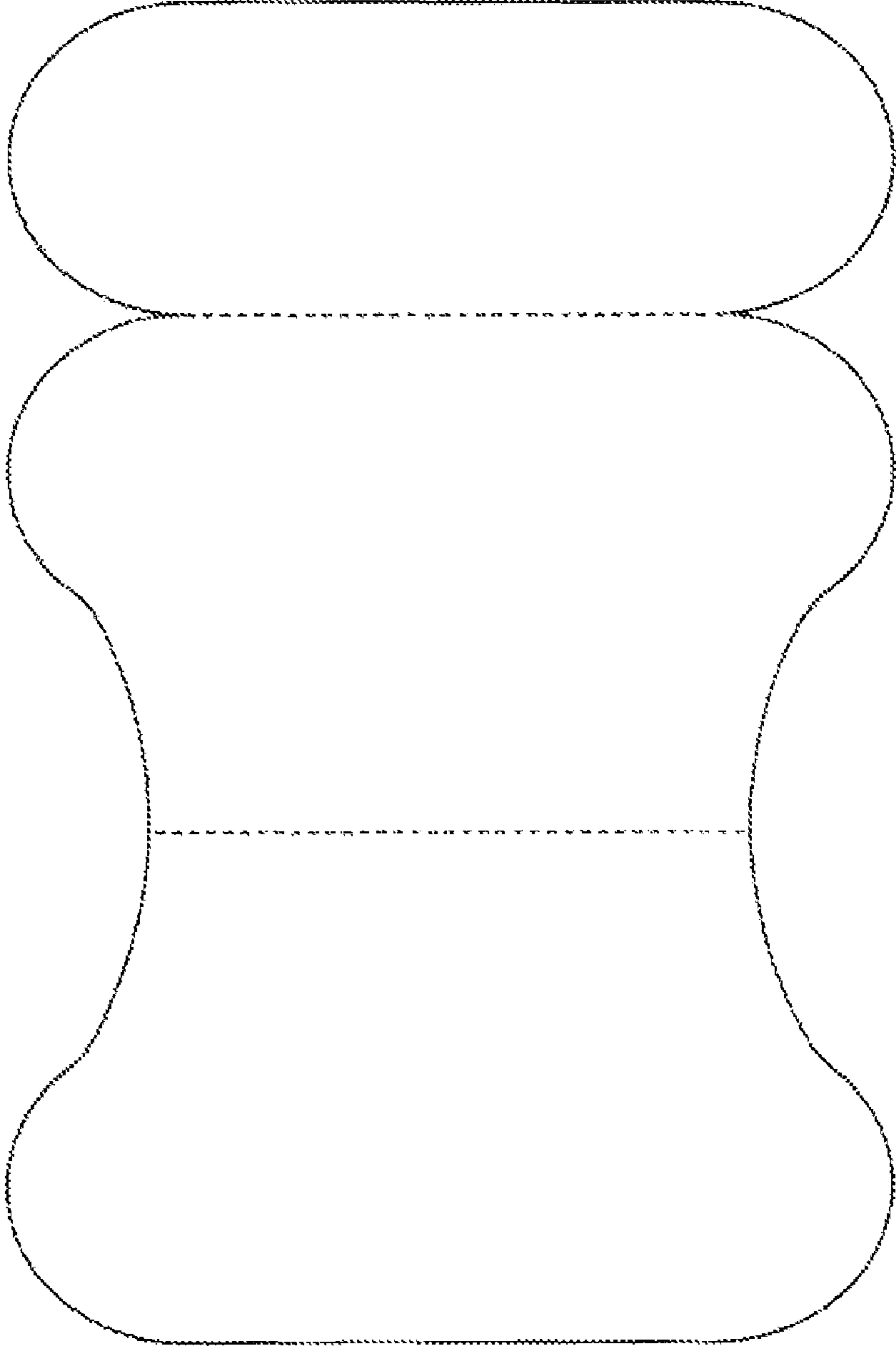
FIG. 2 is an enlarged top view of the label in a first closed/

closed/folded position.

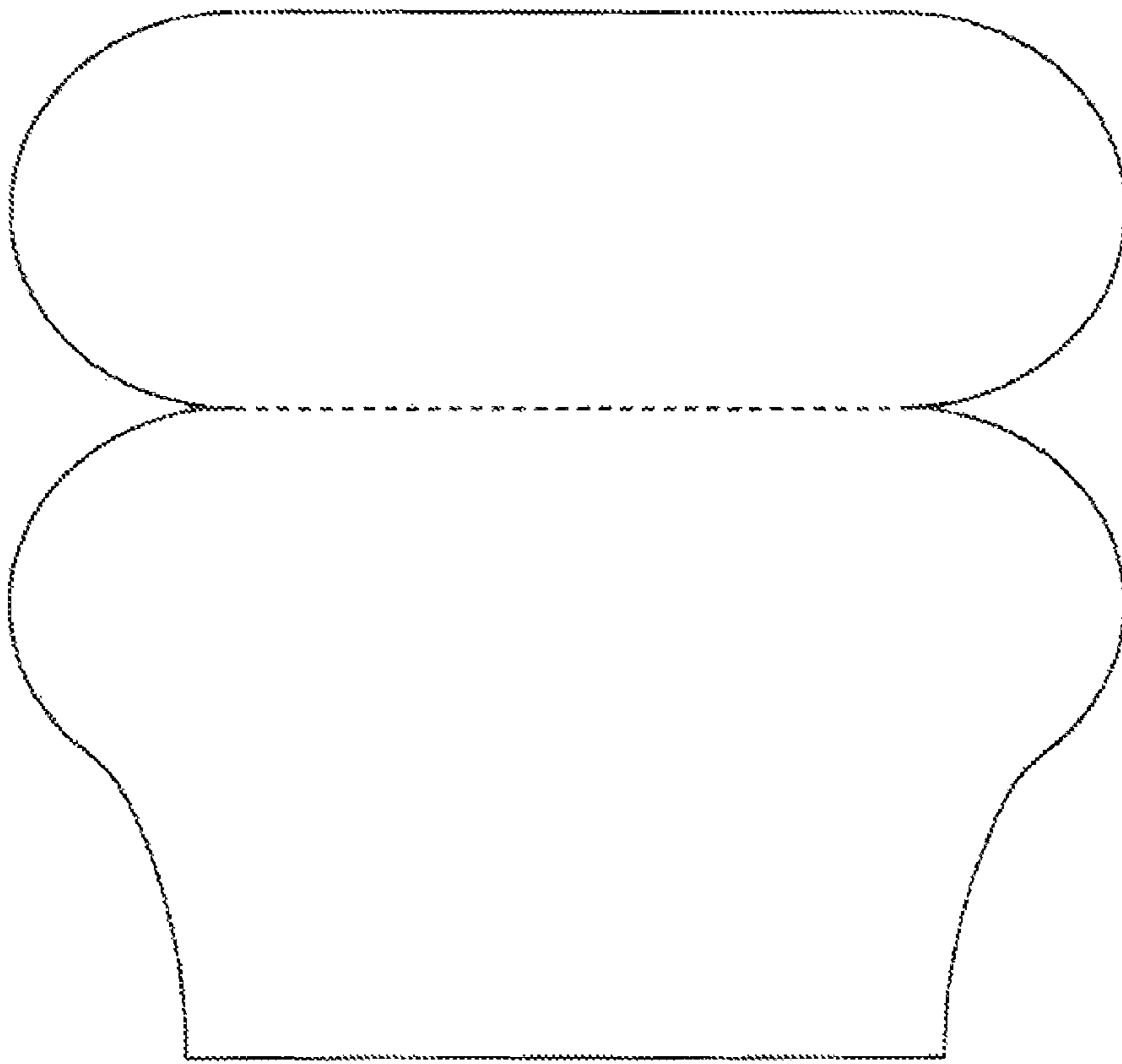
In the drawings, the broken lines represent fold lines.

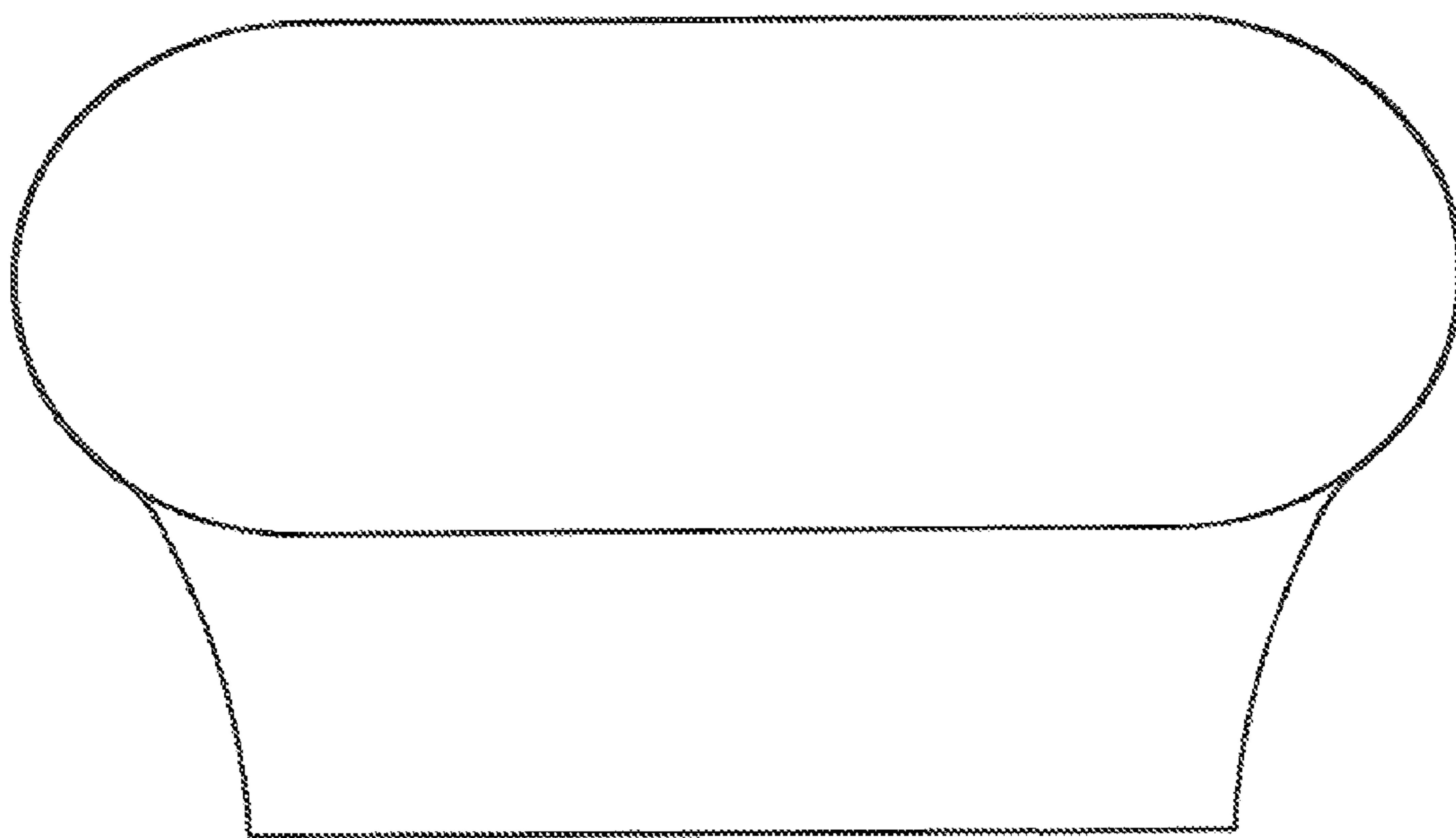
