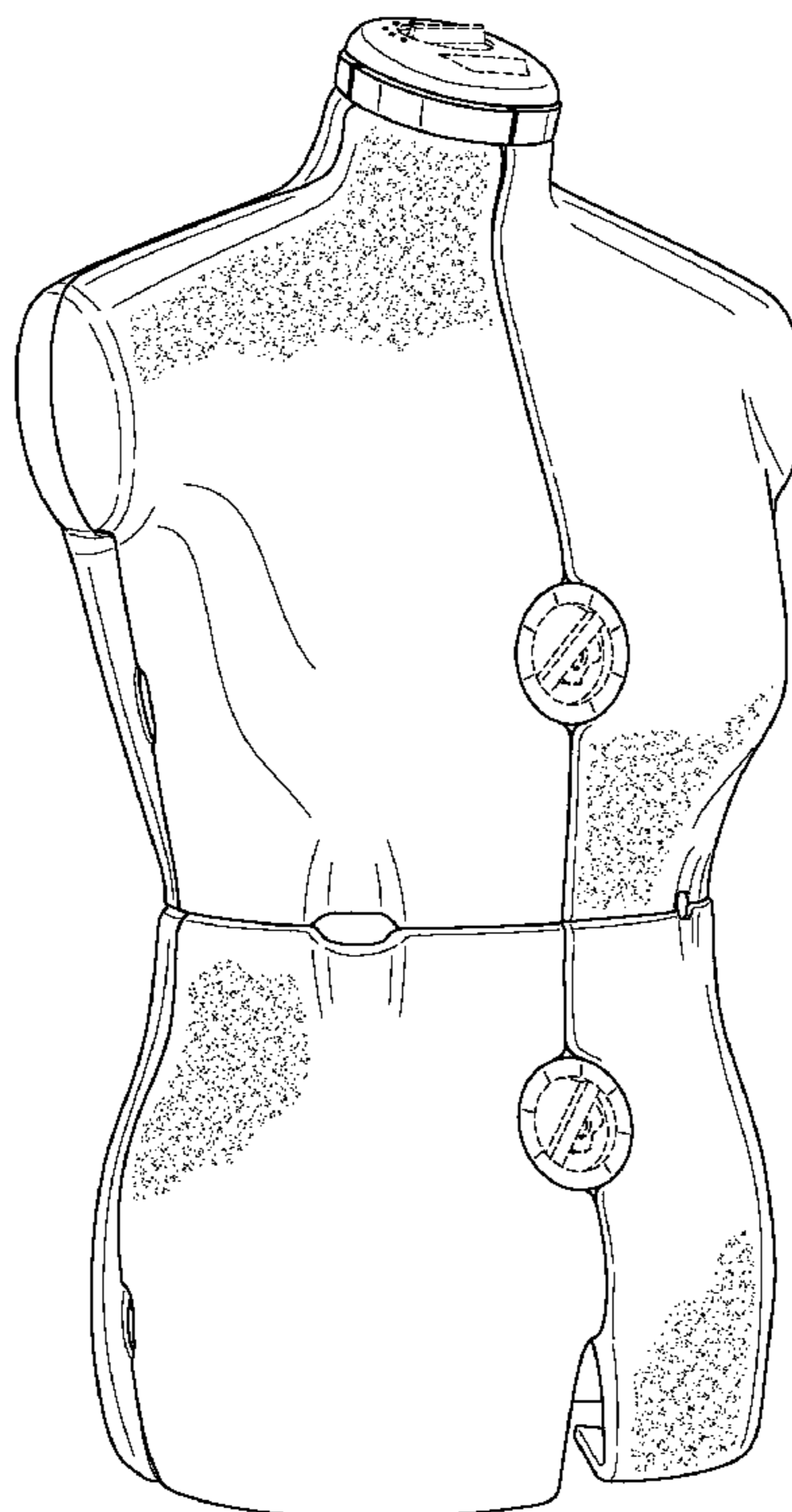
FIG. 4 is a left view thereof.

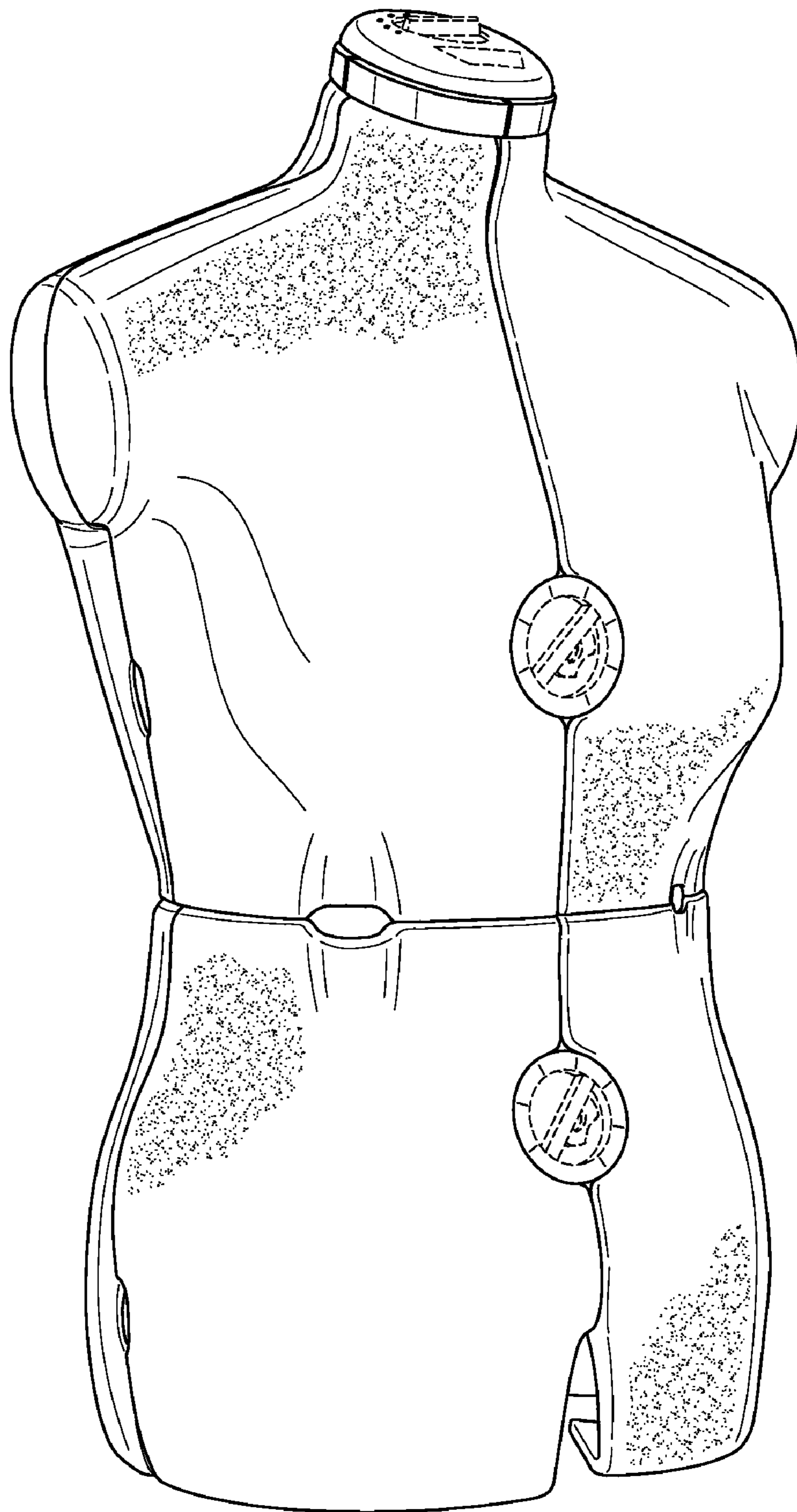

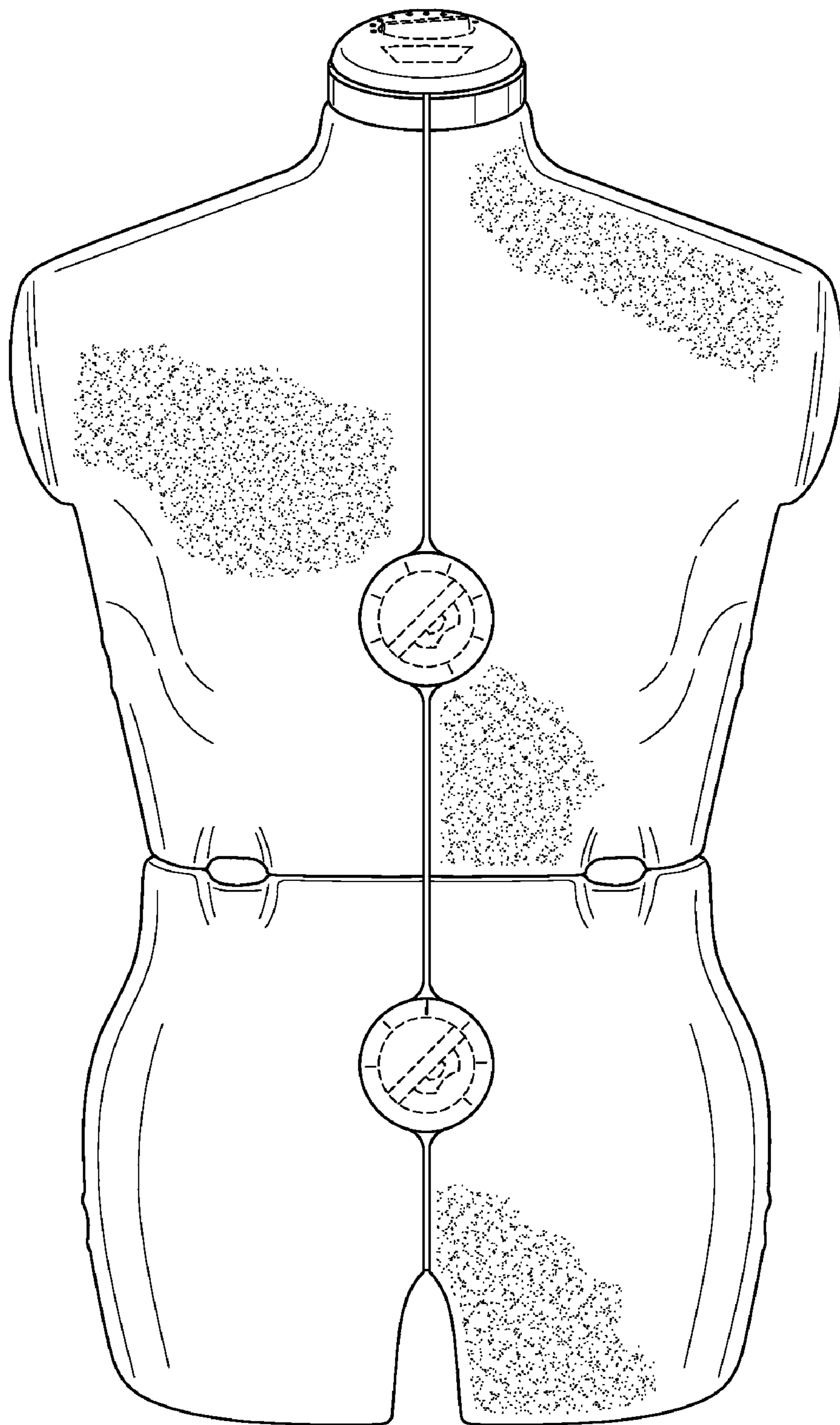

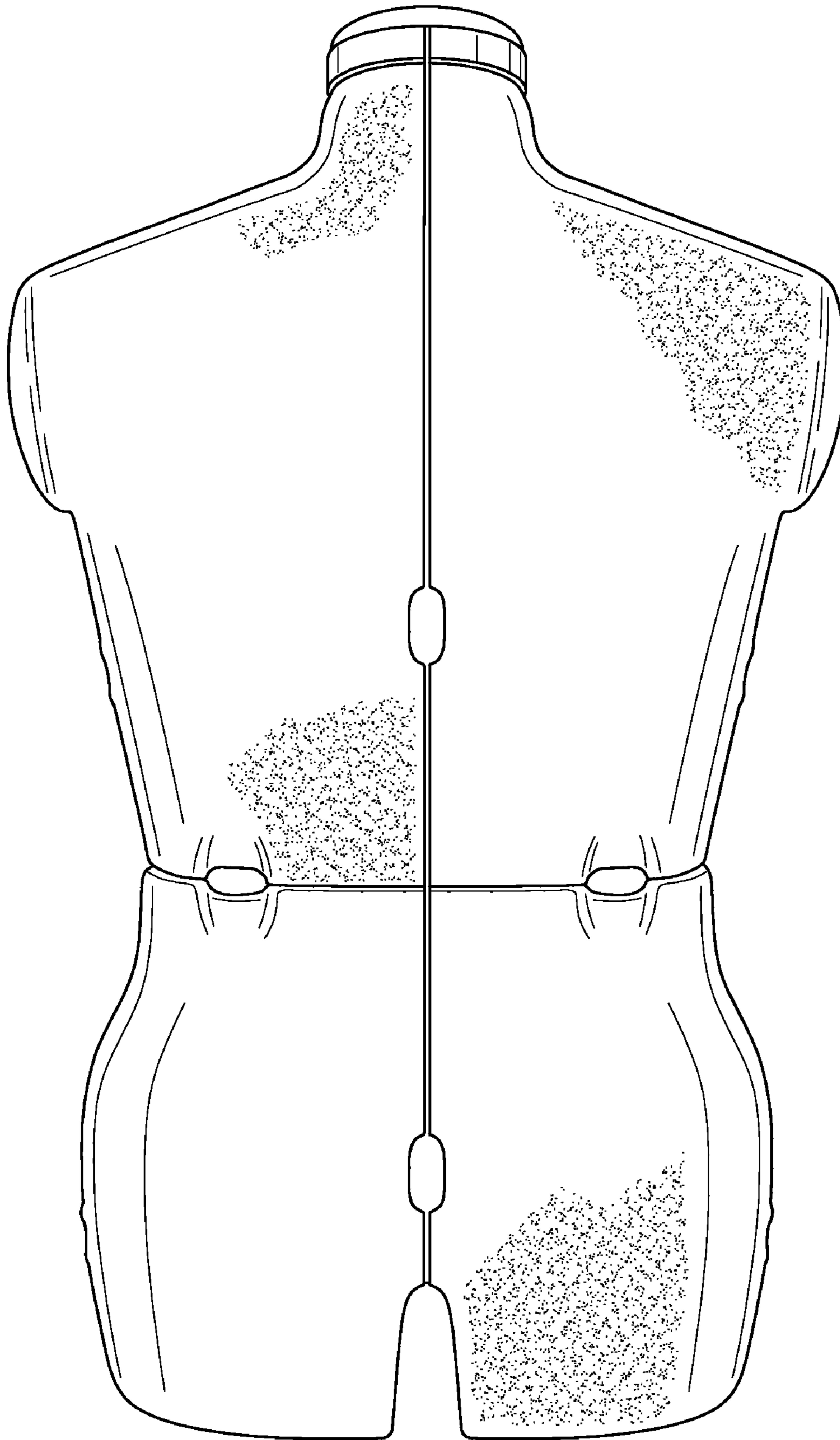

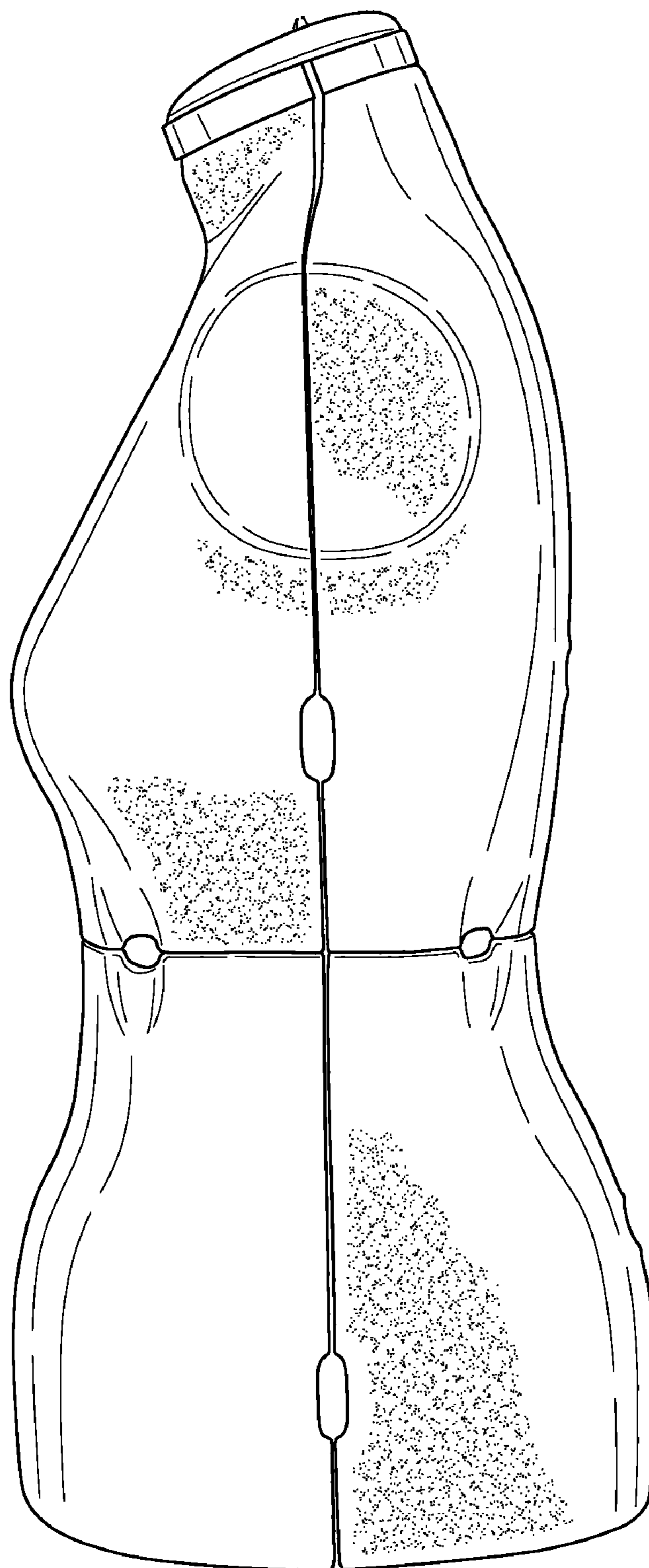

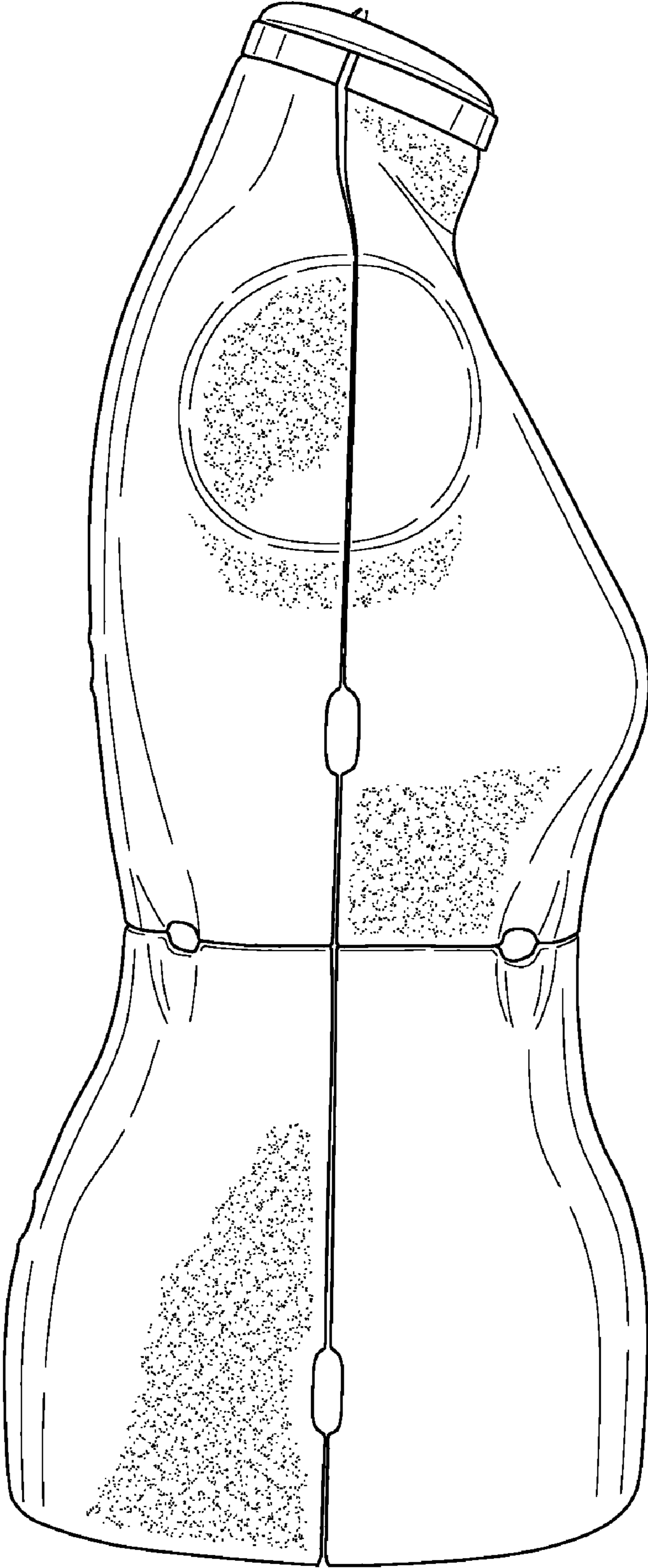

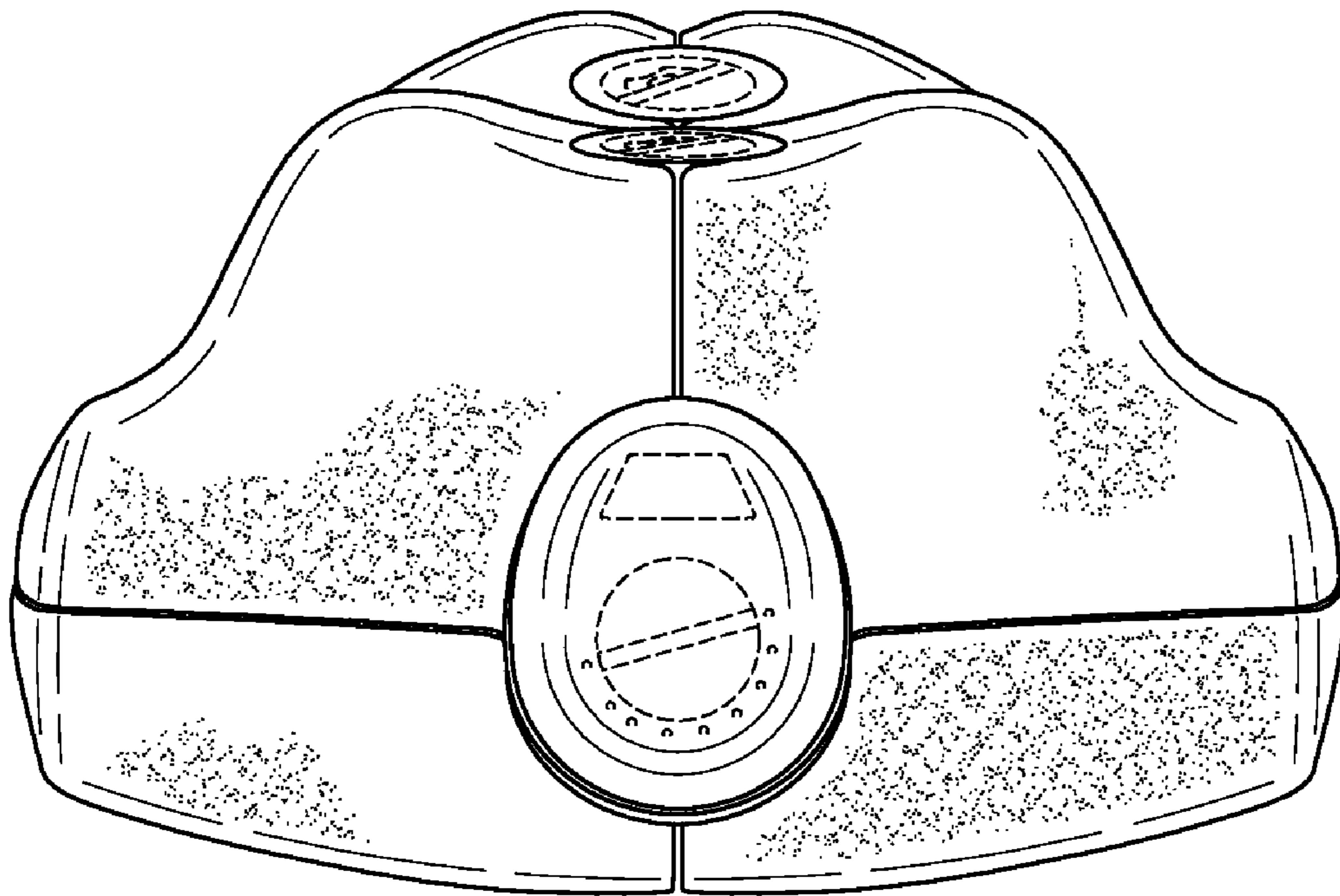
